Drinfeld Twists and Symmetric Bethe Vectors of Supersymmetric Fermion Models

Abstract

We construct the Drinfeld twists (factorizing F-matrices) of the gl(m|n)-invariant fermion model. Completely symmetric representation of the pseudo-particle creation operators of the model are obtained in the basis provided by the F-matrix (the F-basis). We resolve the hierarchy of the nested Bethe vectors in the F-basis for the gl(m|n) supersymmetric model.

I Introduction

In [1], it was realized that the R-matrices for the one-dimensional integrable XXX and XXZ spin chain systems are factorized in terms of certain non-degenerate lower-triangular F-matrices (Drinfeld twists [2])

$$R_{12}(u_1, u_2) = F_{21}^{-1}(u_2, u_1) F_{12}(u_1, u_2).$$
(I.1)

This leads to the natural F-basis for the analysis of these models. Working in the F-basis, the pseudo-particle creation operators of the systems take the completely symmetric form. Compared to the original Bethe vectors of the models, Bethe vectors in the F-basis are dramatically simplified and can be written down explicitly. These results allow form factors, correlation functions and spontaneous magnetizations of the systems to be represented in exact and compact form [3, 4].

The results of [1] were generalized to other models including the models associated with any finite-dimensional irreducible representations of the Yangian Y[gl(2)] [5], the gl(n) rational Heisenberg model [6], the elliptic XYZ and Belavin models [7, 8].

Recently [17, 18], we have successfully constructed the Drinfeld twists for the t-J models with gl(2|1) and $U_q(gl(2|1))$ supersymmetries, and resolved the hierarchies of the nested Bethe vectors of the two models. In this paper, we construct the factorizing F-matrices of the gl(m|n)-invariant fermion model. Working in the F-basis, we obtain the symmetric representations of the monodromy matrix and the creation operators. Moreover we resolve the hierarchy of the nested Bethe vectors in the F-basis for the gl(m|n) model.

The present paper is organized as follows. In section II, we introduce some basic notation on the gl(m|n)-invariant fermion model. In section III, we construct the F-matrix and its inverse. In section IV, we give the representation of the monodromy matrix and creation operators in the F-basis. In section V, specializing to the gl(2|2) invariant superconductive electronic model, we resolve its nested Bethe vectors in the F-basis. In section VI, we resolve the hierarchy of the Bethe vectors of the gl(m|n) model in the F-basis. We conclude the paper by offering some discussions in section VII.

II Basic definitions and notation

Let V be a (m+n)-dimensional gl(m|n)-module and $R \in End(V \otimes V)$ be the R-matrix associated with this module. V is Z_2 -graded, and in the following we choose the following grading for V: $[1] = \ldots = [m] = 1, [m+1] = \ldots = [m+n] = 0$. The graded permutation operator \mathcal{P} is defined by

$$\mathcal{P}(a \otimes b) = (-1)^{[a][b]}(b \otimes a) \tag{II.1}$$

or in matrix form

$$(\mathcal{P})_{ab}^{cd} = (-1)^{[c][d]} \delta_{ad} \delta_{bc}.$$

The R-matrix depends on the difference of two spectral parameters u_1 and u_2 associated with the two copies of V, and is given by

$$R_{12}(u_1, u_2) = R_{12}(u_1 - u_2) = a_{12}I + b_{12}\mathcal{P},$$
(II.2)

where I is the identity operator, and

$$a_{12} = a(u_1, u_2) \equiv \frac{u_1 - u_2}{u_1 - u_2 + \eta}, \qquad b_{12} = b(u_1, u_2) \equiv \frac{\eta}{u_1 - u_2 + \eta}$$
 (II.3)

with $\eta \in C$ being the crossing parameter. One can easily check that the R-matrix satisfies the unitary relation

$$R_{21}R_{12} = 1. (II.4)$$

Here and throughout $R_{12} \equiv R_{12}(u_1, u_2)$ and $R_{21} \equiv R_{21}(u_2, u_1)$. The *R*-matrix satisfies the graded Yang-Baxter equation (GYBE) [13]

$$R_{12}R_{13}R_{23} = R_{23}R_{13}R_{12}. (II.5)$$

In terms of the matrix elements defined by

$$R(u)(v^{i'} \otimes v^{j'}) = \sum_{i,j} R(u)_{ij}^{i'j'} (v^i \otimes v^j), \tag{II.6}$$

the GYBE reads [13]

$$\sum_{i',j',k'} R(u_1 - u_2)_{ij}^{i'j'} R(u_1 - u_3)_{i'k}^{i''k'} R(u_2 - u_3)_{j'k'}^{j''k''} (-1)^{[j']([i'] + [i''])}$$

$$= \sum_{i',j',k'} R(u_2 - u_3)_{jk}^{j'k'} R(u_1 - u_3)_{ik'}^{i'k''} R(u_1 - u_2)_{i'j'}^{i''j''} (-1)^{[j']([i] + [i'])}. \quad (II.7)$$

The quantum monodromy matrix T(u) on a lattice of length N is defined as

$$T(u) = R_{0N}(u, z_N) R_{0N-1}(u, z_{N-1}) \dots R_{01}(u, z_1),$$
(II.8)

where the index 0 refers to the auxiliary space and $\{z_i\}$ are arbitrary inhomogeneous parameters depending on site i. T(u) can be represented in the auxiliary space as a $(m+n)\times(m+n)$ matrix whose elements are operators acting on the quantum space $V^{\otimes N}$:

$$T(u) = \begin{pmatrix} A_{11}(u) & \cdots & A_{1\ m+n-1}(u) & B_1(u) \\ \vdots & \vdots & \vdots & \vdots \\ A_{m+n-1\ 1}(u) & \cdots & A_{m+n-1\ m+n-1}(u) & B_{m+n-1}(u) \\ C_1(u) & \cdots & C_{m+n-1}(u) & D(u) \end{pmatrix}.$$
(II.9)

By using the GYBE, one may prove that the monodromy matrix satisfies the GYBE

$$R_{12}(u-v)T_1(u)T_2(v) = T_2(v)T_1(u)R_{12}(u-v).$$
(II.10)

Define the transfer matrix t(u)

$$t(u) = str_0 T(u), (II.11)$$

where str_0 denotes the supertrace over the auxiliary space. Then the Hamiltonian of the ql(m|n) supersymmetric model is given by

$$H = \frac{d\ln t(u)}{du}|_{u=0}.$$
 (II.12)

This model is integrable thanks to the commutativity of the transfer matrix for different parameters,

$$[t(u), t(v)] = 0,$$
 (II.13)

which can be verified by using the GYBE.

Following [1], we now introduce the notation $R_{1...N}^{\sigma}$, where σ is any element of the permutation group \mathcal{S}_N . We note that we may rewrite the GYBE as

$$R_{23}^{\sigma_{23}}T_{0,23} = T_{0,32}R_{23}^{\sigma_{23}}, (II.14)$$

where σ_{23} is the transposition of space labels (2,3), $R_{23}^{\sigma_{23}} \equiv R_{23}$, and $T_{0,23} \equiv R_{03}R_{02}$. It follows that $R_{1...N}^{\sigma}$ is a product of elementary R-matrices, corresponding to a decomposition of σ into elementary transpositions. With the help of the GYBE, one may generalize (II.14) to a N-fold tensor product of spaces

$$R_{1...N}^{\sigma} T_{0,1...N} = T_{0,\sigma(1...N)} R_{1...N}^{\sigma},$$
 (II.15)

where $T_{0,1...N} \equiv R_{0N} \dots R_{01}$. This implies the "decomposition" law

$$R_{1\dots N}^{\sigma'\sigma} = R_{\sigma'(1\dots N)}^{\sigma} R_{1\dots N}^{\sigma'},\tag{II.16}$$

for a product of two elements in S_N . We remark here that for the elementary transposition $\sigma_{i,i+1}$, $R_{1...N}^{\sigma_{i,i+1}} = R_{i,i+1}$, and for any $\sigma \in S_N$, $R_{1...N}^{\sigma}$ can be obtained with the help of (II.16).

Note that $R^{\sigma}_{\sigma'(1...N)}$ satisfies the relation

$$R^{\sigma}_{\sigma'(1...N)} T_{0,\sigma'(1...N)} = T_{0,\sigma'\sigma(1...N)} R^{\sigma}_{\sigma'(1...N)}. \tag{II.17}$$

As in [6], we write the elements of $R_{1...N}^{\sigma}$ as

$$(R_{1...N}^{\sigma})_{\beta_N...\beta_1}^{\alpha_{\sigma(N)}...\alpha_{\sigma(1)}}, \qquad (II.18)$$

where the labels in the upper indices are permuted relative to the lower indices according to σ .

III F-matrices for the gl(m|n) supersymmetric model

In this section, we construct the factoring F-matrix and its inverse for the supersymmetric gl(m|n) model.

III.1 The F-matrix

For the R-matrix (II.2), we define the F-matrix

$$F_{12} = \sum_{m+n > \alpha_2 > \alpha_1} P_1^{\alpha_1} P_2^{\alpha_2} + c_{12} \sum_{\gamma=1}^m P_1^{\gamma} P_2^{\gamma} + \sum_{m+n > \alpha_1 > \alpha_2} P_1^{\alpha_1} P_2^{\alpha_2} R_{12}, \quad (III.1)$$

where $(P_i^{\alpha})_k^l = \delta_{k,\alpha}\delta_{l,\alpha}$ is the projector acting on *i*th space, and $c_{12} \equiv a_{12} - b_{12}$. Then by the *R*-matrix (II.2) and *F*-matrix (III.1), we have

$$F_{21}R_{12} = \left(\sum_{m+n\geq\alpha_1\geq\alpha_2} P_2^{\alpha_2} P_1^{\alpha_1} + c_{21} \sum_{\gamma=1}^m P_2^{\gamma} P_1^{\gamma} + \sum_{m+n\geq\alpha_2>\alpha_1} P_2^{\alpha_2} P_1^{\alpha_1} R_{21}\right) R_{12}$$

$$= \left(\sum_{m+n\geq\alpha_1>\alpha_2} P_2^{\alpha_2} P_1^{\alpha_1} + (1+c_{21}) \sum_{\gamma=1}^m P_2^{\gamma} P_1^{\gamma} + \sum_{\gamma=m+1}^{m+n} P_2^{\gamma} P_1^{\gamma}\right)$$

$$+ \sum_{m+n \geq \alpha_{2} > \alpha_{1}} P_{2}^{\alpha_{2}} P_{1}^{\alpha_{1}} R_{21} \right) R_{12}$$

$$= \sum_{m+n \geq \alpha_{1} > \alpha_{2}} P_{2}^{\alpha_{2}} P_{1}^{\alpha_{1}} R_{12} + (1 + c_{12}) \sum_{\gamma=1}^{m} P_{2}^{\gamma} P_{1}^{\gamma} + \sum_{\gamma=m+1}^{m+n} P_{2}^{\gamma} P_{1}^{\gamma}$$

$$+ \sum_{m+n \geq \alpha_{2} > \alpha_{1}} P_{2}^{\alpha_{2}} P_{1}^{\alpha_{1}}$$

$$= \sum_{m+n \geq \alpha_{1} > \alpha_{2}} P_{2}^{\alpha_{2}} P_{1}^{\alpha_{1}} R_{12} + c_{12} \sum_{\gamma=1}^{m} P_{2}^{\gamma} P_{1}^{\gamma} + \sum_{m+n \geq \alpha_{2} \geq \alpha_{1}} P_{2}^{\alpha_{2}} P_{1}^{\alpha_{1}}$$

$$= F_{12}. \qquad (III.2)$$

Here we have used $R_{12}R_{21} = 1$ and $c_{12}c_{21} = 1$. Some remarks are in order. The solutions to (I.1), i.e. the *F*-matrices satisfying (I.1), are not unique [1, 6]. In this paper, we only consider particular solution of the form (III.1), which is lower-triangle.

We now generalize the F-matrix to the N-site problem. As is pointed out in [6], the generalized F-matrix should satisfy three properties: i) lower-triangularity; ii) non-degeneracy and

iii)
$$F_{\sigma(1...N)}(z_{\sigma(1)}, \dots, z_{\sigma(N)}) R_{1...N}^{\sigma}(z_1, \dots, z_N) = F_{1...N}(z_1, \dots, z_N),$$
 (III.3)

where $\sigma \in \mathcal{S}_N$ and z_i , i = 1, ..., N, are generic inhomogeneous parameters. Define the N-site F-matrix:

$$F_{1,\dots N} = \sum_{\sigma \in \mathcal{S}_N} \sum_{\alpha_{\sigma(1)} \dots \alpha_{\sigma(N)}}^* \prod_{j=1}^N P_{\sigma(j)}^{\alpha_{\sigma(j)}} S(c, \sigma, \alpha_{\sigma}) R_{1\dots N}^{\sigma}, \tag{III.4}$$

where the sum \sum^* is over all non-decreasing sequences of the labels $\alpha_{\sigma(i)}$:

$$\alpha_{\sigma(i+1)} \ge \alpha_{\sigma(i)}$$
 if $\sigma(i+1) > \sigma(i)$
 $\alpha_{\sigma(i+1)} > \alpha_{\sigma(i)}$ if $\sigma(i+1) < \sigma(i)$ (III.5)

and the c-number function $S(c, \sigma, \alpha_{\sigma})$ is given by

$$S(c, \sigma, \alpha_{\sigma}) \equiv \exp\{\sum_{l>k=1}^{N} \delta_{\alpha_{\sigma(k)}, \alpha_{\sigma(l)}}^{[\gamma]} \ln(1 + c_{\sigma(k)\sigma(l)})\}$$
 (III.6)

with $\gamma = 1, \ldots, m$, $\delta_{\alpha_{\sigma(k)}, \alpha_{\sigma(l)}}^{[\gamma]} = 1$ for $\alpha_{\sigma(k)} = \alpha_{\sigma(l)} = \gamma$, and $\delta_{\alpha_{\sigma(k)}, \alpha_{\sigma(l)}}^{[\gamma]} = 0$ otherwise.

The definition of $F_{1...N}$, (III.4), and the summation condition (III.5) imply that $F_{1...N}$ is a lower-triangular matrix. Moreover, one can easily check that the F-matrix is non-degenerate because all diagonal elements are non-zero.

We now prove that the F-matrix (III.4) satisfies the property iii). Any given permutation $\sigma \in \mathcal{S}_N$ can be decomposed into elementary transpositions of the group \mathcal{S}_N as $\sigma = \sigma_1 \dots \sigma_k$ with σ_i denoting the elementary permutation (i, i + 1). By (II.16), we

have if the property iii) holds for elementary transposition σ_i ,

$$F_{\sigma(1...N)}R_{1...N}^{\sigma} = F_{\sigma_1...\sigma_k(1...N)}R_{\sigma_1...\sigma_{k-1}(1...N)}^{\sigma_k}R_{\sigma_1...\sigma_{k-2}(1...N)}^{\sigma_{k-1}} \dots R_{1...N}^{\sigma_1}$$

$$= F_{\sigma_1...\sigma_{k-1}(1...N)}R_{\sigma_1...\sigma_{k-2}(1...N)}^{\sigma_{k-1}} \dots R_{1...N}^{\sigma_1}$$

$$= \dots = F_{\sigma_1(1...N)}R_{1...N}^{\sigma_1} = F_{1...N}.$$
(III.7)

For the elementary transposition σ_i , we have

$$F_{\sigma_{i}(1...N)}R_{1...N}^{\sigma_{i}} =$$

$$= \sum_{\sigma \in \mathcal{S}_{N}} \sum_{\alpha_{\sigma_{i}\sigma(1)}...\alpha_{\sigma_{i}\sigma(N)}}^{*} \prod_{j=1}^{N} P_{\sigma_{i}\sigma(j)}^{\alpha_{\sigma_{i}\sigma(j)}} S(c, \sigma_{i}\sigma, \alpha_{\sigma_{i}\sigma}) R_{\sigma_{i}(1...N)}^{\sigma} R_{1...N}^{\sigma_{i}}$$

$$= \sum_{\sigma \in \mathcal{S}_{N}} \sum_{\alpha_{\sigma_{i}\sigma(1)}...\alpha_{\sigma_{i}\sigma(N)}}^{*} \prod_{j=1}^{N} P_{\sigma_{i}\sigma(j)}^{\alpha_{\sigma_{i}\sigma(j)}} S(c, \sigma_{i}\sigma, \alpha_{\sigma_{i}\sigma}) R_{1...N}^{\sigma_{i}\sigma}$$

$$= \sum_{\tilde{\sigma} \in \mathcal{S}_{N}} \sum_{\alpha_{\tilde{\sigma}(1)}...\alpha_{\tilde{\sigma}(N)}}^{*(i)} \prod_{j=1}^{N} P_{\tilde{\sigma}(j)}^{\alpha_{\tilde{\sigma}(j)}} S(c, \tilde{\sigma}, \alpha_{\tilde{\sigma}}) R_{1...N}^{\tilde{\sigma}},$$

$$(III.8)$$

where $\tilde{\sigma} = \sigma_i \sigma$, and the summation sequences of $\alpha_{\tilde{\sigma}}$ in $\sum_{i=1}^{s(i)} n_i \sigma_i$ now has the form

$$\alpha_{\tilde{\sigma}(j+1)} \ge \alpha_{\tilde{\sigma}(j)} \quad \text{if} \quad \sigma_i \tilde{\sigma}(j+1) > \sigma_i \tilde{\sigma}(j),$$

$$\alpha_{\tilde{\sigma}(j+1)} > \alpha_{\tilde{\sigma}(j)} \quad \text{if} \quad \sigma_i \tilde{\sigma}(j+1) < \sigma_i \tilde{\sigma}(j). \tag{III.9}$$

Comparing (III.9) with (III.5), we find that the only difference between them is the transposition σ_i factor in the "if" conditions. For a given $\tilde{\sigma} \in \mathcal{S}_N$ with $\tilde{\sigma}(j) = i$ and $\tilde{\sigma}(k) = i + 1$, one finds that if |j - k| > 1, then σ_i does not affect the sequence of $\alpha_{\tilde{\sigma}}$ at all, that is, the sign of inequality ">" or " \geq " between two neighboring root indexes is unchanged with the action of σ_i ; and if |j - k| = 1, then in the summation sequences of $\alpha_{\tilde{\sigma}}$, when $\tilde{\sigma}(j+1) = i + 1$ and $\tilde{\sigma}(j) = i$, sign " \geq " changes to ">", while when $\tilde{\sigma}(j+1) = i$ and $\tilde{\sigma}(j) = i + 1$, ">" changes to " \geq ". Thus (III.5) and (III.8) differ only when equal labels $\alpha_{\tilde{\sigma}}$ appear. With the help of the c-number S in the definition of $F_{1,\ldots,N}$ (III.4) and the relation $c_{12}c_{21} = 1$, one easily shows that for the equal labels, $F_{\sigma_i(1,\ldots,N)}R_{1,\ldots,N}^{\sigma_i} - F_{1,\ldots,N} = 0$. (For detailed proof, please see [17].)

Therefore, we have proved that the Drinfeld twist factorizes the R-matrix of the N-site gl(m|n) model:

$$R_{1...N}^{\sigma}(z_1,\ldots,z_N) = F_{\sigma(1...N)}^{-1}(z_{\sigma(1)},\ldots,z_{\sigma(N)})F_{1...N}(z_1,\ldots,z_N).$$
 (III.10)

In summary, the factorizing F-matrix $F_{1...N}$ of the gl(m|n) model is proved to satisfy all three properties.

III.2 Inverse $F_{1...N}^{-1}$ of the F-matrix

The non-degenerate property of the F-matrix implies that we can find the inverse matrix $F_{1...N}^{-1}$. To do so, we first define

$$F_{1...N}^{*} = \sum_{\sigma \in \mathcal{S}_{N}} \sum_{\alpha_{\sigma(1)}...\alpha_{\sigma(N)}}^{**} S(c, \sigma, \alpha_{\sigma}) R_{\sigma(1...N)}^{\sigma^{-1}} \prod_{j=1}^{N} P_{\sigma(j)}^{\alpha_{\sigma(j)}},$$
(III.11)

where the sum \sum^{**} is taken over all possible α_i which satisfies the following non-increasing constraints:

$$\alpha_{\sigma(i+1)} \le \alpha_{\sigma(i)}$$
 if $\sigma(i+1) < \sigma(i)$,
 $\alpha_{\sigma(i+1)} < \alpha_{\sigma(i)}$ if $\sigma(i+1) > \sigma(i)$. (III.12)

Now we compute the product of $F_{1...N}$ and $F_{1...N}^*$. Substituting (III.4) and (III.11) into the product, we have

$$F_{1...N}F_{1...N}^{*} = \sum_{\sigma \in \mathcal{S}_{N}} \sum_{\sigma' \in \mathcal{S}_{N}} \sum_{\alpha_{\sigma_{1}}...\alpha_{\sigma_{N}}}^{*} \sum_{\beta_{\sigma_{1}'}...\beta_{\sigma_{N}'}}^{**} S(c, \sigma, \alpha_{\sigma}) S(c, \sigma', \beta_{\sigma'})$$

$$\times \prod_{i=1}^{N} P_{\sigma(i)}^{\alpha_{\sigma(i)}} R_{1...N}^{\sigma} R_{\sigma'(1...N)}^{\sigma'-1} \prod_{i=1}^{N} P_{\sigma'(i)}^{\beta_{\sigma'(i)}}$$

$$= \sum_{\sigma \in \mathcal{S}_{N}} \sum_{\sigma' \in \mathcal{S}_{N}} \sum_{\alpha_{\sigma_{1}}...\alpha_{\sigma_{N}}}^{*} \sum_{\beta_{\sigma_{1}'}...\beta_{\sigma_{N}'}}^{**} S(c, \sigma, \alpha_{\sigma}) S(c, \sigma', \beta_{\sigma'})$$

$$\times \prod_{i=1}^{N} P_{\sigma(i)}^{\alpha_{\sigma(i)}} R_{\sigma'(1...N)}^{\sigma'-1} \prod_{i=1}^{N} P_{\sigma'(i)}^{\beta_{\sigma'(i)}}. \qquad (III.13)$$

To evaluate the r.h.s., we examine the matrix element of the R-matrix

$$\left(R_{\sigma'(1\dots N)}^{\sigma'^{-1}\sigma}\right)_{\beta_{\sigma'(N)}\dots\beta_{\sigma'(1)}}^{\alpha_{\sigma(N)}\dots\alpha_{\sigma(1)}}.$$
(III.14)

Note that the sequence $\{\alpha_{\sigma}\}$ is non-decreasing and $\{\beta_{\sigma'}\}$ is non-increasing. Thus the non-vanishing condition of the matrix element (III.14) requires that α_{σ} and $\beta_{\sigma'}$ satisfy

$$\beta_{\sigma'(N)} = \alpha_{\sigma(1)}, \dots, \beta_{\sigma'(1)} = \alpha_{\sigma(N)}. \tag{III.15}$$

One can verify [6] that (III.15) is fulfilled only if

$$\sigma'(N) = \sigma(1), \dots, \sigma'(1) = \sigma(N). \tag{III.16}$$

Let $\bar{\sigma}$ be the maximal element of the \mathcal{S}_N which reverses the site labels

$$\bar{\sigma}(1,\ldots,N) = (N,\ldots,1). \tag{III.17}$$

Then from (III.16), we have

$$\sigma' = \sigma \bar{\sigma}. \tag{III.18}$$

Substituting (III.15) and (III.18) into (III.13), we have

$$F_{1...N}F_{1...N}^{*} = \sum_{\sigma \in \mathcal{S}_{N}} \sum_{\alpha_{\sigma_{1}}...\alpha_{\sigma_{N}}}^{*} S(c,\sigma,\alpha_{\sigma}) S(c,\sigma,\alpha_{\sigma}) \prod_{i=1}^{N} P_{\sigma(i)}^{\alpha_{\sigma(i)}} R_{\sigma(N...1)}^{\bar{\sigma}} \prod_{i=1}^{N} P_{\sigma(i)}^{\alpha_{\sigma(i)}}.$$
(III.19)

The decomposition of $R^{\bar{\sigma}}$ in terms of elementary R-matrices is unique module GYBE. One reduces from (III.19) that FF^* is a diagonal matrix:

$$F_{1...N}F_{1...N}^* = \prod_{i < j} \Delta_{ij},$$
 (III.20)

where

Therefore, the inverse of the F-matrix is given by

IV The monodromy matrix in the F-basis

In the previous section, we see that the gl(m|n) R-matrix factorizes in terms of the F-matrix and its inverse which we constructed explicitly. The column vectors of the inverse of the F-matrix form a set of basis on which gl(m|n) acts. In this section, we study the generators of gl(m|n) and the elements of the monodromy matrix in the F-basis.

IV.1 gl(m|n) generators in the F-basis

Denoted by $E^{\gamma}^{\gamma\pm 1}$ the simple generators of the N-site gl(m|n) supersymmetric system. Then $E^{\gamma}^{\gamma\pm 1} = E^{\gamma\gamma\pm 1}_{(1)} + \ldots + E^{\gamma}_{(N)}^{\gamma\pm 1}$, where $E^{\gamma\gamma\pm 1}_{(k)}$ acts on the kth component of the tensor product space. Let $\tilde{E}^{\gamma\gamma\pm 1}$ denote the corresponding simple generators in the F-basis: $\tilde{E}^{\gamma\gamma\pm 1} = F_{1...N}E^{\gamma\gamma\pm 1}F_{1...N}^{-1}$. For later use, we derive $\tilde{E}^{\gamma}^{\gamma+1}$. From the expressions of F and its inverse, we have

$$\tilde{E}^{\gamma \gamma+1} = F_{1\dots N} E^{\gamma \gamma+1} F_{1\dots N}^{-1}$$

$$\times \prod_{i=1}^{N} P_{\sigma(i)}^{\alpha_{\sigma(i)}} R_{1...N}^{\sigma} E^{\gamma} Y^{+1} R_{\sigma'(1...N)}^{\sigma'(-1)} \prod_{i=1}^{N} P_{\sigma'(i)}^{\beta_{\sigma'(i)}} \prod_{i < j} \Delta_{ij}^{-1}$$

$$= \sum_{\sigma, \sigma' \in S_N} \sum_{\alpha_{\sigma(1)} \dots \alpha_{\sigma(N)}}^{*} \sum_{\beta_{\sigma'(1)} \dots \beta_{\sigma'(N)}}^{**} S(c, \sigma, \alpha_{\sigma}) S(c, \sigma', \beta_{\sigma'})$$

$$\times \prod_{i=1}^{N} P_{\sigma(i)}^{\alpha_{\sigma(i)}} E^{\gamma} Y^{+1} R_{\sigma'(1...N)}^{\sigma'(-1)} \prod_{i=1}^{N} P_{\sigma'(i)}^{\beta_{\sigma'(i)}} \prod_{i < j} \Delta_{ij}^{-1} \qquad (IV.1)$$

$$= \sum_{\sigma, \sigma' \in S_N} \sum_{k=1}^{N} E_{(\sigma(a+l))}^{\gamma+1} \sum_{\alpha_{\sigma(1)} \dots \alpha_{\sigma(N)}}^{**} \sum_{\beta_{\sigma'(1)} \dots \beta_{\sigma'(N)}}^{**} S(c, \sigma, \alpha_{\sigma}) S(c, \sigma', \beta_{\sigma'})$$

$$\times P_{\sigma(1)}^{\alpha_{\sigma(1)}} P_{\sigma(2)}^{\alpha_{\sigma(2)}} \dots P_{\sigma(a)}^{\alpha_{\sigma(a)} = \gamma - 1} P_{\sigma(a+1)}^{\alpha_{\sigma(a+1)} = \gamma} \dots \left(P_{\sigma(a+l) = k}^{\alpha_{\sigma(a+l)} = \gamma \to \gamma + 1} \right) \dots$$

$$\times P_{\sigma(N)}^{\alpha_{\sigma(N)}} R_{\sigma'(1...N)}^{\sigma'(-1)} \prod_{i=1}^{N} P_{\sigma'(i)}^{\beta_{\sigma'(i)}} \prod_{i < j} \Delta_{ij}^{-1}, \qquad (IV.2)$$

where in (IV.1), we have used $[E^{\gamma \gamma \pm 1}, R^{\sigma}_{1...N}] = 0$. The element of $R^{\sigma'^{-1}\sigma}_{\sigma'(1...N)}$ between $P^{\alpha_{\sigma(1)}}_{\sigma(1)} \dots \left(P^{\alpha_{\sigma(a+l)}=\gamma \to \gamma+1}_{\sigma(a+l)=k}\right) \dots P^{\alpha_{\sigma(N)}}_{\sigma(N)}$ and $P^{\beta_{\sigma'(N)}}_{\sigma'(N)} \dots P^{\beta_{\sigma'(1)}}_{\sigma'(1)}$ is denoted as

$$\left(R_{\sigma'(1\dots N)}^{\sigma'^{-1}\sigma}\right)^{\sigma(N) \quad \sigma(a+l)=k \quad \sigma(a+1)\sigma(a) \quad \sigma(1) \atop \alpha_{\sigma(N)}\dots\gamma\to\gamma+1\dots\gamma \quad \gamma-1\dots\alpha_{\sigma(1)} \atop \gamma-1\dots\alpha_{\sigma(1)}} . \tag{IV.3}$$

We call the sequence $\{\alpha_{\sigma(l)}\}$ **normal** if it is arranged according to the rules in (III.5), otherwise, we call it **abnormal**.

It is now convenient for us to discuss the non-vanishing condition of the R-matrix element (IV.3). Comparing (IV.3) with (III.14), we find that the difference between them lies in the kth site. Because the group label in the kth space has been changed, the sequence $\{\alpha_{\sigma}\}$ is now a abnormal sequence. However, it can be permuted to the normal sequence by some permutation $\hat{\sigma}_k$. Namely, $\alpha_{\gamma \to \gamma + 1}$ in the abnormal sequence can be moved to a suitable position by using the permutation $\hat{\sigma}_k$ according to rules in (III.5). (It is easy to verify that $\hat{\sigma}_k$ is unique by using (III.5).) Thus, by procedure similar to that in the previous section, we find that when

the R-matrix element (IV.3) is non-vanishing.

Because the non-zero condition of the elementary R-matrix element $R_{ij}^{i'j'}$ is i+j=i'+j', the following R-matrix elements

$$= \sum_{l=1}^{N} E_{(k)}^{\gamma \gamma+1} \otimes_{j \neq k} G_{(j)}^{\gamma \gamma+1}(k, j). \qquad (IV.7)$$

Here in (IV.6) $\hat{\sigma}_k$ is the element of \mathcal{S}_N which permutes the first abnormal sequence in the square bracket of (IV.6) to normal sequence and $G^{\gamma}^{\gamma+1}(i,j)$ in (IV.7) has the following elements: For $1 < \gamma + 1 \le m$,

$$G^{\gamma \gamma+1}(i,j)_{kl} = \delta_{k,l} \begin{cases} (a_{ij})^{-1} & k = \gamma \\ 1 & \text{otherwise} \end{cases}$$

The non-simple generators are generated by the simple generators through the relation

- 1. For m = 0, the gl(m|n) supersymmetric model degenerates to the bosonic gl(n) model, which has been discussed in [6] by Albert et al.

VI The resolution of the gl(m|n) nested Bethe vectors in the F-basis

In this section, we generalize the results in the previous section to the gl(m|n) supersymmetric model. The procedure is similar to that of the gl(2|2) case. Here we only give the final results.

Associated with the (m+n)-dimensional gl(m|n) representation space, we have the orthogonal states $|j>(j=1,2,\ldots,m+n)|$ defined by

VII Discussions

In this paper, we have constructed the factorizing F-matrices for the gl(m|n)-invariant fermion model. In the basis provided by the F-matrix (the F-basis), the monodromy matrix and the creation operators take completely symmetric forms. We moreover have obtained a symmetric representation of the Bethe vector of the system.

Authors in [19] derived a formula that expresses the local spin and field operators of fundamental graded models in terms of the elements of the monodromy matrix. In particular they reconstructed the local operators (E^{ij}) in terms of operators figuring in the gl(m|n) monodromy matrix. This together with the results of the present paper in the F-basis should enable one to get the exact representations of form factors and correlation functions of the supersymmetric fermion models. These are under investigation and results will be reported elsewhere.
