# ON THE INTEGRATION THEORY OF EQUATIONSOFNONHOLONOM IC MECHANICS*

#### Abstract

The paper deals w ith the problem of integration ofequations ofm otion in nonholonom ic system $s$. By m eans ofw ell-know $n$ theory of the di erential equations $w$ ith an invariant $m$ easure the new integrable system $s$ are discovered. A $m$ ong them there are the generalization of Chaplygin's problem of rolling nonsym $m$ etric ball in the plane and the Suslov problem of rotation of rigid body with a xed point. The structure of dynam ics of system $s$ on the invariant $m$ anifold in the integrable problem $s$ is show $n$. Som e new ideas in the theory of integration of the equations in nonholonom ic $m$ echan ics are suggested. The rst of them consists in using known integrals as the constraints. The second is the use of resolvable groups of sym $m$ etries in nonholonom ic system $s$. The existence conditions of invariant $m$ easure $w$ ith analytical density for the di erential equations of nonholonom ic $m$ echanics is given.


## 1. Introduction

The integration theory of equations of $m$ otion for $m$ echanical system $s w$ ith nonholonom ic constraints isn't so com plete as in the case of system $s w$ ith holonom ic constraints. This fact has $m$ any reasons. $F$ irst, the equations of nonholonom ic $m$ echanics have a m ore com plex structure than the Lagrange equations, which describe the dynam ics of system $s$ w ith integrable constraints. For exam ple, a nonholonom ic system can't be characterized by the only function of its state and tim e (cf. [1], ch. XX IV ). Second, the equations ofnonholonom icm echanics have no invariantm easure in the generalcase (a sim ple example is given in section 5). The point is that nonholonom ic constraints $m$ ay be realized by action of com plem entary forces of viscous anisotropic friction w ith a large viscosity coe cient ([3]). $T$ he absence of an invariant $m$ easure is a characteristic property of system $s w$ ith friction. In lim it, the anisotropic friction is com patible w ith the conservation of total energy. B ut asym ptotically stable equilibrium $s$ or lim it cycles $m$ ay arise on the $m$ anifolds of energy levels (cf. [4]), and th is is the reason for nonexistence of additional \regular" integrals of $m$ otion.
$T$ he $m$ ost popular $m$ ethod to integrate the equations of nonholonom ic dynam ics is based on the use of the available rst integrals or the \conservation law s": if a Lie group that acts on a position space preserves the Lagrangian and if vector elds that generate this group are the elds of possible velocities then the equations of $m$ otion have the rst \vector" integral or the generalized integral of kinetic $m$ om ent $[5,6]$. A num ber of problem $s$ of nonholonom ic dynam ics $w$ as solved by this $m$ ethod, am ong them, we note especially C haplygin's problem on an asym m etricalball rolling over a horizontal plane [5].

A ttem pts to generalize the H am ilton \{ Jacobi m ethod to the system s w ith nonholonom ic constraints were non-e ective as well as attem pts to present the equations of nonholonom ic dynam ics in the form of H am iltonian canonicalequations. It tumed out that w th the help of the H am ilton \{ Jacobi

[^0]generalized $m$ ethod it is possible to nd at $m$ ost only som e special solutions of the $m$ otion equations. T his paper contains the detailed analysis of these questions.

A nother general approach to the integration of nonholonom ic equations is based on the theory of Chaplygin's reducing factor (5]): one try to obtain a change of tim e (di erent along di erent trajectories), such that the equations of $m$ otion are presented as Lagrange or $H$ am ilton equations. Though such change exists in exceptional cases only, it allows to solve a num ber of new problem s of nonholonom ic dynam ics (cf. [5]). Let us note that the equations ofm otion som etim es may be reduced to the H am iltonian form by other reasoning (see section 5).

The list of exactly solvable problem s of nonholonom ic dynam ics isn't long: alm ost com plete inform ation $m$ ay be found in the books [1,5,8]. In this work we present som e new integrable problem $s$, consider the characteristic features of behavior of nonholonom ic system $s^{\prime}$ trajectories in the phase space, and propose som e general theoretical reasonings on $m$ ethods of integrating the equations of nonholonom ic dynam ics.

## 2. D i erential equations w ith an integrable m easure

Let us consider a di erential equation

Let us recall the well-known L iouville assertion: a sm ooth function $f: R^{n}!R$ is a density of an invariant

The existence of an invariant $m$ easure simpli es the integration of a di erentialequation; for exam ple, in the case ofn $=2$ the equation is alw ays integrable in quadratures. A coording to Euler, $M$ is also referred to as an integrating factor.

N ow the integrability by quadratures on $\mathrm{E}_{\mathrm{c}}$ follow s from Euler's rem ark. T he rst conclusion of theorem 1 (which was rstly mentioned by Jacobi) is proved by this reasoning. The second conclusion is the well-know n topological fact: any connected, com pact, orientable, two-dim ensionalm anifold that ad$m$ its a tangent eld w thout singular points is di eom onphic to a two-dim ensional torus. The third conclusion is, in fact, the K olm ogorov theorem on reduction of di erential equations on a torus $w$ ith a sm ooth invariant $m$ easure [9].

## 3. S.A.C haplygin's problem

Let us consider as an exam ple the problem of rolling of a balanced, dynam ically non-sym m etric ball on a horizontal rough plane (see [5]). Them otion of the ball is described by the follow ing system of

Rem ark. This assertion is true for integrable problem s of dynam ics of a heavy body $w$ ith a xed point de ned by the system ofEuler-P oisson equations (see [10]). Since the Euler-P oisson emations are $H$ am iltonian, by the Liouville theorem, in integrable cases they alw ays can be reduced to form on two-dim ensional invariant tori. It seem s that equations have no such property; inequality is not ful led on all invariant non-resonant tori.

This result can cause the temptation to use C haplygin's reducing m ultiplier theorem: if we can reduce using change of tim e to the Euler-Lagrange equations of som e variational problem (they are w ritten, as well as the classical E uler-P oisson equations, in redundant variables) then according to the Liouville theorem , the equations of $m$ otion on the two-dim ensional invariant tori in som e angle variables $u$; $v \mathrm{~m}$ od 2 have form It is possible to show that this $m$ ethod does not lead to the goal. In conclusion, note that S.A.Chaplygin him self never considered the problem of the balls rolling in connection w the the reducing multiplier theory.

## 4. A generalization of S A.C haplygin's problem

W e are going to show that the problem of rolling of a balanced, dynam ically non-sym $m$ etric ball on a rough plane is still integrable (in the sense of section 1), if the particles of the ball are attracted by this plane proportionally to the distance. Since the center of $m$ ass of the ball coincides $w$ ith its geom etrical center, we can calculate the potential by the formula

Since equations have the invariant $m$ easure $w$ ith density , they are integrable by theorem 1. It would be interesting to integrate this equation explicitly and test if proposition 3 rem ains true for equations

N ote that the problem of rotation of a body about a xed point in an axisym $m$ etric force eld w ith potential is also integrable ([1]). In addition to the classical integrals $\mathrm{F}_{1}, \mathrm{~F}_{2}, \mathrm{~F}_{3}$, there is the integral $\mathrm{F}_{4}$, where one must put $\mathrm{a}=0$. This integralwas found independently by C lebsh in the problem on $m$ otion of a body in an ideal uid and by T isseran, who investigated rotationalm otion of heavenly bodies.

## 5. G.K.Suslov's problem and its generalization

Follow ing G .K .Suslov ([11], ch. 53), we consider the problem of rotation about a xed point of a body $w$ ith the nonintegrable constraint ha; $!i=0$, where $a$ is a vector that is constant in the $m$ oving fram $e$ of reference. Suppose that the body rotates in an axisym $m$ etric force eld $w$ th the potential $V()$. Follow ing the $m$ ethod of Lagrange $m$ ultipliers, we w rite dow $n$ the equations ofm otion ([11], ch. 46):

G .K .Suslov has considered a particular case of the problem, when the body is not under action of exterior forces: $V \quad 0$. In this case the rst equation of is closed relatively to ! . W e can show that it is integrable by quadratures (see [11], ch.53). T he analysis of these quadratures show s that ifa isn't an eigenvector of the inertia operator, then all tra jectories! ( $t$ ) approach asym ptotically ast! 1 to some xed straight line on the plane ha; ! i= $=0$ (see Fia. 1). C onsequently, the equation $w$ ith respect to ! and com plete system have no invariant $m$ easure $w$ ith continuous density. In this case theorem 1 isn't applicable, so, the question about the possibility to nd the

At $I_{1}=I_{2}$ we have the motion of point in a central eld. This m otion corresponds to the well-known integrable \Lagrange case" of the generalized Suslov problem. A s w ell as in Lagrange's classical problem of a heavy sym $m$ etric top, the equations ofm otion are integrable in this case in elliptical functions oftim $e$. The trajectories of vibrationalm otions, when one of the com ponents $k_{1}$ or $k_{2}$ becom es zero, are especially interesting. Let us consider as an exam ple Suslov's problem in a hom ogeneous force eld in the K harlam ova integrable case. The equations ha; ! i=0 and hI!;bi=0 form an integrable eld of directions on the $m$ anifold of the rigid body positions (on the group $S O$ (3)). Thus, Suslov's problem is reduced in this case to a system w ith one degree of freedom. Though the one-dim ensionalm anifold of states of such system isn't closed in SO (3) in the general case.

If the constraints are non-linear w ith respect to velocities, it is natural to use the energy integral

## 8. Existence of an invariant $m$ easure

The existence ofan integral invariant w ith a positive density is interesting not only from the standpoint of integration of di erential equations. It is interesting by itself, from the standpoint of possible applications, for exam ple, in ergodic theory. W e are going to consider the problem of existence of an invariant $m$ easure for system s of di erentialequations. W e are especially interested in its applications to nonholonom ic $m$ echanics.

By the theorem on recti cation of tra jectories, in a su ciently sm all neighborhood of an ordinary point there always exists an invariant m easure with a sm ooth stationary density. Therefore, the problem of existence of an invariant $m$ easure is especially interesting near equilibrium $s$ as well as in su ciently big dom ains of the phase space, where trajectories have the property of retuming. Let us consider the rst possibility. Let the point $x=0$ be an equilibrium of an analytical system of di erential equations

Let us consider as an exam ple the problem on perm anent rotations of a convex rigid body w ith an analytical convex bound on a horizontal absolutely rough plane (see [4]). The m otion of such body is described by a system of six di erential equations that have the integral of energy and the geom etrical integral. In a particular case, when one of principal central axes of inertia of the body is orthogonal to its surface, we have a one-param eter fam ily of stationary rotations about the vertical axis of inertia. Singular points of equations of $m$ otion correspond to the stationary $m$ otions. The characteristic equation has the follow ing form :

T he dependence of the coe cients $a_{s}$ on num erous param eters of the problem is rather com plicated; practically, they are arbitrary. T he existence of the double zero root is connected with the existence oftw o independent integrals, since the di erentials of the energy integral and of the geom etrical integral are independent in the general case at points that correspond to perm anent rotations. $F$ ixing the levels of the rst integrals we get di erential equations on four-dim ensionalm anifolds that have no invariant $m$ easure w ith an analytical density in the general case. C onsequently, the in itial equations also have no invariant $m$ easure in a neighborhood of stationary $m$ otions.
$N$ ow let us consider the problem of existence of invariant $m$ easure for


Fig. 3 system $s$ of di erential equations that are sim ilar to integrable system $s$ that satisfy the conditions of theorem 1 . It is natural to take the constants of the rst integrals $I_{1} ;::: ; I_{n} 2$ as independent variables in a neighborhood of invariant tori of a non-disturbed integral system and to take angle variables $x ; y \mathrm{mod} 2$ on the invariant tori.
