Statistics of tum bling of a single polymerm olecule in shear ow .

W e present experimental results on statistics of polymer orientation angles relatively to shear plane and tum bling times in shear ow with thermal noise. Strong deviation of probability distribution functions (PDF) of these parameters from G aussian was observed and a good accord with theory was found. The scaling relations of PDF widths for both angles as a function of the control parameter W i are veried and compared with numerics. An universal exponential PDF tail for the tum bling times and its predicted scaling with W i are also tested experimentally against numerics.

D ynam ics and statistics of a single polymer molecule in stationary as well as in random ow's have recently attracted attention of both experimentalists [1{4] and theorists [5{10]. Stretching dynamics and statistics and coil-stretch transition in these ow's were investigated in detail. Besides, another remarkable elect was instrucserved in a shear ow [2], namely large uctuations in a polymerelongation due to end-to-end aperiodic tum bling (see Fig.1D).

Recently rather extensive theoretical [11,12] and numerical [13,14] e orts were conducted with the goal to understand the statistics of the angular orientation of a polymer molecule and of the tum bling time in a random velocity eld with a mean shear. Shear ow with a therm al noise was considered there as a particular case. A role of thermal noise on a solid rod tumbling in a shear ow was rst considered in Ref. [15]. Then the role of the Brownian uctuations in the polymer dynam ics and statistics was studied in num erical simulations [7], where, how ever, only the power spectral density and the statistics of polymer extension in a shear ow were investigated. An average polym er extension and angular orientation were theoretically considered also in Ref. [8], where the results of calculations were compared with light scattering m easurem ents [16,17].

In this Letter we concentrate on statistics of angular orientation and tum bling and scaling relations of their characteristics for a single DNA molecule in a shear ow, when thermal uctuations are the main cause for tum - bling.

It is well known that a probability distribution function (PDF) of the end-to-end vector \mathcal{R} for a polym er described by a dum bbell model with a linear relaxation in a simple shear is G aussian [7]. Nevertheless, PDFs of the polym er extension, \mathcal{R} j R, as well as polym er angular orientation are strongly non-G aussian due to anisotropy introduced by the shear. A functional form of the PDF of the polym er extension in a shear ow was rst identi ed experimentally [2] and then explained theoretically and numerically [7].

The main result of the recent theory [11,12] is the pre-

diction of the interm ittent (non-Gaussian) statistics of polym er angular orientation in a shear ow. Moreover, it was also shown that interm ediate asymptotic of the angular polym er statistics bears som e universal features independent of the nature of polym er random excitation [11,13,14].

The universal features of the orientation statistics are related to a determ inistic nature of the angle evolution at large angles, where a random pum ping can be neglected. Then the theory [11,12] predicts the following results on the angular distributions and tum bling time statistics: W i¹ one gets P () / (sin)², (i) at j j is the width of P(); (ii) at 1 j j where the PDF tail for is determined as P() / j f; both scalings follow from the determ inistic process; (iii) the tail of PDF of tum bling time between two consequent ips, , is exponential at $_{t}$, where $_{t}$ is the characteristic tum bling tim e that is proportional to rel. Thus, the mapr theoretical nding is the interm ittency phenom enon in the statistics of a single polym er tum bling that results in either algebraic or exponential tails of the distribution of polym er angular orientations and tum bling tim es, respectively.

A nother theoretical result veri ed by extensive num ericalsim ulations based on linear dum bbellas wellas FENE models describes the scaling relations for the width of the angular distributions and the characteristic tum bling $tim e w ith W i [11{14}]$. The scaling can be derived by sim ple physical argum ents used by the theory [11,14]. The dynam ic equation for one of the molecule orientation angles (see Fig.1A), namely , in the region of 1 can be written as $\frac{d}{dt} = s \sin^2 + \frac{R_g}{R} (rel)^{1=2}$ [11{14], where R_{q} is the polymer gyration radius, and is the white therm alnoise. In a stationary state one gets from a balance of shear and noise term s the following estimates for the m s of the angular uctuations (or the PDF width),

and). In the linear extension limit, R R_{max} , where R_{max} is the maximum polymer extension, a typical polymer elongation, R, can be estimated as R_g W i that is realized at su ciently smallextensions (up to 20% of R_{max} [1,4]). It leads to [11{14]

In the opposite lim it of a non-linear regime, where typically W i $R_{m ax}=R_{g}$, a stretched polymer can be treated as a rigid rod with R $R_{m ax}$ subjected to the B row nian motion [15]. Then the resulting scaling appears to be strikingly dimerent [11{14]:

The experiments were carried out in a shear ow in two ow con gurations. To measure we used a shear ow in a gap between the at bottom of the uniform ly rotating glass rod of radius $r_1 = 1.5$ mm and a cover slip (see for details of the set-up [4]). The measurements were made at the xed height of 30 m above the cover glass in the region located at radius r ' 700 m, where the main shear occurs in the vertical plane. Then only can be measured in this con guration (see Fig.1B).

To measure a shear boundary layer of a Poiseuille ow in a micro-channel was used. The micro-channel of 500 m wide and 100 m deep was produced from a single cast of a silicon elastom er Polydim ethylsiloxane (PDM S) using the soft lithography m ethod [18]. The measurem ents were carried out at about the m iddle height of the channel in a small region at a distance of

30 m from the channelwall, where only was detected via the cover glass (see Fig.1C).

Particle in age velocin etry (P IV) measurements were conducted with 0.2 m uorescent beads in both ow congurations. In the swirling ow the shear rate in the vertical plane is rather constant at the location of measurements of 30 m (Fig 2A), while the azim uthal veloc-

ments of 30 m (Fig 2A), while the azim uthal velocity in the horizontal plane alm ost independent of radius in the region of measurements (inset in Fig 2A). In the channel ow the longitudinal velocity measured in the horizontal plane changes rather linear in the observation region of 30 m from the wall, while looks fairly constant in the vertical plane at the middle height of the channel within the focus depth (0.4 m) (see Fig 2B). In both cases the measured velocity promess are compared with numerical calculations, and good quantitative agreement is found (solid lines, Fig 2A, B). A limitation to conduct P IV measurements in a vertical plane deeper than 50 m in both geometries is due to the objective working distance that is about 200 m.

As a working uid a bu er solvent [19] with sucrose concentration varied in the range between 47% (w/w) and

67% (w/w) to tune viscosity in the range between $_{\rm s}$ = 0.012 Pa sand_s = 0.24 Pa sat the working tem perature of 22.5 C was used.

To study the tum bling dynam ics and statistics of poly-

mermolecules in a ow 10³ ppm of -DNA molecules, uorescently labelled with YOYO-1 (Molecular Probes) at a dye/base ratio of 1:4 for 1 hour, were added into the solvent. At equilibrium the coiled -DNA has $R_q =$ 0:73 m, while the entire contour length is R_{max} 21 m. So it may be considered as a " exible" polymer with roughly 300 persistence lengths [1]. The maximum relaxation time relevant for further analysis, rel = 11 0:1 sec for a solvent with 62% (w/w) sucrose was found. $_{rel}$ for solvents with di erent sucrose concentrations was taken proportional to its concentration variation [1,2]. Fluorescently labelled DNA molecules were monitored via 63, 1.4NA oil immersion objective (Zeiss) with 0.4 m depth of focus with a homem ade inverted epi- uorescent microscope [4]. Im ages of the molecules were digitized, and their and angles were autom atically measured by approximation of a molecule outline with an ellipse, which m ain axis was used as the end-to-end vector, \tilde{R} , to dene an inclination angle, either or depending on the

ow con guration (see Fig.1A, B, C). This approximation works well for su ciently stretched molecules down to 2 3 m for the main axis. Two time series of di erent scenarios of tumbling that occur in a shear ow are presented in Fig.1D. One mentions that tumbling can take a place via coiled as well as folded states.

In the lower inset in Fig. 3 we present PDFs of for two values of W i. Each plot is based on up to 30,000 points. It is clear seen that at low W = 1.6 PDF can be tted by Gaussian almost entirely, while at high W i = 17.6the PDF tails strongly deviate from the Gaussian. In Fig.3 PDFs for three values of W i are presented in the logarithm ic coordinates. The PDF tails for all values of W i decay algebraically with the exponent rather close to the theoretical, $j j^2$, indicated by a solid line on the plot. The larger W i, the wider the scaling region at the tail as predicted by the theory [11]. Variations in W i values were achieved by viscosity tuning as well as variation in s by changing rotation speed between 0 and 0.7 \sec^{1} . The half-height width of PDFs, , decreases as /Wi^{0:38 0:03} (see the upper inset in Fig.3) in a rather good agreem ent with the recent num erical simulations based on the FENE model [14].

In the same set-up with the rotating rod we measured PDFs of the tumbling time P (), determined in the experiment as time between two following consequent conformations: two coiled, two folded, or coiled and folded ones (see Fig.1D). This tumbling time, , is elongation based time de ned by a certain length threshold $R_{\rm th} > R_{\rm g}$, and it is di erent from that is angular based. The lower the threshold, the higher $_{\rm t}$ [14]. We present in Fig.4 P () for three values of W i together with the exponential ts. Each plot is based on up to 600

points. The same data presented in the log-linear coordinates together with the ts dem onstrate the t quality (inset in Fig.4). Figure 5 shows the characteristic tum bling time, t, obtained from the slopes of the PDF tails, versus ${\tt W}\,$ i. The value $\,_{\rm t}$ depends on the threshold value R_{th}=R_q.W iwas varied in two ways: full squares present the data, where W i was tuned just by viscosity variation (it means the variation of $_{\rm rel})$, and open squares were obtained at di erent W i by adjusting s. By presenting the same data as the ratio $_{rel}=_{t}$ versus W i in the inset in Fig.5 we show, rst, that t is proportional to rel at lower W i, and second, rel=t grows as / W i^{0:54} 0:04 at higher W i in a rather close agreem ent with Eqs.(3,4). W e would like also to point out the fact that the cross-over region for scaling in t takes place at W i' 10 in am azing agreem ent between the experiment and the recent num erical simulations [14]. An obvious shift upwards of the data relatively to the simulations (inset in Fig.5) is explained by about twice smaller value of R_{th} = R_q for determ ination of in the simulations [14].

In Fig.6 PDF of measured in a micro-channel ow at W i = 25 together with the t by (sin)² is shown. It is clear that the PDF maximum is located at $_{\rm t}$ 6 0 but limited angular resolution does not allow us to study its dependence on W i. Similar data on P (), based on 2000-3000 points for each plot, were obtained for several values of W i. The half-height width of PDFs, , as a function of W i is shown in the inset in Fig.6 together with the t and the results of the num erical simulations based on the FENE m odel [14]. The observed scaling / W i ^{0.51} ^{0:04} manifests the cross-over region between / W i ¹⁼³ expected at high W i and W i¹ at lower W i values (see Eq.(3,4)).
