# Chemo-Sensitive Running Droplet

Chem ical control of the spontaneous m otion of a reactive oil droplet m oving on a glass substrate under an aqueous phase is reported. Experim ental results show that the selfem otion of an oil droplet is conned on an acid-treated glass surface. The transient behavior of oil-droplet motion is also observed with a high-speed video camera. A mathematical model that incorporates the elect of the glass surface charge is built based on the experim ental observation of oil-droplet motion. A numerical simulation of this mathematical model reproduced the essential features concerning connement of oil droplet motion within a certain chemical territory, and also its transient behavior. Our results may shed light on physical aspects of reactive spreading and a chemica other spreading things.

### I. IN TRODUCTION

The spontaneous motion of reactive droplets has attracted considerable attention in relation to energy transduction by living organisms, i.e. chem om echanical energy transduction. In 1978, the motion of a droplet driven by a surface-tension gradient was predicted by G reenspan to explain som e aspects of cell cleaving from a physicochem ical view point [1]. Various kinds of droplet motion driven by a surface-tension gradient have been reported since, where the surface-tension gradient was given by an initial [2, 3] or an external [4] asym metry in a surface condition. Spontaneous motion in reactive spreading, or a droplet driven by a self-produced surface-tension gradient, has also been noted in various experimental systems [5, 6, 7, 8, 9, 10, 11, 12, 13]; for example, a droplet of surfactant on a gold surface [5], alloy melting [6], and a water droplet containing silane on a glass substrate [7, 8, 9]. To interpret these phenomena, extensive theoretical studies on reactive droplets have been performed with the lubrication approximation [14, 15, 16].

An oil-water system composed of an organic phase with potassium iodide and iodine and an aqueous phase containing stearyltrim ethylammonium chloride (STAC) exhibits self-agitation at the oil-water interface, accompanied by spatiotem poral instability of interfacial tension [17, 18, 19, 20, 21, 22]. It has also been found that the motion of an oil droplet in an oil-water system exhibits chemo-sensitivity [23]. Based on the measurement of the electrical potential at the oil-water interface in a similar system, the nature of the electrical uctuation/oscillation has been shown to strongly depend on the chemical properties and the concentration [24]. How ever, the detailed mechanism of this electric of chemical substances has not yet been clarified. Recently, it was proposed that an oil-water system also shows reactive spreading on a glass surface with recovery of the surface condition [25, 26].

In the present study, we experimentally observed the chem o-sensitive motion of an oil droplet on a glass substrate that had been partially pretreated with acid. We found that an oil droplet exhibits various behaviors, such as turningback motion, stopping at a certain position, or slowing down around regions treated with acid. In addition, we also noted that the velocity and shape of the oil droplet show dam ped oscillation while the droplet moves continuously. However, detailed observations show that the motion of an oil droplet strongly depends on slight changes in the surface condition of the substrate. In terms of the argument given in our previous study [26], we expect that the chem o-sensitivity of oil-droplet motion is caused by the condition of the glass surface a certed by acid, which inhibits the aggregation of stearyl trimethylam monium ion (STA<sup>+</sup> ion) on the glass surface. To con model successfully reproduces the observed experimental results. Furtherm ore, a numerical simulation of the model reveals that the selection among the turning-back motion, stopping at a certain position, and slowing down can be




FIG.1: Schem atic representation of the experim ental setup (a) on a Y-shaped path on a glass surface, and (b) on an acidtreated narrow glass substrate. Prior to the experim ent, both ends of the narrow glass substrate ( 15 mm) were treated with acid.

explained in term s of the e ect of the acid on the glass substrate, where m inute changes in the acid e ect drastically change the behavior of the droplet. A shasbeen reported previously, the oil-water system exhibits tem poral uctuation in electrochem ical potential, which is sensitive to chem ical stimuli [24]. On the other hand, the present study shows s that it may be possible to acquire spatio-tem poral information on m inute changes in the chem ical concentration on a surface by noting a drastic change in the characteristic motion of a self-running oil droplet. This result may be associated with the mechanism of chem otaxis in biological systems, where living organisms show extrem e sensitivity to a small spatial gradient in chem icals [27, 28].

# II. EXPERIMENTS

The aqueous phase contained 1 m M STAC and the organic phase was 5 m M iodine solution of nitrobenzene saturated with potassium iodide. STAC was prepared by recrystallization using acetone. For glass substrates, we used m icro slide glass (M atsunam i, O saka; S9111). The glass surface was treated with acid as follows. First, 1 M sulfuric acid solution was dabbed on the glass substrate with a cotton swab, and then it was rinsed from the surface with running distilled water. Extrem e care was taken in rinsing to avoid invading the bare glass surface.

In the measurement on a Y-shaped path, 100 lof the oil was placed in an aqueous phase on the pretreated glass




FIG.2: Experiments on spontaneous droplet motions. (a) Conned motion of an oil droplet. The path of an oil droplet (100 ) was enclosed within the acid-treated surface. The left in age shows the actual appearance of a substrate. The outside of the Y-shaped region was treated with acid. In the middle in age, the path of the CM of an oil droplet is shown. The superposition of both in ages is shown on the right. (b), (c) Motion of a 15-loil droplet on a narrow acid-treated glass substrate. An in age from the experiment and a spatio-tem poral in age of oil-droplet motion are shown. An oil droplet showed (b) shuttling motion and (c) intermittent shuttling motion. When an oil droplet did not intrude into the acid-treated region it showed turning-back motion, which resulted in shuttling motion.

substrate [Fig. 1(a)]. A digital video cam era (Panasonic; NV-GS100K-K) was used to record the motion of an oil droplet at 30 fram es per second.

In the experim ents on an acid-treated narrow glass substrate, the glass substrate (1 mm 52 mm 3.1 - 3.2 mm)was cut from slide glass. Both ends of this substrate were pretreated with acid for 15 mm [Fig. 1(b)]. An oil droplet of 15-60 1 was placed on the substrate in the sam e m anner as in the Y-shaped path experiment. The motion of an oil droplet was recorded by a high-speed video cam era (RedLake MASD Inc.,San Diego, CA; Motion Scope PCI) at 125 fram es per second. All measurements were carried out at room temperature (20 C 3 C). The recording of a droplet motion was digitized by an image-processing system (Library, Tokyo).




FIG.3: Experiments on spontaneous droplet motion. Motion of a 15-loil droplet on a narrow acid-treated glass substrate. An image from the experiment and a spatio-tem poral image of oil-droplet motion are shown. An oil droplet showed (a) stopping and (b) slowing. When an oil droplet intruded into the acid-treated region, it showed stopping (a) or slowing (b).

## III. RESULTS




FIG.4: Time trace of the apparent length, r, and velocity, v, of an oil droplet for the motion shown in Fig.2(c).

The spontaneous motion of an oil droplet was found to be conned within a Y-shaped path and a narrow substrate [Figs. 2, 3]. On the Y-shaped path [Fig. 2(a)], motion is clearly limited to within the region that was not treated with acids. On the narrow substrate, oil droplets exhibit quasil-dimensional motion [26], i.e. an oil droplet of 15 l show ed turning-back motion that resulted in a shuttling motion [Fig. 2(b), (c)] when the oil droplet could not intrude into the acid-treated region. The time trace of oil-droplet velocity v and the apparent length of an oil droplet r in the motion shown in Fig. 2(b) are plotted in Fig. 4. v and r show ed dam ped oscillation after each returning motion until both reached steady values. On the other hand, when an oil droplet of 15 l intruded into the acid-treated region, the oil droplet stopped and stood still [Fig. 3(a)] or slow ed down [Fig. 3(b)]. The motion of an oil droplet was found to be sensitively dependent on the manner of acid treatment.

### IV. DISCUSSION

It has been suggested by our previous study [26] that the motion of an oil droplet can be explained in terms of reactive spreading [15]. STA<sup>+</sup> ions in the aqueous phase aggregate on the glass surface that has negative charges at neutralpH [29]. The organic phase dissolves STA<sup>+</sup> ions that have adhered to the glass substrate, and this dissolution




FIG.5: Schem atic diagram of oil-droplet motion and glass surface conditions. STA<sup>+</sup> is represented as a hydrophobic bar with a hydrophilic head.

is promoted since STA<sup>+</sup> and  $I_3$  in the organic phase make an ion-pair. The ion-pair dissolves well in non-polar solvent, i.e. the organic phase. Therefore, a di erence in interfacial energy arises from the di erence in the concentration of STA<sup>+</sup> ions on the glass surface between the front and back of an oil drop let [Fig. 5], and the oil drop let is driven by M arangonie ect. Thus, the condition of the glass surface on which STA<sup>+</sup> ions aggregate plays an important role in the motion of an oil drop let.

Nakata and cow orkers exam ined the chem o-sensitivity of the motion of an oil droplet escaping from acids [23]. In




FIG. 6: Schem atic diagram of the model of oil-droplet motion on a glass surface. The lower arrow represents the spatial coordinate, where 0 to 0 and 0 to 1 are treated with acid.  $u_0$  and  $u_1$  are the saturated concentration of the STA<sup>+</sup> ions on the glass substrate on bare and acid-treated glass substrate, respectively. The oil droplet is modeled as two lines (perpendicular to the x-axis), with a mass density of , connected to a spring with an elastic constant of  $(r_0)$  (see also Appendix A)

their experiment, hydrochloric acid was injected in the aqueous phase while an oil droplet was moving. From the above discussion, modi cation of a glass surface by acids signi cantly a ects oil-droplet motion. It has been reported that the point of zero charge  $(pH_0)$  of the SiD<sub>2</sub> surface is around 2.2 [30, 31]. Thus, the glass surface charge m ay have been partially reversed to be positive due to the e ect of acid since the pH of 1M sulfuric acid is around 0. We can consider that this results in fewer adsorption sites for STA<sup>+</sup> ions on the glass surface. This may explain why an oil droplet showed con ned motion [Fig.2(a)] and shuttling motion [Fig.2(b)] on an acid-treated glass substrate when it was encircled by an acid-treated glass surface. Furthermore, the dependence of droplet motion on the condition of the acid-treated region can be attributed to the di erence in the number of adsorption sites on the glass substrate much more accurately. On the other hand, in the experimental process, these di erent types of the characteristic motions were observed even under nearly identical conditions, including the concentration and duration of treatment with sulfuric acid. To understand this strong dependence on the condition of an arrow substrate.

There m ay be various ways to theoretically analyze for the spontaneous m otion of an oil droplet, such as interface dynam ics based on Young's equation [14, 15] or a hydrodynam ic approach which adopts the lubrication approxim ation [16]. Instead of m aking a detailed m odel, we propose a simple \beads-spring" m odel for an oil droplet to abstract the essential features of droplet m otion.

### V. MODELING

Since we want to know the basic mechanism of the motion of an oil droplet on a glass substrate, we make a simple one-dimensionalmodel. The x axis is set along the surface of the glass substrate. The droplet proceeds on a line with stretching and shrinking. The positions at the both ends of the droplet are set as  $x_1$  (t) and  $x_2$  (t), where  $x_1 < x_2$ . The concentration of STA<sup>+</sup> ions on the glass surface is set as u (x;t). The dynamics of  $x_1$  and  $x_2$  are written as follows:

where ,  $_0$ , and  $r_0$  correspond to the mass of the oil droplet reduced to two lines, a viscous damping coe cient and the characteristic size of the oil droplet, respectively. ( $r_0$ ) is the elastic constant of the oil droplet with characteristic size  $r_0$  (see Appendix A):

E (u) is the surface energy of the glass surface modulated by the STA<sup>+</sup> ions adsorbed on it:

where  $e_0$ , a and n are positive constants. On the other hand, the dynam ics of u can be written as follows:

where d is the di usion constant of the STA<sup>+</sup> ions on the glass surface. F ( $u_{i}x_{i}x_{1}$  (t);  $x_{2}$  (t);  $a_{0}$ ) corresponds to the desorption of STA<sup>+</sup> ions from the glass surface to the oil droplet. For this term, we assume the following description:

where  $k_1$ ,  $k_2$ ,  $u_0$ , ' and '\_0 are positive constants that correspond to the desorption rate, the adsorption rate, the saturated concentration of STA<sup>+</sup> ions on the glass surface, the length of the glass substrate, and the length of the glass substrate treated with acid, respectively (see Fig. 6 and Appendix B). The initial and boundary conditions are




FIG. 7: Spatio-tem poralplot of the oscillatory motion of a droplet given by numerical calculations using Eqs. (11) - (18). Only the parameter  $U_1$  was changed: (a)  $U_1 = 0.65$  and (b)  $U_1 = 0.658$ . The other parameters are = 0.2,  $R_0 = 0.05$ ,  $E_0 = 5$  10<sup>5</sup>, A = 1, n = 4, W = 0.1, D = 2.5 10<sup>5</sup>,  $L_0 = 0.25$ ,  $U_0 = 1$ ,  $K_2 = 1$ ,  $K_3 = 1$ ,  $X_{10} = 0.23$ , and  $X_{20} = 0.27$ . The thick lines along the x axis correspond to the regions treated with acid.




FIG.8: Spatio-tem poral plot of the slow ing of a droplet in the acid-treated region given by num erical calculations using Eqs. (11) - (18). Only the parameter  $U_1$  was changed: (a)  $U_1 = 0.68$  and (b)  $U_1 = 0.75$ . The other parameters are the same as those in Fig. 7. The thick lines along the x axis correspond to the regions treated with acid.

VI. NUMERICAL RESULTS

W e perform ed a num erical simulation using Eqs. (11) - (15) under the initial and boundary conditions shown in Eqs. (16) - (18).

We only changed the parameter  $U_1$ , while all of the other parameters are xed. It is noted that  $U_1$  corresponds to the saturated concentration at the region treated by acid. Spatio-tem poralplots of the droplet given by the num erical calculations are shown in Figs. 7 and 8.




FIG.9: Tem poral changes in (a) the length  $X_1 = X_2$  and (b) the velocity of the oil droplet undergoing the oscillatory motion shown in Fig. 7 (b). The high-frequency oscillation is attributed to the eigen-frequency of the mathematical model that did not appear in the experimental results.

W hen  $U_1$  is small enough, i.e., it is di cult for STA<sup>+</sup> ions to adsorb to the acid-treated region, the oil droplet m oves back and forth inside the untreated region, as shown in Fig. 7(a). A s  $U_1$  increases slightly, the oil droplet does not turn back quickly but rather rests at the border between the acid-treated region and the untreated region. A fler a brief stop, it begins to m ove backward, and this interm ittent shuttling m otion is repeated as shown in Fig. 7(b). For m uch larger  $U_1$ , the oil droplet does not go back any m ore, as shown in Fig. 8. The oil droplet goes into the acid-treated region and it continues to m ove very slow ly or stops according to the value of  $U_1$ .

These di erences in the characteristics of the motion of an oil droplet are seen only with slight di erences in  $\Psi$ . Thus, the num erical results suggest that a slight uctuation in acid treatment can cause a dramatic change in the characteristics of the motion of an oil droplet. In the experiments, the oscillatory motion shown in Fig. 2 (b), the stopping of the droplet at the border shown in Fig. 3 (a), and the slow motion in the acid-treated region shown in Fig. 3 (b) were observed under almost the same conditions. We can guess that the various kinds of motion observed in the experiments are due to slight di erences in the acid treatment of the glass. We have also noted that interm ittent-oscillatory motion (Fig. 7(b)) and stopping (Fig. 8(a)) does not appear without a di usion term in Eq. (5). This suggests that the di usion on a glass surface has a signi cant e ect in the real experimental system. There have been several studies concerning the e ect of di usion on the motion of a self-running droplet [16, 32, 33]. Thiele et al. [16] stated that in their model a running droplet can be stopped by increasing the e ect of a surfactant di usion on a substrate. In our study, the di usion of surfactant on the glass substrate is not large enough to stop the motion of a droplet. How ever, at the boundary of the acid-treated region where an oil droplet stopped, the concentration of the surfactant on the acid-treated region is in equilibrium with the di used surfactant from the non-treated region. Thus, the e ect of di usion is optimized by the inhom ogeneity in the glass surface so that an oil droplet stopps its motion.

Figure 9 shows (a) the norm alized length and (b) the velocity of an oil droplet. W hen the velocity of the oil droplet is large, the length of the droplet increases, and vice versa, which well corresponds to the actual experimental trend (Fig. 4).

### VII. CONCLUSION

In the present study, we investigated the self-running motion of an oil droplet on an acid-treated glass substrate. In these experiments, the oil droplet undergoes either oscillatory motion within the untreated region or stopping/slowing at the border between the acid-treated region and the untreated region. We made a simple \beads-spring" model and performed numerical calculations, which suggest that a slight dimension. We made a simple \beads-spring model and region can cause a dramatic change in the characteristics of this motion. The numerical results well reproduced the experimental results. In particular, the numerical results suggest that a slight dimension acid treatment can cause a dramatic change in the motion of an oil droplet. The results with the model also suggest that dimension on the glass surface plays an important role in the spontaneous motion of a droplet. The inhom ogeneity of the glass surface, i.e. the boundary of the surface condition, optimizes the end of a usion.

In this study, an oil droplet avoided the area that was treated with acid. It is possible that some other chem icals m ay attract an oil droplet. A bove all, the present results showed that a running droplet senses inform ation regarding a m inute variation in the chem ical concentration in space by showing a drastic change in its motion. Thus, this result m ay inspire studies on chem otaxis and chem osensitivity in chem istry as well as biology.




FIG.10: Schem atic representation of the fram ework of the \beads-spring" model. The hem isphere-shaped oil droplet as shown in (a) is regarded as a rectangular solid. Since we consider only the x dimension, the conservation law for the volume corresponds to the elastic constant of the spring.

### APPENDIX A: VALIDITY OF THE BEADS-SPRING MODEL

We discuss here the validity of the beads-spring model for an oil droplet. As shown in Fig. 10, we assume that the droplet is shaped as a rectangular solid, whose length, width and height are r, w, and h, respectively. The volume of the droplet is conserved:

The main terms of the energy of the droplet are due to gravity and interfacial tension:

where is the interfacial tension, is the density, m is the mass of the drop let, and g is the gravitational acceleration.

From the above discussion, we can regard the oil droplet as two beads connected with a spring whose elastic constant is proportional to the inverse of the characteristic size of the droplet.

The spring constant is on the sam e order of magnitude even if the shape of the droplet is regarded as a cap-like or ribbon-shaped droplet.

APPENDIX B: MODEL OF THE ADSORPTION /DESORPTION PROCESS ON A GLASS SURFACE.

The e ect of acids is thought to result in a decrease in the number of adsorption sites  $X_{sur}$  for STA<sup>+</sup> ions [29]. A ssum ing that adsorption-desorption is a langmuir isotherm al process,

Since  $m_0$  is the total density of adsorption sites on the glass surface, x is the density of free adsorption sites, and u is the concentration of STA<sup>+</sup> ion in the aqueous phase, the surface concentration  $u_{sur}$  of STAX sur under aqueous phase changes according to

where we assume that  $x + u_{sur} = x_0$ , and k and k<sup>1</sup> are reaction constants in Eq. (B1). The e ect of acid is included in the decrease in  $x_0$ , which is equivalent to the decrease in  $u_0$  to  $u_1$  in the acid-treated region in Eq. (6).

W e assume that the reaction proceeds only from left to right. Therefore, u<sub>sur</sub> changes according to

where v represents the concentration of  $I_3$  in an oil droplet, and  $\hat{k}$  represents the reaction constant. This equation, again, is equivalent to Eq. (6).
