# Stability analysis of dynam ical regim es in non linear system $s w$ ith

#### Abstract

W e present a theorem that allow s to sm plify linear stability analysis of periodic and quasiperiodic nonlinear regim es in $N$-particle $m$ echanical system $s$ (both conservative and dissipative) $w$ ith di erent kinds of discrete sym $m$ etry. This theorem suggests a decom position of the linearized system arising in the standard stability analysis into a num ber of subsystem $s$ whose dim ensions can be considerably less than that of the full system. A s an exam ple of such sim pli cation, we discuss the stability of bushes of m odes (invariant $m$ anifolds) for the Ferm iP asta-U lam chains and prove another theorem about the $m$ axim aldim ension of the above $m$ entioned subsystem $s$.

## I. $\quad \mathbb{N}$ TRODUCTION

D i erent dynam ical regim es in a m echanical system with discrete-sym $m$ etry group $G_{0}$ can be classi ed by subgroups $G_{j} \quad G_{0}$ of this group [1, 2, 3]. A ctually, we can nd an invariant $m$ anifold corresponding to each subgroup $G_{j}$ and decom pose it into the basis vectors of the irreducible representations of the group $G_{0}$. As a result of this procedure, we obtain a bush of $m$ odes (see above cited papers) which can be considered as a certain physical ob ject in geom etrical, as well as dynam ical sense. T he m ode structure of a given bush is fillly determ ined by its sym metry group $G_{j}$ and is independent of the speci c type of interparticle interactions in the system. In $H$ am iltonian system $s$, bushes ofm odes represent dynam icalob jects in which the energy of initial excitation tums out to be \trapped" (this is a phenom enon of energy localization in the $m$ odal space). T he num ber of $m$ odes belonging to a given bush (the bush dim ension) does not change in tim e, while am plitudes of the m odes do change, and we can nd dynam ical equations determ ining their evolution.

Being an exact nonlinear excitation, in the considered $m$ echanical system, each bush possesses its ow $n$ dom ain of stability depending on the value of itsm ode am plitudes. B eyond the stability threshold a phenom enon sim ilar to the param etric resonance occurs, the bush loses its stability and transform s into another bush of higher dim ension. This process is accom panied by spontaneous low ering of the bush sym m etry: $G_{j}!G_{j}$, where $G_{j} \quad G_{j}$.

The concept of bushes of $m$ odes was introduced in [1, 2], the detailed theory of these dynam ical ob jects was developed in [3]. Low-dim ensional bushes in m echanical system $s$ $w$ ith various kinds of sym $m$ etry and structures w ere studied in $[1,2,3,4,5,6,7,8,6]$. T he problem of bush stability w as discussed in [3,7,8, 9]. T w o last papers are devoted to the vibrationalbushes in the Ferm iP asta-U lam (FPU) chains.
$N$ ote that dynam icalob jects equivalent to the bushes ofm odes w ere recently discussed for the m onoatom ic chains in the papers of di erent authors $10,11,12,15]$. Let us em phasize that group-theoretical $m$ ethods developed in our papers [1, 2, 3] can be applied e ciently not only to the $m$ onoatom ic chains (as was ilhustrated in $[8,9]$ ), but to all other physical system $s$ w ith discrete sym $m$ etry groups (see, [1, 2, $3,4,5,6,7]$ ).

In this paper, we present a theorem which can sim plify essentially the stability analysis of the bushes of $m$ odes in com plex system $s w$ ith $m$ any degrees of freedom. The usefulness of this theorem is illustrated w ith the exam ple of nonlinear chains $w$ ith a large num ber
of particles. $N$ ote that the sm pli cation of the stability analysis in such system s actually originate from the well-known W igner theorem about the block-diagonalization of the m atrix com $m$ uting $w$ ith all $m$ atrices of a representation of a given sym $m$ etry group.

In Sec . Il we start w ith the sim plest exam ples for introducing basic concepts and ideas. In Sec III, we present a general theorem about invariance of the dynam icalequations linearized near a given bush w ith respect to the bush sym $m$ etry group. In Sec IV, we prove a theorem which tums out to be very useful for splitting the above $m$ entioned linearized dynam ical equations for $N$-particle $m$ onoatom ic chains. Som e results on the bush stability in the FPU chains are discussed in Sec $V$.

## II. SOMESIMPLE EXAMPLES

A. FPU-chains and their sym m etry

W e consider longitudinal vibrations of $N$-particle chains of identicalm asses ( $m=1$ ) and identical springs connecting neighboring particles. Let $x_{i}(t)$ be the displacem ent of the $i-$ th particle ( $i=1 ; 2 ;:: ; i N$ ) from its equilibrium position at a given instance $t$. D ynam ical equations of such m echanical system (FPU-chain) can be written as follow s:

The nonlinear force $f(x)$ depends on the deform ation $x$ of the spring as $f(x)=x+x^{2}$ and $f(x)=x+x^{3}$ for the FPU - and FPU - chains, respectively. W e assum e the periodic boundary conditions

to be valid. Let us also introduce the \con guration vector" X ( t$)$ which is the N -dim ensional vector describing all the displacem ents of the individual particles at the $m$ om ent $t$ :

In the equilibrium state, a given chain is invariant under the action of the operator a which shifts the chain by the lattioe spacing a. This operator generates the translational group

where $E$ is the identity elem ent and $N$ is the order of the cyclic group $T_{N}$. The operator a induces the cyclic perm utation of all particles of the chain and, therefore, it acts on the \oon guration vector" X (t) as follow s:


The full sym $m$ etry group of the $m$ onoatom ic chain contains also the inversion ${ }^{\wedge}$, w ith respect to the center of the chain, whid acts on the vector X ( t ) in the follow ing m anner:

The com plete set of all products $\mathrm{a}^{\mathrm{k} \wedge}$ of the pure translations ${ }^{\text {ct }}(\mathrm{k}=0 ; 1 ; 2 ;:: ; \mathrm{N} \quad 1)$ w ith the inversion ^ form $s$ the $s o$-called dihedral group $D_{N}$ which can be written as the direct sum of two cosets $\mathrm{T}_{\mathrm{N}}$ and $\mathrm{T}_{\mathrm{N}} \quad \wedge$ :

W ew illconsider di erent vibrationalregim es in the FPU chains, which can be determ ined by the speci c form s of the con guration vector. Each of these regim es depends on $m$ independent param eters ( $m \quad N$ ) and this num ber is the dim ension of the given regin e.

T he sim plest case of one-dim ensionalvibrational regim es represents the so-called mode (zone boundary m ode) [21]:

where $A(t)$ is a certain function of $t$. In our term inology, this is the one-dim ensional bush B [ $\left.a^{2} ;{ }^{\wedge}\right]$ (see below about notation of bushes ofm odes).

The vector

represents a two-dim ensional vibrational regim e that is determ ined by two tim e-dependent functions A ( $t$ ) and $B(t)$. This is the two-dim ensionalbush $B\left[a^{6} ; a^{\wedge}\right]$ (see $\left.\mathbb{I}\right]$ ).

In general, for $m$-dim ensional vibrational regin $e$, we write $X(t)=C(t)$, where the N -dim ensional vector $\mathrm{C}(\mathrm{t})$ depends on m tim e-dependent fiunctions only. Each speci c dynam ical regim eC ( $(t)$, being an invariant $m$ anifold, possesses its ow $n$ sym $m$ etry group that is a subgroup of the parent sym $m$ etry group $G_{0}=D_{N}$ of the chain in equilibrium .
B. FPU- chain with $N=4$ particles: existence of the bush $B\left[\hat{a}^{2} ; \wedge\right]$

Let us consider the above discussed equations for the sim plest case $N=4$. D ynam ical equations (1) read:

H ereafter, we write generators of any sym metry group in square brackets, while all its elem ents (if it is necessary) are given in curly brackets.

The operators a and $\wedge$ act on the con guration vector $X=f x_{1} ; x_{2} ; x_{3} ; x_{4} g$ as follow $s$

Therefore, we can associate the follow ing $m$ atrioes $M$ ( $\Delta$ ) and $M(\uparrow)$ of the $m$ echanical representation w ith these generators:

Their action on the con guration vector X is equivalent to that of the operators a and $\wedge$, respectively.

Let us now make the transform ations of variables in the system (9) according to the action of the $m$ atrioes (10), i.e.

It is easy to check that both transform ations (11) and (12) produce system s of equations which are equivalent to the system (9) . M oreover, these transform ations act on the individual equations $u_{j}(j=1 ; 2 ; 3 ; 4)$ of the system (9) exactly as on the com ponents $x_{j}(j=1 ; 2 ; 3 ; 4)$ of the con guration vector X. For exam ple, for the operator^^(orm atrix M ( ) ) we have

It is obvious that a certain transposition of these equations multiplied by 1 w ill indeed, produce a system fiully identical to the original system (9). Thus, we are convinced that the sym $m$ etry group $G_{0}=D_{4}$ of our chain in equilibrium tums out to be the sym $m$ etry group (the group of invariance) of the dynam ical equations of this m echanical system .

Let us now consider the vibrational regin e (7), i.e. mode, and chedk that it represents an invariant $m$ anifold for the dynam ical system (9). Substituting $x_{1}(t)=x_{3}(t)=A(t)$, $x_{2}(t)=x_{4}(t)=A(t)$ into $(\theta)$, we reduce these equations to one and the sam e equation of the form

In the case of the FPU - m odel this equation tums out to be the equation of ham onic oscillator (for the FPU - m odel it reduces to the D $u n g$ equation). Indeed, for the FPU chain, we obtain from the Eq.(13):

U sing, for simplicity, the initialcondition $A(0)=C_{0}, A-(0)=0$, we get the follow ing solution to Eq. (14) :

Thus, the one-dim ensional bush $B\left[a^{2} i^{\wedge}\right]$ (or mode) for the FPU - chain, represents purely harm onic dynam ical regim e

On the other hand, the invariant manifold $X(t)=f A(t)$; $A(t) ; A(t) ; A(t) g$, corresponding to the bush $B\left[a^{2} ; \wedge\right]$, can be obtained w th the aid of the group-theoreticalm ethods
only, w ithout consideration of the dynam icalequations (9). Let us discuss this point in $m$ ore detail.

At an arbitrary instant $t$, the displacem ent pattem fA $(t)$; $A(t) ; A(t)$; $A(t) g$ possesses五s ow $n$ sym m etry group $G=D_{2} \quad G_{0}=D_{4}$. Indeed, this pattem is conserved under inversion ( ) and under shifting all particles by 2a. T he latter procedure can be considered as a result of the action on the chain by the operator $a^{2}$. These two sym metry elem ents ( $\hat{a}^{2}$ and ${ }^{\wedge}$ ) determ ine the dihedral group $D_{2}$ which is a subgroup of order tw o of the original group $\mathrm{G}_{0}=\mathrm{D}_{4}$ [22].

It is obvious, that the old elem ent a of the group $G_{0}$, describing the chain in equilibrium, does not survive in the vibrational state described by the pattem 77) . N ote that this elem ent (a) transform $s$ the regim e (7) into its equivalent (but di erent!) form f $A(t) ; A(t) ; A(t) ; A(t) g$. In the present paper, we will not discuss di erent equivalent form $s$ of bushes of $m$ odes (a detailed consideration of this problem can be found in [G]). Thus, we encounter the reduction of sym metry $G_{0}=D_{4}!G=D_{2}$ when we pass from the equilibrium state to the vibrational state (7) for the considered m echanical system .

The dynam ical regim e (7) represents the one-dim ensional bush consisting of only one
 the group of the bush sym $m$ etry is indicated by listing its generators ( $\mathrm{a}^{2}$ and ${ }^{\wedge}$, in our case), while the characteristic fragm ent of the bush displacem ent pattem is presented next to the colon. The bush sym $m$ etry group $G$ filly determ ines the form (displacem ent pattem) of the bush B [G] (see, for exam ple, [3, 9$]$ ). Indeed, in the case of the bush $B\left[a^{2} ;{ }^{\wedge}\right]$, it is easy to show that this form, $X=f A(t) ; A(t) ; A(t) ; A(t) g$, can be obtained as the general solution to the follow ing linear algebraic equation representing the invariance of the con guration vector $X: g_{1} X=X, g_{2} X=X, w h e r e g_{1}=\hat{a}^{2}$ and $g_{2}=\wedge$ are the generators of the group $G$. In our previous papers we often w rite these invariance conditions for the bush $B$ [ $G$ ] in the form

It is very essential, that the invariant vector $X(t)$, which was found in such geom etrical (group-theoretical) $m$ anner, tums out to be an invariant $m$ anifold for the considered dynam ical system [3]. Thus, we can obtain the sym $m$ etry-determ ined invariant $m$ anifolds (bushes of $m$ odes) $w$ ithout any inform ation on intenparticle interactions in the $m$ echanical system .

C. FPU - chain w ith N = 4 particles: stability of the bush B [ [A ' ;^ ]

W e now tum to the question of the stabillty of the bush $B\left[\hat{a}^{2} ; \wedge\right]$, representing a periodic vibrational regim e $X=f A(t)$; $A(t) ; A(t) ; A(t) g$, with $A(t)=G \cos (2 t)$. A ccording to the conventional prescription, wem ust linearize the dynam icalsystem (9) in the in nitesim al vicinity of the given bush and then study the obtained system. For this goal, let us w rite

It easy to check that $m$ atriges $L$ and $M$ com $m$ ute $w$ ith each other: $L \quad M=M \quad L$. Therefore, there exists a tim e-independent orthogonalm atrix $S$ that transform $s$ the both $m$ atriges $L$
 $w$ ith respect to $S$ ). In tum, it $m$ eans that the Jacobim atrix $J(t)$ can be diagonalized at any
tim e t by one and the sam e tim e-independent $m$ atrix $S$. T herefore, our linearized system (20) for the considered bush B $\left[a^{2} ;{ }^{\wedge}\right]$ can be decom posed into four independent di erential equations.

Let us discuss how the above matrix $S$ can be obtain with the aid of the theory of irreducible representations of the sym $m$ etry group $G$ (in our case $G=D_{2}$ ).

In Sec IV, we will consider a generalm ethod for obtaining the $m$ atrix $S$ which reduces the Jacobim atrix $J(t)$ to a block-diagonal form. This $m$ ethod uses the basis vectors of irreducible representations of the group $G$, constructed in them echanical space of the considered dynam ical system. In our sim plest case of the monoatom ic chain with $N=4$ particles, this $m$ ethod leads to the follow ing result

The row s of the $m$ atrix $S$ from (23) are sim ply the characters of four one-dim ensional irreducible representations (irreps) \{ $1,2,3,4$ \{ of the A belian group $D_{2}$, because each of these irreps is contained once in the decom position of the $m$ echanical representation of the group $G=D_{2}$. Introducing new variables $y=f y_{1} ; y_{2} ; y_{3} ; y_{4} g$ instead of the old variables

$W$ ith the aid of Eqs. (24), we can nd the stability threshold in $C_{0}$ for loss of stability of the one-dim ensional bush B $\left[a^{2} ; \wedge\right]$. Indeed, according to Eqs. [24), the variables $y_{j}(t)$ ( $j=1 ; 2 ; 3 ; 4$ ) are independent from each other, and we can consider them in tum. Eq. In such a way we can nd that critical value $C_{C}$ for the amplitude $C_{0}$ of the given bush for which it loses its stability is $\mathrm{C}_{\mathrm{C}}=0: 303$.

In conclusion, let us focus on the point that tums out to be very im portant for proving the general theorem in Sec ITI. The system (19) was obtained by linearizing the original system (9), near the dynam icalregim eC ( $t$ ) $=\mathrm{fA}(\mathrm{t})$; $\mathrm{A}(\mathrm{t}) ; \mathrm{A}(\mathrm{t})$; $\mathrm{A}(\mathrm{t}) \mathrm{g}$, and Eqs (G) are invariant w ith respect to the parent group $G_{0}=\left[a_{i} ;^{\wedge}\right]$. D espite this fact, Eqs . (19) are invariant only
 a $2 \mathrm{G}_{0}$ (aswellas $\hat{a}^{3}$, $\hat{a}^{\wedge}, \hat{a}^{3} \wedge$ ) does not survive as result of the sym $m$ etry reduction $G_{0}$ ! $G$. Indeed, acting on Eqs. (19) by the operator $\hat{g}=\mathrm{a}$, which transposes variables $j$ as follow $s$

W hat is the source of this phenom enon? The originalnonlinear dynam ical system, which can be written as $X=F(X)$, is invariant under the action of the operator $g=a$. Being linearized, by the substitution $X(t)=C(t)+\quad(t)$ and neglecting all the nonlinear in $j(t)$

A s a consequence, we cannot diagonalize both $m$ atrices $L$ and $M \operatorname{sim} u l t a n e o u s l y$, i. e. w ith the aid of one and the sam e orthogonalm atrix S. Therefore, it is im possible to diagonalize the Jacobim atrix $J(t)$ in equation $=J(t)$ for all timet. In other words, there are no such $m$ atrix $S$ that com pletely splits the linearized system for the bush $B\left[a^{2} ; \wedge\right]$ for the chain w th $\mathrm{N}=6$ particles.

This di erence between the cases $N=4$ and $N=6$ (generally, for $N>4$ ) can be explained as follow s. The group $G=\left[a^{2} ; \wedge\right]$ of the considered bush, in fact, determ ines di erent groups for the cases $N=4$ and $N=6$. The latter group $\left(D_{3}\right)$ is non-A belian $\left({ }^{A} a^{4}=a^{2 \wedge}\right)$, unlike the group $D_{2}\left(\hat{a}=a^{2 \wedge}\right)$ and, as a consequence, it possesses not only one-dim ensional irreducible representations, but tw o-dim ensional irreps, as well. It will be show $n$ in $\operatorname{Sec}$ IV, that precisely this fact does not perm it us to split fully the above discussed linearized system [23].

In spite of this di culty, we can sim plify the linearized system $=J(t) \quad$ considerably w th the aid of som e group-theoretical m ethods, which are discussed in the two follow ing sections. N ow, we only would like to present the nal result of the above splliting for the case $N=6:$

$N$ ote, that the stability of the $m$ ode (the bush $B\left[a^{2} ;^{\wedge}\right]$ ) was discussed in a num ber of papers $18,19,20,8,9,10,12,13,14,15]$ by di erent $m$ ethods and $w$ ith an em phasis on di erent aspects of this stability. In particular, in our paper [8], a rem arkable fact was revealed for the FPU - chain: the stability threshold of the m ode is one and the sam e for interactions $w$ th all the other $m$ odes of the chain. (For other one-dim ensional nonlinear modes, for both the FPU - and FPU - chains, the stability thresholds, determ ined by interactions $w$ ith di erent $m$ odes, are essentially di erent [9]).

## III. THE GENERALTHEOREM AND ITSCONSEQUENCE

W econsider an N -degrees-of-freedom m echanicalsystem that described by N autonom ous di erentialequations

An exam ple of such noncomm utativity and the source of this phenom enon were presented in Sec IIC.

## C onsequence of Theorem 1

Taking into account $T$ heorem 1, we can apply the well-known $W$ igner theorem [17] to split the linearized system $=J(t)$ into a certain number of independent subsystem $s$. Indeed, according to this theorem, the $m$ atrix ( $J(t)$, in our case) com $m$ uting $w$ ith all the $m$ atrices of a representation of the group G (m echanical representation, in our case), can be reduced to a very speci cblock-diagonal form . The dim ension ofeach block ofthis form is equal to $n_{j} \quad m_{j}$, where $n_{j}$ is the dim ension of a certain irreducible representation (irrep) $j$ of the group $G$ containing $m_{j}$ tim es in the reducible representation. M oreover, these blocks possess a particular structure which w ill be considered in Sec. IV.

To implement this splilting explicitly one must pass from the old basis old =
 by the com plete set of the basis vectors $k(k=1 ; 2 ;::: ; N)$ of all the irreps of the group G. If new $=S$ old then the unitary transform ation [25]

IV. STABILITY ANALYSIS OF DYNAM ICAL REGIMES IN MONOATOM IC CHAINS

A . Setting up the problem and Theorem 2

In general, the study of stability of periodic and, especially, quasiperiodic dynam ical regim es in the $m$ echanical system $s$ with $m$ any degrees of freedom presents considerable di culties. Indeed, for this punpose, we m ust integrate large linearized (near the considered regim e) system of di erential equations $w$ ith tim e-dependent coe cients. In the case of periodic regim $e$, one can use the $F$ loquet $m$ ethod requiring integration over only one tim eperiod to construct the $m$ onodrom $y m a t r i x . ~ B u t$ for quasiperiodic regim $e$ this $m$ ethod is inapplicable, and one often needs to solve system of great num ber of di erential equations for very large tim e intervals to reveal instability (especially, near the stability threshold).

In such a situation, a decom position (splilting) of the full linearized system into a number of independent subsystem $s$ of sm all dim ensions proves to be very useful. M oreover, this decom position can provide valuable inform ation on generalized degrees of freedom responsible for the loss of stability of the given dynam ical regim e for the rst tim e. Let us note that the num ber of such \critical" degrees of freedom can frequently be rather sm all.

W e want to ilhustrate the above idea $w$ th the case of $N$-particle $m$ onoatom ic chains for N 1. Let us introduce the follow ing notation. T he bush B [G]w ith the sym m etry group G containing the translational subgroup $\left[\mathrm{A}^{\mathrm{m}}\right] \mathrm{w}$ ill be denoted by B [ $\left.\mathrm{a}^{\mathrm{m}} ;::: /\right]$, where dots stand for other generators of the group G. (N ote, that any m -dim ensionalbush can exist only for the chain w ith $N$ divisible by $m$ ).

Theorem 2. Linear stability analysis of any bush $B\left[a^{m} ;:::\right]$ in the $N$-degrees-of-freedom m onoatom ic chain can be reduced to stability analysis of isolated subsystem $s$ of the second order di erentialequations w ith tim e-dependent coe cients whose dim ensions do not exaeed the integer num ber m.

C orollary. If the bush dim ension is $d$, one can pass on to the subsystem $s$ of autonom ous
di erential equations with dim ensions not exceeding ( $m+d$ ).
Before proving these propositions we must consider the procedure of constructing the basis vectors of the irreducible representations of the translational group T.
B. B asis vectors of irreducible representations of the translational groups

The basis vectors of irreducible representations of di erent sym m etry groups are usually obtained by the $m$ ethod of projection operators [17], but, in our case, it is easier to $m$ ake use of the \direct" $m$ ethod based on the de nition of the group representation [26].

Let be an n -dim ensional representation (reducible or irreducible) of the group G , while V [ ] be the invariant subspace corresponding to this representation that determ ined by the set ofN -dimensional basis vectors j ( $j=1 ;::: ; n$ ):

Being cyclic, the group $\mathrm{T}_{\mathrm{k}}$ from (55) possesses only one-dim ensionalirreps, and their total num ber is equal to the order ( $k=N=m$ ) of this group.

Below, for sim plicity, we consider the case $m=3$ and $N=12$. The generalization to the case of arbitrary values ofm and $N$ tums out to be trivial.

As it is well-known, the one-dim ensional irreps $i$ of the k-order cyclic group can be constructed w ith the aid of $k$-degree roots of 1 and, therefore, for our case $N=12, m=3$, $\mathrm{k}=4$, we obtain the irreducible representations listed in Table ].

In accordance w th the de nition (52), the basis vector of the one-dim ensional irrep , for which $M(g)=$, m ust satisfy the equation

Here we write the vector as the superposition (w ith coe cients $x, y, z$ ) of three basis vectors. It $m$ eans that the irrep is contained thrice in the decom position of the $m$ echanical representation into irreducible representations of the group $G=\left[a^{3}\right]$.
$T$ his result can be generalized to the case of anbitrary $N$ and $m$ in trivial $m$ anner: each irrep of the group $G=\left[\lambda^{m}\right]$ enters exactly $m$ tim es into the decom position of the $m$ echanical representation for $N$-particle chain, and the rule for constructing $m$ appropriate basis vectors is fully obvious from Eq. (58).

## C. Proof of Theorem 2

P roof. The basis vectors of all irreps i, listed for the case $\mathrm{N}=12, \mathrm{~m}=3$ in T ablell , can be obtained from (58) setting = 1;i; 1; i, respectively (these values are one-dim ensional $m$ atrioes corresponding in $i(i=1 ; 2 ; 3 ; 4)$ to the generator $\left.g \quad \alpha^{3}\right)$.

Let us w rite the above basis vectors sequentially, as it is done in Table四, and prove that 1212 m atrix, determ ined by this table, is precisely the m atrix S that splits the linearized dynam ical equations $=J(t)$ for the considered case. In $T$ ar we denote the basis vectors $j(i)$ by the symbol of the irrep $i(i=1 ; 2 ; 3 ; 4)$ and the num ber $j=1 ; 2 ; 3$ of the basis vector of this irrep. The norm alization factor $\frac{1}{2} \mathrm{~m}$ ust be associated w ith each row of this table to produce the norm alized basis vectors (because of this fact, we m ark the row s as $2{ }_{j}\left({ }_{i}\right)$ in the last colum $n$ of $T a b l e$ ( $)$.

O bviously, we can use the m atrix $S$ from Table (the row $s$ of this $m$ atrix are the basis vectors of all the irreps of the group $\mathrm{T}_{4}$ ) not only for the action on the vectors in the X space of the full nonlinear system, but on the vectors in the -space of the linearized system $=J(t) \quad$, as well. It is essential that in the latter case the $m$ atrix $S$ reduces the Jacobi $m$ atrix $J(t)$ to a certain block-diagonal form. Indeed, as was shown in $T$ heorem 1 , the $m$ atrix $J(t)$ com $m$ utes $w$ th all the $m$ atrioes of the $m$ echanical representation of the bush sym $m e-$ try group. Therefore, according to $W$ igner theorem [17], it can be reduced, using unitary

transform ation by the $m$ atrix $S$, to the block-diagonal form $w$ th blocks whose dim ension is equal to $n_{j} \quad m$. H ere $n_{j}$ is the dimension of the irrep $\quad{ }_{j}$ while $m_{j}$ is the number of tim es that this irrep enters into the decom position of the $m$ echanical representation (constructed, in our case, in the -space).

In $S e c \sqrt{I V} B$, we have show $n$ that for the translational group $T=\left[\mathrm{a}^{m}\right]$ all $n_{j}=1$ and all $m_{j}=m$. Therefore, the abovem atrix $S$ decom poses the Jacobim atrix $J(t)$ into blocks whose dim ension is equal to $m$. A s a consequence of this decom position, the system $=J(t)$ splits into $k=N=m$ independent subsystem $s, L_{j}(j=1 ; 2 ;:: ; i k)$, each consisting of $m$ di erential equations of the second order. T he coe cients of these equations are tim edependent functions, and this tim e dependence is determ ined by the functions $A(t)$, $B(t)$, $C$ ( $t$ ) etc., entering into the bush displacem ent pattem (see, for exam ple, 7,8) ). For the one-dim ensionalbushes, the coe cients of the above subsystem $s L$ j tum out to be periodic functions w ith identicalperiod, while for the m any-dim ensionalbushes they possess di erent periods (such bushes describe quasiperiodic m otion).

In general, it is im possible to obtain the explicit form of the functions A ( t ), B ( t ), C ( t ) etc., determ ining the bush displacem ent pattem. T herefore, we can add the bush dynam ical equations to them di erentialequations ofeach subsystem $s L_{j}$. These additionald equations determ ine the functions A ( $t$ ), B ( t , , C ( t ) etc. im plicitly, where d is the dim ension of the considered bush B [ám ;:::].

O $n$ the other hand, we can give the follow ing estim ate for the bush dim ension $d$ :
d m:

Here $m$ is the index of the translational sym $m$ etry of the bush $B$ [ ${ }^{m} ;:::$ ] (进 determ ines the ratio betw een the size of the prim itive œell in the vibrational state and in the equilibrium ). Indeed, the bush displacem ent pattem can be found as the solution to the equation $\hat{\mathrm{GX}}=$ $X$. If we take into account only translational sym m etry group of the bush $B$ [ $a^{m} ;:::$ ], i.e. $G=\left[a^{m}\right]$, this equation reduces to the equation $g=\left(\hat{g}=\mathrm{a}^{m}\right)$ for the basis vector of the identity irrep ( $=1 \mathrm{in}$ (56) ) of the group $\mathrm{T}=\left[\mathrm{a}^{\mathrm{m}}\right]$. A s it has been already show n in Sec IV B, such vector depends on exactly m arbitrary param eters. But som e additional sym m etry elem ents, denoted by dots in the bush sym bol $\mathrm{B}\left[\mathrm{a}^{m} ;:::\right]$, can lead to a decrease in the num ber $m$ of the above param eters. For exam ple, the bush $B\left[\lambda^{3} ;{ }^{\wedge}\right]$ tums out to be one-dim ensional, ie., in this case, $d=1$, while $m=3$. Even the vibrational bush $B\left[a^{3}\right]$ tums out to be two-dim ensional $(\mathrm{d}=2)$, if the condition of $\mathrm{m} m$ obility of the m ass center is taken into account. Thus, for all cases, $d \quad m$, and we can state that $m$ equations of each $L_{j}$, extended by $d$ additional equations of the given bush, provide us with $k=N=m$ independent subsystem $s I_{j}$ of $(m+d)$ autonom ous di erential equations.

Taking into account the additional bush symmetry elem ents, denoted by dots in the sym bolB [ám ;:::], leads not only to reducing the bush dim ension, but to a further splitting of the above discussed subsystem $s L_{j}$ (we consider this point in the next section). Thus, the linear stability analysis of the bush $B\left[a^{m} ;:::\right]$ in the $N$-particle chain indeed reduces to studying stability of individual subsystem s whose dim ension does not exceed ( $\mathrm{m}+\mathrm{d}$ ). This is the conclusion of T heorem 2 and, thus, we have com pleted the proof.

These equations can be obtained from (62) taking into account the relation $f(x)=x+x^{2}$ for the case of the FPU - m odel.

Rem ark. A coording to (61), (62) (see, also (74)), the vibrational bush B [A ${ }^{3}$ ] is threedim ensional. H ow ever, it actually tums out to be a two-dim ensional bush. Indeed, there is no onsite potential in the FPU - chains and, therefore, the conservation law of the total m om entum of such system holds. A ssum ing that the center of $m$ asses is xed, we obtain an additional relation $x(t)+y(t)+z(t)=0$ which reduces the dim ension of the bush $B\left[A^{3}\right]$ from 3 to 2 .
E. Further decom position of linearized system sbased on $h$ igher sym $m$ etry groups

U p to this point, we have discussed the decom position of the linearized system $=J(t)$ using only the translational part of the bush sym $m$ etry group. In general, one can arrive at a $m$ ore detailed splitting, if one takes into account the additionalbush sym $m$ etries.

1. E xam ple 2: Splitting of the linearized system for the bush $B\left[a^{3} ;{ }^{\wedge}\right]$

Let us consider the decom position of the linearized system for the bush B $\left[a^{3} ; \wedge\right]$ in the case of an arbitrary $m$ onoatom ic chain. Since translational part of the sym $m$ etry group $G=\left[a^{3} ;{ }^{\wedge}\right]$, which tums out to be the dinedral group, is the same as that of the early considered bush B [â ${ }^{3}$ ], we can take advantage of all the results obtained in Sec IV D and add only som e restrictions originating from the presence of the additional generator^ of the group [a ${ }^{3} ; \wedge$ ].

Substituting the vector $X(t)$ in the form (61) into the equation $\wedge^{\wedge} X(t)=X(t)$, we obtain $z(t) \quad x(t), y(t) \quad y(t)$ and, therefore, $y(t) \quad 0 . T$ he displacem ent pattem for the bush $B\left[a^{3} ;{ }^{\wedge}\right]$ then can be written as follow $s$ :

It can be shown that taking into account that [a $\mathrm{i}^{\wedge}$ ] is the supergroup w ith respect to group $\left[a^{3}\right]$, allow s one to obtain the follow ing splltting schem e of the linearized system $=J(t)$

H ere we present the dim ension ofeach independent subsystem (before the colon) and the list of its variables (after the colon). From the schem e (78), one can see that tw o of four threedim ensionalsubsystem s corresponding to the splitting provided by group [a3 ] (see Eqs. 72) ) in the case of the supergroup $\left[\Delta^{3} ; \wedge\right]$ are decom posed into new independent subsystem $s$ of dim ensions equal to 1 and 2. Below we explain how one can obtain the splilting schem es analogous to (78) .

## 2. General case

$N$ ow we consider the application of the $W$ igner theorem in case of an arbitrary bush $B[G]$.
Let us consider a m atrix $H$ com $m$ uting w ith all m atrices of a reducible representation of the group $G$ that can be decom posed into the irreps $j$ of this group as follow s

A ccording to the $W$ igner theorem, the $m$ atrix $H$ can be reduced to a block-diagonal form $w$ th the blocks $D_{j}$ of dim ensions $n_{j} \quad m$, corresponding to the each $j$, $w$ th $n_{j}$ being the dim ension of the irrep $j$ entering $m_{j}$ tim es into the decom position (79) of the representation into the irreducible parts.

M oreover, each block $D_{j}$ possesses a very speci c form, nam ely, 迅 consists of subblocks representing $m$ atrioes proportional to the identity $m$ atrix $I_{n_{j}}$ of the dim ension $n_{j} w$ hich repeat $m_{j}$ tim es along the row sand colum ns of the block $D_{j}$. W e can illustrate the structure
of a certain block $D_{j}=D$ characterized by the num bers $n_{j}=n, m_{j}=m$ as follow $s$

In our case, the $m$ atrix $H$ is the Jacobim atrix $J(t)$ of the linearized system $=J(t)$, $G$ is the sym $m$ etry group of a given bush $B[G]$, is the $m$ echanical representation of this group. Each block $D_{j}$ generates an independent subsystem $w$ th $n_{j}$ mequations in the decom position of the linearized system. H ow ever, each of these subsystem s autom atically splits into $n_{j}$ new subsystem $s$ consisting ofm ${ }_{j}$ di erentialequations, as a consequence of the speci c structure of the block $D_{j}$ (see Eq. 80) ). Indeed, for exam ple, if a certain D tolock for the $m$ atrix $J(t)$ possesses the form $\left(n_{j}=3, m_{j}=2\right)$ :

$N$ ote that the dim ension of each subsystem (81) is equal to $m_{j}=2$, while the total num ber of these subsystem $s$ is equal to $n_{j}=3$.
3. Irreducible representations and their basis vectors for the dihedral group

H ereafter, for sim plicity, we w ill discuss only chains w ith an even num ber (N) ofparticles and illustrate the $m$ ain ideas w ith the exam ple $N=12$.

The sym $m$ etry of an $N$-particle ( $m$ onoatom ic) chain is com pletely described by the dihedral group $G_{0}=D_{N}$ which can be written as the union of two cosets w ith respect to its translational subgroup $\mathrm{T}_{\mathrm{N}}=\mathrm{f}$; $\mathrm{a} ; \mathbf{a} \mathrm{a}^{2} ;::: ; \mathrm{a}^{\mathrm{N}}{ }^{1} \mathrm{~g}:$

Here ${ }^{\wedge}$ is the inversion relative to the center of the chain. The group $D_{N}$ is a non-Abelian group, since som e of its elem ents do not com m ute $w$ th each other (for example, ${ }^{\wedge} \hat{a}=\Delta^{1} \wedge$ ). A s a consequence, the num ber of classes of con jugate elem ents of this group is less than the totalnum ber ( 2 N ) of its elem ents and som e irreps j are not one-dim ensional. The irreps of the dihedral group $D_{N}$ can be obtained by the well-known induction procedure from those of its subgroup $T_{N}$. It tums out that for $D_{N} w$ ith even $N$ there are four one-dim ensional irreps, w hile all the other ( $\frac{N}{2} \quad 1$ ) irreps are tw o-dim ensional. W e discussed the construction of these irreps in [8], w here the follow ing results w ere obtained.

Every irrep can be determ ined by tw o matrioes $M_{j}(\hat{a}), M_{j}(\mu)$ corresponding to its generators $a$ and ${ }^{\wedge}$, where $j$ is the num ber of this irrep. Four one-dim ension irreps $(j=1 ; 2 ; 3 ; 4)$ are real and are determ ined by $m$ atrices [28]

Let and be the basis }\end{array}\right.$ vectors of the two-dim ensional invariant subspace corresponding to the irrep $w$ th the $m$ atrix $M(g)=@ \int^{0} A$, where $g=\Delta^{m}$ is the translational generator of the dinedral group. They can be obtained from the equations $\hat{g}=$ and $\hat{g}=$, respectively. For exam ple, using

B ecause of these relations, there appear certain connections betw een the arbitrary constants $(x ; y ; z)$ and $(x ; y ; z)$. A s a consequence, the basis vectors and , foreach two-dim ensional irrep of the group $\left[a^{3} ; \wedge\right]$, depends on only three arbitrary param eters: $x, y$ and $z$. In tum, thism eans that each two-dim ensional irrep enters exactly three tim es into the decom position of the $m$ echanical representation of the dihedral group [à ${ }^{3} ; \wedge$ ].

Unlike this, the one-dim ensional irreps of the dihedral group $\left[\hat{a}^{3} ; \wedge\right.$ ] are contained in the $m$ echanical representation less than 3 tim es. Indeed, let us consider the basis vectors and of the one-dim ensional irreps of the group $\left[\hat{a}^{3}\right]$ determ ined by the $m$ atrioes $M\left(a^{3}\right)=1$ and $M\left(a^{3}\right)=1$, respectively, for the case $m=3, N=12$ :

From the above results, we conclude that the irreps $1_{1}$ and ${ }_{4}$ are contained once, while the irreps 2 and 3 are contained tw ice in the decom position of the $m$ echanical representation for the considered chain .
$T$ he generalization of these results to the case of the dihedral group [ $\mathrm{a}^{m} ; \wedge$ ] with arbitrary $m$ is trivial.

The splitting schem e (78) for the bush $B\left[a^{3} ; \wedge\right]$ for the $m$ onoatom ic chain $w$ ith $N=12$ particles can be now explained as follows. There are ve irreps $\left(\begin{array}{llll}1, & 2, & 3, & 4\end{array}\right)$ of the
 ireeps ${ }_{1}\left(n_{1}=1\right)$ and ${ }_{4}\left(n_{4}=1\right)$ are contained once $\left(m_{1}=1, m_{4}=1\right)$ in the decom position of the $m$ echanical representation for our chain. On the other hand, the one-dim ensional irreps $2\left(n_{2}=1\right)$ and $3\left(n_{3}=1\right)$ are contained tw ice $\left(m_{2}=2, m_{3}=2\right)$ in , while two-dim ensional irrep $5\left(n_{5}=2\right)$ is contained thrice ( $m_{5}=3$ ) in. The twelve variables ${ }_{j}$ from Eq. (78) are associated w ith the irreps of the group $D_{4}$ in the follow ing $m$ anner:

Here, in parenthesis, we give the index of the copy of the irrep $i$ (whose dim ension is equal to $n_{i}$ ) in the decom position of the $m$ echanical representation . N ote that the total num ber of such copies determ ines how $m$ any tim es $m_{i}$ the irrep $i_{i}$ is contained in. On the other hand, as we already know, $m_{i}$ show $s$ us the dim ension of the subsystem $s L_{j}$, while $n_{i}$ determ ines the total num ber of $L_{j} w$ th the sam e dim ension associated with ${ }_{i}$. A s a result, we obtain the splitting schem e 78) .

The above discussed decom position of the fiull linearized system $=J(t)$ into independent subsystem $s L_{j}$ of $s m$ all dim ensions perm its one to analyze e ciently the stability of a given bush in the $m$ onoatom ic chain with arbitrary large num ber of particles $(\mathbb{N})$.

U sing this idea, the stability diagram s for all the one-dim ensionalbushes in both FPU and FPU - chains were obtained in [9]. A s an exam ple, in Fig. [1, we reproduce the stability diagram for the bush $B\left[a^{3} ;^{\wedge}\right]$ for the FPU - chain from that paper. In this diagram, each point (A ; q) determ ines a certain value of the bush $m$ ode am plitude $A$ and a certain value

of the wave number $q=\frac{2 j}{N}$ that is associated $w$ th the index $j$ of a xed mode. Theblack points ( $A ; q$ ) correspond to the case where the $m$ ode $j=q \frac{N}{2}$ becom es excited because of its param etric interaction $w$ the the ode of the bush $B\left[\hat{a}^{3} ; \wedge\right]$. The white color denotes the opposite case: the corresponding $m$ ode $j$, being zero at the initial instant, continues to be zero in spite of its interaction w ith the considered bush. Such a diagram allow s one to study stability of one-dim ensionalbushes not only for nite $N$, but also for the case $N$ ! 1 (some $m$ ore details can be found in [9]).

## V. SOMEADDITIONALEXAMPLES

A. Stability of the -m ode in the FPU- chain

The sym metry group of the -m ode $\mathrm{X}(\mathrm{t})=\mathrm{fA}(\mathrm{t})$; $\mathrm{A}(\mathrm{t}) ; \mathrm{A}(\mathrm{t}) ; \mathrm{A}(\mathrm{t}) ; \mathrm{A}(\mathrm{t}) ; \mathrm{A}(\mathrm{t}) ;::: \mathrm{g}$ in the FPU - chain is $\left[a^{2} ; \wedge\right]$. U sing results of the previous sections, one can deduce for N divisible by 4 that the linearized system in the vicinity of this $m$ ode splits into four individualequations and a num ber of two-dim ensional system s of di erential equations 30]. T he rst pair of individualequations represents two independent harm onic oscillators, while the second pair represents tw o M athieu equations. A ll the other system s represent pairs of coupled equations:

T hese results were obtained and discussed in [8] using a di erent (in com parison $w$ th the present paper) $m$ ethod. Indeed, there we obtained exact equations for the FPU - chain in the modal space and only then linearized them near the mode.

As it was discussed in [8], the system [87) tums out to be rather rem arkable: the $m$ ode (or one-dim ensional bush B $\left[a^{2} ;{ }^{\wedge}\right]$ ) loses its stability sim ultaneously with respect to interaction w ith all the otherm odes. In other words, the threshold c for the loss of stability for the bush $B\left[a^{2} ;{ }^{\wedge}\right]$ tums out to be the sam $e$ for all the values of $q$, ie. for all the subsystem $s$ 86) :

This property of the linearized system 877) was discussed in $m$ ore detail in [8]. The stability diagram for the bush $B\left[a^{2} ; \wedge\right]$ can be found in $\left.g\right]$.
B. Stability of the -m ode in the FPU - chain

This case is of a particular interest since the linearized system for the mode in the FPU - chain possesses a higher sym metry com pared to that in the FPU - chain. Indeed, for the FPU - model, the interparticle potential is an even function, and som e additional sym $m$ etry elem ents of the dynam ical equations appear as a consequence of this fact.

Let us introduce an operator $\hat{4}$ that changes signs of the displacem ents of all the particles:

Therefore, the symmetry group of the FPU - dynam ical equations tums out to be a supergroup $G_{0}^{0}$ w ith respect to the sym $m$ etry group $G_{0}=\left[a ; ;^{\wedge}\right]$ of the FPU - chain :

A s a result, one can classify bushes of modes in the FPU- chain by subgroups of the group $\mathrm{G}_{0}^{0}$ rather than by subgroups of the $\mathrm{G}_{0}$. The invariant $m$ anifolds (bushes ofm odes) in the FPU - m odelw ith respect to the group $\mathrm{G}_{0}^{0}$ were found by R ink in [11]. Som e additional details ofthis problem were discussed in our paper [9] (in particular, the dynam icalequations and stability of these bushes ofm odes).

C onsidering $\mathrm{G}_{0}^{0}$ from (90) as the parent group, we discover that the $m$ ode in the FP U chain $m$ ust be characterized by the group $G=\left[\hat{a}^{2} ; \wedge ; A \hat{u}\right]$, unlike the group [a; $\left.;^{\wedge}\right]$ characterizing the m ode in the FPU- chain with the parent group [ $\mathrm{A} ;^{\wedge}$ ].

The third generator [B1] ât $\hat{u} \hat{a}$ of the group $G=\left[\left\{a^{2} ; \wedge ; \hat{u}\right]\right.$ acts on the con guration vector $X$ as follow $s$ :

W ith the aid of the operators $\hat{p}=\hat{a} \hat{u}$ and $\hat{q}=\wedge$, we can obtain all the elem ents of the group

From these relations, one can see that $G$ is the dihedral group D 6 (by the w ay, it is isom orphic to the point groups $\mathrm{C}_{6 \mathrm{v}}, \mathrm{D}_{3 \mathrm{~h}}$ and $\mathrm{D}_{3 \mathrm{~d}}$, as well) .

The irreducible representations of the dihedral group were discussed in [8] (see also Sec IV E ofthepresent paper). There are four one-dim ensionaland $\frac{N}{2} 1$ two-dim ensional irreps of the group $D_{N} w$ ith an even index $N$. For sim plicity, let us discuss the case $N=6$ only (the generalization to arbitrary values of $N$ tums out to be trivial).

A 11 irreps of the group $\mathrm{D}_{6}$ can be constructed from the irreps of its subgroup $\mathrm{T}_{6}$ (see (94)) w th the aid of the induction procedure. A s a result, we obtain the follow ing irreps of the group $G=[\hat{p} ; \hat{q}]$ presented in TableIT. In this table, each irrep $j(j=1 ; 2 ;::: ; 6)$ is determ ined by the $m$ atrices $M(\hat{p})$ and $M(\hat{q})$, corresponding to the generators $\hat{p}$ and $\hat{q}$ of the group $\mathrm{D}_{6}$.

The generalization of this conclusion to the case of the FPU - chain with an arbitrary even number $\mathrm{N}=2 \mathrm{n}$ of particles can be achieved trivially. N am ely, each tw o-dim ensional ireep of the group $D_{2 n}$ is contained only once in the $m$ echanical representation of this group for the FPU - chain. O ne-dim ensional irreps are contained in the m echanical representation once or not at all. Rem em bering the above discussion about the application of the W igner theorem to splitting the linearized system $=J(t)$, we discover that for the FPU - chain (unlike FPU - chain) this system is decom posed into individual di erentialequations of the second order, i.e. we have the com plete splitting in this case.

W hat does it $m$ ean? Each bush (the $m$ ode, in our case) is associated $w$ ith a certain subgroup of the parent group $G_{0}$, the sym $m$ etry group of the original nonlinear dynam ical equations of the considered mechanical system. The operator $\hat{u}$ does not belong to the sym m etry group $G_{0}$ of the FPU - chain (unlike the case ofthe FP U - chain !) and, therefore, there are no sulogroups of the group $G_{0}$ whose elem ents contain $\hat{u}$. P recisely this fact can
explain why we m ust not take into consideration the operator ât for the case of the FPU chain, even through this operator does not change the pattem (105) of the $m$ ode.

The function A ( $t$ ) from the displacem ent pattem (105) of the $m$ ode is determ ined by the dynam ical equation of the one-dim ensional bush B $\left[a^{2} ; \wedge\right]$. A s it was already discussed, this equation can be obtained by substituting the vector $X$ ( $(\mathrm{t})$ from Eq. (105) into the nonlinear dynam ical equations of the FPU chain. For the FPU - m odel this equation tums out to be the equation of a harm onic oscillator $A+4 A=0$, while for the FPU $-m$ odel it is the $D u \operatorname{ng}$ equation $A+4 A+16 A^{3}=0$.

T hus, in both cases, the exact expression for the function A ( $t$ ) can be found. For studying the stability of the $m$ ode, we must substitute the corresponding expression for $A(t)$ into the linearized system $=J(t)$. As we saw in the present section, the linearized system splits into individual equations for the FPU - chain, while for the FPU - chain it can be decom posed into four individualequations and $(\mathbb{N} \quad 4)=2$ pairs of di erential equations. A 11 these equations tum out to be equations of the second order w ith tim e-periodic coe cients depending on the function $A(t)$ [ $[8$, 9$]$.

Let us note that stability of the m ode in the FPU - and FPU - chainswas investigated by di erent $m$ ethods in a large num ber of papers (see, for exam ple, 18, 19, $20,6,19,10,12$, 13, 14, 15]), but, to our best understanding, the in uence of sym $m$ etry of these $m$ echanical m odels on stability analysis was not discussed. Unlike the above cited works, the bush stability analysis presented in this paper based on the sym m etry-related argum ents only. Therefore, our conclusion about the di erence in splitting schem e of linearized system sfor the m ode in the FPU - and FPU - chains can be autom atically extended to all the other nonlinear chains w th the sam e sym $m$ etry characteristics. In particular, we can conclude that the splitting of the linearized system into individual equations can be perform ed not only for the FPU - chain, but for every chain with an even potential of the interparticle interaction. In contrast, it is im possible for the chains $w$ ith arbitrary potential, and the FPU - m odel is a sim ple ilhustration of this proposition.

W e would like to focus on the paper [14], where som e analytical results were obtained for the stability of the $m$ ode in the nonlinear chains $w$ ith a general even form of the interparticle interaction potential. The author of [14] succeeded in his analysis thanks to the decom position of the linearized system into individual equations, but such analysis cannot be extended to the FPU - chain precisely because the potential of this m odel is odd.

The generalization to the case of an arbitrary N (note that $\mathrm{N} \bmod 4=0 \mathrm{~m}$ ust hold !) is trivial: each one-dim ensionalirrep is contained tw ioe in the decom position ofthe m echanical representation of the N -particle chain, while each two-dim ensional irrep [35] is contained fourtimes in it.

In conclusion, in F ig , 2 we reproduce the stability diagram for the two-dim ensional bush $B\left[a^{4} ;^{\wedge}\right]$ from our paper $\Phi$ ]. This diagram corresponds to the FPU - chain $w$ ith $N=12$ particles. It represents a planar section of the four-dim ensional stability dom ain in the space of the initialconditions $1(0), 2(0), \ldots(0),{ }_{2}(0)$, where $1(t)$ and $2(t)$ are two modes of the considered bush.

In producing Fig.2, we specify $\quad 1(0)=0, \__{2}(0)=0$, and change $1(0), 2(0)$ in som e interval near their zero values. The stability dom ain, resem bling a beetle, is drown in black color in the plain $1(0), 2(0)$. The bush B $\left[a^{4} ;^{\wedge}\right]$ losses its stability (and transform $s$ into another bush of higher dim ension), when we cross the boundary of the black region in any direction. From Fig [2 it obvious, how nontrivial stability dom ain for a bush ofm odes can be.

A detailed description of the stability dom ains for one-dim ensional and tw o-dim ensional bushes ofm odes in both FPU - and FPU - chains can be found in [g].
VI. CONCLUSION

A ll the exact dynam ical regim es in $N$-particle $m$ echanical system w ith discrete sym $m$ etry can be classi ed by the subgroups $G_{j}$ of the parent group $G_{0}$, i.e. the sym $m$ etry group of its equations of $m$ otion. A ctually, each subgroup $G_{j}$ singles out a certain invariant $m$ anifold which, being decom posed into the basis vectors of the irreducible representations of the group $\mathrm{G}_{0}$, is term ed as a \bush ofm odes" [1, 2, [3].

The bush $B\left[G_{j}\right]$, representing an $n$-dim ensional vibrational regim $e$, can be considered as a dynam ical ob ject characterized by its displacem ent pattem of all the particles from their equilibrium positions, by the appropriate dynam ical equations and the dom ain of the stability. O ne-dim ensional bushes are sym $m$ etry-determ ined sim ilar nonlinear norm al m odes introduced by R osenberg [16] (see also [4]). For H am iltonian system s , the energy of the initial excitation tums out to be \trapped" in the bush and this is a phenom enon of energy localization in the $m$ odal space.
$T$ he di erent aspects of the bush theory were developed in $1,2,2,3,4,5,6,7]$. Bushes of vibrationalm odes (invariantm anifolds) in the FPU chainswere discussed in [8, $9,10,11,12]$.
$T$ he stability analysis of a given bush B [G] reduces to studying the linearized (in the vicinity of the bush) dynam ical equations $=J(t)$. In the present paper, we prove (T heorem 1) that the sym $m$ etry group of the linearized system $=J(t)$ tums out to be precisely the sym $m$ etry group $G$ of the considered bush B [G ]. This result allow s one to apply the well-know W W igner theorem about the speci c structure of them atrix ( $\mathrm{J}(\mathrm{t})$, in our case) com $m$ uting $w$ th all the $m$ atrioes of a xed representation ( $m$ echanical representation, in our case) of a given group. A ccording to the above theorem one can split e ectively
the linearized system $=J(t)$ into a num ber of independent subsystem $s$ of di erential equations w ith tim e-dependent coe cients.

W ewant to em phasize that this sym $m$ etry-related $m$ ethod for splltting the linearized system s arising in the linear stability analysis of the dynam ical regim es is suitable for arbitrary nonlinear $m$ echanical system $s$ w ith discrete sym $m$ etry. Such a decom position (splitting) of the linearized system $=J(t) \quad$ is especially im portant for the $m$ ultidim ensional bushes of m odes, describing quasiperiodic vibrational regim es, which cannot be treated with the aid of the F loquet m ethod. Indeed, in this case, we need to integrate the di erential equations w ith tim e-dependent coe cients over large tim e interval, unlike the case of periodic regim es where we can solve the appropriate di erential equations over only one period to construct the $m$ onodrom $y m$ atrix.

The above $m$ ethod is applied for studying the stability ofsom e dynam icalregim es (bushes ofm odes) in the $m$ onoatom ic chains. For this speci c $m$ echanical system $s$, we prove $T$ heorem 2 which allow s one to nd very sim ply the upperbound ofdim ensions of the independent subsystem s obtained after splitting the linearized system $=J(t)$. Indeed, according to this theorem, the dim ension of each such subsystem does not exceed the integer $m$ deter$m$ ining the ratio of the volum es of the prim titive cell of the chain in the vibrational state, corresponding to the given bush $B[G]=B\left[a^{m} ;:::\right]$, and the equilibrium state.

Taking into account any other sym $m$ etry elem ents of the considered bush allow $s$ to reduce the dim ensions of at least som e of the above discussed subsystem $s$. W e illustrate this fact com paring the stability analysis of the $m$ ode (zone boundary mode) for the FPU - and FPU- chains.
