# Optim ized suppression of coherent noise from seism ic data using the Karhunen-Loeve transform

Signals obtained in land seism ic surveys are usually contam inated with coherent noise, am ong which the ground roll (Rayleigh surface waves) is of major concern for it can severely degrade the quality of the information obtained from the seism ic record. Properly suppressing the ground roll from seism ic data is not only of great practical importance but also remains a scientic challenge. Here we propose an optimized liter based on the Karhunen {Loeve transform for processing seism ic data contam inated with ground roll. In our method, the contam inated region of the seism ic record, to be processed by the liter, is selected in such way so as to correspond to the maximum of a properly de ned coherence index. The main advantages of the method are that the ground roll is suppressed with negligible distortion of the remanent relation signals and that the litering can be performed on the computer in a largely unsupervised manner. The method has been devised to liter seism ic data, how ever it could also be relevant for other applications where localized coherent

structures, em bedded in a com plex spatiotem poral dynam ics, need to be identi ed in a m ore re ned way.

I. IN TRODUCTION

Locating oil reservoirs that are econom ically viable is one of the main problems in the petroleum industry. This task is primarily undertaken through seism ic exploration, where explosive sources generate seism ic waves whose reections at the di erent geological layers are recorded at the ground or sea level by acoustic sensors (geophones or hydrophones). These seism ic signals, which are later processed to reveal information about possible oil occurrences, are often contam inated by noise and properly cleaning the data is therefore of param ount im portance [1]. In particular, the design of e cient liters to suppress noise that show s coherence in space and time (and offen appears stronger in magnitude than the desired signal) remains a scienti c challenge for which novel concepts and methods are required. In addition, the ltering tools developed to treat such kind of noise may also nd relevant applications in other physical problems where coherent structures evolving in a complex spatiotem poral dynam ics need to identi ed properly.

In land seism ic surveys, the seism ic sources generate various type of surface waves which are regarded as noise since they do not contain inform ation from the deeper subsurface. This so-called coherent noise represents a serious hurdle in the processing of the seism ic data since it may overwhelm the re ection signal, thus severely degrading the quality of the inform ation that can be obtained from the data. A source-generated noise of particular concern is the ground roll, which is the main type of coherent noise in land seism ic records and is com monly much stronger in amplitude than the re ected signals. G round rollare surface waves whose vertical components are Rayleigh-type dispersive waves, with low frequency and low phase and group velocities.




FIG.1: A space-tim e plot of seism ic data. The horizontalaxis represents the o set distance and the vertical axis indicates time. The origin is at the upper-left corner, and them axim um o set and time are 475 m and 1000 m s, respectively. The gray scale is such that black (white) corresponds to the m inim um (m axim um) am plitude of the seism ic signal. The ground roll noise appears as downward oblique lines.




FIG. 2: Seism ic signal recorded by a single geophone (trace 58). The am plitude is in arbitrary units and time in m s.

An example of seism ic data contam inated by ground roll is shown in Fig. 1. This seism ic section consists of land { based data with 96 traces (one for each geophone) and 1001 sam ples per trace. A typical trace is shown in Fig. 2 corresponding to geophone 58. The image shown in Fig. 1 was created from the 96 traces using a standard in aging technique. The horizontalaxis in this gure corresponds to the o set distance between source and receiver and the vertical axis represents time, with the origin located at the upper { left corner. The maximum o set is 475 m (the distance between geophones being 5 m) and the maximum time is 1000 ms. The gray levels in Fig. 1 change linearly from black to white as the amplitude of the seism ic signal varies from minimum to maximum. Owing to its dispersive nature, the ground roll appears in a seism ic im age as a characteristic fan-like structure, which is clearly visible in Fig. 1. The data shown in this gure was provided by the Brazilian Petroleum Com pany (PETROBRAS).

Standard m ethods for suppressing ground roll include one-dimensional high {pass ltering and two-dimensional f {k ltering [1]. Such \global" lters are based on the elim ination of specic frequencies and have the disadvantage that they also a ect the uncontam inated part of the signal. Recently, \local" lters for suppressing the ground roll have been proposed using the K arhunen-Loeve transform [2, 3] and the wavelet transform [4, 5]. The W iener-Levinson algorithm has also been applied to extract the ground roll [6].

Filters based on the Karhunen {Loeve (KL) transform are particularly interesting because of the adaptativity of the KL expansion, m eaning that the original signal

is decom posed in a basis that is obtained directly from the empirical data, unlike Fourier and wavelet transform s which use prescribed basis functions. The K L transform is a mathematical procedure (also known as proper orthogonal decomposition, empirical orthogonal function decomposition, principal component analysis, and singular value decomposition) whereby any complicated data set can be optimally decomposed into a nite, and offen small, num ber of modes (called proper orthogonal modes, empirical orthogonal functions, principal components or eigenimages) which are obtained from the eigenvectors

of the data autocorrelation matrix. In applying the KL transform to suppress the ground roll, one must rst m ap the contam inated region of the seism ic record into a horizontal rectangular region. This transform ed region is then decomposed with the KL transform and the rst few principal components are removed to extract the coherent noise, after which the ltered data is inversely mapped back into the original seism ic section. The advantage of this method is that the noise is suppressed with negligible distortion of the relection signals, for only the data within the selected region is actually processed by the lter. Earlier versions of the KL lter [2, 3] have how ever one serious draw back, nam ely, the fact that the region to be ltered must be picked by hand a procedure that not only can be labor intensive but also relies on good judgm ent of the person perform ing the ltering.

In this article we propose a signi cant im provement of the K L ltering method, in which the region to be ltered is selected automatically as an optim ization procedure. We introduce a novel quantity, namely, the coherence index C I, which gives a measure of the amount of energy contained in the most coherent modes for a given selected region. The optimal region is then chosen as that that gives the maximum C I. We emphasize that introducing a quantitative criterion for selecting the best' region to be ltered has the considerable advantage of yielding a largely unsupervised scheme for dem arcating and e ciently suppressing the ground roll.

A lthough our m ain m otivation here concerns the suppression of coherent noise in seism ic data, we should like to remark that our method may be applicable to other problem swhere coherent structures embedded in a com plex spatiotem poral dynam ics need to be identi ed or characterized in a more re ned way. For example, the KL transform has been recently used to identify and extract spatial features from a complex spatiotem poralevolution in combustion experiment [7, 8, 9]. A related method the so-called biorthogonal decom position has also been applied to characterize spatiotem poral chaos and identied structures[10, 11] as well as identify changes in the dynam ical com plexity, and the spatial coherence of a multim ode laser [12]. W e thus envision that our optim ized K L lterm ay nd applications in these and related problem s of coherent structures in com plex spatiotem poraldynam ics.

The article is organized as follows. In Sec. II we de ne the K arhunen {Loeve transform, describe itsm ain properties, and discuss its relation to the singular value decom – position of matrices. In Sec. III we present the K L liter and a novel optim ization procedure to select the noisecontam inated region to be parsed through the liter. The results of our optim ized liter when applied to the data shown in Fig. 1 are presented in Sec. IV. O urm ain conclusions are sum marized in Sec. V. In Appendixes A and B we brie y discuss, for com pleteness, the relation between the K L transform and two other sim ilar procedures known as proper orthogonal decom position (or empirical orthogonal function expansion) and principal com ponent analysis.

### II. THE KARHUNEN {LOEVE TRANSFORM

#### A. De nition and main properties

Consider a multichannel seism ic data consisting of m traces with n samples per trace represented by a m n m atrix A, so that the elem ent A<sub>ij</sub> of the data m atrix corresponds to the amplitude registered at the ith geophone at time j. For de niteness, let us assume that m < n, as is usually the case. We also assume for simplicity that the m atrix A has full rank, i.e., r = m, where r denotes the rank of A. Letting the vectors  $\mathbf{x}_i$  and  $\mathbf{y}_j$  denote the elem ents of the ith row and the jth column of A, respectively, we can write

W ith the above notation we have

where  $a_{ij}$  denotes the jth element of the vector  $a_i$ . (To avoid risk of confusion matrix elements will always be denoted by capital letters, so that a small-cap symbol with two subscripts indicates vector elements.)

Next consider the following m m symmetric matrix

where the superscript t denotes matrix transposition. It is a well known fact from linear algebra that matrices of the form (3), also called covariance matrices, are positive de nite [19]. Let us then arrange the eigenvalues  $_{i}$  of in non-ascending order, i.e.,  $_{1}$  \_ 2 :::  $_{m} > 0$ , and let  $u_{i}$  be the corresponding (norm alized) eigenvectors.

The Karhunen-Loeve (KL) transform of the data matrix A is de ned as the m n matrix given by

where the columns of the matrix  ${\tt U}\,$  are the eigenvectors of  $\,:\,$

The original data can be recovered from the KL transform by the inverse relation

 ${\tt W}$  e refer to this equation as the K L expansion of the data matrix A . To render such an expansion more explicit let

us denote by the  $\sim_i,\,i=1;:::;m$  , the elements of the ith row of the KL m atrix , that is,

Then (6) can be written as

where it is implied matrix multiplication between the column vector  $\mathbf{u}_i$  and the row vector  $\sim_i$ . The eigenvectors  $\mathbf{u}_i$  are called empirical eigenvectors, proper orthogonal modes, or KL modes.

As discussed in Appendix A, the total energy E of the data can be de ned as the sum of all eigenvalues,

so that  $_{\rm i}$  can be interpreted as the energy captured by the ith empirical eigenvector  $u_{\rm i}$ . We thus de ne the relative energy E  $_{\rm i}$  in the ith KL mode as

W e note furtherm ore that since is a covariance-like matrix its eigenvalues  $_i$  can also be interpreted as the variance of the respective principal component  $u_i$ ; see Appendix B form ore details on this interpretation. We thus say that the higher  $_i$  the more coherent the KL mode  $u_i$  is. In this context, the most energetic modes are identiced with the most coherent ones and vice-versa.

An important property of the KL expansion is that it is bptim al' in the following sense: if we form the matrix  $_k$  by keeping the rst k rows of and setting the remaining m k rows to zero, then the matrix  $A_k$  given by

is the best approximation to A by a matrix of rank k < m in the Frobenius norm (the square root of the sum of the squares of all matrix elements) [13]. This optimality property of the KL expansion lies at the heart of its applications in data compression [14] and dimensionality reduction [13], for it allows to approximate the original data A by a smaller matrix  $A_k$  with minimum loss of information (in the above sense). Another interpretation of relation (11) is that it gives a low-lass liter [15], for in this case only the rst k KL modes are retained in the litered data  $A_k$ .

On the other hand, if the relevant signal in the application at hand is contam inated with coherent noise, as is the case of the ground roll in seism ic data, one can use the KL transform to remove e ciently such noise by constructing a high-pass lter. Indeed, if we form the matrix  ${}^0_k$  by setting to zero the rst k rows of and keeping the remaining ones, then the matrix  $A^0_k$  given by

is a litered version of A where the rst k in ost coherent' m odes have been rem oved. However, if the noise is localized in space and time it is best to apply the liter only to the contam inated part of the signal. In previous versions of the KL liter the choice of the region to be parsed through the liter was made a priori, according to the best judgem ent of the person carrying out the litering, thus lending a considerable degree of subjectivity to the process. In the next section, we will show how one can use the KL expansion to implement an autom ated liter where the undesirable coherent structure can be bptim ally' identi ed and rem oved.

Before going into that, how ever, we shallbrie y discuss below an in portant connection between the KL transform and an analogous mathematical procedure known as the singular value decomposition of matrices. Readers already know ledgeable about the equivalence between these two form alisms (or more interested in the specic application of the KL transform to liter coherent noise) may skip the remainder of this section without loss of continuity.

## B. Relation to Singular Value Decom position

We recall that the singular value decomposition (SVD) of any m n matrix A, with m < n, is given by the following expression:

where U is as de ned in (5), is a m m diagonal matrix with elements  $_{i} = _{i}$ , the so-called singular values of A, and V is a m n matrix whose columns correspond to the m eigenvectors  $fv_{i}g$  of the matrix  $A^{t}A$  with nonzero eigenvalues. The SVD allows us to rewrite the matrix A as a sum of matrices of unitary rank:

In the context of im age processing the matrices Q  $_{\rm i}$  are called eigenim ages [16].

Now, comparing (6) with (13) we see that the KL transform is related to the SVD matrices and V by the following relation

so that the row vectors  $\sim_i$  of are given in term s of the singular values  $_i$  and the vectors  $\bm{v}_i$  by




FIG. 3: Schem atic diagram for dem arcating the ground roll on a seism ic section and the corresponding rectangular sectors obtained by applying a linear map.

It thus follows that the decomposition in eigenimages seen in (14) is precisely the KL expansion given in (8). Furtherm one the approximation  $A_k$  given in (11) can be written in terms of eigenimages as

Similarly, the ltered data  $A_k^0$  shown in (12) reads in terms of eigenim ages:

The SVD provides an e cient way to compute the KL transform, and we shall use this method in the numerical procedures described in the paper.

# III. THE OPTIM IZED KL FILTER

As already mentioned, owing to its dispersive nature the ground-roll noise appears in a seism ic image as a typical fan-like coherent structure. This space-time localization of the ground roll allows us to apply a sort of 'surgical procedure' to suppress the noise, leaving intact the uncontam inated region. To do that, we rst pick lines to dem arcate the start and end of the ground roll and, if necessary, interm ediate lines to dem arcate di erent wavetrains, as indicated schem atically in Fig. 3. In this gure we have for simplicity used straight lines to dem arcate the sectors but more general alignment functions, such as segmented straight lines, can also be chosen [2, 3]. To make our discussion as general as possible, let us assume that we have a set of N param eters f ig, i = 1; :::; N , describing our alignment functions. For instance, in Fig. 3 the parameters f<sub>i</sub>q would correspond to the coe cients of the straight lines de ning each sector.

Once the region contam inated by the ground roll has been dem arcated, we map each sector onto a horizontal rectangular region by shifting and stretching along the time axis; see Fig. 3. The data points between the top and bottom lines in each sector is mapped into the corresponding new rectangular dom ain, with the mapping being carried out via a cubic convolution interpolation technique [17]. A fter this alignment procedure the ground roll events will becom e approxim ately horizontal, favoring its decomposition in a smaller space. Since any given transform ed sector has a rectangular shape it can be represented by a matrix, which in turn can be decom posed in em pirical orthogonalm odes (eigen im ages) using the KL transform. The rst few modes, which contain m ost of the ground roll, are then subtracted to extract the coherent noise. The resulting data for each transform ed sector is nally subjected to the corresponding inverse m apping to compensate for the original forward mapping. This leaves the uncontaminated data (lying outside the dem arcated sectors) una ected by the whole ltering procedure.

The KL lter described above has indeed shown good performance in suppressing source-generated noise from seism ic data [2, 3]. The method has however the drawback that the region to be ltered must be picked by hand, which renders the analysis somewhat subjective. In order to overcome this di culty, it would be desirable to have a quantitative criterion based on which one could decide what is the best choice' for the parameters f ig describing the alignment functions. In what follows, we propose an optimization procedure whereby the region to be ltered can be selected automatically, once the generic form of the alignment functions is prescribed.

Suppose we have chosen l sectors to dem arcate the different wavetrains in the contam inated region of the original data, and let f<sub>1</sub>;:::; <sub>N</sub> g be the set of parameters characterizing the respective alignment functions that dene these sectors. Let us denote by  $\tilde{A_k}$ , k = 1; :::; l, the matrix representing the kth transformed sector obtained from the linear mapping of the respective original sector, as discussed above. For each transform ed sector  $\tilde{A_k}$  we then compute its KL transform and calculate the coherence index C I<sub>k</sub> for this sector, de ned as the relative energy contained in its rst KL mode:

where  $_{i}^{k}$  are the eigenvalues of the correlation m atrix  $_{k}^{k} = \mathcal{K}_{k}\mathcal{K}_{k}^{t}$  and  $r_{k}$  is the rank of  $\mathcal{K}_{k}$ . Such as de ned above, C I<sub>k</sub> represents the relative weight of the most coherent mode in the K L expansion of the transformed sector  $\mathcal{K}_{k}$ . (A quantity analogous to our C I is known in the oceanography literature as the sim ilarity index [18].)

Next we introduce an overall coherence index  $C I(_1; :::;_N)$  for the entire dem arcated region, de ned

as the average coherence index of all sectors:

As the name suggests, the coherence index C I is a measure of the amount of boherent energy' contained in the chosen dem arcated region given by the parameters f  $_{ig_{i=1}^{N}}$ . Thus, the higher C I the larger the energy contained in them ost coherent modes in that region. For the purpose of litering coherent noise it is therefore mostly favorable to pick the region with the largest possible C I. We thus propose the following criterion to select the optimal region to be litered: vary the parameters f ig over some appropriate range and then choose the values i that maxim ize the coherence index C I, that is,

Once we have selected the optim al region, given by the parameters  $f_{i}g_{i=1}^{N}$ , we then simply apply the KL leter to this region as already discussed: we remove the rst few eigenim ages from each transformed sector and inversely map the data back into the original sectors, so as to obtain the nal litered in age. In the next section we will apply our optim ized KL litering procedure to the seism ic data shown in Fig. 1.

## IV . RESULTS

Here we illustrate how our optim ized KL lter works by applying it to the seism ic data shown in Fig. 1. In this case, it su ces to choose only one sector to dem arcate the entire region contam inated by the ground roll. Thism eans that we have to prescribe only two alignment functions, corresponding to the uppermost and lowermost straight lines (lines AB and CD, respectively) in Fig. 3. To reduce further the number of free param eters in the problem, let us keep the leftm ost point of the upper line (point A in Fig. 3) xed to the origin, so that the coordinates  $(i_A; j_A)$  of point A are set to (0; 0), while allowing the point B to move freely up or down within certain range; see below. Sim ilarly, we shall keep the rightmost point of the lower line (point C in Fig. 3) pinned at a point ( $i_c$ ;  $j_c$ ), where  $i_c = 95$  and  $j_c$  is chosen so that the entire ground roll wavetrain is above this point. The other endpoint of the lower dem arcation line (point D in Fig. 3) is allowed to vary freely. W ith such restrictions, we are left with only two free parameters, namely, the angles  $_1$  and  $_2$  that the upper and lower dem arcation lines make with the horizontal axis. So reducing the dimensionality of our parameter space allows us to visualize the coherence index  $CI(_1;_2)$  as a 2D surface. For the case in hand, it is more convenient how ever to express C I not as a function of the angles 1 and 2 but in terms of two other new parameters introduced below.

Let the coordinates of point B, which de nes the right endpoint of the upper dem arcation line in Fig.3, be given by  $(i_B; j_B)$ , where  $i_B = 95$ . In our optimization procedure we let point B move along the right edge of the seismic section by allowing the coordinate  $j_B$  to vary from a minimum value  $j_{B_m in}$  to a maximum value  $j_{B_m ax}$ , so that we can write

where N<sub>B</sub> is the number of intermediate sampling points between  $j_{B_{m\,in}}$  and  $j_{B_{m\,ax}}$ , and  $_{B} = (j_{B_{m\,ax}}, j_{B_{m\,in}}) = N_{B}$ . Similarly, for the coordinates  $(i_{D}; j_{D})$  of point D in Fig. 3, which is the moving endpoint of the lower straight line, we have  $i_{D} = 0$  and

where  $N_D$  is the number of sampling points between  $\dot{j}_{D_{min}}$  and  $\dot{j}_{D_{max}}$ , and  $_D = (\dot{j}_{D_{max}} - \dot{j}_{D_{min}}) = N_D$ .




FIG. 4: The coherence index C I as a function of the indices k and 1 that de ne the dem arcation lines; see text.




FIG.5: a) The selected region in the new dom ain; b) its rst eigenim age; c) the second eigenim age; and d) the result after subtracting the rst eigenim age.

For each choice of k and lin (22) and (23), we apply the procedure described in the previous section and obtain the coherence index C I (k; 1) of the corresponding region. In Fig. 4 we show the energy surface CI(k; 1), for the case in which  $j_{B_{m in}} = 280$ ,  $j_{B_{m ax}} = 600$ ,  $j_{C} = 864$ ,  $\mathbf{j}_{\text{min}}$  = 0,  $\mathbf{j}_{\text{max}}$  = 576, and  $\mathbf{N}_{\text{B}}$  =  $\mathbf{N}_{\text{D}}$  = 64. We see in this gure that CI possesses a sharp peak, thus show ing that this criterion is indeed quite discrim inating with respect to the positioning of the lines dem arcating the region contam inated by the ground roll. The global maximum of CI in Fig. 4 is located at k = 42 and l = 24, and in Fig. 5a we show the transform ed sector obtained from the linear mapping of this optimal region. In this qure one clearly sees that the ground roll wavetrains appearm ostly as horizontal events. In Fig. 5b we present the rst eigenimage of the data shown in Fig. 5a, which




FIG.6: The relative energy of the rst 10 KL modes of the region shown in Fig.5a.

corresponds to about 33% of the total energy of the in age in Fig. 5a, as can be seen in Fig. 6 where we plot the relative energy  $E_i$  captured by the rst 10 eigenin ages. The second eigenin age, shown in Fig. 5c, captures about 10% of the total energy, with each successively higher mode contributing successively less to the total energy; see Fig. 6. In Fig. 5d we give the result of removing the rst KL mode (Fig. 5b) from Fig. 5a. It is clear in Fig. 5d that by removing only the rst eigenin age the main horizontal events (corresponding to the ground roll) have already been greatly suppressed.




FIG. 7: a) The ltered seism ic section after removing the rst eigenim age of the select region shown in Fig. 5a. In b) we show the result after removing the rst two eigenim ages.

Perform ing the inverse mapping of the image shown in Fig. 5c yields the data seen in the region between the two white lines in Fig. 7a, which shows the nal litered image for this case (i.e., after removing the rst KL mode from the transform ed region). We see that the ground roll inside the dem arcated region in Fig. 7a has been considerably suppressed, while the uncontam inated signal (lying outside the marked region) has not been a ected at allby the litering procedure. If one wishes to liter further the ground roll noise one may subtract successively higher modes. For example, in Fig. 7b we show the litered im age after we also subtract the second eigenim age. One sees that there is som e m inor in provem ent, but rem oving additionalm odes is not recom m ended for it starts to degrade relevant signal as well.

#### V. CONCLUSIONS

An optimized liter based on the Karhunen {Loeve transform has been constructed for processing seism ic data contam inated with coherent noise (ground roll). A great advantage of the KL liter lies in its local nature, m eaning that only the contam inated region of the seism ic record is processed by the liter, which allows the ground roll to be rem oved without distorting m ost of the re ection signal. A nother advantage is that it is an adaptative m ethod in the sense the the signal is decom posed in an empirical basis obtained from the data itself. We have im proved considerably the KL liter by introducing an

used in the optim ization procedure as well as the num ber of eigenim ages to be rem oved from the selected region. These m ay vary depending on the speci c application at hand. How ever, once these choices are m ade, the Itering task can proceed in the computer in an autom ated way.

A lthough ourm aim motivation here has been suppressing coherent noise from seism ic data, ourm ethod is by no means restricted to geophysical applications. In fact, we believe that the method may prove useful in other problems in physics that require localizing coherent structures in an autom ated and more re ned way. We are currently exploring further such possibilities.

## APPENDIX A :RELATION BETW EEN THE KL TRANSFORM AND PROPER ORTHOGONAL DECOM POSITION

In dynamical systems the mathematical procedure akin to the KL transform is called the proper orthogonal decomposition (POD). In this context, one may view each colum n vector y; of the data m atrix A as a set of m m easurem ents (realor num erical) of a given physical variable f (x;t) perform ed simultaneously at m space locations and at a certain time  $t_j$ , that is,  $y_{jk} = f(x = x_k; t = t_j)$ , k = 1; :::;m. For example, in turbulent ow s the vectors yi often representmeasurements of the uid velocity at m points in space at a given time i. The data matrix A thus corresponds to an ensemble fyig of n such vectors, representing a sequence of m measurements over n instants of time. In POD one is usually concerned with nding a low-dimensional approximate description of the highdim ensional dynam ical process at hand. This is done by nding an optimal basis in which to expand (and then truncate) a typical vector y of the data ensemble. Such a basis is given by the eigenvectors of the tim e-averaged autocorrelation m atrix R, which is proportional to the matrix de ne above:

Hence the eigenvectors  $fa_ig$  of are also eigenvectors of R. In POD parlance the eigenvectors  $fa_ig$  are called empirical eigenvectors or proper orthogonal modes. In the

continuous case, the corresponding eigenfunctions  $u_i(x)$  of the autocorrelation operator are known as empirical orthogonal functions (EOF).

From (1), (4) and (5), one can easily verify that

We thus see that the columns of the KL transform correspond to the coordinates of the vectors y in the em pirical basis:

It is this expansion of any m ember of the ensemble in the empirical basis that is called the proper orthogonal decomposition or empirical orthogonal function expansion. It now follows from (A 3) that

where in the last equality we used the fact that

where is the diagonal matrix = diag( $_1$ ;:::;  $_m$ ). Equation (A4) thus suggests that we can interpret the eigenvalue  $_i$  as a measure of the energy in the ith em – pirical orthogonal mode. For example, in the case of turbulent ows where the vector  $y_i$  contains velocity measurements at time i, the left hand of (A4) yields twice the average kinetic energy per unit mass, so that  $\frac{1}{2}_{i}$  i gives the kinetic energy in the ith em pirical orthogonal mode [13]. Sim ilarly, in the case of seism ic data the vectors  $y_i$  represent amplitudes of the rected waves, and hence the quantity  $\sum_{i=1}^{n} y_i^2 = \sum_{i=1}^{n} i$  may be viewed as a measure of the total energy of the data, thus justifying the de nition given in (9).

The optimality of the KL expansion also has a nice physical and geom etrical interpretation, as follows. Suppose we write a vectory in an arbitrary orthonorm albasis  $fe_ig_{i=1}^m$ :

$$y = \sum_{i=1}^{X^n} a_i e_i; \quad (A 6)$$

where  $a_i = e_i$  y. If we now wish to approximate y by only its rst k < m components,

$$\mathbf{y}^{k} = \sum_{i=1}^{X^{k}} a_{i} \mathbf{e}_{i}; \qquad (A7)$$

then the optimality of the KL expansion implies that the rst k proper orthogonalm odes capture more energy (on average) that the rst k modes of any other basis. More precisely, the mean square distance  $\frac{1}{2}$  y<sup>k</sup>  $\frac{2}{J}$  is minimum if we use the empirical basis.

## APPENDIX B:RELATION BETWEEN THE KL TRANSFORM AND PRINCIPAL COMPONENT ANALYSIS

In statistical analysis of multivariate data, the KL transform is known as principal component analysis (PCA). In this case, one views the elements of a row vector  $\mathbf{x}_i = (\mathbf{x}_{i1}; \dots; \mathbf{x}_{in})$  of the data matrix A as being n realizations of a random variable X<sub>i</sub>, so that the matrix A itself corresponds to n samples of a random vector X with m components:  $\mathbf{X} = (\mathbf{X}_1; \dots; \mathbf{X}_m)^t$ . In other words, the column vectors  $\mathbf{y}_j$  correspond to the samples of X̃. If the row sofA are centered, i.e., the variable X<sub>i</sub> have zero m ean, then them atrix is proportional to the covariance matrix S<sub>X</sub> of X̃ [20]:

or alternatively in matrix notation

Note that the matrices R and  $S_X$  de ned respectively in (A1) and (B2) are essentially the same but have di erent interpretations.] In the PCA context, the diagonal elements ii of the matrix are thus proportional to the variance of the variables X i, whereas the o -diagonal elements ij, i f j, are proportional to the covariance between the variables X i and X j. Furtherm ore, the eigenvectors ui of correspond to the principal axis of the covariance m atrix Sx . The idea behind PCA is to introduce a new set of m variables P<sub>i</sub>, each of which being a linear com bination of the original variables X i, such that these new variables are mutually uncorrelated. This is accomplished by projecting the vector X onto the principal directions of the covariance m atrix. M ore precisely, we de ne the principal com ponents  $P_i$ , i = 1; ...; m, by the follow ing relation

In other words, the vector of principal components  $P = (P_1; :::; P_m)^t$  is obtained from a rotation of the original vector X:

T he covariance m atrix  $S_{\rm P}\,$  of the principal components is then given by

as desired. The rst principal component  $P_1$  then represents the particular linear combination of the original variables X $_{\rm i}$  (am ong all possible such combinations that yield mutually uncorrelated variables) that has the largest variance, with the second principal component possessing the second largest variance, and so on.

From (4) and (B4) one sees that the elements of the ith

row of the K L transform correspond to the n samples or scores of the ith principal component. That is, if we denote the sample vector of the ith principal component by  $p_i = (p_{i1}; ...; p_{in})$ , then  $p_{ij} = u_i \quad y = i_j$ . For this reason in the PCA context the K L transform is called the m atrix of scores.
