THEN-SOLITON OF THE FOCUSING NONLINEAR SCHROD INGER EQUATION FOR N LARGE

#### Abstract

W e present a detailed analysis of the solution of the focusing nonlinear Schrodinger equation $w$ ith initial condition $(x ; 0)=N \operatorname{sech}(x)$ in the $\lim$ it $N!1 . W$ e begin by presenting new and more accurate num erical reconstructions of the N -soliton by inverse scattering (num erical linear algebra) for $N=5,10,20$, and 40. W e then recast the inverse-scattering problem as a $R$ iem ann $H$ ilbert problem and provide a rigorous asym ptotic analysis of this problem in the large-N lim it. For those ( $x$; t ) where results have been obtained by other authors, we im prove the error estim ates from $O\left(\begin{array}{ll}(N \quad 1=3\end{array}\right)$ to $O\left(\mathbb{N} \quad{ }^{1}\right)$. W e also analyze the Fourier power spectrum in this regim e and relate the results to the optical phenom enon of supercontinuum generation. W e then study the $N$-soliton for values of ( $x ; t$ ) where analysis has not been carried out before, and we uncover new phenom ena. The $m$ ain discovery of this paper is the $m$ athem atical $m$ echanism for a secondary caustic (phase transition), which tums out to di er from the $m$ echanism that generates the prim ary caustic. Them echan ism for the generation of the secondary caustic depends essentially on the discrete nature of the spectrum for the N -soliton, and m ore signi cantly, cannot be recovered from an analysis of an ostensibly sim ilar $R$ iem ann $H$ ilbert problem in the conditions of which a certain form al continuum lim it is taken on an ad hoc basis.


## 1. Introduction

It is well known (see, e.g., [13]) that the solution of the initial-value problem for the focusing nonlinear Schrodinger equation

is a special solution called the $N$-soliton. This solution is rapidly decreasing in $\dot{k} j$ and periodic in $t w$ ith period independent of N . To further describe this solution, we recall that (1I) is exactly solvable via the inverse-scattering fram ew ork introduced by Zakharov and Shabat in [1] ]. There are three steps in the procedure:
(i) forward scattering | the initial data generates the scattering data which consists of eigenvalues, proportionality constants, and a re ection coe cient;
(ii) tim e evolution | the scattering data have a sim ple evolution in tim e;
(iii) inverse scattering | the solution of the partialdi erentialequation at later tim es is reconstructed from the tim e-evolved scattering data.
For the special initial data $[\underset{\sim}{[1})$, Satsum a and Ya \#̈m a [1] $]$ have show $n$ that the re ection coe cient is identically zero and there are $N$ purely im aginary eigenvalues. Such a re ectionless solution whose eigenvalues have a com $m$ on realpart is an $N$-soliton.
 For the rst few positive integer values of $N$, it is possible to $w$ rite down explicit form ulas for these exact solutions of the nonlinear partial di erentialequation (II). H ow ever, these form ulae rapidly becom e unw ieldy. Even for $N=3$, the form ula is already quite com plicated and hard to analyze. Am azingly, while these form ulae grow increasingly com plicated as N increases, it is also true that certain orderly features em erge in the $\lim$ it $N!1$.

where $\sim=\sim_{N}:=A=N$ and $A>0$. Studying the large $N$ lim it of the $N-$ soliton is thus equivalent to studying

 in the num ericalexperim ents of $M$ iller and $K$ am vissis [1] ] , and the rst, a so-called prim ary caustic curve in the ( $x$; t)-plane, w as rigorously explained by $K$ am vissis, $M$ cLaughlin, and $M$ iller [1d]. H ere, our $m$ ain result is a description of the $m$ echanism for the observed second phase transition; it di ers from the rst one.
 is the case here, the re ection coe cient is absent, the algebraic-integralsystem that one expects to solve to reconstruct the solution of $(\bar{i})$ ) for generic in itial data reduces to a linear algebraic system. W e derive such a system in $x$ 柋 below . W e also show, in x $\times 1,1$, that the reconstruction step can be cast as a discrete $R$ iem annH ilbert problem for a m erom orphic 22 m atrix unknow. W e use the linear algebraic system as a basis for num erically com puting the N -soliton while the R iem ann H ibert form ulation provides the starting point for our asym ptotic analysis. In either case, the reconstruction of the solution begins $w$ ith the eigenvalues

In x $x$ we describe how to explicitly modify the discrete $R$ iem ann $H$ ibert problem we obtain in x to arrive at an equivalent problem that is conducive to rigorous asym ptotic analysis in the lim it N ! 1 (or equivalently ~! 0). In x 132 we convert the discrete $R$ iem ann $H$ ibert problem into a conventional $R$ iem ann $H$ ilbert problem for an unknow $n$ w ith speci ed jum $p$ discontinuities across contours in the com plex plane. N ext, we show how to \precondition" the resulting $R$ iem ann H ilbert problem for the lim it N ! 1 by introducing a scalar function $g()$ that is used to capture the $m$ ost violent asym ptotic behavior so that the residualm ay be analyzed rigorously. In som e cases, the function $g()$ leads to an asym ptotic analysis in the lim it N ! 1 based on the theta functions of hyperelliptic $R$ iem ann surfaces of even genus $G$, and in such cases the function $g()$ can be constructed explicitly, as we show in xi3.4. This construction forces certain dynam ics in $(x ; t)$ on the $m$ oduli (branch points) of this $R$ iem ann surface, and in xin. the $m$ oduli satisfy a universal system of quasilinear partialdi erentialequations in $R$ iem ann-invariant form, the $W$ hitham equations. The success or failure of the function $g()$ constructed in this $w$ ay in capturing the essentialdynam ics asN! 1 hinges upon certain inequalities and topologicalconditions on levelcurves that are described in x $w$ ith the asym ptotic analysis, which is based on a steepest descent technique for $m$ atrix $R$ iem ann $H$ ibert


The theory outlined above provides, through a handful of technicalm odi cations, a re nem ent of results previously obtained by $K$ am vissis, $M$ cLaughlin, and $M$ iller [1]. The key techincal im provem ents are the avoidance, through a dual intenpolant approach developed in [1] and M1], of a local param etrix near the origin in the com plex plane and the explicit and careful tracking of the errors in replacing a distribution of point $m$ asses representing condensing soliton eigenvalues by its weak continuum lim it, encoded in certain functions S ( ) and T ( ). These extra steps allow us to deduce the sam e asym ptotic form ulae obtained in [ $\left[_{2}^{-1}{ }^{-1}\right]$ goveming the sem iclassical lim it up to and just beyond the prim ary caustic curve in the ( $x$; $t$ )-plane, but with an im proved error estim ate that is $0(\sim)$ (which beats the $O\left(\sim^{1=3}\right)$ estim ate in $\left.[1-1]\right)$.

It is fair to say that $m$ uch of the work in analyzing the $N$-soliton in the lim it of large $N$ com es about from vanquishing the poles representing the soliton eigenvalues from the $m$ atrix-valued $R$ iem ann $H$ ilbert problem that represents the inverse-scattering step. In som e sense, the poles disappear $w$ th the interpolation step that converts the discrete $R$ iem ann $H$ ilbert problem with poles but no jum $p$ discontinuities into one $w$ ith jum $p$ discontinuities and no poles. On the other hand, this is only a partialsolution, since the jum p m atrix
relating the boundary values taken along a curve of jum $p$ discontinuity extends from this curve as an analytic function $w$ ith poles at the soliton eigenvalues. H ow ever, as long as the jum $p$ contour rem ains bounded aw ay from these poles, it is a reasonable approxim ation that can be controlled rigorously to replace the jum $p$ $m$ atrix by another one in which the distribution of poles is \condensed" into a continuous distribution with an analytic density. M aking this replacem ent on an ad hoc basis changes the problem. W e refer to this changed inverse-scattering problem as the form al continuum -lim it problem and we discuss it brie y in $\times$ bi $T$ he form alcontinuum -lim it problem indeed gives the correct asym ptotics of the $N$-soliton and related in itial data for the sem iclassical focusing nonlinear Schrodinger equation ( $\bar{S}_{1}$ ) sub ject to the above caveat, and it even form s the starting point for the analysis of $\left.\overline{1} \overline{1} \bar{T}_{1}^{1}\right]$.

Interestingly, the choice of the function $g()$ tums out to have the follow ing tw o properties:
It depends only on the analytic weak lim it of the discrete distribution of soliton eigenvalues.
It determ ines the contours of the $R$ iem ann $H$ ilbert problem of inverse scattering, and in particular their relation to the locus of accum ulation of the discrete soliton eigenvalues.
So, from the rst property, $g()$ does not know about the poles of the jum $p m$ atrix, and from the second property it chooses the contours appropriate for the asym ptotic analysis. It is therefore possible that the contours selected by choice of $g$ ( ) could cross the locus of accum ulation of discrete eigenvalues. A nd once the contours are no longer bounded aw ay from the poles, the form al continuum -lim it problem is not the correct $m$ odel for inverse scattering.

It tums out that, in the region beyond the prim ary caustic curve, this actually happens. In other words, the dependence of the fiunction $g()$ on $(x ; t)$ predicts a contour that as $t$ increases passes through the branch cut that is the continuum lim it of the pole distribution. At this point, the rigorous analysis m ust break down. Signi cantly, however, this is not the $m$ echanism for further phase transitions. It tums out that the di culty is a technical one that can be rem oved w ith the further use of the $m$ ulti-interpolation $m$ ethod developed in $\left[1 \overline{1}_{1}^{\prime}\right]$ and $[\underline{11}]$. The additional steps that are required to surm ount this crisis, and to therefore prove that there is no phase transition when curves determ ined from the function $g()$ cross the pole locus, are described in $\times 3.9$

The analysis described in x 3.9 is new, and one of the new features is the appearance of a new inequality that $m$ ust be satis ed by the fiunction $g()$ on certain contours. It tums out that the failure of th is inequality is the $m$ athem atical $m$ echanism for the next phase transition of the $N-$ soliton, a secondary caustic curve in the $(x ; t)$-plane.

Before studying the secondary caustic, we discuss brie $y$ in $x$ '4, the quiescent region of the ( $x$; $t$ )-plane before the prim ary caustic curve. W e recall in xiA som e inform ation from [1] $]$ about the relation betw een the dynam ics of the N -soliton in this region and a fam ily of hyperelliptic R iem ann surfaces of genus zero. $W$ e also discuss the $m$ athem aticalm echanism behind the prim ary caustic phase transition, which tums out to correspond to an instantaneous jum p from genus zero to genus two. Then, in xi42, we analyze the Fourier power spectrum of the N -soliton in the region before the prim ary caustic, and show that its evolution is consistent w ith the supercontinuum generation phenom enon of current interest in optical science (see below).

In carrying out a study of the $N$-soliton for large $N$, three di erent com putational techniques com e to $m$ ind:
(i) D irect num ericalsim ulation of the in itial-value problem for the focusing nonlinear Schrodinger equation $\overline{(\overline{3}} \mathbf{1})$ in the sem iclassical lim it. By adapting discretization $m$ ethods to this problem, it is possible to study the dynam ics of the $N$-soliton as well as m uch m ore general initialdata, and also non-integrable variants of ( $\overline{3}$ ). H ow ever, thesem ethods are severely constrained in the lim it of interest due to num erical sti ness, and worse yet, m odulational instability that is exponentially strong in N. See $\bar{L}_{1}^{1}$
(ii) N um erical solution of the inverse-scattering problem for the focusing nonlinear Schrodinger equation. This m ethod applies only to the integrable equation $(\vec{i})$, and like the direct num erical sim ulation m ethod is also ill-conditioned in the sem iclassical lim it. H ow ever, it a ords an im portant advantage over direct num erical sim ulation, nam ely that the solution is calculated independently for each ( $x$; $t$ ), and therefore roundo errors do not accum ulate.
(iii) Num erical construction of the fiunction $g()$. This m ethod also applies only to the integrable equation $\left(\overline{3} \bar{\beta}_{1}\right)$, and it is further constrained in that it is only m eaningful in the sem iclassical lim it. H ow ever, it speci cally takes advantage of the $m$ athem aticalstructure of th is lim it, and consequently the num erical calculation is extrem ely well-conditioned.
 betw een the prim ary and secondary caustics for the $N-$ soliton. W hile a num erical calculation, this is clearly fundam entally di erent from either the num erical solution of linear algebra problem s equivalent to inverse scattering for the $N$-soliton as in $x$, corresponding to the N -soliton. It is w ith the help of these calculations that we observe the crossing of the pole locus (which does not correspond to the secondary caustic, as can be seen once the analysis is $m$ odi ed
 caustic phase transition).

In $x_{1}^{\prime}$-1w w take up the question of exactly what happens to the $N-s o l i t o n ~ i m ~ m ~ e d i a t e l y ~ b e y o n d ~ t h e ~ s e c o n d a r y ~$ caustic curve in the ( $x ; t$ )-plane. W e characterize the secondary caustic (failure of the new inequality from x 3.9 ) as the occurance of a criticalpoint on a level curve de ning the boundary of the region in the com plex plane w here the relevant inequality holds. W e then $m$ ake the guess that the failure ofg ( ) corresponding to a $R$ iem ann surface ofgenus two in this new way is resolved by going over to a form ula forg ( ) corresponding to a $R$ iem ann surface of genus four, but w ith signi cantly di erent topological features than in the (hypothetical) case that genus tw o fails due to the violation of the sam e inequality that leads to the prim ary caustic. $W$ e construct $g()$ in this new situation, and obtain an im plicit description of the $m$ oduli of the corresponding genus four $R$ iem ann surface. These are new form ulae that have a di erent character than those obtained earlier. W e then prove that these new formula provide another solution to the sam e type of $W$ hitham equations that govem the $m$ oduli in the case of sim pler contour topology.

W e conclude the paper w th som e hypotheses regarding further phase transitions (higher-order caustics) for the N -soliton and related in itial-value problem sfor [i]), and by stressing once again that the phenom enon of the secondary caustic (and possibly furtherphase transitions) is fundam entally linked to the discrete nature of the eigenvalue distribution, which forcesm odi cations to the analysis as described in x ${ }^{13} .{ }^{-1} y_{1}$ and introduces coincident inequalities to be satis ed by $g()$. These inequalities are simply not part of the asym ptotic theory of the form al continuum -lim it problem discussed in x 3.8 , and therefore the latter problem is unable to correctly predict the secondary caustic. This cam e as som e surprise to us, as we and other authors had alw ays assum ed that either the form al continuum -lim it problem govems the dynam ics for all tim e or that the secondary caustic occurs upon crossing the locus of eigenvalues. B oth of these are incorrect.

The problem ( $\overline{-1})$ for sm all ~ is relevant as a m odel for the propagation of light pulses in optical bers that have the property of weak (because ~ is small) anom alous dispersion. T here has alw ays been great interest in optical bers w ith weak dispersion. In itially this was because when such bers are operated in the linear regim e (sm all am plitude) the propagation is $\mathrm{im} m$ une to dispersive spreading of pulses that is considered to degrade a data stream. For long ber links, how ever, the theory of linear propagation becom es inadequate due to the accum ulation of weakly nonlinear e ects. M ore recently these bers have becom e im portant again because it becam e clear that advantage could be taken speci cally of the nonlinearity. Indeed, when operated in the w eakly nonlinear regin e ( $m$ oderate am plitude) nonlineare ects are $m$ uch stronger com pared to lineare ects and therefore propagation in such bers can drastically alter the pow er spectrum of a signal, possibly in a usefulway. Indeed, one of the applications envisioned for weakly dispersive bers is so-called supercontinuum generation (see, for exam ple, into the ber and spectrally broadened under propagation so that the output is a coherent source of white light. The output can then be ltered to produce coherent light of virtually any frequency, which is desirable for w avelength division $m$ ultiplexing telecom $m$ unication system $s$. The $m$ ost prom ising current technology for creating optical bers w th very low dispersion, in both the norm al and anom alous regin es, is based on photonic crystal bers, which are $m$ ade from ber preform $s w$ ith extrem ely com plicated cross sections. $T$ he complexity of the cross section is preserved to the $m$ icroscopic level upon draw ing the ber (carefiully stretching the cylindrical ber preform along its axis untilan optical ber results), and as the possibilities for cross sections go far beyond the traditional core/cladding/jacket step-index model it is possible to engineer bers w ith properties thought im possible until recently [9].
In this paper, we m ake frequent use of the three $P$ aulim atrices:

W e use boldface notation (e.g. $m$ or $P$ ) throughout for square $m$ atrices, $w$ ith the exception of the identity $m$ atrix $I$, and arrow notation for colum $n$ vectors (e.g. $v$, w th row-vectortranspose $\mathrm{w}^{\mathrm{T}}$ ). C om plex con jugation
is indicated with an asterisk, and $P$ eans the $m$ atrix whose elem ents are the com plex conjugates of the corresponding elem ents of $P$ (no transpose).

## 2. Linear Systems D escribing the N -Soliton

2.1. Theory. The spectral data $\overline{(\bar{T}} \overline{1})\{(\bar{G})$ can be used to set up a system of linear equations whose solution $y$ ields the $N$-soliton for arbitrary ( $x ; t$ ). (See, for exam ple, the discussion in C hapter 2 of $[1010]$.) To arrive at such a square inhom ogeneous system, we begin by de ning expressions

C learly, the equations ( $\left(\overline{1} \overline{1}_{-1}^{\prime}\right)$ and (12 $A_{p}(x ; t)$ and $C_{p}(x ; t)$, with coe cient $m$ atrices ofblock $-V$ anderm onde type. O ne approach to com puting the value of ${ }_{N}(x ; t)$ for $x e d(x ; t)$ is then to solve this linear algebra problem and then obtain $n(x ; t)$ from (13). This approach was used in [1] to nd ${ }_{N}(x ; t)$ on a grid of values of $(x ; t)$ for $N=5, N=10$, and $\mathrm{N}=20$. T here is an advantage here over direct num erical sim ulation of the focusing nonlinear Schrodinger equation in that num erical errors do not propagate from one value of $t$ to another.

W hile the above approach is attractive, it can be $m$ ade $m$ ore so by reducing the problem explicitly to a linear algebra problem involving $m$ atrices of size only $N \quad N . W$ e use Lagrange interpolation and (111) to express $C(x ; t ;)$ in term $s$ of the values $A(x ; t ; n ; k) ; k=0 ;:: ; N_{1} \quad$. Thus,

In general, num erical integration of the in itial-value problem ( $\overline{\sin })\{(\overline{4})$ for the sem iclassically scaled focusing nonlinear Schrodinger equation is di cult; the problem is notoriously sti due to multiple scales. The presence of sm all oscillations (m icrostructure) of wavelength and period of order ~ requires that one use a tim estep proportional to $\sim$ while resolving the larger scale structures ( $m$ acrostructure) necessitates that the num ber of tim esteps $m$ ust be of order ~ ${ }^{1}$. In addition, to accurately com pute the spatialm icrostructure, the num ber of gridpoints/Fourier $m$ odes $m$ ust also be proportional to $\sim^{1}$. Thus, sim ulating the sem iclassical lim it is com putationally intensive, and the accum ulation of roundo errors is a serious issue. W hat is particularly striking in this sequence of gures is how the boundary betw een these two behaviors of the solution appears to becom e increasingly sharp as $N$ increases. T w o features of this solution are im portant for the subsequent steps in the analysis. First, the dependence of the solution on ~ enters through the realquantities $j=\sim$ and $j=\sim$, which determ ine a point in the real part of the Jacobian variety of $X$, topologically a torus of dim ension $G$. Essentially, this point is a phase shift in the argum ent of the $R$ iem ann theta functions used to construct the solution, and in particular this im plies that the $m$ atrix $P()$ rem ains uniform ly bounded for aw ay from the band/gap endpoints in the lim it ~! 0, even though the phase point oscillates $w i l d l y$ in the Jacobian in this lim it. The im provem ent com es from (i) the modi cations of the contours near $=0$ which obviates the need for a local param etrix near the origin (this was also used to handle \transition points" in [1]) and (ii) the carefiltracing of the in uence of the finctions S ( ) and $T($ ) through the asym ptotics, especially their explicit rem oval near the band/gap endpoints via the near-identily transform ations P ! Q .
3.8. The form al continuum -lim it problem. M uch of the above analysis is based on the facts that $S()=1+O(\sim)$ and $T()=1+O(\sim)$ under the assum ptions in force on the relation betw een the contours on which these functions appear in the jump $m$ atrix and the contours $C$ and $C_{1}$. $T$ hese two functions $m$ easure the di erence betw een the discreteness of the eigenvalue distribution and a natural continuum lim it
thereof (a weak lim it of a sequence of sum s of point masses). It is tem pting to notice the role played by the approxim ations S ( ) 1 and T ( ) 1 in the rigorous analysis and propose in place of the problem for P ( ) an ad hoc \continuum -lim itl R iem annHilbert problem for a matrix P ( ); the conditions of this $R$ iem ann $H$ ilbert problem are precisely the sam e as those of the $R$ iem ann $H$ ilbert problem goveming $P$ ( ) except that in all cases one $m$ akes the substitutions $S()!1$ and $T()!1$.
$T$ he rigorous analysis described earlier proves that, as long as the contour geom etry adm its the approxim ations $S(1) 1$ and $T() 1$ onem ay also com pute the asym ptotic behavior of the $N-$-soliton by studying the form al continuum -lim it $R$ iem ann $H$ ilbert problem for $P$ ( ). How ever, it tums out that there are som $e$ circum stances in which the conditions that constrain the contours of the $R$ iem ann $H$ ilbert problem for $P$ ( ) are inconsistent with the approxim ations S () 1 and $T$ ( ) 1. W e will show that this is not merely a technical inconvenience standing in the way of analyzing the large $N$ lim it with the help of the form al continuum -lim it R iem ann $H$ ilbert problem for $P^{r}()$, but that the $m$ odi cations necessary to com plete the analysis ofP ( ) rigorously under these circum stances introduce new $m$ athem atical features that ultim ately provide the correct description of the secondary caustic.

N ote also that making the substitutions S ( ) ! 1 and T ( ) ! 1 is com pletely analogous to the ad hoc
 suggest that extrem e care $m$ ust be taken in relating asym ptotic properties of the $m$ atrix $P$ ( ) w ith those of the $m$ atrix P ( ) . P robably it is better to avoid analyzing P ( ) and instead keep track of the errors by working (as we do in this paper) w ith P ( ) directly.
3.9. D ual interpolant $m$ odi cation necessary for contours passing through the branch cut. This can happen because the function $L$ ( ) is de ned relative to the contour $C$ which while having the sam e endpoints as $[0 ; i A]$, is otherw ise arbitrary, and the endpoint equations are analytic as long as the endpoint variables are distinct and avoid C. Thus, it can (and does) happen that a band I evolves in $x$ and $t$ so as to com e into contact with the locus of accum ulation of eigenvalues. W hen this occurs, we have to reconcile the facts that on the one hand the solution of the endpoint equations $m$ ay be continued (by choice of $C$ ) in $x$ and $t s o$ that the band I passes through the interval [0;iA] com pletely, while on the other hand the function S ( ) can no longerbe controlled and the continuum -lim it approxim ation can no longer be justi ed in the sam e way.
$T$ he situation can be recti ed in the follow ing way. Retuming to the $m$ atrix $m$ ( ) solving the discrete $R$ iem ann $H$ ibert problem characterizing the $N$-soliton, we rem ove the poles by taking into account three di erent interpolants of residues rather than just tw $O$. W hen $t=t_{1}(x)$ the hyperbolic branches degenerate to lines crossing at $={ }^{\wedge}(x ; t)$. This mechanism for the form ation of the prim ary caustic is illustrated in the spectral plane in $F$ igures 6.11 and 6.12 of [1] ${ }^{-1}$ ]. In particular, it is known in the case of the $N$-soliton that $t_{1}(x)$ is an even function and inf $f_{x 2 R} t_{1}(x)=t_{1}(0)=(2 A)^{1}$. In $[1 \overline{1} \overline{1}]$ it is show $n$ that if $\dot{x} j$ decreases $w$ ith $t$ xed from a point ( $x_{\text {crit }} ; t_{\text {crit }}$ ) at which (1991) holds, then the genus-tw o ansatz takes over. A new band is bom w ith two new endpoints $1(x ; t)$ and $2(x ; t)$ em erging from the double point ${ }^{\wedge}$ where the singularity of the level curve for $\left.<(1)\right)=0$ occurs. Therefore, the prim ary caustic is a phase transition between genus zero and genus two.

In fact, the conditions ( $\mathbf{1}^{-1} \mathbf{-}^{\prime} 9^{\prime}$ ) are not speci c to the failure of the genus-zero ansatz, but $m$ ay be considered for any genus, being as they sim ply describe the change in connectivity of the region where the essential inequality $<(())<0$ holds. Thus, we may consider the conditions (199) for general even genus w ith the aim of determ ining whether phase transitions beyond the prim ary caustic can occur for the N -soliton. Sim ultaneous solutions of the tw o equations in (1991) can be interpreted as collisions betw een branches of the level curve $<(())=0$, and these branches $m$ ay em anate from band/gap endpoints $k(x ; t)$, or from the branch cut $C$, or they $m$ ay be noncom pact. (A s level curves of a harm onic fiunction they cannot close on them selves unless they enclose a singularity of ( ) .) A s shown in $F$ igures 6.11 and 6.12 of $[1]$ d, the prim ary caustic is caused by the collision of a noncom pact branch com ing in from in nity with a branch joining $o(x ; t)$ to the origin. It is not di cult to analyze the function () for generaleven genus to determ ine its singular points and asym ptotic behavior as ! 1 , and such analysis leads to the conclusion that for genus two no further branches exist for large that can eventually collide with branches connecting band/gap endpoints. This fact suggests that further phase transitions (higher-order caustics), if they exist, $m$ ay com e about for a di erent reason than the prim ary caustic. The $m$ ain point of this paper is to show that a secondary caustic indeed occurs for the $N$-soliton in the large $N$ lim it, and that its $m$ echanism is indeed di erent from that leading to the form ation of the prim ary caustic.
$T$ he validity of the genus-zero ansatz for $g()$ for $s m$ all tim $e$ is in fact established in "ld] for a general class of $\backslash$ re ectionless" initial data for the focusing nonlinear Schrodinger equation that leads to a discrete $R$ iem ann $H$ ilbert problem for $m$ ( ) of the sort relevant in the study of the $N$-soliton. Sim ilar results have been found by Tovbis, Venakides, and Zhou [1"- ${ }^{-1}$ ] for certain special-fiunction initial conditions that are not re ectionless.
42. Fourier power spectrum and supercontinuum frequency generation. In applications of the focusing nonlinear Schrodinger equation to nonlinear ber optics, the lim it ~ \# 0 is interesting because it corresponds to weak dispersion, a situation in which nonlinear e ects are dom inant over linear dispersive e ects. W hile conservative linear e ects leave the Fourier power spectrum of a signal unchanged, strongly nonlinear e ects can change the spectrum signi cantly, and one application of weak dispersion in ber optics is the generation of broadband spectra from input signals with a narrow power spectrum. This is know $n$ in the literature as supercontinuum generation. $W$ hile it is som etim es thought that supercontinuum generation occurs as a result of the wave breaking at the prim ary caustic, in fact the e ect is already present for $t<\inf _{x 2 R} t_{1}(x)$. Indeed, in this region, the $N$-soliton has, for each $x 2 R$ the representation (1911) corresponding to the genus-zero ansatz for $g()$. M oreover (see $\left[10_{-1}^{\prime}\right]$ ) in the genus-zero case,

The w eak convergence of the pow er spectrum to a broad plateau of spectralw idth (on the ! scale) of ${ }^{1} \mathrm{M}$ can be considered as evidence of supercontinuum frequency generation for the N -soliton in the genus-zero region, before any w ave breaking occurs. Furthem ore, these calculations show that the broad spectralplateau develops in absence of the R am an e ect or higher-order dispersion, which are not part of the basic nonlinear Schrodinger m odel but are frequently thought to play an im portant role in supercontinuum generation.

## 5. Numerical Computation of Endpoints and Contours in the Genus-Two Region

O urm ain interest in this paper is to analyze the $N$-soliton in the genus-tw o region to determ ine and explain the $m$ echanism for the secondary caustic curve that can be observed in $F$ igures, 124 there are three com plex endpoints $0(x ; t), 1(x ; t)$, and $2(x ; t)$ that satisfy the six realequations

W e wrote a M atlab code that continues a solution of these equations along a path from point ( $\mathrm{x}_{0} ; \mathrm{t}_{0}$ ) at which a solution is known for which the Jacobian of the system is nonsingular to a nearby point ( $x_{1} ; t_{1}$ ). W ith the help of these form ulae, we could employ our continuation code beginning w ith a point slightly beyond the prim ary caustic where the three endpoints are distinct. Thus, wem ay obtain num erically, for any ( $x ; t$ ) beyond the prim ary caustic, the analytic solution of the equations (213) that correctly em erges from the prim ary caustic.

W e also w rote a $M$ atlab code that takes a point $(x ; t)$ beyond the prim ary caustic and the corresponding endpoints $0(x ; t), 1(x ; t)$, and $2(x ; t)$ as input, and com putes the band $I_{0}$ connecting $0(x ; t)$ to the origin
and the band $I_{1}$ connecting $1(x ; t)$ and $2(x ; t)$ by integrating num erically the equation $<(\mathbb{R}() Y() d)=0$ to determ ine the level curves. The code also nds the regions of the com plex plane where the inequality $<(())<0$ holds; the gaps 1 connecting $0(x ; t)$ to $1(x ; t)$ and 2 connecting $2(x ; t)$ to an neighborhood of the origin must lie in these regions. By plotting this inform ation, we can visualize the dynam ics of the genus-two ansatz in the spectralplane, and hopefully determ ine the nature of the secondary caustic.

A representative sequence of such plots is given in $F$ igure $\overline{12}$. H ere we see the bands of the $G=2$ contour in red and the region where the inequality $<(())<0$ holds shaded in blue. For the contour $C$ we sim ply take the im aginary interval [ 0 ; $i A]$, show $n$ w th a black line. Each spectral plot is paired with a plot like $F$ igure the genus-two con guration for a point in the $(x ; t)$-plane just beyond the prim ary caustic. $T$ he band $I_{1}$ in the left halfelane has just been bom from a point ${ }^{\wedge}$ where ( $\left.\mathbf{1 9}^{-} 9{ }^{-1}\right)$ holds. The bands can clearly be joined together w ith gaps 1 and 2 lying in the shaded regions to complete a contour $\mathrm{K}_{0}[\mathrm{~K} \quad 1$ that encircles the locus of poles form ( ). N otioe, how ever, that according to the subsequent plots in this gure the band $I_{1}$ approaches the locus of accum ulation of poles for $m$ ( ) as $t$ increases. A lthough a collision of one of the endpoints $w$ ith the interval [ 0 ; iA ] w ould im ply a failure of the genustwo ansatz in its original form ulation (that is, $w$ thout the $m$ odi cation described in $x \overline{3} \cdot \overline{9})^{\prime}$, it is clear by com parison $w$ th the corresponding ( x ; t)-planeplots that the secondary caustic is still far o .
$F$ igure $1 \overline{1} 1$ interval $[0 ; i A]$, so we m ust sw itch to the m odi ed version of the genus-tw o ansatz described in x 3
 along this contour. The region where this inequality is satis ed is shaded in green. The deform ed contour $C$ we choose here, som ew hat arbitrarily, is the union of the tw o indicated solid black line segm ents. It is clear that in each case the bands $m$ ay be com plem ented $w$ ith gaps in the blue regions to form (along $w$ ith a sm all interval ( ;0)) a closed loop. In cases where this loop necessarily cannot enclose the poles ofm ( ) accum ulating in [0;iA ], it is clear that a curve K 3 lying entirely in the green shaded region $m$ ay be added that passes over the top of $[0 ; i A]$ and form s along w ith parts of the above closed loop the boundary of a region contain ing the poles.

In $F$ igure $\overline{1}_{2}^{1} \overline{4}_{1}^{\prime}$ w e continue the evolution tow ard a curve in the $(x ; t)$-plane at which the asym ptotic behavior abruptly changes for the second tim e, where we expect to nd a $m$ athem aticalexplanation for the secondary caustic. N ote that betw een the last two snapshots there is a pinch-o of the green shaded region where $<\left(() 2 i^{0}()\right)<0$. W hen this happens, a contour lobe $K 3$ that serves to bound the region containing the poles ofm ( ) (soliton eigenvalues) and also along which the inequality < ( ( ) $2 i^{0}$ ( )) < 0 holds can no longer exist. $T$ his is the $m$ athem atical $m$ echanism for the developm ent of the secondary caustic.

To dem onstrate $m$ ore convincingly that the secondary caustic in the num erical reconstructions of the N -soliton solution for large N actually corresponds to the curve in the ( $x ; t$ )-plane along which the region in which the inequality $<\left(() 2 i^{0}()\right)<0$ is pinched $o$ at a point, we used a secant $m$ ethod to nd, for a given $x$, the $t-v a l u e$ at which $<\left({ }^{\wedge}\right) 2 i^{0}(\hat{)})=0$ where ${ }^{\wedge}$ is a complex root of ${ }^{0}() 2 i^{00}()$. This $m$ ethod yields (approxim ate) coordinates of points in the ( $x$; $t$ )plane at which the con guration of level curves $m$ akes a transition betw een the two types of con gurations illustrated in the nal two fram es of Figure '11 . T hese points lie along a curve $t=t_{2}(x)$ that de nes the location of the secondary caustic. C on gurations corresponding to three of the points we obtained in this way are illustrated in F igure ${ }^{1} \overline{15}^{\prime}$.

K now ing that they adm it the solution $=\quad=0 \mathrm{when}(x ; t)$ is a point on the secondary caustic, wew ish to solve them for the variables and for nearby ( $x ; t$ ). W ew ill show that there is a unique solution satisfying the condition that and are complex conjugates of each other for real $x$ and $t$ (there are other solutions that bifurcate from $=\quad=0$ that do not have this sym $m$ etry, which is the prim ary source of di culty). W e de ne polar coordinates by

Being as the complexi cation of $R_{2}$ can be written as the average of two integrals, one on a path surrounding the two endpoints 3 and 4 and the other on a path surrounding the two endpoints ${ }_{3}$ and ${ }_{4}$, it is easy to see that $R_{2}$ is an even function of and individually that vanishes when $=\quad=0$, and therefore the equation $R_{2}=0$ has the form

$T$ his equation clearly de nes tw o analytic curves crossing orthogonally at the origin in the realpolar plane, w ith angles $=(\mathrm{x} ; \mathrm{t})+=4+\mathrm{n}=2$.
$N$ ow, the complexi ed form of $V_{2}$ de nes a multivalued function of and , even when we restrict to the real subspace w here these tw o variables are com plex con jugates ofeach other. This com es about because the value of the integralterm inating at 3 in $V_{2}$ can change its value if 3 and 4 are perm uted. Thism onodrom $y$ $e$ ect can, how ever, be rem oved in the real subspace, because the deform ation ( ; ) ! ( $e^{i}$; $e^{i}$ ) for
going from zero to (which exchanges the endpoints and their conjugates) sim ply adds to $V_{2}$ a copy of the function $R_{2}$. This suggests that in place of $V_{2}=0$ we can solve an equivalent $m$ odi ed equation that is single-valued in the real subspace. Indeed, we opt to replace $V_{2}=0$ by $\nabla_{2}^{\#}=0$ where

Here $Y_{+}()$refers to the boundary value taken by $Y()$ on $A_{2}$ from the interior of this closed contour. $C$ learly the equation $\nabla_{2}^{\#}=0$ has the same solutions as does $V_{2}=0$, sub ject to the condition $R_{2}=0$. But
the function $\nabla_{2}^{\#}$ has the advantage ofbeing single-valued in the realpolar plane of ( $r$; ) . M oreover, we $m$ ay $w$ rite $V_{2}^{\#}$ in the form

Here we see that the rst term of $\nabla_{2}^{\#}$ is complexi ed as an analytic function of ${ }^{2}$ and ${ }^{2}$ individually. $T$ herefore it has an expression in the realpolar plane of the form $f(x ; t)+O\left(r^{2}\right)$. The com plexi cation of the second term, while single-valued when and are com plex conjugates of one another, is not single-valued in a full C $^{2}$ neighborhood of $==0$. Therefore it cannot have a tw o-variable Taylor expansion; how ever the factorm ultiplying log (r) clearly is an even analytic function ofboth and that vanisheswhen $=0$ (this is of course just the com plexi cation of the ham onic conjugate $\mathrm{R}_{2}$ ). C onsequently, in the real polar plane we have

Equating this to zero, we see that the balance m ust occur between the $r^{2} \log (r)$ term and the constant term, so the the distance from the secondary caustic scales as $r^{2} \log (r)$ as the new band is bom. T he curve described by (2-4든) near the origin in the polar plane consists of tw o approxim ately hyperbolic branches $w$ th asym ptotes rotated from the curves described by the equation $\mathrm{R}_{2}=0$ by $=4$. Thus, we obtain for each point ( $x$; $t$ ) su ciently close to the secondary caustic a pair of opposite solutions for $=r e^{i}$. As $(x ; t)$ changes sign, the two points com e together at $=0$ and then go back out along the penpendicular direction.

D eterm ination of the sign of $(x ; t)$ analogous to what is carried out in [1] is then needed to show that the points $3(x ; t)$ and $4(x ; t)$ separate in the direction conducive to the com pletion of a genus-four ansatz as long as x decreases (ort increases) as the secondary caustic is crossed. C om bining these steps com pletes the proof that upon crossing the secondary caustic the asym ptotic description of the $\mathrm{N}-$-soliton is given in term $s$ of $R$ iem ann theta functions of genus four.

W e also note that the equations $\mathrm{R}_{2}=0$ and $\nabla_{2}=0 \mathrm{imply}$ that the new band $I_{2}$ and the boundary curves of the region where the inequality $<\left(() 2 i^{0}()\right)<0$ holds are trajectories of the quadratic di erentialR ()$^{2} Y_{+}()^{2} d^{2}$, while the other tw o bands and the boundaries of the region where the inequality $<(())<0$ holds are tra jectories of $R()^{2} Y()^{2} d^{2}$.
62.3. W hitham equations. the conditions $\mathbb{E}_{1}^{2}=\quad \mathrm{E}_{10}^{\sim}=0$ determ ining the endpoints $0 ;::: ; 4$ in the genus-four con guration just beyond the secondary caustic have a di erent form than the relations $\mathrm{E}_{1}=\quad \quad_{10} \mathrm{E}=0$ (for $\mathrm{G}=4$ ) from x the equations $\mathrm{E}_{1}^{r}=\quad \mathrm{E}_{10}=0 . \mathrm{N}$ onetheless, these latter conditions also determ ine im plicitly functions $0(x ; t) ;::: ; 5(x ; t)$ satisfying exactly the sam $e W$ hitham equations.

To reiterate, the only di erence betw een the derivation here and that in the case when no endpoints lie on $K \quad 3$ is in the diagonal factor of the Jacobian consisting of the partial derivatives $@ M_{0}=@ v_{k}$, which certainly are di erent functions of $w$ than the derivatives $@ M \quad=@ v_{k}$. H ow ever, this diagonal factor cancels out of the C ram er's rule form ula for the characteristic velocities $q_{k}(*)$. N ote that the condition that the diagonal factor is nonsingular is, due to (2-4"), equivalent to the function $R() Y()$ which de nes the bands vanishing exactly like a square root at the band endpoints.

## 7. Conclusion

In this paper we have done the follow ing things.
$W$ e used a num erical linear algebra $m$ ethod for com puting the $N-s o l i t o n$ for several values of $N$ as large as $N=40$, plotted the results and described the phenom ena of $m$ acrostructure, $m$ icrostructure, and phase transitions (caustic curves) that becom em ore well-de ned as N ! 1 .
$W$ e have described a new m odi cation of the asym ptotic technique rst used in $\left[\begin{array}{c}{[10]}\end{array}\right]$ to analyze the $N$-soliton for large $N$ that gives an im proved error estim ate of $O\left(N^{1}\right)$ over the cruder estim ate of $0\left(\mathbb{N}^{1=3}\right.$ ) reported in [ $\left[\begin{array}{l}-1 \\ 0\end{array}\right]$.
W e analyzed the Fourier pow er spectrum of the $N$-soliton in the genus-zero region before the prim ary caustic and related the results to supercontinuum generation of coherent broadband spectra from narrow -band sources in optical bers w th w eak anom alous dispersion.
$W$ e com puted num erically for the rst tim $e$ the bands of discontinuly of $g()$ in the genus-two region beyond the prim ary caustic and pointed out the phenom enon of a band crossing the locus of accum ulation of discrete eigenvalues for the $N$-soliton.
$W$ e introduced a new $m$ ulti-intenpolant asym ptotic procedure that allow $s$ the genustw o ansatz for $g()$ to be continued through the discrete eigenvalues, proving that this phenom enon is not the cause of the secondary caustic.
W e observed num erically the failure of a new inequality associated $w$ th the m ulti-intenpolant approach that becom es necessary once a band crosses the discrete spectrum, and we gave evidence that this failure is the $m$ athem atical $m$ echanism for the secondary caustic phase transition.
$W$ e have show $n$ that, under the assum ption that the new inequality indeed fails as we have observed num erically, the secondary caustic represents a change of genus from $G=2$ to $G=4$ but with new topological features of the genus-four ansatz for $g($ ) that have not been seen before. W e also proved that despite the unusual appearance of the im plicit relations de ning the band endpoints in this case, the endpoints still satisfy the $W$ hitham equations.
$T$ he nature of the $m$ athem atical $m$ echanism for the secondary caustic leads us to hypothesize that there could easily be an in nite num ber of caustic curves in the ( $\mathrm{x} ; \mathrm{t}$ )-plane of the N -soliton in the large N lim it. $T$ he scenario we im agine is the follow ing: astincreases for $x e d x>0$, the new band $I_{2}$ that we have show $n$ opens up upon crossing the secondary caustic drifts tow ard the im aginary interval [ 0 ; iA ] of accum ulation of discrete eigenvalues. W hen $I_{2} m$ eets this interval, the analysis fails once again until it is rescued (in
analogy with the m odi cation we introduced in x $\overline{3}-9{ }^{-9}$ ) by adjoining a new contour lobe, K , enclosing a region $D \quad 5$ adjacent to $D \quad 3$ in which the correct intenpolation form ula to use is the analogue of (192) w ith the term $3 i^{0}()$ in the exponent replaced by $5 i^{0}()$. A long $K \quad 5$ we require a new inequality, nam ely $<\left(() 4 i^{0}()\right)<0$. The region in which this inequality holds eventually pinches o (a tertiary caustic), and the situation is resolved by introducing a new band $I_{3}$ on $K \quad 5$ which results in localdynam ics described by $R$ iem ann theta functions of genus six. The reader can then im agine that the process repeats again and again. The kth caustic curve is described by elim inating ${ }^{\wedge}$ from the equations

The formula for ( ) of course changes each time a caustic is crossed and a new band is added. Thus, a harbinger of a developing caustic curve is a recently bom band meeting the im aginary axis. This can be detected just by observing the wave eld as long as (like we see in the num erical constructions of $g$ ( ) in the genus-tw o case) the endpoint crossing the $m$ aginary axis has an im aginary part $m$ uch larger than those of all other endpoints. In this case, the wave eld, although locally described by R iem ann theta fiunctions of som e even genus $G>0$, is well-approxim ated by a com plex exponential fiunction $\left.e^{i(k x}!t\right)=\sim$ (because the genus is \alm ost" zero), and the real part of the dom inant endpoint is proportional to the wavenum ber k . $T$ hus a sign change of $k$, which could be detected by localspectralanalysis, indicates the dom inant endpoint crossing the im aginary axis, an event that precedes the form ation of a new caustic.

W e want to stress that the $m$ echanism for all of the caustics beyond the prim ary caustic depends in a crucial way on the discrete nature of the spectrum for the $N-$ soliton, which causes us to reinvent our $m$ ethod of analysis each time a band wants to cross the discrete spectrum . Signi cantly, if we chose to begin our analysis by assum ing that there is no essential cost in the lim it ~! 0 for analyzing the form al continuum -lim it problem for $P^{\prime}($ ) (in which we sim ply neglect the di erence betw een the discrete spectral $m$ easure and its weak $\lim$ it as $N$ ! 1 ) in place of the exact $R$ iem ann $H$ ibert problem for $P$ ( ), we would not need to m odify our analysis if a band crosses the spectrum, and we w ould not need to introduce the new inequality < ( ( ) $\left.2 i^{0}()\right)<0$ that leads to the secondary caustic. In other words, the form alcontinuum lim it problem corresponds to a solution $\tilde{N}_{N}(x ; t)$ of the focusing nonlinear Schrodinger equation ( $\left.\overline{\underline{3}}\right)$ that accurately resembles the N -soliton $\mathrm{N}(\mathrm{x} ; \mathrm{t})$ for ( $\mathrm{x} ; \mathrm{t}$ ) in the region before the secondary caustic, but not beyond. In particular, the solution obtained from the form al continuum-lim it problem does not experience any phase transition at all when the N -soliton experiences the secondary caustic. Of course, as the form al continuum -lim it problem $m$ ay break the even sym $m$ etry of the $N$-soliton (recall xi32 2 grounds for expecting any sim ilarity betw een $N_{N}(x ; t)$ and $\tilde{N}_{N}(x ; t)$ for any $x$ and $t$, and therefore it seem $s$ to us that we m ust therefore regard the correspondence before the secondary caustic as a lucky coincidence.
