# THE N-SOLITON OF THE FOCUSING NONLINEAR SCHRODINGER EQUATION FOR N LARGE

A bstract. We present a detailed analysis of the solution of the focusing nonlinear Schrodinger equation with initial condition  $(x;0) = N \operatorname{sech}(x)$  in the lim it N + 1. We begin by presenting new and more accurate numerical reconstructions of the N-soliton by inverse scattering (numerical linear algebra) for N = 5, 10, 20, and 40. We then recast the inverse-scattering problem as a Riemann-Hilbert problem and provide a rigorous asymptotic analysis of this problem in the large-N lim it. For those (x;t) where results have been obtained by other authors, we improve the error estimates from  $O(N^{-1-3})$  to  $O(N^{-1})$ . We also analyze the Fourier power spectrum in this regime and relate the results to the optical phenom enon of supercontinuum generation. We then study the N-soliton for values of (x;t) where analysis has not been carried out before, and we uncover new phenom ena. The main discovery of this paper is the mathematical mechanism for a secondary caustic (phase transition), which turns out to di er from the mechanism that generates the prim ary caustic. The mechanism for the generation of the secondary caustic depends essentially on the discrete nature of the spectrum for the N-soliton, and more signi cantly, cannot be recovered from an analysis of an ostensibly sim ilar Riem ann-Hilbert problem in the conditions of which a certain form all continuum lim it is taken on an ad hoc basis.

#### 1. Introduction

It is well known (see, e.g., [13]) that the solution of the initial-value problem for the focusing nonlinear Schrodinger equation

with initial data

is a special solution called the N-soliton. This solution is rapidly decreasing in jxj and periodic in t with period independent of N. To further describe this solution, we recall that (1) is exactly solvable via the inverse-scattering fram ework introduced by Zakharov and Shabat in [16]. There are three steps in the procedure:

 $(x;0) = N \operatorname{sech}(x)$ 

- (i) forward scattering | the initial data generates the scattering data which consists of eigenvalues, proportionality constants, and a rejection coe cient;
- (ii) time evolution the scattering data have a simple evolution in time;
- (iii) inverse scattering | the solution of the partial di erential equation at later times is reconstructed from the time-evolved scattering data.

For the special initial data (2), Satsum a and Yajim a [13] have shown that the rejection coe cient is identically zero and there are N purely imaginary eigenvalues. Such a rejection less solution whose eigenvalues have a common real part is an N-soliton.

Here, using the the inverse-scattering fram ework for (1) (2), we study the N-soliton in the limit N ! 1. For the rst few positive integer values of N, it is possible to write down explicit form ulas for these exact solutions of the nonlinear partial di erential equation (1). However, these form ulae rapidly become unwieldy. Even for N = 3, the form ula is already quite complicated and hard to analyze. Am azingly, while these form ulae grow increasingly complicated as N increases, it is also true that certain orderly features emerge in the limit N ! 1.

As a rst step, we rescale and t in (1) { (2) to make the initial amplitude independent of N and the period proportional to N, and we arrive at

where  $\sim = \sim_{N} = A = N$  and A > 0. Studying the large-N lim it of the N -soliton is thus equivalent to studying the sem iclassical (~ # 0) lim it of (3) { (4). A feature that emerges in the lim it is the sharpening boundaries in the (x;t)-plane that separate di erent behaviors of the solution. Two such \phase transitions" were noticed in the num erical experiments of M iller and K am vissis [12], and the rst, a so-called primary caustic curve in the (x;t)-plane, was rigorously explained by K am vissis, M cLaughlin, and M iller [10]. Here, our main result is a description of the mechanism for the observed second phase transition; it di ers from the rst one.

We use two form ulations of the inverse-scattering step to study the limiting behavior of (3)  $\{(4), W$  hen, as is the case here, the rejection coefficient is absent, the algebraic-integral system that one expects to solve to reconstruct the solution of (3) for generic initial data reduces to a linear algebraic system. We derive such a system in x 2 below. We also show, in x 3.1, that the reconstruction step can be cast as a discrete R iem ann-H ilbert problem for a merom orphic 2 2 matrix unknown. We use the linear algebraic system as a basis for num erically computing the N-soliton while the R iem ann-H ilbert form ulation provides the starting point for our asymptotic analysis. In either case, the reconstruction of the solution begins with the eigenvalues

In x 3 we describe how to explicitly modify the discrete Riemann-Hilbert problem we obtain in x 3.1 to arrive at an equivalent problem that is conducive to rigorous asymptotic analysis in the limit N ! 1 (or equivalently ~ ! 0). In x 3.2 we convert the discrete R iem ann-H ilbert problem into a conventional Riem ann Hilbert problem for an unknown with specied jump discontinuities across contours in the complex plane. Next, we show how to \precondition" the resulting Riem ann-Hilbert problem for the limit N ! 1 by introducing a scalar function g() that is used to capture the most violent asymptotic behavior so that the residual may be analyzed rigorously. In some cases, the function g() leads to an asymptotic analysis in the limit N ! 1 based on the theta functions of hyperelliptic Riem ann surfaces of even genus G, and in such cases the function g() can be constructed explicitly, as we show in x 3.4. This construction forces certain dynam ics in (x;t) on the moduli (branch points) of this R iem ann surface, and in x 3.4.1 we show that the moduli satisfy a universal system of quasilinear partial di erential equations in R iem ann-invariant form, the W hitham equations. The success or failure of the function g() constructed in this way in capturing the essential dynamics as N ! 1 hinges upon certain inequalities and topological conditions on level curves that are described in x 3.4.2. With a function q() in hand that satis es all of these conditions, we may proceed with the asymptotic analysis, which is based on a steepest descent technique for matrix Riemann-Hilbert problem s developed by D eift and Zhou [7]. We sum marize these steps in x 3.5, x 3.6, and x 3.7.

The theory outlined above provides, through a handful of technical m odi cations, a re nem ent of results previously obtained by K am vissis, M cLaughlin, and M iller [10]. The key technical improvements are the avoidance, through a dual interpolant approach developed in [11] and [1], of a local parametrix near the origin in the complex plane and the explicit and careful tracking of the errors in replacing a distribution of point m asses representing condensing soliton eigenvalues by its weak continuum limit, encoded in certain functions S () and T (). These extra steps allow us to deduce the same a symptotic form ulae obtained in [10] governing the sem iclassical limit up to and just beyond the primary caustic curve in the (x;t)-plane, but with an improved error estimate that is O (~) (which beats the O ( $\sim^{1=3}$ ) estimate in [10]).

It is fair to say that much of the work in analyzing the N -soliton in the limit of large N comes about from vanquishing the poles representing the soliton eigenvalues from the matrix-valued R iem ann-H ilbert problem that represents the inverse-scattering step. In some sense, the poles disappear with the interpolation step that converts the discrete R iem ann-H ilbert problem with poles but no jump discontinuities into one with jump discontinuities and no poles. On the other hand, this is only a partial solution, since the jump matrix

relating the boundary values taken along a curve of jump discontinuity extends from this curve as an analytic function with poles at the soliton eigenvalues. However, as long as the jump contour remains bounded away from these poles, it is a reasonable approximation that can be controlled rigorously to replace the jump matrix by another one in which the distribution of poles is \condensed" into a continuous distribution with an analytic density. Making this replacement on an ad hoc basis changes the problem. We refer to this changed inverse-scattering problem as the form al continuum -limit problem and we discuss it brie y in x 3.8. The form alcontinuum -limit problem indeed gives the correct asymptotics of the N-soliton and related initial data for the sem iclassical focusing nonlinear Schrödinger equation (3) subject to the above caveat, and it even form s the starting point for the analysis of [15].

Interestingly, the choice of the function g() turns out to have the following two properties:

It depends only on the analytic weak lim it of the discrete distribution of soliton eigenvalues.

It determ ines the contours of the R is ann-H ilbert problem of inverse scattering, and in particular their relation to the locus of accumulation of the discrete soliton eigenvalues.

So, from the rst property, g() does not know about the poles of the jump matrix, and from the second property it chooses the contours appropriate for the asymptotic analysis. It is therefore possible that the contours selected by choice of g() could cross the locus of accumulation of discrete eigenvalues. And once the contours are no longer bounded away from the poles, the form al continuum -lim it problem is not the correct model for inverse scattering.

It turns out that, in the region beyond the prim ary caustic curve, this actually happens. In other words, the dependence of the function g( ) on (x;t) predicts a contour that as t increases passes through the branch cut that is the continuum limit of the pole distribution. At this point, the rigorous analysis must break down. Signi cantly, however, this is not the mechanism for further phase transitions. It turns out that the di culty is a technical one that can be removed with the further use of the multi-interpolation method developed in [11] and [1]. The additional steps that are required to sum ount this crisis, and to therefore prove that there is no phase transition when curves determ ined from the function g( ) cross the pole locus, are described in x 3.9.

The analysis described in x 3.9 is new, and one of the new features is the appearance of a new inequality that must be satisfied by the function g( ) on certain contours. It turns out that the failure of this inequality is the mathematical mechanism for the next phase transition of the N-soliton, a secondary caustic curve in the (x;t)-plane.

Before studying the secondary caustic, we discuss brie y in x 4 the quiescent region of the (x;t)-plane before the prim ary caustic curve. We recall in x 4.1 some inform ation from [10] about the relation between the dynamics of the N-soliton in this region and a fam ily of hyperelliptic R iem ann surfaces of genus zero. We also discuss the mathematical mechanism behind the primary caustic phase transition, which turns out to correspond to an instantaneous jump from genus zero to genus two. Then, in x 4.2 we analyze the Fourier power spectrum of the N-soliton in the region before the primary caustic, and show that its evolution is consistent with the supercontinuum generation phenom enon of current interest in optical science (see below).

In carrying out a study of the  ${\tt N}$  -soliton for large  ${\tt N}$  , three di erent computational techniques com e to mind:

- (i) D irect num ericalsim ulation of the initial-value problem for the focusing nonlinear Schrodinger equation (3) in the sem iclassical limit. By adapting discretization methods to this problem, it is possible to study the dynam ics of the N -soliton as well as much more general initial data, and also non-integrable variants of (3). However, these methods are severely constrained in the limit of interest due to num erical sti ness, and worse yet, modulational instability that is exponentially strong in N. See [2, 5, 3, 4].
- (ii) Numerical solution of the inverse-scattering problem for the focusing nonlinear Schrodinger equation. This method applies only to the integrable equation (3), and like the direct numerical simulation method is also ill-conditioned in the sem iclassical lim it. However, it a ords an important advantage over direct numerical simulation, namely that the solution is calculated independently for each (x;t), and therefore roundo errors do not accumulate.
- (iii) Numerical construction of the function g(). This method also applies only to the integrable equation (3), and it is further constrained in that it is only meaningful in the sem iclassical lim it. However, it speci cally takes advantage of the mathematical structure of this lim it, and consequently the numerical calculation is extremely well-conditioned.

In x 5, we take the third approach and use numerical methods to solve for the function g() in the region between the primary and secondary caustics for the N-soliton. While a numerical calculation, this is clearly fundamentally different from either the numerical solution of linear algebra problem sequivalent to inverse scattering for the N-soliton as in x 2, or direct numerical simulation of the initial-value problem for (3) corresponding to the N-soliton. It is with the help of these calculations that we observe the crossing of the pole locus (which does not correspond to the secondary caustic, as can be seen once the analysis is modified as in x 3.9) and ultimately the violation of the new inequality introduced in x 3.9 (which causes the secondary caustic phase transition).

In x 6 we take up the question of exactly what happens to the N -soliton in m ediately beyond the secondary caustic curve in the (x;t)-plane. We characterize the secondary caustic (failure of the new inequality from x 3.9) as the occurance of a critical point on a level curve de ning the boundary of the region in the com plex plane where the relevant inequality holds. We then m ake the guess that the failure of g() corresponding to a R iem ann surface of genus two in this new way is resolved by going over to a form ula for g() corresponding to a R iem ann surface of genus four, but with signi cantly di erent topological features than in the (hypothetical) case that genus two fails due to the violation of the same inequality that leads to the prim ary caustic. We construct g() in this new situation, and obtain an implicit description of the moduli of the corresponding earlier. We then prove that these new form ula provide another solution to the same type of W hitham equations that govern the moduli in the case of sim pler contour topology.

We conclude the paper with some hypotheses regarding further phase transitions (higher-order caustics) for the N-soliton and related initial-value problem s for (3), and by stressing once again that the phenom enon of the secondary caustic (and possibly further phase transitions) is fundam entally linked to the discrete nature of the eigenvalue distribution, which forces modi cations to the analysis as described in x 3.9, and introduces coincident inequalities to be satis ed by g(). These inequalities are simply not part of the asymptotic theory of the form al continuum -limit problem discussed in x 3.8, and therefore the latter problem is unable to correctly predict the secondary caustic. This came as some surprise to us, as we and other authors had always assumed that either the form al continuum -limit problem governs the dynam ics for all time or that the secondary caustic occurs upon crossing the locus of eigenvalues. B oth of these are incorrect.

The problem (3) for small ~ is relevant as a model for the propagation of light pulses in optical bers that have the property of weak (because ~ is sm all) anom abus dispersion. There has always been great interest in optical bers with weak dispersion. Initially this was because when such bers are operated in the linear regine (sm all am plitude) the propagation is immune to dispersive spreading of pulses that is considered to degrade a data stream . For long ber links, however, the theory of linear propagation becomes inadequate due to the accumulation of weakly nonlinear e ects. More recently these bers have become important again because it became clear that advantage could be taken speci cally of the nonlinearity. Indeed, when operated in the weakly nonlinear regime (m oderate am plitude) nonlinear e ects are m uch stronger com pared to linear e ects and therefore propagation in such bers can drastically alter the power spectrum of a signal, possibly in a useful way. Indeed, one of the applications envisioned for weakly dispersive bers is so-called supercontinuum generation (see, for example, [6, 8]) in which a nearly monochrom atic laser source is coupled into the ber and spectrally broadened under propagation so that the output is a coherent source of white light. The output can then be litered to produce coherent light of virtually any frequency, which is desirable for wavelength division multiplexing telecommunication systems. The most promising current technology for creating optical bers with very low dispersion, in both the norm al and anom alous regimes, is based on photonic crystal bers, which are made from ber preforms with extrem ely complicated cross sections. The complexity of the cross section is preserved to the microscopic level upon drawing the ber (carefully stretching the cylindrical ber preform along its axis until an optical ber results), and as the possibilities for cross sections go far beyond the traditional core/cladding/jacket step-index m odel it is possible to engineer bers with properties thought in possible until recently [9].

In this paper, we make frequent use of the three Paulim atrices:

We use boldface notation (e.g. m or P) throughout for square matrices, with the exception of the identity matrix I, and arrow notation for column vectors (e.g. v, with row-vector transpose  $v^{T}$ ). C om plex conjugation

is indicated with an asterisk, and P means the matrix whose elements are the complex conjugates of the corresponding elements of P (no transpose).

## 2. Linear Systems Describing the N-Soliton

2.1. Theory. The spectral data (5) { (6) can be used to set up a system of linear equations whose solution yields the N -soliton for arbitrary (x;t). (See, for example, the discussion in Chapter 2 of [10].) To arrive at such a square inhom ogeneous system, we begin by de ning expressions

The N -soliton solution of the focusing nonlinear Schrodinger equation is then given by

C learly, the equations (11) and (12) amount to a 2N 2N system of linear equations for the coe cients  $A_{p}(x;t)$  and  $C_{p}(x;t)$ , with coecient matrices of block-Vanderm onde type. One approach to computing the value of  $_{\rm N}$  (x;t) for xed (x;t) is then to solve this linear algebra problem and then obtain  $_{\rm N}$  (x;t) from (13). This approach was used in [12] to nd  $_{\rm N}$  (x;t) on a grid of values of (x;t) for N = 5, N = 10, and N = 20. There is an advantage here over direct num erical simulation of the focusing nonlinear Schrodinger equation in that num erical errors do not propagate from one value of t to another.

W hile the above approach is attractive, it can be made more so by reducing the problem explicitly to a linear algebra problem involving matrices of size only N N. We use Lagrange interpolation and (11) to express C (x;t; ) in term s of the values A (x;t;  $N_{k}$ ); k = 0; :::; N 1. Thus, З

2.2. N um erical im plem entation. In general, num erical integration of the initial-value problem (3){(4) for the sem iclassically scaled focusing nonlinear Schrödinger equation is di cult; the problem is notoriously sti due to multiple scales. The presence of sm all oscillations (m icrostructure) of wavelength and period of order ~ requires that one use a tim estep proportional to ~ while resolving the larger scale structures (m acrostructure) necessitates that the num ber of tim esteps m ust be of order ~ <sup>1</sup>. In addition, to accurately com pute the spatial m icrostructure, the num ber of gridpoints/Fourier m odes m ust also be proportional to ~ <sup>1</sup>. Thus, sim ulating the sem iclassical lim it is com putationally intensive, and the accum ulation of roundo errors is a serious issue. In spite of these di culties, som e careful num erical experim ents have been carried out [2, 5, 3, 4].

For the special case of initial data  $(x;0) = A \operatorname{sech}(x)$ , the calculation described in the previous section provides a useful alternative approach. Rather than using some numerical integration scheme to directly compute an approximation to the solution of the partial di erential equation, we may take advantage of the fact that the N-soliton can be recovered from the solution of the linear algebraic system (20). That is, for each xed pair (x;t), we numerically solve (20). An approach like this was rst used by M iller and K am vissis [12] using instead the larger system of equations (11) and (12).

In addition to being limited to particular initial data, the approach of solving (20) su ers from the fact that the matrix  $I + W_N$  is ill-conditioned for large N and high-precision arithmetic is necessary for accurate computations. As the derivation leading to (20) involves Lagrange interpolation on equi-spaced points, this is perhaps not surprising. On the other hand, an advantage of this approach is that the calculation for each (x;t) is independent of all the other calculations, so errors do not propagate in time and accumulate. Figures 1{4 show density plots of  $j_N(x;t) \stackrel{?}{f}$  for N = 5;10;20; and 40 computed by solving (20) independently for a large number of (x;t) values using high-precision arithmetic.




Figure 1. The square modulus of  $_5$  (x;t) plotted over a part of the positive quadrant of the (x;t)-plane.

2.3. Phenom enology of the N-soliton for large N. In each of Figures 1{4, the plotted solutions share some common features. A fler an initial period of smoothness, the solution changes over to a form with a central oscillatory region and quiescent tails. W hat is particularly striking in this sequence of gures is how the boundary between these two behaviors of the solution appears to become increasingly sharp as N increases. This initial boundary curve is called the prim ary caustic. The solution up to and just beyond the prim ary caustic has been carefully studied in [10]. See also the discussion in x 4 below.

In F igure 3 and F igure 4, a second transition of solution behavior is clearly visible. It is this secondary caustic curve which is the main focus of this paper. A sour subsequent analysism akes clear, this second phase transition is linked to the presence of the discrete soliton eigenvalues f  $_{\rm N}$  ,  $_{\rm k}$ g [ f  $_{\rm N}$  ,  $_{\rm k}$ g, and the mechanism for this transition is di erent that of the transition across the primary caustic.

We note that Tovbis, Venakides, and Zhou [15] have studied the sem iclassically scaled focusing nonlinear Schrödinger equation for a one-parameter family of special initial data. The forward-scattering procedure for this family [14] generates a rejection coe cent and | depending on the value of the parameter | some discrete soliton eigenvalues. (By contrast, recall that our initial data is rejection less.) For those values of the parameter for which there are no discrete eigenvalues, they prove that the solution undergoes only a single phase transition and that there is no secondary caustic. When the value of the parameter is such that there are both solitons and rejection, they leave the possibility of a second phase transition as an open question.




Figure 2. The square modulus of  $_{10}$  (x;t) plotted over a part of the positive quadrant of the (x;t)-plane.




Figure 3. The square modulus of  $_{20}$  (x;t) plotted over a part of the positive quadrant of the (x;t)-plane.




Figure 4. The square modulus of  $_{40}$  (x;t) plotted over a part of the positive quadrant of the (x;t)-plane.




Figure 5. The regions  $D_1$  and  $D_1$  in the upper half-plane, and the oriented boundary arcs K\_1, K\_0, and K\_1. The N\_soliton eigenvalues f\_N\_{ik} g\_{k=0}^{N-1} and the imaginary interval [D; iA] in which they accumulate as N ! 1 are shown in red. The number > 0 will be taken later to be su\_ciently small, but independent of N .

3.4. The choice of g(). B ands and gaps. Up until this point, the contours have been more or less arbitrary, with the only conditions being that the region D  $_1$  contain the imaginary interval [0;iA] and the branch cut C. Likewise, the function g() remains undetermined aside from its analyticity properties relative to the contours and the symmetry property (68). We now will describe how to choose both the system of contours and the function g() to render the construction of O() asymptotically tractable in the lim it N ! 1.




Figure 6. The contours K  $_1$ , K  $_0$ , K  $_1$ , and K  $_L$ , and their conjugates are the contours of discontinuity of O ( ) and are shown in black. Superimposed in blue are the curves C and C  $_1$ .

Note however, that while the orientation of a contour containing a band is essentially an arbitrary choice, the condition that () be decreasing has intrinsic meaning because () is by de nition proportional to g() g() which changes sign upon reversal of orientation.

G iven an arbitrary set of contours, it may be the case that for no function g() de ned relative to these contours can the conditions (96) and (97) both be satisfied by choice of systems of bands and gaps. Speci cation of the contours is thus part of the problem of nding g().

To nd g() and the contours along which its discontinuities occur, we suppose that the number of bands along K<sub>0</sub> [K<sub>1</sub> is known in advance, and show that certain conditions are then necessary for the existence of g() for which the conditions (96) and (97) both hold. 


Figure 7. The discontinuity contours for P ( ).

3.6. Param etrix construction. Building a model for P () consists of two steps: (i) dealing rst with the asymptotic behavior of the jump matrix away from the endpoints of the bands, and (ii) local analysis near the endpoints. Both of these constructions have been described in detail elsewhere, and we will give just an outline of the calculations.

3.6.1. Pointwise asymptotics: the outer model problem . As N ! 1 (so in particular  $\sim = \sim_{N}$  ! 0) the jump m atrix de ning the ratio of boundary values in the Riem ann-Hilbert problem for P () m ay be approximated by a piecewise constant (with respect to ) jump m atrix that di ers from the identity m atrix only in the bands of K<sub>0</sub> [K<sub>1</sub> and their complex conjugates and also in the nonterm inal gaps of K<sub>1</sub>. Thus we may pose another Riem ann-Hilbert problem whose solution we hope we can prove is a good approximation in a certain sense of P (). This R iem ann-H ilbert problem can be solved by rst introducing an auxiliary scalar R iem ann-H ilbert problem with the aim of removing the jump discontinuities of P-() across the nonterm inal gaps as expressed by the jump conditions (175) while converting the jump m atrix for P-() in all of the bands to the m atrix 1. The two columns of the resulting m atrix unknown thus m ay be considered to be restrictions of a single vector-valued analytic function on a hyperelliptic R iem ann surface X constructed by identifying two copies of the com plex -plane across a system of cuts m ade in the bands and their com plex conjugates. This R iem ann surface has genus G, which explains our term inology for the \genus" of a con guration of endpoints for the g-function. The vector-valued function de ned on the surface X that leads to the solution of the R iem ann-H ilbert problem for P-() is known as a B aker-A khiezer function. It can be expressed explicitly in term s of the R iem ann theta function of X, as can P-(). The details of this construction can be found in [10].

Two features of this solution are in portant for the subsequent steps in the analysis. First, the dependence of the solution on ~ enters through the real quantities  $_{j}=~$  and  $_{j}=~$ , which determ ine a point in the real part of the Jacobian variety of X, topologically a torus of dimension G. E sentially, this point is a phase shift in the argument of the R iem ann theta functions used to construct the solution, and in particular this im plies that the matrix P-() remains uniform by bounded for away from the band/gap endpoints in the lim it ~ ! 0, even though the phase point oscillates wildly in the Jacobian in this lim it. Next, for near the band/gap endpoints, the matrix P-() exhibits a singularity of a universal type that, while a poor model of P () near the endpoints, nonetheless turns out to match well onto another matrix function that is a better model.

3.6.2. Endpoint asymptotics: the A iry function local parametrix. To determ inew hat this betterm odel should be, it su ces to x a su ciently small neighborhood U  $_{\rm k}$  of each band/gap endpoint  $_{\rm k}$ , and to nd a matrix that exactly satis as the jump conditions of P () in this neighborhood. Such a matrix can be found because the jump matrices restricted to U<sub>k</sub> can be written in a canonical form with the use of an appropriate conform al mapping (Langer transformation) taking U<sub>k</sub> to a neighborhood of the origin. Once the jump matrices in U<sub>k</sub> are exhibited in canonical form, a piecew ise analytic matrix functions. Next one observes that in fact there are many piecew ise analytic matrix factor analytic in U<sub>k</sub>. The choice of this factor can be used to single out a particular local solution that is a good match onto the explicit matrix P-() on the boundary  ${\rm eU}_k$  of U<sub>k</sub>. 3.6.3. G lobal parametrix. We now propose the following global parametrix,  $\hat{P}$  (), as a model for P () uniform ly valid in the whole complex plane. The matrix is well-de ned globally with the exception of certain contours on which continuous boundary values are taken from each side:

3.7. Error analysis. We now argue that E () = P () $\hat{P}$  () <sup>1</sup> satisfies

The basic properties of the matrix E () follow on the one hand from the conditions of the Riemann-Hilbert problem satis ed by the factor P () and on the other from our explicit know ledge of the global parametrix  $\hat{P}$  (). Clearly, E () is a piecew ise analytic matrix in the complex -plane, satisfying

The jump discontinuities of E() in the low enhalf plane are consistent with the symmetry E() =  $_2$ E()  $_2$ . In particular, E() is an analytic function inside all neighborhoods  $U_k$  of endpoints and their complex conjugates because  $\hat{P}_k$ () is chosen to satisfy the jump conditions of P() exactly within  $U_k$ .

This inform ation means that E () itself is the solution of a matrix R iem ann-H ilbert problem with given data. By exploiting a well-known connection with systems of singular integral equations with C auchy-type kernels it su ces to estimate the uniform di erence between the ratio of boundary values E ()  ${}^{1}E_{+}$ () and the identity matrix I. In fact, we will show that E ()  ${}^{1}E_{+}$ () I = O (~) holds uniform ly on the ~-independent contour of discontinuity for E (). From this estimate, the estimate (185) follows from the connection to integral equations.

To show that E ()  ${}^{1}E_{+}$  () = I + O (~) requires only a little m ore than the properties of g() and the global parametrix  $\hat{P}$  () already established. We also need the asymptotic behavior of the functions S() and T(). A nalogous functions are analyzed carefully in [1], so we just quote the results:

The function S () is analytic for in the upper half-plane outside the region bounded by the curve C and the imaginary interval with the same endpoints [0; iA]. Uniform by on compact subsets of the open domain of analyticity we have S () = 1 + 0 (~).

The function T () is analytic for in the upper half-plane outside the region bounded by the curve  $C_1$  and the imaginary axis above iA. Uniform ly on compact subsets of the open domain of analyticity we have T () = 1 + 0 (~).

These facts are enough to prove that E ()  ${}^{1}E_{+}() = I + O(\sim)$  on all contours with the exception of K<sub>1</sub> restricted to a neighborhood of = and K<sub>1</sub> restricted to a neighborhood of = . The jump m atrix for P () on K<sub>1</sub> involves both  $e^{i()=\sim}$  and also  $e^{(2i^{\circ}()i())=\sim}$ . The form er is exponentially sm all as  $\sim \# 0$  by a C auchy-Riem ann argument for K<sub>1</sub> su ciently close to K<sub>0</sub>; the choice of a su ciently sm all but positive is crucial to provide the decay where K<sub>1</sub> meets the realaxis. The latter is also exponentially sm all on the parts of K<sub>1</sub> that are bounded away from the imaginary axis, because < (2i<sup>0</sup>()) = 2 < (), which dom inates < (2i<sup>0</sup>()) for K<sub>1</sub> close to K<sub>0</sub>. But it is not immediately clear that an > 0 can be found so that the inequality < (2i<sup>0</sup>()) i ()) < 0 persists along K<sub>1</sub> to the realaxis. How ever, taking a limit of  $g^{0}_{+}()$   $g^{0}()$  as ! 0 along K<sub>0</sub> shows that

A similar explicit calculation involving g<sup>0</sup>() near = 0 shows also that <(()) is decreasing linearly away from the origin along the negative real axis, which proves that while the limit of () as approaches the origin along K<sub>1</sub> is purely imaginary, the inequality <(()) < 0 is satisfied strictly throughout the term inalgap of K<sub>1</sub> as long as > 0 is su ciently small.

This concludes our discussion of the error  $m \operatorname{atrix} E$  (). We only note two things at this point. Firstly, the bound (185) proves that

Therefore, the strong asymptotics of the N -soliton are provided by the modulated multiphase wavetrain that arises from the solution of the outerm odel problem for P-() in terms of R iem ann theta functions of genus G. In particular, the curves in the (x;t)-plane along which the genus changes abruptly are the caustic curves seen in F igures 1{ 4. Secondly, we want to point out that the error estim ate of O (~) = O (N <sup>-1</sup>) in (191) is an improvement over the error bound obtained for the same problem in [10]. The improvement comes from (i) the -m odi cations of the contours near = 0 which obviates the need for a local parametrix near the origin (this was also used to handle \transition points" in [1]) and (ii) the careful tracing of the in uence of the functions S () and T () through the asymptotics, especially their explicit rem oval near the band/gap endpoints via the near-identity transform ations P ! Q.

3.8. The form al continuum -lim it problem . Much of the above analysis is based on the facts that  $S() = 1 + O(\sim)$  and  $T() = 1 + O(\sim)$  under the assumptions in force on the relation between the contours on which these functions appear in the jump matrix and the contours C and  $C_1$ . These two functions measure the discreteness of the eigenvalue distribution and a natural continuum lim it

thereof (a weak lim it of a sequence of sum s of point m asses). It is tempting to notice the role played by the approximations S() 1 and T() 1 in the rigorous analysis and propose in place of the problem for P() an ad hoc \continuum -lim it" R iem ann-H ilbert problem for a matrix P(); the conditions of this R iem ann-H ilbert problem are precisely the same as those of the R iem ann-H ilbert problem governing P() except that in all cases one makes the substitutions S()! 1 and T()! 1.

The rigorous analysis described earlier proves that, as long as the contour geom etry adm its the approximations S() 1 and T() 1 one may also compute the asymptotic behavior of the N-soliton by studying the form al continuum -lim it R iem ann-H ilbert problem for P(). However, it turns out that there are some circum stances in which the conditions that constrain the contours of the R iem ann-H ilbert problem for P() are inconsistent with the approximations S() 1 and T() 1. We will show that this is not merely a technical inconvenience standing in the way of analyzing the large N lim it with the help of the form al continuum -lim it R iem ann-H ilbert problem for P(), but that the modi cations necessary to complete the analysis of P() rigorously under these circum stances introduce new mathem atical features that ultimately provide the correct description of the secondary caustic.

Note also that making the substitutions S() ! 1 and T() ! 1 is completely analogous to the ad hoc substitution P() ! P(), some of the consequences of which were described in x 3.2.2. These arguments suggest that extrem e care must be taken in relating asymptotic properties of the matrix P() with those of the matrix P(). Probably it is better to avoid analyzing P() and instead keep track of the errors by working (as we do in this paper) with P() directly.

3.9. Dual interpolant modi cation necessary for contours passing through the branch cut. The nonlinear equations that determ ine the endpoints only involve quantities related to the continuum limit of the distribution of eigenvalues within the imaginary interval [0; iA]. Indeed, the rational function P() has been replaced by  $e^{L()=~}$  at the cost of a factor S(), which is unifom ly approximated by 1 on K<sub>1</sub>. It turns out (see x 5) that these equations admit relevant solutions that evolve in x and t in such a way that the contours become e inconsistent with the fundam ental assumption that the region D<sub>1</sub> contains all of the discrete eigenvalues (poles of m() in the upper half-plane). This can happen because the function L() is de ned relative to the contour C which while having the same endpoints as [0; iA], is otherwise arbitrary, and the endpoint equations are analytic as long as the endpoint variables are distinct and avoid C. Thus, it can (and does) happen that a band I evolves in x and t so as to come into contact with the bocus of accumulation of eigenvalues. W hen this occurs, we have to reconcile the facts that on the one hand the solution of the endpoint equations may be continued (by choice of C) in x and t so that the band I passes through the interval [0; iA] com pletely, while on the other hand the function S() can no longer be controlled and the continuum -limit approximation can no longer be justi ed in the same way.

The situation can be rectired in the following way. Returning to the matrix m () solving the discrete Riem ann-Hilbert problem characterizing the N-soliton, we remove the poles by taking into account three dimensional dim

Once again it can be checked directly that M () is analytic at allofthe poles of m () in the open domains D<sub>1</sub> and D<sub>3</sub>. The same argument works if it happens that a pole of m () lies exactly on the arc K<sub>2</sub> separating the two domains. Next, we introduce the function g(), which we assume is analytic except on the contours K<sub>2</sub>, K<sub>1</sub>, K<sub>0</sub>, and their complex conjugates, and we de nean ew unknown as before by setting N() = M() e<sup>g() 3=~</sup>. On the arcs K<sub>1</sub>, K<sub>0</sub>, and K<sub>1</sub> the jump conditions relating the boundary values taken by N() are exactly as before, while on the arc K<sub>3</sub> we have




Figure 8. The three regions D  $_1$ , D  $_1$ , and D  $_3$ , and the boundary contour arcs K  $_1$ , K  $_0$ , K  $_1$ , K  $_2$ , and K  $_3$ .




Figure 9. The discontinuity contours for P () in the modi ed con guration. The arc connecting  $_1$  and  $_2$  between  $(l_1)$  is the band  $I_1$  which may now cross the interval [D; iA].

We choose the contour C, relative to which the functions L () and T () are dened, such that the contour K  $_2$  forming the common boundary between the domains D  $_1$  and D  $_3$  lies entirely in the left half-plane according to C [C<sub>1</sub> [C [C<sub>1</sub>. For convenience we will take C to lie in the closure of D  $_1$  [D  $_3$  and to connect = 0 to = iA passing once through the rst intersection point of K  $_1$  and K  $_2$  (in the direction of their orientation, beginning with = 0). We also assume (without loss of generality) that this intersection point turns out to lie in a gap of K  $_1$  [K  $_2$ . See also Figure 9.

The next step is to rem ove the jump discontinuities on the real intervals (;0) and (0; ) by exactly the sam e factorization as was used previously (see (81) and the subsequent de nition of O () in terms of N () and the discussion thereof). Here the contour arc K<sub>L</sub> lies in the region D<sub>1</sub> as before.

The jump relations satis ed by O () for on K $_0$  and K $_1$  are of exactly the same form as before (see (91) and (92)). Furthermore, because K $_2$  is in the left half-plane according to C [C<sub>1</sub> [C [C<sub>1</sub>, we may write the jump relation for O () for on K $_2$  as

We note here that the exponents of the jump m atrix elements are of exactly the same form as for  $2 K_{1}$ . Since T () = 1+ 0 (~) holds uniform ly on K<sub>2</sub> as long as we arrange that this contour is bounded away from the endpoints of C, we may asymptotically analyze the R iem ann-H ilbert problem for O () by choosing g() in exactly the same way as we did earlier, with the same integral conditions on the endpoints of the bands. In particular, the characteristic velocities in the W hitham equations are exactly the same analytic functions of the elements of v as in the simpler con guration. The contours of discontinuity for P () in the modi ed con guration are shown in black in Figure 9.

W ith regard to the determ ination of the function g(), the only essential di erence between this approach and the form er approach is that here a new inequality is required to hold for  $2 \text{ K}_{3}$  in order that the corresponding jump m atrix for 0 () be a sm all perturbation of the identity m atrix. From (193), we see that

Here () denotes the analytic continuation from any gap on K  $_2$  to K  $_3$  (while dimensionally tic functions for each gap on K  $_2$ , they all dimensionally imaginary constants which play no role in (198)).

The term  $2 = ({}^{0}())$  represents a nontrivial modi cation to the inequality < (()) < 0 that must be satisfied in the gaps of K<sub>1</sub> [K<sub>2</sub>. As we will see in x 5, the violation of this inequality is exactly the mechanism for the phase transition from G = 2 (genus two) to G = 4 (genus four). It should be stressed that this inequality is fundamentally an artifact of the discrete spectral nature of the N-soliton. In other

words, if we simply propose (as described in x 3.8) a model R iem ann-H ilbert problem for an unknown P() in the original scheme with all jump matrices modi ed simply by setting S() = T() = 1, we (i) will not care about the implications of a portion of the contour  $K_1$  meeting the interval [0; iA] (which has meaning only as an artical branch cut of an analytic function) and (ii) will only need the inequality <(()) < 0 and ascribe no particular meaning to the modi ed quantity <(()).

## 4. The Genus-Zero Region

4.1. Validity of the genus-zero ansatz. Ansatz failure and prim ary caustic. In Chapter 6 of [10], the genus-zero ansatz for the g-function of the N-soliton is constructed and it is shown that the inequality < (()) < 0 is satis ed throughout the sole (term inal) gap for  $0 < t < t_1 (x)$ , where the curve  $t = t_1 (x)$  is the prim ary caustic curve asymptotically separating the smooth and oscillatory regions in Figures 1{4. The prim ary caustic curve is described by obtaining the endpoints  $_0 (x;t)$  and  $_0 (x;t)$  from the genus-zero ansatz for g() and then elim inating ^ from the equations

In other words, the rst equation says that  $\hat{} = \hat{}(x;t)$  is a critical point of () with endpoints  $_0(x;t)$ and (x;t), and then the second equation is a real relation between x and t, that is, a curve in the (x;t)plane. The equations (199) describe the existence of a critical point ^ for () that lies on the level curve < ( ( )) = 0, which is the boundary of the region of existence for the term in algap  $_1$ . The existence of such a point on the level indicates a singularity of the level curve, generically a sim ple crossing of two perpendicular branches. In other words, if > 0 is small then for  $t_{1}(x) < t < t_{2}(x)$  the region where < (() < 0 holds is connected albeit via a thin channel, delineated by approximate branches of a hyperbola, through which the gap contour  $_1$  m ust pass, whereas for  $t_1(x) < t < t_1(x) + the region where < (()) < 0 holds becomes$ disconnected, and it is no longer possible to choose  $_1$  so that < ( ( )) < 0 holds throughout. When  $t = t_1 (x)$ the hyperbolic branches degenerate to lines crossing at = (x;t). This mechanism for the form ation of the prim ary caustic is illustrated in the spectral -plane in Figures 6.11 and 6.12 of [10]. In particular, it is known in the case of the N-soliton that  $t_1(x)$  is an even function and  $\inf_{x^2R} t_1(x) = t_1(0) = (2A)^{-1}$ . In [10] it is shown that if  $j_{xj}$  decreases with t xed from a point ( $x_{crit}$ ;  $t_{crit}$ ) at which (199) holds, then the genus-two ansatz takes over. A new band is born with two new endpoints  $_1$  (x;t) and  $_2$  (x;t) emerging from the double point  $\hat{}$  where the singularity of the level curve for < ( ( )) = 0 occurs. Therefore, the primary caustic is a phase transition between genus zero and genus two.

In fact, the conditions (199) are not specic to the failure of the genus-zero ansatz, but m ay be considered for any genus, being as they simply describe the change in connectivity of the region where the essential inequality < ( ( )) < 0 holds. Thus, we may consider the conditions (199) for general even genus with the aim of determ ining whether phase transitions beyond the primary caustic can occur for the N-soliton. Simultaneous solutions of the two equations in (199) can be interpreted as collisions between branches of the level curve < () = 0, and these branches may emanate from band/gap endpoints k (x;t), or from the branch cut C, or they may be noncompact. (As level curves of a harm onic function they cannot close on them selves unless they enclose a singularity of ().) As shown in Figures 6.11 and 6.12 of [10], the primary caustic is caused by the collision of a noncompact branch coming in from in nity with a branch joining  $_0$  (x;t) to the origin. It is not di cult to analyze the function () for general even genus to determ ine its singular points and asymptotic behavior as ! 1, and such analysis leads to the conclusion that for genus two no further branches exist for large that can eventually collide with branches connecting band/gap endpoints. This fact suggests that further phase transitions (higher-order caustics), if they exist, m ay com e about for a di erent reason than the primary caustic. The main point of this paper is to show that a secondary caustic indeed occurs for the N -soliton in the large N limit, and that its mechanism is indeed di erent from that leading to the form ation of the prim ary caustic.

The validity of the genus-zero ansatz for g() for small time is in fact established in [10] for a general class of \re ectionless" initial data for the focusing nonlinear Schrodinger equation that leads to a discrete R iem ann-H ilbert problem form () of the sort relevant in the study of the N -soliton. Sim ilar results have been found by Tovbis, Venakides, and Zhou [15] for certain special-function initial conditions that are not re ectionless.

42. Fourier power spectrum and supercontinuum frequency generation. In applications of the focusing nonlinear Schrödinger equation to nonlinear ber optics, the limit ~ # 0 is interesting because it corresponds to weak dispersion, a situation in which nonlinear e ects are dominant over linear dispersive e ects. While conservative linear e ects leave the Fourier power spectrum of a signal unchanged, strongly nonlinear e ects can change the spectrum signi cantly, and one application of weak dispersion in ber optics is the generation of broadband spectra from input signals with a narrow power spectrum. This is known in the literature as supercontinuum generation. While it is sometimes thought that supercontinuum generation occurs as a result of the wave breaking at the prim ary caustic, in fact the e ect is already present for t <  $\inf_{x2R} t_1(x)$ . Indeed, in this region, the N-soliton has, for each x 2 R the representation (191) corresponding to the genus-zero ansatz for g(). Moreover (see [10]) in the genus-zero case,




Figure 10. The upper bbe of the compact part of the curve (202) shown for At = 0;1=8;1=4;3=8;1=2 from inside out. For t > 0 the relation (203) parametrizes the curve from the origin to itself in the clockwise direction.

For such t, the correct solution (in the sense of leading to topological conditions for contours in the complex plane admitting the genus-zero ansatz) of (202) and (203) necessarily lies on the upper lobe of this compact component, on which it is uniquely determined by (203) as a function of x. In other words, (203) param etrizes the upper lobe by x 2 R, taking R to the left half of the lobe,  $R_{+}$  to the right half, and x = 0 to the point above iA where the upper lobe intersects the imaginary axis. As x ! 1,  $_{0}(x;t)$  tends to zero from the second quadrant, and as x ! +1,  $_{0}(x;t)$  tends to zero from the rst quadrant. See Figure 10.

The power spectrum of  $_{\rm N}$  (x;t) in the globally genus-zero regime (for t < (2A) <sup>1</sup>) can be approximated by using the method of stationary phase to analyze the Fourier transform of the approximate solution (200).




Figure 11. The scaled cuto frequency is a monotone increasing function of At.

Since  $jx_+() x$  () jtends to zero as jj! M and grows without bound as ! 0, the ripple becomes less pronounced near the edge of the spectrum and m ore violent near the center of the spectrum. Near the edge of the spectrum the characteristic spectral width still tends to zero with ~ but at a slower rate; in this regime m ore detailed stationary phase analysis of the power spectrum would reveal A iry-like behavior on a scale where jj M is proportional to an appropriate fractional power of ~. In any case, uniform by over the region jj < M, the ripple is rapid enough to give meaning to the local average (weak lim it with xed):

The weak convergence of the power spectrum to a broad plateau of spectral width (on the ! scale) of ~  $^{1}$ M can be considered as evidence of supercontinuum frequency generation for the N -soliton in the genus-zero region, before any wave breaking occurs. Furtherm ore, these calculations show that the broad spectral plateau develops in absence of the R am an e ect or higher-order dispersion, which are not part of the basic nonlinear Schrodinger m odel but are frequently thought to play an important role in supercontinuum generation.

#### 5. Numerical Computation of Endpoints and Contours in the Genus-Two Region

O urm ain interest in this paper is to analyze the N-soliton in the genus-two region to determ ine and explain the mechanism for the secondary caustic curve that can be observed in Figures 1{4. In the genus-two region, there are three complex endpoints  $_0(x;t)$ ,  $_1(x;t)$ , and  $_2(x;t)$  that satisfy the six real equations

We wrote a M atlab code that continues a solution of these equations along a path from point  $(x_0;t_0)$  at which a solution is known for which the Jacobian of the system is nonsingular to a nearby point  $(x_1;t_1)$ . To have a starting point, we need to choose a point  $(x_{crit};t_{crit})$  on the primary caustic, to which there corresponds a single endpoint  $_0(x_{crit};t_{crit})$  of the genus-zero ansatz, and a critical point  $^\circ$  at which (199) holds. In [10] it is shown that for  $x = x_{crit}$  and  $t = t_{crit}$  the equations (213) adm it the solution given by  $_2 = _1 = ^\circ$  and  $_0$  taking the same value as in the genus-zero case. Since the Jacobian of (213) is singular when endpoints coalesce, we need to begin with an analytical perturbation calculation to move slightly away from the primary caustic into the genus-two region. We did the calculations for  $x_{crit} = 0$  and  $t_{crit} = (2A)^{-1}$ , where  $_0 = ^\circ = A^{D} \overline{2}$  and analytically determ ined asymptotic form ulae for  $_0(x;t)$ ,  $_1(x;t)$ , and  $_2(x;t)$  in the lim it t # (2A)  $^1$  with x = 0. W ith the help of these form ulae, we could employ our continuation code beginning with a point slightly beyond the primary caustic where the three endpoints are distinct. Thus, we may obtain num erically, for any (x;t) beyond the primary caustic, the analytic solution of the equations (213) that correctly emerges from the primary caustic.

We also wrote a M atlab code that takes a point (x;t) beyond the prim ary caustic and the corresponding endpoints  $_0(x;t)$ ,  $_1(x;t)$ , and  $_2(x;t)$  as input, and computes the band  $I_0$  connecting  $_0(x;t)$  to the origin

and the band  $I_1$  connecting  $_1(x;t)$  and  $_2(x;t)$  by integrating numerically the equation < (R ()Y ()d) = 0 to determ ine the level curves. The code also nds the regions of the complex plane where the inequality < ( ()) < 0 holds; the gaps  $_1$  connecting  $_0(x;t)$  to  $_1(x;t)$  and  $_2$  connecting  $_2(x;t)$  to an neighborhood of the origin must lie in these regions. By plotting this information, we can visualize the dynamics of the genus-two ansatz in the spectral plane, and hopefully determ ine the nature of the secondary caustic.

A representative sequence of such pbts is given in F igure 12. Here we see the bands of the G = 2 contour in red and the region where the inequality < ( ( )) < 0 holds shaded in blue. For the contour C we simply take the imaginary interval [0; iA], shown with a black line. Each spectral plot is paired with a plot like F igure 4 but with a small red dot indicating the corresponding point in the (x;t)-plane. The rst plots show the genus-two con guration for a point in the (x;t)-plane just beyond the prim ary caustic. The band I<sub>1</sub> in the left half-plane has just been born from a point ^ where (199) holds. The bands can clearly be joined together with gaps 1 and 2 lying in the shaded regions to complete a contour K<sub>0</sub> [ K 1 that encircles the locus of poles form ( ). Notice, how ever, that according to the subsequent plots in this gure the band I<sub>1</sub> approaches the locus of accum ulation of poles form ( ) as t increases. A lihough a collision of one of the endpoints with the interval [0; iA] would imply a failure of the genus-two ansatz in its original form ulation (that is, without the modi cation described in x 3.9), it is clear by comparison with the corresponding (x;t)-plane plots that the secondary caustic is still far o .




Figure 13. Same as in Figure 12 but with t = 1.0 through t = 1.2 in steps of t = 0.1. See the text for a full explanation.

Figure 13 continues the evolution. Note that between the st two frames, the band  $I_1$  collides with the interval [0; iA], so we must switch to the modi ed version of the genus-two ansatz described in x 3.9. Thus, a new contour arc K<sub>3</sub> must be included and a new inequality < (() 2i<sup>0</sup>) < 0 must be satis ed along this contour. The region where this inequality is satis ed is shaded in green. Thus, the contour arc K<sub>3</sub> must be included region, while the gaps of K<sub>1</sub> [K<sub>2</sub> must lie in the blue shaded regions. Furtherm ore, the contour C must from this time onward be deformed somewhat to the right to adm it the passage of the band endpoint 1 (x;t) \through the branch cut". The deformed contour C we choose here, somewhat arbitrarily, is the union of the two indicated solid black line segments. It is clear that in each case the bands m ay be complemented with gaps in the blue regions to form (along with a sm all interval ()) a closed bop. In cases where this bop necessarily cannot enclose the poles of m () accumulating in [0; iA], it is clear that a curve K<sub>3</sub> lying entirely in the green shaded region may be added that passes over the top of [0; iA] and form s along with parts of the above closed bop the boundary of a region containing the poles.

In F igure 14 we continue the evolution toward a curve in the (x;t)-plane at which the asymptotic behavior abruptly changes for the second time, where we expect to nd a mathematical explanation for the secondary caustic. Note that between the last two snapshots there is a pinch-o of the green shaded region where < (()  $2i^{0}()$  <br/>> 0. When this happens, a contour lobe K  $_{3}$  that serves to bound the region containing the poles of m() (soliton eigenvalues) and also along which the inequality < (()  $2i^{0}()$  <br/>> 10 holds can no longer exist. This is the mathematical mechanism for the development of the secondary caustic.







Figure 14. Same as in Figure 13, but with t = 1:3 through t = 1:3 in steps of t = 0:1. See the text for a full explanation.

To demonstrate more convincingly that the secondary caustic in the numerical reconstructions of the N-soliton solution for large N actually corresponds to the curve in the (x;t)-plane along which the region in which the inequality < (() 2i<sup>0</sup>()) < 0 is pinched o at a point, we used a secant method to nd, for a given x, the t-value at which < (() 2i<sup>0</sup>()) = 0 where ^ is a complex root of <sup>0</sup>() 2i<sup>00</sup>(). Level curves of < (() 2i<sup>0</sup>()) passing through simple critical points like ^ necessarily exhibit a characteristic perpendicular crossing singularity. This method yields (approximate) coordinates of points in the (x;t)-plane at which the con guration of level curves makes a transition between the two types of con gurations illustrated in the nal two frames of Figure 14. These points lie along a curve t = t<sub>2</sub>(x) that de nes the location of the secondary caustic. C on gurations corresponding to three of the points we obtained in this way are illustrated in Figure 15.

#### 6. Transition to Higher Genus

6.1. V iolation of the new inequality. According to the numerics explained in x 5, the failure of the genus-two ansatz at the secondary caustic corresponds to the equations (com pare with (199)):




Figure 16. The discontinuity contours for P ( ) in the genus–four con  $\,$  guration with a band on the outer contour lobe K  $_3$  .

In this section we describe the modi cations to the endpoint equations that arise when we allow a band to lie on the arc K<sub>3</sub>. In particular, we suppose that there is a single band in each of the arcs K<sub>0</sub>, K<sub>2</sub>, and K<sub>3</sub>, and we develop equations corresponding to (131) and (133){(134) in this special case. The resulting contours of discontinuity for P() in this situation are illustrated in Figure 16. K nowing that they admit the solution = 0 when (x;t) is a point on the secondary caustic, we wish to solve them for the variables and for nearby (x;t). We will show that there is a unique solution satisfying the condition that and are complex conjugates of each other for real x and t (there are other solutions that bifurcate from = 0 that do not have this symmetry, which is the primary source of di culty). We de ne polar coordinates by

(241) 
$$= re^{i}; = re^{i};$$

and consider the equations  $\tilde{R}_2 = 0$  and  $\tilde{V}_2 = 0$  naturally complexied (that is, the left-hand sides extended as analytic functions of four complex variables x, t, r, and . Being as the complexi cation of  $\tilde{R}_2$  can be written as the average of two integrals, one on a path surrounding the two endpoints  $_3$  and  $_4$  and the other on a path surrounding the two endpoints  $_3$  and  $_4$ , it is easy to see that  $\tilde{R}_2$  is an even function of and individually that vanishes when = 0, and therefore the equation  $\tilde{R}_2 = 0$  has the form

(242) 
$$0 = (x;t)r^2 \cos(2((x;t))) + \text{quartic (and higher order) term s in r.}$$

This equation clearly denes two analytic curves crossing orthogonally at the origin in the real polar plane, with angles = (x;t) + = 4 + n = 2.

Now, the complexied form of  $V_2$  denes a multivalued function of and , even when we restrict to the real subspace where these two variables are complex conjugates of each other. This comes about because the value of the integral term inating at  $_3$  in  $V_2$  can change its value if  $_3$  and  $_4$  are permuted. This monodromy e ect can, how ever, be removed in the real subspace, because the deformation (; )! ( $e^i$ ;  $e^{-i}$ ) for

going from zero to (which exchanges the endpoints and their conjugates) simply adds to  $V_2$  a copy of the function  $\tilde{R}_2$ . This suggests that in place of  $V_2 = 0$  we can solve an equivalent modi ed equation that is single-valued in the real subspace. Indeed, we opt to replace  $V_2 = 0$  by  $V_2^{\#} = 0$  where

Here  $\Upsilon_+$  () refers to the boundary value taken by  $\Upsilon$  () on  $A_2$  from the interior of this closed contour. C learly the equation  $\tilde{V}_2^{\#} = 0$  has the same solutions as does  $\tilde{V}_2 = 0$ , subject to the condition  $\tilde{R}_2 = 0$ . But the function  $\tilde{V}_2^{\#}$  has the advantage of being single-valued in the realpolar plane of (r; ). Moreover, we may write  $\tilde{V}_2^{\#}$  in the form

Here we see that the rst term of  $\nabla_2^{\#}$  is complexied as an analytic function of <sup>2</sup> and <sup>2</sup> individually. Therefore it has an expression in the realpolar plane of the form  $f(x;t) + O(r^2)$ . The complexi cation of the second term, while single-valued when and are complex conjugates of one another, is not single-valued in a full C<sup>2</sup> neighborhood of = 0. Therefore it cannot have a two-variable Taylor expansion; how ever the factor multiplying log(r) clearly is an even analytic function of both and that vanishes when = 0 (this is of course just the complexi cation of the harm onic conjugate  $\Re_2$ ). Consequently, in the real polar plane we have

(245) 
$$\nabla_2^{\#} = \frac{(x;t)}{2} r^2 \log(r) \sin(2((x;t))) + (x;t) + O(r^2);$$

where (x;t) is an analytic function of x and t that vanishes to rst order on the secondary caustic; it is the value of  $\nabla_2^{\#}$  given by (244) evaluated with all endpoints in the degenerate conguration. Equating this to zero, we see that the balance must occur between the  $r^2 \log(r)$  term and the constant term, so the the distance from the secondary caustic scales as  $r^2 \log(r)$  as the new band is born. The curve described by (245) near the origin in the polar plane consists of two approximately hyperbolic branches with asymptotes rotated from the curves described by the equation  $\mathbb{R}_2 = 0$  by =4. Thus, we obtain for each point (x;t) su ciently close to the secondary caustic a pair of opposite solutions for  $= re^i$ . As (x;t) changes sign, the two points come together at = 0 and then go back out along the perpendicular direction.

Determ ination of the sign of (x;t) analogous to what is carried out in [10] is then needed to show that the points  $_3(x;t)$  and  $_4(x;t)$  separate in the direction conducive to the completion of a genus-four ansatz as long as x decreases (or t increases) as the secondary caustic is crossed. C om bining these steps completes the proof that upon crossing the secondary caustic the asymptotic description of the N -soliton is given in term s of R iem ann theta functions of genus four.

We also note that the equations  $\Re_2 = 0$  and  $\nabla_2 = 0$  imply that the new band  $I_2$  and the boundary curves of the region where the inequality < ( ( )  $2i^0$  ( )) < 0 holds are trajectories of the quadratic di erentialR ( )<sup>2</sup>  $\Upsilon_+$  ( )<sup>2</sup> d<sup>2</sup>, while the other two bands and the boundaries of the region where the inequality < ( ( )) < 0 holds are trajectories of R ( )<sup>2</sup> Y ( )<sup>2</sup> d<sup>2</sup>.

62.3. W hitham equations. Recall from x 3.4.1 that for arbitrary even genus G (including G = 4 as a special case), if the endpoints occur along K<sub>0</sub> [K<sub>1</sub> or K<sub>0</sub> [K<sub>1</sub> [K<sub>2</sub>, then the endpoints in plicitly de ned as functions of (x;t) via the relations  $E_1 = =_{2G}E_2 = 0$  satisfy a universal set of quasilinear partial di erential equations, namely the W hitham equations (159) with complex characteristic velocities given as functions of the endpoints only via (160).

W e have just seen, how ever, that with

the conditions  $\tilde{\mathbf{E}}_1 =$  $\vec{E}_{10} = 0$  determ ining the endpoints  $_0$ ; ...;  $_4$  in the genus-four con guration just beyond the secondary caustic have a di erent form than the relations  $E_1 = \frac{1}{20}E = 0$  (for G = 4) from x 3.4.1. In particular, a con guration  $_0$  (x;t); :::;  $_5$  (x;t) satisfying  $E_1 =$ =10E= 0 does not satisfy the equations  $\mathbf{E}_1 = \mathbf{E}_{10} = 0$ . Nonetheless, these latter conditions also determ ine in plicitly functions  $_0$  (x;t);:::;  $_5$  (x;t) satisfying exactly the sam e W hitham equations.

Theorem 1. Any continuously di erentiable solution  $_0(x;t); \dots; _4(x;t)$  of  $E_1 = E_{10} = 0$  satis es the W hitham equations (159) with complex characteristic velocities given by (160) in any region of the (x;t)plane where the endpoints are distinct.

Proof. We complexify the functions  $E_n$ , letting  $\vee$  denote the vector  $(0; \ldots; 4; 0; \ldots; 4)^T$  of endpoints and their complex conjugates, viewed as independent variables. Then, direct calculations show that, by analogy with (153),

and by analogy with (154) we have

(248)

so that

(249) 
$$\frac{\partial \mathcal{E}_{n}}{\partial v_{k}} = i \frac{\partial \mathcal{M}_{0}}{\partial v_{k}} \prod_{n=1}^{n} \frac{\mathcal{R}()d}{v_{k}} \prod_{n=1}^{n-1} \frac{\mathcal{R}()d}{v_{k}} = J_{nk} (v) \frac{\partial \mathcal{M}_{0}}{\partial v_{k}};$$

for n = 1, n = 2, and n = 4, where  $J_{nk}$  (v) are exactly the same matrix elements as de ned for G = 4 by (155). The corresponding calculation for partial derivatives of  $\mathbb{E}_3 = \mathbb{V}_2$  is slightly m ore complicated due to the appearance of terms explicitly depending on  $_2$  and  $_2$ ; however since

(250)

in fact (249) holds for n = 3 as well. Next, by another direct calculation, we nd that by analogy with (156),

(251) 
$$\frac{\partial \mathbf{E}_n}{\partial \mathbf{v}_k} = \frac{1}{2} \mathbf{E}_{n-1} + \mathbf{v}_k \frac{\partial \mathbf{E}_{n-1}}{\partial \mathbf{v}_k}; \quad \text{for } 6 \quad n \quad 10$$

so that on a solution we have

(252) 
$$\frac{\partial \mathcal{E}_n}{\partial v_k} = v_k^{n-1} \frac{\partial \mathcal{E}_5}{\partial v_k} = v_k^{n-1} \frac{\partial \mathcal{M}_0}{\partial v_k} = J_{nk} (v) \frac{\partial \mathcal{M}_0}{\partial v}; \quad \text{for } 5 \quad n = 10,$$

where again the matrix elements  $J_{nk}$  (\*) are precisely the same as dened by (157). Therefore, the elements  $\mathfrak{GE}_n = \mathfrak{Gv}_k$  are assembled into the Jacobian matrix having the factorized form :

$$\frac{\partial \widetilde{E}}{\partial v} = J(v) \quad \text{diag } \frac{\partial M_0}{\partial v_1}; \dots; \frac{\partial M_0}{\partial v_{10}};$$

where the factor J(w) is exactly the same function of v as in the case studied in x 3.4.1. Noting that the partial derivatives  $@E_n = @x$  and  $@E_n = @t$  are all identical expressions in term s of v as in x 3.4.1, it then follows by application of C ram er's rule that

(254) 
$$\frac{\partial v_k}{\partial t} + c_k (v) \frac{\partial v_k}{\partial x} = 0; \quad \text{for } k = 1; \dots; 10,$$

where the characteristic speeds are exactly the same functions of v (see (160)) as in x 3.4.1.

To reiterate, the only di erence between the derivation here and that in the case when no endpoints lie on K  $_3$  is in the diagonal factor of the Jacobian consisting of the partial derivatives  $\mathbb{C}M_0 = \mathbb{C}v_k$ , which certainly are di erent functions of v than the derivatives  $\mathbb{C}M_0 = \mathbb{C}v_k$ . However, this diagonal factor cancels out of the C ram er's rule form ula for the characteristic velocities  $c_k$  (v). Note that the condition that the diagonal factor is nonsingular is, due to (248), equivalent to the function R ()Y () which de nesthe bands vanishing exactly like a square root at the band endpoints.

# 7. Conclusion

In this paper we have done the following things.

W e used a num erical linear algebra m ethod for computing the N-soliton for several values of N as large as N = 40, plotted the results and described the phenom ena of m acrostructure, m icrostructure, and phase transitions (caustic curves) that become m ore well-de ned as N ! 1.

We have described a new modi cation of the asymptotic technique struged in [10] to analyze the N-soliton for large N that gives an improved error estimate of O (N<sup>1</sup>) over the cruder estimate of O (N<sup>1=3</sup>) reported in [10].

W e analyzed the Fourier power spectrum of the N -soliton in the genus-zero region before the primary caustic and related the results to supercontinuum generation of coherent broadband spectra from narrow-band sources in optical bers with weak anom alous dispersion.

We computed numerically for the  $\,$ rst time the bands of discontinuity of  $d^{2}($ ) in the genus-two region beyond the primary caustic and pointed out the phenomenon of a band crossing the locus of accumulation of discrete eigenvalues for the N-soliton.

W e introduced a new multi-interpolant asymptotic procedure that allows the genus-two ansatz forg() to be continued through the discrete eigenvalues, proving that this phenom enon is not the cause of the secondary caustic.

We observed num erically the failure of a new inequality associated with the multi-interpolant approach that becomes necessary once a band crosses the discrete spectrum, and we gave evidence that this failure is the mathematical mechanism for the secondary caustic phase transition.

We have shown that, under the assumption that the new inequality indeed fails as we have observed numerically, the secondary caustic represents a change of genus from G = 2 to G = 4 but with new topological features of the genus-four ansatz for g() that have not been seen before. We also proved that despite the unusual appearance of the implicit relations de ning the band endpoints in this case, the endpoints still satisfy the W hitham equations.

The nature of the mathematical mechanism for the secondary caustic leads us to hypothesize that there could easily be an in nite number of caustic curves in the (x;t)-plane of the N-soliton in the large N limit. The scenario we imagine is the following: as t increases for xed x > 0, the new band  $I_2$  that we have shown opens up upon crossing the secondary caustic drifts toward the imaginary interval [0;iA] of accumulation of discrete eigenvalues. When  $I_2$  meets this interval, the analysis fails once again until it is rescued (in

analogy with the modi cation we introduced in x 3.9) by adjoining a new contour lobe, K  $_5$ , enclosing a region D  $_5$  adjacent to D  $_3$  in which the correct interpolation formula to use is the analogue of (192) with the term  $3i^{0}()$  in the exponent replaced by  $5i^{0}()$ . A long K  $_5$  we require a new inequality, namely <(()) 4i^{0}()) < 0. The region in which this inequality holds eventually pinches o (a tertiary caustic), and the situation is resolved by introducing a new band  $I_3$  on K  $_5$  which results in local dynam ics described by R iem ann theta functions of genus six. The reader can then im agine that the process repeats again and again. The kth caustic curve is described by eliminating  $\hat{}$  from the equations

The formula for () of course changes each time a caustic is crossed and a new band is added. Thus, a harbinger of a developing caustic curve is a recently born band meeting the imaginary axis. This can be detected just by observing the wave eld as long as (like we see in the numerical constructions of g() in the genus-two case) the endpoint crossing the imaginary axis has an imaginary part much larger than those of all other endpoints. In this case, the wave eld, although locally described by R iem ann theta functions of som e even genus G > 0, is well-approximated by a complex exponential function  $e^{i(kx + t)-r}$  (because the genus is \almost work ost" zero), and the real part of the dom inant endpoint is proportional to the wavenum ber k. Thus a sign change of k, which could be detected by local spectral analysis, indicates the dom inant endpoint crossing the imaginary axis, an event that precedes the form ation of a new caustic.

We want to stress that the mechanism for all of the caustics beyond the primary caustic depends in a crucial way on the discrete nature of the spectrum for the N-soliton, which causes us to reinvent our method of analysis each time a band wants to cross the discrete spectrum. Signi cantly, if we chose to begin our analysis by assuming that there is no essential cost in the limit ~! 0 for analyzing the form al continuum -limit problem for P() (in which we simply neglect the difference between the discrete spectral measure and its weak limit as N ! 1) in place of the exact R iem ann-H ilbert problem for P(), we would not need to modify our analysis if a band crosses the spectrum, and we would not need to introduce the new inequality <(() 2i<sup>0</sup>()) < 0 that leads to the secondary caustic. In other words, the form al continuum - limit problem corresponds to a solution  $_{N}^{N}(x;t)$  of the focusing nonlinear Schrödinger equation (3) that accurately resembles the N-soliton  $_{N}(x;t)$  for (x;t) in the region before the secondary caustic, but not beyond. In particular, the solution obtained from the form al continuum -limit problem does not experience any phase transition at all when the N-soliton experiences the secondary caustic. O f course, as the form al continuum -limit problem may break the even symmmetry of the N-soliton (recall x 3.2.2) we have no solid grounds for expecting any similarity between  $_{N}(x;t)$  and  $_{N}^{(x;t)}$  for any x and t, and therefore it seems to us that we must therefore regard the correspondence before the secondary caustic as a lucky coincidence.
