# On the W hitham hierardhy: dressing sdhem e, string equations and additional sym m etries

#### Abstract

A new description of the universalW hitham hierarchy in term s of a factorization problem in the Lie group of canonical transform ations is provided. This schem e allows us to give a natural description of dressing transform ations, string equations and additional sym m etries for the $W$ hitham hierarchy. W e show how to dress any given solution and prove that any solution of the hierarchy $m$ ay be undressed, and therefore com es from a factorization of a canonical transform ation. A particulary im portant function, related to the -function, appears as a potential of the hierarchy. W e introduce a class of string equations which extends and contains previous classes of string equations considered by K richever and by Takasaki and Takebe. The schem e is also applied for an convenient derivation of additional symm etries. $M$ oreover, new functional sym m etries of the Zakharov extension of the Benney gas equations are given and the action of additional sym m etries over the potential in term s of linear P D Es is characterized.


## 1 Introduction

D ispersionless integrable $m$ odels, see [14], [31], [32] and [11], appear in the analysis of various problem s in physics and applied $m$ athem atics from the theory of quantum elds, see [12] and
[2], to the theory of conform al and quasicon form alm aps on the com plex plane, see [5]-[10]. T he new m illenn ium brought new applications of these models, see [29]-[28], in di erent areas, as for exam ple integrable deform ations of conform alm aps e interfacial processes.

The K richever's universalW hitham hierarchies, see [11]-[12], are the integrable system s involved in these applications. T hese hierarchies include as particular cases the dispersion less K P, dispersionless m odi ed KP and dispersionless Toda hierarchies, see [29]-[1] and [8]-[23]. The role of twistor or string equations for studying dispersion less integrable models was em phasized by Takasaki and Takebe in [23]-[27]. Solutions of these string equations have attractive $m$ athem atical properties as well as interesting physicalm eaning.

The ob jective of this paper is to form ulate the factorization problem for the zero genus W hitham hierarchy w thin the context of Lie groups of sym plectic transform ations, and to give a natural and general form alism for string equations and additional sym $m$ etries. In particular, we characterize an special class of string equations, related to a $V$ irasoro algebra. It tums out that th is class determ ines not only the solutions of the algebraic onbits of the $W$ hitham hierarchy [12] but also the solutions arising in the abovem entioned application s of dispersion less integrable m odels [18]-[19].
$T$ he layout of the paper is as follow s . In x 2 we introduce the L ie algebraic splitting for H am iltonian vector elds and the corresponding factorization problem for canonical transform ations. Then, in x3 we show how deform ations of the factorization problem of canonical transform ations lead to solutions of the $W$ hitham hierarchy. W e rem ark a particular system of equations with in the hierarchy: T he B oyer\{F in ley\{Benney equations, which extend the Boyer\{F inley and the Benney equations, respectively. H ere we also introduce a potential function of the hierardhy from which all the elds of the hierarchy are gotten by appropriate derivations. In a forthcom ing paper [20] we show that this function is the $x$-derivative of $\log$, where is the -function of the hierarchy. W e proof that any solution of the $W$ hitham hierarchy $m$ ay be obtained from a factorization problem; i.e. 边 $m$ ay be undressed. To conclude the section we extend the factorization schem e to get the dressing of any given solution of the $W$ hitham hierarchy. In section 4 we consider the string equations in the context of the factorization problem. For that aim we introduce the $O$ rlov $\{S c h u l m$ an functions, and show that the factorization problem leads to string equations. Thus all solutions of the $W$ hitham hierarchy fill $1 l$ certain set of string equations. In [20] we show that any solution of the string equations is a solution of the $W$ hitham hierarchy. We nish this section by introducing som e particular factorization problem $s$ and the corresponding string equations w hich generalize and contains as particular cases, the string equations of $K$ richever and of $T$ akasaki\{ $T$ akebe. $F$ inally, $x 5$ is devoted to the study of additional sym $m$ etries of the $W$ hitham hierarchy. $F$ irst $w e$ derive the additional sym $m$ etries from the factorization problem, and then characterize its action over the potential function of the hierardyy. $W$ e com pute the additional sym $m$ etries of the $m$ entioned B oyer\{ $F$ in ley $\{B$ enney system and obtain a set of explicit functional sym $m$ etries. In particular, for the $Z$ akharov extension of the B enney system we get explicit functional sym $m$ etries depending on three arbitrary functions of variable. W e conclude by considering the action of $V$ irasoro type of additional sym $m$ etries on our extension of the $K$ richever and Takasaki\{Takebe string equations and show ing that solutions of string equations are invariant solutions under a Lie algebra of additional sym m etries, which contains tw o set of V irasoro algebras.

## 2 The factorization problem

### 2.1 Lie algebraic setting

W e present a splitting which is inspired in [22] and in [15], where it was used for a better understanding of harm on ic $m$ aps and chiral models. T he factorization problem technique was applied to the dispersion less K P hierarchy in [7], and is inspired in the dressing $m$ ethod proposed by Takasi and Takabe in the series of papers [23]-[27].

G iven the set $\mathrm{fq}^{(0)} \mathrm{g}^{\mathrm{M}}=0 \quad \mathrm{C}, \mathrm{q}_{0}^{(0)}=1$, of punctures in the extended com plex plane, we introduce the local param eters $p{ }^{1}$ where

For each set of punctures we consider the set $R$ of rational functions in $p w$ ith poles at the punctures; i.e., the functions $f=f(p)$ of the form

W e refer to F igure 1 for a graphical ilhustration of the rational splitting and its com pletion. N ow, we shall extend the above splitting to the Lie algebra of sym plectic vector elds. In spite that norm ally the coordinates ( $p ; x$ ) are real, here we will consider that they take com plex values. T his extension does not a ect the standard local sym plectic constructions.

H ere, we suppose that the coe cients of the vector elds are com plex valued functions. Let us describe in $m$ ore detail these $L$ ie algebras:

### 2.2 Lie group setting

W e now extend the previous construction from the context of $L$ ie algebras to the corresponding Lie groups of canonical transform ations. A ssociated w th each H am ittonian vector eld $\mathrm{X}_{\mathrm{H}}=$ ad $H$ we have the corresponding $H$ am ilton's equations $p=H_{x} \boldsymbol{x}=H_{p}$ that when integrated provides us w ith a ow ${ }_{t}^{H}$, a 1-param eter group of sym plectic di eom orphim $s,(\mathrm{p}(\mathrm{t}) ; \mathrm{x}(\mathrm{t}))=$
${ }_{t}^{H}\left(p_{0} ; x_{0}\right)$ for given initial conditions $(p ; x) \dot{i}=0=\left(p_{0} ; x_{0}\right)$. The exponentialm apping is just the evaluation at $t=1$; i.e. $\exp X_{H}={ }_{t=1}^{\mathrm{H}}$. The group of sym plectic di eom onphim s is a sm ooth regular Lie group w ith L ie algebra given by the set of $H$ am ittonian vector elds [9]. Sym plectic di eorm orphím s are also known as canonical transform ations.

It can be shown [9] that the adjoint action of the group of sym plectic di eom onphim son its Lie algebra (i.e., the set of H am iltonian vector elds) is given by the action of the corresponding induced ow:

The existence problem for (5) will not be treated here. A nyhow, we will assum e that all tim es $J_{n}$ jand initialconditions are sm allenough to ensure that such factorization exists (notice the trivial existence for $T=0$ and $G=0$ ).

O bserve that given a set of in itial conditions $f G g^{M}=0$ the factorization problem (5) consists in nding $H,=0 ;::: ; \mathrm{M}$, and $H$ as functions of $t$. Let us right-multiply both term $s$ of the equality (5) by a term of the form $e^{a d G}$, where G $2 r$. On the left-hand term we have $e^{\mathrm{ad} T} e^{\mathrm{ad} G}$, where the new initial conditions are

Therefore, once we have a solution ( $\mathrm{H} \quad ; \mathrm{H}$ ) for an initial condition $G$ it is trivial to nd solutions ( $\mathbb{H}^{\sim} ; H^{r}$ ) for initial conditions C (c ; C (G;r)). The orbits $e^{\operatorname{adc}} e^{\operatorname{adG}} e^{\operatorname{adr} r}$ describe the m oduli space of solutions to the factorization problem (5). Thus, if we concentrate on the
right action of $r$, we $m$ ay take $G \quad 2 g$ and the right coset $e^{\operatorname{adG}} e^{\text {adr }}$ (or the $H$ am iltonian C ( $G ; r)$ ) as the point in the moduli.

A swew ill see the factorization problem (5) for the action of sym plectic di eom orphim s on the set of functions (observables) im plies the $W$ hitham hierarchy. Therefore, the factorization problem (4) for sym plectic di eorm onphism is also associated $w$ th the $W$ hitham hierarchy. To get these results we will use a well known tool in the theory of regular Lie groups: the right logarithm ic derivative as de ned in [9], see the A ppendix. If we have a sm ooth curve $H: T \quad C^{1}(\mathbb{N})$, assum ing that $T$ is the tim e manifold $w$ ith local coordinates given by $t=\left(t_{n}\right)$ and denoting $@_{m}:=\frac{@}{@ t_{n}}$, the right logarithm ic derivative is

## 3 D ressing $m$ ethods for the $W$ hitham hierarchy

In this section we analyze how the factorization problem (5) is related w ith the W hitham hierarchy and its dressing transform ations. W e rst show that (5) leads to the $W$ hitham hierardhy, de ning the Lax functions a zero-curvature form s . $T$ hen, we construct a potential function $\mathrm{h}_{01}$ of this hierarchy, and as we shall show in the forthcom ing paper [20] $\mathrm{h}_{01}=(\mathrm{log}) \mathrm{x}$ in term s of the -function of the hierardy. In x3.1 we have proved that the di erential version of the factorization problem (5) m ay be described in term $s$ of the $W$ hitham hierarchy. ## 4 String equations in the $W$ hitham hierarchy

In this section we study the form ulation of the $W$ hitham hierarchy in term $s$ of tw istor or string equations and the relation of this form ulation $w$ th the dressing $m$ ethod described above. $W$ e rst introduce the $O$ rlov\{Schulm an operators for the $W$ hitham hierarchy in term $s$ of the factorization problem and then obtain the string equation form ulation as a consequence of the factorization problem. In the forthcom ing paper [20] we w ill show that, in fact, the string equations give all solutions of the $W$ hitham hierardhy. Then, string equations and factorization problem are equivalent tools to form ulate the $W$ hitham hierarchy. Finally, we introduce a very special class of string equation whose construction is based on centerless $V$ irasoro algebra w ithin the $H$ am iltonian functions, and therefore we refer to this as the $V$ irasoro class of string equations.
