Generalised Perk {Schultz models: solutions of the Yang-Baxter equation associated with quantised orthosymplectic superalgebras

A bstract

The Perk{Schultz model may be expressed in terms of the solution of the Yang{Baxter equation associated with the fundamental representation of the untwisted an extension of the general linear quantum superalgebra U_q [sl(m jn)], with a multiparametric co-product action as given by Reshetikhin. Here we present analogous explicit expressions for solutions of the Yang-Baxter equation associated with the fundamental representations of the twisted and untwisted an extensions of the orthosym plectic quantum superalgebras U_q [osp (m jn)]. In this manner we obtain generalisations of the Perk{Schultz model.

1 Introduction

The Perk{Schultz model [1,2] is well known to be exactly solvable [3]. For xed d > 1, the model is de ned on a square lattice where each edge can occupy one of d states. In addition to the spectral parameter the model depends on 1 + d(d-1)=2 continuous variables, and d discrete variables which have value 1. One method to formulate the model and obtain the exact solution is through the R-matrix associated with the fundamental representation of the quantised untwisted a negeneral linear superalgebra U_q [sl(m jn)⁽¹⁾] [4]. The exact solution follows from the fact that the R-matrix satis es the Yang{Baxter equation. In this setting, the continuous variables are given by the deformation parameter q, as well as d(d-1)=2 variables associated with the Reshetikhin twist [4,5] on the coalgebra structure. The discrete variables are associated with the Z_2 -grading of the d-dimensional vector space which a ords the representation of the U_q [sl(m jn)⁽¹⁾] superalgebra, where m + n = d.

Here we report the extension of this result to the case of the quantised untwisted a ne superalgebra $U_q[sp(m\ j_1)^{(1)}]$ and the twisted case $U_q[sl(m\ j_1)^{(2)}]$ where n=2k is even in both instances. A representation theoretic approach is adopted to $nd\ R$ -m atrices satisfying the Z_2 -graded Y ang {Baxter equation (YBE)

where R (z) 2 End (V ($_1$) V ($_1$)) and V ($_1$) is the (m + n)-dimensional space for the vector representation of U_q [osp (m jn)] of highest weight $_1$. The multiplication on the tensor product space is Z_2 -graded (see equation 1 in the following section). The construction of R-matrices satisfying the Z_2 -graded YBE for the general case V ($_a$) V ($_b$) (where $_a$; $_b$ are the highest weights of the modules) has been delineated in [6,7]. In those works, the solutions are presented in general terms as a linear combination of elementary intertwiners, where the co-e cients are determined through tensor product graph methods. However, to have fully complete expressions it is necessary to determine also the form of the U_q [osp (m jn)] invariant intertwiners which project out the submodules in the tensor

product decomposition. Here, we will explicitly formulate R-matrices for the case V ($_1$) V ($_1$) for U $_q$ [osp (m jn)], in both the twisted and untwisted cases by explicitly computing the elementary intertwiners. We mention that formal expressions for the solutions of the Yang{Baxter equation associated with fundamental representations of superalgebras are given in [8], which may also be used to determine explicit expressions for the R-matrices (e.g. [9]). An alternative approach is to use the Lax operator method as described in [10,11].

Once the explicit R-m atrices have been obtained, we will introduce the Reshetikhin twist [5] in order to generate more general R-m atrices with additional free parameters. These results can be used to obtain classes of integrable H am iltonians describing systems of interacting fermions, with potential applications in condensed matter systems (cf. [12]).

2 The quantised orthosym plectic superalgebra U_q [osp (m jn)]

The quantum superalgebra $U_q[sp(m j)]$ is a q-deformation of the classical orthosym plectic superalgebra. A brief explanation of $U_q[sp(m j)]$ is given below, with more details to be found in [10]. Throughout we use n=2k and $l=b^m_2 c$, so m=2l or m=2l+1.

U sing these conventions, the quantum superalgebra U_q [osp (m jn)] is generated by simple generators e_a ; f_a ; h_a subject to relations including:

We remark that U_q [osp (m jn)] has the structure of a quasi-triangular Hopf superalgebra. In particular, there is a superalgebra homomorphism known as the coproduct, $: U_q$ [osp (m jn)]! U_q [osp (m jn)] 2 , which is de ned on the simple generators by:

Here R $_{ab}$ represents a copy of R acting on the a and b components respectively of U U, where each U is a copy of the quantum superalgebra U_q [osp (m $_{in}$)].

Now let End V be the space of endom orphisms of V, an (m + n)-dimensional vector space. Then the irreducible vector representation $:U_q[osp(m j_1)]!$ End V acts on the $U_q[osp(m j_1)]$ generators as given in Table 1, where E_b^a is the elementary matrix with a 1 in the (a;b) position and zeroes elsewhere.

The solutions to the Yang{Baxter equation in a given representation of U_q [osp (m jn)] can sometimes be extended to solutions of the spectral param eter dependent Y ang {B axter equation




Figure 1: The untwisted tensor product graph




Figure 2: The twisted tensor product graph

4 The Reshetikhin Twist

Let (A; ;R) denote a quasi-triangular H opf superalgebra where and R denote the coproduct and R-m atrix respectively. Consider an element F 2 A A satisfying the properties

Then (A; F; RF) is also a quasi-triangular Hopf superalgebra with coproduct and R-matrix given by

We refer to F as a twist element. In particular, for the case of a quantised superalgebra $U_q[g]$ Reshetikhin [5] gave the example where F is given by

with fh_{bg} the generators of the Cartan subalgebra of $U_{q}[g]$ and the $_{bc}$; b < c, arbitrary complex parameters.

Applying this twist to R (z), it is found that both $U_q[osp(m j_1)^{(1)}]$ and $U_q[gl(m j_1)^{(2)}]$ are quasitriangular H opf superalgebras with coproduct F as above and R-m atrix in the fundam ental representation given by

for U_q [gl(m jn)⁽²⁾]. In the above form ulae the representations (h_b) are given by Table 1. For both cases we have obtained models with (l+ k) (l+ k 1)=2 continuous variables (the ab) and m + n discrete variables (the grading terms (1)^[a]: note that there must be an even number of indices a for which [a] = 1, and also that the a_b explicitly depend on them). These variables are in addition to the spectral parameter z. Both models may be considered as generalisations of the Perk {Schultz model. Independently, similar results have been reported in [13].
