# THE METHOD OF MOMENTS FOR NONLINEAR SCHRODINGER EQUATIONS: THEORY AND APPLICATIONS.

A b stract. The m ethod of m om ents in the context of N onlinear Schrodinger E quations relies on de ning a set of integral quantities, which characterize the solution of this partial di erential equation and whose evolution can be obtained from a set of ordinary di erential equations. In this paper we nd all cases in which the m ethod of m om ents leads to closed evolution equations, thus extending and unifying previous works in the eld of applications. For some cases in which the m ethod fails to provide rigorous inform ation we also develop approxim ate m ethods based on it, which allow to get some approxim ate inform ation on the dynam ics of the solutions of the N on linear Schrodinger equation.

1. Introduction. Nonlinear Schrödinger (NLS) equations appear in a great array of contexts [1] as for example in sem iconductor electronics [2, 3], optics in nonlinear media [4], photonics [5], plasm as [6], fundam entation of quantum mechanics [7], dynam ics of accelerators [8], mean-eld theory of Bose-Einstein condensates [9] or in biom olecule dynam ics [10]. In some of these elds and many others, the NLS equation appears as an asymptotic limit for a slow ly varying dispersive wave envelope propagating in a nonlinear medium [11].

The study of these equations has served as the catalyzer of the developm ent of new ideas or even m athem atical concepts such as solitons [12] or singularities in EDPs [13, 14].

One of the most general ways to express a nonlinear Schrodinger equation, is

where =  $0^2 = 0 x_1^2 + 2 = 0 x_n^2$  and u is a complex function which describes some physical wave. We shall consider here the solution of (1.1) on R<sup>n</sup> and therefore u : R<sup>n</sup> [0;T]! C, with initial values u (x;0) = u\_0 (x) 2 X, X being an appropriate functional space ensuring niteness of certain integral quantities to be de ned later.

The fam ily of nonlinear Schrödinger equations (1.1) contains many particular cases, depending on the speci c choices of the nonlinear term  $sg(j_1f;t)$ , the potentials V (x;t), the dissipation (t) and the dimension of the space n. The best known cases are those of power-type  $g(j_1f) = j_1f$  or polynom ial  $g(j_1f) = 1$  j $j_1f^1 + 2$  j $j_1f^2$  nonlinearities.

The potential term V (x;t) m odels the action of an external force acting upon the system and m ay have m any form s. Finally, we include in Eq. (1.1) a simple loss term arising in di erent applications [15, 16]. In m any cases these losses are negligible, i.e. = 0.

The description of the dynam ics of initial data ruled by this equation is of great interest for applications. Nevertheless, gathering information about the solutions of a partial di erential equation that is nonlinear like (1.1) constitutes a problem that is a priori nearly unapproadable. For this reason, most studies about the dynam ics of this type of equation are exclusively numerical. The rigorous studies carried out to date concentrate on (i) properties of stationary solutions [17], (ii) particular results on the existence of solutions [18, 19], and (iii) asymptotic properties [13, 14].

Only when  $n = 1;g(j_1j_1;t) = j_1j_1;V(x;t) = 0; = 0$  it is possible to arrive at a solution of the initial value problem by using the inverse scattering transform method [12]. In this paper we develop the so-called method of moments, which tries to provide qualitative information about the behavior of the solutions of nonlinear Schrödinger equations. Instead of tackling the C auchy problem (1.1) directly, the method studies the evolution of several integral quantities (the so-called moments) of the solution u(x;t). In some cases the method allows to reduce the problem to the study of system s of coupled ordinary nonlinear dimential equations. In other cases the method provides a foundation form aking approximations in a more systematic (and simpler) way than other procedures used in physics, such as those involving nite-dimensional reductions of the original problem : namely the averaged Lagrangian, collective coordinates or variational methods [20, 21]. In any case the method of moments provides an information which is very useful for the applied scientist, who is usually interested in obtaining as much information as possible characterizing the dynamics of the solutions of the problem.

It seems that the rst application of the m ethod of m on ents was performed by Talanov [22] in order to nd a form al condition of su ciency for the blow up of solutions of the nonlinear Schrodinger equation with  $g(j_1 j_1^2) = j_1 j_1^2$  and n = 2. Since then, the m ethod has been applied to di erent particular cases (m ainly solutions of radial symmetry in two spatial dimensions), especially in the context of optics where m any equations of NLS type arise [23].

In previous researchs, the m ethod of m om ents has been studied in a range of speci c situations but in all the cases the success of the m ethod is unrelated to a m ore general study. In this paper we try to consider the m ethod system atically and solve a num ber of open questions: (i) to nd the m ost general type of nonlinear term and potentials in Eq. (1.1) for which the m ethod of m om ents allow s to get conclusions and (ii) to develop approxim ate m ethods based on it for situations in which the m om ent equations do not allow to obtain exact results.

2. P relim in any considerations. Let us de ne the functional space Q (H ) as the space of functions for which the so called energy functional

is nite, G being a function such that  $(G(j_1f;t)=0,j_1f) = g(j_1f;t), (;_{L^2}(k^n))$  denoting the usual scalar product in  $L^2(\mathbb{R}^n)$  and  $H = \frac{1}{2} + V(x;t)$ . For the case V(x;t) = 0 and g independent of time, several results on existence and unicity were given by G inibre and Velo [18].

As regards the case V  $\notin$  0, which is the one we are mainly interested in our work, the best documented case in the literature is that of potentials with  $\therefore$  V jbounded in R<sup>n</sup> for every j j 2; that is, potentials with at most quadratic grow th. Y.Oh 24] proved the local existence of solutions in L<sup>2</sup> (R<sup>n</sup>) and in Q (H) for nonlinearities of the type g(u) = ju<sup>B</sup>; 0 p < 4=n. However the procedure used allows to substitute this nonlinearity with other more general ones. It seems also possible to extend the results to the case in which the potential depends on t.

Therefore, from now on we shall suppose that the nonlinear term satis es the conditions set by G inibre and Velo and that  $\mathcal{D}$  V jis bounded in space for all j j 2. Under these conditions

it is possible to guarantee at least local existence of solutions of Eq. (1.1) in appropriate functional spaces.

2.1. Form all elim ination of the loss term . In the rst place we carry out the transform ation [15]

which is well de ned for any bounded function (t) (this includes all known realistic cases arising in the applications). The equation satis ed by  $\hat{u}(x;t)$  is obtained from the following direct calculation:

From here on we shall consider, with no loss of generality, that (t) = 0 in Eq. (1.1) assuming that this choice m ight add an extra time-dependence to the nonlinear term.

- 3. The m ethod of m om ents: G eneralities.
- 3.1. De nition of the m om ents. Let us de ne the following quantities:

with j = 1; ...; n and k = 0; 1; 2; ..., which we will call moments of <math>u(x;t) in analogy with the moments of a distribution. From now on and also in Eqs. (3.1) it is understood that all integrals and norm s refer to the spatial variables  $x \ge R^n$  unless otherwise stated. In Eqs. (3.1) we denote by u the complex conjugate of u.

In some cases we will make specic reference to which solution u of Eq. (1.1) is used to calculate the moments by means of the notation:  $I_{k;i}^{u}$ , etc.

The moments are quantities that have to do with intuitive properties of the solution u(x;t). For example, the moment  $I_{0;0}$  is the squared  $L^2(\mathbb{R}^n)$ -norm of the solution and therefore measures the magnitude, quantity or mass thereof. Depending on the particular context of application, this moment is denominated mass, charge, intensity, energy, number of particles, etc. The moments  $I_{1;j}(t)$  are the coordinates of the center of the distribution u, giving us an idea of the overall position thereof. The quantities  $I_{2;j}$  are related with the width of the distribution de ned as  $W_j = \begin{pmatrix} \kappa \\ R^n \end{pmatrix} (x_j \\ I_{jj})^2 j_{1j} j_{2j} dx)^{1=2} = (I_{2;j} + I_{1;j}^2 I_{0;0} \\ 2I_{1;j}^2)^{1=2}$ , which is also a quantity with an evident meaning.

The evolution of the moments is determined by that of the function u(x;t). From now on we will assume that the initial datum  $u_0(x)$  and the properties of the equation guarantee that the moments are well de ned for all time.

3.2. First conservation law. It is easy to prove form ally that the moment  $I_{0;0}$  is invariant during the temporal evolution by just calculating

where we have perform ed integration by parts and used that the function u and its derivatives vanish at in nity.

O byiously the above demonstration is form al in the sense that a regularity which we do not know for certain has been used for u. Nevertheless, this type of proof can be form alized by making a convolution of the function u with a regularizing function. The details of these methodologies can be seen in [18] or [24]. In this paper we will limit ourselves to form al calculations.

#### 4. General results for harm onic potentials.

4.1. Introduction. From this point onward we will focus on the particular case of interest for this study when V (x;t) is a harm onic potential of the type V (x;t) =  $\frac{1}{2}$  (x; (t)x), where is a real matrix of the form \_\_\_\_i(t) =  $\frac{2}{i}$  (t) \_ij, with \_i 0 for i = 1;:::,n and \_ij is the K ronecker delta. Bearing in m ind the results of Section 2.1, the NLS equation under study is then

This equation appears in a wide variety of applications such as propagation of waves optical transm ission lines with online modulators [26, 27, 28, 29], propagation of light beam s in nonlinear media with a gradient of the refraction index [30, 31], or dynam ics of Bose-E instein condensates [9]. Generically it can provide a model for studying some properties of the solutions of nonlinear Schrödinger equations localized near a minimum of a general potential V (x).

4.2. First m om ent equations. If we di erentiate the de nitions of the m om ents  $I_{1;j}$  and  $V_{0;j}$ , we obtain, after som e calculations, the evolution equations

so that  $I_{1;j}$ ; j = 1; ...; n satisfy

with inital data  $I_{1;j}(0); I_{1;j}(0) = V_{0;j}(0)$ . These expressions are a generalization of the Ehrenfest theorem of linear quantum mechanics to the nonlinear Schrödinger equation and particularized for the potential that concerns us [24, 32].

This result has been discussed previously in m any papers and is physically very interesting. It indicates that the evolution of the center of the solution is independent of the nonlinear e ects and of the evolution of the rest of the m om ents and depends only on the potential parameters.

4.3. Reduction of the general problem to the case  $I_{1;j} = V_{0;j} = 0$ . We shall begin by stating the following lemma [33]:

Lemma 4.1. Let u(x;t) be a solution of (4.1) with the initial datum  $u(x;0) = u_0(x)$ . Then, the functions

for any set of initial data R (0); R-(0) 2 R<sup>n</sup> are also solutions of (4.1).

Proof. All we have to do is substitute (4.4a), (4.4b) and (4.4c) in (4.1).

O ne noteworthy conclusion is that given a solution of Eq. (4.1) we can translate it initially by a constant vector and obtain another solution. In the case of stationary states, de ned as solutions of the form

which exist in the autonom ous case (i.e. d = dt = 0) and whose dynam ics are trivial, this result in plies that under displacements the only dynam ics acquired are those of the movement of the center given by Eq. (4.4c). The coincidence of the evolution laws (4.3) and (4.4c) allows us to state the following theorem which is an immediate consequence of the above lemma.

Theorem 4.2. If (x;t) is a solution of (4.1) with non-zero  $I_{1;j}$  or  $V_{0;j}$ , then there exists a unique solution  $u(x;t) = (x + fI_{1;j}(t)g_j;t)e^{i(x;t)}$  with

The important conclusion of this theorem is that it suces to study solutions with  $I_{1;j}$  and  $V_{0;j}$  equal to zero, as those that have one of these coeccients dimension from zero can be obtained from previous ones, by means of translation and multiplication by a linear phase in x. From a practical standpoint, what is most important is that  $I_{1;j}$  be null without any loss of generality, as then we can establish a direct link between the widths and the moments  $I_{2;j}$  (see the discussion in the third paragraph of Section 3).

4.4. M om ent E quations. A ssum ing that all of the m om ents can be de ned at any tim e t, we can calculate their evolution equations by m eans of direct di erentiation. The results are gathered in the next theorem .

Theorem 4.3. Let  $u_0(x)$  be an initial datum such that the moments  $I_{2;j}; V_{1;j}; K_j$  and J are well de ned at t = 0. Then

Proof. The demonstration of the validity of Eqs. (4.6) can be carried out from direct calculations, perform ing integration by parts, and using the decay of u and r u at in nity.

To demonstrate (4.6a) it is easier to work with the modulus-phase representation of u,  $u=\ ^{1=2}e^i$  (with > 0). Then

5. Solvable cases of the m ethod of m om ents. In this section we will study several particular situations of practical relevance in which the m ethod of m om ents thoroughly provides exact results.

5.1. The linear case g(;t) = 0. In this case, Eqs. (3.1d) and (4.6d) tells us that J(t) = 0, for all t, and then the moment equations (4.6) become

That is, in the linear case the equations for the m on ents along each direction j of the physical space  $\mathbb{R}^n$  are uncoupled. This property was known in the context of optics for n = 2 and constant j [34]. Here we see that this property holds for any number of spatial dimensions, time dependence (t) and even for nonsymmetric initial data.

5.2. C ondition of closure of the m om ent equations in the general case. Equations (4.6) do not form a closed set and therefore to obtain, in general, their evolution we would need to continue obtaining m om ents of a higher order, which would provide us with an in nite hierarchy of di erential equations. G iven the similarity am ong the term s that involve second derivatives of the phase of the solution in Eqs. (4.6), it is natural to wonder whether it would be possible to som ehow close the system and thus obtain inform ation about the solutions.

Solving (5.12) allows to calculate V and E by simple substitution in (5.10). This equation is similar to that obtained in [30] for solutions of radial symmetry in the case n = 2 and  $g(u) = j_1 f$ . Here we not that it is possible to obtain a more general result for solutions without speci c symmetry requirements, and for any combination of dimension and nonlinearity g(u) = $j_1 f$  satisfying the condition np = 4. The case with sgn(Q) = 1 corresponds to collapsing situations [13, 38]. In what follows we consider mostly the case Q > 0.

Equation (5.12) was studied by Emmakov in 1880 [39], although since then it has been rediscovered many times (see e.g. [40]). It is a particular case of the so-called Emmakov systems [41, 42, 43], for which it is possible to give fairly complete results. Especially easy, though tedious to demonstrate is

Equation (5.13b) is often called the principle of nonlinear superposition. Equation (5.13a) is the well known H ill's equation [44] which m odelizes a parametrically forced oscillator, and which has been studied in depth. In the following, we shall study a couple of special situations in view of their physical interest.

It is remarkable that the complex dynamics of a family of nonlinear partial di erential equations can be understood in term s of a simple equation such as H ill's.

If we suppose that the function <sup>2</sup> (t) depends on a parameter " in the way <sup>2</sup> (t) =  $1 + \sim_{"}$  (t),  $\sim_{"}$  (t) being a periodic function with maximum value " (not necessarily small), there exists a complete theory that describes the intervals of values of " for which the solutions of Eq. (5.13a) are bounded (intervals of stability) and the intervals for which the solutions are unbounded (intervals of instability) [44].

#### 6. Applications.

6.1. Dynam ics of laser beam s in G R IN m edia. W hen a laser beam propagates in a medium with a gradex refraction index (G R IN m edium) with an speci c pro le quadratic in the transverse coordinates, the distribution of intensity u(x;y;z) in perm anent regime is ruled by Eq. (4.1) with g() = and n = 2 (in the optical version of the equation  $t \leq z$ ), so that we are dealing with the critical case that we know how to solve. A librough in principle it would be possible to design bers with arbitrary pro les, technically the simplest way is to join bers with di erent uniform indexes in each section.

In this case, the modelization of the phenomenon is given by

Equation (5.13a) with (t) given by (6.1) is known as the M eissner equation whose solution is trivial, given in each segment by a combination of trigonom etric functions.

The solutions to the M eissner equation can be bounded (periodical or quasiperiodical) or unbounded (resonant oscillations). In gure 6.1 the two types of solutions are shown for a particular choice of parameters.

As far as the regions of stability in the space of parameters are concerned, they can be obtained by studying the discrim inant of equation (5.13a), de ned as the trace of the monodrom y matrix, that is

The F loquet theory for linear equations with periodical coe cients connects the stability of the solutions of (5.13a) with the value of the discriminant. The regions of resonance correspond to values of the parameters for which  $\mathcal{D}$  j> 2, whereas if  $\mathcal{D}$  j< 2 the solutions are bounded [44]. The equations D (a;b;T<sub>a</sub>;T<sub>b</sub>) = 2 and D (a;b;T<sub>a</sub>;T<sub>b</sub>) = 2 are the manifolds that limit the regions of stability in the 4-dimensional space of parameters. In reality, dening = aT; = bT;T<sub>a</sub> = T;T<sub>b</sub> = (1) The number of parameters is reduced to three

The general study of the regions that appear in gure 6.2 is complex, which leads us to focus below on a few particular cases.

If we draw a as a function of 1=T, the regions of resonance are those marked in colors in gure 6.3 (b). Obviously the image is repeated due to the periodicity 2 of D (y) and there are only four basic regions of resonance (together with its harmonics) contained in the intervals (roots of  $f_{+}$  and f): y 2 [0:84;123] [[1:91;2:3] [[3:98;4:37]] [5:05;5:44] (see qure 6.3 (a)).

A nother case of possible interest is that in which one of the bers is not of GRIN type, that is, b = 0. Then the discriminant is given by the limit of equation (6.4) when b ! 0.

Now there is no exact periodicity in the positions of the zeros any more, but at least it is possible to estimate the location of those of high order. To do this we must bear in mind that for y big enough the dominating term in both cases is f (y) ' y sen y, so that the zeros will be given by y = n. It can be seen with a perturbative argument that the convergence ratio is of the order of O (1=n). W riting  $y^{(n)} = n + u^{(n)}$  and substituting it in equations (6.9) it is found that

This type of analysis can be extended to any restricted set of param eters.

6.2. D ynam ics of B ose-E instein condensates. In the case of B ose-E instein condensates, there has recently been great interest in the study of the dynam ics of these systems in a param etrically oscillating potential. Recent experiments (see e.g. [46, 47]) have motivated a series of qualitative theoretical analyses (the pioneer works on this subject can be seen in [48, 49, 50] although there is a great deal of posterior literature).

In the models to which we refer, the trap is modied harm onically in time, that is

with "> 1. Equation 5.13a) with (t) given by (6.11) is called the M athieu equation. For this equation it is possible, as in the case of the M eissner equation, to carry out the study of the regions of the space of parameters in which resonances occur. In the rst place, for any xed ", there exist two successions  $f!_n g; f!_n^0 g$  with  $!_n;!_n^{0 n!}$ ! 0 such that if we take ! 2  $(!_n;!_n^0)$ , equation (5.13a) possesses a resonance. In the second place, for xed !, the resonances appear when " is large enough. The boundaries of those regions are the so-called characteristic curves that cannot be obtained explicitly but whose existence can be demonstrated analytically, as in the previous section, by using the discrim inant. In the case of the M athieu equation, it can be proven that the regions of instability begin in frequencies ! = 2;1;1=2;:::;2=n^2;::: [44].

As in the previous case, the resonant behavior depends only on the parameters, and not on the initial data. W ith respect to stability, the M assers theorem implies that if (";!) is in a region of stability, then there exists a periodic solution of (5.13a), and by the nonlinear superposition principle such a solution is stable in the sense of Liapunov.

## 7. Approxim ate m ethods (I): Q uadratic phase approxim ation (Q PA).

7.1. Introduction and justi cation of the QPA. Up to now, the results we have shown for the evolution of the solution m om ents are exact and in some sense rigorous. Unfortunately, in m any situations of practical interest it is not possible to obtain closed evolution equations for the m om ents. In this section we will deal with an approxim ate m ethod which is based on the m ethod of m om ents.

The idea of this method is to approximate the phase of the solution u by a quadratic function of the coordinates, that is

where U (x;t) is a real function.

W hy use a quadratic phase? A lthough there is not a form al justi cation and we do not know of any rigorous error bounds for the m ethod to be presented here, there are several reasons which can heuristically support the use of this ansatz for the phase for situations where there are no essential shape changes of the solutions during the evolution. First of all, when Eq. (4.1) has self-sim ilar solutions, they have exactly a quadratic phase [45]. Secondly, the dynam ics of the phase close to stationary solutions of the classical cubic NLS equation in two spatial dimensions (critical case) is known to be approximated by quadratic phases [14, 16] Finally, to capture the dynam ics of the phase of solutions close to the stationary ones, which have a constant phase, by means of a polynom ial t, the term s of low est order are quadratic since the linear term s in the phase may be elim inated by using Theorem 4.2.

W e would like to remark that a frequently used approach in the physical sciences to study the evolution of solutions of Eq. (1.1) is the so called collective coordinate m ethod (also called averaged lagrangian m ethod or variational m ethod) where an speci c ansatz for the solution is proposed depending on a nite number (S) of free param eters  $u(x;t) = '(x;p_1(t);::p_S(t))$ . The equations for the evolution of the param eters are then sought from variational arguments [20, 21]. For NLS equations all com m only used ansatzs have a quadratic phase. Our system atic m ethod provides a m ore general fram ew ork in which other m ethods can be system atized and understood.

As we will see in what follows, the choice (7.1) allows to obtain explicit evolution equations and solves the problem of calculating the integrals of the phase derivatives in the equations (4.6).

7.2. M odulated power-type nonlinear term s. Under the QPA, form odulated power-type nonlinearities g(;t) =  $g_0$ (t) p=2, p 2 R for which  $R^n D$ () dx = pJ=2, the moment equations (4.6) are

A gain we obtain a Hill's equation with a singular term. Note that in the case n = 3; p = 2 we have a quartic term in the denom inator, which corresponds with the type of powers that appear in the equations which are obtained in the fram ework of averaged Lagrangian m ethods [20].

The quadratic phase method provides reasonably precise results that at least describe the qualitative behavior of the solutions of the partial di erential equation. Using several numerical methods, we have carried out di erent tests especially in the most realistic case np = 6 in (4.1). For example, in gure 7.1 the results of a simulation of (4.1) with n = 3, p = 2, <sup>2</sup> (t) = 1 + 0.1 sin (2.8t) and  $g_0 = 10$  are presented for an initial datum  $u_0(x) = e^{-x^2 - 2} = 3^{-4}$ . In this case the simplified equation (7.6) predicts quasi-periodic solutions which is what we obtain when resolving the complete problem.

In Fig. 7.2 we show the results for  $^{2}$  (t) = 1 + 0.1 sin (2.1t) for which (7.6) predicts resonant solutions. A gain, the results of the two models are in good agreem ent.

A nother interesting application of the quadratic phase approximation method is the case of cubic nonlinearity,  $g(;t) = g_0(t) = g_0(t)$

This model describes the propagation of light in nonlinear K err media as well as the dynamics of trapless B ose-E instein condensates. In this situation the previous equations are used to study

the possibility of stabilizing unstable solutions of the NLS equation by means of an appropriate tem poralm odulation of the nonlinear term , that is, by choosing a suitable function  $g_0$  (t) thus providing an alternative to more heuristic treatments [51, 52, 53]. More details can be seen in Ref. [54].

7.3. C losure of the equations in other cases. We have just seen that the quadratic phase approxim ation m ethod allow sus to close the m om ent equations in the case of power-type nonlinear term s. Following those ideas we have managed to close the equations in more general cases.

W e start from the evolution equations for the mean moments (5.4), that after performing the quadratic phase approxim ation become

These equations contain a nite-dimensional description of the dynamics of localized solutions of the model and are similar to those found under speci c assumptions for the proleu (x;t) (see e.g. [55, 56, 57]). The main dimension is that the method of moments allows to obtain the equations under minimal assumptions on the phase of the solutions and that depend on general integral quantities related to the initial data  $Q_1; Q_+; Q_-$ . This is an essential advantage over the averaged Lagrangian methods used in the literature for which the speci c shape of the solution must be chosen a priori (see also [20, 45]).

## 8. Approxim ate m ethods (II): Thom as Ferm i Lim it.

8.1. C on cept. In the fram ework of the application of the NLS equations to B ose E instein condensation problem s (thus for nonlinearities of the form g() =  $g_0$ ), the T hom as Ferm ilim it corresponds to the case  $g_0$  1 (note that this is only one of the m any di erent m eanings of T hom as Ferm i" lim it in physics).

U sually, what is pursued in this context is to characterize the ground state, de ned as the stationary solution of the NLS equation given by Eq. (4.5) with xed L<sup>2</sup> norm having minimal energy E. It is also interesting to nd the dynamics of the solutions under sm all perturbations of the ground state solution.

8.2. P hysical treatment. Let us consider the problem of characterizing the ground state of (4.1). The usual \physical" way of dealing with this problem consists of assuming that if the nonlinear term is very large then it would be possible to neglect the Laplacian term in (4.1) (!) and to obtain the ground state solution as

The value of is obtained from the condition of norm alization  $k'_{TF} k_2 = 1$ . This procedure provides a solution without nodes which is then argued to be an approximation to the ground state.

This method is used in m any applied works, but unfortunately it is not even self-consistent. Near the zero of the radicand of (8.1) the approximation obtained has divergent derivatives, which contradicts the initial hypothesis of \sm allness" of the Laplacian term. A lthough several num erical results can be obtained using this approximation, its foundation is very weak.

In order to understand the problem better, we rewrite (4.1) making the change of variables  $= =g_0, = x = \frac{p}{g_0}, () = x = \frac{p}{g_0}, () = x = \frac{p}{g_0}, () = y = \frac{p}{g_0}, () = \frac{p}{g_0},$ 

with  $= 1=g_0$ . It is evident that <sup>2</sup> is a singular perturbation whose e ect may not be trivial.

8.3. The m ethod of m om ents and the Thom as Ferm i lim it. W hat can be said for the case of power-type nonlinearities in the lim it g 1 on the basis of the m ethod of m om ents? Before m aking any approximations we write an evolution equation for I as follows. For the sake of sim plicity, though it is not strictly necessary, we will consider the case of j = 1; :::;n and study the equations for the mean values (5.2).

First, we write Eqs. (5.3a) and (5.3b)

The fact that the energy functional E reaches a m in inum over  $'_0$  in plies, by Lyapunov stability, that initial data  $u_0(x) = '_0(x) + "(x)$  close to the ground statem ust rem ain proximal for su ciently small values of ".

The only approximation needed to complete our analysis is to assume that when g = 1 then J = K for the ground state. Notice that this is a much more reasonable assumption than the direct elimination of the second derivative in the evolution equation. Thus, the energy conservation and the previous considerations allow us to a rm that J(t) = K (t) for all times.

A lthough these facts can be used to write explicit bounds for K, as a rst approximation and just in order to show the power of these ideas we can simply take K ' 0. Under this approximation we have

The equilibrium point of Eq. (8.4) (corresponding to A = B = 0) gives us the \size" of the ground state as a function of the physical parameters. A loo the frequency of the oscillations around the equilibrium point is immediately obtained from Eq. (8.6)

We have perform ed num erical simulations of the partial di erential equations (4.1) to verify this prediction. Specifically, taking g = 5000;20000, = 1 and initial data of the form  $u_0(x) = \prime_0((1 + ")x) = 1 + "$  for " = 0.01 and " = 0.02, we nd a num erical frequency of num = 2.26 which is in excellent agreement with the value provided by our Thom as Ferm i form ula  $_{TF} = 188 = 2.24$ .

9. Sum m ary and C onclusions. In this paper we have developed the m ethod of m om ents for N onlinear Schodinger equations. First we have found the general expressions of the m ethod and classi ed the nonlinearities for which it allows a closed explicit solution of the evolution of the m om ents. W e have also discussed several applications of the m ethod such as the dynam ics of K err beam s in nonlinear strati ed m edia and the dynam ics of param etrically forced B ose E instein condensates.

Approximate techniques based on the method of moments are also discussed in this paper. In particular, the quadratic phase approximation is also developed here and applied to dierent problems, such as the writing of simple equations describing the stabilization of solitonic structures by control of the nonlinear terms and the dynamics of localized structures in cubic-quintic media. Finally, we have also studied the moment equations in the so-called Thom as-Ferm i limit.
