#### Abstract

The $m$ ethod of $m$ om ents in the context of $N$ onlinear Schrodinger Equations relies on de $n$ ing a set of integral quantities, which characterize the solution of this partial di erential equation and whose evolution can be obtained from a set of ordinary di erential equations. In this paper we nd all cases in which the $m$ ethod of $m$ om ents leads to closed evolution equations, thus extending and unifying previous works in the eld of applications. For som e cases in which the $m$ ethod fails to provide rigorous inform ation we also develop approxim ate $m$ ethods based on it, which allow to get som e approxim ate inform ation on the dynam ics of the solutions of the N on linear Schrodinger equation. $K$ ey words. 1. Introduction. N onlinear Schrodinger ( $\mathrm{N} L S$ ) equations appear in a great array of contexts [1] as for exam ple in sem iconductor electronics [2, 3], optics in nonlinear m edia [4], photonics [5], plasm as [6], fundam entation of quantum mechanics [7], dynam ics of accelerators [8], m ean- eld theory of B ose E instein condensates [9] or in biom olecule dynam ics [10]. In som e of these elds and $m$ any others, the $N L S$ equation appears as an asym ptotic lim it for a slow ly varying dispersive w ave envelope propagating in a nonlinear m edium [11].
$T$ he study of these equations has served as the catalyzer of the developm ent of new ideas or even $m$ athem atical conœpts such as solitons [12] or singularities in ED P s [13, [14].

O ne of the $m$ ost general ways to express a nonlinear Schrodinger equation, is

$T$ he fam ily ofnonlinear Schrodinger equations (1.1) contains $m$ any particular cases, depending on the speci c choiges of the nonlinear term $s g(j \mu ; t)$, the potentials $V(x ; t)$, the dissipation ( t ) and the dim ension of the space $n$. The best known cases are those of pow er-type $g(j u f)=j \mu \rho$ or polinom ialg $(j \mu)=1 j \mu \rho^{p}+2 j j^{\rho} \rho^{2}$ nonlinearities.
$T$ he potentialterm $V(x ; t) m$ odels the action ofan extemal force acting upon the system and $m$ ay have $m$ any form $s$. Finally, we include in Eq. (1.1) a sim ple loss term arising in di erent applications [15, 16]. In $m$ any cases these losses are negligible, i. e. $=0$.

[^0]The description of the dynam ics of initialdata ruled by this equation is of great interest for applications. $N$ evertheless, gathering inform ation about the solutions of a partial di erential equation that is nonlinear like (1.1) constitutes a problem that is a priori nearly unapproachable. For this reason, $m$ ost studies about the dynam ics of this type of equation are exclusively num erical. The rigorous studies carried out to date concentrate on (i) properties of stationary solutions [17], (ii) particular results on the existence of solutions [18, 19], and (iii) asym ptotic properties [13, 14].

Only when $n=1 ; g(j u f ; t)=j u f ; V(x ; t)=0 ; \quad=0$ it is possible to arrive at a solution of the in itial value problem by using the inverse scattering transform $m$ ethod [12]. In this paper we develop the so-called $m$ ethod of $m$ om ents, which tries to provide qualitative inform ation about the behavior of the solutions of nonlinear Schrodinger equations. Instead of tack ling the C auchy problem (1.1) directly, the $m$ ethod studies the evolution of several integral quantities (the so-called $m$ om ents) of the solution $u(x ; t)$. In som e cases the $m$ ethod allow $s$ to reduce the problem to the study of system s of coupled ordinary nonlinear di erential equations. In other cases the $m$ ethod provides a foundation for $m$ aking approxim ations in a $m$ ore system atic (and sim pler) way than other procedures used in physics, such as those involving nite-dim ensional reductions of the original problem : nam ely the averaged Lagrangian, collective coordinates or variationalm ethods [20, 21]. In any case the $m$ ethod of $m$ om ents provides an inform ation which is very useful for the applied scientist, who is usually interested in obtaining as much inform ation as possible characterizing the dynam ics of the solutions of the problem.

It seem $s$ that the rst application of the $m$ ethod ofm om ents $w$ as perform ed by Talanov [22] in order to nd a form al condition of su ciency for the blow up of solutions of the nonlinear Schrodinger equation with $g(j u f)=j u \xi$ and $n=2$. Since then, the $m$ ethod has.been applied to di erent particular cases ( $m$ ainly solutions of radial sym $m$ etry in tw o spatial dim ensions), especially in the context of optics $w$ here $m$ any equations of $N L S$ type arise [23].

In previous researchs, the $m$ ethod of $m$ om ents has been studied in a range of speci c situations but in all the cases the success of the $m$ ethod is unrelated to a m ore general study. In this paper we try to consider the $m$ ethod system atically and solve a num ber of open questions: (i) to nd the $m$ ost general type of nonlinear term and potentials in Eq. (1.1) for which the $m$ ethod of $m$ om ents allow $s$ to get conclusions and (ii) to develop approxim ate $m$ ethods based on it for situations in which the $m$ om ent equations do not allow to obtain exact results.
2. P relim inary considerations. Let us de ne the functional space $Q(H)$ as the space of functions for which the so called energy functional

is nite, $G$ being a function such that $@ G\left(j u j^{2} ; t\right)=@ j u^{\rho}=g\left(j u^{\rho} ; t\right),\left(i^{2} k^{n}\right)$ denoting the usual scalar product in $L^{2}\left(R^{n}\right)$ and $H=\frac{1}{2}+V(x ; t)$. For the case $V(x ; t)=0$ and $g$ independent of tim e, several results on existence and unicity were given by G inibre and Velo [18].

A s regards the case $V \in 0$, which is the one we are $m$ ainly interested in our work, the best docum ented case in the literature is that of potentials with $D V j b o u n d e d$ in $R^{n}$ for every j j 2; that is, potentials w ith atm ost quadratic grow th. Y. O h R4 proved the localexistence of solutions in $L^{2}\left(R^{n}\right)$ and in $Q(H)$ for nonlinearities of the type $g(u)=\quad j u g ; 0 \quad p<4=n$. H ow ever the procedure used allows to substitute this nonlinearity with other m ore general ones. It seem salso posible to extend the results to the case in which the potential depends on $t$.
$T$ herefore, from now on we shall suppose that the nonlinear term satis es the conditions set by $G$ inibre and $V$ elo and that $D V$ jisbounded in space for all $j j 2$. Under these conditions

It is posible to guarantee at least local existence of solutions of Eq. (1.1) in appropriate functional spaces.
2.1. Form al elim ination of the loss term. In the rst place we carry out the transform ation (15]

which is well de ned for any bounded function (t) (this includes all known realistic cases arising in the applications). The equation satis ed by $\hat{u}(x ; t)$ is obtained from the follow ing direct calculation:

From here on we shallconsider, w ith no loss ofgenerality, that ( $t$ ) $=0$ in Eq. (1.1) assum ing that this choice $m$ ight add an extra tim e-dependence to the nonlinear term .
3. The m ethod of $m$ om ents: $G$ eneralities.
3.1. De nition of the $m$ om ents. Let us de ne the follow ing quantities:

with $j=1 ;::: ; n$ and $k=0 ; 1 ; 2 ;::$, which we will call $m$ om ents of $u(x ; t)$ in analogy with the m om ents of a distribution. From now on and also in Eqs. (3.1) it is understood that all integrals and norm s refer to the spatial variables $\times 2 \mathrm{R}^{\mathrm{n}}$ unless otherw ise stated. In Eqs. (3.1) we denote by $u$ the com plex con jugate of $u$.

In som e cases we will make speci c reference to which solution u of Eq. 1.1] is used to calculate the $m$ om ents by $m$ eans of the notation: $I_{k ; j}^{u}$, etc.
$T$ he $m$ om ents are quantities that have to do $w$ ith intuitive properties of the solution $u(x ; t)$. For exam ple, the $m$ om ent $I_{0 ; 0}$ is the squared $L^{2}\left(R^{n}\right)$-norm of the solution and therefore $m$ easures the $m$ agnitude, quantity or $m$ ass thereof. D epending on the particular context of application, this $m$ om ent is denom inated $m$ ass, charge, intensity, energy, num ber of particles, etc. $T$ he $m$ om ents $I_{1 ; j}(t)$ are the coordinates of the center of the distribution $u$, giving us an idea of the overallposition thereof. T he quantities $I_{2 ; j}$ are related $w$ th the $w$ idth of the distribution

$T$ he evolution of the $m$ om ents is determ ined by that of the finction $u(x ; t)$. From now on we w ill assum e that the initial datum $u_{0}(x)$ and the properties of the equation guarantee that the $m$ om ents are well de ned for all tim e.
3.2. First conservation law. It is easy to prove form ally that the $m$ om ent $I_{0 ; 0}$ is invariant during the tem poralevolution by just calculating

where we have perform ed integration by parts and used that the function $u$ and its derivatives vanish at in nity.

Obviously the above dem onstration is form al in the sense that a regularity which we do not know for certain has been used for $u$. Nevertheless, this type of proof can be form alized by $m$ aking a convolution of the function $u$ with a regularizing function. The details of these $m$ ethodologies can be seen in [18] or [24]. In this paper we will lim it ourselves to form al calculations.
4. G eneral results for harm on ic potentials.
4.1. Introduction. From this point onw ard wew ill focus on the particular case of interest for this study when $V(x ; t)$ is a ham onic potential of the type $V(x ; t)=\frac{1}{2}(x ;(t) x)$, where
is a realm atrix of the form $\quad i j(t)={ }_{i}^{2}(t){ }_{i j}$, $w$ ith $i_{i} \quad 0$ for $i=1 ;::: ; n$ and $i j$ is the K ronecker delta. Bearing in $m$ ind the results of Section 2.1, the NLS equation under study is then

This equation appears in a wide variety of applications such as propagation of waves optical transm ission lines w th online m odulators [26, 27, 28, 29], propagation of light beam $s$ in nonlinear $m$ edia $w$ ith a gradient of the refraction index [30, 31], or dynam ics of $B$ ose $E$ instein condensates [9]. G enerically it can provide a m odel for studying som e properties of the solutions of nonlinear Schrodinger equations localized near a minim um of a general potential V (x).
4.2. F irst m om ent equations. If we di erentiate the de nitions of the m om ents $I_{1 ; j}$ and $V_{0 ; j}$, we obtain, after som e calculations, the evolution equations

$w$ ith inital data $I_{1 ; j}(0) ; I_{i ; j}(0)=V_{0 ; j}(0)$. These expressions are a generalization of the E hrenfest theorem of linear quantum $m$ echanics to the nonlinear Schrodinger equation and particularized for the potential that concems us [24, 32].
$T$ his result has been discussed previously in $m$ any papers and is physically very interesting. It indicates that the evolution of the center of the solution is independent of the nonlinear $e$ ects and of the evolution of the rest of the $m$ om ents and depends only on the potential param eters.
4.3. $R$ eduction of the generalproblem to the case $I_{1 ; j}=V_{0 ; j}=0 . W$ e shallbegin by stating the follow ing lem m a [33]:

P roof. A llwe have to do is substitute 4.4a, 4.4b) and 4.4d in 4.1] .
O ne notew orthy conclusion is that given a solution of Eq. (4.1) we can translate it in itially by a constant vector and obtain another solution. In the case of stationary states, de ned as solutions of the form

which exist in the autonom ous case (i.e. $d=d t=0$ ) and whose dynam ics are trivial, this result im plies that under displacem ents the only dynam ics acquired are those of the m ovem ent of the center given by Eq. 4.4d. The coincidence of the evolution laws (4.3) and (4.4d) allow s us to state the follow ing theorem which is an im m ediate consequence of the above lem ma.

The important conclusion of this theorem is that it su ces to study solutions $w$ ith $I_{1 ; j}$ and $V_{0 ; j}$ equal to zero, as those that have one of these coe cients di erent from zero can be obtained from previous ones, by $m$ eans of translation and $m$ ultiplication by a linear phase in x . From a practical standpoint, what is m ost im portant is that $I_{1 ; j}$ be null w ithout any loss of generality, as then we can establish a direct link betw een the $w$ idths and the $m$ om ents $I_{2 ; j}$ (see the discussion in the third paragraph of Section 33).
4.4. M om ent E quations. A ssum ing that allof the m om ents can be de ned at any tim e $t$, we can calculate their evolution equations by $m$ eans ofdirect di erentiation. T he results are gathered in the next theorem.

Proof. The dem onstration of the validity of Eqs. (4.6) can be carried out from direct calculations, perform ing integration by parts, and using the decay of $u$ and $r u$ at in nity.

5. Solvable cases of the $m$ ethod of $m$ om ents. In this section we will study several particular situations of practicalrelevance in which them ethod ofm om ents thoroughly provides exact results.
5.1. The linear case $g(; t)=0$. In this case, Eqs . 3.1d and 4.6d tells us that $J(t)=0$, for all $t$, and then the $m$ om ent equations (4.6) becom e

$T$ hat is, in the linear case the equations for the $m$ om ents along each direction $j$ of the physical space $R^{n}$ are uncoupled. This property was know $n$ in the context of optics for $n=2$ and constant j [34]. Here we see that this property holds for any num ber of spatial dim ensions, tim e dependence $(t)$ and even for nonsym $m$ etric initial data.
5.2. C ondition ofclosure of the $m$ om ent equations in the generalcase. Equations (4.6) do not form a closed set and therefore to obtain, in general, their evolution we would need to continue obtaining $m$ om ents of a higher order, which would provide us $w$ ith an in nite hierarchy of di erential equations. $G$ iven the sim ilarity am ong the term $s$ that involve second derivatives of the phase of the solution in Eqs. (4.6), it is natural to w onder whether it would be possible to som ehow close the system and thus obtain inform ation about the solutions.

From this point on, and for the rest of the section, we will lim it ourselves to the case $j(t)=(t) ; j=1 ;::: ; n$, which is the $m$ ost realistic one, and which includes as a particular case the situation $w$ thout extemalpotentials $j=0$. Let us de ne the follow ing quantities

[35, 36, 37] and the case $n=2, w$ th cubic nonlinearity, corresponds probably to the $m$ ost relevant instance of N LS equation, i.e. the cubic one in tw o spatialdim ensions [30, 31]. For $n=3$ the nonlinearity given by Eq. (5.9) appears in the context of the H artree Fock theory of atom s.

Solving (5.12) allow s to calculate $V$ and $E$ by sim ple substitution in (5.10). This equation is sim ilar to that obtained in [30] for solutions of radial symmetry in the case $\mathrm{n}=2$ and $g(u)=j u f$. H ere we nd that it is possible to obtain a m ore generalresult for solutionsw ithout speci c sym $m$ etry requirem ents, and for any com bination ofdim ension and nonlinearity $g(u)=$ $j u f$ satisfying the condition $n p=4$. The case $w$ ith $\operatorname{sgn}(Q)=1$ corresponds to collapsing situations [13, 38]. In what follow s we consider $m$ ostly the case $Q>0$.

Equation (5.12) was studied by E m akov in 1880 [39], although since then it has been rediscovered many tim es (see e.g. [40]). It is a particular case of the so-called E m akov system s [41, 42, 43], for which it is possible to give fairly com plete results. Especially easy, though tedious to dem onstrate is

Equation 5.13b) is often called the principle of nonlinear superposition. Equation 5.13a) is the well known H ill's equation [44] which m odelizes a param etrically forced oscillator, and which has been studied in depth. In the follow ing, we shall study a couple of special situations in view of their physical interest.

It is rem arkable that the complex dynam ics of a fam ily of nonlinear partial di erential equations can be understood in term s of a sim ple equation such as Hills.

Ifwe suppose that the function ${ }^{2}(t)$ depends on a param eter " in the way ${ }^{2}(t)=1+{ }^{\sim}{ }_{n}(t)$, $\sim_{n}(t)$ being a periodic function $w$ ith $m$ axim um value " (not necessarily sm all), there exists a com plete theory that describes the intervals of values of "forw hich the solutions of $q$. (5.13al) are bounded (intervals of stability) and the intervals for which the solutions are unbounded (intervals of instability) [44].

## 6. A pplications.

6.1. D ynam ics of laser beam $s$ in $G R$ IN $m$ edia. W hen a laser beam propagates in a $m$ edium with a gradex refraction index ( $G R \mathbb{N} m$ edium) with an speci c pro le quadratic in the transverse coordinates, the distribution of intensity $u(x ; y ; z)$ in perm anent regim e is ruled by Eq. (4.1) w ith $g()=$ and $n=2$ (in the optical version of the equation $t \$ z$ ), so that we are dealing $w$ th the critical case that we know how to solve. A though in principle it would be possible to design bers w th arbitrary pro les, technically the simplest way is to join bers w ith di erent uniform indexes in each section.

In this case, the m odelization of the phenom enon is given by

$T$ he solutions to the $M$ eissner equation can be bounded (periodical or quasiperiodical) or unbounded (resonant oscillations). In gure 6.1 the two types of solutions are shown for a particular choige of param eters.

As far as the regions of stability in the space of param eters are concemed, they can be obtained by studying the discrim inant ofequation 5.13a), de ned as the trace of the $m$ onodrom $y$ $m$ atrix, that is

If we draw a as a function of $1=T$, the regions of resonance are those $m$ arked in colors in gure 6.3(b). Obviously the im age is repeated due to the periodicity 2 of $D(y)$ and there are only four basic regions of resonance (together with its harm onics) contained in the intervals (roots of $f_{+}$and $f$ ): y $2[0: 84 ; 1: 23][1: 91 ; 2: 3][3: 98 ; 4: 37][5: 05 ; 5: 44]$ (see gure $63(a)$ ).

A nother case of possible interest is that in which one of the bers is not of $\mathcal{R} \mathbb{N}$ type, that is, $\mathrm{b}=0$. Then the discrim inant is given by the $\lim$ it of equation (6.4) when $\mathrm{b}!0$.

Now there is no exact periodicity in the positions of the zeros any more, but at least it is possible to estim ate the location of those of high order. To do this wem ust bear in $m$ ind that for $y$ big enough the dom inating term in both cases is $f(y)^{\prime} \quad y$ sen $y$, so that the zeros $w i l l$ be given by $\mathrm{y}=\mathrm{n}$. It can be seen w ith a perturbative argum ent that the convergence ratio is of the order of $O(1=n)$.W riting $y^{(n)}=n+"^{(n)}$ and substituting it in equations (6.9) it is found that

6.2. D ynam ics of B ose $\Psi$ instein condensates. In the case of $B$ ose $\mp$ instein condensates, there has recently been great interest in the study of the dynam ics of these system $s$ in a param etrically oscillating potential. Recent experim ents (see e. g. [46, 47]) have m otivated a series of qualitative theoretical analyses (the pioneer works on this sub ject can be seen in [48, 49, 50] although there is a great deal of posterior literature).

In the $m$ odels to which we refer, the trap is $m$ odi ed harm onically in tim $e$, that is

T he boundaries of those regions are the so-called characteristic curves that cannot be obtained explicitly but whose existence can be dem onstrated analytically, as in the previous section, by using the discrim inant. In the case of the $M$ athieu equation, it can be proven that the regions of instability begin in frequencies $!=2 ; 1 ; 1=2 ;::: ; 2=n^{2} ;:::$ [44].

As in the previous case, the resonant behavior depends only on the param eters, and not on the initial data. W ith respect to stability, the $M$ assera theorem implies that if (";!) is in a region of stability, then there exists a periodic solution of (5.13a), and by the nonlinear supenposition principle such a solution is stable in the sense of Liapunov.
7. A pproxim ate $m$ ethods (I): Q uadratic phase approxim ation (QPA).
7.1. Introduction and justi cation of the QPA. Up to now, the results we have show $n$ for the evolution of the solution $m$ om ents are exact and in som e sense rigorous. U nfortunatelly, in $m$ any situations of practical interest it is not possible to obtain closed evolution equations for the $m$ om ents. In this section $w e w i l l$ deal $w$ ith an approxim ate $m$ ethod $w$ hich is based on the $m$ ethod ofm om ents.
$T$ he idea ofthis $m$ ethod is to approxim ate the phase of the solution $u$ by a quadratic function of the coordinates, that is

W hy use a quadratic phase? A though there is not a form al justi cation and we do not know of any rigorous error bounds for the $m$ ethod to be presented here, there are several reasons which can heuristically support the use of this ansatz for the phase for situations where there are no essentialshape changes of the solutions during the evolution. F irst of all, when Eq. (4.1) has self-sim ilar solutions, they have exactly a quadratic phase [45]. Secondly, the dynam ics of the phase close to stationary solutions of the classical cubic NLS equation in two spatial dim ensions (critical case) is know $n$ to be approxim ated by quadratic phases 14, 16] F inally, to capture the dynam ics of the phase of solutions close to the stationary ones, which have a constant phase, by $m$ eans of a polynom ial $t$, the term $s$ of low est order are quadratic since the linear term $s$ in the phase $m$ ay be elim inated by using $T$ heorem 42 .

W e would like to rem ark that a frequently used approach in the physical sciences to study the evolution of solutions of Eq. (1.1) is the so called collective coordinate m ethod (also called averaged lagrangian $m$ ethod or variational $m$ ethod) where an speci $c$ ansatz for the solution is proposed depending on a nite num ber $(S)$ of free param eters $u(x ; t)='\left(x ; p_{1}(t) ;:: P_{S}(t)\right)$. $T$ he equations for the evolution of the param eters are then sought from variational argum ents [20, 21]. For N LS equations allcom $m$ only used ansatzs have a quadratic phase. 0 ur system atic $m$ ethod provides a m ore general fram ew ork in which other $m$ ethods can be system atized and understood.

A swe will see in what follow s , the choige (7.1) allow s to obtain explicit evolution equations and solves the problem of calculating the integrals of the phase derivatives in the equations (4.6).

$T$ he quadratic phase $m$ ethod provides reasonably precise results that at least desribe the qualitative behavior of the solutions of the partialdi erentialequation. U sing severalnum erical $m$ ethods, we have carried out di erent tests especially in the $m$ ost realistic case $n p=6$ in (4.1). For exam ple, in gure 7.1 the results of a sim ulation of (4.1) $w$ ith $n=3, p=2$, ${ }^{2}(t)=1+0: 1 \sin (2: 8 t)$ and $g_{0}=10$ are presented for an initial datum $u_{0}(x)=e^{x^{2}=2}={ }^{3=4}$. In this case the sim pli ed equation 7.6) predicts quasi-periodic solutions which is what we obtain when resolving the com plete problem .

In $F$ ig. 72 we show the results for ${ }^{2}(t)=1+0: 1 \sin (2: 1 t)$ for which (7.6) predicts resonant solutions. A gain, the results of the tw o m odels are in good agreem ent.

A nother interesting application of the quadratic phase approxim ation $m$ ethod is the case of cubic nonlinearity, $g(; t)=g_{f}(t)=g_{( }(t) j u f, w$ ithout potential $(t)=0$. In that situation Eq. 7.6) becom es

This $m$ odel describes the propagation of light in nonlinear $K$ err $m$ edia as well as the dynam ics oftrapless B ose $E$ instein condensates. In th is situation the previou sequations are used to study
the possibility of stabilizing unstable solutions of the $N \mathrm{LS}$ equation by $m$ eans of an appropriate tem poralm odulation of the nonlinear term, that is, by choosing a suitable function $g_{0}(t)$ thus providing an altemative to m ore heuristic treatm ents [51, 52, 53]. M ore details can be seen in Ref. [54].
7.3. C losure of the equations in other cases. W e have just seen that the quadratic phase approxim ation $m$ ethod allow s us to close the $m$ om ent equations in the case ofpow er-type nonlinear tem s . Follow ing those ideas w e have $m$ anaged to close the equations in $m$ ore general cases.

These equations contain a nite-dim ensionaldescription of the dynam ics of localized solutions of the $m$ odel and are sim ilar to those found under speci c assum ptions for the pro le $u(x ; t)$ (see e.g. [55, 56, [57]). Them ain di erence is that the $m$ ethod ofm om ents allow $s$ to obtain the equations underm inim alassum ptions on the phase of the solutions and that depend on general integral quantities related to the initial data $Q_{1} ; Q+; Q . T$ his is an essential advantage over the averaged Lagrangian $m$ ethods used in the literature for which the speci c shape of the solution $m$ ust be chosen a priori (see also [20, 45]) .
8. A pproxim ate $m$ ethods (II): Thom asFerm iLim it.
8.1. C on cept. In the fram ew ork of the application of the $N L S$ equations to $B$ ose $E$ instein condensation problem $s$ (thus for nonlinearities of the form $g()=g_{0}$ ), the Thom asFerm ilim it corresponds to the case $g_{0} \quad 1$ (note that this is only one of the $m$ any di erent $m$ eanings of \Thom asFerm i" lim it in physics).

U sually, what is pursued in this context is to characterize the ground state, de ned as the stationary solution of the NLS equation given by Eq. 4.5) with xed $\mathrm{L}^{2}$ norm having minim al energy $E$. It is also interesting to nd the dynam ics of the solutions under sm all perturbations of the ground state solution.
8.2. P hysical treatm ent. Let us consider the problem of characterizing the ground state of (4.1). The usual \physical" w ay of dealing $w$ ith this problem consists of assum ing that if the nonlinear term is very large then it would be possible to neglect the Laplacian term in (4.1) (!) and to obtain the ground state solution as

This $m$ ethod is used in $m$ any applied works, but unfortunately it is not even self-consistent. $N$ ear the zero of the radicand of (8.1) the approxim ation obtained has divergent derivatives, which contradicts the in itialhypothesis of \sm allness" of the Laplacian term. A though several num erical results can be obtained using this approxim ation, its foundation is very weak.

Before $m$ aking any approxim ations we write an evolution equation for $I$ as follow $s$. For the sake of simplicity, though it is not strictly necessary, we will consider the case of $j=$ for $j=1 ;::: ; n$ and study the equations for the $m$ ean values (52).

N otice that this is a much m ore reasonable assum ption than the direct elim ination of the second derivative in the evolution equation. Thus, the energy conservation and the previous considerations allow us to a $m$ that $J(t) \quad K(t)$ for all tim es.

A though these facts can be used to write explicit bounds for $K$, as a rst approxim ation and just in order to show the power of these ideas we can simply take $K \quad 0$. Under this approxim ation we have

9. Sum $m$ ary and C onclusions. In this paper we have developed the $m$ ethod of $m o-$ $m$ ents for $N$ onlinear Schodinger equations. $F$ irst we have found the general expressions of the $m$ ethod and classi ed the nonlinearities for which it allow s a closed explicit solution of the evolution of the $m$ om ents. $W$ e have also discussed several applications of the $m$ ethod such as the dynam ics of $K$ err beam $s$ in nonlinear strati ed $m$ edia and the dynam ics of param etrically forced B ose $E$ instein condensates.

A pproxim ate techniques based on the $m$ ethod of $m$ om ents are also discussed in this paper. In particular, the quadratic phase approxim ation is also developed here and applied to di erent problem $s$, such as the w riting of sim ple equations describing the stabilization of solitonic structures by control of the nonlinear term $s$ and the dynam ics of localized structures in cubic-quintic $m$ edia. Finally, we have also studied the $m$ om ent equations in the so-called Thom asFerm ilim it.
