Quark-m eson coupling m odel with short-range quark-quark interactions

Short-range quark-quark correlations are introduced into the quark-m eson coupling (QMC) model phenom enologically. We study the e ect of the correlations on the structure of the nucleon in dense nuclear matter. W ith the addition of correlations, the saturation curve for sym metric nuclear matter is much improved at high density.

M one than a decade ago, Guichon¹⁾ proposed a relativistic quark model for nuclear matter, where it consists of non-overlapping nucleon bags bound by the self-consistent exchange of scalar () and vector (!) m esons in m ean-eld approximation (M FA). This model has been developed as the quark-m eson coupling (QMC) model, and successfully applied to various phenom ena in nuclear physics.²⁾ Recently, the model has been further extended using relativistic constituent quark models.³⁾

So far, the use of the QMC model has been limited to the region of small to moderate densities because it has been assumed that the nucleon bags do not overlap. It is therefore of great interest to explore ways to extend the model to include short-range quark-quark interactions, which may occur when nucleon bags overlap at high density. In this report we will introduce these short-range correlations in a very simple way, and calculate their e ect on the quark structure of the nucleon in medium . We refer to thism odel as the quark-meson coupling model with short-range correlations (QMCs).

Let us consider uniform ly distributed (iso-symmetric) nuclear matter with nuclear density $_{\rm B}$. At nite density the nucleon bags start to overlap with each other, and a quark in one nucleon may interact with quarks in other nucleons in the overlapping region. Since the interaction between the quarks is short range, it may be reasonable to treat it in terms of contact interactions. An additional interaction term of the form, $L_{\rm int}$ $_{\rm ifj}^{\rm q}$ (i) $_{\rm q}$ (j) $_{\rm q}$ (j), is then added to the original QMC lagrangian density.²⁾ Here $_{\rm q}$ (i) is a quark eld in the i-th nucleon and stands for a combination of matrices (with or without the isospin and color

generators). In this report we shall consider only u and d quarks and simulate the short-range interaction using scalar- and vector-type couplings in MFA: = 1 and 0.

Next we consider the probability for the nucleon bags to overlap, using a simple geometrical approach.⁴⁾ To measure the overlap of nucleons we treat them as the

M IT bag with the radius R. For any two nucleons the overlapping volum e (m easured in units of the nucleon volum e V_N (= 4 R³=3)) is $V_{ov}(y) = 1$ $3y=4 + y^3=16$ (for y 2),⁵⁾ and V_{ov} vanishes beyond y = 2, where y = s=R with s a distance between the two centers of the nucleon bags.

In a nucleus with A nucleons, any given nucleon m ay overlap with (A 1) others. If the nucleons are distributed according to some two-particle density function $_2(r_1;r_2)$, then the overlapping volume per nucleon (in units of V_N) is

where the function $_2$ may be given as the product of single-particle densities $_1$ (r_1) (norm alized to unity), $_1$ (r_2) and the two-nucleon correlation function F ($\dot{r}_1 \quad r_2$). In the lim it A ! 1, we then nd the overlapping volume as $V_1 = (_B V_N)$ (1) in the uniform matter, where

with H (s) = 1 F (s). Here describes the e ect of two-nucleon correlation in the overlapping part. If there were no correlation between two nucleons (namely, F (s) = 1 or = 0) V_1 were 0.32 (when R = 0.8 fm and $_0 = 0.15$ fm 3 , the saturation density of nuclear matter).

For nucleons separated less than 1 fm, som e m odi cation of the two-nucleon density is expected and this is described by the correlation function F (s). In principle, one could calculate the correlation function within QMC self-consistently, as in the relativistic B nuckner-B ethe-G oldstone form alism etc.⁶⁾ It is, how ever, not easy. In this exploratory study we shall use a phenom enological form of the correlation function.

We use a convenient form of the correlation function proposed by M iller and Spencer $^{7)}$ { so-called the M iller-Spencer correlation function.We then nd

where g_p describes the Pauli (exchange) correlations and is given by $g_p(y) = (3=y)j_1(y)$, where $y = sk_F$ with the Ferm im one ntum k_F . The function f (s) describes the strong repulsion in the core part and is parametrized as $f(s) = (1 \quad s^2) \exp(s^2)$, where and are parameters.⁷

The Bethe-G oldstone theory places a restriction on the overall size of f (s). The nuclear matter density times integral of the square of f (s) is known as the <code>\wound"</code> integral, : $_{\rm Z}$

This quantity, which is the convergence parameter of the hole-line expansion, has a typical value of 0.12 around $_{\rm B} = _0.^{8}$ A next condition on f (s) is obtained by the consistency requirement⁷⁾

to ensure the normalization on $_2$. Another quantity of interest is the correlation length $_c^{\prime}$ de ned by $^{7)}$

We shall use the conditions (5) and (6) to determ ine the parameters and and check the value of $\$ integral numerically at the same time.

Now it is natural to choose the probability of overlap to be proportional to V_1 . (We here ignore higher-con gurations like 3-body correlation etc.) In MFA the D irac equation for a quark eld in a nucleon bag is then given by

where m_q is the bare quark mass, and ! are the mean-eld values of the and ! mesons and g^q and g^q are, respectively, the -and !-quark coupling constants in the usualQMC model.²⁾ The new coupling constants $f_{s(v)}^{q}$ have been introduced for the scalar (vector)-type short-range correlations, and are given by $f_{s(v)}^{q} = (f_{s(v)}^{q} = M^{2})V_{1}$ (M = 939 MeV, the free nucleon mass). Note that since the coupling constants have dimension of (energy)² we introduce dimensionless coupling constants $f_{s(v)}^{q}$. In Eq.(7), h $_{q}$ qi and h $_{q}^{y}$ qi are, respectively, the average values of the quark scalar density and quark density with respect to the nucleon in local density approximation.^{2);9)}

Now we can solve the D irac equation Eq.(7), as in the usualQMC, with the elective quark mass

instead of the bare quark mass. The Lorentz vector interaction shifts the nucleon energy in the medium $^{2)}\,$

where M[?] is the e ective nucleon m ass, which is given by the usual bag energy.²⁾ The total energy per nucleon at density _B is then expressed as

where m and m_! are respectively the and ! meson masses. The ! eld created by the uniform ly distributed nucleons is determined by baryon number conservation: $! = 3g_{!}^{q} = m_{!}^{2} = g_{!} = m_{!}^{2}$ (where $g_{!} = 3g_{!}^{q}$), while the eld is given by the therm odynamic condition: ($@E_{tot}=@) = 0$. This gives the self-consistency condition (SCC) for the eld²)




Fig.1. as a function of $_{\rm B}$. The solid (dotted) curve is for $`_{\rm c}$ = 0.75 (0.7) fm .




Fig.2. Energy per nucleon for symmetric nuclear matter. The dashed curve gives the result of the originalQMC.²⁾ The solid and dot-dashed curves are for c = 0.75 and 0.7 fm in QMCs, respectively. The region enclosed with the dotted curves is the empirical one.¹⁰⁾

actual calculations, the quark density h $_{q}^{y}$ qi in the total energy may be replaced by 3 $_{B}$, and the quark scalar density, contributing to the elective quark mass, is approximately given as h $_{q}$ qi = (m²=g) because of the SCC .^{2);9)}

Now we are in a position to show our main results. We choose $m_q = 5 \text{ MeV}$ and the bag radius of the nucleon in free space R_0 to be 0.8 fm. The bag constant B and usual parameter z, which accounts for the center of mass correction and gluon uctuations, in the bag model are determined to t the free nucleon mass with $R_0 = 0.8 \text{ fm}$ { we nd B $^{1=4} = 170.0 \text{ MeV}$ and $z = 3.295.^{2}$ The coupling constants g and g are determined so as to reproduce the average binding energy of symmetric nuclear matter (15:7 MeV) at the saturation density $_0$.

In Fig. 1, we show in Eq.(2). As an example, we set $f_s^q = 40$; $f_v^q = 8$ to t the (observed) energy per nucleon at high $_B$ (see Fig. 2). If we x $c_c = 0.75$ (0.7) fm, the conditions (5) and (6) give = 1.05 (1.20) fm 2 , = 0.617 (0.708) fm 2 and = 0.12 (0.10) at $_0$. We then nd that $g^2 = 50.09$ (48.11), $g_1^2 = 37.22$ (33.80) and K = 360 (370) MeV. As shown in Fig. 1, gradually decreases and it becomes alm ost constant at high density.

In Fig. 2, we present the saturation curve for symmetric nuclear matter. We can see that QMCs can provide the energy per nucleon, which lies in the empirical region (enclosed with the dotted curves).¹⁰⁾ It may imply the importance of the




Fig.3. Scalar mean-eld values in nuclear medium. The curves are labeled as in Fig.2.




Fig. 4. Ratio of the in-medium rm s radius of the nucleon r_q^2 (calculated using the quark wave function) to that in free space ($r_q =$ 0.5824 fm). The curves are labeled as in Fig. 2.

short-range correlations at high density. If we choose a large value of f_v^q the energy becomes larger at high $_B$ and it also makes the elective nucleon mass large. In QMCs we nd M²=M 0.84 at $_0$. We also show the scalar mean-eld values at nite density in Fig. 3. In the original QMC the strength of the scalar eld goes up to about 500 MeV at $_B$ 4 $_0$, while in QMCs it is much reduced at high $_B$ because of the short-range (repulsive) interaction.

Turning next to the size of the nucleon itself, as measured by the root-meansquare (ms) radius of the quark wave function, we see in Fig. 4 that the short-range correlations give a little enhancement. This e ect is, however, not strong within the present parameter set, and the increase of the size around $_0$ lies in the upper-lim it value analysed by the electron scattering experiment.¹¹⁾

W e sum m arize the role of scalar- and vector-type short-range correlations. The scalar-type correlation m odi es the e ective quark m ass in a nuclear m edium as (see Eq.(8))

In Eq.(12) the mean-eld part (g term) provides a density dependence on the quark mass of order of O ($_{\rm B}$) at low density, while the correlation part gives higher order contributions. This leads to the reduction of the scalar mean-eld value in matter, which may a ect the in-medium nucleon properties.^{2);12)}

The vector-type correlation as well as the ! m eson shifts the total energy. The

! and the correlation contribute to the energy as (see Eq.(9))

Since V_1 depends on the density the correlation again gives the contribution of higher order in $_B$. It thus enhances the energy at high density. If we introduce the e ect of higher-con gurations like 3-body, 4-body etc., such correlations m ay have dependences of higher power of $_B$ and play an important role not only at high density but also near the region of the phase transition to quark-gluon plasm a. Those terms m ay correspond to higher order terms appearing in the chiral elective lagrangian for nuclear matter.¹³

In conclusion, we have studied the e ect of short-range quark-quark correlations associated with nucleon overlap in MFA.W e have found that a repulsive vector-type correlation m akes the saturation curve close to the empirical one at high density. Furtherm ore, we have shown that the scalar- and vector-type correlations considerably m odify the properties of nuclear m atter at high density. W hile our inclusion of the correlations has been based on a quite simple, geom etrical consideration, in the future we would hope to formulate the problem in a more sophisticated, dynam ical way.⁶
