GENERALIZED POLARIZABILITIES IN A CONSTITUENT QUARK MODEL

W e discuss low -energy virtualC om pton scattering o the proton within the fram ework of a nonrelativistic constituent quark model. A simple interpretation of the spin-averaged generalized polarizabilities is given in terms of the induced electric polarization (and magnetization). Explicit predictions for the generalized polarizabilities obtained from a multipole expansion are presented for the Isgur-Karl m odel and are com pared with results of various m odels.

Introduction 1

In recent years, low-energy virtual C om pton scattering (VCS) o the proton as tested in, e.g., the reaction e p! e p , has attracted considerable interest from both the experimental and theoretical side. In fact, real C om pton scattering (RCS) has a long history of providing in portant theoretical and experim ental tests for models of hadron structure. For example, the fam ous low -energy theorem (LET) of Low and Gell-M ann and Goldberger³ predicts the scattering amplitude for a spin $\frac{1}{2}$ system in terms of the charge, mass, and magnetic moment to the st two orders in the photon energy. In principle, any model respecting the symmetries entering the derivation of the LET should reproduce the constraints of the LET. It is only term s of second order which contain new information on the structure of the nucleon specic to C om pton scattering. For a general target, these e ects can be param etrized in term s of two constants, the electric and m agnetic polarizabilities and , respectively⁴. A generalized low energy theorem (GLET) including virtual photons was given in Refs. 5;6. The use of virtual photons considerably increases the possibilities to investigate the structure of the target, because on the one hand the energy and three m om entum of the virtual photon can be varied independently, and on the other hand also longitudinal com ponents of current operators becom e accessible. In R ef.⁵, the m odel-dependent response beyond the GLET was analyzed by means of a multipole expansion. Only terms contributing to rst order in the energy of the outgoing real photon were kept, and the result was expressed in terms of ten generalized polariz-

abilities (GPs) which are functions of the three-m om entum of the initial-state virtual photon. If charge conjugation and particle crossing are symmetries of the underlying m odel, only six of the ten GPs are independent⁷. A som e-what di erent generalization in term s of generalized dipole polarizabilities was obtained in R ef.⁸, where a covariant starting point was chosen.

2 Compton Tensor and Low - Energy Theorem

In a covariant fram ework, the nucleon C om pton tensor is de ned as

where T refers to the covariant time-ordered product. As a special case, the RCS amplitude $(q^2 = q^{f2} = 0)$ is obtained by contracting Eq. (1) with the polarization vectors and ⁰ of the initial and nalphotons, respectively,^a

where = eu $u=q^2$ is the polarization vector of the virtual photon, and where we made use of current conservation. In the center-ofmass (cm.) frame, using the Coulomb gauge for the nal (real) photon, the transverse and longitudinal parts of M_{VCS} can be expressed in terms of eight and four independent structures, respectively,

where the functions A_i depend on the three kinem atical variables $j q j j q^0 j$ and $z = q q^0$.

M odel-independent predictions for the functions A_i , based on Lorentz invariance, gauge invariance, crossing sym m etry, and the discrete sym m etries were obtained in Ref.⁶. For example, the result for A_1 up to second order in the m om enta j_1 jand j_2^0 jreads

To this order, all functions $A_{\rm i}$ are completely specied in terms of quantities which can be obtained from elastic electron-proton scattering and RCS, namely M , ,G_E,G_M , r_E^2 , ,and .

3 Generalized Polarizabilities and Their Interpretation

A system atic analysis of the structure-dependent term s speci c to VCS o the nucleon was performed by G uichon et al.⁵. The nonpole term swere expressed in term s of three spin-independent and seven spin-dependent GPs which were introduced in the fram ework of a multipole analysis, restricted to rst order in $\frac{1}{2}$ but for arbitrary $\frac{1}{2}$ j.

For a spin-0 system such as the pion or for the spin-averaged nucleon amplitude the GPs can, to a certain extent, be interpreted in terms of simple classical concepts⁸. To that end, let us consider a spherical charge distribution which is exposed to a uniform static electric eld. The connection between the electric eld and the induced electric polarization is, to rst order, given by the polarizability tensor $_{ij}(r)$ (see Fig. 1),

Inserting Eq. (10) into Eq. (9), perform ing a partial integration, and nally applying the de nition of Eq. (7) with the speci c form of Eq. (8), one obtains Z

Equation (11) nicely displays the connection between the longitudinal generalized polarizability $_{\rm L}$ (q) and the modi cation in the charge distribution. The general connection between the polarizability tensor $_{\rm ij}$ (r) and the generalized electric polarizabilities $_{\rm L}$ (q) and $_{\rm T}$ (q) of Eq. (8) reads⁸

In particular, both generalized electric polarizabilities are required to fully describe the induced electric polarization. The transverse generalized electric polarizability $_{\rm T}$ (q) is associated with rotational displacements of charges which do not contribute to $(r) = \tilde{r} P(r)$. It is not contained in the approximation of G uichon et al.⁵.

The above classical considerations can easily be extended to nonrelativistic quantum mechanics. For example, for a simple harm onic oscillator model of the type

As q ! 0, $_{\rm L}$ (q) reduces to the ordinary electric polarizability = $e^2 = (4 \text{ m } !_0^2)$ which is commonly interpreted as a measure of the sti ness or rigidity of a system⁹.

4 Compton Tensor in a Nonrelativistic Fram ework

Before presenting the results for the GPs in the framework of Guidhon et $al.^5$, we provide a short outline of the ingredients entering the calculation of the Compton tensor¹⁰. The starting point is the nonrelativistic interaction H am iltonian in the Schrödinger picture,

The C ompton tensor is obtained by calculating the contributions of H $_{\rm I,2}$ and H $_{\rm I,1}$ in rst-order and second-order perturbation theory, respectively,

where r^0 refers to the intrinsic coordinates of particle relative to the center of mass. Note that S_{fi} is symmetric under photon crossing, $q \ \ q^0$ and $\ \$. The explicit form of the direct and crossed channels reads

where every single interm ediate state X gives rise to a contribution which is explicitly symmetric under photon crossing. This will be of some importance in checking the predictions for the GPs. For further evaluation, the current operator is divided into intrinsic and cm.contributions^{11;12}

5 Generalized Polarizabilities in a Constituent Quark M odel

Neither S_{fi} nor T_{fi} of Eqs. (23) and (24), respectively, is separately gauge invariant. Thus, before calculating the GPs we divide M_{fi} into two separately gauge-invariant contributions. The rst consists of the ground-state propagation in the direct and crossed channels together with an appropriately chosen term to satisfy gauge invariance. The residual part contains the relevant structure inform ation from which one obtains the GPs.

For the calculation of the GPs we make use of two di erent expansion schemes. The rst consists of a conventional nonrelativistic 1=M expansion. The advantage of this approach is that, at leading order in 1=M, the result does not depend on the average nucleon momentum $p = (p_i + p_f)=2$. In the cm. frame $p = (q + q^0)=2$ such that naive photon crossing | in plying the replacement of any $q = q^0$ would turn p into p. How ever, at leading order in 1=M, at that order, leads to constraints for the GPs as jq = 0 (see Ref.¹⁰ for details).

Here we present the results of a second scheme used by Liu et al. in Ref.¹³. There, the crossed-channel contribution is divided into a leading plus a recoilpart which is de ned via matrix elements depending on both q and q⁰. Furtherm ore, in order to incorporate, to some extent, e ects due to relativity, relativistic expressions for the energies of the intermediate states were used. Since particle crossing is not a symmetry of the nonrelativistic constituent quark model (NRCQM), the results do not satisfy the relations among the ten GPs which were found in Refs.⁷.

The calculation is performed in the framework of the model of Isgur and K arl 14 , where the (1232) resonance and low-lying negative-parity baryons

 D_{13} (1520), S_{11} (1535), S_{31} (1620), S_{11} (1650), S_{13} (1700), D_{33} (1700) have been included. In this model gauge invariance is violated inst because of a mism atch between the resonance masses of the intermediate states and the corresponding wave functions and second because of a truncation of the model space. On the other hand, photon crossing symmetry is respected, because for each diagram the crossed diagram is taken into account.

6 Results

The num erical results for six of the GPs are shown in Fig.2 together with the predictions of the linear sigm a model¹⁵ (dashed lines), heavy-baryon chiral perturbation theory¹⁶ (dashed-dotted lines), an elective Lagrangian model¹⁷ (dotted lines), and dispersion relations¹⁸ (full thin lines). For jgj! 0, the GPs and reduce to the ordinary RCS polarizabilities and . In the Isgur-K arlm odel, these polarizabilities receive their main contributions from the resonances D₁₃ (1520) and (1232), respectively. In case of the spin GPs P^{(01;01)1} and P^{(11;02)1}, the NRCQM generates much smaller values than the linear model¹⁵ and chiral perturbation theory¹⁶. This is interpreted as a consequence of missing pionic degrees of freedom.

For the generalized electric polarizability

our result is in agreement with Ref.¹³. D iscrepancies in P $^{(01;01)1}$, P $^{(11;11)1}$, and P $^{(01;12)1}$ were found to originate from the contributions of the crossed channel relative to the direct one (for details, see Ref.¹⁰).

The results for those structure functions that can be accessed in an unpolarized experiment, are shown in Table 1. The values of jq j correspond to the RCS limit, M IT-Bates¹⁹ and MAM I¹ kinematics, respectively. Table 2

7 Summary

Low energy virtualC om pton scattering opens the door to a new and rich realm of issues regarding the structure and dynam ics of com posite system s| nam ely, what is the local deform ation of a system exposed to a (soft) external stimulus.

In an expansion in terms of the energy of the nal-state real photon and the three-m om entum of the initial-state virtual photon, the GLET species the accuracy needed to be sensitive to higher-order terms in order to distinguish between di erent models. This structure information beyond the GLET can be param etrized in term s of generalized polarizabilities. To some extent, these quantities have their analogies in classical physics and can be interpreted in term s of the induced electric polarization and magnetization. We discussed the virtual C om pton scattering tensor in the fram ework of nonrelativistic Q M and made use of the model of Isgur and Karl to obtain predictions for the GPs of the proton. The m odel does not provide the relations am ong the GPs due to nucleon crossing in combination with charge conjugation. Clearly, the calculation has its lim itations regarding relativity, gauge invariance and chiral sym m etry, leaving room for in provem ent in any of the above m entioned directions. Despite these shortcom ings, the predictions provide an order-ofm agnitude estim ate for the nucleon resonance contributions and as such are com plem entary to the results of the linear sign a model and chiral perturbation theory that emphasize pionic degrees of freedom and chiral symmetry.
