# Static response of Ferm i liquids w ith tensor interactions

#### Abstract

W e use Landau's theory of a norm al Ferm i liquid to derive expressions for the static response of a system with a general tensor interaction that conserves the total spin and the total angular m om entum of the quasiparticle-quasihole pair. The $m$ agnetic susceptibility is calculated in detail, $w$ th the inclusion of the center of $m$ ass tensor and cross vector term $s$ in addition to the exchange tensor one. We also introduce a new param etrization of the tensor Landau param eters which signi cantly reduces the im portance of high angular ham onic contributions. For nuclear $m$ atter and neutron $m$ atter $w e$ nd that the twom ost im portant e ects of the tensor interaction are to give a contribution from $m$ ultipair states and to renom alize the $m$ agnetic $m$ om ents. R esponse to a weak probe $m$ ay be calculated using sim ilar $m$ ethods, replacing the $m$ agnetic $m$ om ents $w$ ith the $m$ atrix elem ents of the weak charges.


## I. INTRODUCTION

For system s w ith central interactions, Landau's theory of norm alferm i liquids provides an econom icalw ay of characterizing $m$ any low tem perature properties. The theory w as applied to atom ic nucleiby M igdaland collaborators, and in that work it was generally assum ed that the non-central contributions to the e ective nucleonnucleon interaction were sm all [ill 1 ]. T he generalization of Landau theory to include e ects of the tensor force
 quently, estim ates of tensor contributions to the e ective


The stim ulus for the present work arose in the context of astrophysics. In the physics of collapse and the subsequent evolution of a neutron star, the properties of neutrinos in dense $m$ atter are a key ingredient [ $\left.{ }_{2}\right]$. A $s$
 neutrino scattering and absonption rates are sensitive to nucleon-nucleon interactions, especially their spindependent parts. D irect calculation of e ective interactions is di cult, but for system $s$ w ith only central interactions, inform ation about the e ective interaction at long w avelengthsm ay be obtained directly from a know $l$ edge of static properties of the $m$ atter. For exam ple, the spin susceptibility of a single-com ponent Ferm i liquid w ith two spin states is given by

$w$ here 0 is the $m$ agnetic $m$ om of a particle in free space, $N(0)=m \quad p_{F}={ }^{2} h^{3}$ is the density of states per unit volum e at the Ferm i surface, $m$ is the quasiparticle e ective mass, $\mathrm{p}_{\mathrm{F}}$ is the Ferm imom entum and $\mathrm{G}_{0}$ is the Landau param eter describing the isotropic part
of the spin dependent contribution to the quasiparticle interaction. Since calculations of the $m$ agnetic susceptibility of neutron $m$ atter exist [18'], it is relevant to ask to what extent it is possible to deduce properties of the e ective interaction from such data. A related question is the extent to which tensor contributions to quasiparticle energies and interactions alter neutrino scattering rates, which w ere previously calculated neglecting tensor e ects in Ref. [1]

A s show $n$ in earlier work $\left[1 \overline{1}_{1}^{\prime}\right]$, the tensor force in $u-$ ences the static response of a system in a num ber of di erent ways. O ne is that the $m$ agnetic $m$ om ent of a quasiparticle is di erent from its value for a particle in vacuum . In particular, the $m$ agnetic $m$ om ent is not a scalar, as it is for system S w th central forces only. A s long ago as 1951, M iyazaw a [20 ${ }_{2}^{\prime}$ I] calculated explicitly how the $m$ agnetic $m$ om ent of a nucleon w ould be $m$ odi ed by the tensor interaction due to one pion exchange and $m$ ore recent discussions $m$ ay be found in e.g. the review [21] and $R$ ef. [2]']. A second e ect is that the quasiparticle interaction contains explicit tensor contributions. Fol-
 these have an exchange-tensor structure sim ilar to that of the one-pion exchange interaction. H ow ever, Schw enk and Frim an $[\bar{i}]$ have pointed out recently that the onepion exchange interaction, when acting in second order, can give rise to contributions to the e ective interaction which have a di erent structure. In their paper they evaluated these induced interaction contributions to the quasiparticle interaction and found that the exchangetensor term in the quasiparticle interaction is much reduced, and that term $s$ of a di erent structure can be of a com parable $m$ agnitude to the exchange-tensor ones. A third e ect of the tensor interaction is that there are m ultipair contributions to the m agnetic susceptibility.

In this paper we begin by deriving a generalexpression for the $m$ agnetic susceptibility in Sec.'III, taking into account tensor contributions to the $m$ agnetic $m$ om ent, and tensor contributions to the e ective interaction which are com pletely general for an interaction which conserves the total angular $m$ om entum and the total spin of the quasiparticle-quasihole pair. This represents a generalization of the earlier calculation of the $m$ agnetic susceptibility by $H$ aensel and Jerzak $\left[2 \overline{3} \overline{3}^{\prime}\right]$, who took into account the e ect of the exchange-tensor contribution to the quasiparticle interaction. A nother issue that we address is how to param etrize tensor contributions to the quasiparticle interaction (Sec. 'iv-I'). The schem e usually em ployed in the past su ens from the disadvantage that it is generally necessary to take into account high angularharm onic contributions to the interaction. W epresent an altemative param etrization forw hich higher harm onic term s play little role. In Sec. N! we evaluate the $m$ atrix elem ents needed for the calculation of the susceptibility and estim ate the $m$ agnitudes of the di erent contributions. In Sec. clearm atter and to responses w ith other spin and isospin properties, for exam ple that to weak interactions. Sec. V- in contains concluding rem arks.

## II. BASIC FORMALISM

The reason for Landau's theory of norm al Ferm i liquids being particularly sim ple for system $s$ w ith interparticle interactions that are central is that the energies of long-w avelength, low-lying states di ering little from the ground state $m$ ay be described solely in term $s$ of the quasiparticle distribution. The im portance of conservation laws in determ ining the low-frequency, longw avelength behaviour ofFerm isystem shas been stressed by Leggett [2]. ${ }^{1}$ ] and a discussion in term $s$ of Landau theory is given in Ref. [25]. Expressed in other term $s$, the only excitations of importance are ones $w$ th a single added quasiparticle and a single quasihole. W hen non-central interactions are present, the energy must include contributions from states $w$ th $m$ ore than one quasiparticle-quasinole pair. To facilitate satisfying the conservation law for particle num ber, it is convenient to w ork w th the therm odynam ic potentialh $\hat{H} \sim \hat{N}$ i which, for brevity, we shall refer to sim ply as the energy. H ere $\hat{H}$ is the H am iltonian operator, $\hat{N}$ the particle num ber operator and ~ the chem ical potential. We write the change $E$ in the energy when the system is excited from its ground state as the sum of a quasiparticle (Landau) contribution, $\mathrm{E}_{\mathrm{L}}$, and a multipair contribution, $\mathrm{E}_{\mathrm{M}}$ :

$T$ he quasiparticle contribution to the energy $m$ ay be expressed as the sum of two tem s , the intrinsic kinetic and $m$ utualinteraction energies of the quasiparticles, and the energy of interaction $w$ th the $m$ agnetic eld:

For sim plicity, let us begin by considering a system of one species of ferm ions $w$ th spin $1 / 2$. The change in the kinetic and interaction energies of the system when the quasiparticle distribution $n_{p}$ changes by an am ount

where $p$ is the quasiparticle energy. N ote that $n_{p}()$ is a $m$ atrix in spin space. The quantity $f_{p p}{ }^{0} 0$ is the Landau quasiparticle interaction, which we w rite in the form

where $f_{p p}$ is the spin-averaged quasiparticle interaction, $g_{p p^{0}}$ is the spin-exchange contribution and $f_{p p}^{T}{ }^{T} \quad \circ$ is the tensor or, $m$ ore generally, the non-central contribution to the interaction. $W$ e shall discuss the form of the tensor
 results of Schw enk and Frim an [1]. To begin, we derive an expression for the $m$ agnetic su sceptibility, for a com letely general interaction that conserves the total spin and the total angular $m$ om entum of the quasiparticle-quasinole pair, and subsequently we shall discuss its speci c form in detail.
$N$ on-central forces can alter the e ective charges of the quasiparticles. W hen calculating the energy of interaction of the quasiparticlesw ith an extemal eld it is therefore im portant to allow for the fact that the e ective couplings (charges) of quasiparticles $m$ ay have com ponents which are not scalars under rotations of the $m$ om entum of the quasiparticle. For de niteness, we consider the case of response to a $m$ agnetic eld. The change in quasiparticle energy due to the application of a $m$ agnetic eld, $H$, is given by

For a quasiparticle interaction containing only exchange-tensor term $s$, the $m$ atrix elem ents hlJ $\mathrm{h}^{\mathrm{A}} \mathrm{j}^{0} \mathrm{Ji}$ have been calculated for the conventional param etrization for the exchange tensor interaction in Ref. [3].

If we take the $m$ agnetic eld to be in the $z$-direction, $H=H_{z}$, we nd that the energy due to the application of this extemal eld is

At rst sight, one $m$ ay be sunprised that there are no term s with $\mathrm{J}=3$. H ow ever, this follow s im m ediately from the observation that the $m$ agnetic $m$ om ent operator ij j transform sas an axial vector under sim ultaneous rotations in $m$ om entum space and spin space, and consequently it contains only com ponents corresponding to totalangular $m$ om entum $J=1$.

By $m$ inim izing the quasiparticle contribution to the energy w ith respect to the coe cients $C{ }_{1 J}^{M}$ we nd that all $C_{1 J}^{M}$ are zero except the follow ing tw O ,

## III. STATIC RESPONSEFUNCTIONS

Them agnetic susceptibility is de ned as the derivative of the $m$ agnetization $w$ ith respect to the $m$ agnetic eld at zero eld,

$W$ e write the magnetization, $M$, as the sum of two tem $s$, one contribution from single quasiparticlequasinole pairs, $M_{L}$, and another contribution from the excitations ofm ultipair states, which we denote by $\mathrm{M}_{\mathrm{M}}$ :

where $m$ is the contribution from transitions to mul tipair states. H ere we have im plicitly $m$ ade the usual choige of phase for the states, in which case the $m$ atrix elem ents of A are real. Ifwe take only the rst term and set $=0$ in Eq. (22그) , th is result reduces to that of $R$ ef. [23]. $Q$ uantitative estim ates of the di erent e ects $w i l l$ be described in Sec. 'V'. after calculation of the relevant $m$ atrix elem ents, but rst we shall discuss the form of the tensor interaction.

## IV. THETENSOR INTERACTION

The explicit form of the tensor interaction including all term sallow ed by invariance under sim ultaneous rotations in coordinate space and spin space is $\left[\bar{L}_{1}\right]$

The functions $h$ and $\pi$ contain the sam e physical infor$m$ ation, but have di erent properties as far as their expansions in term sofLegendre polynom ials are concemed. W ew ill now com pare som easpects of the di erent choioes of param etrization.
$W$ ith the conventional param etrization, $\check{\mathrm{K}}_{\mathrm{pp}}{ }^{0}$, the ex$p l i c i t q^{2}$ factor ensures that the tensor interaction vanishes identically for $q$ ! 0 , provided that $\Pi_{p p} 0$ is nite for $p!p^{0}$. This is in agreem ent $w$ ith the form of the one-pion-exchange contribution which is given by

where $f$ is the pion-nucleon coupling constant, and $f^{2}=(4 \mathrm{hc}) \quad 0: 08$. M ore generally, if the tensor interaction is analytic for sm all $q$, one would expect $h_{p p} 0$ to tend to zero for $p!p^{0}$, since otherw ise the tensor interaction would depend on the way in which $p$ approaches $p^{0}$. Such nonanalytic contributions to the quasiparticle interaction do occur for system $s$ w ith central interactions $[2 d, 2 d]$, and there they are due to exchange of quasiparticle-quasihole pairs and collective $m$ odes with long wavelengths. The work of Schwenk and Frim an [7] indicates that such contributions do not occur in $h_{p p}{ }^{0}$, although they do in $\mathrm{k}_{\mathrm{pp}}$ (see Sec. 'V.'). To ensure that $h_{p p^{0}}!0$ for $p!p^{0}$, the $h_{1} m$ ust satisfy the condition

If the series is truncated after a nite num ber of term $s$, this will inevitably lead to the sum rule being violated. H ow ever, this should not be very im portant as long as long-w avelength processes do not play a dom inant role.

The conventional param etrization su ers from the disadvantage that, when expanding $\check{\mathrm{h}}$ in term s of Legendre polynom ials $\left.\left(22_{1}\right]_{1}\right)$, it is generally necessary to include $m$ any term $s$ in the sum in order to obtain a good representation of the interaction. C onsider, for exam ple, the one pion exchange contribution. U sing the fact that $\cos =1 \quad q^{2}=\left(2 p_{F}^{2}\right)$ one nds

N ote that these were calculated taking the tensor interaction into account only in rst order. $O$ ne sees that as 1 increases from zero, $\mathrm{H}_{1}$ rst increases and then decreases. It is therefore a poor approxim ation to truncate the expansion after the rst few term s . $T$ he reason for this is that typical Ferm i w ave num bers at nuclear densities are of order $1: 5 \mathrm{~F}^{1}$, which is large com pared w th the pion $m$ ass, $m$ hc $0: 7 \mathrm{~F}^{1}$. In the lim it of the zero pion m ass, all the $\check{K}_{1}$ diverge, the leading contribution being $(21+1) f^{2}=\left(3 m^{2}\right)$ ln $\left(2 p_{F}=m\right)$. This is due to the fact that $\kappa \mathrm{K}^{2}$, which leads to a logarithm ic integral for $\overleftarrow{K}_{1}$.

It is not easy to obtain a reliable estim ate ofthe various term $s$ ，since di erent calculations of the tensor Landau param eters give di erent result．To exem plify this for
pure neutrons，we rst use the Landau param eters ob－
 account the tensor interaction only to rst order，and consequently the only tensor term is the exchange ten－ sor．W e nd

W e can now compare this w ith what we get if we use the Landau param eters of $\mathrm{Ref}.\left[\overline{7}_{1}\right]$ ，listed in T able iII． T hese w ere calculated including the tensor interaction to second order．W e nd that the exchange tensor，center of $m$ ass tensor and the cross vector term $s$ are all quite sm all，so the $m$ atrix elem ents are only slightly modi ed from the value one obtains using only the central part of the interaction．In addition to being $s m$ all，the tensor contributions have a di erent sign from the rst order result：

Since the calculation of tensor param eters in Ref．［7］$]$ is only to second order，and the second order e ects alm ost com pletely cancelthe rst order ones，higher ordere ects could be signi cant and should be calculated．

From the two sets of results above we can draw som e conclusions regarding the e ect of the tensor interaction on the susceptibility．T he second term in Eq．（75）is clearly sm all com pared to the rst term，of the order of 1\％，and $m$ ay be neglected．T he third and fourth term s ， could be im portant，depending on the value of the tensor $m$ agnetic $m$ om ent．T he corrections to the bare nucleon $m$ om ent arise from two sources．T he rst is con guration $m$ ixing，which is due to the fact that a quasiparticle in the m edium consists of a bare nucleon and a supenposi－ tion ofm ore com plicated states involving a nucleon plus a num ber of particle－hole pains．T he second source is exchange currents，which are due to the fact that the ex－ temal eld can interact w ith other degrees of freedom than nucleons，for exam ple，interm ediate $m$ esons in a nucleon－nucleon interaction．For de niteness，we shall use the results given by A rim a et al．in $R$ ef．［21］for the Ferm igas model．For neutrons in sym $m$ etric nuclear $m$ atter，they nd $1: 62 \mathrm{~N}$ and T 0：08 N ， where $\mathrm{N}^{2}=$ eh＝2M is the nuclear magneton．C alcula－ tions of the con guration $m$ ixing contribution to weak interaction matrix elem ents $m$ ade by $C$ ow ell and $P$ and－ haripande［32＇］for asym $m$ etric nuclear $m$ atter indicate that the renorm alization of the $m$ agnetic $m$ om ent does not depend strongly on proton fraction，and am ounts to a suppression by about $10 \%$ ．W ew ould thus suspect that renorm alization of the m agnetic m om ent w ould be rela－ tively insensitive to the proton fraction，and would be of a sim ilar order of $m$ agnitude．H ow ever，we stress that it is im portant to $m$ ake $m$ ore detailed estim ates ofm agnetic m om ents in the nuclearm edium ．
$T$ he $s m$ all $m$ agnitude of the tensor $m$ agnetic $m$ om ent $m$ eans that we $m$ ay neglect also the third and fourth term in Eq. (7-5), both being less than one per cent of the rst term. Therefore, we conclude that, the most im portante ects of the tensor force on the susceptibility is $m$ ost likely the renorm alization of the isotropic part of the $m$ agnetic $m$ om ent and to the presence of transitions to $\mathrm{m} u l t$ ipair states.

N o reliable calculation of $m$ exists, but by using the sum rule argum ent presented in $R$ ef. [19] we can put a low er bound on the $m$ ultipair contribution to the susceptibility:

H ere $\mathrm{S}(\mathrm{q})$ is the static structure fiunction, n is the density and ! is the $m$ ean excitation energy. In Ref. [19] we took the values of $S(q)=0: 19$ and $!=63 \mathrm{M} \mathrm{eV}$ from the calculations of $R$ ef. $\left[33_{1}^{1}\right]$ and estim ated the multipair contribution to the susceptibility to be $m$ ore than $60 \%$ of the susceptibility calculated by Fantoniet al [1d] ( $=0: 38 \mathrm{~F}$ ). Here $F$ is the susceptibility of a free Ferm igas of neutrons, $\mathrm{F}=3 \mathrm{n}=2_{\mathrm{F}}$. N New calculations of the static structure function and the $m$ ean excitation energy by $C$ ow ell and $P$ andharipande [34] give a sim ilar result, $S(q=0)=0: 187$ and $!=64 \overline{\mathrm{M} \mathrm{eV}}$. In order to com pare $w$ th sym $m$ etric nuclear $m$ atter in next section we calculate $M_{M}=_{F}$, and we nd it to be 0.23 for neutron $m$ atter, if we use the calculations of $R$ ef. ["3 ${ }^{\prime}$ '].

F inally, we note that the calculation for the total susceptibility ofFantoniet al. [1]'] gives a result very close to the value one get by_calculating $G_{0}$ from $B$ rueckner theory and using Eq. (11) for the susceptibility, which does not take into account the renorm alization of the m agnetic m om ent. This would appear to indicate that the tensor correlations redistribute spectral w eight betw een single pair and $m$ ultipair excitations, leaving the total susceptibility unchanged. A sim ilar e ect is fam iliar for the com pressibility of electrons in $m$ etals when one takes into account the electron-phonon interaction [24].

## VI. SYM M ETRIC NUCLEAR MATTER

Sym m etric nuclearm atter can be treated by a straightforw ard generalization of the discussion above by introducing the isospin degree of freedom in addition to the spin one. T hus the generalization of Eq. ('క్వ') becom es

where is the isospin operator. Since the $m$ agnetic m om ents of neutrons and protons are di erent, a magnetic eld couples to both isoscalar and isovector com ponents. Because the di erence betw een the $m$ agnetic m om ents of a neutron and a proton is $\mathrm{m} u \mathrm{uch}^{\text {larger than }}$

the sum, the $m$ agnetic response $w i l l$ be dom inated by the isovector term. The isoscalar spin response is given by Eq. (22), but the density of states to be used is $N(0)=2 m^{-} p_{F}={ }^{2} h^{3}$, the factor of two re ecting the two nucleon species. The isovector spin response is given by a sim ilar expression, but w th $\mathrm{G} ; \mathrm{H} ; \mathrm{K}$ and L replaced by $\mathrm{G}^{0} ; \mathrm{H}^{0} ; \mathrm{K}^{0}$ and $\mathrm{L}^{0}$. Since there is no calculation of the new tensor term $s$ for sym $m$ etric nuclear $m$ atter, we esti$m$ ate the $m$ atrix elem ents by using the exchange tensor Landau param eters for sym $m$ etric nuclearm atter calcu-

The calculations of $R$ ef. [2] 1 contribution to the isovectorm agnetic $m$ om ent the value T $0: 08 \mathrm{~N}$ and therefore the third and fourth term S in the analogue ofE q. (7T5') for the isovectorm agnetic response $m$ ay be neglected. The second term is also unim portant, since it is on the order of $1 \%$ of the rst term. W e now use sum rule argum ents [1d] to put a bound on the fth term, which com es from multipair excitations. Equation (7 7 arbitary num ber of com ponents, and recent calculations by $C$ owell and $P$ andharipande $\left[3{ }^{3} \overline{2}_{1}^{\prime}\right]$ of the static structure function and $m$ ean excitation energy for the isovector spin response. Their calculations give $S(q)=0: 155$ and! $\quad 253 \mathrm{M} \mathrm{eV}$ in the lim it q ! 0 . C om paring the contributions from $\mathrm{m} u$ ltipair excitations w th the susceptibility of a free Ferm i gas we nd

where ${ }_{F}=3 n=2_{F}$ is the susceptibility of a free Ferm i gas consisting of 2 species of spin-1=2 particles and $F$ is the Ferm i energy. At nuclear $m$ atter density $n=$ $0: 16 \mathrm{fm}^{3}, \mathrm{~F} \quad 37 \mathrm{MeV}$, gives that M is at least $3 \%$ of $F$, which is much smaller than the corresponding bound for pure neutrons.

W e are not aw are of recent calculations of the total susceptibility for sym $m$ etric nuclear $m$ atter sim ilar to the calculations of Ref . [ $[101]$, but we note that for neutron $m$ atter those calculations gave a susceptibility very close
to the result one obtains by calculating $G_{0}$ from B rueckner theory and using Eq. (1, (1) to calculate the susceptibility. Therefore we compare $m$ with the analogue for sym $m$ etric nuclear $m$ atter of Eq. (11), which we call 0 , and nd

where we have taken $m_{-}=m=0: 8$, and $G_{0}^{0}$ from Ref.
 multipair contributions, being at least $9 \%$ of the total susceptibility, can have som e im portance for sym $m$ etric nuclear $m$ atter, even though the bound is $m$ uch sm aller than the corresponding bound for neutron m atter. It would be valuable to have explicit calculations of the multipair contributions to the susceptibility since it is unclear to what extent the bound provides a realistic estim ate of the value of the quantity.

## VII. CONCLUDING REMARKS

In this paper we have derived an expression for the $m$ agnetic susceptibility of a Ferm iliquid for a generalinteraction which conserves the total angular $m$ om entum and the total spin of the quasiparticle-quasinole pair. A part from the contribution from single quasiparticlequasihole pairs, which $m$ ay be calculated using Landau theory, the susceptibility also contains a contributions from excitation of $m$ ultipair states. In addition to the exchange tensor term usually included, we have taken into account the new tensor term sfound in Ref. [7] $]$. We have also introduced an altemative param etrization of the exchange tensor interaction which has the advantage ofreducing the im portanœ ofhigh angularharm onic contributions.

For neutron $m$ atter we nd that the $m$ ost im portant $e$ ects of the tensor force are to renom alize the $m$ agnetic m om ent and to give a contribution from m ultipair states. For symmetric nuclear $m$ atter one can draw the sam $e$ conclusion, the bound on the multipair contribution is, how ever, m uch sm aller, but it is not clear how close the actualcontribution to the susceptibility, from m ultipairs, is to this low er bound.
$T$ he form alism $m$ ay easily be extended to calculate the response to weak probes: the only di erence being that the $m$ agnetic $m$ om ents $m$ ust be replaced by the corresponding $m$ atrix elem ents of the weak charges.
