# C om plex Scaled Spectrum C om pleteness for C oupled Channels

#### Abstract

The Complex Scaling M ethod (C SM ) provides scattering wave functions which regularize resonances and suggest a resolution of the identity in term s of such resonances, com pleted by the bound states and a sm oothed continuum . But, in the case of inelastic scattering w ith m any channels, the existence of such a resolution under com plex scaling is still debated. Taking advantage of results obtained earlier for the tw o channel case, th is paper proposes a representation in which the convergence of a resolution of the identity can be $m$ ore easily tested. The representation is valid for any nite num ber of coupled channels for inelastic scattering w ithout rearrangem ent.


## I. IN TRODUCTION, NOTATIONS

As is well known, the C SM converts the description of resonances by non-integrable G am ow states into one by square integrable states while leaving the discrete spectrum unchanged [ill]. Cuts describing the continuum are rotated, how ever, but thism ay be advantageous, since they are thus disentangled $w$ hen their thresholds di er from one another. (W e are not interested, in this paper, in the case of channels $w$ ith identical thresholds.) It is then expected that the continuum corresponding to such rotated cuts $m$ akes a much sm oother contribution to the calculation of collision am plitudes, leveldensities, strength functions and sum rules $[\bar{Z}][\overline{3}]$, since narrow resonant processes have been assum ed to be peeled out explicitly by the C SM . The CSM H am iltonian, unfortunately, is not herm itian any more, and it is not obvious that a resolution of the identity in term $s$ of its bound states, resonances and presum ably dam ped continuum is possible. For the one channel case, convincing argum ents have been advanced a long tim e ago $[\underline{4}]$ to prove that th is resolution exists. M ore recently [6్1'], a detailed investigation of the case of two channels, coupled by straightforw ard potentials, generated a contour integration of the usualG reen's function whidh provided the identity resolution. T he task was m ade reasonably easy by the sm all com plication of the $R$ iem ann surface in that case. T he purpose of the present paper is to capitalize on the $m$ ethods used for that two channel case and attem pt a generalization to any nite num ber of channels, despite the $m$ ore com plicated nature of the relevant $R$ iem ann surface. W e shall assum e, naturally, that there already exists, derived from single poles and usualcuts, a resolution of the identity for the in itial H am iltonian, before its m odi cation by com plex scaling. O ur problem atics would be $m$ eaningless otherw ise.

Several earlier studies, in particular by [iG] [T] have been concemed w ith a description of resonances w ith square integrable states, w thout com plex scaling. They did not restrict to the consideration of just sim ple poles of the $S \rightarrow m$ atrix and investigated how one $m$ ight, as rigorously as possible, de ne initial wave packets for the description of decaying states; the non purely exponential nature of their decays received a detailed attention, via the analysis of their tim e dependent evolutions. T he present paper, how ever, w illbe content with a G am ow de nition of resonances, by $m$ eans of simple poles; our aim is just to generate a resolution of the identity, with time independent states extending to asym ptotic regions. For earlier searches of a com plete basis of states, inchuding resonances, but $w$ ith in a com pact interaction volum $e$, we $m$ ay refer to the review by $[\underline{d}]$ of $R$ $m$ atrix $m$ ethods and their extensions. In this paper, we shall again assum e that all potentials $\mathrm{V}_{\text {in }}(\mathrm{r})$ driving the channels and their couplings are local and so short ranged, $G$ aussian-like for instance, that the 2 N Jost solutions of the N coupled equation system,
exist and are analytical in the whole complex dom ain of all the $m$ om enta $k_{j}$ : The radius r runs from 0 to +1 ; obviously, and the num ber N of channels is taken as nite. As an additional technicality we also assum e, naturally, that the products $V_{i n} n j$ do not diverge for $r$ ! 0 when singular solutions of $E q$. ( $\overline{1}$ ) are considered.

A lso in this paper no rearrangem ent is allow ed, channels are de ned by just intemal excitations of the pro jectile and/or the target, hence all reduced $m$ asses are equal. Here each tilde~m eans transposition; we refer to $\left[\begin{array}{ll}{[101]}\end{array}\right]$ or to A ppendix $A$ of $\left[{ }_{\underline{1}}^{1}\right]$ for the derivation of such form ulae for G: D espite di erent form ulae whether $r>r^{0}$ or $r<r^{0}$; and the lack of herm iticity, $G$ is sym m etric, nam ely $G\left(r ; r^{0}\right)=G\left(r^{0} ; r\right):$

It w illle noticed that the C SM, as we describe it by the system of Eqs. ( $[\overline{1} 1)$, locates thresholds on a segm ent of the complex E plane w ith slope 2 ; extending from $E=0$ to $e^{2 i} E_{N}$; and that the channel cuts are rotated back into being \horizontal". C onversely, bound states lie on a negative sem iaxis rotated by 2 and resonances are rotated by 2 aswell. This slight change of representation changes nothing to the physics, obviously. For trivialtechnical reasons [Fַ1] ${ }^{1}$, we norm alize energy units so that $\mathrm{E}_{\mathrm{N}}=4$ : A lso we shall use a short notation, $\mathrm{k} \quad \mathrm{k}_{1}$ and $\mathrm{K} \quad \mathrm{k}_{\mathrm{N}}$ : W e show in F igure 1 the cut energy plane in an ilhustrative, four channel situation when $==6 ; \mathrm{E}_{2}=1: 5$ and $\mathrm{E}_{3}=3: 5$ :

Equipped w ith this slightly unw ieldy form alism, we can now investigate whether there exists a representation, and an integration contour, such that the traditional integral, $I=d E G\left(E ; r ; r^{0}\right)$; calculated in two di erent ways, generates a resolution of the identity. This question of a representation and a contour is the sub ject of Section II, the $m$ ain part of our argum ent. A dditional considerations on the tw o w ays of calculating this integralm ake the sub ject of Section III. A discussion and conclusion are proposed in Section IV .

## II. REPRESENTATIONSAND CONTOURS

## A.Energy plane

From $F$ ig. 1 it is intuitive that one could start, for instance, from +1 along the low er rim of the low est channel cut, retum to the origin, $\mathrm{E}=0$; proceed to +1 again on the upper rim, then join there the low er rim of the second cut, retum to the threshold of this second cut, go to $e^{2 i} E_{2}+1$ along the upper rim, join the third cut low er rim at in nity, etc., until arriving at $e^{2 i} \mathrm{E}_{\mathrm{N}}+1$ along the upper rim of the highest channel. Then the contour would be closing at in nity by m eans of an alm ost com plete circle, counterclockw ise, term inating at the starting point, nam ely at +1 on the low er rim of the low est channel.

A long such a contour, it would be necessary to investigate the behaviors of the ingredients $\mathrm{f}^{+}$; W and of G : Furtherm ore, inform ation is neeqed about the singularities of $G$ inside the contour; indeed, residues of sim ple poles are essential for a calculation of $d E G(E)$ by $C$ auchy's theorem; one also needs reasons why no singularities higher than sim ple poles occur.

T he representation discussed in the next subsection $m$ akes easier the needed investigation, for it opens tw of the cuts and lim its the discussion to situations w here all $m$ om enta have sem ipositive im aginary parts, $=k_{j} \quad 0$ :

> B. P seudom om entum plane

A generalization from $[\underset{-3}{-1}]$, where there were tw o channels only, the present $\backslash P$ representation" consists in join ing the upper rim of the low est cut and the low er rim of the highest cut, and in opening both cuts, by rational form ulae,

$T$ hus the sem icircle at in nity in the upper P plane correspondsto $=k_{j}>0 ; 8 j: T$ his is of criticalvalue for the zoology of our Jost functions and it is expected that this sem icircle properly closes the integration contour under design.

Set now $P=x+$ iy and short notations $c=\cos 2$ and $s=\sin 2$ : A trivial calculation separates the real and im aginary parts of the (com plex) energies driving each channel,

$T$ he other cuts rem ain cuts. T heir thresholds lie on the im age, show $n$ as a dotted line again, of the segm ent already pointed out at the stage of $F$ ig. 1. a very sim ple result indeed. W ith $\mathcal{P} j=1$; the positions of the thresholds are easy to obtain. The special cases $j=1$ and $j=N$ give the argum ent ArgP as $=\quad+=2$ and $=$; respectively. This was already known from [5]. The function $\sin 2+\sin (4 \quad 2)$; see Eq ${ }_{( }^{\prime}(\beta)$, decreases $m$ onotonically when increases from to $+\quad=2$; hence a unique solution for each $E_{j}$; and an obvious symmetry about $+=4$ corresponding to the symm etry about $E_{j}=2$ : Then each interm ediate cut generates, from Eq. The im age lies betw een the heavy full and dashed lines, and, being pinched betw een them at $P=0$; also reaches the origin $w$ th slope $2: W$ hile the pinching $m$ akes num erics slightly di cult, it is easy to verify analytically from Eqs. [^0]To illustrate our full controlof the various $=k_{j}$ 's provided by this $P$ representation, whether in side the w edge or near the positive in nity sem icircle, we show in $F$ igure 3 the cut corresponding to $E_{2}$; and its continuation beyond threshold.
\sem icircle". Sim ultaneously, we generate rim s of the cut, and beyond again below threshold. To generate rim s , we use Eq. ( $\overline{1} 1)$, or as well Eq. ( $\overline{\underline{1}} \mathbf{1})$, w ith $\mathrm{E}_{2}$ replaced by $\mathrm{E}_{2} \quad 0: 2$ and $\mathrm{E}_{2}+0: 2$ for the low er and upper rim, respectively. (T he choice 0.2 w as m ade for graphical convenience, but we tested $\mathrm{m} u \mathrm{ch}^{\mathrm{sm}} \mathrm{sm}$ aller intervals, naturally.) The dots represent $P=0$; where the channelenergy is in nite, and the threshold, where it vanishes by de nition. Like the cut, the rim s are pinched by the wedge.
$T$ hen we show in $F$ igure 4 the tra jectory of $k_{3}$ when $P$ follow $s$ this cut from $P=0$; to the threshold and beyond. $N$ otice that, $\mathrm{E}_{2}$ being realalong the line, then the im aginary part of $\mathrm{E}_{3}=\mathrm{E}_{2}+\mathrm{e}^{2 i}\left(\mathrm{E}_{2} \quad \mathrm{E}_{3}\right)$ is obviously negative. $T$ his does not prevent a choice of $k_{3} w$ ith $=k_{3}>0$; generating the leftm ost tra jectory in $F$ ig. 4. Sim ultaneously, we show the trajectories of $k_{2}$ from both rim s of the same cut. The left hand side (when seen in $F$ ig. 3) rim induces $<k_{2}$ ! 1 when $P$ ! 0 ; with an in nitesim ally positive $=k_{2}$ : $C$ onversely the right hand side rim induces $<k_{2}$ ! +1 when P ! 0; with still an in nitesim ally positive $=k_{2}$ : W hen we go from either rim tow ards the upper sem icircle at in nity, this induces $=k_{2}!+1$; as expected. The rim $s$ can be connected by any sm all path, see the bar above the threshold in Fig. 3, and the values of $k_{2}$ along the rim $s$ can be sm oothly $m$ atched, see the curved bar in $F$ ig. 4, the tra jectory of $k_{2}$ when $P$ follow $s$ the bar in $F$ ig. 3 . G eneralizations to every $k_{j}$ in every part of the wedge are trivial.

C. C ontour

To synthetize this Section, the $P$ representation de nes a physical sheet sim ilar to the physical sheet of the energy plane. The region of interest is that region above the tw o curves which open the cuts for the low est and the highest channels, while cuts rem ain for the interm ediate channels. All m om enta inside the wedge, and all the way to the upper sem icircle at in nity, can be de ned with positive im aginary parts. A contour can be found, follow ing all cuts and closing at in nity in the upper plane.
realaxis, follow the \opener curve" which corresponds to the low est channel, all the way to $P=0:$ From there, follow the low er rim of the cut corresponding to the second channel, back to its threshold, then tum around the threshold to follow its upper rim, down to $P=0$ : In tum, follow the low er rim of each interm ediate channel, then its upper rim . A fter bouncing $N 1$ tim es at $P=0$; follow the \opener curve" corresponding to the upper channel, until $P$ ! +1 on the real axis. Then close the contour by means of the upper sem icircle at in nity. In the next Section, we shall investigate what happens to the integral, $I=d E G\left(E ; r ; r^{0}\right) ;$ when considered along this contour in the $P$ plane.
III. THREECONTRIBUTIONSTOTHEGREEN'SFUNCTION INTEGRAL

> A. U pper sem icircle

At in nity in this upper P plane, the integration weight, $d E=2 P \quad Q^{4}=P^{3} \quad d P$; boils down to 2P $d P$ : A ll the N distinct Jost solutions boil down to $\exp i\left(\operatorname{Pr} \quad \frac{1}{2}{ }_{j} \quad\right.$ ) in their respective $\backslash$ ux channel $j$ ", while vanishing in the other channels. The $W$ ronskian $m$ atrix boils dow $n$ to the $N$-dim ensional unit m atrix.

It is trivial to verify that the sam e result is obtained if $r<r^{0}$ :Furtherm ore the term ( $r+r^{0}$ ) cancels out in the space of regular radial waves. H enœ the contribution $I_{s c}$ of the sem icircle $m$ akes nothing but the $m$ ultichannel identity, $m$ ultiplied by ( $2 i$ ): N otioe that, di ering from Rll, this identity is not m ultiplied by a factor depending on ; since for us the ends of the sem icircle, 1 and +1 ; both lie on the realP axis.

> B. C ontinuum

It $m$ akes no di erence here whether we consider the contribution of one of the lopener line" or that of one of the interm ediate cuts. For in both cases we group partner term $s$. Such partners either com e from a transform $P \$ Q^{2}=P$ or from opposite rim s of the interm ediate cut under consideration. W hat is im portant to notioe is that $m$ om enta retain their nite and positive im aginary parts and do not change when we com pare two partner points, except that $m$ om entum speci $c$ to the opener line or the cut. For that $m$ om entum, which is real, \partnership" $m$ eans $k_{j} \$ \quad k_{j}$; $w$ ith still an in nitesim alpositive im aginary part. $K$ eeping in $m$ ind that is even under such a $m$ om entum ip, the contribution of such a continuum thus reads, if $r>r^{0}$ for instance,

W e assum ed that, before com plex scaling, nam ely for $=0$; there existed an identity resolution in term sofunscaled bound states and unscaled scattering states. In other w ords we assum ed that the corresponding, unscaled G ( $E$ ) show s only isolated, simple poles, besides the physical cuts. Such poles can be on the real E axis of the physical sheet, describing bound states, or aw ay from this axis, then describing resonances or antiresonances. The point is, now, that the CSM cannot change the nature of such poles $\left[\begin{array}{ll}11 \\ ]\end{array}\right]$. W ithin our description by Eqs. $\left.\overline{I I}_{1}^{1}\right)$, the CSM just rotates such poles by 2 in the energy representation, along circular arcs, concentric around $E=0$ : In the $P$ representation, the im ages of such arcs are also concentric arcs, $w$ ith angular extension only. This is trivially seen from the equation which, for each initial position " of a pole, de nes those values of P which represent $\mathrm{e}^{2 i}$ ";

For the calculation of I by C auchy's theorem, poles are not due to either $f$ or ; since these, as functions of $E$ or P; are regular. O nly the divergence of ${ }^{1}$ can create poles. The situations of interest are those when the roots of the determ inant, detW ; are located inside the integration contour. W e know that such is the case for the bound states. D epending upon ; som e resonances $m$ ay also rotate into the dom ain. It is already know $n$ that only sim ple, isolated poles occur. The only question to solve is, what is the residue of $G$ at such a pole.

Residues of $G$ at its poles w ill now be obtained from derivatives $d=d E$ : That is equivalent to a calculation in the $P$ representation, anyhow, and slighly easier. We shall use short notations in which the dependence of ; $\mathrm{f}^{+}$; W ; upon $r$; and/or $r^{0}$ and/or $E$ will be $m$ ost often understood. D. C om pleteness

Since the three contributions $I_{s c} ;{ }^{P}{ }_{j} I_{j}$ and $I$ are obviously related by $I_{s c}+{ }^{P}{ }_{j} I_{j}=I$; it is trivial to equate $\frac{i}{2} I_{s c}$;
and $\frac{i}{2}{ }^{P} I_{j}$; the latter term $m$ aking the pseudopro jector upon the continuum for all channels. $N$ aturally, in practical calculations, a cuto and som e am ount of discretization w illbe necessary to integrate such continuum term s , but the $P$ representation provides a suitable fram e for testing the convergence of such a resolution for sum rules, leveldensities and sim ilar observables. $N$ otice that, because of the use of com plex, self dualbras and kets in the resolution, such cuto and discretization $m$ anipulations $m$ ay generate spurious im aginary parts for the expectation values of herm itian observables. For a discussion and possible interpretation of im aginary parts in individualm atrix elem ents, we refer to [1]']. But, when sum $m$ ed upon all discrete and integral term s provided by the resolution, such im aginary parts $m$ ust add up to a negligible, spurious noise com pared to the real parts. $T$ his requested cancellation $m$ akes one $m$ ore criterion to validate num erical operations.

## IV . D ISCUSSION AND CONCLUSION

O nce again we used the ABC theorem s [In to locate the discrete spectrum at trivially rotated positions deduced from the discrete spectrum of an initial, hem itian Ham iltonian. The topological sim ilitude provided by the C SM rotation warrants that, as long as there are no double poles or higher singularities $w$ ith the in itial $H$ am iltonian, the sam ew ill be true w ith the C SM H am iltonian.

Then it was not very di cult to nd a representation which allow s a suitable contour integration of the $G$ reen's function. T here was still a slightly com plicated $R$ iem ann surface to handle, for the num ber of cuts was reduced to N 2 only [12], but we took great care, inchuding a few num erical, ilhustrative exam ples, to show that all cuts in the new representation are well understood, all thresholds are easily located, all com plex $m$ om enta to be used for proofs have positive im aginary parts in a physicaldom ain of a suitable sheet, and in general that all technicalities are sound.

This proof of the C SM com pleteness for $N$ channels is restricted to a nite num ber of well separated channels, norm al square root threshold singularities, in a purely inelastic situation, without rearrangem ent, and with short ranged forces. The case of long range forces $m$ akes a $m$ ore di cult question, indeed [ 13$]$ still allow a large class of practical problem $s$, and for instance in nuclear physics, a very large num ber of collective resonances can be described by the coupled channelequations that we studied.
