Pionic Color Transparency

Abstract

We use a sem iclassical approximation to investigate the electroproduct ransparency on pion electroproduction reactions. The resulting reduced nuclear interactions produce signicant, but not dominating, di erences with the results of conventional distorted-wave, G lauber-type treatments at kinematics accessible to Je erson Laboratory. Nuclear elects that could minic the in uence of color transparency are also discussed.

I. IN TRODUCTION

Colortransparency is the reduction of initial or nalstate interactions in high-m on entum – transfer coherent processes that occurs if a projectile or ejectile propagates in the nucleus as a sm all color singlet object. See the review s: [1]{ [3]. In such situations, the e ects of em itted gluons are canceled [4][5][6] in a manner analogous to the propagation of a sm all electric dipole moment through an electrodynam ic medium [7] so that the sm all color singlet behaves as a Point Like C on guration, PLC. The PLC is a component of a hadron and evolves to its full size in a characteristic hadronic time of the order of 1 fm /c. However, produced at su ciently high energies, time dilation e ects allow a PLC to propagate through the entire nucleus before expanding. In that case, the production cross sections will be larger than those computed using the standard distorted wave or G lauber treatment.

An electroproduction (e;A;e⁰ X) experiment at JLAB[8] attempting to measure pion transparency in nuclei has completed running and is currently under analysis. The pion electroproduction cross section is measured for various values of Q² and p between 1 and 5 G eV and $\pm j < 0.5 \text{ G eV}^2$. The experiment was done at parallel kinematics so that $p = p \frac{Q^2 + Q^2}{Q^2 + Q^2}$ k where k is the magnitude of the three momentum imparted to the target. Targets used in the experiment include H, D, 12 C, 64 Cu and 197 Au. From this data it may be possible to extract the Q², p ;k and A dependence of any observed color transparency.

The state of pion transparency theory has been quiet for some time. Stimulated by the new experiment, our purpose is to display the results of earlier theory [9] using special kinematics and nuclear targets that allows us to discuss the feasibility of observing color transparency in electroproduction reactions as well as other nuclear electro. Papers on pionic transparency [10] have appeared since the time of Ref. [9]. The new feature of the present work is the evaluation at the special electroprotect the possible interference elects of expansion absent from [10]. We do not incorporate the possible interference elects between point-like and blob-like con gurations that could produce oscillations in color transparency that are included in [10].

II. THE SEM I-CLASSICAL APPROX IM AT ION

The nal state interactions of sem i-exclusive nuclear reactions can be described quite well by G lauber-type calculations. If a PLC is created inside the nucleus and subsequently evolves into a physical particle its nal state interactions will be modiled and transparency will result.

If one is summing over all nuclear nal states, the nuclear transparency can be de ned as the ratio of a model calculation of a nuclear cross section (including the e ects of FSI's) to the (A times the) cross section produced by a free nucleon target. The use of this ratio allow s one to assess the in uence of FSI's without having a detailed know ledge of the reaction dynamics.

A sem i-classical form ula [11] has been developed to compute nuclear transparency for situations in which the kinem atics of the outgoing pion are known precisely, but the cross section involves a sum over all of the excited nuclear states [12] The strength of the nal state interactions depends on an emission probability computed using the eikonal approximation and an elective interaction that parameterizes the variation of the nal state interactions as the ejectile propagates through the nucleus. If the particle produced inside the nucleus is a PLC which then expands into the observed nal state, the interaction with the nuclear

matter deviates from that of G lauber-type calculations.

The sem i-classical formula for pion transparency in the reaction (e; $e^{0}A$! ^{+}X) involves only a single integral over the path of the outgoing pion,

The nuclear density (r) is of W oods-Saxon form with radius parameter R = 1.1 fm $A^{1=3}$ and di useness a = 0.54 fm, and is normalized to A and the elects of nalistate interaction is contained in the elective interaction, $_{eff}$. The elective interaction contains two parts, one for $z^0 = z$ less than a length l_c describing the interaction of the expanding PLC, another, for larger values of $z^0 = z$ describing the nalistate interaction of the physical particle. The elective interaction for the PLC is

The prediction that the interaction of the PLC will be approximately proportional to the propagation distance z for $z < l_c$ is called the quantum di usion model. For z = 0 in Eq. (2) the cross section for the initially-produced PLC is identified.

For the pion, n = 2 and $hk_t^2 i^{1=2}$ ' 0.35 G eV .[11] The coherence length, l_c sets the time scale for the PLC to evolve and determ ines the probability that a particle experiences reduced PLC interactions before leaving the nuclear matter. For propagation distances $z > l_c$ the PLC interaction is that of a standard nal state approximation with $_{eff}$ ' $_N$ (p), and is that of a typical G lauber-like calculation. We take the values of $_N$ (p) from Particle D ata G roup parameterization [13]. In the lim it $l_c = 0$ a PLC is not created and the calculation reduces to a G lauber-like calculation.

The transparency is known [11] [14] to have a strong dependence on the unknown param – eter l_e . The best current estimate for l_e is $2p_n = M^{-2}$, with M given by the lowest lying Regge partner. Current data do not constrain the value of l_e for pions. In our calculations we use $M = 0.7 \text{ GeV}^2$ which leads to a prediction of transparency at currently accessible energies, but also show results for $M^{-2} = 1.4 \text{ GeV}^2$. This larger value corresponds to a very

short expansion time $ct_{exp} = 1 = M = 0.16$ fm in the rest frame, and so m ight be expected to provide a reasonable estimate of a lower limit on the elects of color transparency.

The rst step is to assess the size of T and its dependence on the PLC cross section of Eq. (3) for ¹²C. As shown in Fig 2, the e ects of color transparency increase T over its value as obtained from a G lauber calculation. There is generally a small variation with Q^2 . The G lauber result T = 0.6 is similar num erically to the value measured for protons in (e; e⁰p) with ¹²C, and might be expected to be larger than that because the N cross section is about 2/3 the NN cross section. However, the proton experiments are set up so that there is essentially only one nalnuclear state for each knocked out proton. As a result the transparency is computed using a formula di erent than Eq. (1). Analyzing the two formulae shows that the chance for protons to be produced near the edge of the nucleus (where there is little absorption) is larger than that for pions.

The A dependence is displayed in Fig 2. For any xed range of the momentum of the outgoing pion, increasing the size of the target nucleus increases the relative increase in the value of T. The dependence on coherence length is shown in Fig 3. About half (but not all) of the e ects of transparency are removed by decreasing the coherence length.

III. PION TRANSPARENCY AT JLAB

The experiment recently completed at JLAB measured pion electroproduction cross sections at speci c kinematics. The experiment used targets 12 C, 64 Cu and 197 Au. The essential feature of our work is to provide evaluation at the speci c kinematics of [8]. The kinematics are listed in Table I and the evaluations of T are shown in Fig.3. The relevant parameters in transparency are the pion m on entum, Q² and the size of the nucleus. For measurements of di erent pion m on entum and di erent nuclear targets at a given Q² one can de ne an enhancement factor which can be predicted from our semi-classical approximation. It is in portant to emphasize here that the m on enta of the pions k in the kinematics of the Jlab experiment are large. Hence this process cannot be thought of as a knockout of the pion from the meson eld of the nucleon, but rather as a case of a hard process N ! N o a nucleon bound in the nucleus which is governed at large Q² by the QCD factorization theorem [15] which states that in this limit the process is dominated by the PLC con gurations of the produced qq pair.

Since the pion m om enta are very large com pared to the characteristic scale of the nuclear m om enta one expects nuclear m odi cations to the reaction to be sm all. There is still a need to treat the modi cations due to the excitation energy of the residual nucleus and the Ferm i motion of the initial nucleon. If the four-momentum of the struck bound nucleon is given by (m_N ${\tt E}$; ${\tt p}_{\tt N}$), the change in the momentum of the em itted pion is 2:5E $p_{N,3}$, where 3 represents the photon direction. This e ect shifts the peak momentum of the produced pion by about 50 M eV/c with a spread of about 200 M eV/c. The acceptance of the experiment is broad enough to measure pions within this momentum spread.[8] A second e ect is the enhancement of the scattering by forward moving nucleons due to the energy dependence of the elementary cross section. These e ects are mostly important for comparing deuteron results to those of heavier nuclei. C on paring the deuteron to heavier nuclei requires accurate m odeling of the experim ental cuts. For A 12 the average excitation energy and average m om entum becom e a rather weak function of A and so one expects that the e ects discussed

above will mostly cancel in the ratio of heavy nucleivs carbon.

In the following T is plotted vs. k, the magnitude of the three-momentum exchanged with the target. For parallel kinematics, the magnitude of the pion three-momentum is p = jgj k. The usual color transparency prediction is for greater transparency with greater nal state momentum. Thus the chosen value of k strongly in uences the computed values

of T. For the experim ental data one can look at the greatest ratio of transparencies for the

collected data and look for any variation in this ratio between the di erent targets.

There seems to be enough variation with Q^2 and A to allow identication of color transparency for the current beam energies. However, the use of a higher energy beam planned for JLab12 would greatly extend the scope of the study as well as the possibility of obtaining a clean observation of the elects of color transparency.

There are other signi cant e ects that depend on the value of k that are not included in the present calculation. The nuclear EM C e ect tells us that nuclear interactions act to suppress the e ects of quarks m oving with large B jorken x. Therefore the chance for a pion of large m om entum, k, to exist in a nucleus could depend on the nuclear density and di er strongly between the deuteron and heavier nuclei. However, the EM C e ect is sim ilar for all nuclei with m ass as great as C arbon. Therefore com parisons between heavier nuclei could be m ore useful in extracting inform ation about color transparency than com paring between heavy nuclei and the deuteron.

${\tt IV}$. ${\tt CONCLUSION}$

Figure 4 shows a clear pattern in the Q², A and k (three-momentum transfer to the nucleus) dependence of the transparency T.U se of the A-dependence could allow the identi cation of color transparency at the current energies of JLab. The use of a higher energy beam expected at JLab12 would signi cantly enhance the probability of observe color transparency in pion electroproduction experiments. If the dependence of the cross section on k does not vary greatly between di erent nuclei than an enhancement of the cross section for a given k will be a clear signal of color transparency. W e may expect that this variation will be sim ilar for heavy nuclei but not for light nuclei. The ratios of cross sections for heavy nuclei can therefore provide more reliable inform ation than considering ratios with the deuteron cross section. Any understanding of transparency can not be complete w ithout an understanding of the k dependence of the (e;e⁰) reaction. This will be pursued elsew here.

- [12] A quantum mechanical G lauber type procedure is to calculate absorption on the amplitude level and then to sum over the nal states of the nuclear system, see e.g. [16]. This lengthy procedure gives a som ewhat smaller value of the transparency in the G lauber lim it. However the rate of the change of the transparency due to inclusion of the color transparency e ects is rather sim ilar. Thus we will use the sem i-classical form ula here for sim plicity. Note also that in the quantum mechanical form ula reaches the value of tot while in the sem i-classical form ula it reaches inel.
