A nother look at \soft" lepton pair production in nucleon-nucleon brem sstrahlung

A bstract

We compare dierent formalisms for the calculation of lepton pair em ission in hadron-hadron collisions and discuss the consequences of the approximations inherent to each of them. Using a Lorentz-covariant and gauge-invariant formalism proposed by Lichard, we calculate lepton pair em ission via brem sstrahlung in proton-proton and neutron-proton reactions at energies between 1 and 5 GeV to leading order in the virtual photon four-momentum. These new results suggest that some previous brem sstrahlung calculations based on varieties of the soft-photon approximation might have somewhat

overestim ated the DLS low-m ass dilepton cross sections. We not that the respective intensities of dilepton production through pp and np brem sstrahlung are energy-dependent and become comparable at E $_{\rm kin}$ > 2 GeV . We also calculate the polar angle anisotropy of the lepton spectrum .

I. IN TRODUCTION

D ileptons and photons are probably the best carriers of inform ation from the hot and com pressed nuclear matter produced in the early stages of heavy-ion collisions [1]. In principle, those electrom agnetically interacting particles can leave the hadronic environm ent from which they are created without signi cant disturbances, o ering a relatively clean probe of the nuclear collision dynamics. In heavy ion collisions at incident energies of 1 (5 A G eV, where the Law rence Berkeley Laboratory Dilepton Spectrom eter (DLS) has already taken m easurem ents [2], the most important sources of e pairs seem to be Dalitz and radiative decays mainly from mesons and 's, pion-pion annihilations, and nucleon-nucleon brem sstrahlung [3{5]. Measurem ents of lepton pair production in single nucleon-nucleon reactions have also recently been performed in the GeV energy regime. In those, the measured pd/pp dielectron yield ratios display a clear beam energy as well as invariant mass dependence [6]. This suggests that the dominant mechanism for dilepton production may be changing as the beam energy per nucleon increases from 1 to 5 GeV. In particular, one should pay attention to the opening of inelastic nucleon-nucleon channels. The latter have been shown to play an important role for dielectron production in nucleon-nucleon collisions at 4.9 G eV [5]. To eventually understand quantitatively and completely the relative role of all these contributions and their excitation function in the complex environment of nucleus-nucleus collisions, it is vital to st calculate the lepton pair production cross sections for individual processes as accurately as possible. Here we shall concentrate on the brem sstrahlung generation of lepton pairs in the case of nucleon-nucleon reactions.

Several di erent calculations for electron-positron pair em ission through nucleon-nucleon brem sstrahlung have been perform ed for reactions at, and slightly above, 1 G eV. Som e of the more sophisticated approaches used relativistic one-boson exchange (OBE) Lagrangians, with the coupling to the electrom agnetic eld done by minimal substitution [7{9]. These approaches are thus entirely Lorentz-covariant and are also gauge-invariant in the electromagnetic sector. Note that the OBE dilepton calculations can be made gauge-invariant even

when form factors at the strong interactions vertices are used [7]. Such approaches have all the transform ation properties that are required of a complete theory but they are not completely satisfactory in two respects. First, they are very cum bersom e. If several meson elds are involved, the number of Feynm an graphs to be evaluated proliferates rapidly and the di culty of the calculations increases accordingly. The coupling constants in the OBE m odel are tted such that the total nucleon-nucleon cross sections are reproduced as closely as possible. This exercise thus has to be repeated for each colliding system. Second, even if two dierent OBE calculations with two slightly dierent set of ingredients (meson elds, form factors and coupling constants) can do a good job of generating total nucleon-nucleon cross sections that are in agreement with experimental measurements, generally they will have di erent predictions for the di erential cross sections. As we shall see below, there is a way of writing the low invariant mass dilepton production cross section in nucleon-nucleon collisions such that it clearly depends on the di erential elastic cross section of the colliding partners. This fact thus im poses very stringent requirem ents on the OBE models as far as their ability to predict lepton pair production yields is concerned. This point was recently m ade in the literature [10,5]. Because of the above considerations, the calculations pertaining to the brem sstrahlung generation of low invariant mass lepton pairs in nucleon-nucleon collisions have used a \soft photon approximation" [11] of some kind or another. A lm ost all of the recent calculations of dielectron production in nucleon-nucleon (and nucleus-nucleus) collisions that have used the soft photon approximation have used as their starting point a form ula suggested by Ruckl [12]:

This equation links the cross section for production of dileptons via virtual photon brem sstrahlung to the brem sstrahlung cross section for real photons. In the above, p is the three-m omentum of the electron or positron, E is the energy, M 2 = $(p_+ + p_-)^2$ is the dilepton invariant m ass squared, q is the photon m omentum and ! is its energy. The ne structure constant appears as .

The derivation of soft photon formul in the context of brem sstrahlung em ission of lepton pairs has recently been re-analyzed [13]. It was shown that Ruckl's formula was not properly Lorentz-covariant and did not contain the relationship between dilepton cross section and virtual photon cross section that is required by gauge invariance [14]. In the context of the new analysis of dilepton production via virtual photon brem sstrahlung, a new set of formul were derived for the leading order and next-to-leading order contributions to lepton pair em ission [13].

It had been known for some time that the Ruckl formula was not entirely correct [15,7{9}]. Nevertheless, in comparison with OBE calculations, it was deemed quantitatively adequate [4,9]. It is not the point of this paper to restate this known fact. We rather wish to investigate the empirical predictions of the new formalism in the practical framework of quasi-elastic nucleon-nucleon collisions at energies around and above 1 GeV, to establish whether the new leading term approximation deviates signicantly from previous works. We also plan to investigate quantitatively and systematically the elects of diement layers of approximation found in several calculations. Our paper is organized as follows: in section II we introduce the general formalism, in section III we compare diement approaches to the generation of soft virtual photons and discuss the diemences. In section IV we explore the consequences of a better treatment of the many-body phase space. In section V, we discuss how some of the approximations seen in sections II and III can be put into perspective by an angular anisotropy analysis of the lepton spectrum. We then summarize.

II.GENERAL FORM ALISM AND HADRONIC ELECTROM AGNETIC CURRENTS

Consider the reaction

where a, b, c, and d represent nucleons. The generic Feynm an diagram for the leadingterm contributions to the emission of a soft virtual photon are shown in Fig. 1. This is the process on which we concentrate in this work. See the appendix for a mathematical description of what is a leading term and what isn't. The circle schematically represents the strong interaction. In the limit of soft photons, real or virtual, the radiation from the strong interaction blob is a sub-leading contribution. When a, b, c and d are all protons, there are eight Feynman graphs to be added coherently for the calculation of lepton pair emission. Note in passing that there have been arguments that brem sstrahlung from pn reactions should be signicantly more important than that from pp. These were based on the fact that, nonrelativistically, the rst non-vanishing multipole contribution for pp appears at the quadrupole level, whereas for npit is at the dipole stage. It has however been recently shown that such arguments do not hold for relativistic collisions [5]. In fact, the lepton pair yields from these two processes are comparable at 4.9 GeV [5]. There will be more on this later. Naturally, the pp brem sstrahlung contribution is crucial in the interpretation of the ratio of dileptons produced in pd and pp reactions. We will discuss pp contributions in this work, also.

We evaluate and sum the amplitudes of the relevant Feynm an diagram s of the type in Fig. 1. Anticipating the soft photon \lim it, we assume that the hadronic part of the total matrix element is una ected by the fact that one of its legs is slightly o—shell. We write this on—shell matrix element for elastic nucleon—nucleon scattering as M $_0$. We om it the momentum labelling of the initial and nal state, for simplicity. Squaring the net matrix element, M $_0$, and sum ming over nal state spins and averaging over initial states, we obtain to leading order (see appendix)

In the above,

is the hadron electrom agnetic current, and the lepton tensor is

The Q's and p's represent charges and four-m om enta for the particles, and $q=(p_++p)$. Note that J q=0, as a consequence of gauge invariance. $\frac{1}{2}M_0\frac{1}{2}$ is the on-shell hadronic elastic scattering m atrix element, squared, sum m ed over nalspins and averaged over initial spins.

A fler perform ing the appropriate contractions, we may write the dierential cross section for e^+e^- pair production with invariant mass M and energy q_0 as

where $_{\rm c}$ is the azim uthal angle of one of the outgoing hadrons in the center-ofm ass fram e and the four-vector $l=p_{+}$ p is the di erence of positron and electron four-m om enta and t is the four-m om entum transfer. Equation (6) follows from Eq. (2.15) of [13] after specifying the nonradiative cross section as

and including the phase-space correction introduced in [16].

In the evaluation of the original Feynman diagrams, we have neglected the fourm on entum q of the virtual photon in the phase-space—function in order to reproduce the kinematics associated with the on-shell elastic diemential nucleon-nucleon cross section, d = dt [11]. Because of this approximation, we include [16] the ratio of two-body phase space $[17]R_2$ (s_2 ; m_a^2 ; m_b^2) $= R_2$ (s_1 ; m_a^2 ; m_b^2) evaluated at s_2 and s_1 , where s_1 is the invariant energy squared available for all the nal-state particles and $s_2 = s + M^2 - 2q_b^{-p} \overline{s}$. This approximate correction prevents the lepton pair from violating the overall energy-momentum conservation laws and thus has a significant election distributions. The ratio constructed from Eq. (6) with and without the correction factor correctly drops monotonically to zero in the limit of maximum invariant mass. Handling the phase-space properly is quite in portant. However, setting q=0 in the four-dimensional delta function also forces the expression for the current to be evaluated on-shell, i.e. $p_c + p_d = p_a + p_b$. Clearly, this will have some election the value of the current of Eq. (4). For the purpose of clarity, we will investigate separately the elects of a complete treatment of phase space in section \mathbb{N} .

An exercise in relativistic kinematics gets one from Eq. (6) to the Lorentz-covariant di erential cross section in global dilepton variables

where is the electron mass. Our usage of Ruckl's approach for dilepton production consists of neglecting the term $(p_+p_-+p_+p_-)$ of the leptonic tensor [8], Eq. (5), and analytically continuing the realphoton energy to $q_0 = \frac{p_-}{q_-^2 + M_-^2}$. This procedure is however not Lorentz-covariant [13]. One then obtains Eq. (8) multiplied by an additional factor of 3/2 (1+2 $^2/M_-^2$). From here on, we shall discuss electron-positron pair production exclusively and we system atically will use = 0.

To complete our analysis of previous e orts we now turn our attention to the electromagnetic current. For emission of real photons in reaction (2), the current is

This approximation was also used by several authors, in the case of soft virtual photons [15,3,18,4,5]. It is worth mentioning here that for the case of virtual photons, the \soft" lim it is not unambiguously dened: for virtual photons, what is meant by a \soft photon lim it"? Here, we use this term in connection with the condition M $\,!\,$ 0. However, bear in mind that the lepton pair energy and lepton pair three-momentum can individually still be quite large. Thus M $\,!\,$ 0 is in fact not a sudient condition to neglect both q_0 and q in the delta functions, even if this om ission can partially be corrected (e.g. Eq. (6)). The opposite lim it where M is large in plies that the lepton pair energy is large and most certainly can't be ignored in the phase space delta function. By the same token, o -shell e ects on the strong interaction amplitude can be small in the M $\,!\,$ 0 lim it, but won't be, in the large M region. In this work we do not include a discussion of o -shell e ects. We should however keep this point in mind when discussing the regions of validity of our calculations.

There are thus several possible ingredients that can a ect the results of lepton pair em ission calculations of the \soft photon type". One resides in the use of the Ruckl formula,

a widely-used expression which nevertheless is not Lorentz-covariant. This is point is easily settled: our interpretation of Ruckl's formula for electron-positron pair production instead of Eq. (8) simply introduces an overall factor of 3/2. Another possible source of disagreement between calculations has to do with the use of the current of Eq. (9) as the electrom agnetic current for hadrons when massive lepton pairs are emitted. For lepton pairs with very small invariant masses the current represented by Eq. (4) of course reduces to that of Eq. (9). Also, the exact treatment of dynamics will play a role. For the time being, we set q = 0 in the four-dimensional Dirac delta function and simply use the phase space correction factor associated with Eq. (6). In the next section, we investigate the electrom using different hadronic electrom agnetic currents.

III. COM PAR ING CURRENTS

Squaring the current (4), as is required by Eq. (8), we obtain an expression that depends on the spatial orientation of the virtual photon. Taking an angular average, and for an equal-mass reaction of the type specied in Eq. (2) with $m_a = m_b = m_c = m_d = m$, we arrive at

To make the formula more compact, we have introduced the variables

Notice that terms directly proportional to $1=q_0$ have exactly cancelled and disappeared upon squaring the current. If we set M=0 in Eq. (10), we recover Eq.(3.6) of Ref. [19].

We have calculated the ratio $R_0 = J_{\rm virtual}^2 = J_{\rm real}^2$ with the angular-averaged currents of Eq. (4) and Eq. (9). This ratio depends on the invariant energy s, the four-momentum transfert, and the dilepton invariant mass and energy: M and q_0 . For the purpose of comparison, we arbitrarily input some reasonable values and plot R_0 against the virtual photon three-momentum in Fig. 2. We not sizeable deviations from 1 in this quantity. The ratio for pn processes is sensitive to the value of $c_{\rm rm}$; the scattering angle in the nucleon-nucleon centre of mass, whereas it is quite insensitive for the pp case. Interference excise evidently play a role here. To better understand the excit of the \complete" current (also labelled \virtual", above) on the dimensional excitons section for dilepton production, we integrate over the and plot $R_1 = (\frac{d}{dM^2 d^3 q})_{\rm virtual} = (\frac{d}{dM^2 d^3 q})_{\rm virtual}$ as a function of the cm. virtual photon momentum in Fig. 3, for dimensional exciton invariant masses. We are now essentially comparing the exciton pare two sets of calculations that have been done previously, the numerator is derived from Eq. (8), while the denominator is derived from Rudkl's approach.

Before discussing the results in Fig. 3, let us restate that the net lepton pair spectrum will depend on the details of the di erential nucleon-nucleon elastic cross-section, d =dt.

This is evident from Eq. (6) and Eq. (8). It thus follows that the present analysis will have to be redone for di erent systems at di erent energies, with possibly di erent conclusions. For example, quark-quark and pion-pion virtual brem sstrahlung calculations have attracted som e recent attention in connection with ultrarelativistic heavy-ion collisions [19,20]. The consequences of the present formalism on such studies is presently being analyzed [21]. It is thus imperative to have an accurate parametrization for the elastic nucleon-nucleon di erential cross section d =dt over the relevant range in t. For pn elastic collisions, d =dt is nearly symmetric for kinetic energy less than 1 GeV. But at higher energies, the observed distributions are not sym m etric about cm = 90 but rather develop a stronger forward peak. This asymmetry increases with the scattering energy and can suppress the pn bremsstrahlung contribution to dilepton production by a factor of 4 at 4.9 GeV [10,5]. A fairly detailed param etrization at 4.9 GeV kinetic energy was used in Ref. [5] to calculate the absolute sizes of the pn and pp bremsstrahlung contributions. For practical reasons, we instead adopt the param etrizations of Refs. [10] and [22] for the pn and pp elastic di erential cross sections. These two functional forms can the experimental data for energies up to 6 GeV with the necessary accuracy.

Analyzing Fig. 3, the ratio R_1 remains 2/3 for small invariant mass M 10 MeV. For higher invariant masses, R_1 is greater than 2/3 for almost all values of the virtual photon momentum, in the case of pn scattering. Increasing M in the pp case, R_1 remains still considerably smaller than 2/3 at low momenta and drastically increases as the three-momentum grows. The low-momentum value of R_1 is thus quite dierent in the two reactions at hand. It is not simple to draw clear physical conclusions for these behaviours, but the main point is that these features suggest that using the \complete" current for virtual photons changes the distribution of the dielectrons in phase space, especially in the pp case.

Upon integration, we arrive at di erential cross sections in terms of lepton pair invariant mass. In Fig. 4, we show two curves: the dashed curve corresponds to using the Ruckl formula with the real photon current, Eq. (9). The solid curve corresponds to using Eq. (8) with the current of Eq. (4). In each panel three kinetic energies are shown: 1.0,

3.0 and 4.9 GeV. We are thus in e ect evaluating the dierence between two approaches to calculating the dielectron production in nucleon-nucleon collisions: the one based on Ruckl's equation and the real photon current (we rem ind the reader that this combination has become well known and widely used), and the one based on the more recent Lorentzcovariant form alism with a more general electrom agnetic current for hadrons. At these energies (which correspond to DLS measurements) one realizes that the Lorentz-covariant and gauge-invariant formul that we adopted in this work (solid curves) reduce the dilepton production cross section only slightly for M < 0.5 G eV in both pn and pp processes com pared with previous results. For M > 0.5 GeV, the situation is a little more complicated as a slight decrease or a slight increase is observed, depending on the beam energy. We have veri ed that the ratio $(\frac{d}{dM^2})_{virtual} = (\frac{d}{dM^2})_{real}$ is equal to 2/3 in the small M region for both pn and pp cases, and found it to increases monotonically with M for pn process, but decreases m onotonically for pp as one goes toward the kinem atical lim it. Recall that other physical processes dom inate the dielectron yield for M > 0.5 G eV at large enough beam energy [5]. In the large invariant m ass region, Fig. 4 suggests that the previous brem sstrahlung calculations underestim ate the dilepton yields at most by a factor of 2 even at the kinetic energy 4.9 GeV, even though our form alism is not strictly applicable there. For pp scattering, it is worthwhile to point out that the radiation intensity is strongly depleted due to interference e ects near the maxim um M.

Thus our indings at this point are essentially these: the \improved" form alism does not a ect very much the soft lepton yields previously calculated. We do not address in detail the issue of hard leptons (M $0.5 \, \text{GeV}$) because there, the present form alism is inadequate and also because the signal is dominated by other sources. In the small invariant mass region M < $0.5 \, \text{GeV}$, we indicate this new form alism only amounts to the numerical dierence of 2/3.

We have made above a formal comparison of two approaches. However, we did discover that the two formalisms would produce dierent phase space distributions of lepton pairs: see Fig. 3. Let us now consider the specie case of the DLS data. It is a known fact that

any theoretical calculation attempting to reproduce the DLS data should rest be litered by the DLS experimental acceptance. It is then conceivable that the predictions of the two approaches could be a ected quite dierently by the experimental liter. We have run our two sets of calculations through the DLS experimental liter [23]. In Fig. 5 we show the invariant mass dependence of the absolute dierential cross sections, at kinetic energies 1.0, 3.0 and 4.9 GeV. This gure now suggests that the previous calculations overestimated the low-mass dielectron yields by a factor of 2-3 for np and a factor of 2-5 for pp brem estrahlung in collisions at 4.9 GeV. Thus the elect of the DLS acceptance is to make the dierences between the two approaches more pronounced. The elect is smaller for lower kinetic energies. Definite conclusions for comparison with the data are presently being drawn as many-body brem estrahlung has been shown to be quantitatively in portant at 4.9 GeV. [5]. Even though we feel that a complete reassessment of previous results is probably not warranted, surprises can not be excluded.

A nother useful comparison is the relative radiative intensities of pp and np scattering. As mentioned above, pp brem sstrahlung has often been neglected because of a classical multipole argument. We calculate the ratio here, with the formalism based on the leading-term approximation, i.e. with Eq. (8) and Eq. (4). The relative intensities depend on kinetic energy as shown in Fig. 6 which presents the ratio $R = (\frac{d}{dM^2})_{pp} = (\frac{d}{dM^2})_{pn}$ as a function of invariant mass at dierent kinetic energies. Proton-proton brem sstrahlung becomes more and more important as the kinetic energy increases. At 2 GeV, for instance, R is nearly 0.5 for smallmasses whereas at 4.9 GeV it becomes larger than 1. We shall return to this ratio in the next section.

In all of the above comparisons, we have consistently set q = 0 in the 4-dimensional phase space delta function. We now avoid making this approximation and investigate the consequences. The many-body Lorentz-invariant phase space can be expressed in terms of

On Fig. 7 we display three di erent curves for the cases of pn and pp scattering, at energies of 1.0, 3.0 and 4.9 GeV. We compare calculations done with Eq. (19), calculations done using Ruckl's form ula with the current of Eq. (9), and calculations done using Eq. (8) together with the current of Eq. (4). The three approaches display behaviors that are quite similar and are not really remarkably dierent. The largest deviations occur at the lowest bombarding energies at low M. Recall that the \soft photon limit" is not really properly dened by M. 1.0. Running our results through the DLS acceptance. Iter, in Fig. 8, one realizes that the results obtained with Eq. (19), and those obtained with Eq. (8) together with the current of Eq. (4) are very similar for the pn reactions. The only exception there is the low energy pn spectrum at low invariant masses. In the case of pp, the liter elects are such that the results with the complete phase space are lower than the previous ones at

high invariant masses. The elect of the DLS acceptance brings us to the conclusion that the position of the lepton pairs in phase space is mostly determined by the nature of the electromagnetic current, once the on-shell nucleon-nucleon cross section is xed. The pp=np ratio does however show some sensitivity to the treatment of phase space, as displayed in Fig. 9.

There is no question that the current of Eq. (4) is more general and appropriate for leptons than that of Eq. (9). In a given reaction the di erences in dilepton invariant cross sections, before litering, that follow the use of those two currents are not m inuscule but can not be called spectacular. There is an observable that has a remarkably di erent behavior, whether or not the current (4) is used in calculations. We elaborate more on this in the following section.

V.THE ANGULAR DISTRIBUTION OF BREM SSTRAHLUNG DILEPTONS

We have already mentioned that the nature of the electrom agnetic current for the brem sstrahlung producing hadrons will greatly a ect the position of the leptons in phase space. This already became clear in our analysis of Fig. 3. Thus, it is very reasonable that the dierences in currents could be highlighted in a treatment focusing on the ne points of angular distributions, for example. Angular anisotropies have recently been put forward as a means of distinguishing between competing lepton pair production sources [25]. This argument has power only if the angular distributions of those sources can reliably be calculated. Let's elaborate on this below.

Owing to collision dynamics, the polarization of the virtual photon eventually converting into a lepton pair may be such that, in the rest frame of the dilepton, the single lepton distribution may not be isotropic. This is the essence of the idea. Following [25], we write the dierential cross section for emission of a lepton pair of invariant mass M, with a lepton coming out at a polar angle in the rest frame of the lepton pair as

Since the full phase is obviously crucial to the proper kinem atics, we use the methods of the previous section. The cross section to be used in the de nition of S, above, is obtained by noting that for electron-positron pair production [13],

where q_0 is the lepton pair energy and \sim_+ is the solid angle element for positron emission in the rest frame of the lepton pair. With the help of the above equation, one can numerically integrate Eq. (15) into the required format. In the on-shell approximation we are using for the strong matrix element, where M $_0$ has no dependence on q, the anisotropy coe cient B only depends on kinematics and on the electromagnetic current. Details of the strong interaction do not in uence it. We have numerically con med this by varying the strong interaction differential cross section and observing the constancy of B.

We rst investigate the polar anisotropy of the lepton distribution using the current associated with Eq. (9). The results are shown in Fig. 10. We plot the one cient B as a function of invariant mass, for dierent incident kinetic energies. Those energies are 1, 2, 3, and 5 GeV. They can be readily identified in the gure by their kinematical limit moving to higher invariant mass as the beam energy grows. The calculations are for bremsstrahlung in photolisions. Our results at 1 and 2 GeV reproduce those of Ref. [25]. Repeating the calculation with the full current of Eq. (4), we see our results change drastically, both qualitatively and quantitatively. This is now plotted in Fig. 11. The anisotropy one cients no longer cross zero roughly together at about M = 0.25 GeV. The crossing points have spread out, and an important feature is that the curves have all been shifted upwards. The anisotropy one cients are now mostly positive, except in the high invariant mass region of the last two incident kinetic energies. Also, the minima have been shifted to higher invariant masses. Thus, it is clear that any physical interpretation relying on the angular anisotropy

of the lepton spectrum will thus depend on the details of the calculation. In this observable, the di erences in electrom agnetic currents clearly stand out.


FIG. 12. Sam e caption as Fig. 10, but for pp collisions.

For the case of pp brem sstrahlung, the use of the complete current is absolutely crucial. The current of Eq. (9) is used to compute the polar anisotropy coe cient plotted in Fig. 12. The current of Eq. (4) is used to compute the curves appearing in Fig. 13. The dierence is striking. With the complete current, the pp signal bears some resemblance to its pn counterpart, whereas the current associated with real photons yields a complete dierent picture, both qualitatively and quantitatively.

VI.SUM M ARY

In sum mary, we have used a Lorentz-covariant and gauge-invariant form alism to calculate lepton pair production cross sections via pn and pp brem setrablung, in the leading term approximation. The exact squared current derived for virtual photons is suitable for any energy and for any two-body equalmass system. With the appropriate generalizations one could apply it to an unequalmass system and to reactions involving many-body nal states. This is important and should be done. We not that using the complete current for virtual photons will produce differential dilepton cross sections that are not very different from those obtained using the real photon current. Since the exact virtual photon current changes the momentum distributions of the dileptons, the differences are somewhat accentuated by running the calculations through the DLS acceptance. Iter. However, the different phase space population associated with the different currents emerge in a much more striking fashion when plotting the polar anisotropy coefficient for leptons in the lepton pair rest frame. We feel that the lepton angular anisotropy might in fact be useful in the identification of different sources, but only once the calculations are deemed to possess the required level of reliability and precision.

We do not suggest that the DLS brem sstrahlung analyses have to be completely redone. However, larger dierences in the approaches (the one based on Ruckl's formula and

the Lorentz-covariant one) do show up in the pp channel, comparing with the pn channel. Thus to pin down the various mechanisms for dilepton production more precisely and to compare quantitatively to data, it does seem necessary to scrutinize some of the previous bremsstrahlung estimates, as our results suggest that some of them might have somewhat overestimated the low-mass yields.

The relative brem sstrahlung intensities from pp and pn scattering have been an actively debated issue for some time. We provided a practical and quantitative way to illustrate this, for kinetic energies up to 6 GeV. Our results suggest that pp brem sstrahlung is quite important when the kinetic energy is higher than roughly 2 GeV.

APPENDIX: DILEPTON RADIATION FROM FOUR-FERM ION INTERACTIONS

In this appendix we derive the matrix element for lepton pair radiation for a generic form of the strong four-fermion interaction, where we take all the fermions to be charged for the sake of generality. We shall use and generalize slightly the methods of Ref. [13]. Our results are in agreement with those of that reference.

FIG. 11. Sam e caption as Fig. 10. We use here the current of Eq. (4).






























