Nuclear G luon Shadow ing via Continuum Lepton Pairs in p+A at p = 200 A G eV

The dilepton spectra from open charm decay in p+A reactions at $p = 200 \, \text{AG}$ eV are proposed to constrain gluon shadowing in nuclei. We show that the required measurements are feasible at R H IC.

The spectrum of dileptons produced in heavy ion collisions at high energies has been proposed in the past to provide inform ation about the dynam ical evolution of quark-gluon plasm as (see, e.g., the review by Ruuskannen in ref. [1]). Unlike hadronic probes, that spectrum is sensitive to the earliest m om ents in the evolution, when the energy densities are an order of magnitude above the QCD con nem ent scale (1 GeV/fm 3). However, the small production cross sections for pairs with invariant m ass above 1 GeV together with the large combinatorial background from decaying hadrons necessitate elaborate procedures to uncover the signal from the noise. The PHENIX detector [2], now under construction at the Relativistic Heavy ion Collider (RHIC), is designed to measure ee; e, and pairs to carry out this task. One of the important sources of background in the few GeV mass range arises from sem ileptonic decay of charm ed hadrons (DD). As shown recently in ref. [3], the expected thermalsignals in that mass range may only reach 10% of the number of pairs from open charm decay. Therefore, special kinem atical cuts and precise e measurements will be needed to uncover the therm alsignals [2].

There have been several attempts [4,5] to take advantage of the large open charm background as a probe of the evolving gluon density. Most mid-rapidity charm pairs are produced via gluon fusion [6]. Therefore, the dileptons from charm decay carry information about the distribution of primordial gluons before hadronization. In fact, the inside-outside cascade nature of such reactions greatly suppresses [7,8] all sources of charm production except the initial perturbative QCD source. Therefore, the open charm background is dominated by the initial gluon fusion (gg! cc) rate.

The initial cc rate depends sensitively on the nuclear gluon structure function [9], g_A (x;Q 2). The quantity of fundam ental interest [10,11] is the gluon shadow ing function

The point of this Letter, is to show that the A dependence of continuum dilepton pairs in the few GeV mass region provides a novel probe of that unknown gluon structure. We also show that the required measurements of ee,e,

and pair yields in p + A ! " X at " = 200 AG eV are not only experimentally feasible at RHIC but also that the open charm signal can be easily extracted via the proposed PHENIX detector.

A key advantage of the continuum dilepton pairs from open charm decay over those from J= decay is that it is possible to test the applicability of the underlying QCD dynamics at a given xed so by checking for a particular scaling property discussed below. In quarkonium production the mass is xed and the required scaling can be checked only by varying the beam energy. In p+A ! J= production the required scaling was unfortunately found to be violated in the energy range $20 < \frac{5}{s} < 40 \text{ AG eV}$ [12] thus precluding a determ ination of RA. Possible explanations for the breakdown of QCD scaling for J= production and its anom alous negative x_F behavior [9,12] include interaction of next-to-leading order quarkonium Fock state with nuclearm atter [13], nuclear and com over J= dissociation [14], and parton energy loss m echanism s [15]. It remains an open question whether the required scaling will set in at RHIC energies 60 <

Shadowing of the quark nuclear structure functions, $q_A(x;Q^2)$, is well established from deep inelastic 'A! 'X reactions [16]. For heavy nuclei, the quark structure functions are shadowed by a factor, $R_{\alpha=A}$ (x $0:1 A^{1=3}$, nearly independent of Q^2 . Perturbative QCD analysis [10,11] predicts that the gluon structure will also be shadowed at x < 0.01 due to gluon recombination processes. Therefore, a system atic measurement of gluon shadowing is of fundam ental interest in understanding the parton structure of nuclei. The gluon nuclear structure is also of central importance in the eld of nuclear collision since it controls the rate of m ini-jet production that determ ines the total entropy produced at RHIC and higher energies [17]. We focus here on p+A collision rather than A + A to m in im ize the combinatorial ;K decay backgrounds and other nalstate interaction e ects.




FIG. 1. The dilepton dN =dM dy ratio curves (shadowed over unshadowed) at dierent masses obtained via Monte Carlo calculation are compared with the shadowing curves. The upper solid curve is Eskola [19] gluon shadowing for $Q^2 = 10 \text{ GeV}^2$, and the lower solid curve is from HIJING [18]. The ratio curves are plotted as a function of the scaling variable $\log_{10}\,x_{\text{A}}\,$ from eq.(4). The scaled dilepton ratios re ect closely the input shadowing functions.

To demonstrate the sensitivity of open charm dileptons to gluon shadowing R $_{g=A}$ (x;Q 2), we calculate the pair spectrum from open charm decay in p+ Au reactions at 200 G eV/A using for illustration two di erent gluon

shadow ing functions. The rst assum es that gluon shadow ing is identical to the m easured quark shadow ing, i.e. $R_{g=A}$ (x;Q²) = $R_{g=A}$ (x;Q² = 4 G eV²), and is thus essentially Q² independent. This is the default assumption incorporated in the H IJIN G M onte C arbo model [18]. The second is taken from E skola [19], where $R_{g=A}$ (x;Q²) is computed using the modiled G LAP evolution [10] starting from an assumed $R_{g=A}$ consistent with the measured quark shadow ing function at Q² = 4 G eV². This second shadow ing function depends on scale and dilers for q and g. The two shadow ing functions are shown in Fig. 1.

The initial charm pair distribution from B + A nuclear collisions at impact parameter \tilde{b} is computed as in [5]:

where $_{a=A} (x;Q^2;r) = T_A (r)f_{a=N} (x;Q^2)R_{a=A} (x;Q^2;r)$ is the nuclear parton density function in terms of the known nucleon parton structure functions $f_{a=N}$ (x;Q²), the nuclear thickness function T_A (r) = dzn_A ($\overline{z^2 + r^2}$), and the unknown impact parameter dependent shadowing function $R_{a=A}$ (x;Q²;r). The conventional kinem atic variables xa;b are the incoming parton light cone m om entum fractions, \hat{t} = $(p_0 p_1)^2$, and the nalc; chave rapidities y1; y2 and transverse mop. . Next-to-leading order correc $m enta p_{1?} =$ **P**2? tions to the low est order parton cross sections d^ab=dfare approxim ately taken into account by a constant K factor [20,21]. We use the recent MRSA [22] parton structure functions. From a t to low energy open charm production data in pp collisions, we $x m_c = 1.4 \text{ GeV}$, K = 3, $Q^2 = \$ = 2$ for qq! cc and \$ for qq! cc. This choice of param eters leads to a charm pair cross section of 340 b for pp collisions at R H IC . For im pact param eter averaged collisions, the integral over the transverse vector in eq.(2) leads to a factor: $BAR_{b=B}(x_b;Q^2)R_{a=A}(x_a;Q^2) = \frac{BA}{in}$, where $_{\mathrm{in}}^{\mathrm{B}\;\mathrm{A}}$ is the inelastic B + A cross section and R $_{a=A}$ (x_a ;Q 2) is the im pact param eter averaged shadow ing function.

In order to compute the DD pair distribution, a hadronization scheme for c! D must be adopted. In e⁺ e! cc! DDX hadronization can be modelled via string fragmentation or tted for example via the Peterson fragmentation function (see [23]). The nalD carries typically only a fraction 0:7 of the original cmomentum. However, in pp collisions charm hadronization is complicated by the high density of partons produced during beam jet fragmentation. In this system recombination or coalescence of the heavy quark with comoving partons provides another mechanism which in fact seems to be dominant at least at present energies. The inclusive pp! DX data is best reproduced [3,24] with the delta

function fragmentation D (z) = (1 z) in all observed x_f and moderate p_T regions. This observation can be understood in terms of a coalescence model if the coalescence radius is P_c 400 M eV . We assume that hard fragmentation continues to be the dominant mechanism at RHIC energies, and hence no additional A dependent elects due to hadronization arise. However, this assumption must be tested experimentally. Our main dynamical assumption therefore is that the pp! Distransverse momentum distributions can be accurately reproduced from the QCD level rates assuming hard fragmentation as at present energies [24]. At RHIC this can be checked either via single inclusive leptons [2] or directly via K [25].

W ith this assumption, the impact parameter averaged DD pair distribution in p + A is given by

From this distribution of charm ed m esons, we computed the dilepton spectrum via M onte C arlo using JETSET7.3 [26] to decay the D D .

W hile the lepton pair m ass M and rapidity y uctuate around a mean value for any xed M $_{\rm cc}$ and y $_{\rm cc}$, on the average hyi hyci, and hM $_{\rm cc}$ i can be well approximated by a linear relation hM $_{\rm cc}$ i M + M $_{\rm 0}$ over the lepton pair m ass range 1 M 4G eV . For the delta function fragmentation case, 1:5 and M $_{\rm 0}$ 3:0 G eV are determined by the D-m eson decay kinem atics.

Since gluon fusion dom inates, there is an approxim ate scaling in terms of the light cone fraction x_A that one of the gluon carries from nucleus A:

The ratio of the dilepton dN =dM dy spectra in pA to scaled pp for di erent pair m asses is thus expected to scale approxim ately as

where A $_{\rm in}^{\rm pp}=_{\rm in}^{\rm pA}$ A¹⁼³. In order to test gluon dom inance and the accuracy of the above approxim ate scaling we compare in Fig. 1 the gluon shadowing function to the above dilepton ratio from the Monte Carlo calculation. The solid curves are the input gluon shadowings as a function of the B jorken x. The other six curves are ratios of dilepton dN =dM dy spectra of shadowed p+ Au over those from unshadowed p+ Au as given by eq.(5) as a function of the scaling variable x_A for three di erent dilepton m asses.

O verall, the scaled ratio of lepton pair spectra approxim ates the shadowing function remarkably well. We conclude that this ratio can therefore serve to map out gluon shadowing in nuclei. Note that in the case of Eskola shadow ing, even the Q² dependence of the shadow ing function is visible through the rise of the ratio curves with M in the small x region.

Finally, it is important to estimate the dilepton background to see if the proposed signal is experim entally feasible. Therefore we also calculated the signal and background dileptons for the PHEN IX detector [2] taking into account the detector geom etry and specic kinem atical cuts. The electron background is mainly due to 0 Dalitz and photon conversions. The background muon arises from random decays of charged pions and kaons. The electrons from OD alitz decay can be suppressed by sm all angle cut on dielectrons [27], and the background m uons are mainly suppressed by reducing the free decay volume. For the detector geometry, the electron arms cover pseudo-rapidity range 0.35 < e < 0.35, and azim uthal angle range (22.5;112.5). The muon arm covers pseudo-rapidity range 1:15 < < 2:44 and alm ost full azim uthal angle. For the kinem atical cut, we take $E_e > 1$ GeV, E > 2 GeV, and require that the relative azim uthal angle of the lepton pair + > 90 in order to improve the signal-to-background ratio.




FIG. 2. Charm signal and backgrounds coming into the detector are plotted as a function of the lepton pair rapidity y. The solid curves are the signals from open Charm decay labeled CC signal. The label C refers to the lepton coming from open Charm decay, labelD refers to the electron coming from Dalitz and photon conversion, and label R refers to the muon com ing from Random decay of pions and kaons. In (a), the dielectron backgrounds are the dashed curve D C and the dot-dashed curve DD; and both are scaled up by a factor of 100. In (b), the opposite-sign e backgrounds are the dotted curve CR, the dashed curve DR, and the dot-dashed curve DC. In (c), the dim uon backgrounds are the dashed curve RR and the dot-dashed curve RC.

For this background study, we use central p + Au collision with HIJING shadowing. We calculate the ee, e, signal and backgrounds com ing into the detec-

tor, where the background electrons and muons are generated from HIJING Monte Carlo calculation. We nd (see Fig. 2) that the signal-to-background ratio for ee is very large, thus the dielectron signal from open charm decay is the easiest to extract. That ratio falls to about 2.5 fore, and about 1/4 for . The pair rapidity distributions of the signal and backgrounds for centralp + Au collision are shown in Fig. 2. Due to the detector geom etry, ee, e, and spectra cover pair rapidity regions centered at about 0, 1, and 2 (0 ne can also study Au + p collision and measure pair rapidity regions centered at channel. W e

2). Like-sign subtraction [28] should signi cantly reduce the noise, especially in the conclude that the proposed m easurem ent is feasible.

Further details of the calculations will be reported elsewhere [29]. For example, the Cronin e ect and energy loss are estimated to lead to distortions up to 10% at RHIC energies. From studies of the nuclear dependence of transverse m om entum of J= production, the typical increment, of (A), due to multiple collisions is limited to 0:34 GeV² even for the heaviest nuclei [30]. This momentum spread is shared between the c and c, and distributed approximately as g(p_?) = e $p_?^2 = ^2 = ^2$, 2 0:17 GeV². For energy loss, we assume that the charm quark loses an energy E in the lab frame, and the charm quark p_? is reduced by (1), where = E = [p_i sinh (y + y₀)]. Combining these twoeects, we may write for the charm quark that the nal p_? = (p_?^{mi+} + ~p_?)(1). Therefore the D_Rm eson spectrum F (p_?) $d^N = dm_?^2$ becomes F 0 (p_?) = F (p_?^{mi+})g(p_?)d~p_?. Taking F (p_?)/e p ?, r 1:3 GeV 1 from H IJIN G, and expanding the convolution to lowest order, the relative change of the D-m eson spectrum is given by

This is also the relative change of the cc pair spectrum when M $_{\text{cc}}$ = 2m $_{?}$ in case of y_1 = y_2 , $p_{?\,1}$ = $p_{?\,2}$. For m $_{?}$ 3G eV , E = 10G eV , $\cosh y$ ' 100, the relative change in the pair spectrum is estimated to be F $^0(p_?)$ =F $(p_?)$ ' 1 0:1(e y 1).

In sum m ary, we calculated the lepton pair spectra from open charm decay in two di erent shadow ing scenarios. By scaling the ratios for di erent m ass ranges according to eq.(5), we showed that the dilepton rapidity dependence of those ratios on $x_{\rm A}$ reproduces well the underlying gluon shadow ing function de ned in eq.(1). Finally we showed that the measurem ents required to extract the gluon shadow ing are experimentally feasible at RHIC. The above analysis depends on the validity of our basic assumption regarding the hard fragmentation of charm quarks, and this can be checked explicitly via the single inclusive measurements of D production.

We conclude by emphasizing the importance of determining gluon shadowing in p+A to x theoretically the initial conditions in A+A. In A+A the open charm decay is regarded as an annoying large background that must be subtracted to uncover the thermal signal. In p+A that background becomes the signal needed to determine the incident gluon ux in A+A. The continuum charm dileptons in p+A at RHIC are likely to provide a unique source of information on the low x_A nuclear gluon structure at least until HERA is capable of accelerating heavy nuclei.
