A bstract

The optimized -expansion is used to study vacuum polarization e ects in the W alecka model. The optimized -expansion is a nonperturbative approach for eld theoretic models which combines the techniques of perturbation theory and the variational principle. Vacuum e ects on self-energies and the energy density of nuclear matter are studied up to 0 (²). When exchange diagrams are neglected, the traditional R elativistic H artree Approximation (RHA) results are exactly reproduced and, using the same set of parameters that saturate nuclear matter in the RHA, a new stable, tightly bound state at high density is found.

A lthough hadrons are not elementary particles, the use of renorm alizable relativistic quantum eld models em ploying pointlike hadrons, such as the W alecka model [1], for studying the properties of hadronic matter at high density and/or tem perature is im portant in several aspects. Perhaps one of the most in portant aspects is the necessity of understanding the vacuum of such models, since one expects that the description of highly excited matter in terms of such models must breakdown at some scale and then quark-gluon degrees of freedom must be invoked for a proper treatment of the system. Quantum uctuations in the Waledka model have been studied at the Hartree level [2], but severe di culties arise when nonperturbative exchange diagram s (Fock diagram s) are considered. A lthough Biela jew and Serot [3] have set up an appropriate fram ework for the renorm alization of the Hartree-Fock (HF) equations, no explicit calculation em ploying this has been performed so far. Bearing in m ind the di culties associated with the renorm alization within the HF approximation we give in this Letter the rst step towards the in plementation of a di erent nonperturbative approach for studying vacuum uctuations in hadronic models. Namely, we use the expansion [4]; more speci cally we use the optimized linear -expansion [5].

The standard application of the linear -expansion [5, 6, 7] to a theory with action S starts with an interpolation de ned by

where $S_0()$ is the action of a solvable theory. The action S() interpolates between the solvable $S_0()$ (when = 0) and the original S (when = 1). Since S_0 is quadratic in the elds, arbitrary parameters () with mass dimensions are required for dimensional balance. The evaluation of a physical quantity P is performed by considering the term

 $[S \quad S_0()]$ as a perturbation whose order is labeled by which is set to unity at the end. In practice, the perturbative expansion in powers of will be truncated at a given order in plying that the quantity P will have a residual dependence on the unknown parameters. Since does not belong to the original theory it will have to be xed according to some criterion and di erent methods have been proposed. Am ong them the Principle of M inim al Sensitivity (PM S) [8] o ers a particularly attractive way of optim izing the theory by requiring P () to be evaluated at the point where it is less

sensitive to small variations of : (P ()=0 = 0. W) it this variational procedure becomes a function of the original parameters of the theory yielding non-perturbative results.

The di erent forms of the expansion have been successfully applied to m any different problems in quantum m echanics, particle theory, statistical physics and lattice eld theory, and its convergence has been recently proved for quantum m echanical problems [9]. M ore recently, the optimized linear -expansion was used for applications in $\frac{4}{4}$, QED and Yang-M ills theories [10]. In a recent paper [7] it was demonstrated that in truncating the expansion at O (²), and neglecting vacuum e ects, one can readily reproduce the results of the standard self-consistent D irac-H artree Fock approximation [2] (in this approximation vacuum e ects are also neglected) for the equation of state of nuclear m atter. In this Letter we go one step further by including vacuum e ects to O (²) and demonstrate that one can reproduce the renormalized energy density of nuclearm atter, a new stable state is found at high density. O ne of the stengths of the -expansion is that one can proceed to beyond leading order with considerably less computationale ort than in the traditional HF approximation since in one deals in this approach with a nite number of Feynm an graphs as in plied by the perturbative nature of the calculation.

W e start with the Lagrangian density of the W alecka m odel [1, 2]:

where represents the nucleon eld operator, and V are respectively the eld operators of the scalar and vector m eson and F = 0 V 0 V. The massive vector eld is coupled to a conserved baryon current, rendering the model renormalizable in 3+1 dimensions. In order to minimize many body elects the term U(;V), which describes mesonic self interactions, was set to zero in the original work of W alecka and we shall keep the same convention here. The Lagrangian density L_{CT} contains all the counterterm s needed to render the model nite which, for the purposes of the present paper, is given by:

W e are primarily interested in studying e ects of vacuum uctuations in nuclear matter. In particular, we will consider the energy per nucleon, which is related to the energy density by:

where j > is the interacting ground-state of nuclear matter, jvac> is the vacuum state (zero density), T⁰⁰ includes the piece corresponding to L_{CT}. The term s E^B, E^s and E^v refer respectively to baryon, scalar-meson, and vector-meson contributions, which are given by:

where $_{m}$ (k); m = s; v are the Fourier transforms of G reen's functions of the K lein-G ordon operator. It is in portant to note that we are not using the nucleon equation of m otion and, therefore, the above expressions di er from the usual ones [2]. The reasons for not using the nucleon equation of m otion w illbe discussed below. The term $sE_{CT}^{B,s;v}$ w ill be considered in renorm alization of the energy density. In obtaining these expressions, we have eliminated the m eson eld operators and V in favor of the nucleon eld operators by integrating the m eson E uler-Lagrange equations.

The problem of calculating the energy density consists therefore in nding the interacting nucleon propagator in medium. The state towards the calculation of the propagator with the expansion is to de ne the interpolated Lagrangian. A coording to Eq. (1), one has:

where M + .N otice that the -expansion interpolation could also have been done in the mesonic sector. However, we have chosen to eliminate the mesonic elds by integrating their equations of motion; in this way mesonic self-energies are automatically taken into account. O focurse, the integration in favor of the nucleon elds can be done only in the absence of mesonic self-interactions N ote that since we have set U (;V) = 0 the mesonic self-interactions appear in L_{CT} only]. This leaves us with only one unknown parameter, , which will be xed by the PMS condition applied to the energy density. In short, one is perform ing a variational calculation of the energy density with an \educated guess" for the nucleon propagator which can be improved perturbatively as higher powers of are considered. Since one is looking for the propagator that leaves the energy stationary, one is not allowed to substitute the nucleon equation of motion in the expression of the energy. We could also interpolate kinetic energy terms, as in Ref. [10], but we prefer to start with the simplest interpolation. Such generalizations will be exam ined in forthcom ing publications.

The fact that the divergent part of a physical quantity P () calculated with this interpolated Lagrangian will be and dependent in plies that the coe cients appearing in the counterterm Lagrangian L_{CT} () will also depend on both parameters. The interpolated L_{CT} () has the same eld-operator structure as the original L_{CT} of Eq. (3), with - and -dependent coe cients. The explicit and dependence is not in portant since this dependence will appear autom atically in the process of xing the value of the coe cients in the renorm alization process.

Next the strategy consists in calculating the interacting propagator, which is obtained by inverting D ysons's equation S¹ (p) = S^{0¹} (p) (p), where the self-energy (p) is calculated as a perturbation expansion in powers of , using for the \non-interacting" propagator, S⁰, the one corresponding to L₀. S⁰ can be split in the usual way as S⁰ (k) = S⁰_F (k) + S⁰_D (k), where S⁰_F (k) and S⁰_D (k) are the Feynm an and density dependent parts for quasi-particles of mass and energy $E = (k^2 + 2)^{1-2}$. Inversion of D yson's equation is standard [2]. First, one notes that the in-medium (p) is of the general form [2]: $(k) = {}^{\circ}(k) = {}^{\circ}(k) + {}^{\circ}(k)$. where E (k) is the single-particle energy, which satis es E (k) = $[E (k) \ ^{0}(k)]_{k^{0}=E(k)}$. Note that we have assumed that the nucleon propagator has simple poles with unit residue. W ithin the approximation scheme we will work in this paper, this assumption is satis ed, as can be seen below.

The renorm alization procedure in the expansion follows closely the usual perturbative renorm alization program, with small, however important, dierences. Hence, in the following we shall repeat some standard textbook material which we feel essential for the appreciation of the dierences. We start with the problem in vacuum ($k_F = 0$), in which case S⁰(k) = S⁰_F(k). We perform our calculations in 2! = 4 2 dimensions using dimensional regularization techniques [11]. To 0 (), the self-energy is simply $_{F}^{(1)}(k) =$, which arises from the bilinear term . To 0 (²), one has in principle tadpole and exchange contributions:

The vector m eson tadpole contribution vanishes after taking the trace and perform ing the integral, whereas scalar-m eson tadpole contains a nite and a divergent part. The renorm alization of this is perform ed using the term $_1()$ from $L_{CT}()$ in Eq. (3). Its contribution to the self-energy is $_1 = _1()g_{s-s}(0)$. In order to produce a stable vacuum, $_1()$ is chosen so as to eliminate the divergent and nite parts. Any nite piece must be canceled, since such a term would contribute to the energy of the vacuum, which in turn could be lowered without bound. The exchange parts of the self-energy are given by:

The renorm alization of the exchange self-energy is carried out with the last two terms of Eq. (3), which contribute to the self-energy as $_{\rm F}^{\rm CT}$ (k) = M $_{\rm c}$ () + $_{\rm f}$ () (& M), and the renorm alized vacuum contribution to the self-energy, $_{\rm F}^{\rm R}$ (k), up to 0 (²) is given by $_{\rm F}^{\rm R}$ (k) = + $_{\rm F}^{\rm (2)exch}$ (k) + $_{\rm F}^{\rm CT}$ (k).

Generally, counterterms are composed of a divergent part which completely eliminates the poles and of an arbitrary nite part which is xed according to a chosen renormalization scheme [11]. Here we shall consider the parameters g_m , m_m and M to be \the" renormalized physical couplings and masses. This choice amounts to the on-mass shell renormalization scheme in which the counterterms remove both divergent and nite contributions from loop corrections to measurable amplitudes. W ithin this renormalization scheme the nite parts of both counterterms are xed by the renormalization conditions:

In principle one can proceed to higher orders in and include, for example, the important vertex corrections. The renormalization at higher orders introduces no extra complications as compared to the usual perturbative renormalization. Instead of going to higher orders, we consider next the problem of the energy density, where new divergencies arise and extra renormalization is required. In order to simplify the discussion, we shall consider here only direct terms and then compare the results with the ones obtained within the RHA.

W hen considering direct terms only, up to 0 (2) one obtains the following relations for the auxiliary quantities de ned in Eq. (8):

From these, one constructs the nucleon propagator which is then used in the expression for the energy density. We start with the baryon contribution to the energy density:

Note that the divergent and nite parts are dimension the usual ones [2] because we have not used the nucleon million of motion. Carrying out the VEV subtraction, the remaining divergencies are eliminated by the counterterm $P_{n=2}^{4}$ (n=n!) n in Eq. (3). Thus, the nite contribution to the baryonic part of the energy density is given by (after taking = 1):

C learly, Eq. (27) adm its two solutions. The one that follows from the vanishing term in curly braces corresponds to the usual RHA self-consistent solution. It is not di cult to show that when this is substituted into the equation for the energy density, one obtains the RHA energy density:

W ith the parameter set [2], $g_s^2 = 62.89$, $g_v^2 = 79.78$, m_s = 550 M eV, m_v = 783 M eV and M = 939 M eV, nuclear matter is saturated at $k_F = 1.42$ fm⁻¹, with a binding energy of 16 M eV per nucleon.

The other solution to Eq. (27) is:

Note that the solutions of this equation are independent of the parameters of the model; the elective nucleon mass depends only on M and k_F . The numerical solution of this equation gives an elective nucleon mass that is an increasing function of the nuclear density. Moreover, when this solution is substituted into the original expression for the energy density, and using the same parameters as the ones of the RHA, we ind a new saturation point for nuclear matter at k_F 5:3 fm⁻¹, which corresponds to a density of approximately 50 times the one of normal nuclear matter, with a binding energy of the order of 570 M eV per nucleon. Of course, if the parameters are changed, these numbers will change. However, we do not pursue the discussion on this further because exchange terms should be included for consistency (they are of the same order in as the direct ones), although one should notice that in all known cases where exchange graphs are included their elections.

W hen one considers the exchange diagram s in the energy density, the renorm alization becom es m ore di cult, but not m ore com plicated than the usual renorm alization in the loop expansion [12]. In particular, if instead of inverting D yson's equation for obtaining the propagator from the self-energy one uses the sam e approach as Chin [13] for treating the exchange diagram s, the renorm alization is indeed sim pli ed.

We have given the rst step towards the implementation of the expansion for studying vacuum elects in elective hadron eld theories. We demonstrated how the renormalization program can be implemented within the expansion. We also calculated the renormalized energy density of nuclear matter at O (²) by neglecting exchange diagrams, and found that the usual RHA approximation is readily reproduced. In addition, a new state of nuclear matter is found from the PMS applied to the renormalized energy density. Concluding, we believe that the results are very encouraging for future investigations concerning the vacuum of hadronic models.
