Chiral Perturbation Approach to the pp $^{\rm 0}$ R eaction N ear Threshold

Abstract

The usual theoretical treatments of the near-threshold pp ! pp 0 reaction are based on various phenom enological Lagrangians. In this work we exam ine the relationship between these approaches and a systematic chiral perturbation method. Our chiral perturbation calculation indicates that the pion rescattering term should be signi cantly enhanced as compared with the traditional phenom enological treatment, and that this term should have substantial energy and momentum dependence. An important consequence of this energy-momentum dependence is that, for a representative threshold kinematics and within the framework of our semiquantitative calculation, the rescattering term interferes destructively with the Bom-term in sharp contrast to the constructive interference obtained in the conventional treatment. This destructive interference makes theoretical cross sections for pp ! pp 0 much smaller than the experimental values, a feature that suggests the importance

of the heavy-m eson exchange contributions to explain the experim ental data.

I. IN TRODUCTION

Recently Meyer et al. [1] carried out high-precision measurements of the total cross sections near threshold for the reaction

These measurements were conmed by Bondar et al. [2]. The early theoretical calculations β {5] underestimate these swave ⁰ production cross sections by a factor of 5. The basic features of these early calculations may be summarized as follows. The pion production reactions are assumed to be described by the single nucleon process (the Born term), Fig.1 (a), and the s-wave pion rescattering process, Fig.1 (b). The -N vertex for the Born term is assumed to be given by the pseudovector interaction Ham iltonian

where g_A is the axial coupling constant, and f = 93 MeV is the pion decay constant. The rst term represents p-wave pion-nucleon coupling, while the second term accounts for the nucleon recoil e ect and makes H₀ \G alilean-invariant". For s-wave pion production only the second term contributes. Since this second term is smaller than the rst term by a factor of $m = m_N$, the contribution of the Born term to s-wave pion production is intrinsically suppressed, and as a consequence the process becomes sensitive to two-body contributions, Fig.1 (b). The s-wave rescattering vertex in Fig.1 (b) is commonly calculated using the phenom enological H am iltonian [3]

The two coupling constants $_1$ and $_2$ in Eq.(3) were determined from the S₁₁ and S₃₁ pion nucleon scattering lengths $a_{1=2}$ and $a_{3=2}$ as

The current algebra prediction [6] for the scattering lengths, $a_{1-2} = 2a_{3-2} = m = 4 f^2 = 0.175m^{-1}$, in plies that only chiral symmetry breaking terms will give a non-vanishing value of the coupling constant $_1$ in Eq.(3). Therefore $_1$ is expected to be very small. Indeed, the empirical values $a_{1-2}' = 0.175m^{-1}$ and $a_{3-2}' = 0.100m^{-1}$ obtained by Hohler et al. [7] lead to $_1 = 0.005$ and $_2 = 0.05$. So the contribution of the $_1$ term in Eq.(3) is significantly suppressed. Meanwhile, although $_2$ is much larger than $_1$, the isospin structure of the $_2$ term is such that it cannot contribute to the 0 production from two protons at the rescattering vertex in Fig.1 (b). Thus, the use of the phenom enological H am iltonians, Eqs.(2) and (3), to calculate the B om term and the rescattering term s illustrated in Figs.1 (a) and (b), gives significantly suppressed cross sections for the pp ! pp 0 reaction near threshold. Therefore, theoretically calculated cross sections can be highly sensitive to any deviations from this conventional treatment. These delicate features should be kept in m ind in discussing the large discrepancy (a factor of 5) between the observed cross sections and the predictions of the earlier calculations.

A plausible mechanism to increase the theoretical cross section was suggested by Lee and R iska [8]. They proposed to supplement the contribution of the pion-exchange diagram, Fig.1 (b), with the contributions of the short-range axial-charge exchange operators which were directly related to heavy-meson exchanges in the nucleon-nucleon interactions [9]. A ccording to Lee and R iska, the shorter-range meson exchanges (scalar and vector exchange contributions) can enhance the cross section by a factor 3{5. Subsequently, Horowitz et al. [10] demonstrated, for the Bonn meson exchange potential, a prominent role of the meson in enhancing the cross section, thereby basically con rm ing the conclusions of Lee and R iska. The possible in portance of heavy-meson exchanges may be inferred from the following simple argument. Consider Fig.1 (b) in the center-of-mass (CM) system with the initial and nal interactions turned o and with the exchanged particle allowed to be any particle (not necessarily a pion). At threshold, $q_0 = m$, q = 0, $p_1^0 = p_2^0 = 0$, so that any exchanged particle must have $k_0 = m = 2 = 70 \text{ MeV}$ and $j_{K} j = \frac{q}{m m_N + (m = 2)^2} = 370 \text{ MeV}/c$, which implies $k^2 = m m_N$. Thus the rescattering process probes two-nucleon forces at distances 0.5 fm corresponding to a typical elective exchanged mass $p m m_N = 370$ M eV. Its sensitivity to the intermediate-range N -N forces indicates the possible importance of the two-body heavy meson axial exchange currents considered by Lee and R iska. The particular kinematical situation we considered here shall be referred to as the typical threshold kinematics.

Meanwhile, Hernandez and O set [11] considered the o -shell dependence of the N swave isoscalar amplitude featuring in the rescattering process, Fig.1 (b). They pointed out that the s-wave am plitude could be appreciably enhanced for o -shell kinem atics pertinent to the rescattering process. We have seen above that, for the typical threshold kinem atics, the exchanged pion can indeed be far o -shell. The actual kinem atics of course may deviate from the typical threshold kinem atics rather signi cantly due to energy-m om entum exchanges between the two nucleons in the initial and nal states, but the importance of the o-shell kinematics for the exchanged pion is likely to persist. Hemandez and O set exam ined two types of o -shell extrapolation: (i) the Ham ilton model for N isoscalar am plitude based on -exchange plus a short range piece [12], and (ii) an extrapolation based on the current algebra constraints. In either case the enhancement of the total cross section due to the rescattering process was estimated to be strong enough to reproduce the experim ental data. A more detailed momentum -space calculation carried out by Hanhart et al. [13] supports the signi cant enhancem ent due to an o -shelle ect in the rescattering process, although the enhancem ent is not large enough to explain the experim ental data. It should be emphasized that Hanhart et al.'s calculation eliminates many of the kinematical approximations employed in the previous calculations.

G iven these developments based on the phenomenological Lagrangians, we consider it important to exam ine the signicance of these phenomenological Lagrangians in chiral perturbation theory (PT) [14,15] which in general serves as a guiding principle for low-energy

hadron dynamics. In the present work we shall describe an attempt at relating the traditional phenom enological approaches to PT. The fact that PT accounts for and improves the results of the current algebra also makes it a natural fram ework for studying threshold pion production. Furthermore, in this low-energy regime, it is natural to employ the heavy-ferm ion form alism (HFF) [16]. The HFF has an additional advantage of allow ing easy comparison with Eqs.(2) and (3).

It should be mentioned, however, that the application of PT to nuclei involves some subtlety. As emphasized by W einberg [17], naive chiral counting fails for a nucleus, which is a loosely bound m any-body system. This is because purely nucleonic interm ediate states occurring in a nucleus can have very low excitation energies, which spoils the ordinary chiral counting. To avoid this di culty, one must rst classify diagram s appearing in perturbation series into irreducible and reducible diagram s, according to whether or not a diagram is free from purely nucleonic interm ediate states. Thus, in an irreducible diagram, every interm ediate state contains at least one meson. The PT can be safely applied to the irreducible diagram s. The contribution of all the irreducible diagram s (up to a speci ed chiral order) is then to be used as an elective operator acting on the nucleonic Hilbert space. This second step allows us to incorporate the contributions of the reducible diagram s. W e may refer to this two-step procedure as the nuclear chiral perturbation theory (nuclear PT). This method was rst applied by Weinberg [17] to chiral-perturbation-theoretical derivation of the nucleon-nucleon interactions and subsequently used by van Kolck et al. [18]. Park, M in and Rho (PMR) [19] applied the nuclear PT to meson exchange currents in nuclei. The success of the nuclear PT in describing the exchange currents for the electrom agnetic and weak interactions is well known [19{21]. The present paper is in the spirit of the work of PMR.

This article is organized as follows: In the next section we de ne our pion eld and the chiral counting procedure. Then in section III we present the two lowest order Lagrangians, discuss their connection to the early works on this reaction and determ ine within certain approximations the num erical values of the elective pion rescattering vertex strength, th.

In section IV we brie y discuss the connection between the transition m atrix for this reaction and the PT calculated amplitude. In section V we present necessary loop corrections to the Born term, and in section VI we calculate the cross section and discuss the various approximations and the uncertainties of the low energy constants in PT.Finally in section VII, after discussing some higher chiral order diagram s, we present our main conclusions.

A work very similar in spirit to ours has recently been completed by Cohen et al. [22].

II. CHIRAL PERTURBATION THEORY

The elective chiral Lagrangian L_{ch} involves an SU (2) matrix U (x) that is non-linearly related to the pion eld and that has standard chiral transformation properties [23]. An example is [24]

In the meson sector, the sum of chiral-invariant monomials constructed from U (x) and its derivatives constitutes the chiral-symmetric part of L_{ch} . Furthermore, one can construct system atically the symmetry-breaking part of L_{ch} with the use of a mass matrix M the chiral transformation of which is dictated by that of the quark mass term in the QCD Lagrangian. To each term appearing in L_{ch} one can assign a chiral order index de ned by

where d is the sum m ed power of the derivative and the pion m ass involved in this term. A low energy phenom enon is characterized by a generic pion m om entum Q, which is small compared to the chiral scale 1 GeV. It can be shown that the contribution of a term of chiral order carry a factor Q = 0, where Q represents either Q or the pion m assm. This suggests the possibility of describing low energy phenom ena in terms of L_{ch} that contains only a manageably limited number of terms of low chiral order. This is the basic idea of PT.

The heavy ferm ion form alism (HFF) [16] allows us to easily extend PT to the mesonnucleon system. In HFF, the ordinary D irac eld describing the nucleon, is replaced by the heavy nucleon eld N (x) and the accompanying sm all component eld "n (x) through the transform ation

where the four-velocity v is assumed to be almost static, i.e., v (1;0;0;0) [25]. Elim – ination of n (x) in favor of N (x) leads to expansion in $0 = m_N$. Since m_N 1 GeV , an expansion in $0 = m_N$ may be treated like an expansion in $0 = ... L_{ch}$ in HFF consists of chiral symmetric monom ials constructed from U (x), N (x) and their derivatives and of symmetry-breaking terms involving M. The chiral order in HFF is defined by

where d is, as before, the sum m ed power of the derivative and the pion m ass, while n is the number of nucleon elds involved in a given term. As before, a term in L_{ch} with chiral order can be shown to carry a factor Q = 1. In what follows, stands for the chiral order

de ned in Eq.(9).

In addition to the chiral order index de ned for each term in L_{ch} , we assign a chiral order index for each irreducible Feynm an diagram appearing in the chiral perturbation series for a multiferm ion system [17]. Its de nition is

where E_N is the number of nucleons in the Feynm an diagram, L the number of bops, and C the number of disconnected parts of the diagram. The sum over i runs over all the vertices in the Feynm an graph, and _i is the chiral order of each vertex. One can show [17] that an irreducible diagram of chiral order carries a factor Q = 1.

In the literature the term $\langle e \ ective Lagrangian"$ (or $\langle e \ ective H \ am \ iltonian"$) is offen used to in ply that that Lagrangian (or H am iltonian) is only meant for calculating tree diagram s. The H am iltonians given in Eqs.(2) and (3) are regarded as e ective H am iltonians of this type. W emust note, however, that the e ective Lagrangian in PT has a di erent meaning. N ot only can L_{ch} be used beyond tree approximation but, in fact, a consistent chiral counting even dem ands inclusion of every bop diagram whose chiral order is lower than or equal to the chiral order of interest. As will be discussed below, for a consistent PT treatment of the problem at hand, we therefore need to consider loop corrections. However, since the inclusion of the loop corrections is rather technical, we nd it useful to rst concentrate on the tree-diagram contributions. This sim pli cation allows us to understand the basic aspects of the relation between the contributions from PT and the phenom enological H am iltonians, Eqs.(2) and (3). Therefore, in the next two sections (III and IV) we lim it our discussion to tree diagram s. A m ore elaborate treatment including loop corrections will be described in section V.

III.TREE D IAGRAM CONSIDERATIONS

In order to produce the one-body and two-body diagram sdepicted in Figs.1 (a) and 1 (b), we minimally need (see below) term swith = 1 and 2 in L_{ch} . We therefore work with

In L⁽¹⁾ above we have retained only term softdirect relevance for our discussion. The coupling constants $c_1; c_2$ and c_3 can be xed from phenom enology [15]. They are related to the pion-nucleon -term, _N(t) $h_p^0 j_n (uu + dd) j_n (m = average mass of the light quarks, <math>t = (p^0 p^2)$, the axial polarizability _A and the isospin-even N s-wave scattering length $a^+ \frac{1}{3}(a_{1=2} + 2a_{3=2}) = 0.008m^1$ [7]. (The explicit expressions will be given below.) It should be noted that in HFF, a part of the term in L⁽¹⁾ with the coe cient ($c_2 = q_1^2 = 8m_N$), namely the $q_1^2 = 8m_N$ piece, represents the s-wave -N scattering contribution, which in a traditional calculation is obtained from the crossed Born-term .

The four-Ferm i non-derivative contact terms in Eq.(12) were introduced by W einberg [17] and further investigated in two- and three-nucleon systems by van Kolck et al. [18]. A lthough these terms are important in the chiral perturbative derivation of the nucleon-nucleon interactions [17,18], they do not play a major role in the following discussion of the threshold pp ! pp ⁰ reaction. We therefore temporarily ignore these four-ferm ion terms and come back to a discussion of these terms in the last section.

The Lagrangian (11) leads to the pion-nucleon interaction Ham iltonian

Here $H_{int}^{()}$ represents the term of chiral order .

We now compare H_{int} resulting from PT, Eq.(17) with the phenomenological elective H am iltonian H₀ + H₁, Eqs.(2) and (3). (The reader is reminded that the chiral index should not be confused with the sux appearing in H₀ and H₁.) Regarding the NN vertices, we note that the rst term in H⁽⁰⁾ and the rst term in H⁽¹⁾ exactly correspond to the rst and second terms, respectively, in H₀. Thus the so-called G alilean-invariance term naturally arises as a 1=m_N correction term in HFF. As for the NN vertices, we can associate the second term in H⁽⁰⁾_{int} to the ₂ term in H₁, and second term in H⁽¹⁾_{int} to the ₁ term in H₁. This suggests the following identi cations:

In Eq.(20), $q = (!_q;q)$ and $k = (!_k;k)$ stand for the fourmomenta of the exchangedand nalpions, respectively, see Fig.1(b). Since, as already discussed, the ₂ term is not important for our purposes, we shall concentrate on the ₁ term. The best available estimates of the coecients c_i (i = 1-3) can be found in Refs. [15,27], which give

The num erical results are based on the experim ental values: $_{N}$ (0) = 45 8 M eV [28], $_{A}$ = 2.28 0.10m³ [7], and a⁺ = (0.83 0.38) fon ¹ [29]. We shall show in section VI that the uncertainties in the num erical value for c_{2} might be larger than quoted in Eq.(21g). In fact, the term s in Eqs.(21b)-(21g) proportional to the $(g_{A}=f)^{2}$ are 0 ((m =)³) corrections arising from nite term s of L⁽²⁾. However, since the present section is just an introduction to a later system atic treatment, this inconsistency in \accuracy" will be ignored for the moment.

Now, for on-shell low energy pion-nucleon scattering, i.e., k q (m;0), we equate

We now interpret these results in terms of $_1$ of Eq.(3). Conventionally, $_1$ is determined from Eq.(4a) which is the rst term in Eq.(26). Thus

or $_1 = 0.005$ 0.002. This is the \standard value" used in the literature [7,30]. On the other hand, the rh.s. of Eq.(22) based on PT gives from Eq.(28)

which is about twice as large as the conventional value. This means the second term in Eq.(26) is almost as large as the rst term. Thus PT leads to a substantial modi cation of the commonly used formula, Eq.(4a) or Eq.(29). This large higher chiral order" corrections due to L⁽²⁾ [the term proportional to $(g_A = f)^2$ in Eq.(26)] indicates that PT does not converge very rapidly in this particular case. This apparent lack of convergence is probably due to the fact that the rst terms in expansion, the -N isoscalar scattering length a^+ , is exceptionally sm all.

To develop further the connection between the traditional and the PT approaches, we return to a discussion of Eq.(20). Obviously, the constant $_1$ cannot be fully identied with (k;q) which depends on the momenta q and k. In fact, the momentum dependence of (k;q) should play a signi cant role in describing the physical pion-nucleon elastic scattering

process where $!_q = \frac{q}{m^2 + q^2}$, $!_k = \frac{q}{m^2 + k^2}$. An additional crucial point in the present context is that, in the rescattering diagram Fig.1 (b), the exchanged pion can be far o -shell, and therefore the q and k dependence in (k;q) may play an even more pronounced role. As an illustration, let us consider again the typical threshold kinematics discussed in the introduction: q (m;0) and k $\frac{1}{2}$ m; $\frac{p}{m}$ m_N). If we denote by the the value of (k;q) [Eq.(20)] corresponding to the typical threshold kinematics, we have

Thus the strength of the s-wave pion-nucleon interaction here is much stronger than the on-shell cases, see Eqs.(30) and (31), and the sign of the o -shell coupling strength is opposite to the on-shell cases. The instificature is qualitatively in line with the observation of H emandez and 0 set [11] that the rescattering term should be larger than previously considered. However, the sign of the typical o -shell coupling in our case [Eq.(33)] is opposite to the one used in Ref. [11]. A swill be discussed later, this ip of the sign drastically changes the pattern of interplay between the B om and rescattering term s. W e must emphasize that the o -shell enhancement depends strongly on the values of c_1 ; c_2 and c_3 , which, as discussed in Ref. [15,27], are not known very accurately. It is therefore in portant to exam ine to what extent the existing large am biguities in c_1 ; c_2 and c_3 a ect the o -shell enhancement of the pp ! pp ⁰ reaction. W e shall address this question in section V I.

IV.TRANSITION OPERATORS FOR pp $^{\rm 0}$

As explained earlier, in the nuclear PT we rst use PT to calculate the contributions of the irreducible diagram s. Let T represent the contributions of all irreducible diagram s (up to a specified chiral order) for the pp ! pp 0 process. Then we use T as an elective transition operator in the H ilbert space of nuclear wavefunctions. Consequently, the twonucleon transition matrix element T for the pp ! pp 0 process is given by

These distorted waves should be obtained by solving the Schrödinger equation with nucleon-nucleon interactions generated by irreducible diagram s pertinent to nucleon-nucleon scattering, thereby incorporating an in nite number of \reducible" ladder diagram s. In this section we concentrate on the derivation of the transition operator T, relegating the discussion of T and Eq.(34) to section VI.

where T⁽⁾ represents the contribution from Feynm an diagram s of chiral order , as de ned in Eq.(10). The lowest value of occurs for the Born term shown in Fig.2 (a). For s-wave production at threshold the N N vertex with = 0, the rst term in Eq.(17), cannot contribute; hence the lowest for N N vertex involving an external pion must be = 1. The rst term in Eq.(18b) provides this vertex. A coording to Eq.(10), the chiral order of Fig.2(a) is given by = 4 2 2 2 + 20 + 1 = 1: A s can be checked easily, there are no diagram s with = 0 since in the rescattering diagram, Fig.2 (b), the second term in Eq.(18a), which gives the N N vertex with = 0, is not operative here due to the isospin selection rule. The rescattering diagram in Fig.2 (b) with the indicated value of at eachvertex contributes to T⁽⁼¹⁾. It should be noted that because of the 2C term in the chiral counting expression, Eq.(10), exchange-current-type diagram s such as Fig.2 (b) give higher values of \cdot In this work we truncate the calculation of the transition operator T at = 1: Thus,

The above enumeration is, as brie y discussed in section III, far from complete because loop diagrams and counter terms and nite terms from L⁽²⁾ have been left out. In Fig.3 we show the loop corrections to the Born term [Fig.2 (a)]. The diagram s in Fig.3 allhave = 1 and hence are of the same chiral order as the leading order rescattering diagram, Fig.2 (b). A s discussed earlier, for the pp ! pp ⁰ reaction at threshold the contribution of the Born term is numerically suppressed so that the rescattering diagram, which is form ally of higher chiral order by two units of , plays an essential role. This is plies that a meaningful and consistent PT calculation of this reaction must include the loop corrections to the leadingorder Born term. However, we continue to postpone the discussion of loop corrections to the next section.

The tree diagram s contributing to Eq.(36), F igs2 (a) and 2 (b), are as follows. The Bom term, F ig2 (a), contributes to T $^{(1)}$ and the rescattering term, F ig2 (b), contributes to T $^{(1)}$. These contributions are given, respectively, by

V.LOOP DIAGRAM S

We have emphasized above that the loop corrections to the Born diagram, Fig 2 (a), which has chiralorder = 1, are of the same chiralorder = 1 as the two-body pion rescattering process, Fig 2 (b). These loop corrections therefore must be included in a consistent = 1 calculation.

For our present purposes it is not necessary to go into a general discussion of the renormalization of the parameters in L_{ch} . Instead we concentrate on an estimation of the size of

the nite loop corrections to the speci c tree level term s shown in Fig.2. This will be done by applying standard Feynm an rules and using dimensional regularization [15]. Speci cally, we only need consider the loop corrections to the single ^{0}NN vertex in the s-wave channel:

The two contributions to V, Eqs.(40c) and (40d), originate from two di erent combinations of term s in Eqs. (18). To calculate Eq.(40c), the second term in Eq.(18a) and the rst term in Eq.(18b) are used at the vertices, whereas Eq.(40d) is calculated using the rst term of Eq.(18a) and the second term of Eq.(18b).

The standard renorm alization consists in the following procedure:

The amplitude V_3 contains energy-independent and energy-dependent parts, as can be seen in Eq. (40). The energy-independent part can be absorbed in the renormalization of the following physical parameters: the pion wave function renormalization factor Z [Fig.3(e)], the nucleon mass m_N and the nucleon wave function renormalization factor Z_N [(Fig.3(f)], as well as the axial coupling constant g_A [Figs.3(a),(b),(e),(f)]. For the evaluation of the energy-dependent part we use the typical threshold kinematics: vq = m, $vp_1 = m$, $vp_2 =$ 0. Putting these values into the corresponding terms in eq. (40), we obtain as the total contribution of the diagram s in Fig.3

Thus $V_3 f^{\text{in ite}}$ amounts to 10% of the Born term [Fig2(a)]. In addition we have nite contributions from the counterterms of L⁽³⁾, $V_{\text{ct:}}f^{\text{in ite}}$. We note that only very few of the bw energy constants in the counterterms $D_i f^{\text{in ite}}()$ are known [15]. Some of the low energy constants in L⁽²⁾, $B_i f^{\text{in ite}}()$ have been estimated in Ref. [15] assuming resonance saturation. The result indicates $B_i f^{\text{in ite}}()$ 0 (0:1). For an estimate of the low energy constants $D_i f^{\text{in ite}}()$ in L⁽³⁾ it seems reasonable to assume that they are of the same order of m agnitude as the $B_i f^{\text{in ite}}()$ in L⁽²⁾. To be conservative let us assume $D_i f^{\text{in ite}}()$ 0 (1); then we expect $V_{\text{ct:}} f^{\text{in ite}}$ 0:1. It is clear that, if those coe cients were \unreasonably large", the convergence of the whole chiral series would be destroyed.

A logether, after renormalization the total contributions from the loop terms are expected to amount to at most 20% of the Born term. This is not a completely negligible contribution in the present context because, as will be discussed in the next section, there can be a signi cant cancelation between the Born and the rescattering terms. Nevertheless, since our present treatment involves other larger uncertainties, we will neglect the renormalization of the Born term and henceforth concentrate on the bare Born term [Fig.2(a)] and the rescattering term [Fig.2(b)].

VI.CALCULATION OF THE TW O-NUCLEON TRANSITION MATRIX

We derived in section IV the elective transition operator T arising from the tree diagrams and, in section V, we estimated the additional contributions due to the loop corrections and

presented an argument for ignoring the loop corrections in this work. These considerations lead to the HFF expression of T up to order = 1, given in Eqs.(36) and (37), and this T is to be used in Eq.(34) to obtain the two-nucleon transition matrix T.

A form ally \consistent" treatment of Eq.(34) would consist in using for $j_{i}i$ and $j_{f}i$ two-nucleon wave functions generated by irreducible diagrams of order up to = 1. A problem in this \consistent" PT approach is that the interm ediate two-nucleon propagators in Figl can be signi cantly o -m ass-shell, which creates a di culty in any PT calculation. A nother more practical problem is that, if we include the initial- and nal-two-nucleon (N -N) interactions in diagram s up to chiral order = 1, these N -N interactions are not realistic enough to reproduce the known N -N observables. A pragmatic rem edy for these problem s is to use a phenom enological N -N potential to generate the distorted N -N wavefunctions. Park, M in and Rho [21] used this hybrid approach to study the exchange-current in the n + p ! + d reaction and at least, for the low -m om entum transfer process studied in Ref. [21], the hybrid method is known to work extrem ely well.

Apart from the above-m entioned problem, there is a delicate aspect in the derivation of an elective two-body operator from a given Feynman diagram. Ordinarily, one works with r-space transition operators acting on r-representation wavefunctions, for the nuclear wavefunctions are commonly given in this representation. To this end, a Feynman am plitude which is most conveniently given in momentum space, is Fourier-transformed into the r-representation. This method works best for low momentum transfer processes which have substantial transition am plitudes for on-shell initial and nal plane-wave states. However, the pp ! pp ⁰ reaction at threshold does not belong to this category. For this reaction it is essential to recognize that the nucleon lines that appear as external lines in Fig.2 are in fact internal lines in larger diagram s illustrated in Fig.1. These internal lines can be far o -shell due to the initial- and nal-state interactions. Indeed without this o -shell kinem atics, the Born term [Fig.2 (a)] would not contribute at all ! In the conventional approach, how ever, one ignores this feature in deriving T in coordinate representation. For example, in Fourier-transform ing an operator of the type of T_{+1}^{Res} , Eq.(37b), even though p_i and p_{-1}^0

in Eq.(37b) in fact can be anything due to momentum transfers caused by the initial and nalN-N interactions, it is a common practice to keep the energy of the propagating pion xed at the value determined by the asymptotic energies of the nucleons. Hanhart et al. [13]m ade a critical study of the consequences of avoiding these kinematical approximations. They worked directly with the two-nucleon wavefunctions in momentum representation. In the present work we do not attempt at detailed momentum space calculations and simply use the \conventional" Fourier transform method. Because of this and a few other approximations adopted, the numerical work presented here is admittedly of exploratory nature. Nonetheless, as we shall show, our sem iquantitative study of T based on the chiral-theoretically motived transition operator T provide som e valuable insight into the dynam ics of the threshold pp ! pp ⁰ reaction.

Let us denote the contribution of Fig2(b) for plane-wave initial and nal states by $\langle p_1^0; p_2^0; qT^{(1)} \dot{p}_1; p_2 \rangle$. We is calculate this matrix element for the typical threshold kinem atics described earlier; for the meson variables, q = (m; 0) and k = (m = 2; k) with $\dot{k} j = \frac{p_{m-m_N}}{m_N}$. Correspondingly, the coupling strength (k;q) Eq.(37b)] is taken to be $t_h = 1.5 \text{GeV}^{-1}$ Eq.(33)]. Subsequently, by liberating the momentum variables $p_1, p_1^0, p_2, \text{ and } p_2^0$ from the on-mass-shell conditions ($p_1^2 = m_N^2; :::$), we treat $\langle p_1^0; p_2^0; qT^{-(1)} \dot{p}_1; p_2 \rangle$ as a function of $p_1, p_1^0, p_2, \text{ and } p_2^0$. Let T ($p_1^0; p_2^0; p_1; p_2$) stand for this function. We still require momentum conservation at each vertex, which in poses the conditions $p_1 + p_2 = p_1^0 + p_2^0 + q = 0$, and $k = p_1^0 - p_1 = p_2$ p_2^0 . T ($p_1^0; p_2^0; p_1; p_2$) can be easily Fourier transform ed to give T_{+1}^{Res} in r representation. The sim pli ed treatment described here, which is commonly used in the literature, shall be referred to as the xed kinem atics approxim ation.

Now, in the xed kinematics approximation, T [Eqs.(36), (37)] is translated into dierential operators acting on relative coordinate of the two-nucleon wavefunctions:

From this point on, our calculation of T follows exactly the traditional pattern described in the literature. Thus T is evaluated by inserting the transition operators, T_1^{Bom} and T_{+1}^{Res} , Eq.(51), between the initial and nalnuclear states

Under the approximation (56), the energy dependence of the cross section is solely given by I (E_f), which incorporates the phase space and the nal state interaction e ect (in the W atson approximation [31]).

We have calculated the integrals J_1^{Bom} and J_{+1}^{Res} for representative nuclear potentials: the H am ada-Johnston (H J) potential [32], and the R eid soft-core potential (R SC) [33]. The results are given in Table I, and the corresponding cross sections are presented in Table II. These results indicate that, for the nuclear potentials considered here, the value of jJ j is m uch too sm all to reproduce the experim ental cross section. If we de ne the discrepancy ratio R by

with $_{tot}^{exp}$ taken from Ref. [1], then R = 80 (R = 210) for the Ham ada-Johnston (Reid soft-core) potential, and R happens to be almost constant for the whole range of E_f 23 MeV for which $_{tot}^{exp}$ is known. Thus, although the o-shell behavior of the s-wave pion scattering amplitude derived from the chiral Lagrangian does enhance the contribution of

the rescattering process over the value reported in the literature, the sign change that occurs in as one goes from $_0$ [Eq.(22)] to the Eq.(32)] results in a significant cancelation between the Born term J_1^{Born} and the rescattering term $J_{\pm 1}^{Res}$, leading to the very small cross sections in Table II [34]. The drastic cancelation between J_1^{Born} and $J_{\pm 1}^{Res}$ found here means that the calculated cross sections are highly sensitive to the various approximations used in our calculation and also to the precise values of the constants $c_1; c_2$ and c_3 of Eq.(21). We will discuss these two questions in the next two paragraphs.

We adopted the threshold kinematics approximation and neglected the energymomentum dependence in Eq.(20) and treated the vertices in Figs.1 and 2 as xed numbers, i.e., $(k;q) = _{th} = constant$. In addition, although the loop corrections of chiral order = 1, shown in Fig.3 (a), automatically introduces energy-momentum dependent vertices, we ignored this feature. The fact that the kinematics of the reaction Eq.(1) requires highly o -shell vertices leads to the expectation that the vertex form factors can be very in portant and invalidate the threshold kinematics approximation leading to Eq.(51). In this connection we note that a momentum -space calculation [13], which is free from this approximation, indicates that even a negative value of _1 could lead to the moderate enhancement of the cross section.

The strong cancelation between the Born and rescattering terms also means that, even within the framework of the xed kinematics approximation, the large errors that exist in the empirical value of a^+ and the $c_1;c_2$ and c_3 constants can in uence the cross sections significantly. To assess this in uence, we rewrite Eq.(32) as

We note that this value is larger than the one given in Eq.(21g), indicating that the determ ination of c_2 requires further studies. With the new value of the given in Eq.(64) we not that the discrepancy ratio R [Eq.(59)] can be as small as 10. (In this case $jJ_{+1}^{\text{Res}}j > jJ_{1}^{\text{Bom}}j$ the exact cancelation between the Bom and the pion rescattering term occurs for the 2G eV¹.)

W ithout attaching any signi cance to the detailed numbers above, we still learn the extrem e sensitivity of $\frac{calc}{tot}$ to the input parameters and that, despite this high sensitivity, $\frac{calc}{tot}$ still falls far short of $\frac{exp}{tot}$ (w ithin the fram ework of the xed kinem atics approxim ation).

In this work we have used PT to calculate the elective pion-exchange current contribution to the pp ! pp ⁰ reaction at threshold. As stated repeatedly, our aim here is to carry out a system atic treatment of T up to chiral order = 1 [see Eq.(36)]. However, in order to make contact with the expressions appearing in the literature [3], let us consider a very limited number of = 2 diagram s. To be specific, we consider a diagram in Fig.2 (b) but with the = 0 (p-wave) NN vertex replaced with a = 1 (s-wave) vertex. Then, instead of Eq.(51b), we will obtain

which is the two-body transition operator used in Ref. [3]. Thus, we do recover the usual phenom enological parameterization in PT, but this is just one of many = 2 diagrams. Our systematic = 1 calculation excludes all = 2 diagrams.

We have also ignored the exchange current contributions from scalar and vector twonucleon exchanges. Following the PT of Refs. [17,18] the vector meson exchange is largely accounted for via the four-nucleon contact terms illustrated in Fig.4 (a). If we had retained the last two terms of Eq.(12), the pion-nucleon interaction $H_{int}^{(1)}$, Eq.(18b), would have had an additional piece $H_{int}^{(1)^0}$

The H $_{int}^{(1)^0}$ term of Fig.4(a) has a q structure, which means it describes p-wave pion production and therefore does not contribute to the threshold pp ! pp ⁰ reaction. The s-wave pion production contact term, also belonging to the type of diagram illustrated in Fig.4(a), enters as a $\frac{1}{m_N}$ recoil correction to H $_{int}^{(1)^0}$ and therefore is of chiral order = 2. Form ally, the chiral order = 2 diagram s have no place in the present calculation limited to = 1. However, in view of the great current interest in the possible large contribution of the heavy-m eson exchange diagram s, we make a few remarks on the s-wave

= 2 contact terms depicted in Fig.4 (a). We note that the coordinate representation of this contact term contains 3 (r). Meanwhile, in the threshold pp ! pp 0 reaction the initial two-nucleon relative motion must be in p-wave (because of parity) and so its wavefunction vanishes at r = 0. Thus, even in a chiral order = 2 calculation, the contact term Fig.4 (a) corresponding to s-wave pion production will play no role. Including meson boops corrections to these contact terms [an example illustrated in Fig.4 (b)] would smear out the -function behavior, allowing them to have a nite contribution to the threshold pp ! pp 0 reaction. This involves, however, diagram s of even higher chiral order than = 2. Thus, in order to include the strong elective isoscalar-vector repulsion of the N-N forces (! exchange) contained in the four-nucleon contact term s of W einberg's [17] and van Kolck's et al.'s [18] PT description, we have to go to chiral order = 3.

M eanwhile, one m ay picture the \e ective heavy m esons" as generated by multipion exchange diagram s like those illustrated in Fig.5. These diagram s, which necessarily contain loops, represent a very limited class of 3 diagram s. For example, an important part of the e ective scalar exchange between two nucleons involve intermediate - s-wave interaction which requires at least two loop diagram s like Fig.5 (c). Thus, if we are to interpret the heavy-meson exchange diagram s of Lee and Riska [8] in the fram ework of nuclear PT, we must deal with terms with chiral order 3, which at present is beyond practical calculations.

We now recapitulate the main points of this article.

1. Using PT in a system atic fashion we have shown that the contribution of the pion rescattering term can be much larger than obtained in the traditional phenom enolog-ical calculations. This fact itself supports the suggestion of H emandez and O set [11] that the o -shell s-wave pion-nucleon scattering should enhance the rescattering contribution signi cantly. However, the sign of the enhanced rescattering vertex obtained in PT is opposite to that used in R ef. [11], at least for the typical threshold kinem atics

de ned in the text. This sign change in the coupling constant the leads to a destructive interference between the Born and rescattering terms instead of the constructive interference found in Ref. [11]. The signi cant cancelation between these terms give rise to the very small cross section for the near-threshold pp ! pp ⁰ reaction calculated in this work. A lthough our particular num erical results were obtained in what we call the xed kinem atics approximation, these results at least indicate that the large enhancement of $\frac{\text{calc}}{\text{tot}}$ obtained in Ref. [11] is open to more detailed examinations.

- 2. The xed kinematics approximation (which is commonly used in the literature) should be avoided. There are at least two reasons why this is not a good approximation for this reaction: (i) The initial- and nal-state interactions play an essential role in the near-threshold pp ! pp ⁰ reaction; (ii) The theoretical cross section within the framework of the Born plus rescattering terms is likely to depend on the delicate cancelation between these two terms. In a momentum space calculation [13], we can easily avoid the xed kinematics approximation. Such a calculation will allow us to work with full o -shell kinematics, to incorporate the PT form factors in the Born term, and to reduce ambiguities in our calculation down to the level of uncertainties in the input parameters in PT and the chiral counter terms.
- 3. Several works [8,10,13] indicate that the two-nucleon scalar (sigm a) exchange can be very in portant. We gave in the introduction a simple kinem atical argument for its plausibility, and our dynamical calculation (albeit of sem iquantitative nature) seems to indicate the necessity of the sigm a exchange contribution in order to explain the observed cross sections for the threshold pp ! pp ⁰ reaction. It is of great interest to see to what extent an improved PT calculation based on momentum -space representation helps sharpen the conclusion on the necessity of the sigm a exchange diagram. Such a calculation is now in progress. If it is established that the heavy meson exchange diagram s play an essential role in the threshold pp ! pp ⁰ reaction, it seems that we must resort to a modi ed version of PT, for a brute force extension of our

treatment to 2 seems extremely dicult. An attempt to include vector meson degrees of freedoms explicitly can be found e.g. in Ref. [19]. A purely phenom enological approach as used in [8] may also be a useful alternative.









































