Inelastic J= Photoproduction o Nuclei: G luon Enhancement or Double Color Exchange?

Abstract

The nuclear enhancement observed in inelastic photoproduction of J= should not be interpreted as evidence for an increased gluon density in nuclei. The nuclear suppression of the production rate due to initial and nal state interactions is calculated and a novel two-step color exchange process is proposed, which is able to explain the data.

1. Introduction

M easuring inelastic photoproduction of J= o heavy nuclei, A ! J=X, the EMC collaboration [1] and later the NMC collaboration [2] have observed an enhancement of the production rate compared to a proton or a light nuclear target: the experimental ratio of the cross sections per nucleon on tin to carbon exceeds the value one by about 10%. If this enhancement is fully attributed to an enhancement of the gluon density { as the authors of experiment [2] do { the gluon density in heavy nuclei should be larger by a similar value of a few percent, which is perfectly compatible with the theoretical expectations.

This conclusion is dangerous, however, since it neglects initial and nalstate interactions due to the presence of the other nucleons. The data from the E 772 experiment [3] for J= production in proton-nucleus collisions show a suppression, which may be parameterized by A ,where = 0.08. There is no reason, why this kind of initial/ nalstate interaction should not be present in photoproduction. Therefore, the observed enhancement in the Sn=C ratio in ! J= production of the order of 10% has to be seen in the light of an expected 20% suppression due to initial/ nal state interaction. It is theoretically unacceptable to claim that the discrepancy of 30% is attributed to a modil ed gluon distribution. O ther mechanisms have to be looked for. This is the aim of the present paper, which is organized as follows.

In the next section the triple-Regge approach to inelastic photoproduction of charm onium is developed. Since the charm onlium is produced di ractively via Pomeron exchange, we conclude that at x_1 ! 1 the reaction is sensitive to the double-gluon distribution function (sim ilarly as in elastic photoproduction), rather than to the single gluon density [4]. Then, in section 3, the suppression factor for inelastic photoproduction of J= o nuclei is calculated using G lauber's eikonal approximation for the nal state interaction. The form ulas are derived for the rst time. Since G lauber's approximation assumes lack of form ation time we consider the color-singlet model for J= photoproduction in section 4. We demonstrate that contrary to the wide spread opinion the time interval for evaporation of color is quite short, about 1 fm in the energy range of the NMC experiment. Therefore G lauber's model

can be used in this case as well. Inelastic shadow ing corrections to G lauber's approximation are considered in section 5. We demonstrate that this corrections make the nuclear medium substantially more transparent for charmonium: the elective absorption cross section turns out to be only about 60 % of that for J=. In section 6 we present the novel mechanism for diractive photoproduction of charmonium ol nuclei: the photon interacts with a bound nucleon via color-exchange and produces a color-octet state. The pair propagates through nuclear matter and losses energy via hadronization. Then, with another nucleon the color pair exchanges color and converts to a color-singlet state. Such a process leads to J= 's with $x_1 < 1$. Since this mechanism relies upon two interactions at least, its cross section may have an A -dependence with > 1. Interplay of this mechanism with the standard multiple scattering one nicely explains the NMC data.

2. G lauber theory for inelastic J= photoproduction o nuclei

The inelastic photoproduction cross section of a J= on a nucleus can be represented in the form

In this section we derive the nuclear suppression factor S^A within G lauber theory. There are two types of am plitudes which contribute to the inelastic photoproduction of a J=0 nuclei:

I) The incoming photon does not interact in the nucleus until the point with coordinates (b; z) (the impact parameter and the longitudinal coordinate, respectively), where it interacts inelastically, $N \ J = X$, and produces the J = w ith the detected nalmomentum, which leaves the nucleus without inelastic interactions;

II) prior the inelastic interaction at the point (b;z) the photon produces elastically a J= at the point $(b;z_1)$, N ! J= N, with $z_1 < z$. The J= propagates through the nucleus without interaction up to the point (b;z), where it produces the nal J= in the reaction J= N ! J= X.

In both cases the longitudinal momentum transfer at the point (b; z) is so large, $q_{in} (1 x_i)$, that only those am plitudes interfere, which correspond to the inelastic production of the J= with the desired momentum on the same nucleon.

On the other hand, the longitudinal momentum transfer in elastic photoproduction at the point $(b; z_1)$ may be small at high energies,

Therefore the amplitudes corresponding to di erent coordinates z_1 m ay interfere.

A coording to our classi cation of the amplitudes I and II the suppression factor S^A has three term s, S^A = (S^A)₁+ (S^A)₁₂+ (S^A)₂, where the rst and the third term s correspond to squares of the amplitudes I and II, respectively, and the second one is the interference term .

The amplitude I squared provides the following suppression factor

Here $T_z(b) = \frac{R_1}{z} dz^0$ (b; z^0), where (b; z) is the nuclear density normalized to A. The nuclear thickness function is T (b) = $T_{z!}$ (b).

The interference term has a form

This term has a negative sign because the amplitude Π plays the role of an absorptive correction to amplitude I.

To calculate the contribution of the amplitude II squared we can use the results of ref. [10, 11] for quasielastic photoproduction of vector m esons on nuclei, which we should apply to production of the J= prior the point (b;z). However, as di erent from [10, 11], we should include both coherent (sm all q_r) and incoherent (large q_r) interactions of the J= in the nucleus. The result reads,

At high energies, in the lim it q_{el} ! 0 the sum of expressions (4)-(6) simplies very much,

Using the smallness of $_{tot}^{N}$ 5 m b we can expand (6) as S^A $j_{l_{e1}}$ $_{1=R_{A}}$ 1 $\frac{1}{2}$ $_{tot}^{N}$ hT i, where the mean nuclear thickness hT i = A $^{1^{R}}$ d²b T² (b). In the approximation eq. (7) we have kept only the rst order of the expansion parameter $_{tot}^{N}$ hT i, and neglected $_{e1}^{N}$ hT i, which is of the second order. To the same order the low-energy limit eq. (6) leads to S $^{A}j_{l_{e1}}$ $_{1=R_{A}}$ 1 $_{tot}^{N}$ hT i.

Thus, the nuclear suppression factor at high energy turns out to be smaller than that at low energy. This result has a natural space-time interpretation: at high energies a photon may interact strongly via its hadronic uctuations. The lifetime of the cc uctuation of the photon, called coherence time, is t_c $1=q_1$. A uctuation created long in advance propagates and attenuates through the whole nuclear thickness, as is explicitly exposed in (7). On the other hand, at low energy the photon converts to a cc inside the nucleus just prior to the J= production. So the cc pair propagates only through about a half of the nuclear thickness. Such a contribution corresponds to $(S^A)_1$ given by (3). There is, however, a possibility to produce J = "elastically" in N ! J = N prior the inelastic rescattering J = N ! J = X. This correction is suppressed by factor ${}_{el}^{N} = {}_{in}^{N}$ and is also included in eq. (6).

Expressions (3) – (5) give the correct extrapolation between the low-energy eq. (6) and the high-energy eq. (7) lim its and are quite complicated. If one uses the same approximation $_{\text{tot.}}^{N}$ hT i 1 and expands eqs. (3) – (5) in this small parameter up to rst order (compare

with quasielastic photoproduction of J= o nuclei [12, 13]), one nds

where the e ective longitudinal nuclear form factor squared is de ned as

O ne can approximate F_A^2 (q_{el}) quite well using a Gaussian parameterization instead of the more realistic W oods-Saxon form for the nuclear density [14] and obtains F_A^2 (q_{el}) = exp (R_A^2 q_{el}^2)=3, where R_A^2 is the mean squared charge radius of the nucleus [14]. Note that S^A is independent of x₁, therefore this mechanism of nuclear suppression keeps the same x₁-distribution of the cross section as on a free nucleon and cannot account for the data (cf. section 4).

There is another possibility within the standard G lauber approach to produce the J= in two-step process on a nucleus: the photon produces the J= inelastically on one nucleon with a subsequent di ractive scattering of the charm onlum on another nucleon. Inelasticities of these two interactions should be adjusted to provide the desired x_1 for the nal J= . The contribution of thism echanism to the cross section is evaluated in the Appendix and a value of less than 2% is found, which we neglect compared to the main mechanism considered above.

3. Triple-Regge form alism for J= photoproduction.

As soon as the nuclear suppression factor S^A is calculated within G lauber approxim ation, one can predict the nuclear cross section provided that the J= photoproduction cross section on a free nucleon is known. We review brie y in this and the next sections the well accepted m echanism s in order to justify the usage of G lauber m odel and to get a reasonable param eterization for the cross section.




Figure 1: The triple-Pom eron graph for the cross section of the reaction

In the standard triple-Regge form alism (see for instance [5]) the directive inelastic photoproduction of J= is described by the triple-Pomeron graph, depicted in Fig.1.

The corresponding di erential cross section reads

Here x_1 and t are the relative share of the photon light-cone m om entum carried by the J= and the 4-m om entum squared of the produced J=, respectively. _P (t) is the Pom eron trajectory and B_{in}^p is the slope parameter for inelastic J= p collisions. The factor G (N ! J= X) includes the triple-Pom eron coupling as well as the P and the PNN vertices. It can be evaluated using the data from hadronic interactions, assuming factorization of the Pom eron.

The momentum transfer squared t is rather large in N ! J = X, $j_{j_{min}} = M^2 + x_1Q^2$) (1 $x_1 = x_1$, where $x_1 = p^+ = p^+$ ($x_1 = x_1 + 1$) is the fraction of the photon lightcone momentum carried by the $J = . j_{min}$ jm ay reach a few $G \in V^2$ dependent on x_1 . The Pomeron trajectory $_P$ (t) is known to approach the value of 1 at high j_j [6], therefore we take $_P$ (t) = 1.

Combining all the factors we get an estimate for the x_1 -distribution of the inclusive photoproduction of J= on a proton, integrated over transverse momenta

The ective triple-Pomeron constant G (pp ! pX) = 32 m b-G eV is xed by an analysis of data on pp ! pX [5]. The elastic pp cross section and the slope parameter are taken as $_{e1}^{pp} = 8 \text{ m b}$ and B_{e1}^{pp} 10 G eV ². The slope of the p_T-distribution of elastic J= photoproduction is assumed B_{e1}^{N} B_{e1}^{pp} =2, since the slopes are related to the nucleon and the J= form factors respectively. On the other hand, in the inelastic photoproduction of J= the nucleon is destroyed and its form factor does not contribute to the elective slope (the same as in the case of pp ! pX reaction, where the slope B_{in}^{pp} 4 G eV ² [5]). Therefore B_{in}^{N} is only due to the charmonium form factor. It was measured in the EM C experiment [7] to be $B_{in}^{p} = 0.58$ 0.07 G eV ², but the NM C experiment [8] led to $B_{in}^{p} =$ 0.23 0.02 G eV ². For a mean photon energy h i 100 G eV, the elastic photoproduction cross section is (p ! J= p) 12 nb according to the EM C measurements [7], but is

27 nb according to the NMC results [9]. In view of the uncertainties in the measured values of the elastic photoproduction cross section and the inelastic slope we x them at a middle value ($p \mid J = p$) = 20 nb and B $_{in}^{p} = 0.45 \text{ GeV}^{-2}$.




Figure 2: The data from the NMC experiment [2] for inelastic J= photoproduction on protons. The solid curve shows predictions based on the triple-Pom eron phenom enology.

The the cross section form ula (12) is calculated with the parameters given above and is compared with the data from the NMC experiment [9] in Fig.2.A good agreement is found both in shape and normalization.

Note that the triple-Pomeron is known to dominate in the inclusive cross section of pp interaction only at $x_1 > 0.9$ [5]. The nondi ractive RRP triple-Reggeon graphs are important at smaller x_1 . O ZI rule suppresses the RRP term for J= interactions, therefore the triple Pomeron contribution may be important down to lower x_1 . Nevertheless, the triple-Pom eron phenom enology does not necessarily describe the data for $x_1 < 0.8$. Particularly, the longitudinal form factor of the ! J= vertex may substantially diminish the cross section at m id x_1 . Yet we need a parameterization of the data for further applications, and F ig. 2 shows that eq. (12) reproduces the data well down to $x_1 = 0.6$.

U sually the inelastic photoproduction of J= is treated perturbatively, within the so called color-singlet model [4]. In that approach the cross section is predicted to be proportional to the low-x gluon density distribution in the proton. A lthough the Pom eron by de nition includes all possible kinds of perturbative graphs, but the ones of the color-singlet

m odelare not the leading contributions at x_1 ! 1. Therefore the spectrum of J= predicted by the color singlet m odel does not peak at x_1 ! 1, while the triple-P om eron contribution does. The dom inant m echanism com es from the ladder-type graphs with excitation of the proton. C orrespondingly, the cross section is proportional to the double-gluon density, which is approximately equal to the single-gluon density squared.

We conclude that for $x_1 ! 1$ the inelastic photoproduction of $J = cannot be used as a probe for the single-gluon distribution, but it m ight be possible at m id <math>x_1$ -values.

4. Color-singlet m odel

A popular approach to inelastic di ractive photoproduction of J= on a nucleon target is the color-singlet m odel (CSM) [4]. It is somewhat similar to the mechanism suggested in section 6, except that the color-octet cc pair becomes colorless via radiation of a gluon, rather than by means of a color-exchange rescattering.

Radiation of a gluon takes some time, which may be important if the process takes place in a nuclear environment. Indeed, rescatterings of the color-octet corpair may induce additional energy loss, and may result in an elective A-dependence. Therefore we need to understand the space-time pattern of gluon radiation in the CSM.

Som etim es the production of a charm onium in C SM is associated with a two-step spacetim e developm ent: rst the color-octet cc pair is produced, then it propagates and nally converts into a color-singlet state via radiation of a gluon. The second stage is usually assumed to take a long time.

We do not think that such a treatment is possible in view of a principal quantum – mechanical uncertainty: analogous to the standard electrom agnetic brem sstrahlung one cannot say whether the gluon/photon has been radiated before or after the interaction. Both Feynm an graphs contribute to the cross section (actually both are taken into account in perturbative calculations [4]). One can understand this uncertainty as related to the lifetime of a uctuation on the initial particle containing the radiated gluon and the coloroctet cc pair. This lifetim e given by the energy-denom inator equals to

Taking the mass of the cc pair M $_{\rm cc}$ M we get the following expression for the radiation time

This radiation time is only about 1 fm in the kinematical region of the NMC experiment. One can safely neglect an in uence of nuclear medium on the process of hadronization for such a short time interval. Therefore the multiple scattering approach developed in sections 2 can be applied in the case of CSM.

Note that even at very high energies, when t_r becomes long, the elects of induced radiation by the color-octet color-octet and radiation time can be neglected since 2 ind=M² 1, where ind 1 GeV² is the density of energy loss via induced radiation.

5. Beyond G lauber approxim ation

Considering photoproduction of J= in the quark representation one understands that a colorless cc wave packet, rather than a J=, is produced and propagates through the nucleus, but the J= m ay be form ed far away from the nucleus if the energy is high. Due to quark-hadron duality one can consider the same e ects taking into account photoproduction of higher di ractive excitations of the charm onium, ⁰, ⁰⁰ etc., as well as all diagonal and o -diagonal di ractive rescatterings of these states in nuclear matter. The corresponding corrections are know as inelastic shadowing [15]. The simplest, but quite accurate twocoupled-channel approximation including J= and ⁰ was considered in [16]. It was found that the the cc wave packet produced in pp interaction is such a combination of J= and ⁰, which is quite close to the eigenstate of interaction having the minim all possible interaction cross section. This fact explains particularly why J= and experience similar nuclear attenuation (cf. the E 772 experiment [3]).

W e assume that the ratio of the photoproduction amplitudes

where $f^{\rm b}$ is the operator of di ractive amplitude, is close to one. In pp scattering the corresponding value of $R_{\rm pp}$ is measured to be 0.5 (see in [16]). This assumption on $R_{\rm p}$ can be motivated by the similarity of the ∞ components of the wave functions of a photon and of a gluon.

The solution of evolution equation for the cc wave packet propagated through nuclear matter, which incorporates with both e ects of the coherence and form ation lengths will be presented elsewhere [18], but som e num erical results are published in [17]. Here we use the approximation of small $_{tot}^{N}$ hT i 1. Then one can modify the G lauber model expression (8) as follows [17]

is according to eq. (8) the elective nuclear thickness covered by the charmonium, which is controlled by the coherence length $l_c = 1=q_1$ [11], and

is the elective absorptive cross section for charm only , which is controlled by the form ation length for the charm only wave function, $l_f = 1-q_f$, where

is the longitudinalm omentum transfer in the o-diagonal reaction N $^{\circ}$ N .

The new parameter in eq. (19) is

and is estimated in [16] in the oscillator approximation, = $\frac{q}{2=3}$. Remarkably, with these parameters at high energies $_{eff}$ 0:6 $_{in}^{N}$, i.e. the J= attenuates in nuclear matter substantially less than predicts G laubermodel. This may be understood as a natural consequence of color transparency.




Figure 3: The data from the NMC experiment [2] for the ratio of inelastic J= photoproduction rates on tin to carbon, measured with 200 G eV (squares) and 280 G eV (circles) muons. The thin solid and dashed curves correspond to the G lauber-G ribov mechanism for nuclear suppression of J= and = 100 and 70 G eV, respectively. The thick solid and dashed curves show predictions based on the proposed novel mechanism of di ractive interaction with a nucleus at = 100 and 70 G eV, respectively. For the origin of the dividing line at $x_1 = 0.85$ see text.

We calculate ratio of production rates of J= for tin to carbon using eq. (17). The results for = 70 and 100 G eV are plotted in Fig. 3 in comparison with the data from the NM C experiment [2]. We see that the discrepancy with the inelastic photoproduction data ($x_1 < 0.85$) is so large that it is di cult to explain it by a few percent enhancement of the gluon density in heavy nuclei. One has to look for another explanation of the EM C-NM C e ect.

6. Novelmechanism of J= photoproduction in nuclearmatter

A coording to the arguments in section 3 the photoproduction of J= on a nucleon proceeds via Pomeron exchange, which in the language of perturbative QCD can be interpreted as a colorless gluonic exchange, containing at least two gluons in the t-channel. In a nuclear interaction this colorless exchange can be split into two color-exchange interactions with di erent nucleons, keeping the beam and the nuclear remnants in the nal state colorless [21, 22].

The same physics can be represented as a consequence of unitarity: the imaginary part of the elastic forward scattering amplitude of J = 0 on a nucleon is a product of an inelastic J = N amplitude with itselftim e-conjugated (up to sm allelastic and di ractive corrections). In the case of a nuclear target one has to consider also products of two inelastic amplitudes on di erent nucleons.

Thus, the J= photoproduction on a nucleus can result from the photoproduction on a bound nucleon of a cc pair in a color-octet state, which propagates through nuclear matter

bosing energy via hadronization until another color-exchange interaction inside the nucleus converts the pair back to a colorless state. A ctually, this is a speci cQCD mechanism of di ractive excitation of the nucleus. The energy of the J= (and the excitation energy of the nucleus) is less than the photon energy by the amount lost via hadronization by cc pair while it is in the color octet state. We assume a constant energy loss per unit of length dE = dz = 0, what is true both for the color string [23] and for the brem sstrahlung [24] mechanism s of hadronization. In this case we have

where z is the longitudinal distance covered by the cc pair in the color-octet state.

The correction from this mechanism to the cross section for nuclear photoproduction can be calculated as follows

The derivation of this expression includes following ingredients. We assume that the photon energy is su ciently high, M ${}^{2}R_{A}$ = 2 to allow the photon to convert into the ∞ pair long in advance. At the rst interaction point $(b; z_1)$ the cc pair converts into the color octet state, corresponding to the cut Pomeron with cross section $\ _{in}^{\rm N}$. It is important that no $\log i u d i n a l m om entum$ is transferred to the ∞ pair at this point. All the loss of longitudinal m om entum, $(1 x_1)$, is due to the hadronization, until the last interaction at point $(b; z_1)$, where the color octet ∞ pair converts back to the colorless state. This interaction proceeds with the same cross section as the very rst one, except for a factor 1=8 (no sum mation over nalcolors of the cc in this case). We also use the relation $\frac{N}{el}$ = $(_{tot}^{N})^{2}$ =16 B_{el}^{N} , where B_{el}^{N} 5 GeV 2 is the slope of N elastic scattering (see section 3. The -function in eq. (23) takes care of energy-conservation including the energy loss (22) during the intermediate state hadronization. We also assume that the cc pair does not attenuate when it propagates through the nucleus in a color octet state. Actually, rescatterings of such a pair also may cause an attenuation [25], but it is small provided that the photon energy is su ciently high $(1 x_1) = R_A$. However, the ∞ pair does attenuate propagating through the nucleus in the colorless state before the st interaction 1) and after the last one. We assume in eq. (23) a long coherence length and $(if q_{el} R_A)$ zero formation length. We neglect the energy variation due to these e ects because the estimate eq. (23) is quite rough and the accuracy of data [1, 2] is low as well.

The only unknown parameter we are left with in eq. (23) is , the energy loss per unit length. In the string model it equals the string tension. The color-octet string tension may substantially exceed the known value for color-triplet strings $_3$ (2 $_{\rm R}^{0}$) ¹ 1 G eV=fm [23], where $_{\rm R}^{0}$ 1 G eV ² is the universal slope of R egge trajectories. Indeed, the string tension of the color-octet string must to be related to the slope of the Pom eron trajectory,

 $^{0}_{P}$ 02 GeV 2 , which is much smaller than $^{0}_{R}$. Thus, $_{8}$ (2 $^{0}_{P}$) 1 5 GeV=fm [22].

One may also treat the energy loss perturbatively as a result of gluon brem sstrahlung by the color-octet co pair. It was dem onstrated in [24] that brem sstrahlung provides a constant density of energy loss, similar to the string model. The mean squared color-octet charge is 9=4 times bigger than the color-triplet one, so is the energy loss. Besides, in the case under discussion the color-charge appears during the st interaction with a bound nucleon at the time $t = t_1$, then propagates for the time, $t = t_2$ t_2 and disappears when the oc pair becomes colorless. Such a process with switch-on and switch-o causes a double brem sstrahlung [24] (see also [21]): only that part of the frequency spectrum is emitted during a time interval t, which has radiation time t $_r = 2! = k_T^2 < t$, where ! and k $_T$ are the energy and transverse momentum of the radiated gluon, respectively. At the time $t = t_2$ when the ∞ pair converts to a colorless state and the radiation process stops. A new radiation process caused by the charge stopping starts, and another piece of the gluon spectrum is radiated, identical to the one previously emitted. Thus, the intensity of radiation and the energy loss are twice as large as in a single-scattering process. Sum marizing, we expect the energy loss for gluon bremsstrahlung in the double-scattering process with a cobroctet intem ediate state to be 4.5 tim es larger than that for radiation of a color-triplet charge, produced in a single scattering process. This estimate is very close to the one we found above in the string model, so we x for further calculations = 5 GeV = fm.

The new mechanism provides an x_1 -dependence of the cross section quite di erent from the standard one. There is no cross section for $x_1 < 1$ $R_A =$, since the amount of lost energy is restricted by the length of the path of the color-octet ∞ pair inside the nucleus. This contribution does not peak at x_1 ! 1, but may have even a minimum due to a longer

path of the colorless cc pair in nuclear matter.




Figure 4: The cross section per nucleon for J= photoproduction on lead. The solid curve corresponds to G lauber-G ribov mechanism of nuclear shadowing at = 100 GeV. The novel mechanism contributions at = 70, 100 and 140 GeV are shown by dashed curves.

The contribution of this mechanism may cause an A-dependence steeper than A^1 , since there is more room for integration over longitudinal coordinates z_1 and z_2 . For this reason the contribution of the mechanism under discussion, is in portant for heavy nuclei at moderately high x_1 . We compare the contribution of G lauber-G ribov mechanism calculated with eq. (17) and the novel one given by eq. (23) to J= photoproduction on lead at dierent photon energies in Fig. 4. We see a strong energy variation of the latter contribution, which shifts with energy towards $x_1 = 1$. At the same time the energy dependence of nuclear elects provided by a variation of the coherence and form ation lengths is so small that we plotted only one curve for the G lauber-G ribov mechanism at = 100 GeV.

We see that both mechanisms the G lauber one and the two-step production are of the same order at x_1 0.6 0.7.

The novelm echanism proposed here does not display the Feynm an scaling typical for the standard mechanism, but this contribution grows with energy at xed x_1 . This is easy to understand: the total contribution integrated over x_1 is energy independent, but the range of 1 x_1 shrinks / 1= .

W ith the above value of = 5 GeV = fm and $\prod_{\text{in}}^{N} = 5 \text{ m b we calculate the contribution}$ of the double-color-exchange mechanism (23). Combining with the G lauber contribution from section 2 we have

The result for the ratio of the cross sections for tin to carbon is plotted in Fig. 3 for two photon energies = 70 and 100 GeV typical for the NMC experiment in comparison with the data [2].

It should be noted that such a comparison is legitim ate only for $x_1 < 0.85$ where the experimental resolution of the J= momentum su ces to separate events of inelastic photoproduction from the quasielastic ones. For $x_1 > 0.9$ quasielastic photoproduction of J= is supposed [1, 2] to be the dom inant process. In this region we should compare the data

with the quasielastic photoproduction cross section. The corresponding formula is derived in [10, 11]. It is dimension from ulas (3) – (5) for inelastic photoproduction, but in the approximation $\sum_{tot}^{N} hT i$ 1 books analogous to eq. (17)

The results of calculation with eq. (17) shown in Fig.3 correspond to quasielastic scattering in the limit $x_1 \ 1$, where the momentum transfer eq. (20) acquires the value $q_f = (M^{2}) M^{2} = 2$.




Figure 5: Nuclear suppression/enhancement factor for J= photoproduction on xenon and nitrogen at = 30 GeV

Fig. 3 shows a good agreem ent with the data both for inelastic and quasielastic photoproduction of J= o nuclei. It is important to study the energy dependence of the e ect under discussion, which is expected to be interesting. It seems most likely that new data on inelastic J= photoproduction will be taken with the HERMES spectrom eter at HERA. In Fig. 5 we show predictions for nuclear suppression/enhancement factor S^A at = 30 GeV for xenon and nitrogen.

7. Conclusions and discussion

W e sum m arize the m ain results of the paper as follows.

The cross section of inelastic photoproduction of charmonia o nuclei is calculated within the eikonal (G lauber) approximation. Corresponding formulas are derived for the rst time. We also correct the G lauber formulas for inelastic shadowing, which makes nuclear medium substantially more transparent for charmonium.

The experimentally observed nuclear enhancement of inelastic J= photoproduction at $x_1 < 0.85$ is found to be too large compared with expectation of G lauber model to be explained by an enhancement of gluons in nuclei at low x_{Bj} . A novel QCD mechanism of charmonium photoproduction is suggested, which is not included in the standard multiple-scattering theory and can only occur in a nuclear target. This mechanism arises as a natural consequence of the colored structure of the Pomeron: the projectile hadron (or a hadronic uctuation of the photon) induces a color dipole in the target nucleus, leaving the nucleus in a colorless state. This is a speci c way of di ractive excitation of the nucleus and inclusive production of leading hadrons.

As di erent from the G lauber model the new mechanism contribution is essentially energy-dependent and violates Feynman scaling. Due to steeper an A-dependence this mechanism successfully competes with G lauber one at moderate x_1 in the energy range of the EMC and NMC experiments and nicely explains the observed [1, 2] nuclear enhancement of the photoproduction cross section. This elect is expected to be squeezed towards $x_1 = 1$ and to vanish under the quasielastic peak at higher energies.

W e conclude that the observed nuclear enhancem ent of inelastic photoproduction of J= is the evidence of a new phenom enon related to speci cs of QCD. An analogous e ect in the case of interaction of light hadrons turns out to be suppressed and escapes observations [21, 22]. Photoproduction of heavy quarkonia m ight be a unique reaction where the new mechanism can be observed.

Note, that a speci c channel of decay of the color-dipole created inside the nucleus into two nucleons was suggested in [26] as a source of the backward protons in the laboratory fram e. M easurements by the SIGMA Collaboration [27] of backward proton production in pion-beryllium interaction at 40 G eV nicely con rm ed the theoretical expectations. This is another manifestation of the of double-color-exchange mechanism.

The important signature of the mechanism under discussion its speci c energy dependence. The nuclear enhancement does not vanish at higher energies, but is squeezed towards $x_1 = 1$. This is different from gluon distribution in a nucleus, which anyway have to switch

to nuclear shadowing at higher energies, i.e. smaller B jorken x_2 .

Appendix

We estimate the correction $(d^{A}=dx_{1})$ from inelastic production of J=w ith inelasticity at one point in the nucleus, with subsequent inelastic rescattering with inelasticity on another bound nucleon. This contribution to the cross section integrated over transverse momenta reads

W e assume for the sake of simplicity that the energy is high, $q_{al}R_A$ 1. A fler integration (26) takes the form

Here = M_0^2 =s, where M_0 is the minimal mass of the excited nucleon in nal state, which we include in the integration over inelasticities in (26). At M_0 = 2 GeV and x_1 = 0.9 we estimate the factor K 0.03 fm² The elective nuclear thickness (27) for tin is $f^{Sn} = 0.3$ fm².

We conclude that according to these estimates and expression (29) the correction under discussion has nearly the same form of x_1 -dependence as the standard mechanism contribution, but is suppressed by the factor K $f^{\text{P}} A = S^{\text{N}}$ 0:016. We can neglect such a small correction for our purposes.
