Interplay of Soft and H ard Interactions in Nuclear Shadow ing at H igh Q 2 and Low x

A bstract: Nuclear shadowing corrections are dominated by soft interaction and grow as function of 1=x m ore slow by than the single scattering term, which has an essential contribution from hard interaction. Therefore we predict vanishing nuclear shadowing at very low x provided that Q^2 is high and xed. At the same time, at medium and low Q^2 , nuclear shadowing grows with 1=xas is well known for soft hadronic interactions.

Experimental observation [1, 2] of nuclear shadowing in deep-inelastic scattering at low x was probably the rst signal that this process is substantially contam inated by soft physics even at high Q^2 . Since nuclear shadowing is closely related to diraction [3], it is not surprising that recent measurements at HERA found diraction to be a large fraction of the total cross section.

The structure function $F_2(x;Q^2)$ is proportional to the total cross section of interaction of a virtual photon with the target. This invites one to consider deep-inelastic lepton scattering in the rest frame of the target, where the virtual photon demonstrates its hadronic properties. Namely, the hadronic uctuations of the photon interact strongly with the target [4]. Such a process looks quite di erent from the partonic interpretation of deep-inelastic scattering. The observables are Lorentz-invariant, but the space-time interpretation depends on the reference fram e.

The observed virtual photoabsorption cross section on a nucleon is an average of total interaction cross sections $^{hN}_{tot}$ of hadronic uctuations weighted by probabilities W $_{h}$,

In the case of a nuclear target the sam e procedure leads to [5],

Here T (b) = $\begin{bmatrix} R_1 \\ 1 \end{bmatrix}$ dz A (b; z) is the nuclear thickness at in pact parameter b and hT i = (1=A) $\begin{bmatrix} R \\ d^2b \end{bmatrix}$ T² (b) is its mean value. A (b; z) is the nuclear density dependent on b and longitudinal coordinate z. The longitudinal nuclear form factor

takes into account the e ects of the nite lifetime t_c $1=q_L$ (the coherence time) of hadronic uctuations of the photon, where, $q_L = (m_h^2 + Q^2)=2m_N$ is the longitudinal momentum transfer in N ! hN. At large $q_L > 1=R_A$, the nuclear form factor (3) vanishes and suppresses the shadowing term (2). This is easily interpreted: for large q_L the uctuation lifetime and its path in nuclear medium are shorter, and shadowing is reduced. For further estimations we assume that the mean mass squared of a photon uctuation is Q^2 , leading to $q_L = 2m_N x$.

Thus, all the factors in the rst-order shadowing term (2) are known, except h($_{tot}^{hN}$)²i. First, let us analyse the Q²-behaviour of this factor. It is known that h $_{tot}^{hN}$ i / 1=Q² according to B jorken scaling. In QCD this is usually interpreted as a consequence of color screening: the higher the value of Q², the sm aller the mean transverse size squared h²i 1=Q² of its hadronic uctuation. Due to color screening the cross section of interaction of such a uctuation with external gluonic elds vanishes as 1=Q². However, the situation is more complicated, as a nite admixture of soft uctuations having large size is unavoidable [6, 7, 8]. We classify in a simplied way the hard and soft mechanism s of deep-inelastic scattering in Table 1.

Table 1. Contributions of soft and hard uctuations of a virtual photon to the D IS cross section and to nuclear shadowing

As previously stated, the mean uctuation of a highly virtual photon is hard and has a small transverse size $1=Q^2$. This is why we assign to it a weight close to 1 and a small $1=Q^2$ cross section in Table 1. On the contrary, a soft uctuation having a large size $1={}^2$, where is a soft parameter of the order of $_{QCD}$, is expected to be quite rare in the photon, suppressed by factor ${}^2=Q^2$. ¹ On the other hand, such a soft uctuation has a large $1={}^2$ cross section. Therefore, the soft contribution to h $_{tot}^{hN}$ i has the same

¹T his is shown to be true for a transverse photon by perturbative calculations [8], but in a longitudinal photon soft uctuations have an extra suppression $1=Q^4$ [8]. Therefore shadowing is a higher twist e ect.

leading twist behaviour $1=Q^2$ as the hard one. Thus, according to Table 1 one cannot say that B jorken scaling results only from the smallness of the interaction cross section of hard photon uctuations, that also arises from the rareness of the soft components of a virtual photon.

The last column of Table 1 summarizes the Q²-dependence of hard and soft contributions to $(h_{tot}^{hN})^2 i$, which sets the size of nuclear shadowing and direction e ects. In this case the hard component turns out to be a higher twist e ect, and the leading contribution comes from soft interaction². This is why the applicability of pure perturbative calculations to nuclear shadowing or direction is questionable.

This conclusion is di erent from the statem ent in paper [10] that quite a small transverse size, 0.2 fm, is typical for a hadronic uctuation of a transversely polarized photon in di ractive dissociation. This value corresponds to a tiny cross section 1 1.5 m b, which is in a strong disagreem ent with the observed nuclear shadowing [1, 2], which dem ands h($\frac{hN}{tot}$)² i=h $\frac{hN}{tot}$ i 20 m b.

Since $(h_{tot}^{hN})^2 i$ is dominated by soft interactions, we can parameterize it as [5],

We are interested in the behaviour of this factor at very low x and assume for the num erator dom inance of the soft P on eron with intercept $_{P}(0) = 1 + (^{2})$, where $(^{2})$ 0:1 is known from Regge phenom enology of soft hadronic interactions. This explains particularly why a soft P on eron intercept was found in diraction at high Q² [11], while the intercept describing x-dependence of $F_{2}^{P}(x;Q^{2})$ at high Q² is much larger, $_{P}(Q^{2})$ 0:3 0:4 [5].

The proton structure function was xed in [5] by tting available data. The only unknown parameter N is universal for all nuclei and is xed by the tat N = 3 GeV^{-2}

[5].

 $^{^{2}}$ Soft interaction also contributes to the higher twist term s [9], which we neglect, provided that Q 2 is su ciently high.




Figure 1: Normalized ratio $F_2^A(x;Q^2) = F_2^D(x;Q^2)$ calculated for carbon using (2). The data points are from [1].

Now we are in a position to predict nuclear shadowing down to low x. The fact that $2_{P}(2) < P(Q^{2})$ at high Q^{2} leads to the unusual prediction of vanishing nuclear shadowing at very low x. That is, the rst shadowing correction in (2) decreases with 1=x provided that the nuclear form factor saturates, $F_{A}^{2}(x)$! 1. This is demonstrated in Figs. 1-2, where we have plotted our predictions for carbon and the versus x at xed values of Q^{2} . Note that form ula (2) does not include the small (a few percent) e ect of nuclear antishadowing. We have renorm alized all curves by factor 1.03 in order to incorporate this e ect, which we assume to be A-independent for simplicity. Note that com parison

with data [1] in Fig. 1 is marginal, since Q^2 substantially varies from point to point. To make the comparison with data more sensible it was suggested in [5] to plot the data against a new variable,

nicely con rm such a scaling. Note that the data points for dierent nucleim ay dier within a few percent due to the antishadowing e ect, if it is A-dependent. The




Figure 3: Nuclear shadowing versus scaling variable $n(x;Q^2;A)$ (see text). The data for Li, C and Ca are from [1, 2], other data points are from [12].

results depicted in Figs. 1-2 demonstrate a substantial variation of nuclear shadowing with Q^2 , especially at low x. Q^2 -dependence of shadowing was observed recently by the NMC experiment [13]. Their data are plotted in Fig. 3 together with our predictions, which reproduce well the order of magnitude of the elect. We cannot claim a precise description, since the data represent the results of averaging over large interval of Q^2 down to quite low values, where our approximation may not work. It is important that all Q^2 -dependence of shadowing originates in form ula (2) only from the proton structure function in the denominator. Consequently, this elect in (2) has no relation to shadowing of gluons in nuclei.

To conclude, we would like to comment on the approximations used.

First of all, in saying that h $_{tot}^{hN}$ i is dominated by soft interaction we neglected the

higher twist corrections $1=Q^2$ presented in Table 1. Thus, one should be cautious using this approximation at low Q^2 .

A lthough we use a double-leading-log type param eterization for $F_2^p(x;Q^2)$, which provides a vanishing elective $_p$ at x ! 0, it is almost a constant in the range of x under discussion, i.e. is compatible with the BFKL solution [14].

It is easy to show that the higher-order shadowing corrections on itted in (2) are soft as well. However, the x-dependence of the n-fold correction is governed by the power $n_{P}(^{2})_{P}(Q^{2})$ which may be positive for n = 3 or 4 and so on. A question arises, whether the grow th of higher-order shadowing corrections can change our conclusion about the shadowing decreasing with 1=x. We think it cannot. Indeed, let us consider an eikonal shadowing where the rst term correspond to the hard Pomeron with a large $_{P}(Q^{2})$, but all other terms correspond to the soft $_{P}(^{2})$. Eikonalization of form ula (2) leads to the full shadowing correction, which reads

where we assume x small and x $F_A^2 = 1$. The rst term in curly brackets is bigger than the second one and both grow with 1=x. For this reason, the right hand side of (6) decreases with 1=x m ore steeply than (1=x) $P(^2) P(^2)$. Thus, addition of higher order shadowing corrections makes vanishing of the shadowing for x ! 0 even stronger.

In order to estimate q_L in (2)-(3) we assumed $hm_h^2 i = Q^2$. This may not be a good approximation for so called triple-Pomeron term in shadowing, which provides a mass distribution in diractive dissociation / $1=m_h^2$, not steep enough to neglect the high-mass tail. The nuclear form factor in Gaussian form, convoluted with this mass distribution, results in a modil ed form factor

where E i is the integral exponential function, $q_{m in} = m_N (x + m_{m in}^2 = 2m_N)$ and $q_{m ax} = m_N (x + m_{m ax}^2 = 2m_N)$. The limit of integration over m_h are $m_{m in}$ and $m_{m ax}$. In contrast

to form factor (3), the modi ed one (7) grows logarithm ically with 1=x. However, with a reasonable choice of the mass interval, this growth does not stop the power decrease (4) of the shadowing correction, even if the triple Pomeron contribution (i.e. gluon fusion) dom inates nuclear shadowing.

Sum marising, we predict the unusual phenom enon of vanishing nuclear shadowing for $x \mid 0$ at xed large Q².
