Strong decays of nonstrange q³ baryons

Abstract

We study strong decays of nonstrange baryons by making use of the algebraic approach to hadron structure. I. IN TRODUCTION

A large amount of experimental data was accumulated in the 1960's and 1970's on the spectroscopy of light hadrons. These data led rst to the introduction of SU_f (3) by GellM ann [1] and Ne'em an [2] (later enlarged to SU_{sf} (6) by Gursey and Radicati [3]), and subsequently to $SU_{c}(3)$ color symmetry as a gauge symmetry of strong interactions. The construction of dedicated facilities (e.g. CEBAF, MAMI, ELSA) that promise to produce new and more accurate data on the same subject, have stimulated us to revisit baryon spectroscopy with the intent to reexam ine whether or not the new data can shed some new light on the structure of hadrons. In this reanalysis we have introduced, in addition to the basic spin-avor-color sym m etry, SU_{sf} (6) SU_{c} (3), a new ingredient, namely a space sym m etry, G, which we have taken to be G = U(7) for baryons [4]. The introduction of the space symmetry allows us to examine, in a straightforward way, several limiting situations (e.g. harm onic oscillator and collective dynam ics), and to produce transparent results that can be used to analyze the experim ental data. This approach has been used [4,5] to analyze the mass spectrum and electromagnetic couplings of nonstrange baryon resonances. It presents an alternative for the use of nonrelativistic or relativized Schrodinger equations. In addition to electrom agnetic couplings, strong decays of baryons provide an im portant, com plem entary, tool to study the structure of baryons. These strong couplings are needed to analyze the new upcoming experimental data, especially (e; e^0) and (e; e^0). Furtherm ore, we want to understand whether or not unusual features appear in the data, which may point out to hew' physics, new meaning here unconventional con gurations of quarks and gluons, such as hybrid states, q³ q, or multiquark states, q³ qq. For example, the observed large $\,$ width of the N (1535) S_{11} resonance has led to considerable discussion [6{10] about the nature of this resonance.

The strong decays have been analyzed previously in the nonrelativistic [11] and relativized quark models [12]. These models emphasize single-particle aspects of quark dynamics in which only a few low-lying con gurations in the con ning potential contribute signicantly to the baryon wave function. In the fram ework of the earlier mentioned algebraic approach, it is possible to study also other, more collective, types of dynamics. In this article, we analyze in detail the strong decays in a collective model of baryon structure. The article is organized as follows: in Section II we brie y discuss the method of calculation, in Section III we present the results, which are compared with the existing data in Section IV. Finally, in Section V we present our conclusions and point out some open problems.

II.M ETHOD OF CALCULATION

We consider in this article strong decays of baryons by the emission of a pseudoscalar meson

In order to calculate these decays we need two ingredients: (i) the wave function of the initial and nal states and (ii) the form of the transition operator. We write both the wave functions and the transition operators in algebraic form. We take the wave functions as representations of U(7) SU_{sf} (6) SU_{c} (3), as discussed in [4]. The algebraic formulation allows us to study a large class of models, all with the same spin-avor-color structure, but dierent types of quark dynamics (e.g. single-particle and collective). Each scenario corresponds to dierent ways in which the U(7) spatial symmetry is broken down to the angular momentum group SO(3). Among the models in this class is the familiar harmonic oscillator quark model characterized by the breaking

where the index and refers to the two relative Jacobi coordinates

The nonrelativistic and relativized quark potential models [13,14] are formulated in this harmonic oscillator basis.

In a collective model the baryon resonances are interpreted in terms of rotations and vibrations of the string con guration in Fig. 1, which is characterized by the two relative Jacobi coordinates of Eq. (3). The three constituent parts carry the global quantum numbers: avor = triplet = u;d;s; spin = doublet = 1=2; and color = triplet (we do not consider here heavy quark avors). Dierent types of collective models are specified by a distribution of the charge, magnetic moment, etc., over the entire volume. For the present analysis of strong decays we use the (normalized) distribution

where is a radial coordinate and a is a scale parameter. We have shown in [5] that the above distribution appears to describe the available data on electrom agnetic form factors and helicity amplitudes up to Q^2 10 20 (GeV/c)².

The spatial part of the baryon wave functions in the 'collective' model is characterized by the following labels: $(v_1; v_2)$; K; L_t^P [4], where $(v_1; v_2)$ denotes the vibrations (stretching and bending) of the conguration of Fig. 1; K denotes the projection of the rotational angular momentum L on the body-xed axis; P the parity and the symmetry type of the state under the point group D_3 . The classication under D_3 and parity is equivalent to that of the point group D_{3h} , which describes the discrete symmetry of the object of Fig. 1. Instead of the D_3 labels ($t = A_1, A_2, E$) one can use the labels of S_3 (t = S, A, M), the group of permutations of the three constituent parts (S_3 and D_3 are isomorphic). The permutation symmetry to fine spatial part of the wave function must be the same as that of the spinaror part in order to have total wave functions that are antisymmetric (the color part is a

color-singlet, i.e. antisym m etric). Therefore one can also use the dimension of the SU_{sf} (6) representations to label the states: A_1 \$ S \$ 56, A_2 \$ A \$ 20 and E \$ M \$ 70. We adhere to the latter notation and label the states by

When the spin-avor quantum numbers are explicitly added, we obtain the total baryon wave function

where S and J are the spin and total angular momentum $\mathcal{J} = \mathcal{L} + \mathcal{S}$. For example, in this notation the nucleon and delta wave functions are given by

The second ingredient in the calculation is the form of the operator inducing the strong transition. Several form s have been suggested [15]. We use here the simple form [11]

where r_j , p_j and s_j are the coordinate, momentum and spin of the j-th constituent, respectively; $k_0 = E_M = E_B = E_{B^0}$ is the meson energy, and $k = P_M = P = P^0 = k2$ denotes the momentum carried by the outgoing meson. Here $P = P_z \hat{z}$ and $P^0 = k2$ are the momenta of the initial and nalbaryon. The coe cients g and h denote the strength of the two terms in the transition operator of Eq. (8). The avor operator X_j^M (to be discussed below) corresponds to the emission of an elementary meson M) by the j-th constituent: $q_j : q_j^0 + M$ (see Figure 2).

U sing the sym metry of the wave functions for nonstrange baryons (the only case we discuss here), transform ing to Jacobi coordinates and integrating over the baryon center of mass coordinate, we nd

By using momentum conservation $P_z + P_z^0$ can be written as $2P_z$ k. The dependence on the overall center of mass momentum is spurious and must be eliminated. (In the rest frame

of B, $P_z = 0$ and the spurious term is automatically absent.) By making the replacement, $p = m_q!$ ik₀~ [16], and the mapping onto the algebraic operators, 2=3 m! $\hat{D}_m = X_D$ [4,5], we can write Eq. (10) as

The dipole operator \hat{D}_{m} is a generator of U (7) and X_{D} is its normalization, as discussed in [4,5]. The calculation of the matrix elements of H can be done in conguration space (\sim,\sim) or in momentum space (p,p). The mapping onto the algebraic space of U (7) is a convenient way to carry out the calculations, much in the same way as the mapping of coordinates and momenta onto creation and annihilation operators in the harmonic oscillator space.

In the collective model the matrix elements of H are obtained by folding with the distribution function g() of Eq. (4). These collective matrix elements can be expressed in terms of helicity amplitudes. For decays in which the initial baryon has angular momentum $\mathcal{J} = \mathcal{L} + \mathcal{S}$ and in which the nalbaryon is either the nucleon or the delta with $L^0 = 0$ and thus $J^0 = S^0$, the helicity amplitudes are

Here denotes the labels that, in addition to L, S, J and , are needed to specify the baryon wave function (see Eq. (6)). The coe cients $_{\rm m}$ are the spin-avormatrix elements of X $_{\rm 3}^{\rm M}$ s_{3,m}, to be discussed below, and Z $_{\rm m}$ (k) (m = 0;) are the radial matrix elements

The calculation of the radial matrix elements is identical to that already reported for electromagnetic couplings [4,5]. Therefore, we do not repeat it here, but only show in Table I the matrix elements F (k) and G_m (k) of \hat{U} and \hat{T}_m , respectively, for the bollective' model with distribution given by Eq. (4). Note that Table I presents the results for an emission process, whereas the corresponding table for the bollective' model in [4,5] shows the results for an absorption process. For any other model of baryons with the same a spin-avor structure, the

corresponding results can be obtained by replacing Table I with the appropriate table (for example, by using harm onic oscillator wave functions as discussed in [4]).

Contrary to the case of electrom agnetic couplings where the spin-avor part is relatively simple, the calculation of the spin-avor part for strong decays is som ewhat more involved. The spin-avor matrix elements factorize into a spin matrix element of $s_{3,m}$ between spin wave functions and a avormatrix element of X_3^{M} between avorwave functions (and x_3^{M}). The calculation of the spin part is straightforward. For the avor part we take the avor operators of the form

where $_{i}$ are the Gell-M ann matrices [17] and I denotes the unit operator in avor space. For the pseudoscalar mesons we introduce a mixing angle $_{P}$ between the octet and singlet mesons [17]

The avor operators X_3^M appearing in Eq. (9) only act on the 3-rd constituent. The corresponding matrix elements can either be evaluated explicitly for each channel separately, or more conveniently, by using the W igner-Eckart theorem and isoscalar factors of SU_f (3) [18]. In this notation $(p_i;q_i) = (1;1)$ or (3;0) for the baryon avoroctet and decuplet, respectively, and (p;q) = (1;1) or (0;0) for the meson avoroctet and singlet, respectively (see Eq. (14)). The sum over is over different multiplicities. The avor states are labeled by the quantum

numbers (p;q); I; M $_{\rm I}$; Y corresponding to the reduction SU $_{\rm f}$ (3) SU $_{\rm I}$ (2) U $_{\rm Y}$ (1). The right hand side contains the sum of products of an isospin C lebsch-G ordan coe cient, which contains the dependence on the charge channel, a SU (3) isoscalar factor, which depends on the isospin channel, and a SU (3) reduced matrix element, which depends on the coupling of the avormultiplets (p;q), but not on isospin I; M $_{\rm I}$ and hypercharge Y . In Table II we give the expressions for the SU $_{\rm f}$ (3) reduced matrix elements.

U sing Eqs. (14) { (17) and the matrix elements of the spin operator, we can compute all spin-avormatrix elements for a given isospin channel. In Tables III and IV we present the results for the decay into and , ⁰, respectively. Results for a special channel can be obtained by multiplying with the appropriate isospin C lebsch-G ordan coe cient.

The helicity am plitudes A (k) of Eq. (12) can be converted to partial wave am plitudes a_1 (k) by [19]

Here l is the relative orbital angular momentum between the nalbaryon and the emitted meson. It takes the values l = L 1 (the value l = L is not allowed because of parity conservation). With the de nition of the transition operator in Eq. (8) and the helicity amplitudes and partial wave amplitudes, the decay widths for a special isospin channel are given by [15]

where f is a phase space factor.

III. R E SU LT S

For all resonances with the same value of $(v_1; v_2); L^P$ the expression for the decay widths of Eq. (19) can be rewritten in a more transparent form in terms of only two elementary partial wave amplitudes $W_1(k)$,

For this set of resonances, the k dependence of the partial wave amplitudes $a_1(k)$ is contained in the amplitudes $W_1(k)$, while the dependence on the individual baryon resonance is contained in the coe cients c_1 . In the algebraic method, the elementary partial wave amplitudes $W_1(k)$ can be obtained in closed form.

In Table V we present the values of c_1 for the negative parity resonances with $(v_1;v_2);L^P = (0;0);1$. In the 'collective' model with distribution given by Eq. (4) the corresponding S and D elementary partial wave amplitudes are

Partial widths for other models of the nucleon and its resonances can be obtained by introducing the corresponding expressions for the elementary amplitudes W $_1$ (k). For example, the relevant expressions in the harm onic oscillator quark model are

IV.ANALYSIS OF EXPERIMENTAL DATA

Use of Eqs. (20) { (22) allows us to do a straightforward and system atic analysis of the experimental data. Here we adopt the procedure of [15], in which calculations are performed in the rest frame of the decaying resonance, and in which the relativistic expression for the

phase space factor $_{\rm f}$ as well as for the momentum $\,$ k of the em itted meson are retained. The expressions for k and $_{\rm f}$ are

We consider here decays with emission of and . The experimental data, extracted from the compilation by the Particle D ata G roup [17] are shown in Tables V II, V III and IX, where they are compared with the results of our calculation. The calculated values depend on the two parameters g and h in the transition operator of Eq. (8), and on the scale parameter a of Eq. (4). We keep g, h and a equal for all resonances and all decay channels (N , N , ,). In comparing with previous calculations, it should be noted that in the calculation in the nonrelativistic quark model of [11] the decay widths are parametrized by four reduced partial wave amplitudes instead of the two elementary amplitudes g and h. Furthermore, the momentum dependence of these reduced amplitudes are represented by constants. The calculation in the relativized quark model of [12] was done using a pair-creation model for the decay and involved a dierent assumption on the phase space factor. Both the nonrelativistic and relativized quark model calculations include the elects of mixing induced by the hyper ne interaction, which in the present calculation are not taken into account.

In the present analysis we determ ine the values of g, h and a from a least square t to the N partial widths (which are relatively well known) with the exclusion of the S_{11} resonances. For the latter the situation is not clear due to possible mixing of N (1535) S_{11} and N (1650) S_{11} and the possible existence of a third S_{11} resonance [9]. As a result we nd g=1:164 G eV 1 and h=0:094 G eV 1 . The relative sign is consistent with a previous analysis of the strong decay of mesons [20] and with a derivation from the axial-vector coupling (see e.g. [15]). The scale parameter, a=0:232 fm, extracted in the present t is found to be equal to the value extracted in the calculation of electrom agnetic couplings [5]. Just as in our study of the electrom agnetic couplings [5] we present the strong decays of the resonances, that in the 'bollective' model are assigned as vibrational excitations of the congulation of Fig. 1, in terms of two one cients, s=10 and s=11 s=12 s=13 s=14 s=15 s=1

The calculation of decay widths into the N channel, as shown for the 3 and 4 star resonances in Table VII, is in fair agreement with experiment. This is emphasized in Figs. 3 and 4. The results are to a large extent a consequence of spin-avor symmetry. The use of bollective form factors improves somewhat the results when compared with older (harmonic oscillator) calculations. This is shown in Table X where the decay of a Regge trajectory

into N is analyzed and compared with the calculations of [15], which are based on the harm onic oscillator model discussed in [21]. We also include the results of more recent calculations in the nonrelativistic quark model [11] and in the relativized quark model [12]. There does not seem to be anything unusual in the decays into and our analysis con rms the results of previous analyses. In Table XI we show the N decays of the calculated resonances below 2 G eV which have not been observed (missing resonances). The resonances with $L^P=1^+$ and $L^P=2$ are decoupled because of the spin-avor symmetry. Most of other resonances have small decay widths, with the exception of the P_{13} and P_{15} states, which have widths comparable to those of the well-established P_{13} and P_{15} states of Table V II. This behaviour can be understood by inspection of Table V I. The coecients for the P_{13} states are $P_{13} = 2$. This leads to comparable N widths of 31 M eV and 56 M eV, respectively. The difference is due to the k values of these resonances that enter in the elementary partial wave amplitude W P_{13} (k) of Eq. (22). A similar situation holds for the P_{15} states. The relative magnitude of the P_{13} coecients in Table V I explain the smaller decay widths for the other missing resonances of Table X I.

Contrary to the decays into , the decay widths into have some unusual properties. The calculation gives systematically small values for these widths. This is due to a combination of phase space factors and the structure of the transition operator. Both depend on the momentum transfer k. The values of k in Tables V II, V III and IX show that, due to the dierence between the and mass, the momentum carried by the is smaller than that carried by the . Therefore, the decay widths are suppressed relative to the decays. The spin-avor part is approximately the same for N and N , since and are in the same S U $_{\rm f}$ (3) multiplet. We emphasize here, that the transition operator was determined by tting the coe cients g and h to the N decays of the 3 and 4 star resonances. Hence the decays are calculated without introducing any further parameters.

The experimental situation is unclear. The 1992 PDG compilation [22] gave system atically small widths ($1\,\text{M eV}$) for all resonances except N (1535)S $_{11}$. The 1994 PDG compilation [23] deleted all widths with the exception of N (1535)S $_{11}$. This situation persists in the latest PDG compilation [17], where N (1650)S $_{11}$ is now assigned a small but non-zero width. The results of our analysis suggest that the large width for the N (1535)S $_{11}$ is not due to a conventional q 3 state. One possible explanation is the presence of another state in the same mass region, e.g. a quasi-bound meson-baryon S wave resonance just below or above threshold, for example N , K or K [8]. A nother possibility is an exotic con guration of four quarks and one antiquark (q 4 q).

For possible use in the analysis of new experimental data, we give in Table X I the strong decay widths of the socalled missing resonances with a calculated mass below 2 GeV which up to now have not been observed experimentally.

V.CONCLUSIONS

We have presented a calculation of the strong decay widths N ! N + , N ! + , N ! N ! N ! N + , N ! N ! N N ! N ! N N ! N N ! N N !

Our calculations can be easily extended to include other decay channels, such as K and K. These calculations are currently underway and are part of the extension of the model to include strange resonances as well.
