A bstract

The propagation of the scalar () and vector (!) mesons in nuclear matter is studied in detail using the W alecka model over a wide range of densities and including the elects of a nite width through the inclusion of a two-pion loop. W e calculate the dispersion relation and spectral functions of the and (transverse and longitudinal) ! mesons, including the elect of -! mixing in matter. It is shown that the mixing elect is quite in portant in the propagation of the (longitudinal) ! and mesons above norm alnuclearm atter density. W ellips there is a two-peak structure in the spectral function of the channel, caused by -! mixing.

K eywords: quantum hadrodynam ics, dense nuclear matter, vector-scalar mixing, dispersion relation, spectral function Recently much attention has been focused on the variation of hadron properties in hot and/or dense nuclearm atter[1]. In particular, the medium modi cation of the light vector (, ! and) meson masses has been investigated by many authors[2, 3, 4, 5, 6, 7, 8, 9]. Experimentally, dilepton production in hot and/or dense nuclear matter produced by relativistic heavy ion collisions can provide a unique tool to measure such modi cations. It is well known that data obtained at the CERN /SPS by the CERES [10] and HELIDS [11] collaborations show a signi cant amount of strength below the free meson peak. Some authors[12] have concluded that this is caused by a downward shift of the rho meson mass in dense nuclear matter. To test this idea, measurements of the dilepton spectrum from vector mesons produced in nuclei are planned at T JNAF [13] and G SI[14] (see also Ref.[15]).

On the other hand, the meson has been treated as a correlated two-pion state in the scalar channel for a long time. However, recently some people have reanalysed the s-wave (I= 0) -scattering phase shift, and argued for the existence of the as a genuine resonance [16]. From the theoretical side, it is also anticipated that the meson may play an important role as the chiral partner of the meson [17]. Some experimental possibilities have been proposed for investigating the behaviour of the in hot and/or dense nuclear matter [17, 18].

It is well known that in nuclear matter the can couple to the longitudinal mode of the ! m eson [19]. This work is an extension and elaboration of studies in Ref.[3] where the invariant m ass of the ! m eson m oving in nuclear matter was studied. Here, we generalize this work by including free space widths for the and ! and by studying -! mixing in some detail as a function of density. Recently W olf et al.[20] studied the e ect of -! mixing on the e⁺ e -pair production in relativistic heavy ion collisions. However they calculated only the lowest order mixing diagram, and did not include the nucleon-loop diagram s for the and ! m eson propagators. The interesting results obtained in these earlier papers and the experimental relevance of the problem suggests that it is time for a m ore complete self-consistent calculation.

A complete investigation of the propagation of and ! mesons in a dense nuclear medium requires that one includes the e ect of -! mixing. In this letter we will study in detail the medium modi cation of and ! mesons in dense (symmetric) nuclear matter using the simplest version of quantum hadrodynamics (QHD or the W alecka model) [21] and including -! mixing, coupling, and the ! width.

The Lagrangian density of the W alecka m odel (Q H D –I) is well known and a full description of it can be found in Ref.[21]. We not treat the nuclear ground state in relativistic Hartree approximation (RHA), which is also explained in Ref.[21]. Here we shall ignore the coupling to the channels involving iso-vector mesons, neglecting, for example, ! + N ! + N and ! + N ! + N [22].

To compute the meson propagators, we sum over the ring diagrams, which consist of repeated insertions of the lowest order one-loop proper polarization part. This is the relativistic, random phase approximation (RPA) [19]. Since we want to include -! mixing, it is convenient to use a meson propagator D_{ab} in the form of a 5 5 matrix with indices a, b running from 0 to 4, where 4 is for the dhannel and 0 3 are for the !.

D yson's equation for the full propagator, D, is given in matrix form as:

where D 0 is the lowest order m eson propagator given by a block-diagonal form as

The polarization insertion in Eq.(1) is also then given by a 5 5 m atrix,

where the lowest order scalar, vector and scalar-vector-mixed polarization insertions are given respectively as

Note that we have added the contribution from the pion-loop to $_{\rm s}$ (the second term in the r.h.s. of Eq.(6)) in order to treat the more realistically. The pion propagator, , is given by equation (3) with the pion mass m instead of m. Here g_v , g_s and g are respectively the nucleon-!, nucleon- and - coupling constants. We denote G (k) as the self-consistent RHA nucleon propagator, which is given by the sum of the Feynman (F) part and the density-dependent (D) part as

where $k = (k^0 \quad g_v V^0; \tilde{k})$ (V^0 is the mean value of the ! eld), $E_k = \frac{q}{\tilde{k}^2 + M^2}$ (M is the eld ective nucleon mass in matter) and k_F is the Ferm in one ntum. Therefore, each polarization insertion (except the pion-loop contribution) can be divided into two pieces: the Feynman (F) (or vacuum) part, which does not involve the $(k_F \quad \tilde{j}; \tilde{j})$ term, and the density-dependent (D) part. The explicit expressions for the various components of D can be found in Ref.[23].

W e can work out the F parts using the m ethod of dim ensional regularization to rem ove the divergence in the loop calculations. W e show the results explicitly. For the , we must renorm alize two terms: the nucleon-loop and pion-loop diagrams. For the nucleon-loop contribution to the we introduce the usual counter term s to the lagrangian [21]

which includes quadratic, cubic, quartic and wavefunction renorm alization. To get the \physical" properties of the meson in free space, we impose the following condition on the F part of the nucleon-loop diagram [24]:

where M is the free nucleon mass. We adjust the coe cients $_2$ and to satisfy this condition. For $_3$ and $_4$ we use the usual values given in Ref.[21]. For the pion-loop, we also introduce an appropriate counter term to the lagrangian, and require a similar condition to Eq.(11) for the polarization insertion of the pion-loop diagram in free space:

where $z_v = 1 = \frac{4M^2}{m_1^2}$. Note that vacuum uctuations do not contribute to the mixed part of Eq.(8).

U sing these polarization insertions, we de ne the dielectric function as[19, 21, 23]

where $T_{[SL]}$ is the dielectric function for the transverse (T) [scalar and longitudinal (SL)] mode. (Note that the full propagator Eq.(1) can be rewritten as $D = D^0 = (1 D^0)$ and hence det $D = det D^0 = 0$.) Then, we nd

Here q = jqj and $d_0^{1} = q^2$ m²₁ + im $_{!}^{0}$, where we add the width of the ! in free space ($_{!}^{0} = 9.8 \text{ M eV}$). The transverse ($_{T}$) and longitudinal ($_{L}$) components of the polarization insertion Eq.(7) are respectively deneed by $_{11}$ (or $_{22}$) and $_{33}$ $_{00}$ (we choose the direction of q as the z-axis). Note that $_{0}^{m}$ is the 0-th component of the mixed polarization insertion Eq.(8), which vanishes when q = 0 (because of current conservation). The eigencondition for determining the collective excitation spectrum is just equivalent to searching for the zeros of the dielectric functions. Since we are interested in the medium m odi cation of the m eson propagation, we restrict ourselves here to the m eson branch in the tim e-like region.

To study the dispersion relation of the m eson branch, we rst have to solve the nuclear ground state within RHA. Because we choose $_2$ and to satisfy the renorm alization condition for the at $q^2 = m^2$ (see Eq.(11)), the total energy density is written as

where E_0 is the usualone (in RHA) given in Ref.[21]. (Note that in Ref.[21] the renorm alization condition on nucleon loops is in posed at $q^2 = 0$. This difference yields the second term of the r.h.s. of Eq.(21) [24]. As a result, ourmodel gives the same physical quantities as those of Ref.[21].) Requiring the saturation condition, E = B M = 15:7 MeV at $_0 = 0.15 \text{ fm}^3$ (where B and $_0$ are respectively the density of nuclear matter and the saturation density), we determ ine the coupling constants g_s^2 and g_v^2 : $g_s^2 = 101:50$ and $g_v^2 = 72:296$. In the calculation we is the values of the free hadron masses to be M = 939M eV, m = 550 MeV, $m_1 = 783 \text{ MeV}$ and m = 138 MeV. This yields the elective nucleon mass M = M = 0:73 at $_0$ and the incompressibility K = 452 MeV. We do not consider the possibility of medium modi cation of the pion loop or any of the coupling constants in the present work.

To determ ine the coupling constant g, we adjust it to x the width of the in free space. Since the full propagator of in free space is given in terms of the pion-loop polarization insertion, the width ⁰ is given by

If we choose $^{0} = 300 \text{ MeV}$ [16], we ndg = 18:33.

Now we are in a position to show our results. First, in Fig. 1, we show the dispersion relation for the meson branches, which are calculated by searching for the zeros of the real part of the dielectric function given in Eq.(20). As illustrated in the gure, if the -! mixing is ignored, the longitudinal (L) mode and the (S) mode cross each other at one point. However, once the mixing is involved, the two modes never cross each other.

W e can understand this phenom enon as a level-level repulsion due to the mixing, which is quite familiar in conventional nuclear physics, for example, in the N ilsson diagram (see Ref.[25])). Adding the o -diagonal (or mixing) matrix element in the Hamiltonian leads to new eigenstates which never cross each other. The new states approach the original crossing modes as the o -diagonal part becomes weaker. This occurs at mid and high density (above $_{0}$) because its origin is the mixing elect, which vanishes at $_{B} = 0$.

In Figs. 2 and 3, we show the \invariant m ass" (m $_{inv}$ $\frac{1}{q_0^2}$ $\frac{q^2}{q^2}$, with q chosen as in Fig. 1 so that the real part of the dielectric function vanishes for that value of q) as a function of density. As shown in the gures, we can clearly see the role of m ixing, which is quite in portant in determining the m eson m ass at m id and high density. If the m ixing is ignored, the m asses of the L and S m odes cross each other, like the dispersion relation shown in Fig. 1, and the L m ass is below the other two at high density. However, in the

case where the mixing is included the L and S masses never cross each other. At high density the L mass is pushed upwards, while the S mass is pulled downwards because of mixing (through the level-level repulsion). From the gures we can see that the mixing e ect becomes vital above 0.

Next we calculate the spectral functions of the T, L and S m odes. It is very interesting to study these functions because in a therm alm odel the dilepton yields in heavy ion collisions would be proportional to the spectral functions. The spectral function is usually de ned in terms of the imaginary part of the full propagator. For the T m ode it is:

W hile, in practice, it may be dicult or even impossible to separate the L and S m odes in an experiment, it is of considerable theoretical interest to study the following spectral

functions:

corresponding to the complete, diagonal, longitudinal! and propagators, respectively.

In Figs. 4, 5 and 6, we show the shape of the spectral function S_i (i= T, L or S), as a function of the invariant mass and three-momentum transfer, at $_B = _0 = 2$. For the T mode the shape is very simple, while for the L and S modes they are complicated because of the elect of mixing. In particular, the S mode is quite remarkable: at q= 0 M eV there is only one peak, while at xed, nite q there exist two peaks in the spectral function. Note that at q= 0 M eV the mixed polarization insertion vanishes, so this two-peak structure is clearly associated with -! mixing. A sthe density grows the two peaks becomes separated more widely. In the L mode there is no such structure at xed q. However, the peak at

low q and that at high q are separated very well and the values of their invariant m asses are quite di erent. As the density goes up this tendency becom es m ore clear.

Finally, we should comment on the width of the in free space. In our calculation we have used $^{0} = 300 \text{ M} \text{ eV}$ [16] (see Eq.(22)), which is somewhat smaller than usual. We have therefore also calculated the spectral functions using a width of 600 M eV but, as the results were not qualitatively different we do not report them here.

which could be measured in future experiments[18]. It would clearly be very interesting to compare these results with the medium modi cation of the meson propagation using the quark-meson coupling (QMC) model[7], in which the elect of hadron internal structure is involved. We will report such a study in the near future.
