A Perturbative Calculation of the Electrom agnetic Form Factors of the Deuteron

Abstract

Making use of the electron eld theory expansion recently developed by the authors, we compute the electron agnetic form factors of the deuteron analytically to next-to-leading order (NLO). The computation is rather simple, and involves calculating several Feynm an diagram s, using dimensional regularization. The results agree well with data and indicate that the expansion is converging. They do not su er from any ambiguities arising from o -shell versus on-shell am plitudes.

The techniques introduced by the authors in refs. [1] put the study of low energy twonucleon interactions on the same footing as chiral perturbation theory in the mesonic and single nucleon sectors [2]. In particular, there is a system atic low momentum expansion, such that at any given order one need only calculate a nite number of Feynm an diagram sto arrive at an analytic result. The procedure is superior in several ways to the conventional technique of solving the Schrodinger equation with a potential constructed to t the scattering data: (i) There is a well de ned expansion parameter, and one can estimate errors at any given order in the expansion; (ii) it is straightforward to incorporate relativistic and inelastic e ects within the expansion; (iii) analytic results allow one to see quite simply the relative in portance of short- and long-distance physics to a given process; (iv) there is no am biguity concerning o -shell matrix elements when calculating physical processes; (v) at low orders in the expansion, the number of free parameters to be t to the data is few, and the same parameters are used in all processes. The results at lower orders in the expansion are therefore very constrained.

Until now, the techniques of ref. [1] have only been applied to reproducing scattering phase shifts. While a necessary rst step, tting the phase shifts does not seriously test the method, as the low energy phase shifts can be well t by rather simple functions of few param eters. W hat is needed are calculations of dynam ical processes that involve the sam e interactions as are t to the N N phase shifts. The obvious ones to consider are N N ! N N , np! d, parity and isospin violation in NN processes, pp! de⁺, and the deuteron electrom agnetic form factors. In this paper we present the perturbative calculation of the deuteron electrom agnetic form factors at NLO. This subject has been addressed previously in the context of e ective eld theory in refs. [3,4], although using a somewhat dierent form alism and involved num erical, as opposed to analytical, calculations. We preface the calculation with a brief review of our expansion, and a discussion of the deuteron. After identifying the graphs contributing the electrom agnetic form factors, we show explicitly that there is no am biguity arising from the fact that the nucleons in a deuteron are not on their mass shell, even though the couplings in the elective theory are t to NN scattering data. We conclude with a discussion of features that will appear in the NNLO (next-to-next-to leading order) calculation of the form factors.

It is not unreasonable to ask why it is worth pursuing an e ective eld theory description of the deuteron since e ective range theory [5,6], can be used to predict m any of its properties [7,8]. For som e quantities, like the deuteron charge radius, e ective range theory is rem arkably precise. The prim ary m otivation is to m ake a clear connection to QCD and therefore enable system atic calculations to be perform ed, even for processes where e ective range theory is not applicable. Furtherm ore we expect that, even in cases where e ective range theory is very accurate, the e ective eld theory approach will surpass this level of precision if pursued to higher orders.

In this paper the application of the electrice eld theory expansion of ref. [1] to processes involving the deuteron is developed. For de niteness we focus on the electrom agnetic form factors of the deuteron. However, it is straightforward to use the methods developed here for other quantities, like the cross sections for np ! d and d ! d.

At NLO the predictions of the e ective eld theory expansion for the electrom agnetic

form factors of the deuteron are not as accurate as those of e ective range theory. How ever at NNLO they should reach the precision of e ective range theory. Furtherm ore, the e ective eld theory approach is a system atic one at som e order it will include physical e ects beyond those that are encorporated into e ective range theory.

II.EFFECTIVE FIELD THEORY FOR NN INTERACTIONS

In order to compute the electrom agnetic form factors of the deuteron, we must consider the possible interactions between nucleons, pions and photons. In an elective led theory, these interactions take the form of local operators, constrained only by the symmetries of QCD and QED. In this section we discuss the form of the operators that occur to the order that we will be working, and then turn to the issue of power counting, which allows a consistent expansion of the form factors.

A. Interactions

Term s in the elective Lagrangian describing the interactions between nucleons, pions and photons can be classied by the number of nucleon elds that appear in them. It is convenient to write

where L_n contains n-body nucleon operators.

 L_0 is constructed from the photon eld $A = (A^0; A)$ and the pion elds ; it does not contain any nucleon elds. The pion elds are incorporated in a special unitary matrix,

The ellipsis denotes operators with more covariant derivatives D , insertions of the quark mass matrix, $m_q = \text{diag}(m_u; m_d)$, or factors of the electric and magnetic elds. A cting on the covariant derivative is

The parameter ! has dimensions of mass and $m^2 = ! (m_u + m_d)$.

W hen describing pion-nucleon interactions it is convenient to introduce the eld = exp i = f = 0. Under SU (2) L SU (2) transform ations

where U is a complicated nonlinear function of L; R and the pion elds them selves. Since U depends on the pion elds it has spacetime dependence. The nucleon elds are introduced as a doublet of spin 1=2 elds

The covariant derivative of N transforms in the same way as N under SU $(2)_L$ SU $(2)_R$ transform ations (i.e., D N ! UD N) and under U (1) gauge transform ations (i.e., D N ! $e^{i Q em} D N$).

The one-body term s in the Lagrange density are

To the order to which we are working $_0 = \frac{1}{2} (p + n)$ and $_1 = \frac{1}{2} (p - n)$ are isoscalar and isovector nucleon m agnetic m om ents in nuclear m agnetons, with

at tree-level. At higher orders there will be contributions to eq. (2.12) from pion loop graphs [9]. The isoscalar magnetic moment $_0$ receives leading corrections of the form $m^2 \log (m^2 = ^2)$, suppressed by two powers of the pion mass. In contrast, the isovector magnetic moment $_1$ receives leading corrections of the form m, suppressed by only one power of the pion mass. The ellipsis in eq. (2.11) denotes higher order terms that do not contribute at the order we are working.

Finally it remains to consider the two body operators. Some of these were discussed in refs. [1]; however, since we will be computing electrom agnetic form factors of the deuteron there are additional considerations that didn't arise in the NLO calculation of nucleon phase shifts.

F irst we will consider the two-body operators involving nucleons alone, then we will bok at those containing a photon; to the order we will be working, we need not consider twobody operators involving pion elds. In the spin triplet channel, there is one NN contact interaction with no derivatives or insertions of the quark mass matrix, corresponding to a diagonal transition ${}^{3}S_{1}$! ${}^{3}S_{1}$; the coe cient of this operator is taken to be C₀. There is an additional contact interaction involving no derivatives and one insertion of the quark m ass matrix, with coe cient D $_2$; it can be distinguished from the C $_0$ interaction by its chiral properties. There are ve contact interactions involving two gradients, corresponding to diagonal transitions in the ${}^{3}S_{1}$; ${}^{3}P_{0}$; ${}^{3}P_{1}$, and ${}^{3}P_{2}$ partial waves, as well as an o -diagonal ${}^{3}S_{1}$ ${}^{3}D_{1}$ transition. Only the rst and the last of these are relevant for the deuteron; furtherm ore, at NLO we can ignore the ${}^{3}S_{1} - {}^{3}D_{1}$ transition interaction. Thus the only r² two-body contact interaction we will consider is ${}^{3}S_{1}$! ${}^{3}S_{1}$, and has coupling C₂. Therefore for a ${}^{3}S_{1}$! ${}^{3}S_{1}$ scattering process, where the incoming nucleons have momenta p_{1} , p_{2} and polarization i, and scatter into states with momenta p_1^0 , p_2^0 and polarization j, the Bom amplitude arising from the contact interactions is

The form of the C₂ am plitude is xed by Lorentz invariance (which is equivalent to G alilean invariance to the order we work), and by the norm alization we used in ref. [1], where in the center of m ass frame, where we dened the amplitude to be iC_2p^2 , p $\dot{p}_1j = \dot{p}_1^0j^1$. As discussed in appendix B, while one can construct a two-body contact interaction with one factor of Q_0 instead of two gradients, for any S-m atrix element (including those involving the deuteron) one can use the equations of motion to eliminate time derivatives for gradients. Thus no independent Q_0 contact interaction needs to be introduced.

Including gauge elds introduces several two-body contributions to the electrom agnetic current. Firstly, the C₂ interaction described above becomes gauged. Secondly there are two new two-body magnetic moment type interactions. In order to write L₂ compactly we de ne the matrix P_i which projects onto the ${}^{3}S_{1}$ state,

where the matrices act on the nucleon spin indices, while the matrices act on isospin indices. Then the two-body Lagrangian may be written as

¹T he couplings C_0 , D_2 and C_2 are the same couplings that appear as $C_0^{(3S_1)}$, $D_2^{(3S_1)}$, and $C_2^{(3S_1)}$ in refs. [1]; we drop the ³S₁ designation here as there can be no confusion with analogous couplings in the ¹S₀ channel.

where the ellipsis refers to contact interactions irrelevant for the deuteron channel, or of higher order than we will be considering. The new coupling L_2 corresponds to an interaction that did not enter the calculation of N N scattering, but which a ects the deuteron m agnetic form factor. As written, eq. (2.15) is not chirally invariant, which can be remedied by an appropriate insertion of the elds; how ever, since the two-body operators with pions do not contribute at NLO, we om it them.

B.Power counting

We begin by summarizing the results of refs. [1]. The starting point is the e ective Lagrangian for nucleons, pions and photons introduced in the previous section. The part of the Lagrangian describing purely mesonic interactions, as well as interactions between m esons and a single baryon, is the conventional chiral Lagrangian. In addition there are local interactions corresponding to short distance interactions between two nucleons. These contact interactions are expanded in powers of derivatives and insertions of the quark mass matrix, m_a. (Isospin violation from the di erence between the up and down quark masses is neglected. Consequently insertions of m_q are equivalent to factors of m^2 .) The lowest dim ension operator is a four ferm ion contact interaction; there are two independent operators of this form, corresponding to the ${}^{1}S_{0}$ and ${}^{3}S_{1}$ channels. The next lowest dimension twobody operators involve a factor of p^2 , where p is the momentum of one of the nucleons in the center of mass frame, or a factor of m 2 . There are seven independent p^2 operators corresponding to diagonal matrix elements in the $f^{1}S_{0}$; P_{1} ; S_{1} ; P_{0} ; P_{1} ; P_{2} ; dhannels, as well as a ${}^{3}S_{1} = {}^{3}D_{1}$ m ixing term; there are two independent m² operators corresponding to the ${}^{1}S_{0}$ and ${}^{3}S_{1}$ channels. At higher powers of derivatives, the number of contact interactions quickly grows.

Central to e ective eld theory is a power counting scheme which allows one to calculate consistently to any given order in the low energy expansion. A main point in refs. [1] was to develop the PDS subtraction scheme which allows one to readily identify the order of any particular Feynman graph. The scheme involves computing loop diagram susing dimensional regularization, and then subtracting o the poles in dimensions D 4, which correspond to logarithm ic or power-law divergences. A typical integral in this scheme is

The last step includes the nite subtraction m andated in the PDS scheme. The parameter is the renorm alization scale and physical observables are independent of it. In fact, one may set to zero and recover the usual m inimal subtraction scheme (MS) with = 0 if

one wishes². However, a change in must be compensated by the renormalization group ow of the couplings in the theory. Therefore, what is a weak coupling at one value of can be strong at another, which e ects how one de nest he power counting scheme.

Rapid scaling with is only an issue for two body operators, and then only for those a ected by the large scattering lengths in the ${}^{1}S_{0}$ and ${}^{3}S_{1}$ channels. Consider a four nucleon contact interaction connecting angular momentum states L and L⁰, where conservation of angular momentum and parity requires $JL = L^{0}j$ to equal zero or two. We assume that the operator involves m insertions of the quark mass matrix, and 2d (L + L⁰ + 2n) spatial gradients, and has a coe cient $C {}_{m,n}^{L,L^{0}}$. By examining the coupled renormalization group equations in the PDS scheme, one can determ ine that these couplings scale as

Here M is the nucleon mass, $g_A = 1.25$ is the axial current coupling and f = 1.32 MeV is the pion decay constant. Thus in the deuteron channel, C_0 ¹, while C_2 and D_2 scale as

 2 . Extending the analysis to include photons, we nd L $_2$ 2 as well.

The coe cients of the four-nucleon contact terms that have explicit factors of the electric eld E or the magnetic eld B scale similarly to those in eq. (2.17), counting gauge elds as derivatives. For example, the L_2 operator in eq. (2.15) counts as a two-derivative, $L = L^0 = 0$ operator, and its coe cient scales as L_2 . The rapid scaling of the operators contributing to S-wave processes is what makes our expansion di erent than the one proposed by W einberg [10].

A m ed with the above results, we are able to arrive at a particularly simple set of rules for determining the order of a graph. Choosing the scale p = m = Q we perform an expansion in Q, where

- 1. Each nucleon or pion propagator scales as Q 2 ;
- 2. Each loop integration $^{R} d^{4}q$ scales as Q⁵;
- 3. A gradient at a vertex contributes Q^1 , while each time derivative scales as Q^2 ;
- 4. An insertion of the quark mass matrix m $_{\rm q}$ at a vertex counts as Q 2 ;
- 5. The coe cient of the contact interactions scale according to eq. (2.17).

² In the M S scheme with = 0 one must rst integrate out the pion to avoid factors that diverge as $\log (m^2 = 2)$.

The rst three rules follow simply from the scaling of four momenta q appropriate to the nonrelativistic regime. Explicitly, M q₀ q^2 Q². The fourth rule is fam iliar from conventional chiral perturbation theory, m_q m² Q². The procedure for calculating physical quantities of interest is to write down the most general electrice eld theory consistent with gauge invariance, chiral symmetry and Lorentz invariance ³, and then compute the desired matrix element to a given order in the Q expansion, following the above rules. Note that according to the power counting rules, a loop with two propagators entails a factor of Q, while the coe cient of the lowest order N N contact interaction (C $_{dm}^{LL^0}$ with L = L⁰ = d = m = 0, de ned to be C₀) scales as 1=Q; thus any graph m ay be dressed by an in nite bubble chain with C₀ interactions without changing the order of the graph.

III.THE DEUTERON FORM FACTORS

A deuteron with four-momentum p and polarization vector is described by the state \dot{p} ; i, where the polarization vector satis es p = 0. An orthonorm albasis of polarization vectors $_{i}$ satis es

where M_d is the deuteron mass. It is convenient to choose the basis polarization vectors so that in the deuteron rest fram $e_i = i$. Deuteron states with these polarizations are denoted by \dot{p} ; $\dot{i}i$ (i.e., \dot{p} ; $\dot{i}i$) and satisfy the normalization condition

³R elativistic corrections are accounted for as perturbations according to the above power counting rules, and at the order we work the theory only appears G alilean invariant. The procedure for dealing with relativistic corrections perturbatively requires distinguishing between potential and radiation pions at NNLO, as discussed in [1].

where $_{\rm M}$ = 0:85741 (=2M) is the deuteron magnetic moment, and $_{\rm Q}$ = 0:2859 fm² is the deuteron quadrupole moment.

As shown in appendix A, the form factors are readily calculated by computing in perturbation theory the irreducible two-point function , and the irreducible three-point function

. In the present context, \irreducible" m eans the sum of graphs which do not fall apart when cut at any C_0 vertex. The m atrix elem ent of the electrom agnetic current is then given by the exact relation

where B is the deuteron binding energy and \overline{E} is the energy of the incoming two nucleon state in the center of mass frame,

where the ellipsis refers to relativistic corrections to the energy-momentum relation. \overline{E}° is the analogous quantity for the outgoing nucleon pair. By Lorentz invariance, and can only depend on the energy and momentum in this combination.

We can now expand the relation eq. (3.5) in perturbation theory and determ ine the form factors by comparing the result with eq. (3.3). The two-point function has the graphical expansion shown in Fig. 1, where the vertices represent the insertion of an interpolating eld D_i with the quantum numbers of a deuteron with polarization i. We take D_i to be




FIG.2. The expansion of ⁰. In all of these graphs, the photon corresponds to A_0 with the minimal coupling to the proton propagator, arising from the gauged nucleon kinetic energy term. The graph in the rst row is the leading O (Q⁻¹) contribution, ⁰₍₁₎. The second row are the subleading graphs at O (Q⁰), summing to give ⁰₍₀₎. In the third row are several graphs contributing at the O (Q¹): a dressing of the photon-nucleon vertex, a relativistic correction to the nucleon propagator, and an exchange current contribution.

where P_i is the projection de ned in eq. (2.14). The form factor one calculates does not depend on the particular choice for D_i , so long as it is used consistently.

By exam ining the graphs and using the power counting outlined in the previous section, one sees that begins at order Q¹ | the leading graph has two nucleon propagators and one loop. At subleading order, O (Q²), there are three two-loop graphs, one involving the exchange of a potential pion (which has a derivative coupling), one with an insertion of the C₂ (D)² two-body operator, and one with an insertion of the D₂m² two-body operator. Recall that with renormalization scale Q the coe cients C₂ and D₂ are O (Q²). At O (Q³) there are a host of diagram s, including the exchange of two potential pions, or one radiative pion, as well as p⁴ relativistic corrections to the nucleon propagator, etc. W e have calculated to O (Q²), and the results are presented in appendix A.

A. The NLO computation of the electric form factors

To compute the electric form factors F_c and F_Q we need to calculate the three-point function $^0_{ij}$, which is expanded graphically in Fig.2. The results for both the leading O (Q⁻¹) and subleading O (Q⁰) contributions are presented in appendix A. Once ⁰ is computed in the Q-expansion, the electric form factors can be determined by expanding eq. (3.5) as

where ${}^{0}_{(n)}$, ${}^{(n)}$ denote the O (Qⁿ) contribution to 0 and respectively. We have suppressed the q dependence of 0 , and its polarization indices. Furtherm ore everything is evaluated on-shell, $\overline{E} = \overline{E}^{0} = B$. Since d=d $\overline{E} = O$ (Q²), the rst bracket in eq. (3.8) is O (Q⁰), the second bracket is $0 (Q^1)$, etc. Therefore, taking into account the explicit factors of q in the de nition of the form factors, eq. (3.3), we see the electric form factors have a Q expansion of the form




FIG.3. The expansion of ⁱ, where the photon corresponds to the vector potential Aⁱ. The coupling of the photon to the nucleon lines represents the entire one-body current from L_1 , eq. (2.11), including the magnetic moment contribution. The rst graph is the LO contribution at O (Q⁰), while the remaining graphs are the NLO contributions at O (Q¹). The photon couplings arise through any of the operators in L_0 , L_1 or L_2 . We speci cally distinguish the C₂, D₂ and L₂ vertices by the symbols \blacksquare , and respectively.

O ur task in computing F_M is greatly simplified by recognizing from eq. (3.3) that we need only pick out contributions with spin structure anti-symmetric in the deuteron polarization vectors. (3.18), along with insertions of the C_2 operator or one pion exchange; there is also a contribution from the two-body current arising from the operator in eq. (2.15) whose coe cient is L₂. We nd that there are no pion exchange current contributions at this order, nor any two-body current contribution from the C_2 operator in eq. (2.15). With the exception of the two-body contribution involving an explicit factor of B (see eq. (2.15)), all the graphs contributing are all proportional to those giving rise to the electric form factors in Fig. (2). E ective range theory predicts the matter radius, r_m , with remarkable precision. Using $r_0 = 1.75$ fm e ective range theory yields $r_m^{(E\,R\,)} = 1.98$ fm. The most recent measurement of the deuteron charge radius is $r_{ch} = 2.1303$ 0.0066 fm from which the matter radius is found to be $r_m = 1.9685$ 0.0049 fm [12]. (In elective eld theory the elects that distinguish between the matter and charge radius don't arise until NNLO.) The numerical success of the prediction of elective range theory for the matter radius suggests that the most important higher order terms in elective eld theory are those that arise from iterating the NLO potential from C₂ and one-pion exchange. However, from the elective eld theory perspective this cannot be justiled since there are new local operators that will contribute at the same order.

E ective range theory can also be used to predict the magnetic form factor and it gives,

IV.COMPARISON W ITH DATA

We now compare the analytic results of our elective eld theory perturbative expansion for the deuteron form factors with experimental data. We have evaluated these expressions at the same renormalization point = m used in refs. [1] and have used the same value

derived from a t to the N N scattering phase shifts in the spin triplet channel. The values of C₀ and D₂ do not enter our expressions explicitly, but they do enter indirectly through the constraint on the two-point function that the deuteron pole occurs at the correct binding energy, eq. (A 6). G iven C₂ from the N N phase shift analysis, we have no new parameters at through NLO for thing the electric form factors. A swe have seen, for the m agnetic form factor, a single new parameter, L₂, enters at NLO.

We rst consider that static m on ents of the deuteron, at $q^2 = 0$. We have analytic form ulas for the charge radius, the quadrupole m on ent, and the m agnetic m on ent in eqs. (3.14), (3.16), and (3.21) respectively. A comparison of these values to experiment is given in

Table I. The charge radius shows a rapid convergence to the measured value, which is encouraging. The LO calculation is expected to be within 30% of the experim ental value, 10%. It is clear from Table I that while the NLO calculation is expected to be within this expectation is fulled. When the NNLO calculation is performed we expect that the result is within 3% of the experim ental value. The magnetic moment agrees well with experiment at LO, and then is t to the experimental value at NLO by choosing the strength L₂ of the two-body magnetic operator appropriately. The LO prediction for the magnetic m om ent is much closer to the experim ental value (within 3%) than naively expected from the power counting. The quadrupole moment vanishes at LO, and the NLO value of 0:40 fm 2 iso by 40%, as expected from the power counting. It would be useful to compute the NNLO contribution to $_{0}$ to see if it exhibits the same convergence as the charge radius. The idea of including pions perturbatively has been used previously to estim ate the deuteron quadrupole moment [14], obtaining a value of 0:40 fm². More interesting is that iterated potential pion exchange reproduces the deuteron quadrupole moment [8] reasonably well. This suggests that contributions to the quadrupole moment from higher order counterterm s are sm all compared to additional insertions of potential pion exchange. This sm allness is not something that arises naturally in the elective eld theory. It is also interesting that state-of-the-art nuclear calculations of the quadrupole m om ent [15] (0.270 fm^2) are system atically lower than the experimental value by 7%. This strongly suggests that dynamics beyond potential interactions are required, something that e ective eld theory provides a system atic way to include.

O f greater interest is the com parison of the form factors over a range of q^2 , as we should be able to see at what m on entum the expansion begins to fail; our naive estimate is that the expansion is in powers of $q=2_{NN}$ q=(600 MeV). The dimension for elastic electron-deuteron scattering is given by




FIG.4. A pbt of A (q^2) vs. q in M eV for elastic electron-deuteron scattering. The dotted curve shows the result of the LO calculation, while the solid curve is the NLO prediction. There are no free parameters at this order. The dashed curve shows the result of elective range theory.




FIG.5. A plot of B (q^2) vs. q in MeV for elastic electron-deuteron scattering. The dotted curve shows the result of the LO calculation, while the solid curve is the NLO prediction. There is one free parameter at this order, L_2 , which is xed to correctly reproduce the deuteron magnetic moment. The dashed curve shows the result of elective range theory.

We see that to the order we are working, A is sensitive only to the electric form factor F_c , while B depends only on the magnetic form factor F_M . A comparison of A and B with experimental data in Figs. (4,5) shows that our expansion is quite successful, and converging rapidly, in the kinematic regime where it is expected to work. The data for Fig. 4 was taken from ref. [16], and the error bars are smaller than the size of the points; the data for Fig. 5 com es from refs. [16{19}].

It is evident from Figs. (4,5) that the NLO e ective eld theory calculation of the deuteron form factors in not as accurate as what e ective range theory gives. The validity of e ective range theory over such a wide range of momentum occurs because of the smallness of the shape parameter, r_1 . In the eld theory expansion, the coe - cients in the eld theory range expansion them selves have perturbative expansions. However, ultimately when carried out to higher orders the eld theory calculations will be more precise than the eld theory range calculations. This is because the eld theory correctly describes the strong interactions, which eld theory only approximates.

V.CONCLUSIONS

We have demonstrated that one can compute properties of the two nucleon system to surprising accuracy simply by calculating several Feynm an diagram s. The technique for doing this was introduced in refs. [1] where it had been shown how to work at NLO for N N phase shifts in both spin singlet and triplet channels. W hile encouraging, those results were not de nitive as the NLO calculation required three free parameters in both spin channels. The true test of the theory has been presented in this paper with the computation of the electrom agnetic form factors of the deuteron | by using the parameters t to scattering

data, we are able to reproduce very well at NLO both the electric and m agnetic form factors in elastic e d scattering up to momentum transfers $\hat{q} = (400 \text{ MeV})^2 = 4:1 \text{ fm}^2$. Since our results are analytic, it is straightforward to analyze what features in the data are due to short versus long distance physics. A central feature of our expansion | that pion exchange is perturbative | is supported by the success of our t to the form factors.

O ne feature of our results which is especially encouraging is the evidence that the expansion is converging rapidly. This is apparent in the in provem ent of the tstoe d scattering data in going from LO to NLO, in provem ents in the static moments of the deuteron. The RMS charge radius presented in Table I deviates from the experimental value by 30% at leading order, but only 10% at next-to-leading order. The magnetic moment was o by 3% at leading order, and exact at next-to-leading order, due to the contribution of a new operator. At NLO the results of e ective eld theory for the electric and m agnetic form factors of the deuteron, F_C (q²) and F_M (q²), are not as accurate as those from e ective range theory. However at NNLO the e ective eld theory approach should reach (or even surpass) the precision of e ective range theory. Furtherm ore, the methods developed in this paper can be used to make predictions for other properties of the deuteron, including those for which e ective range theory is not applicable.

Since the NLO result for the quadrupole form factor is the rst nonvanishing term in its expansion, it is expected to work less well. At the level we are working, the quadrupole form factor does not contribute to e d scattering, how ever, we can compare the quadrupole moment with experiment, and it is 40% too large. We expect this error to be substantially reduced in the NNLO calculation, which includes among other things the exchange of two potential pions, and short distance ${}^{3}S_{1}$ ${}^{3}D_{1}$ transitions. In general, it would be interesting to compare NNLO results for all of the form factors. O there exists that enter at this order are relativistic corrections, radiation pions, and nucleon form factors.

There remain a number of NLO calculations to be done in the two nucleon system, and we are optim istic about their success. Extending this procedure to the three body system and beyond remains a fascinating challenge [20].




FIG.7. The expansion of full three-point function G % = 0.11 in terms of the irreducible two- and three(point functions , .

A s discussed in the text, the calculation of the parts of i which are antisymm etric in the deuteron polarizations is completely analogous to the complete calculation of 0 presented here.

APPENDIX B:NO OFF-SHELL AM BIGUITY | AN EXPLICIT COMPUTATION

W hen working with potential models for N N interactions one offen faces am biguities about how to continue matrix elements o -shell. In an elective eld theory approach, there is no such am biguity. All uncertainties arising in a consistent calculation are due to higher order operators neglected at the order one is working [21]. To illustrate this, we consider the elect of the operator




FIG.8. Feynm an diagram s contributing to the matrix element of O_1 and O_2 . The gray circle denotes an insertion of the operator O in eq. (B1).

 Q_{em} being the electric charge m atrix. The operator O is not G alilean invariant but nonetheless we can in principle consider how it enters the NLO calculation of the deuteron form factors via the graphs in Fig. 8. However, to the order we are working, it vanishes by the equations of m otion,

One might naively think that the equations of motion imply that the operator O will not enter a calculation of N N phase shifts (as the nucleons are on-shell in that process), yet that O will a ect deuteron matrix elements, since the nucleons are not on-shell in a bound state. This would mean that a new constant enters the deuteron calculation which cannot be determined vis N N scattering.

However, this is reasoning is incorrect, and we now show by explicit calculation that operator 0 does indeed vanish when considering deuteron matrix elements. This result is consistent with general theorems of eld theory that state that o -shell matrix elements are arbitrary (they can be changed by making a eld rede nition) and that the S-matrix elements never depend on them (even when the matrix element is between bound states).

As an example, consider the contribution to the deuteron three-point function 0 of the operator 0 in the graphs of Fig. 8, corresponding to the matrix element

It follows that the sum of the three graphs in Fig. 8 vanishes, and there is no o -shell ambiguity arising from this new operator O. Sim ilar remarks hold for other operators with a single time derivative. Therefore we can choose to only include the two spatial derivative operators in the Lagrangian (our interaction proportional to C_2) and to elim inate the analogous operators with a time derivative by the equations of motion | even though we are considering nucleons bound in a deuteron. This result is not peculiar to the particular regularization scheme we used.
