Soliton Interaction with an External Traveling W ave

The dynamics of soliton pulses in the Nonlinear Schrödinger Equation (NLSE) driven by an external Traveling wave is studied analytically and num erically. The H am iltonian structure of the system is used to show that, in the adiabatic approximation for a single soliton, the problem is integrable despite the large number of degrees of freedom. Fixed points of the system are found, and their linear stability is investigated. The xed points correspond to a D oppler shifted resonance between the external wave and the soliton. The structure and topological changes of the phase space of the soliton parameters as functions of the strength of coupling are investigated. A physical derivation of the driven NLSE is given in the context of optical pulse propagation in asymmetric, tw in-core optical bers. The results can be applied to soliton stabilization and am pli cation.

I. IN TRODUCTION

Investigations of the externally driven N onlinear Schrödinger (NLS) equation date back to the sem inal work of K aup and N ewell [1] on the AC -driven dam ped NLS equation. That work was also one of the pioneering papers in which a perturbation method for solitons based on the Inverse Scattering Transform (IST) technique was developed. Externally driven NLS equation arises in m any applications, m ainly in the context of solid state physics, such as long Josephson junctions [2] and charge density waves [3]. The same equation describes plasm as driven by RF elds [4]. M uch attention has been paid to the study of chaotic phenom ena in the phase space of the soliton parameters of the driven system [5{7], and to the formation and stability of soliton states unique to the driven system [7,8]. Problem s of generation of solitons via a coupling to external perturbations have been also investigated, for a hom ogeneous AC -drive [9] and traveling waves [10].

In the model system that we shall consider (see Eq. (1) below) the perturbation term does not introduce dissipation (the system remains conservative), and the uniform time-dependent driving is generalized to a, spatially dependent, driving eld. The physical background of our model system is the nonlinear pulse propagation in optical bers. In this case the driving force can assume, as will be shown in Sec. IV, the form of a Traveling wave coupled linearly to the NLS equation. The model system can be realized in the context of propagation of envelope optical pulses in twin-core optical bers. The aim of this work is to study the e ects of the driving eld on the dynamics of the NLS-solitons. The emphasis is on weak couplings, and the main motivation is stabilizing and controlling solitons by an external traveling wave.

W e will lim it ourselves to one-soliton pulses (that persist in an unperturbed NLS equation) and investigate the evolution of the parameters of the soliton when it is driven by a Traveling wave. This form of coupling preserves the H am iltonian structure of the equation, thus making possible to employ H am iltonian perturbation methods. W e will show that, in the adiabatic approximation for a single soliton, the problem is integrable despite the large number of degrees of freedom. W e will show that there exists a resonance, or phase locking, between the soliton and the driving eld. W e will see how this resonance is linked to the particle-like properties of solitons and how the resonance conditions are in uenced by the strength of interaction.

Transm ission of solitons over long distances is essential for the use of solitons as digital bits in optical transm ission lines [11]. This has been achieved by use of Iridium doped ber am pli ers [12]. Here we will suggest an alternative scheme that employs a twin-core optical ber. For identical bers with pulses centered around the same central frequency, the twin-core system is also term ed the Nonlinear Directional Coupler [13], and this system has been extensively investigated (see [14] and references therein). A symmetric twin-core optical bers were also investigated. Numerical investigation of the asymmetric coupler as a means of performing logical gate operations with solitons was carried out in [15]. In [16], \static" soliton states which can exist in these bers with a limited asymmetry, were investigated in the model of two coupled NLS equations, where new types of solitons unique to the twin-core ber were found.

In ourm odel, the two coupled NLS equations, which describe the evolution of optical pulses in asym m etric tw in-core bers, are reduced to a single NLS equation driven by an external traveling wave. We will see how the driving by an external wave can be used to stabilize soliton propagation in optical bers, suggesting that this scheme can be used in transm ission of solitons over long distances. We will also show how solitons can be amplied by the external Traveling wave with slow ly varying parameters.

The paper is organized as follows. In Sec. II we outline the Ham iltonian perturbation method for the NLS equation driven by an external traveling wave. In Sec. III we show that the reduced problem is integrable and investigate a novel type of resonance (phase locking) between the soliton and the external wave. The linear stability analysis of this resonance is performed, and the structure and topological changes of the phase plane are investigated, analytically and num erically. A physical derivation of the driven NLS equation and possible applications are presented in Sec. IV. Sec. V summarizes our results.

II. HAM ILTON IAN PERTURBATION METHOD FOR THE DRIVEN NLS EQUATION

Consider the NLS equation coupled to an external traveling wave eld:

where we use dimensionless variables (see Sec. IV for the corresponding physical units in the case of optical bers). In Eq. (1) " is the (norm alized) strength of the coupling, and it is assumed to be small: " 1. A lso, ! and k are the (norm alized) frequency and wave number of the driving eld, respectively. For specic physical models ! and k are related by an appropriate dispersion relation.

The unperturbed (" = 0) version of Eq. (1) is completely integrable [17], and its most interesting solutions are solitons. The full one-soliton solution is given by:

where , p, \hat{q} and " are free parameters. The quantity denes the amplitude and width (1=) of the soliton, p is the soliton's velocity, $2\hat{q}$ is the location of its \center of m ass", and " is its initial phase.

Eq. (1) has Ham iltonian form, as it can be obtained from the variational derivative of a Ham iltonian:

where the Ham iltonian is given by

Here is the complex conjugate of , and < and = are the real and im aginary parts of a complex number.

For the unperturbed system, " = 0, the four parameters of the single-soliton solution (2) form a Ham iltonian dynamical system [18]. For the variables $q = q - \frac{p}{2}t$, and $' = '' - \frac{\binom{2}{2}p^2}{4}t$, the soliton amplitude becomes the canonicalmomentum conjugate to the coordinate ' while the soliton velocity p is the canonicalmomentum conjugate to q. The (reduced) one-soliton Ham iltonian of the unperturbed system is given [18] by:

Going back to the perturbed system, " \notin 0, we will employ the adiabatic approximation and investigate slow variations of the soliton parameters caused by the external eld. In doing so we neglect radiation e ects and possible form ation of other solitons. This approach is physically motivated in the context of interaction of soliton pulses in optical bers, where a typical initial condition is a single soliton solution of the unperturbed NLS equation. It is known that solitons are robust objects, especially in the case when the perturbations to the integrable system are H am iltonian [19]. Therefore, for weak couplings, it is reasonable to expect that the main e ect will be that of the solitons persisting, but slow ly changing their parameters.

It is advantageous to preserve the important H am iltonian properties of the perturbed problem. Therefore, we will treat the perturbed system as a H am iltonian system in the phase space of the one-soliton parameters driven by the external eld. The driving term is obtained directly from the H am iltonian (4). Indeed, by inserting the unperturbed solution $_{sol}$ with time-dependent parameters from Eq. (2) into the H am iltonian (4), we obtain:

The Ham iltonian (6) describes a dynamical system with two and a half degrees of freedom, as it is nontrivially coupled to an explicitly time-dependent driving force. As the dependence of the Ham iltonian upon ' and t enter only through a linear combination of these variables, a simple canonical transformation (see below) will eliminate the explicit time dependence, thus yielding an integral of motion: the new Ham iltonian. The new Ham iltonian with two degrees of freedom may still seem non-integrable, and one is tempted to look for chaos in this system. We will show, how ever, that because of the existence of an additional integral of motion, the one-soliton problem is actually integrable and can be fully investigated analytically. Form ally, integrability occurs for any ". We expect, how ever, that the adiabatic approximation (that neglects radiation and possible creation of other solitons) will be valid only for small enough ". Therefore, we will treat the driving term perturbatively and correspondingly require that " 1.0 n the other hand, one should assume that > 1, to make the contribution of the nonlinear term in the NLS equation signi cant. This means that " which will be assumed to hold in the follow ing.

It can be easily checked that the perturbed one-soliton H am iltonian (6) has an additional integral of m otion,

This integral follows from the complete, irreduced system, Eq. (1), possessing an exact conservation law:

where = $\exp[i(kx !t)]$. Indeed, inserting the one-soliton Ansatz (2) for in Eq. (8), one immediately obtains Eq. (7).

Note that the single-soliton solution form, Eq. (7) in our case, of exact integrals of the type (8), is only an approximation, valid as long as generation of radiation and formation of other solitons are ignored. Even so, it is a good approximation [19,14] when studying single soliton evolution under Ham iltonian perturbations.

We now choose the integral of motion (7) as a new momentum and make the corresponding canonical transform ation in the one-soliton parameters' phase space. Simultaneously, we exploit the abovem entioned symmetry in the time dependence of the one-soliton H am iltonian and introduce the new phase (see below). The generating function of this canonical transform ation is:

and the new m om entum P is a constant of m otion of the system. Therefore, the H am iltonian (11) represents a system with one e ective degree of freedom and is therefore integrable. This fact excludes any possibility of chaotic m otion [20] in the reduced, one-soliton system.

Let us investigate possible resonances between the external wave and the soliton. In the language of the H am iltonian (11), an exact resonance is related to a stable (elliptic) xed point. Looking for xed points, we should equate @H =@R and @H =@ both to zero. This yields two conditions. The st is

an exact condition, valid in all orders of ". W riting down the second condition, we will rst lim it ourselves to the zero order approximation with respect to ":

The non-trivial, multi-valued resonance condition for the momentum R arises from the non-standard dependence of the H am iltonian (11) on the momentum R.

From Eq. (13) we obtain two conditions for the existence of a resonance between the driving eld and soliton. First, $k^2 > 1$, which is a condition on the dispersion relation of the external wave alone. Second, $4k^2 = 1^2 > P^2$, which is a condition on the parameters of the soliton and the external wave.

The linear stability of the xed points (12) and (13) is determined by the sign of the product FG, where $G = (P^2 H_0 = QR^2 (R = R_0))$ (H₀ is obtained from the Ham iltonian (11) by setting "to 0), and F = " $\cosh^{-1} P = 2R_0^2$

The phase plane of the system (11) for a relatively weak coupling (" = 0.3) is shown in Fig. 1. The four-valued, in R, xed points are clearly seen. The coordinates of the xed points, found num erically, agree very well with the values given by Eqs. (12) and (13).

Fig. 2 shows the phase plane of the system (11) for a stronger coupling, " = 0.6.0 ne can see that a topology of the phase plane has changed. Four out of the eight xed points have disappeared. In order to explain this bifurcation, we should modify the resonance condition, Eq. (13) and take into account higher order corrections in ".

In the storder in "the resonance condition for R becomes:

where the values for R_0 should be taken form the zeroth approximation (13). From Eq. (14) we can see that indeed not all the xed points which were present when " was small (see Eqs. (12) and (13)) still persist when the coupling is increased. For a given P, when

two of the resonant values of R do not exist anym ore, thus leading to a topological change in the phase plane, as observed in Fig. 2.

Now let us discuss the resonance condition in physical term s. Transform ing back to the \lab" coordinates, using Eq. (10), we can write the resonance condition = 0 as

But P is a constant of motion of our reduced system, so $P_{-} = 0$. Also, $R_{-} = 0$ at resonance. Therefore, Eq. (16) reduces to

From Eq. (18) we can see that the resonance described by the reduced H am iltonian (11) is a D oppler shifted resonance between two waves: the external (pumping) wave with the wave number k and frequency !, and the carrier wave of the soliton with the wave number and frequency !. It is interesting that there are two D oppler shifts in the resonance condition. The rst D oppler shift enters the right hand side of Eq. (18), and it is by the center-of-m ass velocity of the soliton. The second D oppler shift, entering the left hand side, is less intuitive, and is also by the center-of-m ass velocity of the soliton, but this time with the soliton carrier wave's wave number. This problem provides us with another non-trivial example of particle-like properties of solitons.

Let us bok at the limiting case of k ! 0, in which the system should reduce to well known resonance with a hom ogeneous AC-drive [1]. For ! < 0 and p = 0 (which are the parameter values studied in [1]), the constant of motion P = 0 and the resonant values of the soliton's amplitude are reduced, see Eq. (13), to $= R = \frac{P}{2!}$, as obtained in [1]. For ! > 0, we not from Eq. (13) that since $k^2 > !$ must hold there will be no resonance for k = 0. So that in this case the resonance is unique to a coupling to an external travelling wave.

A nother interesting limiting case is when the values of the wave vectors of the driving eld and the internal soliton wave are close to each other. That is k' = p=2. This translates (see the transform ation (10)) to P ! 0. From Eq. (14) we can see that in this limiting case the reduced system will be exactly at the bifurcation point, for all values of ". Note that for = 0, also $v_s = 0$ so that the resonance (18) is reduced to a simple resonance.

In this Section we will present a physical derivation of Eq. (1). We will start with the equations for the envelopes of pulses in the cores of two adjoining, closely spaced, non-identical, single-mode bers (twin-core optical bers) [21,22]:

The coordinates x and t in Eqs. (19) are written in the \soliton units" [23] corresponding to Eq. (19a). The couplings $_{12}$ and $_{21}$ result from the overlapping of the evanescent eds of the transverse berm odes with the eds in the adjoining ber cores. Since the bers are not identical, the coupling is not symmetric, i.e. $_{12} \in _{21}$. It is assumed that the transverse berm ode is not a ected by the proximity of the adjoining ber, and by the identical transverse m ode in it. We also assume that the interaction term arising from the cross phase m odulation (term proportional to j $_{1j}^{2}$ $_{3}$ $_{1j}$ is the ratio of the nonlinearity strengths in the two bers, where [24]

 A_i^e is the elective core area (which scales like 2_i , ${}_i$ being the ber core radius), n_2 is the K err coe cient, c is the speed of light, and $!_i$ is the carrier frequency in each ber. The amplitudes ${}_i$ of the pulses are scaled, following [23], to $({}_i =)^{1=2} T_0$, where ${}_i$ is the dispersion coe cient of the pulses in Eq. (19a), and T₀ is the pulse width.

It follows from Eq. (20) that the inequality \notin 1 m ay result from the bers having di erent radii, in which case is the ratio between the radii of the ber cores of the two bers. A lso, if the bers are centered around di erent central frequencies !_i, then = (!₁=!₂)¹⁼². Let us continue our discussion of the di erent coe cients in Eq. (19). The coe cient ₁ is a measure of the di erence in the group velocity in Eq. (19b) from that in Eq. (19a). The coe cient ₂ is the ratio of the dispersion coe cients of the two bers. ₂ \notin 1 m ay result from the bers not having the same transverse wave numbers, or from the pulses in the bers being centered around di erent central frequencies. The di erent carrier frequencies and/or transverse wave numbers also lead to the bers having di erent phase velocities. This fact results in the oscillatory term in the interaction, with \hat{k} and \hat{k} being the m ism atches in the wave-num ber and frequency, respectively. This oscillatory term arises in the evaluation of the overlap integral of the transverse m odes of the two bers. Notice that, as the coupling in Eqs. (19) is asymmetric, it is not possible in general to cast the system in a Ham iltonian form as it was done in [22]. We will show below, how ever, that in a certain lim it the system (19) can be reduced (see Eq. (22)) to an equation possessing Ham iltonian structure.

We assume that the interaction term (the rh.s.) in Eq. (19a) is much larger than the interaction term in Eq. (19b): 12 21= . This condition in plies that 1 which occurs when the ratio between the radii of the two bers is large, and when the carrier frequencies are not the same. Under these conditions the interaction term in Eq. (19b) can be neglected, and Eq. (19b) is decoupled from Eq. (19a) in the sense that it only enters as a driving term in Eq. (19a), while there is no back action. Now, if we further assume that the pulses described by Eq. (19b) are in the positive (norm al) dispersion regime then there is no modulational instability [24] in Eq. (19b), and stable linear dispersive waves can propagate in the ber. We are interested in the small am plitude lim it of Eq. (19b), when the pulses are just linear waves. In this case we can drop the term arising from the Kerr nonlinearity. Then the set of equations (19) can be written as:

where $" = _{12}$. Therefore the system (19) reduces to a single NLS equation driven by an external Traveling wave. The equation for $_{1}$, Eq. (21a), can be written (om itting the indices) as:

where the dispersion relation (K) is given by the equation for $_2$ in Eq. (21b) together with the phase m ism atch \hat{k} and \hat{k} from Eq. (19).

Eq. (22) is equivalent to Eq. (1) with x and t interchanged, K = !, and = k. Therefore we can apply the results obtained in Sec. III to the analysis of the dynam ics of soliton pulses in twin-core bers, under the conditions that lead to Eq. (22).

O ne application of our results is soliton phase locking. The resonance conditions [see Eqs. (12) and (13)] correspond to the soliton's parameters being phased locked to the driving eld. For the stable xed points this allows xing of the soliton parameters (see also Fig. 1). Speci cally, the soliton amplitude , see Eq. (2), is constant. The values of the soliton parameters for which the resonance condition is satis ed are given, using Eq. (10), by Eqs. (12) and (13), and by the value of the constant of motion, Eq. (7), which is determined by the initial conditions of the soliton pulse and by the parameters of the driving eld. Furtherm ore, the resonance is sustained, as can be seen from Fig. 2, also for large values of coupling (" in Eq. (1)), only that the number of resonances is decreased (see Eq. (14)).

The phase locking can be used in order to stabilize solitons. In any real soliton transmission system there exists dissipation due to ber losses. The dissipation will result in a decrease of the solitons' am plitude. The dissipation can be incorporated into the NLS equation by the addition [24] of a perturbation term in the form i . Although the dissipative term cannot be directly included in our H am iltonian perturbation approach, we can anticipate, in analogy to the problem of a driven dam ped oscillator, that by keeping the soliton's parameters in resonance with the driving eld we will be able to overcome the elect of the losses in the system. In this case, the elliptic is a points of F igs. 1 and 2 will become attracting points.

A nother application for which the coupled system can be used is soliton amplication. The amplitude (in Eq. (2)) of the soliton can be increased for pulses which parameters correspond to periodic orbits surrounding stable xed points (see Figs. 1 and 2). The period of oscillations for the stable orbits is long and, for sm all oscillations, is given by $m^{1-2}FG$, where F and G were de ned following Eq. (13). By a proper choice of the initial conditions and interaction length the soliton amplitude can be increased by performing a half period of nonlinear oscillation around a stable xed point.

A nother m echanism, by which the amplitude of solitons can be increased more signi cantly, is the \D ynam ic A utoresonance" [9,10,25]. The frequency of nonlinear oscillations depends on their amplitude. Therefore, the in nite grow th of the amplitude, obtained for a linear, dissipation free oscillator driven by a resonant external force, is not possible for a nonlinear oscillator with constant param eters. By \chimping" adiabatically the driving eld's frequency, one can preserve the phase plane structure so that the oscillator will continue to perform nonlinear oscillations around the (tim e dependent) resonant value of the action variable, R in Eq. (11) in our case. The soliton param eters will rem ain phase locked in resonance with the (slow ly varying) driving eld. Since R is the soliton amplitude, see Eq. (10), this mechanism provides a means for substantially increasing the soliton amplitude in a resonant manner.

V.SUMMARY

We have investigated the evolution of single-soliton pulses of the Nonlinear Schrödinger (NLS) equation driven by an external traveling wave eld. This system, even though not integrable, is still H am iltonian. U sing the H am iltonian structure and adiabatic approximation for a single soliton, we reduced the perturbed NLS equation to a two-and-ahalf dimensional H am iltonian system in the phase space of the parameters of the single soliton solution. One integral of motion in this system results from the fact that the time-dependence drops out in a rotating reference frame. An additional integral of motion is a consequence of an exact integral of motion in the complete, unreduced partial di erential equation. Therefore, the reduced system becomes e ectively one-dimensional and therefore integrable. Physically, the reduced system represents a nonlinear oscillator (with an unusual form of the H am iltonian) coupled to an external harm onic force. The phase plane of this system was investigated analytically and num erically, and a good agreement between these two was found. As the coupling strength increases, there occurs a bifurcation in the phase plane of the reduced system. This bifurcation has been explained analytically.

W e gave a physicalm otivation to this model by showing that dynamics of soliton pulses in twin-core, non-identical, single-mode optical bers can be reduced to a system in which the dynamics in one core are governed by a NLS equation driven by a linear Traveling wave propagating in the adjoining core. In this regime, one can neglect the back action of the nonlinear wave on the linear wave.

F inally, we discussed possible applications of our results to stabilization and amplication of soliton pulses in the asymmetric, twin-core optical ber.
