# $T$ he $m$ om ent $m$ ethod in general $N$ on linear Schrodinger E quations

#### Abstract

In this paper we develop a new approxim ation m ethod valid for a w ide fam ily of nonlinear w ave equations of $N$ on linear Schrodinger type. T he result is a reduced set of ordinary di erential equations for a nite set of param eters $m$ easuring global properties of the solutions, nam ed mom enta. W e prove that these equations provide exact results in som e relevant cases and show how to im pose reasonable approxim ations that can be regarded as a perturbative approach and as an extension of the tim e dependent variationalm ethod.

The solution of nonlinear w ave equations representing physically relevant phenom ena is a task of the highest interest. H ow ever, it is not possible to nd exact solutions except for a few sim ple cases where one is lucky to integrate the equations involved. In particular, in the 70's som em athem atical techniques w ere discovered which allow ed the integration of several relevant nonlinear w ave equations ${ }_{[1]}^{[1]}$ 1. So the developm ent of rigorous approxi$m$ ation $m$ ethods is of interest in those cases where the equations are known to be non-integrable.

O ne fam ily of nonlinear wave equations with lots of practical applications is that of N onlinear Schrodinger
 biom olecule dynam ics, fundam entals of quantum $m e^{-}$ chanics, beam physics, etc., but specially in the elds of $N$ onlinear O ptics [ $\left[_{i}^{4}\right]$ and Bose\{E instein condensation [Fַ1] . In the last two elds a great variety of these equations appear involving di erent spatial dim ensionalities, nonlinear term s (saturation, polynom ial, nonlocal, losses, etc.) and num ber of coupled equations.

O ne com $m$ on approxim ate theoretical approach to the analysis of the dynam ics involved in those problem $s$ is to assume a xed shape for the solution $w$ ith a nite set of tim e dependent param eters so that the dim ensionality is $m$ ade nite at the cost of loss of inform ation on the solution ( $m$ any degrees of freedom are lost). This $m$ ethod receives $m$ any denom inations depending on the context: collective coordinate technique, tim e-dependent variationalm ethod, equivalent particle approach, energy balance equations, etc.

A though not explicitly stated $m$ ost of those $m$ ethods can be reduced to a more elegant form ulation which is the tim e dependent variational technique, originally developed by A nderson [ $[\underline{6}]$ for one dim ensional problem s based on R itz's optim ization procedure. This approxi-
$m$ ate technique is a good tool to study the propagation of distributions having sim ple shape. If the shape of the actual solution is close to the trial function, the outcom e of variationalm ethod w illbe in good agreem ent w ith the realsolutions, otherw ise it $m$ ay be very rough or even fail [7] ${ }^{1}$. D espite of this fact the technique has been used in m any physicalsituations. In N onlinear O ptics it hasbeen applied to $m$ any problem s som e of them being listed in Ref. [id $\left.{ }^{1}\right]$. The $m$ ethod has been applied to $m$ any other physical problem s where nonlinear wave equations (in particular NSEs) arise including random perturbations $[\underline{10}]$, nonlocal equations $[1]$ propagation and scattering of nonlinear $w$ aves [13], etc. A review of the application of the technique with em phasis on problem swith di erent scales (focused in condensed $m$ atter) is given in $R$ ef. [14]. This technique has been also used in the last years in the fram ew ork ofB oseE instein condensation (BEC) applications to explain the low energy excitation spectrum of single [15] and double [12리 condensates, collapse dynam ics [12 $\left.{ }^{1} 1\right]$ and $m$ any other problem s [1] 1

In this letter we develop a com pletely di erent technique called the $m$ om ent $m$ ethod [ $101{ }^{\prime} 1$ ]. This $m$ ethod is based on the de nition of several integral param eters whose evolution can be com puted in closed form and has been used to obtain exact results in particular applications $\left[1 \overline{1}_{2}^{\prime},\left[\overline{2} \overline{1} \overline{1}_{1}^{1}\right]\right.$. W e provide here a general fram ew ork for its application as w ell as severalw ays to treat it system atically as a perturbative technique.

The general NSE and m om ent equations.- Let us consider the n -dim ensionalN SE

Here D G is a shorthand notation for $G() \quad g()$. $T$ hrough this paper wew ill concentrate in the $m$ ost com $m$ on case $(j \jmath ; t)=(t)$ for which the equations are

A s stated before, som e of these law s can be found in other treatm ents [B] [1] [1] which m ostly concentrate on particular cases or treat them as basis for perturbation $m$ ethods choosing one particular shape for the solution. From Eqs.

In conservative systems $w$ th any type of potential the classical result of $Q$ uantum $M$ echanics $d h x_{i} i=d t=$ $h @ V=@ x_{i} i$ is obtained as described in $\left.[1] \overline{1}_{1}\right]$.
O nœe Eqs. (3and are integrated one is left with the problem ofsolving the rem aining $3 n+1$ equations. Typically these equations do not form a closed set but involve integral quantities which are not included in the de nitions of the $m$ om enta. To close them, i.e. to equal the
num bers of equations and of unknow ns, one $m$ ust either restrict the problem or im pose som e kind of approxim ation.

E xact closure of $m$ om ent equations. $-W$ e have found only tw o relevant cases in which the closure is exact for the rest of the equations. B oth sim pli ed problem s correspond to conservative, $=0$, spherically sym m etric potentials, ! ${ }_{i}=$ ! ( $t$ ) where

Here M a constant that depends only on the initialdata and interaction strength $U$. This equation has been used to prove the existence of extended resonances in $R$ ef. $\left.{ }_{[2]}^{2} \overline{1}_{-1}^{1}\right]$.

A nother am ple fam ily of system $s$ for which $m$ om ent equations are closed and exact is those with a timeindependent interaction strength, $@ G=@ t=0$ (the usual case), and a divergenceless velocity distribution (given by the phase gradient) div ( $r$ ) $=4=0$ :This condition im poses no restriction on the density distribution and is autom atically satis ed by the well known vortex-line solutions, which in $n$ spatialdim ensions read

$H$ ere $X$ are free, tim e dependent param eters, and 0 is arbitrary. W ith those simple conditions we get an innite num ber of constants of evolution nam ed \superm om enta", Q (F) F ( ), built up from di erentiable functions of the m odulus, $F$ ( ), that satisfy the regular-斗y conditions. In these cases one can prove that $D$ is a constant and that Eqs. ( $\left.\bar{S}_{1}^{\prime}\right)$ becom e equivalent to Eq. (G)

U niform divergence approxim ation.- Intuition dictates that the zero-Laplacian phase condition is related to (a) the con guration of the cloud, i.e. , does not change, (b) the soliton or the wavepacket is either stationary or at $m$ ost su ers displacem ents and rotations and (c) all of the \superm om enta" depend solely on the norm, $Q(F)=f(\mathbb{N})$. General solutions have nonzero divergence of the velocity eld, thus the zeroth order approxim ation, $4=0$, fails to describe the system. The next possibility is a rst order approxim ation in which the Laplacian of the phase is uniform. As we will see,
this extension now allow sfor changes in the shape of the cloud and introduces three new independent variables in the superm om enta Q ( $F$ ). M athem atically, the rst order approxim ation the phase is

where ${ }_{B}(x ; t)$ is any function satisfying $4 \quad$ в $=0$. This approxim ation $w$ illbe called uniform divergence approxim ation on the phase in what follows. A lim ited version of this approxim ation that uses a linear function (which has zero divergence) in place of B was rst applied to radially sym $m$ etric problem $s$ in $R$ ef. "R] and to the study of resonances in general 3D forced NSE problem $s$ in $R$ efs. $[1,21]$. In that case, were $(x ; t)=$
$0(t)+\sim x+\quad j j(t) x_{j}^{2}$ it is evident that the approxim ation consists on a Taylor expansion of the phase or even better a polynom ial tting $w$ ith tim e dependent param eters. H ere we provide a general fram ew ork for the application of the technique to arbitrary NSE problem s. In a certain sense this is a generalization of the usual time dependent variational $m$ ethod but now no assum ption on the shape of the am plitude of the wave is needed and the phase has a free is approxim ated by a least-squares type tting with tim e-dependent param eters and only very general restrictions on the phase.

Let us rst take the case w ith $\mathrm{B}=\sim \mathrm{x}$. W e will assum e for simplicity that the nonlinearity is or can be approxim ated by a polynom ial

The dissipative term $s$ can be rem oved from the equations by rescaling the solution with $=\begin{gathered}\mathrm{R}_{\mathrm{t}} \\ 0\end{gathered}\left(\mathrm{t}^{0}\right) \mathrm{dt}^{0}$; so that ~ = e. W e will denote the mom enta obtained using ~ by a tilde, as in $W_{i}$. It is im portant to stress that Eqs . (3, ${ }^{3}$ ) do not close im $m$ ediately and it is necessary to study the $m$ onom ial superm om enta

where the constants $C{ }^{(m)} m$ ust be determ ined from initial data. $W$ e can use this property to estim ate all the integrals in which $G()$ appears, as a function of powers of the $m$ ean square $w$ idths. $U$ sing this, and de ning as before the naturalw idths, $\mathrm{R}_{\mathrm{i}}=\overline{\mathrm{W}_{\mathrm{i}}}$, in the general nonsym $m$ etric case we arrive to

where $M_{i}$ is a constant to be determ ined from the in itial data, and $G\left(R_{1}::: R_{d} ; t\right)$ is a function that $m$ ay be calculated from Eqs. $(\underline{9})$ and $\left(\underline{1}-\overline{3} \overline{3}_{1}^{\prime}\right)$. Finally, to interpret these results one $m$ ust rem em ber that the actualw idth of the cloud is actually $R_{i}(t)=R_{i}(t) e^{2}$.

Eq. (14i) $m$ eans that given an initialdata it is possible to com pute the evolution of the width (and all the mo$m$ enta of the initialdatum ) provided the parabolic phase is a good description for the solution. Them ethod is very pow erful as it accounts for the evolution of any solution that can be described in term sof a nite num ber ofm o$m$ enta (since higher orderm om enta are functions of low er order ones). Though $m$ uch $m$ ore general than the collective coordinate $m$ ethod the one presented here is sim pler to apply and extend since it only involves com puting the integrals in Eqs. (

W e m ust also rem ark that the phase is not restricted to be a polynom ial in $x$ as in Ref. [20 obtains inform ation when the solution has $m$ any other form s. For exam ple, if phase is of type ( $\overline{7}_{1}$ ), then one can com bine the tw o w idths from the plane on which the vorticity is present, $\mathrm{W}_{\mathrm{k}}$ and $\mathrm{W}_{1}$, into a radial one, R $W_{k}+W_{l}$ and the evolution of $R$ can be studied together $w$ ith the $w$ idths from the rem aining spatial directions.

Independent $m$ om ent approxim ation.- W e have seen that the uniform divergence condition leads to a closed expression for every $Q^{(m)}$ in term sof the widths $W_{i}$. A 1though this approach is $m$ ore powerful than the usual tim e dependent ansatz it is possible to im prove the mo$m$ ent $m$ ethod to higher precision. The basic idea is to assume that only a nite set of $m$ om enta are independent, the num ber of those independent $m$ om enta being related to the accuracy of the solution and nding expressions for higher order $m$ om enta as functions of low er order ones. For instance if only the $\mathrm{fN} ; \mathrm{W}$ ig m om enta are truly independent (as it occurs w ith the uniform divergence approxim ation) it is possible to nd expressions for the rest of the $m$ agnitudes in term sof these $m$ om enta. By scaling the $w$ ave $w$ th respect to one of the coordinates

This equation has a solution of the form re ected in Eq. (13) and also sim ilar expressions $m$ ay be derived for the rest of the unknown integrals in Eq. (2á). Thus, in the rst order case discussed here the $m$ ethod can provide a closed set of equations for any type of nonlinear term. In principle the procedure could be extended to higher precision approxim ation of the evolution of initial data. W ork on this point is in progress and w illbe reported in detail elsew here.

Finally we would like to point out that Eqs. $\overline{\overline{3}}$ ) can be used straightforw ardly by replacing (x) w ith an appropriate ansatz. In the conservative case, $=0$, this procedure is equivalent to R itz's optim ization procedure, w ith the advantages that one needs not build a huge Lagrangian integral, and that our central equations (2a) can also be applied to dissipative system $s$ that lack a Lagrangian density at all. It m ust also be rem arked that unless the ansatz has a phase di erent from ( $\overline{\hat{\beta}}$ ), one w ill alw ays arrive to Eq. (14).

In conclusion we have presented the $m$ om ent $m$ ethod in a general fram ew ork and discussed under which conditions it leads to closed equations for a nite set of param eters. The uniform divergence ansatz has been introduced as a way to im prove usual collective coordinate $m$ ethods and obtain a closed set of equations for any NSE w ith polynom ial nonlinearity and linear dissipation (w ith or without a parabolic tim e dependent spatial potential). $T$ he second $m$ ethod takes the zeroth, rst and second orderm om enta to be the only independent ones and builds analytical approxim ations for other $m$ agnitudes. It is an extension of the uniform divergence approxim ation that seem sto w ork for non polynom ic self-interaction energies.
