Logarithm ically Slow Expansion of H ot B ubbles in G ases

We report logarithm ically slow expansion of hot bubbles in gases in the process of cooling. A model problem rst solved, when the tem perature has compact support. Then tem perature pro le decaying exponentially at large distances is considered. The periphery of the bubble is shown to remain essentially static (\glassy") in the process of cooling until it is taken over by a logarithm ically slow ly expanding \core". An analytical solution to the problem is obtained by matched asymptotic expansion. This problem gives an example of how logarithm ic corrections enter dynam ic scaling.

D ynam ic scaling behavior of extended nonlinear systems out of equilibrium have attracted much attention in di erent areas of physics [1]. In continuum models dynam ic scaling is intimately related to self-sim ilar asymptotics of nonlinear partial di erential equations [2]. Som etim es logarithm ic corrections enter dynam ic scaling laws [1]. No general scenario for their appearance is known. One can say from experience that they appear in marginal cases, dividing (in an appropriate functional space) regim es with qualitatively di erent behavior. The aim of this work is to investigate one particular setting, of general interest, where logarithm ic corrections to scaling appear som ew hat unexpectedly: cooling dynam ics of hot bubbles in gases.

Heat transfer in gases, strongly heated locally, looks quite di erently from the simple picture provided by the linear heat di usion equation. The di erence is mainly due to the small-Mach-number gas ow that develops (even at zero gravity) owing to intrinsic pressure gradients. This conductive cooling ow (CCF) brings in cold gas from the periphery and strongly modiles the cooling dynamics. Some aspects of CCFs have been studied experimentally and theoretically, mainly in the context of the late stage of strong explosions [3[5]. In this Letter we report a new, striking feature of a CCF.We ind that, if the initial temperature prove decays rapidly enough at large distances [like exp(kjx]; k > 0], the hot bubble, while cooling down signi cantly, expands logarithm ically slow ly.

Starting from the continuity, momentum and energy equations for an inviscous ideal gas at zero gravity, and employing the small-M ach-number expansion, one arrives at the following nonlinear equation for the scaled gas temperature [3]:

where indices t and x stand for partial derivatives (a slab geom etry is assumed), and is the exponent in the power-law temperature dependence of the heat conductivity of the gas [6].

The scaled gas pressure stays constant (and equal to unity) in this approximation, so the scaled gas density is simply $(x;t) = T^{-1}(x;t)$, while the gas velocity is $v(x;t) = T \ \theta_x T \ \beta$]. Therefore, once solving Eq. (1) for the temperature, one can easily ind all other variables.

Eq. (1) has a multitude of similarity solutions:

T (x;t) =

where is an arbitrary parameter. Therefore, an interesting selection problem appears, like in many other situations in nonlinear dynamics of extended systems [2,7].

Eq. (1) has appeared in the context of cooling of the \ reball" produced by a strong local explosion in a gas β {5]. An explosion involves energy release on a time scale short compared to the characteristic acoustic time. In this case the preceding rapid stage of the dynam ics produces an inverse power-law dependence of the gas temperature on the distance from the explosion site [8]. It has been shown [3,4] that the exponent of this power law uniquely selects the scaling exponent . As the result, the reball expansion exhibits a power law in time.

A di erent type of local gas heating occurs when the tim e scale of the energy release is long com pared to the acoustic tim e, but still short com pared to the cooling tim e. In this case the initial tem perature pro le is more localized, as it re ects the spatial structure of the heating agent (for example, the radial intensity of laser beam). This regim e will be in the focus of this Letter. W e will see that there is no self-sim ilar asym ptotics to this problem. Instead, the solution approaches, at long tim es, a \quasisim ilarity" asym ptotics with logarithm ic corrections to scaling.

Consider rst a model problem when the initial tem – perature pro le has compact support: $T(x;0) = T_0(x) > 0$ at x 2 [L;L], and zero elsewhere. We will lim it ourselves to a temperature-independent heat conductivity, = 0. Despite this choice, the nonlinearity of Eq. (1)

persists. A sum e symmetry with respect to x = 0 and in pose the Neum ann boundary conditions: $0_x T(0;t) =$

 $(\mathfrak{g}_{\mathbf{x}} T (\mathbf{L}; t) = 0. A$ localanalysis of Eq. (1) near the edge of support of its solution T (x;t) shows that the support remains compact and unchanged for t > 0. Therefore, this model problem exhibits a complete localization. W hat is the late-time behavior of the temperature? The constancy of support in mediately selects = 0, so the sim - ilarity ansatz becomes $T_0(x;t) = t^{-1}(x)$. Then Eq. (1) yields (x) = (a^2=2)\cos^2(x=a) for x 2 [L;L]; (x) = 0 elsew here, and a = L=2. This simple similarity solution describes cooling of the hot bubble (and lling it with the dense gas) without any change in the bubble size.

Remarkably, T_0 (x;t) represents a long-time asymptotics for any initial condition that has compact support [L;L] and obeys the Neum ann boundary conditions. We will show here only that this solution is linearly stable with respect to small perturbations, and nd the spectrum of the linearized problem. Introduce new variables: u = tT (x;t) and = lnt. Eq. (1) assumes the form

while the similarity solution $T_0(x;t)$ becomes steadystate solution (x). Introducing a sm all correction v(x;) to this solution and linearizing Eq. (3), we obtain $0 v = \hat{L}()v$, where

and = x=a. We look for the eigenfunctions in the form of v(;) = e (). The general solution of the resulting ordinary dimensional equation is

where $_2F_1$ is the hypergeom etric function, C_1 and C_2 are arbitrary constants, a = 1 $(8 + 9)^{1=2} = 4$ and b = 3 $(8 + 9)^{1=2} = 4$. Requiring that the perturbation remains small compared to the unperturbed solution [and hence vanishes like (=2)² or faster at !=2], we nd the (continuous) spectrum of the linearized problem : 1 < 1. This result proves linear stability of the similarity solution T_0 (x;t). Notice the presence of gap between the upper edge of the spectrum = 1 and stability border = 0. Going back to physical variables, we nd that small temperature perturbations around the similarity solution exhibit a power law decay t ¹.

At this stage we notice that = 0 is a marginal case dividing two qualitatively di erent types of dynam ics as described by the fam ily of sim ilarity solutions (2). Indeed, solutions with > 0 describe power-law expansions β {5], while solutions with < 0 correspond to power-law shrinkings [9]. O ne can expect logarithm ic corrections to appear \on the background" of the special case = 0, when the initial condition does not have com pact support, but decays rapidly at large distances. Therefore, we assume that the initial tem perature pro le of the bubble is symmetric with respect to x = 0 and decays exponentially at large distances [10]. W e will continue using the new variables and require u(x;0) ! cexp(kjxj) at \dot{x} j! 1, where k and c are positive constants. One can always put k = 1 [11]. We will be interested in a long-time asymptotics of the solution: 1. Our rst in portant observation is that u(x;) = cexp(x) is an exact solution of Eq. (3). This traveling wave solution with a unit speed corresponds to a steady-state solution T(x) = cexp(x) in physical variables, and it represents the correct asymptotics of the solution to our problem at x ! +1 .W hat about the bubble \core"? W e will show that it can be described, at 1, by a \quasi-sim ilarity" solution plus sm all corrections:

and ::: $u_1 u_0$. One of our goals is to nd an asymptotic expansion for a ().

The leading term of a () can be guessed im m ediately. Indeed, expansion of $u_0(x;)$ in powers of x a()=2 near the point x = a()=2 begins with the term $a()=2)^2$. This is a wave traveling with speed (1=2) (x a=2 along the x-axis! Therefore, it is natural to look for a general traveling wave solution v(x;) = V(x)) of Eq. (3) with a unit speed and require that it behaves like $(z + const)^2 = 2$ at z ! 1 and like c exp(z) at z + 1, where z = x. If such a solution exists, we can match it with the leading term of the quasi-sim ilarity solution (7) in the region 1 a=2) (x a;1 z, once

Eqs. (7) and (8) have important implications. First, the temperature scaling with physical timet at the bubble center acquires a logarithm ic correction. Second, the bubble core expands logarithm ically slow ly. W e will show in the following that these are indeed correct results, calculate the subleading and sub-subleading terms for a (), and nd other attributes of asymptotic solution.

The general traveling wave solution of Eq. (3), V (z), obeys the second-order equation

that is soluble analytically. One integration yields

where W () is the product log function de ned as the solution of equation W $e^{W} = (see, e.g., Ref. [12], p. 751)$. The arbitrary constant in Eq. (10) has been chosen

to satisfy the required asymptotic behavior V (z) ! (z + const)²=2 at z ! 1 . Notice that, as V > 0 and V_z < 0, we should work with the negative branch of the product log function: < 0 and W () < 0.

Integrating Eq. (10), we obtain the traveling wave solution in an implicit form :

 $U(V) = \ln W \exp(1 V^{1})$ and C is an arbitrary constant.

To understand the asymptotic behavior of this solution at z ! 1 and z ! +1, we need to know the asymptotics of J (V). A fler som e algebra we obtain

Using Eqs. (11) and (13) we obtain:

The required asymptotic behavior V ! c exp(z) at z ! + 1 selects $C = _1$ ln c, so the traveling wave solution (11) is now fully determ ined. A fter some rearrangem ent, we rewrite the asymptotics (14) and (15) as

where = $_1$ $_2$ + (1=3) $\ln 2$ + $\ln c$.

The leading term in Eq. (16) corresponds to a steadystate solution in the physical variables, while the subleading term is exponentially small with respect to the leading one. This essentially static (\glassy") behavior of the solution at large distances re ects e ective di usion choking at small tem peratures.

Now let us return to the bubble core description, Eq. (7). Our basic assumption here (supported by the results) is that, in the asymptotic stage 1, the term s $u_0; u_1; :::$ depend on time only through the time dependences of a, of a and a, of a; a; :::, respectively. The sm all parameter of this expansion is a=a. In the zeroth approximation of this perturbation scheme, u_0 obeys Eq. (3) without the time derivative term. In the rst approximation we obtain the following linear equation:

where we have again used = x=a.

The zero modes of the operator \hat{L} are () = \cos^2 + $\cos \sin$ and () = $\sin \cos$. Looking for the general solution of Eq. (18) in the form of $u_1 = C_1()$ () + $C_2()$ () and de ning a() by the condition $u(0;) = a^2()=2$, we arrive at

where $\operatorname{Li}_{2}(\mathbf{x}) = \prod_{k=1}^{P} k^{2} \mathbf{x}^{k}$ is the dilogarithm (see, e.g., Ref. [12], p. 743). In the vicinity of = = 2

where $\tilde{} = 2$. Too close to = 2 the correction u_1 and its derivatives become larger than the zero-order solution u_0 and its corresponding derivatives, so the perturbation procedure breaks down. Therefore, the bubble core solution Eqs. (6), (7) and (19)] should be matched with the traveling wave solution Eq. (11)] in the region where j_x a=2j is small enough (so that the leading term of the asymptotics of u_0 is much larger than the subleading term s) but, on the other hand, large enough (so that u_1 is small compared to u_0). W orking in this region and collecting the leading contributions from u_0 and u_1 , we obtain after some rearrangement:

where x = x (=2) a (=3) <u>a</u> ln ($e^2 a = 4$).

Now we can perform the matching procedure. We require that the z! 1 asymptotics of the traveling wave solution, Eq. (17), coincide with the asymptotics (21) of the bubble core solution. This yields

where $B = 1 + _1 + _3 = 0.514362926:::, o(1)$ denotes terms that vanish as ! 1 and we have restored the k-dependence [11]. We see that the leading term in a() is logarithm ic in physical time t, and it coincides with Eq. (8). The subleading term behaves like ln ln lnt, while the sub-subleading term is constant.

The matching region is determined by the requirements that the subleading term in Eq. (21) is much less than the leading term, but much greater than the rest of terms. These yield an approximate condition $\ln^2 a \qquad x + \frac{1}{2} a \qquad a^{2=3}$, so that the matching region expands as ! 1.




FIG.1. The am plitude a versus the new time = lnt found num erically (dashed line) and analytically (solid line). The parameters are described in the text.

W e com pared the asym ptotic solution with num erical simulations. Finding logarithm ic corrections num erically usually requires going to very long times. Instead, we directly solved Eq. (3) in the new variables, which en-20, that is t 5 ⁸10Eq.(3) abled us to reach was solved on the interval x 2 (0;9) subject to the Neumann boundary conditions. The initial condition was $3(x^2 + 0:1)^{1=2}$, so that c = 2 and $u(x; = 0) = 2 \exp(-1)$ k = 3. The system length was large enough for the solution to enter the asym ptotic regim e before the expanding \core" reaches the boundary x = 9. Fig. 1 com pares $a = (2u(0;))^{1=2}$ found num erically with the prediction ofEq. (22). At long times the agreement is excellent. We also veried other attributes of the asymptotic solution.

In separate simulations that will be presented elsewhere [13], evolution of the same initial condition was investigated in the fram ework of the full gasdynam ic equations. Remarkably, the results essentially coincide, even for m oderate M ach numbers, with those obtained with Eq. (1). This shows robustness of the reduced equation in the description of CCFs.

In conclusion, we have show n that hot bubbles in gases expand logarithm ically slow ly in the process of cooling. By constructing an asymptotic solution, that matches a \quasi-sim ilarity" inner solution and a \glassy" outer solution, we have been able to see how logarithm ic corrections enter dynam ic scaling.
