# Phenom enological model of propagation of the elastic waves in a uid-saturated porous solid with non-zero boundary slip velocity

## Abstract

It is known that a boundary slip velocity starts to play in portant role when the length scale over which the uid velocity changes approaches the slip length, i.e. when the uid is highly con ned, for example, uid ow through porous rock or blood vessel capillaries. Zhu & Granick Phys. Rev. Lett. 87, 096105 (2001)] have recently experim entally established existence of a boundary slip in a New tonian liquid. They reported typical values of the slip length of the order of few m icro-m eters. In this light, the e ect of introduction of the boundary slip into the theory of propagation of elastic waves in a uid-saturated porous medium form ulated by Biot [J.A coust. Soc. Am., 28, 179-191 (1956)] is investigated. Namely, the e ect of introduction of boundary slip upon the function F () that m easures the deviation from Poiseuille ow friction as a function of frequency parameter is studied. By postulating phenom enological dependence of the slip velocity upon frequency, notable deviations in the dom ain of interm ediate frequencies, in the behavior of F ( ) are introduced with the incorporation of the boundary slip into the model. It is known that F ( ) crucially enters Biot's equations, which describe dynamics of uid-saturated porous solid. Thus, consequences of the non-zero boundary slip by calculating the phase velocities and attenuation coe cients of the both rotational and dilatational waves with the variation of frequency are investigated. The new m odel should allow to the experimental seism ic data in circum stances when B iot's theory fails, as the introduction of phenom enological dependence of the slip velocity upon frequency, which is based on robust physical arguments, adds an additional degree of freedom to the model. If fact, it predicts higher than the Biot's theory values of attenuation coe cients of the both rotational and dilatational waves in the interm ediate frequency dom ain, which is in qualitative agreem ent with the experimental data. Therefore, the introduction of the boundary slip yields three-fold benets: (A) Better agreem ent of theory with an experim ental data since the param etric space of the m odel is larger (includes e ects of boundary slip); (B) Possibility to identify types of porous medium and physical situations where boundary slip is in portant; (C) Constrain model parameters that are related to the boundary slip.

#### I. IN TRODUCTION

It has been a common practice in the uid dynamics to assume that when a uid ows over an interface with a solid, the uid molecules adjacent to the solid have zero relative velocity with the respect to solid. So far, this widely used assumption, known as "no-slip boundary condition", has been successfully applied to the theoretical modeling of almost all m acroscopic experiments. As relevantly noticed by Craig et al. [1], the success of this assumption does not re ect its accuracy, but rather insensitivity of the experiment to a partial-slip boundary condition. It is known that the boundary slip becom es in portant only when the length scale over which the uid velocity changes approaches the slip length, that is the distance behind the interface at which the uid velocity extrapolates to zero, i.e. when the uid becomes highly conned, e.g., blood ow through capillaries or uid ow through natural porous rock. Recently, authors of Refs. [1, 2] presented a convincing experim ental evidence of a boundary slip in a New tonian liquid. They perform ed direct measurem ents of the hydrodynam ic drainage forces, which show a clear evidence of boundary slip. A lso, they found that the boundary slip is a function of the uid viscosity and the shear rate. These results have in portant in plications for the blood dynam ics in capillaries, the permeability of porous media, and lubrication of nano-machines. For example, results of Craig et al. suggest that red blood cells squeeze through narrow capillary walls more easily and induce less shear stress on capillary walls due to the boundary slip. A lso, in oil production industry, the residual oil is di cult to produce due to its naturally low mobility. Thus, the enhanced oil recovery operations are used to increase production. It has been experim entally proven and theoretically validated that there is a substantial increase in the net uid ow through a porous medium if the latter is treated with elastic waves [3, 4, 5, 6]. We may conjecture that the elastic waves via the pore wall vibration cause boundary slip of the residual oil droplets, which likew is red blood cells, squeeze through pores with less resistance, e ectively increasing perm eability of the porous m edium .

A quantitative theory of propagation of elastic waves in a uid-saturated porous solid has been formulated in the classic paper by B iot [7]. A fter its appearance, this theory has seen num erous modi cations and generalizations. One of the major indings of B iot's work was that there was a breakdown in Poiseuille ow above a certain characteristic frequency species to this uid-saturated porous material. B iot theoretically studied this breakdown

by considering the ow of a viscous uid in a tube with longitudinally oscillating walls under an oscillatory pressure gradient. B iot's theory can be used to describe interaction of uidsaturated porous solid with sound for a classic N ew tonian uid assuming no-slip boundary condition at the pore walls holds. However, in the light of recent experimental results of R ef. [2], revision of the classic theory is needed in order to investigate novelties bought about by the boundary slip.

B iot's theory has been a successful tool for interpreting the experim ental data for decades, but there are circum stances when it fails. G ist [8] perform ed ultrasonic velocity and attenuation m easurem ents in sandstones with a variety of saturating uids and com pared the data with the predictions of the Biot's theory. Velocity data show system atic deviations from Biot theory as a function of pore uid viscosity. Ultrasonic attenuation is much larger than the B iot prediction and for several sandstones is nearly constant for a three decade variation in viscosity. This behavior contrasts with synthetic porous media such as sintered glass beads, where B iot theory provides accurate predictions of both velocity and attenuation. The sim ilar claim has been also made by earlier experim ental studies e.g. Ref. [9]. Even Biothim self adknowledged [10] that the model of a purely elastic solid matrix saturated with a viscous uid is rather idealistic and there are rare occasions where it gives satisfactory agreem ent with the experim ent. Thus, he generalized theory applying the correspondence principle, and incorporated the solid and uid attenuation, and dissipation due to non-connected pores. In this work B iot introduced the viscodynam ic operator, which is a sum of the viscosity and inertial terms, and it accounts for the dynamic properties of the uid motions in pores valid for the both low and high frequencies. The theory can model other, more complex, mechanisms such as therm celastic dissipation, which produce a relaxation spectrum, or local ow mechanisms as the 'squirt' ow [11], [12]. A time domain formulation based on memory variables has been also successfully introduced [13], [14]. In order to narrow down the source of discrepancy between B iot theory and experim ent, G ist [8] tried to m odify natural sandstone by curing a residual saturation of epoxy in the pore space, lling sm all pores and m icro-cracks. This altered rock has a signi cantly reduced attenuation, dem onstrating the dom inance of sm all pores in controlling ultrasonic attenuation. Then he suggested that two non-Biot viscous attenuation mechanisms are needed: local ow in micro-cracks along grain contacts, and attenuation from pore-wall surface roughness. The model model based on these two mechanisms seemed to succeed in improvement of thing the data. However,

this by no means does not exclude other possibilities, and all plausible e ects that could explain the discrepancy should be explored. At low frequencies, the uid ow is of Poiseuille type and the inertia e ects are obviously negligible in comparison with the e ects of the viscosity. At high frequencies, however, these e ects are con ned to a thin boundary layer in the vicinity of the pore walls and the inertia forces are dom inant. Therefore, we conjecture that in such situations, apart from other yet unknown e ects, non-zero boundary slip e ect m aybe responsible for the deviations between the theory and experiment. This justi es our aim to form ulate a model that would account for the boundary slip.

In the section II we form ulate theoretical basis of our model and in section III we present our num erical results. In the section IV we conclude with the discussion of the results.

II. THE MODEL

In our model we study a Newtonian uid owing in a cylindrical tube, which minics a natural pore, whose walls are oscillating longitudinally and the uid is subject to an oscillatory pressure gradient. We give analytical solutions of the problem in the frequency domain.

The governing equation of the problem is the linearized momentum equation of an incompressive uid

Here,  $\mathbf{v}$ , p, denote velocity, pressure and m ass density of the uid, while is the viscosity coe cient.

Now, let u be a velocity of the wall of the tube which oscillates in time as  $e^{i!t}$ . The ow of uid in a cylindrical tube with longitudinally oscillating walls can be described by a singe component of the velocity, namely, its z-component  $v_z$  (z axis is along the centerline of the tube). We use cylindrical coordinate system (r; ;z) in treatment of the problem. We introduce the relative velocity  $U_1$  as  $U_1 = v_z$  u. Thus, assuming that all physical quantities vary in time as  $e^{i!t}$ , we arrive at the following master equation for  $U_1$

Here, we have introduced the following notations:

which is a sum of the applied pressure gradient and force exerted on the uid from the oscillating wall of the tube and, , which is = =.

The solution of Eq.(2) can be found to be [7]

Following work of Biot [7] we calculate the stress at the wall ,

The total friction force is  $2 \, a$ . Following B iot we calculate the ratio of total friction force to the average velocity, i.e.

Note, that F() measures the deviation from Poiseuille ow friction as a function of frequency parameter . The Biot's expression for F() in the no boundary slip regime can be easily recovered from Eq.(7) by putting  $U_s$ ! 0 for all 's.

So far, we did not specify  $U_s$ , however there are certain physical constraints it should satisfy:

(A) A uthors of R ef. [1] dem onstrated that the slip length (which, in fact, is proportional to the slip velocity) is a function of the approach rate and they showed why several previous careful measurement of conned liquids have not observed evidence for boundary slip. Under the low approach rates employed in previous measurements slip length is zero and no-slip boundary condition is applicable. Experiments reported in R ef. [1] were performed when half-sphere approached a plane with liquid placed in-between at diement approach rates. However, we should clearly realize what term "approach rate" means in the context of B bot's theory: B bot investigated uid ow in the cylindrical tube whose walls are harmonically oscillating in the longitudinal direction as  $x(t) = A e^{-it t}$ , therefore if similar to R ef.[1] experiment would be done for the oscillation tube, the "approach rate" would be the amplitude of  $x_i(t)$ , i.e. i! A. Thus, when !! 0,  $U_s$  should also tend to zero.

(B) At high frequencies the viscous e ects are negligible compared to the inertial e ects. Thus, uid at high frequencies behaves as an ideal (non-viscous) pore uid, which allows for an arbitrary slip. Therefore, when  $! ! 1 , U_s$  should tend to zero. W hen we exam ine F ig. 6 from R ef.[1] and F ig. 3 (bottom panel) from R ef.[2] closely we should understand that the authors measured ascending part where slip length increases with the increase of the approach (ow) rate. Since, the viscous e ects should be negligible compared to the inertial e ects for large approach rates, there must be also a descending part { clearly slip length (or the sam e as slip velocity) cannot grow in nitely as approach rate increases. V iscous e ects should give in to the inertial e ects and uid should behave an ideal uid allowing for an arbitrary slip.

Based upon the above two physical arguments we conclude that  $U_s$  should be a smooth function which tends to zero when ! (or the same as ) tends to both zero and 1. Therefore,

we postulate following phenom enological expression for Us

This function has a maximum at  $= \frac{q}{2A=3}$ . By xing B at  $5^5A^3 = (4 \quad 3^3)$  we force it to achieve its maximum equal to unity at = (when = 1). We introduced (usually 0 1) as a sort of "weight" of the boundary slip e ect into the solution. Putting, = 0 this way would easily allow us to recover no-slip case, while the increase of we would be able to trace e ect of non-zero slip onto the all physical quantities. We plot this function in Fig. 1 for A = 25 and = 1.

It is worthwhile to mention that, at rst glance, it seems that non-zero boundary slip, which appears at "high approach rates", should be attributed to the non-linear e ects. However, thorough interpretation of the experimental results of Ref. [1], in the context of the oscillatory tube (see points (A) and (B) above) allows us to conclude that the non-zero boundary slip can be also incorporated into the linear Biot's theory.

Next, we plot both  $F_r() = ReF()$  and  $F_i() = ImF()$  in Fig. 2 for the three cases: when there is no boundary slip (=0), and = 0.05; 0.1. We gather from the plot that the = 0 is identical to Fig. 4 from Ref.[7] as it should be. However, we also notice a noticeable di erence from the classic case when is non-zero in the interm ediate frequencies dom ain. O f course, according to our de nition of the phenom enological form of  $U_s()$ , even for non-zero (non-zero boundary slip), when ! 0 and ! 1, asymptotically F() behaves as classic B iot's solution [7], i.e.

Since in our phenom enological model we allow for the deviations in the interm ediate frequency dom ain, it is easy to foresee that these will have an impact on all of the predictions of the Biot's theory precisely in that frequency range. Namely, all observable quantities predicted by the Biot's theory, such as phase velocities and attenuation coe cients of the both rotational and dilatational waves will be a ected by the introduction of boundary slip into the model in the interm ediate frequency range.

B iot [7] showed that the general equations which govern propagation of rotational and dilatational high-frequency waves in a uid-saturated porous medium are the same as in the low-frequency range provided the viscosity is replaced by its elective value as a function of frequency. In practice, it means replacing the resistance coel cient b by bF ( ).

The equations describing dynamics of the rotational waves are [7]

where, 11; 12 and 22 are mass density parameters for the solid and uid and their inertia coupling;  $\frac{1}{2}$  = curl u and  $\sim$  = curl U describe rotations of solid and uid with u and U being their displacement vectors, while the rigidity of the solid is represented by the modulus N. Substitution of a plane rotational wave of the form

where l is wavenum ber, = 2 f is wave cyclic frequency, =  $_{11}$  + 2  $_{12}$  +  $_{22}$  is the mass density of the bulk material and a is a pore radius.

For the hollow cylinder-like pores,  $= \frac{p}{8}$  [7] and we use this value throughout the paper.  $f_c$  is the critical frequency above which the Poiseuille ow

breaks down, and it equals  $b=(2 \ _2)$ . Here  $_2$  denotes the product of porosity and uid mass density.

In order to obtain phase velocity and attenuation  $coe cient of the rotational waves, we put l = Re[] + iIm []. Thus, the phase velocity is then <math>v_r = = \Re e[]$ . Introducing a reference velocity as  $V_r = \frac{q}{N}$ , we obtain the dimensionless phase velocity as

To obtain the attenuation coe cient of the rotational waves, we introduce a reference length,  $L_r$ , de ned as  $L_r = V_r = (2 \ f_c)$ . The length  $x_a$  represents the distance over which the rotational wave am plitude is attenuated by a factor of 1=e. Therefore we can construct the dimensionless attenuation coe cient as  $L_r = x_a$ ,

where, P;Q and R are the elastic coe cients, e = div u and = div U are the divergence of solid and uid displacements. Again, substitution of a plane dilatational wave of the form

where  $z = l^2 V_c^2 = {}^2$ ,  $V_c^2 = (P + R + 2Q) =$  represents the velocity of a dilatational wave when the relative motion between uid and solid is absent,  $z_{1;2} = V_c^2 = V_{1;2}^2$  with  $V_{1;2}$  being the velocities of the purely elastic waves with subscripts 1,2 referring to the two roots of Eq.(22), and nally  $M = (1 + i_2) = (11 22 {}^2_{12})$  with 11 = P = (P + R + 2Q), 22 = R = (P + R + 2Q)and 12 = Q = (P + R + 2Q). Eq.(22) has two complex roots  $z_I$  and  $z_{II}$ . Phase velocities of the two kinds of dilatational waves can be de ned as

### III. NUMERICAL RESULTS

In order to investigate the novelties brought about into classical B iot's theory of propagation of elastic waves in porous medium [7] by the inclusion of boundary slip, we have studied the full parameter space of the problem.

In all forthcom ing results, we calculate phase velocities and attenuation coe cients for the case 1 from Table I taken from Ref. [7], which is  $_{11} = 0.610$ ,  $_{22} = 0.305$ ,  $_{12} = 0.043$ ,  $_{11} = 0.500$ ,  $_{22} = 0.500$ ,  $_{12} = 0$ ,  $z_1 = 0.812$ , and  $z_2 = 1.674$ .

We calculated normalized phase velocity of the plane rotational waves,  $v_r = V_r$ , and the attenuation coecient L<sub>r</sub>=x<sub>a</sub> using our more general expression for F () (which takes into account non-zero boundary slip) given by Eq.(7).

In Fig. 3 we plot phase velocity  $v_r = V_r$  as a function of frequency for the three cases: the solid curve corresponds to = 0 (no boundary slip), while long-dashed and short-dashed curves correspond to = 1:0 and = 1:5 respectively (we have used these large values in order to emphasize the e ect of the boundary slip). Note that the = 0 case perfectly reproduces the curve 1 in Fig. 5 from Ref.[7]. For = 1:0 and 1:5 we notice a deviation from the classic behavior in the form of an decrease of phase velocity in the domain of interm ediate frequencies.

Fig. 4 shows the attenuation coe cient L  $_r=x_a$  of the rotational wave as a function of frequency for the three values of : the solid curve corresponds to = 0 (no boundary slip), while long-dashed and short-dashed curves represent the cases = 1:0 and = 1:5 respectively. Note that = 0 case coincides with curve 1 in Fig. 6 from Ref.[7]. We observe that, in the interm ediate frequency range, with increase of boundary slip our model yields substantially higher values of the attenuation coe cient than in the classic no-slip case, which is in qualitative agreem ent with the experimental data [8], [9].

W e also calculated norm alized phase velocities of the plane dilatational waves,  $v_I = V_c$  and  $v_{II} = V_c$ , and the attenuation coe cients L  $_c = x_I$  and  $L_c = x_{II}$  using our more general expression for F () given by Eq. (7).

In Figs. 5 and 6 are similar to Fig. 3 except that now we plot phase velocities  $v_I = V_c$  and  $v_{II} = V_c$  as a function of frequency for = 0; 0.05; 0.1. Note that the solid curves on the both graphs reproduce curves 1 in Figs. 11 and 12 from Ref. [7]. We gather from the graph that introduction of the non-zero boundary slip leads to decrease of  $v_I = V_c$ , while  $v_{II} = V_c$  increases in the in the dom ain of interm ediate frequencies as boundary slip, , increases.

In Figs. 7 and 8 we plot the attenuation coe cients  $L_c=x_I$  and  $L_c=x_{II}$  in a similar manner as in Fig. 4, but now for = 0; 0:05; 0:1. Again we observe that the = 0 case reproduces curves 1 in Figs. 13 and 14 from Ref.[7]. We gather from Figs. 7 and 8 that introduction of the non-zero boundary slip yields higher than in the no boundary slip case values of the attenuation coe cients for both types of the dilatational waves in the dom ain of interm ediate frequencies, which, again, is in qualitative agreement with the experimental results [8], [9].

It is worthwhile to note that for no-zero the asymptotic behavior of the elastic waves in the  $f=f_c$ ! 1 as well as  $f=f_c$ ! 0 lim it is identical to the classic behavior established by B iot [7]. This is a consequence of the assumptions of our phenom enological model, which is based on robust physical arguments.

## IV . D ISC U SSIO N

In this paper we have studied the e ect of introduction of the boundary slip in the theory of propagation of elastic waves in a uid-saturated porous solid originally formulated by B iot [7]. B iot's theory does not account for boundary slip e ect, however, the boundary slip becomes in portant when the length scale over which the uid velocity changes approaches the slip length, i.e. when the uid is highly conned, for instance, uid ow through porous rock or blood vessel capillaries. In the light of recent convincing experimental evidence of a boundary slip in a New tonian liquid [2], it is necessary to take into account this e ect into the B iot's theory where appropriate. We have studied the e ect of introduction of boundary slip upon the function F () that measures the deviation from Poissuille ow friction as a function of frequency parameter . This function crucially enters B iot's equations which describe dynamics of uid-saturated porous solid. Therefore, a revision of B iot's theory

was needed in order to incorporate boundary slip e ect into the all measurable predictions of this theory such as phase velocities and attenuation coe cients of the both rotational and dilatational waves. We have performed such analysis, and in summary, we found that the introduction of the non-zero boundary slip into the Biot's theory of propagation of the elastic waves in a uid-saturated porous solid results in

the decrease, as compared to the no-slip limiting case, of the phase velocities of both rotational waves  $(v_r=V_r)$  and dilatational wave of the rst kind  $(v_I=V_c)$  in the domain of intermediate frequencies. On contrary, the phase velocity of the dilatational wave of the second kind  $(v_{II}=V_c)$  experiences an increase as compared to the no-slip limiting case in the domain of intermediate frequencies.

in the dom ain of interm ediate frequencies the attenuation coe cients of both the rotational ( $L_r=x_a$ ) and dilatational waves ( $L_c=x_I$  and  $L_c=x_{II}$ ) are increased as compared to the no-slip limiting case as the boundary slip increases, which is in qualitative agreement with the experimental data [8], [9].

behavior of all physical quantities which describe the elastic waves in the asymptotic lim its of both sm all and large frequencies is not a ected by the introduction of the non-zero boundary slip. The deviation occurs only in the domain of intermediate frequencies, as prescribed by our phenom enological model.

The investigation of properties of elastic waves is in portant for a number of applications. The know ledge of phase velocities and attenuation coe cients of elastic waves is necessary, for example, to guide the oil- eld exploration applications, acoustic stimulation of oil producing elds (in order to increase the amount of recovered residual oil), and the acoustic clean up of contam inated aquifers [3, 4, 5, 6]. Therefore, our results would be useful for various applications in oil production as well as in ecology.

From the recent experimental results of Ref.[2] we gathered that there are physical situations were the no-slip boundary condition becomes invalid. We have formulated a phenomenological model of elastic waves in the uid-saturated porous medium based on Biot's linear theory and certain physically justiled assumptions on the variation of boundary slip velocity with frequency,  $U_s$  (). Since, there are no experimental measurements of  $U_s$  (), for a cylindrical tube, on which "Biot-like" theory relies, there is a certain freedom of choice,

which could be used to obtain a better t of experimental data with the theory in cases where classic B iot's theory fails to do so. If fact, our model predicts higher than the B iot's theory values of attenuation coe cients of the both rotational and dilatational waves in the intermediate frequency domain, which is in qualitative agreement with the experimental data [8], [9]. Therefore, the introduction of the boundary slip yields three-fold bene ts:

Better agreem ent of theory with an experim ental data, since, the param etric space of the model is larger (includes e ects of boundary slip).

Possibility to identify types of porous medium and physical situations where boundary slip is important.

Constrain model parameters that are related to the boundary slip.

We would like to close this paper with the following two remarks: First, the reported slip length varies from tens of nano-meters [1] to a few microns [2], depending on a type of a liquid and di erences in the experimental set up. The latter experimental work clearly demonstrates the applicability of our model to the elastic wave phenomena in a usual porous media found in Nature. Second, in this work we postulated a phenomenological expression for the boundary slip velocity based on some physically sound arguments (in fact, sim ilar, successful, approach has been used by the authors of Ref.[15] in the context of solar physics). However, perhaps it may be possible to derive an expression based on more general "rst principles", which should be a subject of a future work.
