Fig. 2: The variations of ionospheric parameters over the time interval 12:00 - 16:00 UT on June 21 and on the background days of June 20 and 22, 2001, using the data from station Madimbo - panels a, b, c. Solid curves with dots correspond to the variations in critical frequencies f_0F2 (panel a), TEC (panel b), and the heights of the F2-layer maximum (panel c) for June 21, 2001 (from here on the heights of the F-region and higher altitudes are implied). Solid curves and solid curves with triangles show the variations of the parameters f_0F2 , TEC, and $h_m F2$ for June 20 and 22, 2001, respectively. The dashed curve on panel a shows the geometrical function of eclipse S(t) obtained for ionospheric station Madimbo during 12-14:22 UT. The onset time of the phase of totality (13:10 UT) at 300 km level at the station's location is shown by a thin vertical line (panels a, b, c). These panels also show the geometrical eclipse functions S(t) (dash lines) at 300 km altitude calculated for the corresponding subionospheric points. The filtered variations resemble in their form a triangle whose vertex (point A) corresponds to the time, at which a minimum TEC value is attained. A bstract. W e discuss the measurements of the main parameters of the ionospheric response to the total solar eclipse of June 21, 2001. This study is based on using the data from three stations of the global GPS network located in the area of the totality band in A frica. This period was characterized by a low level of geom agnetic disturbance (the D st-index varied from -6 to 22 nT), which alleviated greatly the problem of detecting the ionospheric response to eclipse. An analysis revealed a clearly pronounced e ect of a decrease (depression) of the total electron content (TEC) for all GPS stations. The delay between the sm allest value of the TEC with respect to eclipse totality was 9-37 m in. The depth and duration of the TEC depression were 0.5-0.9 TECU and 30-67 m in, respectively. The results obtained in this study are in good agreement with earlier m easurements and theoretical estimations.

1. Introduction

Experimental observations of the ionosphere at the time of solar eclipses provide a source of information about the character of behavior of the various ionospheric parameters. Regular ionospheric e ects of solar eclipses are fairly well understood. They imply an increase of e ective re ection heights, a reduction in concentration in the F-layer maximum, and a decrease in total electron content (TEC) in the ionosphere, which is typical of the transition to the nightside ionosphere [Cohen, 1984]. The behavior of the above parameters can be modeled using appropriate ionospheric models [Boitman et al., 1999; Stubbe, 1970].

The main parameters of the ionospheric response include the value of the delay with respect to the eclipse totality phase, as well as its amplitude A and duration T. A lm ost all publications devoted to the study of the ionospheric response to solar eclipses make estimates of these parameters. A know ledge of these values makes it possible to re ne, in terms of the respective aeronom ic ionospheric models, the time constants of ionization, and the recombination processes at dimension the ionosphere.

The statistic of m easurem ents of these param eters according to published data is presented in Table 1 (columns 5, 6 and 7, respectively). Table 1 also includes: D ate - date of the total solar eclipse; Location - geographic region where the eclipse was observed or the path for the methods recording the delay time on the VLF signal ray path between the signal reception site and the transmitting station (VLF); FD S - frequency D oppler shift on the HF ray path between the signal reception site and the transm itting stations, as well as for the m ethod of oblique-incidence ionospheric sounding (O IS); M ethod -m ethod used in the investigation; R efference - reference to publication. The N ote colum n (colum n 9 of Table 1) presents the time resolution of the m ethod used in investigating the ionospheric response to total solar eclipse, and the number of stations. The following abbreviations are used in Table 1: I vertical-incidence ionospheric sounding; D S - di erential D oppler shift; G P S - G lobal Positioning System; N m F 2 - electron density in the F2-layer m axim um; hm F 2 - height of the F2-layer m axim um; f₀F 2 - F2-layer critical frequency; f₀E - E-layer critical frequency; hp F 2 - virtual height of the F2-layer; h⁰F 2 - virtual height of the lower boundary of the F2-layer; h⁰ - virtual height at xed plasm a frequencies; f₁ - frequency D oppler shift; A - signal am plitude; and St - num ber of stations. The TECU (Total E lectron C ontent Units), which is equal to 10¹⁶ m⁻² and is commonly accepted in the literature, will be used throughout the text.

M easurements of were made by analyzing the characteristics of the ionospherere ected radio signal at vertical-incidence soundings at a network of ionospheric stations Borisov et al., 2000; Cheng et al., 1992; D atta et al., 1959; Huang et al., 1999; W alker et al., 1991]. In the cited references, the value of was found to vary from 5 m in W alker et al., 1991] (line 2 of Table 1) to 80 m in [Huang et al., 1999] (line 7 of Table 1) according to the N_m F 2 data, and from 9.5 m in [Borisov, 2000] (line 4 of Table 1) to 30 m in [W alker et al., 1991] according to the f₀F 2 data. The am plitude A of a decrease in local electron density from 0.2 to 1 10^{12} m⁻³ (N_m F 2), and from 0.2 to 1.4 M H z (f₀F 2). The response duration T = 100-240 m in according to the data on N_m F 2 and f₀F 2. To analyze the ionospheric e ects from the total solar eclipse of September 23, 1987, Cheng et al., [1992] used the phase variation of the VLF signal transmitted from NDT, Yosami (34.97 N; 137.02 E), Japan, and recorded at K ao jong (24.95 N; 121.15 E), Taiwan, as well as the di erential D oppler shift data from the Lunping O bservatory (25 N; 121.17 E). Results of this investigation are presented in line 3 of Table 1.

Interesting results were obtained by investigating the ionospheric response to the total solar eclipse of M arch 9, 1997 [Boitm an et al., 1999] (line 5 of Table 1) and of August 11, 1999 [Cherkashin and Agafonnikov, 2001] (line 6 of Table 1) using FD S and O IS [Boitm an et al., 1999; Borisov et al., 2000] (lines 5 and 4 of Table 1).

Boitm an et al., [1999] used the following radio sounding paths: Tory (51.7 N; 103.8 E)-Irkutsk, Tory-U lan-U de, Tory-K rasnoyarsk, Tory-Chita (recording of FD S), and Tory-Irkutsk (O IS m ethod). To investigate the ionospheric response to the total solar eclipse of M arch 9, 1997, Borisov et al., [2000] used frequency D oppler shift data obtained from soundings for the following paths: N ovosibirsk-Tom sk, K rasnoyarsk-Tom sk, M agadan-Y akutsk, K om som olsk-on-Am ur-Y akutsk, K habarovsk-Y akutsk, Y akutsk-Tom sk, M agadan-Tom sk, Irkutsk-Tom sk, and Thushim a-Tom sk. A coording to the data obtained using O IS, = 6-20 m in, A = 0.5-1.5 H z (for short paths) and 2.3-3 H z (for long paths), and T = 40-150 m in (lines 4 and 5 of Table 1).

Cherkashin and Agafonnikov, [2001] investigated the ionospheric response to the total solar eclipse of August 11, 1999 for the following paths: London (GB)-Troitsk (IZM IRAN) with L=2.5 Mm (at 12095 kHz frequency), and Prague (Czech Republic)-Troitsk (at 9520 kHz frequency). In the cited reference the value of the frequency

D oppler shift was converted to the amplitude A of the variation of the rection height (line 6 of Table 1). The values of and T, obtained by Boitm an et al., [1999] and Cherkashin and Agafonnikov, [2001] using FDS are 0-15 m in and 87-120 m in (lines 5 and 6 of Table 1), respectively.

The developm ent of the global navigation system GPS and the creation, on its basis, of extensive networks of GPS stations (which at the end of 2001 consisted of no less than 900 sites), the data from which are placed on the Internet [K lobuchar, 1997], opens up a new era in remote sensing of the ionosphere. At almost any point of the globe and at any time at two coherently-coupled frequencies $f_1 = 1575.42$ MHz and $f_2 = 1227.60$ MHz, two-frequency multichannel receivers of the GPS system are used to carry out high-precision measurements of the group and phase delay along the line of sight between the ground-based receiver and satellite-borne transmitters in the zone of reception. The sensitivity a orded by phase measurements in the GPS system permits irregularities to be detected with an amplitude of up to 10⁻³ of the diumal variation of TEC [M elbourne et al., 1994].

A large body of data of analysis of the ionospheric response to total solar eclipse was obtained using the GPS [A fraim ovich et al., 1998; A fraim ovich et al., 2001; Feltens, 2000; Huang et al., 1999; T sai and Liu, 1999]. The values of , A and T, derived from investigating the ionospheric response to total solar eclipses using the GPS, di er greatly (varies from 4 to 16 m in, A ranges from 0.1 to 3 TECU, and T varies between 32 and 75 m in). The large scatter of the values of , A and T is likely to be associated with the di erence of the longitude and latitude ranges, over which the investigations

were carried out, the season, the technique for processing the GPS data, as well as with di ering geom agnetic situations.

To investigate the ionospheric response to the total solar eclipses of M arch 9, 1997 and August 11, 1999, A fraim ovich et al., [1998, 2001] used the variations in total "oblique" electron re ection and the "vertical" TEC value, respectively. The study of the ionospheric response to the August 11, 1999 total solar eclipse is based on using the data from about 100 GPS stations located in the neighbourhood of the eclipse totality phase in Europe.

In exam ining the ionospheric e ect from the total solar eclipses of O ctober 24, 1995 and M arch 9, 1997, Huang et al., [1999] and T sai and Liu, [1999] analyzed the variations in "vertical" TEC. T sai and Liu, [1999] carried out their investigations near the m agnetic equator; for that reason, the TEC series contain, in addition to the response to total solar eclipse, variations caused by the dynam ics of the equatorial anom aly.

Feltens, [2000] investigated the ionospheric response to the August 11, 1999 total solar eclipse using total electron content m aps (TEC m aps, line 10 of Table 1), the raw data for which are represented by TEC series obtained by m eans of the global network of GPS receivers. Taking into account the tem poral resolution of standard TEC m aps (2 hours) as well as the parameter T derived from analyzing earlier work (1-1.5 hour) it can be concluded that such TEC m aps do not secure the necessary determ ination accuracy of , A and T.

Hence a large body of experim ental data do not perm it us to make any reliable

estim ates of the basic parameters of the ionospheric response. One of the reasons for such a great dierence is that dierent methods of measurements are used, which dier greatly by spatial and temporal resolution. However, the main reason is caused by dissimilar characteristics of the eclipse itself, by geophysical conditions of individual measurements, and by a large dierence in latitude, longitude and local time when experiments are conducted.

To obtain m one reliable inform ation about the behaviour of the ionosphere during an eclipse requires simultaneous m easurem ents over a large area covering regions with di erent local times. Furtherm one, high spatial (of some tens of kilom eters at least) and tem poral (at least 1 m in) resolution is needed. However, none of the above fam iliar m ethods m eets such requirem ents.

In this paper the m ethod of detecting the ionospheric response to solar eclipse, reported in A fraim ovich et al. [2001], is used to estimate the main parameters of the ionospheric response to the total solar eclipse of June 21, 2001.

2. The geom etry and general inform ation of total solar eclipse June 21, 2001

The total solar eclipse of June 21, 2001 began in the South Atlantic O cean 400 km to the south of U ruguay. The M oon's shadow m ade its rst contact with the surface at 10:35 UT. The eclipse duration at that point was 2 m in 6 s. W ithin two subsequent hours the shadow was moving along the surface of the South Atlantic O cean. Totality

occurred at 12:04 UT at the point with the coordinates 11:25 S; 2:75 E and lasted for 4 m in 56 s. The velocity of the M oon's shadow along the surface averaged 1.2 km/s. For 2 h 56 m in (duration of the total solar eclipse), the M oon's shadow traveled a distance of about 12000 km.

Figure 1 presents the schematic map of the movement of the Moon's shadow along the surface in A frica (based on using the data from E spenak and Anderson [2001]). The heavy line shows the centerline of the eclipse at the ground level, and thin line show the southern and northern boundaries. The location of the reference ionospheric station M adim bo (22:38 S; 30:88 E) is shown by the heavy cross symbol. Heavy dots correspond to the locations of the GPS stations used in the analysis; their geographic coordinates are presented in Table 1. Numbers for the longitudes of 10, 20, 30, 40 and 50 E correspond to the local time of eclipse totality at ground level.

In this paper we have con ned ourselves only to analyzing the area from the western coast of A frica to the point with the coordinates 19:95 S; 40:07 E, where the phase of totality was observed at 13:25 UT (16:09 LT). Thus the eclipse e ect in the region under investigation took place for the conditions of the dayside sum mer ionosphere.

Fig. 2d shows the D st-variations for June 20 (solid curve), June 20 (solid curve with dots), and June 22 (solid curve with triangles) 2001. This period was characterized by a low level of geom agnetic disturbance (within -6 - 22 nT), which alleviated greatly the problem of detecting the ionospheric response to eclipse.

3. The ionospheric response by eclipse from date of

ionospheric station M adim bo

First we consider the variations of ionospheric param eters over the tim e interval 12:00 - 16:00 UT on June 21 and on the background days of June 20 and 22, 2001, using the data from station M adim bo -F ig. 2a, b, c. Solid curves with dots correspond to the variations in critical frequencies $f_0F 2$ (panel a), TEC (panel b), and the heights of the F2-layer m axim um ($h_m F 2$) for June 21, 2001 (from here on the heights of the F -region and higher altitudes are in plied). Solid curves and solid curves with triangles show the variations of the param eters $f_0F 2$, TEC, and $h_m F 2$ for June 20 and 22, 2001, respectively. The dashed curve on panel a show s the geom etrical function of eclipse S (t) obtained for ionospheric station M adim bo during 12-14.22 UT. The geom etrical function of eclipse S (t) represents a part of the solar disk area that is not occulted by the M oon's shadow, and is expressed in fractions of this area in arbitrary units. To calculate the geom etrical function of eclipse, we developed a special program which can be used to calculate S (t) at any heights. The m athem atical apparatus that was used in preparing this program, was described in a large num ber of publications [e. g., M ikhailov, 1954].

The onset time of the phase of totality (13:10 UT) at 300 km level at the station's location is shown by a thin vertical line (Fig. 2a).

The eclipse e ect is most clearly distinguished in the variations of critical frequencies $f_0F 2$, the greatest di erence of which from background values on June 20 and 22 at the time of a minimum (13:35 UT, thick vertical line in Fig. 2a) was 1.5-2 M Hz. The delay

between the times of totality and a minimum $f_0F 2$ was 25 min (the time resolution of the data from the ionospheric data used in this study, is 5-15 min).

The delay between the times of a minimum $f_0F 2$ and a minimum of the function S (t) for ionospheric station C hilton during the total solar eclipse of A ugust 11, 1999 was 4 m in [A fraim ovich et al., 2001] (time resolution 4 m in).

The di erence of for the total solar eclipses of June 21, 2001 and August 11, 1999 seems to be caused by the di erent time resolution used in the analysis of the for 2, as well as by the di erent distance of ionospheric stations in latitude from the band of totality.

The eclipse e ect on other parameters (the TEC value obtained using the data from ionospheric station M adim bo to the height of the $f_0F 2$ layer m axim um and using the ionospheric m odel above this m axim um, as well as the height of the $h_m F 2 - F$ ig. 2b, c) is not as clearly pronounced as in the case of $f_0F 2$. A coording to the TEC data, = 5 m in, and for $h_m F 2$ we have = 30 m in.

Sim ilar results (for f_0F 2) of measurements at the ionospheric station were obtained during the solar eclipse of September 23, 1987 in South-East Asia [Cheng et al., 1992].

4. The process of GPS {network data and results of analysis of ionospheric e ect by total solar eclipse of June 21, 2001

We now describe brie y the sequence of procedures of processing the GPS data. Primary data include series of the "oblique" value of TEC I(t), as well as the

corresponding series of values of the elevation (t) measured from the ground, and of the azim uth (t) of the LOS to the satellite measured eastward from north. These parameters are calculated using our developed program CONVTEC which transforms R INEX - les [Gurtner, 1993], standard for the GPS system, received via the Internet. The series of values of the elevation (t) and azim uth (t) of the LOS to the satellite are used to determ ine the location of subionospheric points. In the case under consideration these results were obtained for elevations (t) larger than 45.

The snow ake symbol in Fig. 1 shows the location of the subionospheric point at the time of a maximum TEC response.

Variations of the "oblique" TEC I (t) are determined on the basis of phase measurements at each of the spatially separated two-frequency GPS receivers using the formula from [A fraim ovich et al., 1998]:

where L_{1-1} and L_{2-2} are additional paths of the radio signal caused by the phase delay in the ionosphere, (m); L_1 and L_2 represent the number of phase rotations at the frequencies f_1 and f_2 ; $_1$ and $_2$ stand for the corresponding wavelengths, (m); const is the unknown initial phase ambiguity, (m); and nL are errors in determining the phase path, (m).

The series of values of the elevation (t) and azim uth (t) of the LOS to the satellite were used to determ ine the location of subionospheric points and to transform

the "oblique" TEC I_0 (t) to the corresponding value of the "vertical" TEC using the technique described in [K lobuchar, 1986]:

where R_z is the Earth's radius, and $h_m = 300$ is the height of the equivalent thin shell.

W ith the purpose of elim inating variations of the regular ionosphere, as well as trends introduced by the satellite's motion, we employ the procedure of elim inating the trend by prelim inarily smoothing the initial series with the time window in the range from 40 to 60 m in which is tted for each TEC sampling. The selection of the time window from 40 to 60 m in when removing the trend is reconciled with the expected duration of the ionospheric response. The determ ination accuracy of the time of the TEC response extrem um at the chosen values of the time window was su ciently high (not worse than 1 m in). The reason is that under the conditions of the magnetically quiet day of June 21, 2001 (the largest value of D st did not exceed 12 nT) the amplitude of TEC background variations was far below the amplitude of the TEC response to the eclipse.

Fig. 3 presents the litered variations of TEC dI (t) for HRAO stations for satellite N03 (PRN03) - Fig. 3a; HRAO (PRN22) - Fig. 3b; HRAO (PRN31 - Fig. 3c; MALI (PRN31) - Fig. 3d; SUTH (PRN27) - Fig. 3e; and SUTH (PRN31) - Fig. 3f for June 21, 2001 (heavy lines). These panels also show the geometrical eclipse functions S (t) at

300 km altitude calculated for the corresponding subionospheric points. Onset times of m inim a $t_{m in}$ of the dI (t) series are presented in Table 1. In Table 1 the following symbols are used: PRN – satellite number; SLAT and SLON – latitude and longitude of the subionospheric point, respectively; A – m inim um value of dI (t)-variations; T – response duration; and – delay between m inim a of the dI (t) and S (t) series.

It is evident from Fig. 3a, the Itered variations resemble in their form a triangle whose vertex (point A) corresponds to the time, at which a minimum TEC value is attained. The value of $dI_{m in}$ itself can serve as an estimate of the amplitude of the TEC response to eclipse, and the time interval between the times of intersection of the dI=0 line (points B and C) can serve as an estimate of the response duration T.

Such dI (t) variations are characteristic for all the GPS stations and satellite numbers 1, 3, 13, 22, 27 and 31 listed in Table 1. That the above-mentioned satellites were chosen for the entire set of GPS station was dictated by the fact that for these satellites a maximum value of the elevation of the LOS to the satellite, for the time interval 13:00-14:00 UT, exceeded 45, which minimized the possible error of transform ation to the "vertical" TEC value as a consequence of sphericity.

For comparison, Fig. 4 presents the dI (t) - variations for di erent subionospheric points of station HRAO: PRN 22 - thin solid line, and PRN 31 - thick solid line separated by 7 in longitude. It is evident from the gure, the responses to eclipse for the subionospheric points PRN 22 and PRN 31 are quite sim ilar both in their form and in am plitude, but the delay of the response increases with longitude.

A thin dashed line and a thin dashed line with dots in Fig. 4 shows that S (t) for

HRAO (PRN22) and HRAO (PRN31), respectively. The points A and A[°] for GPS station HRAO (PRN31) correspond to the time of totality and the time of a minimum of the dI (t), respectively. The points B and B[°] for GPS station HRAO (PRN22) correspond to the time of totality and the time of a minimum of the dI (t), respectively. The use of satellites PRN22 and PRN31 for the HRAO station was dictated by the fact that the paths of these satellites lie in about the same latitude range (Fig. 1). It is evident from Table 1 that the longitudinal dependence of the time of a minimum dI (t) is not a monotonic function for all GPS stations in latitude from the totality band, i. e. the geophysical conditions for some of the trajectories di ered drastically.

5. Conclusion

The results reported in this study are in good agreem ent with earlier m easurem ents and theoretical estimations (see a review of the data in the Introduction). The principal di erence of our data is the higher reliability of determination of the main eclipse response parameters caused by high space-time resolution and by improved sensitivity of detection of ionospheric disturbances using GPS.

To investigate the ionospheric response to the total solar eclipses of M arch 9, 1997 and August 11, 1999, A fraim ovich et al., [1998, 2001] used the variations in total "oblique" electron re ection and the "vertical" TEC value, respectively. The values of , A and T, derived from investigating the ionospheric response to total solar eclipses using the GPS, di er greatly (varies from 0 to 400 m in, A ranges from 0.1 to 15 TECU, and T varies between 32 and 200 m in). The large scatter of the values of A and T is likely to be associated with the di erence of the longitude and latitude ranges, over which the investigations were carried out, the season, the technique for processing the GPS data, as well as with di ering geom agnetic situations.

The TEC data for the total solar eclipses of August 11, 1999 and June 21, 2001 were processes following the technique described in the "The process of GPS {network data and results of analysis of ionospheric e ect by total solar eclipse of June 21, 2001" section. The values of the parameters , A and T, obtained by analyzing the ionospheric response to the total solar eclipses of August 11, 1999 and June 21, 2001, di er by no m ore than 5-21 m in, 0.4-0.6 TECU, and 6-7 m in, respectively. The di erence of the parameters , A and T can be explained by the di erence of the geometry of the eclipses as well as by the di erence of the latitude and longitude ranges.

The time constant of ionization decrease in the F2 maximum exceeds greatly the duration of the totality phase of eclipse, which leads to a decrease in the response amplitude. The TEC response amplitude in terms of various models were made in [Stubbe, 1970] and [Boitm an et al., 1999], also for the spring season.

The value of for $f_0F 2$ about 25 m in corresponded to the local time of 15:38 LT. The parameter for $f_0F 2$ at the time of the total solar eclipse of M arch 9, 1997 varied from 9.5 to 16 m in according to the data reported by Borisov et al., [2000], which is in good agreement with our data.

We cannot directly compare the physical signi cances of the delay times obtained from $f_0F 2$ observations with those obtained from TEC measurements. $f_0F 2$ refer to a given height, namely the height of peak density. On the other hand, , which is

height-dependent, gives a weighted value because is small at low heights, say, 200 km, and is large in the topside, say, 1000 km. Thus will vary along the GPS-G round ray path. Since most of the TEC is above the peak the observed GPS-tau should be larger than the f_0F 2-.

Ivelskaya et al., [1977], using simulation methods, showed that the variations of the delay time of a minimum local electron density $N_e(t)$ with respect to a minimum of the ion production function are: at 150 km altitude = 1-2 min, at 200 km - = 3 min, at 300 km - = 20 min, and above 600 km - = 45 min. In this paper, was estimated at about 3 min for 200 km altitude, and at 40 min for 300 km for 12 LT.
