Optical chaos in nonlinear photonic crystals

Abstract

W e exam ine a spatial evolution of lightwaves in a nonlinear photonic crystal with a quadratic nonlinearity when simultaneously a second harm onic and a sum-frequency generation are quasi-phase matched. We nd the conditions of a transition to Ham iltonian chaos for dierent am plitudes of lightwaves at the boundary of the crystal. PACS: 42.65 Sf,05.45 A c,42.70 M p,42.65 K y

W ave m ixing in nonlinear optical m aterials is a basis of modern optical sciences and technologies. Cascading several wave-m ixing processes in the same low-loss material one can in principle achieve a high e ciency using a large value of the lowest-order optical nonlinearity. The theoretical investigations of cascading of several scalar optical three-wave-mixing processes in the bulk materials with ⁽²⁾ nonlinearity has a long history [1]. In particular, A khm anov and co-workers have found the e ciency of a third harm onic generation (THG) via cascading of a second harm onic generation (SHG) and a sum -frequency m ixing (SFM) in a quadratic m edium [2], while K om issarova and Sukhorukov have described an e cient param etric am pli cation at a high-frequency pum p in the sam e system [3]. O by iously, the observation of these nonlinear e ects dem ands a simultaneous satisfaction of phase-m atching conditions for several param etric processes as perfectly as possible. On other hand, it has been shown later that the system s, for which severalopticalwave-mixing processes can be simultaneously phase-m atched, are in general non integrable; therefore a com petition of two (or more) param etric processes can often result in a chaotic spatial evolution of lightwaves [4, 5]. However, until now adays it was unclear how to achieve a phase-m atching for several processes in hom ogeneous medium employing traditional techniques, such as using a birefringence in ferroelectric crystals.

The solution of this problem has been found rather recently [6,7,8]; it consists in an introduction of the di erent types of articial periodicity of a nonlinear medium resulting in a formation of nonlinear 1D and 2D superstructures term ed optical superlattices [9] or nonlinear photonic crystals (NPC s) [10]. In NPC s there is a periodic (or quasiperiodic) spatial variation of a nonlinear susceptibility tensor while a linear susceptibility tensor is constant.

In these engineering nonlinear materials a phase m ism atch between the interacting lightwaves could be com – pensated by the Bragg vector of NPC. The idea of such kind of quasi-phase-matching (QPM) was introduced by B been bergen and co-workers many years ago [11]. How – ever, only recently the rapid progress in a fabrication of high quality ferroelectric crystals with a periodic domain inversion made the QPM method very popular [9, 12]. We should stress that the conditions for QPM may be full led for several wave-mixing processes simultaneously; the QPM also has an advantage as using of largest nonlinear coe cient.

Now adays there are several experiments on an observation of third and fourth harmonics in dierent periodically or quasiperiodically poled ferroelectric crystals with ⁽²⁾ nonlinearity [7, 13, 14], which clearly demonstrate an importance of multiple-mixing in NPCs for the potential applications. Modern theoretical activities on the nonlinear lightwaves interactions in NPCs are mainly focused on the studies of strong energy interchange between the waves [12] (this is a development of the earlier activities [2, 3]), as well as on the formation of spatial optical solitons [15].

In this work we describe a novel for the physics of NPCse ect of Ham iltonian optical chaos. Namely, we show that spatial evolution of three light waves, participating simultaneously in SHG and SFM in the conditions of QPM, is chaotic for many values of complex am plitude of the waves at the boundary of (2)-NPC. There also exists an integrable lim it when the evolution of waves is always regular regardless of absolute values of their com plex am plitudes. The integrable lim it corresponds to the particular values of two combinations of wave phases at the boundary of nonlinear medium . In particular, the problem of THG belongs to the integrable lim it, therefore in the conditions of recent experiments [7, 13, 14], nonlinear light dynam ics should be always regular. However, even a rather sm all change in am plitudes and phases of waves at the boundary of crystal, in respect to those considered in [7, 13, 14], should result

where q(z) is a function that equals to +1 (or -1) in a single positive (negative) polarization dom ain of the ferroelectric crystal. In this work for the sake of sim plicity, we consider only a periodic alternative domain superlattice with a spatial period . However, g(z) can be a quasiperiodic function in the case of nonlinear quasicrystals [8, 9]. Note that we consider a typical situation

, where is a wavelength [9, 12, 14].

The coupling constants between waves, $_2$ and $_3$, are de ned as

where $d_{eff} = 2$ ⁽²⁾ and n is a refractive index. The refractive indexes for the di erent waves are di erent due to a light dispersion. However, it may be shown that n=n′ = 1 in the conditions of QPM, therefore in what follow swew ill take $_2 = _3$. Finally, the phase m is matches involved in Eqs. (1) are $k_2 = k_2 - 2k_1$ and $k_3 = k_3$ k_2 k_1 . Let both these m ism atches be compensated by a reciprocal lattice vector of NPC, that is

where $m_1 = 1$; 3; 5; The methods of achievement of QPM for several parametric processes in a single NPC have been recently discussed in Refs. [6, 8, 10] (theory) and Refs. [7, 13, 14] (experim ent).

The dynamical system (1) together with initial conditions, which in our case are the values of com plex am plitudes at the boundary of NPC, $A_{i}(z = 0)$, com pletely determ ine the nonlinear spatial evolution of waves. Before speci cation of these initial conditions, we can further simplify the equations of motion. F_{inst} , we introduce new scaled amplitudes $a_1 = A_1 = (1A_0)$, where $l = 1;2;3 \text{ and } A_0 \quad \max(A_1(0); A_2(0); A_3(0)). \text{ Sec-}$ ond, we make the Fourier expansion of the function g(z)

In the derivation of motion equations (3) we rem oved all fast varying terms performing averaging over 2 = . It can be shown that such a procedure is correct if l_{n1} [16].

The equations (3) can be presented in the canonical form with the Ham iltonian function

Additionally to the energy of wave interaction E н, (Eq. (5)), the dynamical system (3) has the integral of m otion

corresponding to the conservation of energy of noninteracting waves. In a general case the system (3) does not have other global integrals of motion, thus it is nonintegrable and should dem onstrate chaotic dynam ics for m any initial conditions $a_1(0)$ [17, 18]. How ever, for som e values of and some specic initial conditions, an additional local integral of m otion can arise. Let us list these cases because they include the physically in portant situations.

First, if one of the param etric processes, either SHG or SFM , is dom inant (1 or 1), then an additional integral of motion arises, which is of the Manley-Rowe type [12]. Second, nonlinear dynam ics is strongly dependent on the initial values of two \resonant phases" $_2(0)$ and $_{3}(0)$, where

and j (j = 1;2;3) are the lightwave phases, i.e. $a_j =$ $j_{a_1} j_{a_2} (0) = 0 dy$ nam ics is always regular. M oreover, using approaches of Refs. [3, 19], it is possible to show that an additional local motion integral exists in this case [20]. In particular, the problem of THG $(a_1(0) = 1, a_2(0) = a_3(0) = 0)$ belongs

to this class of initial conditions. Therefore, the spatial dynam ics of lightwaves at THG is regular (cfRef. [21], where an analytic solution has been found).

W e have perform ed an intensive search of chaotic trajectories solving the equations of m otion (3) num erically for two characteristic values of control parameter that correspond to the experim ental situations described in works [7] and [13], correspondingly:

W e consider several types of initial conditions, which cover practically all physically interesting cases (note that all these initial conditions satisfy to the restriction arising from the integral of motion (6)):

We start our analysis with \Problem 1". This set of initial conditions describes, in particular, the THG at = 1 (= 0) and the parametric amplication with a low-frequency pump at 1 [12]. In order to increase an e ciency of energy transform ation from a basic wave of frequency ! to a wave of frequency 3!, it was suggested recently to mix some nonzero signal at the frequency 2! with a basic beam [22]. Such kind of initial conditions correspond to ! 1 (but \neq 1) with di erent values of phase .

To distinguish regular and chaotic dynam ics we com pute the maxim al Lyapunov exponent max for the different values of initial lightwave's amplitudes, , and phases, . For chaos $m_{ax} > 0$, in contrast $m_{ax} = 0$ for a regular motion [18]. The dependence of m_{ax} on for the rst order QPM s (set I) is depicted in Fig. 1. For = 0 the initial values of resonant phases, $_2(0)$ and $_{3}$ (0), are zero corresponding to the integrable lim it with $m_{ax} = 0$ independently on the value of (not shown in Fig. 1). However, even a small deviation from the integrable lim it, $j_2(0)j = j_3(0)j = j_j = 0.01$, results in a chaotic motion for a quite wide range of initial conditions (dashed line). Further increase in the value of j jm akes chaos m ore strong (dotted line, j j= 0:1); the m ost strong chaos arises for j = -2 (solid line) corresponding to the initial values of resonant phases $j_{2;3}(0)j$ most distant from the integrable lim it.

The motion is always regular for the standard THG

spatial evolution of lightwaves for = 1 is shown in the upper subplot of Fig. 2. How ever, for j j= =2 a strong chaos exists already for 0:95, i.e. for a (0) = 0:95, $a_2(0) = 0.22i_1 a_2(0) = 0$, see lower subplot of Fig. 2. Thus, the possibility of transition to chaosm ust be taken

into account in the application of an additional pump of frequency 2! in order to increase an e ciency of THG [22].

We consider now the situation corresponding to the left hand side of Fig. 1 with 1. This is the param etric amplication with a low-frequency pump [12]. In this case our analysis demonstrates that the evolution of waves is weakly chaotic for $j_{2,3}(0)$ j distant from the integrable lim it. In this regime, the Lyapunov exponent has some very small but yet positive value, therefore it (= 1), as well as for some range of in the vicinity is very dicult to distinguish a weak chaos from a reguof = 1 (see the right hand side of Fig. 1). A regular larmotion. In practical terms, it means that one needs to have a very long sample to see the di erences between regular and weakly chaotic spatial evolutions of light waves.

Now we turn to the consideration of nonlinear dynam ics using the second set of QPM parameters but same set of initial conditions (\Set II, Problem 1"). Main results on the transition to chaos are depicted in Fig. 3. A gain,

as in Fig.1, j₂ (0) j= j₃ (0) j= j j= 0 results in a regular motion, while a motion is chaotic for many initial conditions if j j> 0. However, the absolute values of Lyapunov exponent are small: Really, max $_{max}$ ' 0:1 in Fig.1, but max $_{max}$ ' 0:01 in Fig.3. Therefore, we conclude that multiple interaction of waves employing high order QPM s is more stable against a transition to chaos in comparison with the case of rst order QPM s.

We consider now a nonlinear dynamics in the case when some portion of energy is presented at z = 0 in each of interacting waves (\P roblem 2"). We present our ndings in Fig. 4. A strong chaos arises as soon as one of the resonant phases becomes dierent from the integrable lim it j_{2;3} (0) j= 0 (j₂ (0) j= and j₃ (0) j= =2 for a solid line, j₂ (0) j= =2 and j₃ (0) j= 0 for a dashed line). We should note that for the parameters corresponding to a solid curve in Fig. 4 strong chaos exists for almost all values of initial wave amplitudes . Chaos is su ciently weaker for the high order QPM s in comparison with the case of rst order QPM s: cf a dashed line with a dashed and dotted line that correspond to the same values of phases j but to the dierent sets of QPM -parameters.

Finally, we analyze the set of initial conditions term ed as P roblem 3". In particular, it includes the down conversion [3, 12] or, in other words the fractional conversion ! ! (2=3)! [19], in the case 1. For this set of initial conditions we did not nd visible regions of chaotic dynamics.

In order to reliably distinguish regular and chaotic spatial evolutions of lightwaves in conditions of an experiment, one needs to have m any enough characteristic nonlinear lengths, l_{n1} , on the total length of the crystal L: $L = l_{n1} \& 10 [4, 5]$. Importantly, it appears possible

to m eet this condition in the typical NPCs. Really, for periodically poled lithium niobate with a period = 30 m, a crystal length L ' 1 cm, a nonlinear coe cient $d_{33} = 34 \text{ pm /V}$ [7, 13] and a light intensity $A_0^2 = 0.76$ GW /cm² (= 1:064 m) [23], we have $L = l_{h1}$ ' 100. M oreover, chaos should be easier observable in the G aA s optical superlattice with d_{14} 90 pm /V [24].

In sum m ary, we have shown that a simultaneous multiw avelength generation in typical nonlinear photonic crystals is often chaotic. This fact m ust be taken into an account in realization of compact laserm ulticolor sources for printers, scanners, and color displays based on the quasi-phase-m atched harm onics generation.

W e should distinguish our results from a recent paper [25], where nonlinear spatial eld dynamics and chaos have been studied in a quadratic m edia with a periodic B ragg grating.
