M ultiple scattering of light by atom s with internal degeneracy

A bstract. An analyticalm icroscopic theory for the resonant multiple scattering of light by cold atoms with arbitrary internal degeneracy is presented. It perm its to calculate the average amplitude and the average intensity for onephoton states of the full transverse electrom agnetic eld in a dilute medium of unpolarized atoms. Special emphasis is laid upon an analysis in terms of irreducible representations of the rotation group. It allows to sum explicitly the ladder and maxim ally crossed diagrams, giving the average intensity in the Boltzm ann approximation and the interference corrections responsible for weak localization and coherent backscattering. The exact decomposition into eld modes show sthat the atom ic internal degeneracy contributes to the depolarization of the average intensity and suppresses the interference corrections. Static as well as dynam ic quantities like the transport velocity, di usion constants and relaxation times for all eld modes and all atom ic transitions are derived.

1. Introduction

W ave propagation in disordered m edia has been an active eld of research for m ore than a century. The rst descriptions of electronic conduction in weakly disordered m etals by D rude [1] and of light propagation in interstellar clouds by Schuster [2] were based on B oltzm ann-type transport equations. D espite their successful predictions (e.g. 0 hm 's law), these theories overlooked the subtle role of interference. P. Anderson rst showed that su ciently strong disorder can induce a m etal-insulator transition for quantum -m echanical wave functions on a random lattice, a phenom enon baptized Anderson localization [3]. Furtherm ore, it was realized that interference in uences transport even far from the localization transition and that also other waves are concerned. For example, the constructive interference of counter-propagating light am plitudes in the backward direction, as rst pointed out by W atson [4], survives an average over disorder, giving rise to the coherent backscattering (CBS) peak [5, 6, 7]. In the past 20 years, the eld of m esoscopic physics has developed, with beautiful experimental and theoretical results pertaining to the weak localization regime [8, 9, 10].

A tom s, as natural realizations of highly resonant identical point scatterers, have been proposed as an ideal sample for multiple light scattering and even localization [11,12]. How ever, as rst discovered in experiments on CBS by rubidium atom s [13,14] and recently con rm ed on strontium atom s [15], the quantum internal structure of atom ic scatterers has a strong in pact on light transport properties. The Zeem an degeneracy of the probed dipole transition reduces the interference contrast of coherent backscattering [16] dram atically. The single and double scattering contribution to the CBS peak for atom s with arbitrary internal degeneracy have been calculated in [17].

In the present contribution, we develop an analytical theory of multiple resonant one-photon elastic scattering in an in nite medium consisting of a dilute gas of cold atom s at xed classical positions, but with arbitrary internal degeneracy. Our results are a rst step towards a microscopic generalization of the existing theories for the scattering of transverse vector waves by Rayleigh point scatterers [18, 19] on the one hand and of scalar waves by anisotropic scatterers [20, 21] on the other. The paper is organized as follows. In section 2, we de ne the Ham iltonian for the coupled system light and atom s. In section 3, we calculate the average propagator of a one-photon Fock state inside the scattering medium with the aid of the Dyson equation and the photon self-energy. In section 4, we de ne the average intensity for the full vector eld in terms of photo-detection probability. The corresponding Bethe-Salpeter equation is then solved by evaluating the so-called irreducible vertex in the Boltzmann approximation. Technically, this is achieved by a systematic analysis in terms of irreducible tensor operators. In section 5, we sum the so-called ladder series in the static lim it by applying the same method of irreducible tensors to the intensity propagator of transverse eld modes. The interference correction described by the maximally crossed diagrams is then easily obtained by applying substitution rules. In section 6, we generalize our results to the dynam ic case and derive analytical expressions for transport velocities, di usion constants, extinction lengths and relaxation times for the dierent eld modes and all atom ic transitions. W e conclude by possible extensions of the work.

2. Description of the system

2.1. Ham iltonian

In order to analyze the role of the atom ic quantum internal structure, we must treat the atom ic internal degrees of freedom quantum mechanically. For reasons of symmetry, the light eld is treated quantum mechanically as well. Using natural units such that $\sim = c = 1$, the global system \matter + light" is then described by the Ham iltonian $H = H_0 + V$ where

 H_{em} is the Hamiltonian of the free electrom agnetic eld. The annihilation and creation operators for the eld modes (wave vector k, transverse polarization ", free dispersion relation !_k = k) obey the usual bosonic commutation relation $[a_{k}";a_{k^{0}m}^{Y}] = ";^{n_{0}} k;k^{0}$. For brevity, a one-photon Fock state will be noted jk" i a_{k}^{y} ju where the transversality " k = 0 is understood. H_{t} is the sum of the individual internal atom ic Hamiltonians




Figure 1. Resonant degenerate dipole transition, here for $J=1,\,J_e=2.$ The atom ic resonance frequency is noted $!_{\,0}$, the detuning of the light probe $= ! \; !_{\,0}$, and the natural width of the excited atom ic state . The internal magnetic quantum numbers m are coupled to the polarization of scattered photons (full and dotted lines).

Each atom = 1;:::;N is described as a degenerate closed two-level system with an energy separation $!_0$ between the ground-state with total angular momentum J and the excited-state with total angular momentum J_e (gure 1). These levels are resonantly coupled by the dipole interaction

The individual atom ic dipole operator D acts on the Hilbert space H_g H_e of the internal atom ic states of atom . Dropping subscript , we de ne the reduced dipole operator d = D =d where d = hJ_ejp jjJ i= $2J_e + 1$. The matrix elements of its spherical components d_q e_q d, q = 1;0;+1 are the C lebsch-G ordan coe cients hJ_em_ejd_qjJm i = hJ_em_ejJ m qi according to the W igner-E ckhart theorem [22]. In the dipole interaction, the electric eld operator

is evaluated at the center of mass r of each scattering atom. The eld oscillator strength $E_1 = (!=2 \ _0 L^3)^{1=2}$ is given in terms of a quantization volum e L^3 that will disappear from physically relevant expressions in the limit of an in nite medium by virtue of the rule L $_{3}^{3}$ (:::) 7 (2) $_{3}^{3}$ d³k (:::).

2.2. Length scales hierarchy

The detailed description of wave propagation in a large sample of scatterers at quenched random positions is such a form idable task that one rather resorts to a statistical description, catching the generic features through con guration averaged quantities (average amplitude, average intensity, etc) [23, 24, 25]. In the following, we will consider the limit of a disordered in nite medium where resonant point scatterers are distributed with constant spatial density n. The absence of boundaries greatly simpli es the theory since translational symmetry is restored on average. The importance of interference depends essentially on the hierarchy between the physically relevant length scales in the system, here the wave length and the mean inter-particle distance n¹⁼³. We will concentrate on the bw density regime where n¹⁼³. This inequality, alternatively rewritten as n³ 1, justi es a sem i-classical description of propagation along rays between consecutive scatterers that de ne scattering paths

and their associated amplitudes. It also implies that scattering paths involving di erent scatterers are uncorrelated: since their phase di erence greatly exceeds 2, the associated interference term can be expected to average to zero. A lso, recurrent scattering sequences (visiting a given scatterer more than once) can be neglected: this is the independent scattering approximation (ISA) [23]. In this dilute regime, the elastic mean free path (mean distance traveled between two successive scattering events) is given by '= 1=m where is the total cross-section for elastic scattering. Since we treat resonant point scatterers where ², the low density condition implies ': wave scattering is described in the far eld. On the same ground, the equivalent relation '' shows that recurrent scattering is indeed negligible. And nally, the low density condition implies k' 1 where k = 2 = , which de nes the weak localization regime.

3. A verage light propagation

The simplest quantity of interest for wave propagation in random media is the average amplitude, so we st compute the conguration-averaged propagator hG (!) i.

3.1. The one-atom scattering operator

In the weak localization regime, a scattered wave has reached its asymptotic limit when undergoing a subsequent collision. Hence a central quantity in the theory is the oneatom transition operator T (z), given by the Born series T (z) = V + V G₀ (z)V + ::: in powers of the interaction V and the free resolvent operator G₀ (z) = (z H₀)¹ [26]. The scattering amplitude associated to the elastic scattering process jii = k"; Jm i! jfi = k^{0n} ; Jm⁰; Jm⁰ i is proportional to

where the notation ! + i0 indicates that retarded propagators are used in the Bom series and that the matrix elements are taken on-shell $(! = !_k = !_{k^0})$. Note that the incident and scattered wave vector appear only in the exponential on the right hand side: in the dipole approximation, the atom indeed behaves as a point scatterer, and the external and internal degrees of freedom are factorized. The frequency dependence of the internal transition operator t(!) is

where $= d^2 !_0^3 = 3_0$ is the natural width of the excited atom ic state, $= !_0^3$ is the detuning of the probe light from the atom ic resonance and $_0(!) = L^3 !_0^2 = 2^2$ is the free photon spectral density. This form of a resonant scalar t-m atrix is well known in the context of classical point scatterers [27]. But as the atom ic scatterer has an internal structure, particular attention m ust be paid to the tensor character of the scattering operator. For a given atom ic transition m $?m^0$, the C artesian elements of the t-m atrix are

This 3 3 t-m atrix can be decomposed into its irreducible components with respect to rotations, its scalar part (or trace), its antisym metric part and sym metric traceless

In the case of a point dipole $(J = 0; J_e = 1)$, only the scalar part is non-zero, $t_{ij} = t(!)_{ij}$. In the more general situation of arbitrary degeneracy, we have to determ ine the in uence of precisely the non-scalar parts on the average light evolution.

3.2. A veraging procedure

In the statistical description of light evolution inside a disordered scattering m edium, con guration averaged quantities h i $Tr[(_{at}]]$ are obtained by tracing over the m atter degrees of freedom. The external degrees of freedom are the uncorrelated classical positions fr g, and the average is performed by spatial integration. The internal average is a trace over the internal density m atrix. Since scattering theory relates asymptotically free states, this density m atrix only describes the statistical properties of the ground state. We further assume the total density m atrix $_{int} = \frac{1}{N}$

 $_{\rm J}$ () to be a direct product of one-atom density matrices, each proportional to the ground state unit matrix (complete statistical mixture, no internal correlations):

The free evolution of the photon state is then determ ined by the resolvent operator

where the average of the free resolvent operator $G_0(z) = (z + H_0)^{-1}$ (which is of course independent of the disorder) simply projects onto the atom ic ground state chosen to have zero energy. The full average evolution in the presence of the scatterers is described by the average resolvent operator hG (z) i which can be expanded in the Bom series

Summing all repeated interactions with the same scatterer, one obtains a series in term s of the one-atom scattering operators T (z) = V + V G₀(z)V + :::,

The average one-atom transition operator hT (z)i does not depend on its index

The right hand side features the contributions of free evolution, single scattering, double scattering, and so forth. Starting from the following term of triple scattering (not shown), this average contains second- and higher-order moments of one-atom scattering operators, arising from recurrent scattering by the same scatterer. A susual in diagram matic expansions [24], one introduces an operator representing the sum of irreducible contributions, the self-energy.

3.3. Self-energy and D yson equation

The average one-photon G reen function hG (z)i satis es the D yson equation

The Dyson equation actually de nes the self-energy (z) whose exact calculation remains in possible in most cases. Nevertheless, introducing the self-energy has two major advantages: First, any approximate expression for the self-energy will yield an approximate, but non-perturbative result for the average propagator (16). Second, the perturbative expansion of the self-energy in a power series and its truncation are controlled by the small parameter n⁻³. The self-energy contains precisely all irreducible diagrams, i.e. those that cannot be separated into independent diagrams by cutting a single line,

Here, the dotted line identies the same scattering operator appearing twice. Substituting this series into the Dyson equation (15) indeed reproduces the average propagator (13) in the therm odynam ic lim it N; L ! 1 at constant density $n = N = L^3$.

For a dilute medium n³ 1, the independent scattering approximation (ISA) amounts to the rst order truncation (z) N = N hT (z)i. With (5), the one-photon matrix elements of the self-energy are

The external average gives $he^{i(k-k^0)}$ $\exists_{ext} = k_{ik^0}$, indicating that the self-energy is diagonal in momentum space as required by the statistical invariance under translations. The internal average of the scattering operator (7) with the scalar density

The scalar product of polarization vectors, "⁰ " = ";"⁰ shows that the self-energy, as a second-rank tensor, is proportional to the unit matrix, (!) = (!)1, as required by statistical invariance under rotations. N ote that

depends directly on the number density $n = N = L^3$ so that the therm odynamic limit is trivial. For convenience, we de ne the multiplicity ratio $M_J = (2J_e + 1) = 3(2J + 1)$ with the non-degenerate limit $M_0 = 1$.

In optics and atom ic physics, the response of an atom to an external electric eld is often expressed in terms of the atom ic polarizability $(!) = \frac{2L^3}{!} ht(!) i [28]$. In the ISA, the polarizability is simply proportional to the self-energy, $(!) = \frac{!}{2}n$ (!), and thus a scalar. The dilute regime is alternatively characterized by nj j 1.

3.4. E ective medium

Its singularities are the solutions of the complex dispersion relation ! k (!) = 0. The average propagation can be seen to proceed through an elective medium with the complex-valued frequency-dependent refractive index $n_r = k = ! = 1 (!) = !$. The imaginary part of the self-energy denes the elastic mean free time

of a pure one-photon state k"i inside the m edium. Our perturbative approach proves to be consistent: the correction 1= to the free frequency ! is small by de nition in the weak scattering regime 1=! 1. A propagating wave-packet is therefore exponentially damped on average with a scattering mean free path '= (rem ember c = 1). This depletion is not caused by absorption, but by elastic collisions into initially empty eld states. At bw densities, and by virtue of the optical theorem, the m ean free path is simply '= 1=n in terms of the total elastic scattering cross section

In all of the above expressions, only a m odest dependence on J and J_e arises through the multiplicity ratio M_J. Obviously, the quantum internal structure has almost no impact on the average am plitude: under an average over the scalar density m atrix (9), only the scalar part or trace of the t-m atrix (8) can survive. We are left with a scalar theory for the average am plitude, describable in terms of the polarizability alone. But one should not conclude prem aturely that the internal structure has no impact on the average intensity which, of course, must be carefully distinguished from the square of the average am plitude.

4. A verage light intensity

In order to determ ine the average population of initially empty eld modes, we now turn to the average intensity, de ned in terms of photo-detection probability.

4.1. Intensity propagation kernel

Since the total H am iltonian $H = H_0 + V$ is time-independent, the density matrix of the coupled system \atom s + eld" evolves according to (t) = U (t) $U^{y}(t)$ where the forward time evolution operator U (t) is the Fourier transform of the retarded propagator G (!) = (! H + i0)¹,

The m easurable average light intensity at position r and time t is proportional to the average photo-detection probability [29],

Here, the factor N contains the detection e ciency, and E $^{()}(r)$ are the annihilation and creation components, respectively, of the electric eld operator (4). Their normal ordering assures that the photon vacuum state yields zero intensity. The amplitude evolves with the retarded propagator $G(!_+)$, and the conjugate amplitude with the advanced propagator $G^{y}(!_-)$. Here, ! is the average evolution frequency while is the frequency di erence: ! = ! =2. For sm all frequencies ! 0, the stationary regime (or long-time lim it) is recovered.

In the following, we restrict our theory to low intensity light elds, neglecting the non-linear response (i.e. saturation) of the atom ic dipole transition, by studying the evolution of a eld state containing at most one photon p^{W} e thus consider an initial density matrix of the form (0) = at where = $_{1,2} _{1,2}$ jlih2j describes the one-photon initial light eld with the short-hand notation 1 k_1 ". For example, $_{1,2} = _{1,i} _{2,i}$ describes a pure state consisting of an initial plane wave k_i "i. U sing (4), a straightforward calculation gives the average intensity for any incident eld

4.2. Bethe-Salpeter equation

For the average amplitude, the average propagator hG (!) i had been calculated by solving the Dyson equation with the help of the self-energy. In close analogy, the intensity propagation kernel obeys the Bethe-Salpeter equation

Here, the irreducible vertex U (!;) contains all diagram s with at least one vertical connection between the direct am plitude (upper line or \particle channel") and the conjugate am plitude (low er line or \hole channel") [30],

In general, this equation cannot be solved exactly, and the irreducible vertex U (!;) has to be approximated. Any approximation of U (!;) should be consistent with that of (!) since, physically speaking, the depletion of in initial state is caused by scattering into initially empty eld modes. M athem atically, this consistency is assured order by order in perturbation theory by a W ard identity [30].

4.3. Boltzm ann approxim ation

In the weak-scattering regime, the irreducible vertex m ay be approximated by the statem on the right hand side of (29) that represents the single-scattering contribution:

This is the so-called Boltzm ann approximation (or rst-order smoothing approximation). It proves to be consistent with the independent scattering approximation (18) for the self-energy since the corresponding W and identity reduces to the optical theorem (22) for = 0 [23]. The Bethe-Salpeter equation (32) then acquires by iteration the familiar and simple ladder structure R (!;) L (!;), or diagram atically:

Here both the direct and the conjugate am plitude are scattered by exactly the same scatterers. Thus, it is the squared am plitude or intensity that propagates from scatterer to scatterer, and all interference has disappeared. This approximation leads

for q ! 0 to a Boltzm ann transport equation for the intensity, justifying the D rude m odel for the electronic conductivity or the radiative transfer equation for di usive light transport [23].

The average single-scattering intensity (33) can be calculated explicitly. Using expression (5) for the matrix element of the one-atom scattering operator, one can immediately compute the external average and verify the total momentum conservation $he^{i(k_1 \ k_2+k_3 \ k_4)} \ r_{i_{ext}} = k_1+k_3,k_2+k_4}$ as required by the statistical invariance under translations of the in nite medium. The internal average of the squared atom ic scattering operator (7) can be calculated for an arbitrary internal degeneracy using the techniques of irreducible tensor operators (for details, see [17]):

4.4. W eak localization corrections

Finding among all possible diagrams the dominant interference corrections to the Boltzmann approximation proves to be a delicate subject [31]. Langer and Neal [32] introduced the so-called maximally crossed diagrams yielding an interference correction to the ladder terms independently of the density of scatterers:

These diagram s describe am plitudes that propagate along the same scattering paths but in opposite directions. Their interference is responsible for the weak localization corrections to the conductivity of electrons in weakly disordered m esoscopic system s [8] and can be implemented self-consistently through U (!;) U⁽¹⁾ (!;) + C (!;) [30]. This interference also gives rise to the coherent backscattering peak scattered from a bounded m edium [6]. There, the interference correction is calculated using the heuristic prescription R (!;) L(!;)+C(!;). In sections 5 and 6, the full ladder and crossed contributions will be calculated, preparing the ground for the calculation of the CBS peak and weak localization corrections.

The survival of an interference term despite an average over random realizations may seem miraculous at rst glance. Closer analysis reveals that it is really due to the fundamental symmetry of time reversal invariance. Let us brie y recall the exact relation between ladder and crossed diagrams. Take the rst non-trivial term of the ladder sum (34), the second-order scattering contribution with matrix elements

The rst substitution rule (46a), well known in the case of scalar wave scattering, in plies that the crossed and ladder terms are equal for scattering of plane waves $(k_1 = k_4 = k, k_2 = k_3 = k^0$ such that q = 0) in the backwards direction $k^0 = k$ since then also $q_c = k + k^0 = 0$. The second substitution rule (46b), known for vector waves, restricts the equality to the channels of preserved helicity or parallel linear polarization where $n^0 = n$. If these two conditions in the case of isotropic point scatterers are satis ed, then the reciprocity theorem, stemming from time-reversal invariance, indeed justi as the equality of ladder and crossed series. Symbolically, the crossed diagram can be disentangled by turning around its low er line and becomes topologically a ladder diagram [34]. The third substitution rule (46c) is new and arises because of the scatterers' internal structure: by turning around the low er am plitude according to the two previous rules, the atom ic internal vertices (39) are twisted. As explained in detail in [17], the inequality $w_2 \in w_3$ that causes a di erence of crossed and ladder contributions even for parallel polarizations must be attributed to the antisymmetric part $t^{(1)}$ of the scattering operator (represented by the coe cient s_1 in equation (37)).

The substitution rules (46a)-(46c) perm it to obtain the crossed contributions immediately from the ladder contributions or vice versa. In principle, one can calculate diagrams of arbitrary scattering order using the above prescriptions. A di usive transport for the intensity, however, only emerges in the limit where all ladder diagrams are summed up.

5. Sum m ation of ladder and crossed series

W aves can be either scalar or vectorial, and point scatterers can be either isotropic or anisotropic. This distinction de nes four classes of multiple scattering theories with growing complexity. The rst case of scalar waves and isotropic point scatterers can be considered well understood [25, 27]. The case of scalar waves and anisotropic point scatterers has been solved in the fram ework of the radiative transfer theory [20]. The multiple scattering of electrom agnetic vector waves by point dipole scatterers, from the rst approaches based on the di usion approximation [6, 35, 36] up to the exact solution of the radiative transfer equation by the W iener-H opf m ethod [18, 19], has kept a som ewhat discouraging appearance. Indeed, for a vector wave like light, polarization and direction are linked by transversality. In order to describe the evolution of the light intensity in three dimensions, one needs to manipulate tensors of rank four or 9 9 transferm atrices. The strategy employed in the literature consists in applying the scalarm ethods to this transferm atrix, which needs to be diagonalized in an appropriate way. The published results dem onstrate the di culty of the problem and the com plexity of its solution.

A solution for the most di cult case of vector waves and arbitrary scatterers is still lacking to our know ledge. But the scattering of light by atom s with a quantum internal structure falls precisely into this last class of di culties since the internal structure couples to the polarization and the isotropic dipole approximation J = 0is forbidden by de nition. In a previous work [17], we have been able to obtain the atom ic intensity vertex I (fxg) for arbitrary internal degeneracy J > 0 by a system atic analysis in terms of irreducible operators with respect to the rotation group. It is therefore natural to apply the same powerful tool in order to simplify the sum mation of the multiple scattering series as much as possible. In this section, we will consider the static case = 0, postponing the discussion of dynam ic e ects to section 6.

5.1. Strategy of sum m ation

Let us rst recall the solution for the case of scalar waves. This case can be viewed as a lim it of the full vector case by averaging over the incident polarization ", and

Note that n stems from the single scattering vertex U ⁽¹⁾ whereas 'is dened through the imaginary part of the self-energy. This distinction should be kept in mind when approaching the localization threshold, but in the present dilute regime we can use n '= 1. A thus only depends on the reduced momentum p = q'. The average intensity for vector waves is described in terms of four-point diagrams that connect the incident to the scattered polarization vectors. We see that the eigenvalues $_{\rm K}$ 2 [0;1] determ ine how faithfully the irreducible component $["_1"_4]^{({\rm K})}$ of incident eld polarizations is mapped on average to $["_2"_3]^{({\rm K})}$. An eigenvalue $_{\rm K} = 1$ means perfect mapping, an eigenvalue $_{\rm K} = 0$ means total extinction. Note that the scalar eigenvalue is identically $_0 = 1$ for all J;J_e. The scalar eld mode being the intensity, this sum rule rejects the conservation of energy. The explicit dependence of eigenvalues on the ground-state angular momentum J is given in table 2 on page 15 and displayed in gure 2 on page 17. In the case of the isotropic point scatterer (J = 0; J_e = 1) all eigenvalues saturate, $_{\rm K} = 1$, as expected for the identity operator (59). For J > 0, the non-scalar eigenvalues lie below unity, $_{1;2} < 1$. This is consistent with the physical intuition that an initially well-polarized light beam will be depolarized by so-called degenerate R am an transitions between di erent Zeem an-sublevels jJm 0 i \in jJm i.

Table 3 on page 16 contains their explicit dependence on J, and their behaviour is displayed in gure 2 on page 17. For the pure dipole scatterer (J = 0;J_e = 1), all ladder and crossed eigenvalues coincide trivially $_{\rm K}$ = $_{\rm K}$ = 1. But contrary to the ladder case, the crossed scalar eigenvalue $_0$ is not xed by any conservation law. It indeed deviates from unity, $_0 < 1$, as soon as J > 0, signifying a loss of contrast for interference corrections to the Boltzm ann intensity. In the lim it J_e = J ! 1, crossed and ladder eigenvalues take pairwise equal lim its, signifying a perfect contrast of interference, but non-negligeable depolarization as from a classical, anisotropic scatterer (think of a sm all oriented antenna). A negative crossed eigenvalue, e.g. $_0 = 1=3$ for $I_{\rm c} = J = 1=2$, in plies an even greater loss of contrast since then the sum m ed series behaves like $1=(1 \ _{\rm K}) < 1=(1 \ _{\rm j}\ _{\rm J})$.

Instead of using the exchange rule $(w_2; w_3)$ 7 $(w_3; w_2)$, the crossed eigenvalues can be obtained from the ladder ones by a partial recoupling of vectors in the vertex. By using the de ning properties of 6j-sym bols, one nds



From a conceptual point of view, the expressions (65) and (68) of the atom ic vertex eigenvalues in terms of 3n j-symbols are fully satisfying since we have reached their most concise, truly irreducible form ulation.

The direct product of two polarization vectors has nine independent components. The atom ic scattering vertices therefore can be represented by 9 9 transferm atrices whose eigenvalues are $_{\rm K}$ and $_{\rm K}$. Since the atom ic scattering vertices are averages over a scalar density matrix and therefore invariant under rotations, these eigenvalues are (2K + 1)-times degenerate (corresponding to the C lebsch-G ordan decomposition of the direct product of representations of dimension 3 3 = 1 + 3 + 5). Introducing the irreducible components greatly simplifies a problem that at rest glance de ed an analytical treatment. It is thus natural to apply this strategy to the problem of transverse propagation as well.

5.3. Irreducible eigenmodes of the transverse intensity propagator

The sum over the polarizations of an interm ediate photon in scattering diagram s like (42) de nes a transverse projector $"_{2k}"_i"_j = i_j \hat{k}_i \hat{k}_j$. The average retarded

Contrary to the rotation-invariant atom ic vertex, the intensity propagator now depends on the momentum q. Thus isotropic tensor modes can no longer be su cient, leading to a more involved, but still exact decom position (for details, see Appendix A)




Figure 3. Irreducible eigenvalues (74) of the transverse intensity propagator as functions of the reduced moment $p = q^{*}$. At the isotropic lim it p = 0, the eigenvalues are (2K + 1)-fold degenerate, and the coupling q(p), equation (76), between scalar and symmetric traceless modes vanishes.

The (2K + 1)-degenerate eigenvalues at the origin, g_{K} (0), have been used by A kkem ans et al. [6] in a qualitative evaluation of polarization e ects on the coherent backscattering peak, based on the di usion approximation for scalar waves. The expressions at order p^{2} (with a small error for the coe cient of g_{20}) have been found by Stephen and Cwilich [35, (7.4){ (4.9)] and M acK intosh and John [36, (4.16)]. The above functions, noted $_{i}(p) = 1$ g_{i} (p), are identical to those found by 0 zrin [18, (3.16)]. In a slightly modiled form, they appear also in the radiative transfer theory solved exactly by Am ic, Luc and N ieuwenhuizen [19, (3.8),(3.15)]. But these last approaches do not make use of an explicit analysis in terms of irreducible components, which here gives also the projectors on the corresponding eigenmodes in terms of

The multiplication table (A 30) of these coupling tensors can be found in the appendix. This coupling at $q \in 0$ can of course be form ally diagonalized, at the price of rather unwieldy expressions. At the limit of the summed multiple scattering series, this coupling term is more simply taken care of by the diagonalization of a 2 2 m atrix. Furtherm ore, it vanishes in the di usion approximation.

5.4. Sum of the ladder and crossed series

The tensor A entering into the ladder series (52) is given as the product of transverse intensity propagator and atom ic intensity vertex, $A_L(q) = G(q) I$. Knowing the respective decompositions (61) and (73) into eigenmodes, the product is simply

The m essage of this expression is clear: in order to generalize the multiple scattering of light to atom s, it su ces to multiply the vector eigenfunctions g_K (p) by the corresponding atom ic eigenvalue $K(J;J_e)$ a rather trivial prescription once the m eaning of the word \corresponding" has been clari ed (which constitutes the m ain achievem ent of the present theory).

6. Transport velocity, di usion constant and relaxation times

Let us now turn to the discussion of dynamic quantities like the transport velocity and the di usion constant for the di erent eld modes. In the dynamic setting

6.1. Transport velocity

In order to determ ine the long-time and long-distance behaviour of transport, one habitually develops the propagator to lowest orders in and q. Since the atom ic internal structure has completely factorized from the frequency dependence, we exactly recover results that are well-known from the case of resonant scattering of scalar waves by point particles [23, 25]. Let us brie y show how the main results are obtained very easily in our fram ework. The small frequency behavior of (96), B() = 1 + i + 0(2), de nes a common transport time scale for all eld modes,

Re (!)). The group velocity by itself boses its physical meaning in the vicinity of a scattering resonance where extinction cannot be neglected. The transport velocity $v_{tr} = '=_{tr} = (v_g^{-1} + w_g)^{-1}$, how ever, stays causal, $v_{tr} = 1$, at all frequencies !, and m ay decrease by orders of magnitude at resonance for a high enough density of scatterers [39, 23]. In the present case of resonant point scatterers, the above expressions sim plify remarkably since

and the dwelltim e1= .At resonance, for example, the W ignertime delay is $_{W} = 2 = ,$ but the group velocity correction is negative since Re $^{0}(!_{0})=2$ Im $(!_{0}) = 1 = .$ W hereas the W ignertime delay accounts for the (possibly large time) spent \inside" a resonant scattering object, the total dwell time includes the self-consistent dressing of scatterers by the surrounding elective medium which must not be neglected.

6.2. Extinction lengths

The transversality of the light eld and the atom ic internal structure are connected to the spatial variable q. Setting = 0 in a rst step, all propagation eigenfunctions (74) have a quadratic development in p = q of the form g_K (p) $k \in p^2$, whereas the coupling term vanishes quadratically, $g(p) = ep^2$. At order p^2 , the coupling between scalar and symmetric traceless modes disappears, and the propagators (84) for the transverse ladder modes behave like

that is responsible for an exponential decay of the mode K; in real-space (in eld theory, this corresponds to a nite particle mass $m = {*}_{K}^{-1}$). We notice immediately that the intensity or scalar mode K = 0 has a diverging extinction length since $b_0 = 1$ and $_0 = 1$ for arbitrary internal degeneracy. This true di usion pole (or massless G oldstone mode) survives thanks to a fundamental conservation law, the conservation of energy. All other eld modes have nite, and in fact rather short extinction lengths ${}^{*}_{K}$ (J). ', implying that the transversality of propagation mixes well-de ned polarization modes. The smaller b_{K} and $_{K}$, the shorter the extinction length. Thus, the atom is internal degeneracy, responsible for $_{1;2} < 1$ as soon as J > 0, leads to even smaller extinction lengths for non-scalar eld modes. This observation con ms the intuitive picture that degenerate R am an transitions between di erent Zeem an sublevels jJm ⁰i \in jJm i contribute to scram ble the eld polarization.

A nalogous argum ents apply for the crossed propagator. Here, the atom ic ladder eigenvalues are replaced by their crossed counterparts $_{\rm K}$, and the crossed extinction lengths are

The scalar eigenvalue $_0$ is not constrained by energy conservation and can become very small for J > 0 (cf. gure 2). The atom ic internal degeneracy breaks the tim e-reversal sym m etry between ladder and crossed propagators, and leads to a rapid exponential dam ping of the interference m odes.

Extinctions lengths of the order of or smaller than the scattering mean free path 'in ply that the evolution can no longer be considered di usive. Am ic et al. [19] have stressed that the exact extinction length, de ned as the inverse of the pole of the propagator with smallest imaginary real part, can di er from the above di usive expression by as much as 50%. This di erence is bound to become even worse as the atom ic eigenvalues decreases. Clearly, a quantitative prediction for the propagation of the full vector eld must go beyond the di usion approximation. This is especially true if one is interested in coherent backscattering from a nite scattering medium, where short paths or non-scalar eld modes can become dom inant.

6.3. Di usion constant and relaxation times

Combining the developments linear in and quadratic in q, the ladder propagators take the form

The physical meaning of this relaxation time is equivalent to that of the extinction lengths $'_{\rm K}$ dened above since $'^2_{\rm K} = D_{\rm K} t_{\rm K}$. For the scalar mode of eld intensity, $t_0^{-1} = 0$ implies a truly di usive transport as required by local energy conservation. For the non-scalar eld modes, the nite relaxation times $t_{1,2}$ become of the order of the transport time $t_{\rm tr}$ indicating that light transport can no longer be described accurately in the di usion approximation, a tendency aggravated by the internal atom ic degeneracy leading to $t_{1,2} < 1$. For the crossed propagator, analogous conclusions hold. The quantum internal structure introduces dephasing times as will be discussed elsewhere [40].

6.4. Conclusion and things to be done

In summary, we develop a consistent theory for the multiple scattering of photons by a dilute gas of cold atom s. The external degrees of freedom of the atom ic point scatterers are supposed to be classical Poissonian variables. Particular attention is paid to the internal degrees of freedom : a resonant dipole transition of arbitrary degeneracy is treated analytically by a system atic use of irreducible tensor operators. We sum the ladder diagrams of the full transverse vector eld, and calculate the correction of maxim ally crossed diagram s. The internal degeneracy has no impact on the properties of the average am plitude (such as the scattering m ean free path) since the average over a scalar internal density matrix projects onto the scalar component of the transition matrix. Furtherm ore, the internal degeneracy is only coupled to the (static) polarization vectors and completely factorized from the (dynamic) frequency dependence. Therefore, the transport velocity and the di usion constant remain una ected. However, the interference properties are strongly modied. Indeed, the non-scalar parts of the scattering t-m atrix survive in the average intensity and are responsible for a decrease of contrast as soon as J > 0. In the di usion approximation, we give expressions for extinction lengths or relaxation times that depend in very simplem anner on J. A tom s thus appear as an important class of an isotropic scatterers with intriguing interference properties that allow a complete analytical description of light scattering.

The present contribution deals with transport inside an in nite scattering medium, taking full advantage of the statistical invariance under translations which

m akes all operators diagonal in m om entum representation. The in uence of boundary conditions, relevant for coherent backscattering or transm ission experiments, m ay be evaluated in the framework of the exact W iener-Hopfm ethod or of the approximate m ethod of images. Both approaches deserve a detailed discussion which is beyond the scope of this paper and will be discussed elsewhere [41]. A nother important issue is the in uence of an external magnetic eld. Perhaps the systematic use of irreducible tensors can help to simplify the theoretical description of light transport in magneto-active media [42]. In addition, the impact of a splitting of the internal Zeem an degeneracy remains to be studied, experimentally as well as theoretically.

The transversality of the propagating light eld in poses a change of polarization in the course of multiple scattering. In this respect, the present theory provides a m icroscopic analogue of spin-orbit coupling studied extensively in electronic disordered system s [8]. But contrary to the electron case of spin $\frac{1}{2}$, no weak anti-localization for the spin 1 photon can be expected, however strong the spin-orbit coupling. The scattering of photons by atom s with internal degeneracy appears as an analogue of spin- ip scattering of electrons by m agnetic in purities [8]. Interestingly, we can derive exact expressions for characteristic extinction lengths and relaxation times, and further experimental as well as theoretical studies can be envisaged. The links between optics and atom ic physics on the one hand and condensed m atter physics on the other thus prom ise to continue to be an in portant source of inspiration to both elds.
