## Shannon information increase and rescue in friction

## A bstract

On the standard m icroscopic model of friction we con muthe common belief that the irreversible entropy production originates from the increase of Shannon information. We reveal that the reversible microscopic dynamics would continuously violate the Gibbsian interchangeability of molecules. The spontaneous restoration of interchangeability constitutes the mechanism of irreversibility. This is the main suggestion of the Letter. We also point out that the irreversible entropy can partially be rescued if the size of the medium is nite. The rescueable entropy is found to be proportional to the square of the Fisher statistical (also called thermodynamic) distance.

Introduction. It is commonly trusted that the thermodynamic entropy produced in irreversible processes is identical to the increase of the Shannon information in the underlying microdynamic process. A direct proof is yet missing. The microscopic dynamics is reversible, it preserves the Shannon information. We need a transparent model to resolve this fundamental paradox. In this Letter I discuss the mechanical friction of a thin disc' perpendicularly driven through a medium with small velocity V. The phenomenological model is a prototype for the whole theory of irreversible processes [1]. A coordingly, the disc moves against the frictional force V where is the friction constant. If the medium (reservoir) is in thermal equilibrium at inverse temperature—then the rate of them odynamic entropy production can be written in this form:

An elementary microscopic model will be considered where the medium is ideal gas of light molecules scattering elastically on both at surfaces of

the disc. This is the Brownian motion microscopic model well-known from textbooks [2], applied this time to a disc instead of a ball [3]. The model enables us to calculate the exact reversible evolution of the microscopic system. I will con m that the thermodynamic entropy production rate (1) can indeed be identified as the rate I-of Shannon information increase in an in nite medium:

if the molecular interchangeability, which is being violated by each reversible collision on the disc, is being re-imposed (a la Gibbs). This appears to be a generic mechanism of irreversibility in the otherwise reversible dynamics.

The molecular interchangeability is less relevant if the medium is nite. Then, as we shall prove, the increase of Shannon information becomes less than the standard irreversible entropy production (1):

In the given m icroscopic model, the rate of the rescued information (and entropy) will take the following form:

where S- is the standard irreversible entropy production rate (1) and the rescue factor is the ratio of the already interacted molecules within the whole reservoir.

Shannon information. Let the medium be ideal gas of N identical molecules of mass m . The initial distribution of the momenta  $p_1; \ldots; p_N$  is the thermal equilibrium distribution at inverse temperature :

The molecules collide on the disc elastically (reversibly). The mean intercollision time is assumed to be independent of V which is a good approximation for small velocities V. In a single collision, the momentum change of the given molecule is approximately the following:

provided the m olecules are much lighter than the disc. In a short yet m acroscopic interval  $\,t\,$  , the average m om entum  $\,$  transfer to the m edium  $\,$  is

 $2m\ V = .T$  herefore the average frictional force is  $2m\ V = w$  hile the friction constant takes this  $sim\ ple$  form :

(For sim plicity, we request that no molecules will scatter twice or more. It also means that the mass of the medium is being consumed by the collisions at rate =2. Then, in a nite reservoir of mass M  $_{\rm R}$  = N m, the friction process would be cut at time 2M  $_{\rm R}$  = .)

After time t, the equilibrium distribution is shifted:

where  $p_r$  is the mean momentum transfer caused by collision to the r'th molecule. Obviously, the Shannon information has been preserved by the collisions. On the other hand, we know from the thermodynam ics of friction that there is a denite entropy production (1). We suspect that an ultimate information increase comes from the undistinguishability of the molecules. We assume that know ledge is leaking out, regarding which molecule scattered on the disc and which did not. A coordingly, the true distribution to the medium must be the re-symmetrized projection of the post-collision distribution (8) over all permutations of the N molecules:

We de ne the increment of the Shannon information (counted in ln2 bit units) during the interval t:

U sing the Eqs.(5,9), I have derived the Taylor-expansion upto the lowest non-vanishing order of the momentum transfers:

The two terms on the R.H.S. correspond to macroscopic quantities. There are two relationships, respectively. The rst is the balance between the

average energy increase of the medium and the energy dissipated by the friction force:

Sim ilarly, there is an average m om entum balance as well:

Let us insert the above two relationships into (11), yielding the following rate of inform ation increase:

This is the central result of the Letter. It con mm s the equality (2) of irreversible information (14) and entropy (1) productions in in nite mass reservoirs (M  $_{\rm R}$  = N m = 1 ).

Information rescue. In a nite reservoir, the Eq.(14) contains a non-stationary correction, we call it the rescued information. Its rate reads:

This equation is equivalent with the Eq.(4) if we set  $=\frac{t}{2M_p}$  which is indeed the ratio of the consum ed m ass of molecules to the total m ass of the reservoir. In conventional system (reservoir setups the mass M  $_{\rm R}$  of the reservoir is kept constant. Yet we can consider non-static setups where the reservoir mass is allocated dynamically, i.e., varying with time. We shall therefore introduce a monotone function M  $_{\rm R}$  (t) with xed in itial M  $_{\rm R}$  (0) = 0 and nalvalues M  $_{\rm R}$  (t<sub>tot</sub>) = M  $_{\rm R\,tot}$ , where t<sub>tot</sub> is the total considered time of the process. (The allocation rate  $M_{-R}$  should never fall below the consum ption rate M-R =2. In the rest of the Letter we shall understood this condition, without mentioning it again.) The function  $M_R$  (t) will govern the gradual allocation of the medium to the friction process. A discretized interpretation is the following. We divide the total time and reservoir into small yet macroscopic parts. In each short interval [t;t+ t] in turn, a sm all part M  $_R$  (t) = M  $_R$  (t+ t) M  $_R$  (t) of the total m ass M  $_{R \text{ tot}}$  is used as medium: the small medium is brought into contact with the disc at the beginning of the small period and removed at the end of it, to be replaced by the forthcoming smallmedium e.t.c., until the whole period [0;ttot.] and

the total reservoir m ass M  $_{R \text{ tot}}$  are both exhausted. To the first short period [0; t], in particular, we allocate a smallm ass M  $_{R}$  (t) M $_{R}$  (0) t. Substituting M  $_{R}$  by M $_{R}$  (0) t, the rate (15) of the rescued information becomes stationary on the macroscopic time scale:

We can extend this dierential relationship for all later time. Invoking the Eq.(4), we can read out the rescue factor for the case of time-dependent reservoir allocation:

This is the ratio of the reservoir's consumption rate =2 with respect to its allocation rate  $M_{-R}$ .

An optim ization of the rescued inform ation (entropy) is straightforward. We are going to maxim ize the total rescued inform ation:

by varying M  $_R$  (t) at xed total reservoir m ass M  $_R$  tot. The Euler-Lagrange equation yields M $_R$  = const V  $_R$  The optim um reservoir allocation M  $_R$  (t) is thus proportional to the length  $_0$  V dt of the disc trajectory. W e should allocate equal reservoir m asses over equal lengths of the driven trajectory of the disc. For the special case of stationary driving V = const, the optim um allocation is also stationary: M $_R$  M $_R$  tot= $t_{tot}$ . The optim um ratio (17) of the rescued/standard inform ation (entropy) takes this form:

Reservoir-driven process. We apply our results to the case when we do not directly drive the disc. Rather we change slowly the velocity  $V_R$  (t) of the medium and only the frictional force  $(V \ V)$  will drive the disc. All previous equations remain valid if V is substituted by  $V \ V_R$  which can be further expressed from the Newton equation M  $V = (V \ V)$  where M is the disc mass. The resulting substitution has thus to be  $V \cdot V = V$ . The therm odynamic entropy production rate (1) takes this form:

and for the rescued information (entropy) rate (16) we obtain:

It is rem arkable that the friction constant canceled! The rescued inform ation in the reservoir-driven process is universally independent of the tem poral scales. (The rescue factor will, however, keep its -dependence (17).) The optim ization of the rescued information (entropy) is again straightforward. We minimize the total rescued information:

at xed total reservoir m ass M  $_{R\,tot}$ . The variation of the allocation function M  $_{R}$  (t) yields the condition M $_{R}$  = const V. The optimum reservoir allocation M  $_{R}$  (t) is proportional to the velocity change V (t) V (0) of the disc. For the special case of constant acceleration V = const, the optimum allocation is stationary: M $_{R}$  M $_{R\,tot}$ =t $_{tot}$ . The optimum rescue factor is the same (19) as for the externally driven disc.

rescaling the parameter length dV in absolute units of equilibrium them odynamics. Let us express the evolution in function of the statistical length instead of the time t. Replacing (21), we obtain the following result for the rescued entropy rate:

where the apostrophes stand for 'derivatives. The maximum of the rescued entropy is obtained by variation of the reservoir allocation function M  $_{\rm R}$  (') between the xed endpoints. The resulting optimum is M  $_{\rm R}$  (') = const '. In the thermodynamic length, the optimum rescued entropy rate (24) is

constant and the total rescued entropy becomes a simple quadratic function of the total statistical length:

It depends exclusively on the equilibrium therm odynam ics of the disc { reservoir frictional interaction .

Discussion. On the common microscopic model of friction we have pointed out that the standard therm odynam ic entropy production derives exactly from the increase of Shannon information. The well-known discrepancy with the microscopic reversibility has been resolved in a natural way. The resolution comes from a related discrepancy, revealed by the Letter: The microscopic model is inevitably violating the Gibbsian interchangeability of molecules. The recovery, i.e., the re-sym metrization of the phasespace density is obviously irreversible. This is the mechanism of Shannon inform ation increase and of macroscopic entropy production. (The role of interchangeability in the irreversibility of system-reservoir interactions has independently been noticed for a quantum in form atic model of non-therm al equilibration by Zim an et al. [6].) The rst proof of perfect coincidence between the Shannon information and the phenomenological entropy production in a common irreversible process has been achieved by the present Letter. The phenom enology of friction is structurally identical to the model of general irreversible processes [1]. We therefore incline to think that our results rejects general features of irreversible processes.

We have also shown that the inform ation increase falls with the size of the medium. A certain portion of the standard entropy production can thus be rescued in nite reservoirs. The Gibbsian molecular interchangeability, having been violated locally, will be recovered by a process propagating in space. The identity of the distinguished molecules (i.e. of those which took part' in friction) will be smashed gradually over bigger and bigger parts of the surroundings. It is clear that this propagation is cut by the walls of the reservoir though temporal aspects (if any) of the propagation have not been discussed at all.

Entropy rescue m ight remain pure speculation for static reservoirs. The Letter has discussed time-dependent reservoir allocations. An externally driven by ject' in a medium at rest as well as an object driven merely by the frictional force in a moving medium have been considered. The optimum reservoir allocation is proportional to the real length of the object trajectory in the rst case, and to the statistical (thermodynamical) length in the second case. The second result gives an exact microscopic interpretation

for the role of therm odynam ic length in irreversible process optim ization. This may be a crucial step in the longstanding complex research [4, 5, 7] to illuminate the signicance of Fisher's statistical distance in statistics, control, therm odynamics, and quantum information.
