Structure Space of M odel P roteins: A Principal C om ponent A nalysis

Abstract

We study the space of all compact structures on a two-dimensional square lattice of size N = 6 6. Each structure is mapped onto a vector in N – dimensions according to a hydrophobic model. Previous work has shown that the designabilities of structures are closely related to the distribution of the structure vectors in the N -dimensional space, with highly designable structures predominantly found in low density regions. We use principal component analysis to probe and characterize the distribution of structure vectors, and nd a non-uniform density with a single peak. Interestingly, the principal axes of this peak are almost aligned with Fourier eigenvectors, and the corresponding Fourier eigenvalues go to zero continuously at the wave-number for alternating patterns (q =). These observations provide a stepping stone for an analytic description of the distribution of structures by simply Fourier transform ing the hydrophobicities of the corresponding sequences.

I. IN TRODUCTION

Proteins fold into speci c structures to perform their biological function. Despite the huge diversity in their functions, evolutional paths, structural details, and sequences, the vast majority of proteins adopt only a small number (1000) of folds (\topology").^{1,2,3,4,5,6} This observation has intrigued a number of authors and lead to the concept of designability.^{1,7,8,9,10} The designability of a structure is de ned to be the number of sequences that have that structure as their unique lowest-energy state.¹⁰ It has been shown in various model studies that structures di er drastically in their designability; a small number of highly designable structures are also found to possess other protein-like properties, such as therm odynam ic stability,¹⁰ fast folding kinetics,^{9,17} and tertiary symmetry.^{8,10,18} These results suggest that there may be a designability principal behind nature's selection of protein folds; these small number of folds were selected because they are readily designed, stable against mutations, and therm odynam ically stable.

W hy are some structures more designable than others? How do we identify highly designable structures? Finkelstein and ∞ -workers argued that certain motifs are easier to stabilize and thus more common because they either have lower (e.g. bending) energies or have unusual energy spectra over random sequences.^{1,19,20} G ovindara jan and G oldstein suggested that the topology of a protein structure should be such that it is kinetically \foldable".^{9,11,21} M ore recently, it was noted that an in portant clue resides in the distribution of structures in a suitably de ned structure space, with highly designable structures located in regions of low density.^{12,13} In particular, within a hydrophobic model, Liet al. showed that the distribution of structures is very nonuniform, and that the highly designable structures are those that are far away from other structures.¹² However, identifying highly designable structures and the structure and the sequence spaces, making studies of large systems prohibitive.

In this paper, we investigate the properties of the structure space of the hydrophobic model of Li et al., starting from a Principal Component Analysis (PCA). We show that while the distribution of the structures is not uniform, it can be approximated as a cloud of points centered on a single peak. The principal directions of this cloud are almost coincident with those obtained by rotation into Fourier space; the coincidence is in fact exact for the subset of cyclic structures. An interesting feature is that the eigenvalues of PCA, describing the extent of the density cloud along the principal axis, vary continuously with the Fourier label q, with a minimum at q = corresponding to alternating patterns. The continuity of the eigenvalues suggests an expansion around q = , which leads to an analytical conjecture for the density of structures in the N-dimensional binary space. A ssum ing the validity of this conjecture in more generalm odels, it provides a means of estimating density, and hence indirectly designability, of structures by simply analyzing their sequences, without the need for extensive enumerations of other possible structures.

The rest of the paper is organized as follows. In Section II we review the hydrophobic model and the designabilities of structures. In Section III we discuss the methods and the results of PCA applied to the structure space, and relate the density and designability of a structure to its projections onto the principal axes. In Section IV we demonstrate that

Fourier transform ation provides a very good approxim ation to PCA, and show that in fact the two procedures are equivalent for the subset of cyclic structures. As a comparison with real structures, in Section V we introduce and study an ensemble of pseudo-structures constructed by a M arkovian process. Finally, in Section V I we synthesize the num erical results of PCA analysis, and develop a conjecture for the density of points in structure space.

II.THE HYDROPHOBIC MODEL

We start with a brief review of the hydrophobic model of Liet al¹² and the designabilities of structures. Model sequences are composed of two types of am ino acids, H and P. Each sequence fh_ig (for i = 1;2; ;N) is represented by a binary string or vector, with h 0 for a P-m er and h_i = 1 for an H-m er. We take the polym er length N = 36, for which there are 2^{36} sequences. Each of these sequences can fold into any one of the many compact structures on a 6 6 square lattice (Fig. 1). There are 57;337 such compact structures unrelated by rotation and m inter symmetries. In the hydrophobic model, the only contribution to the energy for a sequence folded into a structure is the burial of the H-m ers in the sequence into the core of the structure. So if one represents a structure by a binary string or vector, fs_ig, for i = 1;2; ;36, with s0 for the surface sites and s_i = 1 for the core sites (Fig. 1), the energy is

where h_i is the sequence vector.

The designability of a structure is de ned as the number of sequences that have the structure as their unique lowest-energy state. To obtain an estimate for designabilities of structures, we random ly sam pled 50;000;000 sequences and found the unique lowest-energy structure, if any, for each of them. In Fig. 2, we plot the histogram of designabilities, i.e. number of structures with a given designability. Note that we have normalized designability so that its maximum value of 2981 is scaled to one. In this paper, we de ne highly designable structures to be the top one percent of designable structures (structures with nonzero designability), which means 307 structures with a designability larger than 0:47.

In the hydrophobic model, both sequences and structures can be regarded as points in a 36-dimensional binary space, or corners of a hypercube in a Euclidean space of similiar dimension. In this representation, the lowest-energy state of a sequence is simply its nearest structure point.¹² D esignabilities can then be obtained by constructing Voronoi polyhedra around allpoints corresponding to structures in this space; the designability of each structure is then the number of sequence points that fall within the corresponding Voronoi polytope (Fig. 3). Structures in the lower density regions have larger Voronoi polytopes and higher designability. Understanding how the structure points are distributed in this 36-dimensional space can thus help us address questions concerning designability. In the next section we exam ine the distribution of the structure points via the method of PCA. First, let us note that while sequences are uniform ly distributed in the 36-dimensional hypercube, structures are distributed on a 34-dimensional hyperplane because of the follow - ing two geometrical constraints. The rst constraint on structure vectors comes from the fact that all compact structures have the same number of core sites, and thus

The second constraint is that since the square lattice is bipartite, and any compact structure traverses an equal number of black' and white' points,

Next, let us de ne the covariance matrix of the structure space as

where i; j = 1;2; ;36, and the average is over all the 57;337 possible; $(s_2; s_3;)$ s for compact structures. The 36 36 covariance matrix is symmetric $C_{i;j} = C_{j;i}$, and also satis as the condition $C_{i;j} = C_{37} \cdot i;37 \cdot j$. The latter is due to the reverse-labeling degeneracy of the structure ensemble, since if the string $(s_1; s_2; s_3;)$ s is in this ensemble, then its reverse $(s_{36}; s_{35}; s_1)$; is also included. This symmetry implies that if $(v_1; v_2; s_3;)$ vis an eigenvector of the matrix $C_{i;j}$, then $(v_{36}; v_{35}; s_1)$; is also an eigenvector with the same eigenvalue. Therefore, for every eigenvector of $C_{i;j}$ we have either $v_j = v_{37,j}$ or $v_j = v_{37,j}$.

As depicted in Fig. 4, the matrix C_{ij} is peaked along the diagonal and decays o diagonally with short range correlations. This feature rejects a general property of compact self-avoiding walks; if a monomer is in the core (on the surface) the neighboring monomers along the chain have enhanced probability to be in the core (on the surface). Another characteristic of C_{ij} is that it is almost a function of ji jjonly, i.e. C_{ij} F (ji j), barring some small end and parity elects. We expect this feature of approximate translational invariance to be generic beyond the 6 for a barring some attrix for the subset of highly designable structures. While qualitatively similar, it tends to decay faster o -diagonally than that of all structures. This is attributed to the fact that highly designable structures tend to have more frequent transitions between core and surface sites.^{12;15;22}

For PCA of structure space, the matrix C_{ij} is diagonalized to obtain its eigenvectors $fv^{(k)}g$, and the corresponding eigenvalues f_kg for k = 1;2;; 36, which are shown in Fig. 5. The two zero eigenvalues $(_1 = _2 = 0)$ result from the constraints in Eqs. (2) and (3), with the corresponding eigenvectors of $v_i^{(1)} = 1$, and $v_i^{(2)} = (_1)^i$ for i = 1;2;; 36, respectively. The remaining 34 nonzero eigenvalues range smoothly from zero to one, making any further dimensional reduction not obvious. For comparison, the 36 eigenvalues of the uniform ly distributed points of sequence space are all the same (= 1=4). (It is easy to show that the covariance matrix for the sequence space is $C_{ij} = _{ij}=4$.) On the other hand,

a uniform distribution on the 34-dimensional hyperplane where the structure points reside would result in 34 identical eigenvalues of 360=1377 0.26.²³

Identi cation of the principal axes and eigenvalues does not necessarily provide inform ation about the distribution of points in space. To exam ine the latter, we ist project each structure vector onto its components along the eigenvectors. Using the rotation m atrix R_{ki} that diagonalizes the covariance m atrix, the component y_k of the structure vector along principal axis k is obtained as

Interestingly, we do not hat along each of the principal directions, the distribution of components is a bell-shaped function with a single peak at zero. Such distributions can then be well approximated by G aussians whose variances are the corresponding eigenvalues $_{k}$, i.e.

In Fig.6 we show the distribution of projections y_k on two principalaxes k = 16 and k = 36, along with the corresponding G aussian distributions.

Equation (6) provides a good characterization of the density of structures in the N dimensional space. Highly designable structures are expected to lie in regions of this space where the density of structures is small, while the number of available sequences is large. Let us consider a structure characterized by a vector y. If the density of structural points in the vicinity of this point is $_{\rm str}$ (y), the number of available structures in a volum e V around this point is $V_{\rm str}$ (y). Neglecting various artifacts of discreteness, the volum e of the V oronoi polyhedron (see F ig. 3) around this point is given by V (y) $1 = _{\rm str}$ (y). The designability is the number of structures within this volum e, and estim ated as $_{\rm seq}$ (y), where $_{\rm seq}$ (y) is the density of sequences. The sequence density is in fact uniform in the N -dimensional space. The structure density can be approximated as the product of G uassians along the principal projections, and thus

We have neglected various proportionality constants in the above equation, leading to the quantity M (γ) which is our estimator for designability. In Fig. 7, the estimate M is plotted against the actual designability for all designable structures. There is a reasonably good, but by no means perfect, correlation between the designability and the estimator M. The structures with the top one percent value of M include 39% of the highly designable structures.

IV.FOURIER DECOMPOSITION AND CYCLIC STRUCTURES

In discussing Fig. 4, we already noted that the covariance matrix C_{ij} is approximately a function of ji j; with corrections due to end e ects. If this were an exact symmetry, the

m atrix would be diagonal in the Fourier basis. Even in the presence of the end e ects, Fourier decom position provides a very good approximation to the eigenvectors and eigenvalues of PCA, as demonstrated below. For each structure vector fs_jg , the Fourier components are obtained from

where q = 2 = N, with = 0;1;; N = 1. The average value of this subtracted for convenience. With this subtraction, the two constraints in Eqs. (2) and (3) correspond to two zero modes in Fourier space, as $S_0 = 0$ and S = 0, and since fs_jg are real $S_q = S_q$.

The covariance matrix in the Fourier space is

and is both real and symmetric (since $C_{jj^0} = C_{j^0j}$). If C_{jj^0} is translationally invariant, i.e. $C_{jj^0} = F(jj = j^0 jm \text{ od } N)$, Eq. (9) becomes

are the diagonal elements of the diagonalized m atrix in Eq. (10), and hence the eigenvalues of C_{ij0} . Note that because the m atrix is real(symmetric, its eigenvalues appear in pairs, i.e.

Since our covariance m atrix is not fully translationally invariant, $S_q S_{q^0}$ is not diagonal. However, as shown in Fig. 8a, its o diagonal elements are very small. As required by symmetry, the diagonal elements form pairs of identical values. These diagonal elements, plotted versus the index in Fig. 8b, should provide a good approximation to the eigenvalues obtained by PCA. This is corroborated in Fig. 9a, where we compare $h\beta_q fiw$ ith the true eigenvalues of the covariance m atrix C_{jj^0} .

Finally, we note that the end e ects that m ar the translational invariance of the covariance m atrix are absent in the subset of cyclic structures. Any structure whose two ends are neighboring points on the lattice can be m ade cyclic by adding the m issing bond. Any one of the N = 36 bonds on the resulting closed loop can be broken to generate an element of the original set of structures, and the corresponding structure strings are cyclic permutations of each other. Thus, the covariance m atrix C_{cyclic} (j; j⁰) of the set of all cyclic structures is translationally invariant. In our m odel of 6 6 com pact polymers, there are a total of 276 cyclic structures. The Fourier transform of their covariance m atrix is diagonal as expected, with diagonal elements depicted in Fig. 9b. The corresponding Fourier eigenvalues are quite close to the eigenvalues of the full m atrix obtained in the PCA (Fig. 9b). Thus the end e ects do not signi cantly m odify the correlations, and this is specially true for the sm allest eigenvalues which m ake the largest contributions to the density in Eq. 7.

V.A MARKOVIAN ENSEMBLE OF PSEUDO {STRUCTURES

The geom etry of the lattice, and the requirem ent of com pactness constrain the allowed structure strings of zeros and ones in a non-trivial fashion. In our estimation of designabilities so far, we have focused on the covariance matrix which carries information only about two point correlations along these strings. In principle, higher point correlations may also be important, and we may ask to what extent the covariance matrix contains the information about the structures' designabilities? As a preliminary test, we perform ed a comparative study with an articial set of strings, not corresponding to real structures, but constructed to have a covariance matrix similar to true structures on the 6 lattice.

Speci cally, we generated a set of random strings ftg, of zeros and ones of length 36, using a third order M arkov process as follows. For each string, the rst element t_1 is generated with probability P ($t_1 = 1$) = $hs_1 i$, where $hs_1 i$ is the fraction of the true structure strings with $s_1 = 1$. The second element t_2 is generated according to a transition probability P ($t_1 ! t_2$) which is taken to be the \conditional probability "P ($s_2 js_1$) extracted from the true structure strings. The third point t_3 is generated according to a transition probability P ($t_1 t_2 ! t_3$) which is the \conditional probability "P ($s_3 js_1 s_2$) extracted from the true structure strings. All the remaining points t_j , j = 4;5;; 36, are generated according to the true \conditional probabilities" P ($s_j js_{j-3} s_{j-2} s_{j-1}$) of actual structures. Sequences that do not satisfy the global constrains of Eqs. (2) and (3) are thrown out. For every M arkov string generated, we also put its reverse in the pool, unless the string is its own reverse.

The above M arkovian ensemble has a covariance m atrix, and corresponding eigenvalues, very similar to those of the true structures, as shown in Fig. 10. We then calculated the designabilities of these \pseudo-structures" using Eq. (1) by uniform by sampling 5 10^7 random binary sequences. The histogram of the designabilities (Fig. 11) is qualitatively similar to that of the true structures (Fig. 2). Next we constructed the designability estim ator M (Eq. (7)) for the pseudo-structures, using the eigenvalues and eigenvectors of their covariance m atrix. The quantity M is plotted versus designability in Fig. 12 for all the artical pseudo-structures with non-zero designability. The pseudo-structures with the top one percent value of M include 60% of the highly designable psuedo-structures.

These results suggest that a considerable amount of inform ation about the designability is indeed contained in the two point correlations of the string. The designability estimator, Eq. (7) in fact does a somewhat better job in the case of pseudo-structures generated according to short-range M arkov rules.

VI.CONCLUSIONS

One of the most intriguing properties of compact structures, which emerged from early extensive enum eration studies,¹⁰ is that designabilities range over quite a broad distribution of values. Such a large variation in designability is a consequence of a non-uniform distribution of structure vectors, with highly designable structures typically found in regions of low density.¹² However, our study of 6 6 lattice structures using PCA indicates that the non-uniform density actually has a rather simple form that can be well approximated by a single multi-variable Gaussian, as in Eq. (7). Since this method of estimating structure

designability is based only on the overall distribution of structures, it can be a useful tool in cases where there is not enough computational power to enumerate the whole structure space and calculate the designability. To obtain an accurate enough covariance matrix requires only a uniform sampling of the structure space.

W e can also attem pt to use the num erical results as a stepping stone to a m ore analytical approach for calculating the density of structures. First, we note that the covariance m atrix for all structures is rather sim ilar to that of the subset of cyclic structures, and that for the latter PCA is equivalent to Fourier decomposition. Second, we observe that the multivariable Gaussian approximation to structure density in Eq. (7) is most sensitive to the eigenvalues that are close to zero. In terms of Fourier components, these are eigenvalues corresponding to values of q close to , and related to the constraint of Eq. (3). There is also a zero eigenvalue for q = 0, related to condition (2). However, the latter global constraint appears not to have any local counterpart, as there is a discontinuity in the eigenvalues close to zero. Third, the continuity of the eigenvalues as q ! , along with the symmetry of Eq. (12), suggests as expansion of the form $_{q} = K (q)^{2} + O ((q)^{2})^{2}$)⁴). Indeed the num erical results indicate that the important (sm aller) eigenvalues can well be approxim ated)², w ith K 0:04.24 by K (q

W ith this approximation, the designability estimate of Eq. (7) becomes

The rst form in the above equation expresses the estimate in terms of the Fourier modes of the structure string, while the second term is directly in terms of the elements fs_ig . The function J_N (ji j) is the discrete Fourier transform of $1=q^2$, which for large N behaves as ji jj. Equation (13) is thus equivalent to the Boltzm ann weight of a set of unit charges on a discrete line of N pointsmarked by parity. The charges on the sublattice of the same parity attract each other with a potential J_N (r), while those on dimensions in which the charges a larger weight (and hence designability) to con gurations in which the charges alternate between the core and surface sites, as observed empirically.^{12,15,22}

In would be revealing to see how much of the above results, developed on the basis of a lattice hydrophobic model, can be applied to real protein structures. One could use the exposure level of residues to the solvent in building up the structure vectors. Current methods deal with structure strings of a xed length, equal to the dimension of the structure space. Since real proteins have dierent lengths, there is a need for a scaling method to handle them all together. Our study shows that the two point correlations of structure vectors are approximately translationally invariant, and can be captured by Fourier analysis. This suggests the possibility of casting the density of points in structure space in universal functional forms dependent only of a few parameters encoding the properties of the underlying polymers. If so, it would be possible to provide good estimates for designability with polymers of varying length, without the need for extensive numerical computations.

Requiring zero eigenvalues for eigenvectors (1;1;1;1;:::) and (1;1; 1;1;:::) gives the constraints 36x + z = 0, and 36y + z = 0, i.e. x = y = z=36. The value of z is then set by $C_{ii} = hs_i i(1 hs_i i) = 20=81$, where $hs_i i = 16=36$. So we have x = y = 10=1377 and z = 360=1377. It is then easy to see that the 34 nonzero eigenvalues are 360=1377.
- ²⁴ If not forced to go through zero for q = -, a somewhat better t can be obtained with $_q = 0.03 + 0.04 (q)^2 + 0 ((q)^4)$. Fourier transforming back to real space, the additional constant leads to screened C oulomb interactions for J_N (s).




FIG.1. Yahyanejad, et al.




FIG.2. Yahyanejad, et al.




FIG.3. Yahyanejad, et al.




FIG.4. Yahyanejad, et al.




FIG.5. Yahyanejad, et al.




FIG.6.Yahyanejad, et al.




FIG.7. Yahyanejad, et al.




FIG.8. Yahyanejad, et al.




FIG.9.Yahyanejad, et al.




FIG.10. Yahyanejad, et al.




FIG.11. Yahyanejad, et al.




FIG.12. Yahyanejad, et al.
