# Phase Synchronization in Temperature and Precipitation Records

#### A bstract

We study phase synchronization between atm ospheric variables such as daily mean tem perature and daily precipitation records.We nd signi cant phase synchronization between records of 0 x ford and V ienna as well as between the records of precipitation and tem perature in each city. To nd the time delay in the synchronization between the records we study the time lag phase synchronization when the records are shifted by a variable time interval of days.We also compare the results of the method with the classical cross-correlation method and nd that in certain cases the phase synchronization yields more signi cant results.

### 1 Introduction

In recent years there was much interest in long term persistence of tem perature records [1] detected by D etrended F luctuation A nalysis [2]. F luctuations in space and time of m eteorologic records are usually characterized by Teleconnection Patterns [3]. They describe recurring and persistent patterns of circulation anomalies that take place in huge geographical domains. P rom inent patterns are the N orth A tlantic O scillation (NAO) that appears all over

the year, or the East Atlantic Pattern (EA), which appears from Septem – ber to April. Each site in the Teleconnection Patterns is characterized by the strength of the cross-correlation of this site with all other sites in the pattern, for a given meteorologic parameter. By this, a correlation matrix is de ned, which usually exhibits two to four regions of extrem e high or low values, which are called "centers of action". A more recent measure is the Rotated Principal Component Analysis (RCPA), which uses eigenvectors of the correlation (or cross-covariance) matrix after certain scaling and rotation to identify the meteorologic patterns.

The methods to identify teleconnection patterns are based on cross-correlation which essentially compares the amplitude records. Here we suggest an alternative method for studying relations between meteorological records, which is based on the phase synchronization approach [4]. We show that this method can be applied also to complex signals where the uctuations are not pure oscillations. For certain meteorological records, we indicate the phase synchronization approach setter than the conventional cross-correlation approach. The method also enables to quantify the typical wavelengths of a signal, which cannot be detected by cross-correlation.

The paper is organized as follows: We describe the phase synchronization m ethod in Section 2, present the results in Section 3 and discuss and sum m arize them in Section 4.

# 2 Phase Synchronization M ethod

The Phase Synchronization M ethod was originally applied to weakly coupled chaotic oscillators. The m ethod enables to reveal relations between two com – plex records by focusing on the phases of the uctuations in each record. The technique was found very useful for identifying phase synchronization in several biological systems, including the synchronization between the breathing cycle and the heart rhythm [5], which reveals the weak interaction between the hum an respiratory and the cardiovascular system. A nalysis of synchronization oscillations occur [6]. For m ore applications and a pedagogical review of the m ethod we refer to [7].

G enerally, two periodic oscillators are in resonance, if their frequencies  $!_1$  and  $!_2$  are related by

where  $n_{i}m$  are integers. We de ne a phase  $j(t) = !_{j}t$  for each oscillator, and

the generalized phase-di erence is  $'_{n,m} = n_1$  (t)  $m_2$  (t). Hence we have resonance for the condition

where represents the phase shift between both oscillators, and the constant on the rh.s. is any positive nite number. This condition holds also when the frequencies are uctuating. In this case,  $_{j}(t)$  is calculated for each single record by using a Hilbert transform (see below). In order to test for phase synchronization, we determ ine [8]

If the histogram of  $n_{m}$  shows a maximum at a certain phase-di erence, the two records are synchronized at this phase.

In practice, the phase synchronization analysis of two records of length N consists of ve steps:

In the rst step, we construct from the scalar signals  $_{j}(t)$ , j = 1;2, the complex signals  $_{j}(t) = _{j}(t) + i_{H_{j}}(t) = A_{j}(t)e^{i_{j}(t)}$ , where  $_{H_{j}}(t)$  is the Hilbert transform of  $_{j}(t)$  [9].

Then we extract the phases  $_1$  (t) and  $_2$  (t).

Next we cum ulate the phases such that every cycle, the phases  $\ _{\rm j}$  (t) increase by 2  $\ .$ 

Then we quantify the di erence of the phases  $'_{n,m}$  (t) =  $n_1$  (t)  $m_2$  (t).

Finally, we create a histogram of  $n_{m} = '_{n_{m}} \mod 2$  for various m and n values. To do this, we subdivide the possible range of the phases  $n_{m}$  into M intervals (bins) of size 2 = M and determ ine how often the phase  $n_{m}$  occurs in each interval.

In the absence of phase synchronization, the histogram of  $_{n,m}$  is expected to be uniform, because all phase-di erences occur with the same probability. In the presence of phase synchronization, there exists, for a certain pair (m;n) a peak in the histogram.

To quantify the signi cance of synchronization we use an index [8] based on the Shannon entropy S :

$$n_{m} = \frac{S_{max} S}{S_{max}} ; \qquad (4)$$

where  $S = \prod_{k=1}^{P} p_k \ln p_k$  and  $p_k$  is the probability of nding  $n_m$  in the k-th bin of the histogram. By de nition, the maximum entropy is  $S_{max} = \ln M$ . The synchronization index is restricted to the unit interval 0  $n_m$  1 and is minimal for a uniform distribution and maximal in the case of a -function.

By introducing a time lag into the phase synchronization method, realized by a certain shifting interval S between the two records, it may occur, that for some cases best phase synchronization is found only for a certain time lag. In this case, the synchronization is delayed by this interval, which can be determined by the position of the peak in the synchronization index.

## 3 Results




Fig.1.A typical example of daily m ean tem perature record for 100 days, starting in 1873 at (a) 0 x ford and (b) V ienna, after subtraction of the annual cycles, average over all years of the record.

W e begin the demonstration of the method on the temperature and precipitation records of  $0 \times 10^{\circ} (GBR)$  and V ienna (AUT). The stations are distant enough in order not to give trivial results, but of su cient closeness for their clim ate to interact. In order to analyze only the uctuations, we deseasoned the records by subtracting the annual cycles. W e mostly discuss the temperature time series. The values for the rst hundred days of the year 1873 for both cities are shown in Fig. 1. A lthough som e sim ilarities can be guessed, the question how to quantify these sim ilarities is of interest. O ne method is the cross-correlation approach. Here we propose that com plem entary inform ation can be revealed by the phase synchronization method.




Fig.2. The steps from the signal to the cum ulated phases. (a) Part of the deseasoned tem perature record m easured at 0 x ford. (b) The phases extracted by the H ilbert transform. (c) The cum ulated phases. The arrows represent the edges of the cycles.




Fig. 3. (a) Cum ulated phases for the deseasoned tem perature record of Oxford (solid line) and V ienna (dashed line) for the years from 1873 to 1992. (b) Phase-di erence. (c) H istogram of phase-di erence m od 2 (100 bins).

Figs.2 and 3 dem onstrate the steps of the m ethod. In Fig.2(a) a sm all section of the tem perature record m easured at 0 x ford is given. The corresponding phases (Fig.2(b)) were determ ined using H ilbert transform. Fig.2(c) shows what the cum ulated phases look like, where after every cycle 2 is added. In Fig. 3(a) the cum ulated phases for both com plete records are shown, while in Fig.3(b) the phase-di erences are displayed. The histogram of the phase-di erences m odub 2 , is given in Fig.3(c). A clear peak can be seen in the histogram and the synchronization index is = 0.0242. This value can not be improved by taking n m other than 1:1.




Fig. 4. (a) D ependence of the synchronization index on the shifting interval S between the records of O x ford and V ienna. N egative shifting m eans that the series of V ienna is in advance. The corresponding non-overlapping values were cut from the records. H istogram s for the led dots are shown in (b) with a shift of -1, (c) with shift of + 20. N ote that in Fig. 3 (c) the records are not shifted.

To get inform ation about the signi cance of this result we perform time lag phase synchronization, i.e. a shifting-test, where the series are shifted against each other by a given interval of S days. The non-overlapping values in both sequences are ignored for the process. Obviously in the case of no synchronization the value of must be lower than in synchronization. In Fig. 4 (a) the result of shifting is shown. For shifting of several days in both directions the synchronization decreases dram atically. A histogram for a shift of + 20 days, where = 0.0011, is given in Fig. 4 (c). This shifting-test reveals, that the non-shifted case does not correspond to the best synchronization. A higher synchronization index (= 0.0315) can be achieved with a shift of -1 day. Fig. 4 (b) shows this histogram. The peak is slightly sharper and higher than in Fig. 3 (c). This result is reasonable since a cycle of uctuation which is detected in 0 xford reaches V ienna (due to high latitude western winds) about one day later.




Fig. 5. The synchronization index as a function of the shifting interval S for di erent pairs of daily records. (a) P recipitation at O xford and V ienna (1873–1989), whereas for negative shifting values we cut the beginning of V ienna's and the end of O xford's record. Synchronization between tem perature and precipitation m easured at (b) O xford (1873–1992) and (c) V ienna (1873–1989).




Fig.6.H istogram of wavelengths for (a) tem perature and (b) precipitation records at 0 x ford, determ ined by counting the number of days for which the phases com plete a cycle.

The results are less pronounced for the two precipitation time records. The shifting-test is displayed in gure 5 (a). Here the importance of the shifting-test becomes clear. Even when shifted, -values of the order of 0:004 are achieved, but the peak is still signi cantly higher. This high background is probably due to the large uctuations of the precipitation records. They show a spiky structure, that leads the Hilbert transform to give many slips and phases of short duration. Indeed, apart from the long cycles, these records consist of m any of 3 to 4-day-periods (shown in Fig. 6 (b)). When a pair of precipitation records is shifted, the phases still show matching because of the multitude of very short periods, yielding noise-induced synchronization in the background. N evertheless a dom inant peak is obtained in this representation, the maxim um synchronization with = 0.0072 is reached when the series are shifted by -2 days. Note that this value is a factor 4 sm aller than that for tem perature. Synchronization is also found between temperature and precipitation records at the same site. In 0 x ford the tem perature and precipitation records are very weakly synchronized (Fig. 5(b)), with a small peak of = 0.0009. At V ienna (Fig. 5 (c)) the peak is at least six tim es larger. In both cases the peaks are located at a time lag of +1 day, i.e., they are better synchronized when the tem perature record is one day in advance to the precipitation record. In com parison to synchronization of the two precipitation time series, they have much less noise-induced synchronization in the background.

The fact that best synchronization for temperature records of 0 x ford and V ienna is found when they are shifted by one day, exhibits the statistical delay between cycles of weather at both sites. This conclusion is supported by the result for precipitation series, where the maximum occurs for shifting of two days. P robably the real delay is approximately 1.5 days, which, due to low sample-rate, can not be determined more precisely.

U sually Fourier Transform is applied in order to discover dom inant global frequencies or wavelengths in a considered time series. But no direct inform ation can be gained about cycles of varying wavelength, since Fourier Transform detects global waves in the record. We suggest to use the cumulated phases to estimate the wavelengths in the time series. Namely, we count the days, until the phases pass steps of 2, and generate a histogram with frequency of occurrence versus wavelength.

For the tem perature and precipitation records of 0 x ford these histogram s are shown in Fig. 6. In the case of tem perature (Fig. 6(a)) the uctuations have a wide range from 2 to about 90 days, but most of them take ve to ten days. The precipitation record (Fig. 6(b)) consists of much more uctuations of short wavelength. The length of three days occurs 274 times, while only 84 times in the tem perature record. A loo the maximum wavelength of the precipitation record is only about 50 days. Note that the considered cycles are not periodic, but have random wavelengths. C om paring phase synchronization with the classical cross-correlation m ethod is of interest. W hile in phase synchronization the phases of the cycles play the major role and not the amplitudes, in cross-correlation both aspects are superim posed. Thus we expect to obtain complem entary information from the two approaches. In the following two examples more signi cant results were obtained from phase synchronization compared to cross-correlation.




Fig. 7. An example for comparison between (a) phase synchronization and (b) cross-correlation. The methods were applied to the precipitation records of Wulumuqi (CHN) and Pusan (KOR) (daily 1951-1990). Negative shifting means that the dates of Pusan correspond to earlier dates of Wulumuqi.




Fig. 8.C on parison of (a) phase synchronization and (b) cross-correlation. A gain we analyzed the daily mean temperature records of  $0 \times ford$  and V ienna (1872–1992), but here we subtracted the global average from the record instead of the annual cycle before perform ing the methods. For positive S the record of  $0 \times ford$  is in advance. Note that (a) corresponds to Fig. 4 (a).

In Fig. 7 we compare time lag phase synchronization and time lag crosscorrelation for precipitation in two sites in Asia. The phase synchronization index exhibits a distinct peak with a maximum at 3 days, while the crosscorrelation only gives large background noise with a peak that is almost indistinguishable from the background. Fig. 8 also demonstrates an advantage of phase synchronization. It com pares phase synchronization and crosscorrelation for records without annual deseasoning. Here only the average value of each record was subtracted. It is seen, that while in the phase synchronization almost a constant background with 0:19 is obtained, the cross-correlation shows large annual oscillations, as expected. Thus, the peak in phase synchronization (= 0.25) compared to the background (Fig. 8(a)) is much more signi cant than that in cross-correlation analysis (Fig. 8 (b)). The high value of the constant background in the time lag phase synchronization is due to the annual synchronization, which is almost not in uenced by variation of the time lag. The peak in the time lag phase synchronization (Fig. 8 (a)) is thus mainly due to phase synchronization of the uctuations which represents irregular cycles of deviation from the mean annual cycle.

Synchronization in the atm osphere plays an important role in clim atology. For example tests on an atm ospheric global circulation model have been done, where the complete synchronization of the two hem ispheres has been analyzed [10].W hat does phase synchronization in clim ate records mean? For temperature records, e.g. a complete relatively warm period followed by a cold period represents a cycle in terms of phases. At another site, which is synchronized to the rst, statistically a similar cycle also occurs, maybe with some delay. The amplitudes of these cycles have no in uence on the phase synchronization. This is in contrast to cross-correlation, which is strongly a ected by the amplitudes. Thus, phase synchronization might be useful when interaction in records of di erent clim ate regions is analyzed, such as maritim e, where tem – perature uctuations are less pronounced, and continental regions with larger uctuations.
