Sym bolic Stochastic D ynam ical System s V iewed as B inary N - Step M arkov C hains

A theory of system s with long-range correlations based on the consideration of binary N-step M arkov chains is developed. In the model, the conditional probability that the i-th symbol in the chain equals zero (or unity) is a linear function of the number of unities among the preceding N symbols. The correlation and distribution functions as well as the variance of number of symbols in the words of arbitrary length L are obtained analytically and numerically. A self-sim ilarity of the studied stochastic process is revealed and the sim ilarity group transform ation of the chain parameters is presented. The di usion Fokker-Planck equation governing the distribution function of the L-words is explored. If the persistent correlations are not extrem ely strong, the distribution function is shown to be the G aussian with the variance being nonlinearly dependent on L. The applicability of the developed theory to the coarse-grained written and DNA texts is discussed.

I. IN TRODUCTION

The problem of system swith long-range spatial and/or tem poral correlations (LRCS) is one of the topics of intensive research in modern physics, as well as in the theory of dynam ical systems and the theory of probability. The LRC-system s are usually characterized by a complex structure and contain a number of hierarchic objects as their subsystems. The LRC-systems are the subject of study in physics, biology, economics, linguistics, sociology, geography, psychology, etc. [1, 2, 3, 4]. At the present time, there is no generally accepted theoretical model that adequately describes the dynamical and statistical properties of the LRC -system s. Attempts to describe the behavior of the LRCS in the fram ework of the T salis non-extensive therm odynam ics [5, 6] were undertaken in R ef. [7]. How ever, the non-extensive therm odynam ics is not well-grounded and requires the construction of the additionalm odels which could clarify the properties of the LRC-system s.

One of the e cient methods to investigate the correlated systems is based on a decomposition of the space of states into a nite number of parts labelled by de nite symbols. This procedure referred to as coarse graining is accompanied by the loss of short-rangement ory between states of system but does not a ect and does not damage its robust invariant statistical properties on large scales. The most frequently used method of the decomposition is based on the introduction of two parts of the phase space. In other words, it consists in mapping the two parts of states onto two symbols, say 0 and 1. Thus, the problem is reduced to investigating the statistical properties of the symbolic binary sequences. This method is applicable for the exam ination of both discrete and continuous system s.

O ne of the ways to get a correct insight into the nature of correlations consists in an ability of constructing a m athem atical object (for example, a correlated sequence of sym bols) possessing the same statistical properties as the initial system. There are m any algorithm s to generate long-range correlated sequences: the inverse Fourier transform [8], the expansion-m odi cation Limethod \mathfrak{P}], the Voss procedure of consequent random addition [10], the correlated Levy walks [11], etc. [8]. We believe that, am ong the above-m entioned m ethods, using the M arkov chains is one of the m ost in portant. We would like to dem onstrate this statem ent in the present paper.

In the following sections, the statistical properties of the binary many-steps Markov chain is examined. In spite of the long-time history of studying the Markov sequences (see, for example, [4, 12, 13] and references therein), the concrete expressions for the variance of sum s of random variables in such strings have not yet been obtained. Our model operates with two parameters goveming the conditional probability of the discrete M arkov process, speci cally with the memory length N and the correlation parameter . The correlation and distribution functions as well as the variance D being nonlinearly dependent on the length L of a word are derived analytically and calculated num erically. The nonlinearity of the D (L) function re ects the existence of strong correlations in the system . The evolved theory is applied to the coarse-grained written texts and dictionaries, and to DNA strings as well.

Som e prelim inary results of this study were published in Ref. [14].

II. FORM ULATION OF THE PROBLEM

A. M arkov P rocesses

Let us consider a hom ogeneous binary sequence of symbols, $a_i = f0;1g$. To determ ine the N-step M arkov chain we have to introduce the conditional probability P ($a_i j a_i N; a_i N+1; :::; a_i 1$) of occurring the definite symbol a_i (for example, $a_i = 0$) after symbols $a_i N; a_i N+1; :::; a_i 1$. Thus, it is necessary to de ne 2^N values of the P-function corresponding to each possible con guration of the symbols $a_N; a_i N+1; :::; a_i 1$. We suppose that the P-function has the form,

Such a relation corresponds to the additive in uence of the previous symbols on the generated one. The hom ogeneity of the M arkov chain is provided by the independence of the conditional probability Eq. (1) of the index i.

It is reasonable to assume the function f to be decreasing with an increase of the distance k between the symbols $a_{i \ k}$ and a_{i} in the M arkov chain. However, for the sake of sim plicity we consider here a step-like m en ory function f $(a_{i \ k};k)$ independent of the second argument k. As a result, the m odel is characterized by three parameters only, speci cally by f (0), f (1), and N :

Note that the probability P in Eq. (2) depends on the numbers of symbols 0 and 1 in the N -word but is independent of the arrangement of the elements $a_{i \ k}$. We also suppose that

This relation provides the statistical equality of the num – bers of sym bols zero and unity in the M arkov chain under consideration. In other words, the chain is non-biased. Indeed, taking into account Eqs. (2) and (3) and the sequence of equations,

one can see the symmetry with respect to interchange $a_i \$ a_i in the Markov chain. Here a_i is the symbol opposite to $a_i, a_i = 1$ a_i . Therefore, the probabilities of occurring the words $(a_1; \ldots; a_L)$ and $(a_1; \ldots; a_L)$ are equal to each other for any word length L.At L = 1 this yields equal average probabilities that symbols 0 and 1 occur in the chain.

Taking into account the sym m etry of the conditional probability P with respect to a permutation of sym bols a_i (see Eq. (2)), we can simplify the notations and introduce the conditional probability p_k of occurring the symbol zero after the N -word containing k unities, e.g., after the word (11:::1 QQ;:Q),

We focus our attention on the region of determ ined by the persistence inequality 0 < 1=2. In this case, each of the sym bols unity in the preceding N-word prom otes the birth of new sym bol unity. Nevertheless, the m a jor part of our results is valid for the anti-persistent region 1=2 < < 0 as well.

A similar rule for the production of an N-word $(a_1; :::; a_N)$ that follows after a word $(a_0; a_1; :::; a_N)$ was suggested in R ef. [4]. However, the conditional probability p_k of occurring the symbols a_N does not depend on the previous ones in the model [4].

B. Statistical characteristics of the chain

In order to investigate the statistical properties of the M arkov chain, we consider the distribution W $_{\rm L}$ (k) of the words of de nite length L by the number k of unities in them,

If = 0; one arrives at the known result for the noncorrelated Brownian di usion,

W e will show that the distribution function W $_{\rm L}$ (k) for the sequence determ ined by Eq.(5) (with nonzero but not extrem ely close to 1/2 param eter) is the G aussian with the variance D (L) nonlinearly dependent on L. How ever, at ! 1=2 the distribution function can di er from the G aussian.

C. M ain equation

For the stationary M arkov chain, the probability $b(a_1a_2:::a_N)$ of occurring a certain word $(a_1;a_2;:::;a_N)$ satis es the condition of compatibility for the Chapmen-K olm ogorov equation (see, for example, Ref. [15]):

Thus, we have $2^{\mathbb{N}}$ hom ogeneous algebraic equations for the $2^{\mathbb{N}}$ probabilities b of occurring the N-words and the norm alization equation b = 1. In the case under consideration, the set of equations can be substantially sim – pli ed owing to the following statement.

P roposition : The probability $b(a_1a_2:::a_N)$ depends on the number k of unities in the N -word only, i.e., it is independent of the arrangement of symbols in the word $(a_1;a_2;:::;a_N)$.




FIG.1: The probability b of occurring a word $(a_1;a_2;\ldots;a_N)$ vs its number z expressed in the binary code, $z = \sum_{i=1}^{N} a_i 2^{i-1}$, for N = 8, z = 0.4.

This statem ent illustrated by Fig. 1 is valid owing to the chosen simple model (2), (5) of the Markov chain.

It can be easily veri ed directly by substituting the obtained below solution (15) into the set (11). Note that according to the M arkov theorem, Eqs. (11) do not have other solutions [16].

P roposition leads to the very important property of isotropy: any word $(a_1;a_2;:::;a_L)$ appears with the same probability as the inverted one, $(a_L;a_{L-1};:::;a_1)$.

Let us apply the set of Eqs.(11) to the word (11;::1] 00;::0):

III. DISTRIBUTION FUNCTION OF L-W ORDS

In this section we investigate the statistical properties of the M arkov chain, speci cally, the distribution of the words of de nite length L by the number k of unities. The length L can also be interpreted as the number of jumps of some particle over an integer-valued 1-D lattice or as the time of the di usion imposed by the M arkov chain under consideration. The form of the distribution function W_L (k) depends, to a large extent, on the relation between the word length L and the mem ory length N. Therefore, the sit thing we will do is to exam ine the sim plest case L = N.

A. Statistics of N -w ords

The value b(k) is the probability that an N -word containsk unities with a de nite order of sym bols a_i . Therefore, the probability W_N (k) that an N -word contains k unities with arbitrary order of sym bols a_i is b(k) m ultiplied by the number $C_N^k = N \models k! (N = k)!$ of di erent permutations of k unities in the N -word,

Combining Eqs. (15) and (18), we nd the distribution function,

C om paring Eqs. (15), (18)-(20), one can get Eq. (17) for the constant A in Eq. (15).

Note that the distribution W $_{\rm N}$ (k) is an even function of the variable ~=~k~ N =2,

This fact is a direct consequence of the above-m entioned statistical equivalence of zeros and unities in the M arkov chain being considered. Let us analyze the distribution function $W_N(k)$ for di erent relations between the param eters N and .

1. Lim iting case of weak persistence, n 1

In the absence of correlations, n ! 1, Eq. (19) and the Stirling formula yield the Gaussian distribution at k; N; N = 1. G iven the persistence is not too strong,

one can also obtain the G aussian form for the distribution function,

Equation (23) says that the N -words with equal numbers of zeros and unities, k = N = 2, are most probable. Note that the persistence results in an increase of the variance D (N) with respect to its value N = 4 at = 0. In other words, the persistence is conductive to the intensi cation of the di usion. Inequality n 1 gives D (N) N². Therefore, despite the increase of D (N), the uctuations of (k N = 2) of the order of N are exponentially sm all.

2. Intermediate case, n > 1

If the parameter n is an integer of the order of unity, the distribution function W $_{\rm N}$ (k) is a polynom ial of degree 2 (n $\,$ 1). In particular, at n = 1, the function W $_{\rm N}$ (k) is constant,

At n f 1; W $_{\rm N}$ (k) has a maximum in the middle of the interval [D;N].

3. Lim iting case of strong persistence

If the parameter n satis es the inequality,

one can neglect the parameter n in the arguments of the functions (n+k), (n+N), and (n+N-k) in Eq.10). In this case, the distribution function $W_N(k)$ assumes its maximal values at k = 0 and k = N,

Formula (27) describes the sharply decreasing W $_{\rm N}$ (k) as k varies from 0 to 1 (and from N to N $\,$ 1). Then, at 1 < k < N =2, the function W $_{\rm N}$ (k) decreases more slow ly with an increase in k,

At k = N =2; the probability W $_{\rm N}\,$ (k) achieves its m in im al value,

It follows from normalization (20) that the values W_N (0) = W_N (N) are approximatively equal to 1=2. Neglecting the term s of the order of n^2 , one gets

In the straightforward calculation using Eqs. (8) and (28) the variance D is

Thus, the variance D (N) is equal to N²=2 in the leading approximation in the parameter n. This fact has a simple explanation. The probability of occurrence the N-word containing N unities is approximatively equal to 1=2. So, the relations $\overline{k^2}$ N²=2 and \overline{k}^2 = N²=4 give (31). The case of strong persistence corresponds to the so-called ballistic regime of di usion: if we chose random ly some symbola_i in the sequence, it will be surrounded by the same symbols with the probability close to unity.




FIG .2: The distribution function W $_{\rm N}$ (k) for N = 20 and different values of the parameter n shown near the curves.

The evolution of the distribution function W $_{\rm N}$ (k) from the Gaussian form to the inverse one with a decrease of the parameter n is shown in Fig.2. In the interval ln 1 N < n < 1 the curve W $_{\rm N}$ (k) is concave and the maximum of function W $_{\rm N}$ (k) inverts into minimum . At N $\,$ 1 and ln 1 N < n < 1, the curve remains a sm ooth function of its argument k as shown by curve with n = 0.5 in Fig.2. Below, we will not consider this relatively narrow region of the change in the parameter n.

Formulas (23), (24), (28), (30) and (31) describe the statistical properties of L-words for the xed "di usion time" L = N. It is necessary to exam ine the distribution function W_L (k) for the general situation, L \Leftrightarrow N. We start the analysis with L < N.

B. Statistics of L-words with L < N

1. Distribution function W $_{\rm L}$ (k)

The distribution function W $_{\rm L}$ (k) at L $\,<\,$ N $\,$ can be given as

The total number of unities in this word is i. The righthand part of the word (L-sub-word) contains k unities. The straightforward sum mation in Eq. (32) yields the following form ula that is valid at any value of the parameter n:

It is of interest to note that the parameter of persistence and the memory length N are presented in Eqs. (34), (35) via the parameter n only. This means that the statistical properties of the L-words with L < Nare de ned by this single "combined" parameter.

In the limiting case of weak persistence, n 1, at k; L k 1, Eq. (34) along with the Stirling formula give the G aussian distribution function,

In the case of strong persistence (26), the asymptotic expression for the distribution function Eq. (34) can be written as

Both the distribution $W_{\rm L}$ (k) (38) and the function $W_{\rm N}$ (k) (28) has a concave form. The former assumes the maximal value (39) at the edges of the interval [0;L] and has a minimum at k = L = 2.

2. Variance D (L)

Using the de nition Eq. (34) and the distribution function Eq. (34) one can obtain a very simple formula for the variance D (L),

Eq. (40) shows that the variance D(L) obeys the parabolic law independently of the correlation strength in the M arkov chain.

In the case of weak persistence, at n 1, we obtain the asymptotics Eq. (37). It allows one to analyze the behavior of the variance D (L) with an increase in the \di usion time" L. At small m L 1, the dependence D (L) follows the classical law of the Brownian di usion, D (L) L=4. Then, at m L 1, the function D (L) becomes super-linear.

For the case of strong persistence, n 1, Eq. (40) gives the asymptotics,

The ballistic regime of di usion leads to the quadratic law of the D (L) dependence in the zero approximation in the parameter n 1.

The unusual behavior of the variance D (L) raises an issue as to what particular type of the di usion equation corresponds to the nonlinear dependence D (L) in Eq. (37). In the following subsection, when solving this problem, we will obtain the conditional probability $p^{(0)}$ of occurring the symbol zero after a given L-word with L < N. The ability to nd $p^{(0)}$, with some reduced information about the preceding symbols being available, is very in portant for the study of the self-sim ilarity of the M arkov chain (see Subsubsec. 4 of this Subsection).

3. Generalized di usion equation at L < N , n $\,$ 1 $\,$

It is quite obvious that the distribution W $_{\rm L}$ (k) satis % 1 estimation

Here $p^{(0)}(k)$ is the probability of occurring "0" after an average-statistical L-word containing k unities and $p^{(1)}(k = 1)$ is the probability of occurring "1" after an L-word containing (k = 1) unities. At L < N, the probability $p^{(0)}(k)$ can be written as

The product $b(i)C_{L}^{k}C_{N}^{i}C_{L}^{i}$ in this form ula represents the conditional probability of occurring the N-word containing i unities, the right-hand part of which, the L-subword, contains k unities (com pare with Eqs. (32), (33)).

The product $b(i)C_N^{i} L_L$ in Eq. (44) is a sharp function of i with a maximum at some point $i = i_0$ whereas p_i obeys the linear law (5). This implies that p_i can be

factored out of the sum m ation sign being taken at point $i = i_0$. The asymptotical calculation shows that point i_0 is described by the equation,

Expression (5) taken at point i_0 gives the desired form ula for $p^{\left(0\right)}$ because

is obviously equal to W $_{\rm L}$ (k). Thus, we have

Let us consider a very important point relating to Eq. (45). If the concentration of unities in the righthand part of the word (33) is higher than 1=2, k=L > 1=2, then the most probable concentration $(i_0 \quad k)=(N \quad L)$ of unities in the left-hand part of this word is likewise increased, $(i_0 \quad k)=(N \quad L) > 1=2$. At the same time, the concentration $(i_0 \quad k)=(N \quad L)$ is less than k=L,

This implies that the increased concentration of unities in the L-words is necessarily accompanied by the existence of a certain tail with an increased concentration of unities as well. Such a phenom enon is referred by us as the macro-persistence. An analysis perform ed in the following section will indicate that the correlation length l_c of this tail is N with 1 dependent on the parameter

only. It is evident from the above-m entioned property of the isotropy of the M arkov chain that there are two correlation tails from both sides of the L-word.

N ote that the distribution W $_{\rm L}$ (k) is a sm ooth function of arguments k and L near its maximum in the case of weak persistence and k;L k 1. By going over to the continuous limit in Eq. (43) and using Eq. (47) with the relation p⁽¹⁾ (k 1) = 1 p⁽⁰⁾ (k 1), we obtain the diffusion Fokker-P lanck equation for the correlated M arkov process,

4. Self-sim ilarity of the persistent B rownian di usion

In this subsection, we point to one of the most interesting properties of the M arkov chain being considered, namely, its self-sim ilarity. Let us reduce the N -step M arkov sequence by regularly (or random ly) removing some symbols and introduce the decimation parameter

The comparison between Eqs. (5) and (53) shows that the reduced chain possesses the same statistical properties as the initial one but it is characterized by the renorm alized parameters (\mathbb{N} ,) instead of (\mathbb{N} ,). Thus, Eqs. (52) and (54) determ ine the one-parametrical renorm alization of the parameters of the stochastic process de ned by Eq. (5).

The astonishing property of the reduced sequence consists in that the variance D (L) is invariant with respect to the one-parametric decimation transformation (52), (54). In other words, it coincides with the function D (L) for the initial M arkov chain:

Indeed, according to Eqs. The transform ation (N,) ! (N,) (52), (54) possesses the properties of sem i-group, i.e., the composition of transform ations (N,) ! (N,) and (N,) ! (N,) and (N,) ! (N,) with transform ation parameters $_1$ and $_2$ is likewise the transform ation from the same sem i-group, (N,) ! (N,), with parameter $= _1 _2$.




FIG.3: The dependence of the variance D on the tuple length L for the generated sequence with N = 100 and = 0.4 (solid line) and for the decim ated sequences (the parameter of decim ation = 0.5). Squares and circles correspond to the stochastic and determ inistic reduction, respectively. The thin solid line describes the non-correlated B rownian di usion, D (L) = L=4.

The invariance of the function D (L) at L < N was referred to by us as the phenom enon of self-sim ilarity. It is demonstrated in Fig. 3 and is accordingly discussed below, in Sec. IV A.

It is interesting to note that the property of selfsimilarity is valid for any strength of the persistency. Indeed, the result Eq. (47) can be obtained directly from Eqs. (15)-(17), and (44) not only for n 1 but also for the arbitrary value of n.

C. Long-range di usion, L > N

Unfortunately, the very useful proposition is valid for the words of the length L $\,$ N only and is not applicable to the analysis of the long words with L > N . Therefore, investigating the statistical properties of the long words represents a rather challenging combinatorial problem and requires new physical approaches for its sim – plication. Thus, we start this subsection by analyzing the correlation properties of the long words (L > N) in the M arkov chains with N 1. The two rst subsubsections of this subsection mainly deal with the case of relatively weak correlations, n 1.

1. Correlation length at weak persistence

Let us rew rite Eq. (5) in the form,

The angle brackets denote the averaging of the density of unities in some region of the M arkov chain for its de nite realization. The averaging is perform ed over distances much greater than unity but far less than the memory length N and correlation length l_c (see Eq. (60) below). Note that this averaging di ers from the statistical averaging over the ensemble of realizations of the M arkov chain denoted by the bar in Eqs. (8) and (9). Equation (56) is a relationship between the average densities of unities in two di erent m acroscopic regions of the M arkov chain, namely, in the vicinity of (i + 1)-th element and in the region (i N; i). Such an approach is similar to the mean eld approximation in the theory of the phase transitions and is asymptotically exact at N ! 1. In the continuous limit, Eq. (56) can be rewritten in the integral form,

Law (58) describes the phenom enon of the persistent m acroscopic correlations discussed in the previous subsection. This phenom enon is governed by both parameters, N and . According to Eqs. (59), (60), the correlation length l_c grows as = 1=4 with an increase in (at ! 1=2) until the inequality 1=N is satisfied. Here

Let us note that the inequality 1=N dening the regime of weak persistence can be rewritten in terms of , N=4. At 1=N, the correlation length l_c achieves its maximum value $N^2=4$. With the following increase of , the di usion goes to the regime of strongly correlated di usion that will be discussed in Subsubsec 3 of this Subsection.

At ! 0, the macro-persistence is broken and the correlation length tends to zero.

2. Correlation function at weak persistence

U sing the studied correlation properties of the M arkov sequence and som e heuristic reasons, one can obtain the correlation function K (r) being de ned as,

The independence of the correlation function of r at r < N results from our choice of the conditional probability in the simplest form (5). At r > N, the function K (r) should decrease because of the boss of m en ory. Therefore, using Eqs. 


FIG.4: The dependence of the correlation function K on the distance r between the sym bols for the sequence with N = 20. The dots correspond to the generated sequence with = 0:1 and = 50=101. The lower line is analytical result (67) with $l_c = N$ and = 0:38.




FIG.5: The num erical simulation of the dependence D (L) for the generated sequence with N = 100 and = 0.4 (circles). The solid line is the plot of function Eq. (68) with the same values of N and .

A s an illustration of the result Eq. (68), we present the plot of D (L) for N = 100 and = 0.4 by the solid line in Fig. 5. The straight line in the gure corresponds to the dependence D (L) = L=4 for the usual B rownian di usion without correlations (for = 0). It is clearly seen that the plot of variance (68) contains two qualitatively di erent portions. One of them, at L < N, is the super-linear curve that m oves away from the line D = L=4 with an increase of L as a result of the persistence. For L N, the curve D (L) achieves the linear asymptotics,

This phenom enon can be interpreted as a result of the di usion in which every independent step D (L) of wandering represents a path traversed by a particle during the characteristic \ uctuating time" L (N + 1). Since these steps of wandering are quasi-independent, the distribution function W L (k) is the G aussian. Thus, in the case of relatively weak persistence, n 1, W L (k) is the G aussian not only at L < N (see Eq. (36)) but also for L > N; l_c.

Note that the above-mentioned property of the selfsimilarity is valid only at the portion L < N of the curve D (L). Since the decimation procedure leads to the decrease of the parameter (see Eq. (54)), the plot of asymptotics (70) for the reduced sequence at L N goes below the D (L) plot for the initial chain.

3. Statistics of the L-words for the case of strong persistence, n $$\ln^{-1}N$$

In this subsection, we study the statistical properties of long words (L > N) in the sequences of sym bols with strong correlations. It is convenient to rewrite form ula (5) for the conditional probability of occurring the sym – bol zero after the N -word containing k unities in the form ,

In the case of strong persistence, n $\ln^{-1} N$, the parameter = 1=2 is much smaller than 1=N. Therefore, the probability p can be written as

It is seen that the probability of occurring the symbol zero after the N -w ord which contains only unities (= 0) represents very smallvalue and it increases signi cantly if \notin 0. This situation di ers drastically from the case of weak persistency. At n 1, the parameter exceeds noticeably the value 1=N, and the probability p does not actually change with an increase in the number of zeros in the preceding N -w ord.

The analysis of the sym bol generation process in the M arkov chain in the case of strong persistence gives the following picture of the uctuations. There exist the entire portions of the chain consisting of the same sym bols, say unities. The characteristic length of such portions is 1 = N. These portions are separated by one or more sym bols zero. The number of such packets of the same sym bols in one uctuation zone is about N. Thus, the characteristic correlation distance at which the N-word containing the same sym bols converts into the N-word with = N=2 is about N = ,




FIG.6: The distribution function w (k=L) = LW $_{\rm L}$ (k) for N = 8 and = 1=150. D i erent values of the length L of words is shown near the curves.

The described structure of the uctuations de nes the statical properties of the L-words with L > N in the case of strong persistence. The distribution function differs signi cantly from the Gaussian and is characterized by a concave form at L \leq l_c N = . As L increases, the correlations between di erent parts of the L-words get weaker and the L-word can be considered as consisting of a num ber of independent sub-words. So, according to the general m athem atical theorem s [12, 17], the distribution function takes on the usual Gaussian form . Such an evolution of the distribution function is depicted in Fig. 6.




FIG.7: The dependence of the variance D on the word length L for the sequence with N = 20 and = 50=101 (solid line). The thin solid line describes the non-correlated B rownian diffusion, D (L) = L=4:

The variance D (L) follows the quadratic law $D = L^2=4$ (see Eq. (42)) up to the range of $L < l_c N =$ and then approaches to the asymptotics D (L) = B L with B N=4 (see Fig.7).

The upper curve in Fig. 4 presents the correlation function for the case of strong persistence (= 50=101, N = 20).

IV. RESULTS OF NUMERICAL SIMULATIONS AND APPLICATIONS

In this section, we support the obtained analytical results by num erical simulations of the M arkov chain with the conditional probability Eq. (5). B esides, the properties of the studied binary N -step M arkov chain are com pared with those for the natural objects, speci cally for the coarse-grained written and DNA texts.

A. Num erical simulations of the Markov chain

The rst stage of the construction of the N-step M arkov chain was a generation of the initial non-correlated N symbols, zeros and unities, identically distributed

with equal probabilities 1/2. Each consequent symbol was then added to the chain with the conditional probability determined by the previous N symbols in accordance with Eq. (5). Then we numerically calculated the variance D (L) by means of Eq. (8). The circles in Fig. 5 represent the calculated variance D (L) for the case of weak persistence (n = 12:5 1). A very good agreement between the analytical result (68) and the numerical sim – ulation can be observed. The case of strong persistence is illustrated by Figs. 6 and 7 where the distribution function W_L (k) and the variance D (L) are calculated numerically for n = 4=37 and n = 0:1, respectively. The dots on the curves in Fig. 4 represent the calculated results for the correlation function K (r) for n = 0:1 (the upper curve) and n = 40 (the lower curve).

The num erical simulation was also used for the demonstration of the proposition (Fig. 1) and the selfsimilarity property of the M arkov sequence (Fig. 3). The squares in Fig. 3 represent the variance D (L) for the sequence obtained by the stochastic decimation of the initial M arkov chain (solid line) where each symbol was om itted with the probability 1/2. The circles in this gure correspond to the regular reduction of the sequence by rem oving each second symbol.

And nally, the num erical simulations have allowed us to make sure that we are able to determ ine the param eters N and of a given binary sequence. We generated the M arkov sequences with di erent param eters N and and de ned num erically the corresponding curves D (L). Then we solved the inverse problem of the reconstruction of the param eters N and by analyzing the curves D (L). The reconstructed param eters were always in good agreem ent with their prescribed values. In the following subsections we apply this ability to the treatm ent of the statistical properties of literary and DNA texts.

B. Literary texts





FIG. 8: The dependence D (L) for the coarse-grained text of B ble obtained by m eans of ve di erent kinds of random m apping.

It is well-known that the statistical properties of the coarse-grained texts written in any language exhibit a remarkable deviation from random sequences [4, 18]. In order to check the applicability of the theory of the binary N -step M arkov chains to literary texts we resorted to the procedure of coarse graining by the random mapping of all characters of the text onto the binary set of sym bols, zeros and unities. The statistical properties of the coarsegrained texts depend, but not signi cantly, on the kind of mapping. This is illustrated by the curves in Fig. 8 where the variance D (L) for ve di erent kinds of the mapping of Bible is presented. In general, the random m apping leads to nonequal num bers of unities and zeros, k_1 and k_0 , in the coarse-grained sequence. A particular analysis indicates that the variance D (L) (37) gets the additionalmultiplier,

in this biased case. In order to derive the function D (L) for the non-biased sequence, we divided the num erically calculated value of the variance by this multiplier.




FIG. 10: The dependence of the variance D on the tuple length L for the coarse-grained text of Bible (solid line) and for the decimated sequences with di erent parameters : = 3=4 (squares), = 1=2 (stars), and = 1=256 (triangles). The insert demonstrates the anti-persistent portion of the D (L) plot for Bible.

The study of di erent written texts has suggested that all of them are featured by the pronounced persistent correlations. It is dem onstrated by Fig. 9 where the ve variance curves go signi cantly higher than the straight line D = L=4. How ever, it should be emphasized that regardless of the kind of m apping the initial portions, L < 80, of the curves correspond to a slight anti-persistent behavior (see insert to Fig. 10). Moreover, for some inappropriate kinds of m apping (e.g., when all vow els are m apped onto the same symbol) the anti-persistent portions can reach the values of L 1000. To avoid this problem, all the curves in Fig. 9 are obtained for the de nite representative m apping: (a-m) ! 0; (n-z) ! 1.

Thus, the persistence is the common property of the binary N -step M arkov chains that have been considered in this paper and the coarse-grained written texts at large scales. M oreover, the written texts as well as the M arkov sequences possess the property of the self-sim ilarity. Indeed, the curves in Fig. 10 obtained from the text of B ible with di erent levels of the determ inistic decimation demonstrate the self-sim ilarity. Presumably, this property is the mathematical rejection of the well-known hierarchy in the linguistics: letters ! syllables ! words ! sentences ! paragraphs ! chapters ! books.

All the above-mentioned circum stances allow us to suppose that our theory of the binary N -step M arkov chains can be applied to the description of the statistical properties of the texts of natural languages. How ever, in contrast to the generated M arkov sequence (see Fig. 5) where the full length M of the chain is far greater than the m em ory length N , the coarse-grained texts described by Fig. 9 are of relatively short length M $\,$ $\,$ N . In other words, the coarse-grained texts are similar not to the M arkov chains but rather to some non-stationary short fragm ents. This implies that each of the written texts is correlated throughout the whole of its length. Therefore, as fae as the written texts are concerned, it is in possible to observe the second portion of the curve D (L) parallel (in the log-log scale) to the line D (L) = L=4, sim ilar to that shown in Fig. 5. As a result, one cannot de ne the values of both parameters N and for the coarse-grained texts. The analysis of the curves in Fig. 6 can give the combination m = 2 = N (1 2) only (see Eq. (37)). Perhaps, this particular combination is the real param eter governing the persistent properties of the literary texts.

Wewould like to note that the origin of the long-range

correlations in the literary texts is hardly related to the gram m atical nules as is claim ed in R ef. [4]. At short scales L 80 where the gram m atical nules are in fact applicable the character of correlations is anti-persistent (see the insert in F ig. 11) whereas sem antic correlations lead to the global persistent behavior of the variance D (L) throughout the entire of literary text.

The num erical estim ations of the persistent param eter m and the characterization of the languages and di erent authors using this param eter can be regarded as a new intriguing problem of linguistics. For instance, the unprecedented low value of m for the very inventive work by Lew is Carroll as well as the closeness of m for the texts of English and Russian versions of B ible are of certain interest.

It should be noted that there exist special kinds of short-range correlated texts which can be specified by both of the parameters, N and . For example, all dictionaries consist of the families of words where some preferable letters are repeated more frequently than in their other parts. Yet another example of the shortly correlated texts is any lexicographically ordered list of words. The analysis of written texts of this kind is given below.

C. Dictionaries




FIG.11: The dependence D (L) for the coarse-grained alphabetical list of 15462 English words (circles). The solid line is the plot of function Eq. (55) with the tting parameters N = 180 and = 0.44.

As an example, we have investigated the statistical properties of the coarse-grained alphabetical (lexicographically ordered) list of the most frequently used 15462 English words. In contrast to other texts, the statistical properties of the coarse-grained dictionaries are very sensitive to the kind of mapping. If one uses the above-mentioned mapping, (a-m) ! 0; (n-z) ! 1, the

behavior of the variance D (L) similar to that shown in Fig. 9 would be obtained. The particular construction of the dictionary manifests itself if the preferable letters in the neighboring families of words are mapped onto the di erent symbols. The variance D (L) for the dictionary coarse-grained by means of such mapping is shown by circles in Fig. 11. It is clearly seen that the graph of the function D (L) consists of two portions similarly to the curve in Fig. 5 obtained for the generated N -step M arkov sequence. The tting of the curve in Fig.11 by function (68) (solid line in Fig.11) yielded the values of the parameters N = 180 and = 0:44.

D. DNA texts

It is known that any DNA text is written by four \characters", speci cally by adenine (A), cytosine (C), guanine (G), and thym ine (T). Therefore, there are three nonequivalent types of the DNA text m apping onto onedimensional binary sequences of zeros and unities. The

rst of them is the so-called purine-pyrim idine rule, fA,Gg! 0,fC,Tg! 1. The second one is the hydrogenbond rule, fA,Tg! 0,fC,Gg! 1. And, nally, the third is fA,Cg! 0, fG,Tg! 1.




FIG.12: The dependence D (L) for the coarse-grained DNA text of B acillus subtilis, com plete genome, for three nonequivalent kinds of mapping. Solid, dashed, and dash-dotted lines correspond to the mappings fA,Gg ! 0, fC,Tg ! 1 (the parameter m = 4:1 1°), fA,Tg ! 0, fC,Gg ! 1 (m = 2:5 1°), and fA,Cg ! 0, fG,Tg ! 1 (m = 1:5 1°), respectively.

By way of example, the variance D (L) for the coarse-grained text of Bacillus subtilis, complete genome (ftp:=ftp.ncbinih.gov=genom es=bacteria=bacillus.subtilis=NC_000964.gbk) is displayed in Fig.12 for all possible types of mapping. One can see that the persistent properties of DNA are more pronounced than for the written texts and, contrary to the written texts, the D (L) dependence for DNA does not exhibit the anti-persistent behavior at sm all values of L. In our view, the noticeable deviation of di erent curves in Fig.12 from each other dem onstrates that the DNA texts are much more com -

plex objects in comparison with the written ones. Indeed, the dimension of mapping revealand emphasize various types of physical attractive correlations between the nucleotides in DNA, such as the strong purine-purine and pyrim idine-pyrim idine persistent correlations (the upper curve), and the correlations caused by a weaker attraction A T and C G (the middle curve).




FIG.13: The dependence D (L) for the coarse-grained DNA texts of Bacillus subtilis, complete genome, the Bacteria, (solid line); M ethanosarcina acetivorans, complete genome, the A rchaea, (dashed line); D rosophila m elanogaster chrom osom e X, complete sequence, the Eukarya, (dotted line) for the m apping fA,Gg ! 0, fC, Tg ! 1.

It is interesting to compare the correlation properties of the DNA texts for three di erent species that belong to the major domains of living organisms: the Bacteria, the Archaea, and the Eukarya [19]. Figure 13 shows the variance D (L) for the coarse-grained DNA texts of Bacillus subtilis (the Bacteria), Methanosarcina acetivoransthe (the Archaea), and Drosophila melanogaster fruit y - (the Eukarya) for the most representative mapping fA,Gg! 0, fC,Tg! 1. It is seen that the D (L) curve for the DNA text of Bacillus subtilis is characterized by the highest persistence. A swell as for the written texts, the D (L) curves for the DNA of both the Bacteria and the Archaea do not contain the linear portions given by Eq. (70). This suggests that their DNA chains are not stationary sequences. In this connection, we would like to point out that their DNA molecules are circular and represent the collection of extended coding regions interrupted by sm all non-coding regions. According to Figs. 12, 13, the non-coding regions do not disrupts the correlation between the coding areas, and the DNA system s of the Bacteria and the Archaea are fully correlated throughout their entire lengths. Contrary to them, the DNA molecules of the Eukarya have the linear structure and contain long non-coding portions. As evident from Fig. 13, the DNA sequence of the representative of the Eukarya is not entirely correlated. The D (L) curve for

the X-chrom osome of the fruit y corresponds qualitatively to Eqs. (68), (69) with 0:35 and N 250. If one draws an analogy between the DNA sequences and the literary texts, the resemblance of the correlation properties of integral literary novels and the DNA texts of the Bacteria and Archaea are to be found, whereas the DNA texts of the Eukarya are more sim ilar to the collections of $10^4 \{10^5 \text{ short stories.}\}$

V. CONCLUSION

Thus, we have developed a new approach to describing the strongly correlated one-dimensional system s. The simple, exactly solvable model of the uniform binary N – step M arkov chain is presented. The memory length N and the parameter of the persistent correlations are two parameters in our theory. The correlation function K (r) is usually employed as the input characteristics for the description of the correlated random systems. Yet, the function K (r) describes not only the direct interconnection of the elements a_i and $a_{i+\,r}$, but also takes into account their indirect interaction via other elements. Since our approach operates with the <code>\original"</code> parameters N and <code>, we believe that it allows us to reveal the intrinsic properties of the system which provide the correlations between the elements.</code>

We have demonstrated the applicability of the developed theoretical model to the dierent kinds of relatively weakly correlated stochastic systems. Perhaps, the case of strong persistency is also of interest from the standpoint of possible applications. Indeed, the domain structure of the symbol uctuations at n 1 is very sim ilar to the domains in magnetics. Thus, an attempt to m odel the m agnetic structures by the M arkov chains with strongly pronounced persistent properties can be appropriate.

W e would like to note that there exist som e features of the real correlated system s which cannot be interpreted in term s of our two-param etric m odel. For exam ple, the interference of the gram m atical anti-persistent and sem antic persistent correlations in the literary texts requires m ore than two param eters for their description. O bviously, m ore com plex m odels should be worked out for the adequate interpretation of the statistical properties of the DNA texts and other real correlated system s.

In particular, the M arkov chains consisting of m ore than two di erent elements (non-binary chains) can be suitable for m odelling the DNA system s.
