Scale Invariance in G lobal Terrorism

Traditional analyses of international terrorism have not sought to explain the energence of rare but extrem ely severe events. U sing the tools of extrem al statistics to analyze the set of terrorist attacks workwide between 1968 and 2004, as com piled by the National Memorial Institute for the P revention of Terrorism (MIPT), we nd that the relationship between the frequency and severity of terrorist attacks exhibits the \scale-free" property with an exponent of close to two. This property is robust, even when we restrict our analysis to events from a single type of weapon or events within m a jor industrialized nations. We also nd that the distribution of event sizes has changed very little over the past 37 years, suggesting that scale invariance is an inherent feature of global terrorism .

Although terrorism has a long historical relationship with politics [1], only in the modern era have sm all groups of non-state actors had access to extrem ely destructive weapons [2, 3], particularly chem ical or explosive agents. This dram atic increase in destructive power has allowed severe terrorist attacks such as the M arch 20 1995 release of the Sarin nerve agent in a Tokyo subway which in jured or killed over 5000, the August 7 1998 car bom bing in Nairobi, Kenya which in jured or killed over 5200, or the more well known attack on September 11 2001 in New York City which killed 2823 [19]. Typical analyses of patterns of terrorist events have treated such rare but severe attacks as outliers, and generally focused attention only on the group of subjectively de ned \signi cant" events [2, 4]. W e show here, by exam ining data over the past 37 years, that discounting extrem alevents as special cases ignores a signi cant pattern in terrorism .

U sing the tools of extrem al statistics, we characterize the relationship between the severity and frequency of terrorist events. By severity, we simply mean the num ber of individuals injured or killed by an attack. We show that this relationship may be well-characterized by the simple mathematical function, the power law x, where is the scaling exponent. Such a P (x) pattern is said to be \scale invariant," and is ubiquitous in nature, appearing in the frequency of word usage in a variety of languages (known more commonly as Zipf's Law), the number of citations per scienti c paper, the population of cities, the magnitude of earthquakes, the net worth in US dollars of individuals, etc. (see, for exam ple, [5]). For this work, the most relevant power law is the well established one governing the relationship between the frequency and intensity [20] of wars [6, 7, 8, 9], to which we will return in a later section.

A lthough many organizations track such attacks worldwide, few provide their data publicly or in anything but an aggregate form. The M IPT database appears to be unique in its comprehensive detail, containing, as of January 2005, records of over 19 907 terrorist events in 187 countries worldwide between 1968 and 2004. O fthese, 7 088 resulted in at least one person being in jured or killed. The M IPT database is itself the com - pilation of the RAND Terrorism Chronology 1968-1997, the RAND-M IPT Terrorism Incident database (1998-Present), the Terrorism Indictment database (University of Arkansas & University of Oklahoma), and DFI International's research on terrorist organizations. Each record includes the date, target, city (if applicable), country, type of weapon used, terrorist group responsible (if known), number of deaths (if known), number of injuries (if known), a brief description of the attack and the source of the information.

G lobal P atterns




FIG.1: The distributions P (X x) of attack severity for attacks worldwide between 1968 and 2004 (a) by injuries, deaths and their aggregation, (b) for before and after the management of the database was assumed by M IPT, and (c) for events inside versus outside the G 7 industrialized nations. Solid lines are guides indicating the maximum likelihood power laws given in Table I.

Tabulating the event data as a histogram of severity (injuries, deaths and their aggregation, greater than zero), we show the cumulative distribution functions P (X x) on log-log axes in Figure 1a. The regularity of the scaling in the tails of these distributions suggests that the extrem al events are not outliers, but are instead in concordance with a global pattern in terrorist attacks. This scaling exists in spite of strong heterogeneity in the type of weapon, the perpetrating organization, geographic location, political motivation behind the attack, etc.

A ssum ing for the m om ent that the events are i.i.d., we hypothesize that the distributions follow power laws of the form P (x) x above some m inimum value $x_{m\ in}$. We use the log-likelihood function for the discrete power law with m inimum value $x_{m\ in}$,

to t the distributions, where () is the Reim ann zeta function. Our procedure is thus: we bootstrap a num eric maxim ization of L to estimate the scaling parameter , and m inimize the D-statistic of the K olm ogorov-Sm innov goodness-of-t test to select the parameter x_m in . U sing M onto C arlo m ethods to generate a table of p-values for the K olm ogorov-Sm innov statistical test for power law with the estimated and x_m in , we may that there is insu cient evidence to reject the power law as a model of

the tails of these distributions. We will see in a later section, how ever, that these distributions are the com position of several distinct power laws with di erent scaling parameters and ranges, which, in turn, causes some roughness in the power law model. A lthough we do nd su cient evidence to reject the log-normal distribution [10] hypothesis in all cases ($p_{\rm K~S} < 0.05$), we cannot completely rule out Type I/II errors as asymptotic scaling tests are quite sensitive to the range and num – ber of observations. The consideration of other heavy-tailed distributions, e.g., the q-exponential $e_{\rm q}$ $^{\times}$ or the stretched exponential e $^{\times}$, which may result in a better to fthe lower tail of the distributions, is beyond the scope of this work. Table I sum marizes the statistics and power law models for all distributions shown in Figure 1.

A few brief comments are in order. The form of our power law model ignores all data below $x_{\rm m}$ in; thus, we only model the upper tails and say nothing about the shallow scaling of the lower tails (e.g., in juries, total). A dditionally, within the range defined by $x_{\rm m}$ in, the power law is not as clean as, for example, that of earth-quakes [5]. In a system as complex as global terrorism, such inregularities are to be expected; however, the appearance of scale invariance is not. Finally, Figure 1b and c show two additional view sofglobal terrorism, which we will explain in the subsequent section.

Bias, Trends and Components

A signi cant event during the 37 years over which the M IPT database spans was the assumption of data management by the M IPT from the RAND corporation in 1998. This event raises the natural question of whether any fundamental bias has been introduced into the data as a result of di ering management practices or changes to the criteria used to judge the admissibility of an event, di erences which may result in the regular scaling observed in Figure 1a. In this section, we explore this question and characterize the evolution of the distribution as a function of time.

R eporting B ias. In Figure 1b, we plot the severity distributions (deaths) for all events before (2 304, or 33%) and after (4 784, or 67%) the change in management, which we take to occur on 1 January 1998. Notably, the distributions are very sim ilar and the scaling robust to the signi cant increase in the frequency of events after 1998. We nd that both distributions follow a power law with exponent 2 and that, in spite of di erences in the mid- and upper-tail, the slope changed by only 4%. Although we don't model it as such, the earlier distribution may be best t by a power law with exponential cuto beginning at x = 87; such a cuto could be the result of technological constraints. Generally, the appearance of the scale invariance itself seems unlikely to be the result of changes in database m anagement. Unfortunately, we have no way of accounting for any hum an-bias in the decision of an event's adm issibility. However, an analysis of the smaller but independent databasem aintained by the International Policy Institute for Counter-Terrorism 's (ICT) [21], which contains 1417 events between M ay 1980 and D ecem ber 2002, yields sim ilar results (not show n), suggesting that the scaling in the upper tails is a robust feature of global terrorism .




FIG. 2: Time series showing (left axis) the average interevent interval over a sliding window of 12 m onths, and (right axis) the average logarithm of the total severity of attacks over the same window of 12 m onths. The dashed line shows s the average log-severity for all events. O ver the course of the 37 years, we nd a slight, but statistically signi cant, linear trend in the breadth of p(x), with slope m = 4.2 10⁴, despite large changes in the frequency of events.

Inter-event Interval. W e now consider the evolution of the severity distribution over time. As mentioned above, the majority of events which killed or injured at least one person have occurred since 1998. Figure 2 (left axis) shows the mean time (in days) between recorded events, taken over a 12 m onth sliding-window. The decrease in the mean inter-event interval is striking, falling from approxim ately 28 days in early 1968 to less than 12 hours in 2004. The precipitous drop in 1998 is especially notable, and suggests that when the database changed hands, the adm ission criteria m ay have becom e m ore perm issive or a signi cantly larger num ber of events were being evaluated. However, Figure 2 illustrates that the decrease in inter-event tim e has been a largely continuous trend over the entire lifetime of the database. We note that this increase in the frequency of recorded events worldwide is consistent with ndings by the United States Department of State [4]. Thus, while it seems plausible that the change in maintenance did result in some increase in reporting frequency, we cannot rule out the possibility that there has been a genuine increase in the frequency of attacks in recent years.

G lobal Trends. Given that the distributions we observe in Figure 1a and b are a collection of events over time, we may naturally wonder if each event was drawn from the same distribution (i.e., the severity distribution is stable), or if the distribution has changed in som e way. The right-axis in Figure 2 shows the average log-severity of events within the same sliding window of 12 m onths, over the 37 years of data. Let us assume that each event was drawn independently from the distribution p(x). We then expect the time series to uctuate about the average log-severity for the entire time period, which is $h\ln(s)i = 1:126$. This appears to be the case, although we also measure a slight linear trend in this function, by least-squares, with slope $m = 42 \cdot 10^4$. Using M onte Carlo simulation, we test the likelihood that this linear trend is the result of random uctuations arising from the variation in sampling frequency. To do this, we sim ulate a new sequence of events by drawing a new severity value from the hypothesized heavy-tailed distribution p(x) (Table I) for each observed time; we then compute the window-averaged log-severity as above and measure its linear component m . Repeating this process many times, we nd that we may reject the random - uctuation hypothesis (p_{M C} < 0.013). Bootstrapping the observed distribution yields a similar conclusion. Thus, we may say with some con dence that while the severity distribution has certainly not changed much over the past 37 years, the slight linear trend is unlikely to be the result of random uctuations due to sam pling, or the increased frequency of events in recent years.

C om ponent D istributions. As mentioned above, the richness of the event meta-data allows for many views of global terrorism. Here, we focus speci cally on those which are relevant to the appearance of scale invariance in the severity distributions. D ividing events into categories for those occurring within the major industrialized

nations, i.e., C anada, France, G em any, Italy, Japan, the U nited K ingdom and the U nited States, known collectively as the G 7 (590 events over 37 years), and those occurring throughout the rest of the world (6 498 events, or 92%), we plot the corresponding severity distributions (total) in Figure 1c (also sum marized in Table I). Most notable is the substantial di erence in the scaling in the upper tails: $_{G7} = 1:71 \ 0.03$ versus $_{non \ G7} = 2:5 \ 0.1$; that is, the largest events are signi cantly m ore likely to occur within one of the G 7 nations than elsewhere in the world. We have no m explanation for such a distinction, although it m ay be the result of technological di erences. That is, sm all groups of non-state actorsm ay have access to a greater degree of destructive potential as a result of industrialization.

W e m ay also divide the events into groups based on the type of weapon used; F igure 3 shows the (total severity) distributions of events for chem ical or biological weapons, explosives (including remotely detonated devices), re,

rearm s, knives and a catch-all category <code>\other"</code> (which also includes unconventional and unknown weapons). Surprisingly, these component distributions are all well-m odeled by power laws ($p_{K,S} = 0.9$), which we sum marize in Table II. There are several points to be m ade by this observation. First, the trend in the lower tails of Figure 1a and c (in juries or total, and non-G 7, respectively) is now obviously caused by som e property of explosives. A dditionally, di erent weapon types clearly exhibit distinct cuto s, as one m ight expect, e.g., knives have the sm allest associated maximum severity.

M odels and M echanism s

We believe that the scale invariance in global terrorism is related in some way to the power law observed by Richardson in 1948 [6], and con med independently by [8, 9], for the frequency versus intensity of wars. Using a similar maximum likelihood method on the historical wardata of Sm alland Singer [11], Newman found a scaling parameter of = 1.80 0.09, which is close to several of those that we measure for global terrorism.




FIG.3: Total severity distributions and their corresponding maximum likelihood power laws (see Table II) for six weapon types: chemical or biological agents (0:4% of events), explosives (including remotely detonated devices) (44:3%), re (1:7%), rearms (36:2%), knives (3:3%) and other (which includes unconventional and unknown weapon types) (14:2%).

G iven the appearance of scale invariance across m any views of global terrorism, we may now ask if a simple generative model exists which might explain its origin. We note that the complexity of terrorism makes such a simple explanation unlikely or, at best, highly susceptible to criticism . In this section, we discuss a few power-law mechanisms which are appealing for the system of terrorism /counter-terrorism (see [5, 12, 13] for brief surveys of other power-law mechanisms). Although it has been suggested that Richardson's scaling law is the result of a m etastability in a geopolitical system [14] that has driven itself to a state of self-organized criticality (SOC) [15], this hypothesis seems ill-suited to explain the scaling in the severity of terrorist attacks. Another appealing model is that of highly optim ized toerance (HOT) [16]; however, because it relies both on risk-neutrality and underlying geometric constraints to produce power laws [17], it seems a poor thorour system. Indeed, the most appealing model, and one that is strongly supported by the data, is one based on the mixing of component distributions such as those in Figure 1c and Figure 3.

In the interest of fram ing future work in this area, we suggest a short list of criteria by which to judge any proposed general model of global terrorism : a successfulm odel m ust (in order of in portance)

- represent an intuitive mechanism by which to generate the size of an actual event (e.g., a competition between states and non-state actors);
- 2.produce heavy tails with appropriate scaling
 (Fig.1a);
- 3. allow for the resulting distributions and dynam ics to vary in time; and,
- 4. account for the di erences in scaling caused by technology, e.g., industrial versus non-industrial nations (Fig.1c) and types of weapons (Fig.3).

W e will now analyze a highly idealized m athem atical m odel of the com petition between non-state actors and states which satis es these criteria in the most general sense. Let us assume a large population of non-state actors, each of whom is responsible for executing a single event, and let each event's severity be given by a random variable s with distribution p(s), with some m aximum value $s_{m ax}$. Now assume that some, but not all, events are actually executed, perhaps because of collective counter-terrorism actions by states, social factors,

random failures, etc. Thus, the distribution of actual events p(x) is given by a sampling of the distribution of potential severities p(s), and m ay be derived by solving the equation

p(x)dx = p(s)ds:

Suppose that, perhaps as a result of factors such as the relative availability of cheap weapons, prevalence of potential targets, technological advances β , etc., the distribution of potential severities is exponential, $p(s) = e^{as}$, with a > 0 up to som $es_{m ax}$. Now suppose that the like-lihood of an event being successful is inversely related to its potential severity, so the relationship between x and s m ight be given by x e^{bs} with b < 0. Under these assumptions, the solution to our general equation above yields a power law p(x) = x, where a = 1 a = b. When in the power law with exponent 2.

As shown clearly in Figure 3, the severity distribu-

tion for global terrorism is itself com posed of several distinct component distributions. Thus, it is appealing to consider m athem atical m odels derived from distribution m ixtures, e.g.,

$$p(x) = g(z) f_z(x) dz;$$

where z distinguishes each component distribution $f_z(x)$, and g(z) is som emixing function. From this approach, if the $f_z(x)$ decay faster than any power law, then p(x) itself will only be a power law when g(z) is a power law [18]. Thus, we must still rely upon a power-law generating mechanism, such as the idealized one given above. How – ever, this meta-model has the appealing feature of being able to capture real heterogeneity in the data: if we take g(z) to be some constant, and let $(a=b)_{G7} = 1.71$ and $(a=b)_{non G7} = 2.5$, we may recover a distribution which has scaling in the upper tail like that of total severity in Figure 1a. An empirical estimate of these ratios would provide a point of validation for our model, but adm ittedly may be quite di cult to make.

The mixtures model may be even more useful. As we would expect, Figure 3 shows that the severity of an event is governed by the type of weapon used. Thus, the choice of exponential distribution for the potential severity of an event $p(s) = e^{as} m ust$ itself be a mixture of weapon-speci c distributions. We note also that our simple generative model may be extended to incorporate the slight tem poral trend in the average log-severity of events, as illustrated in Figure 2 by simply letting the parameters a and b vary in time. Finally, it should be noted that our simple model assumes each event is drawn i.i.d. from the underlying distribution; obviously, in the real data, there are likely strong tem poral correlations associated with various geopolitical events and policies. A more realistic m odel might account for these correlations.

Conclusions

In exploring the distribution of the severity of events in global terrorism, we have found a surprising and robust feature: scale invariance. Traditional analyses of terrorism have typically viewed catastrophic events such as the 1995 truck bom bing of the Am erican em bassy in N airobi, K enya, which killed or injured m ore than 5 200, as outliers. However, the property of scale invariance suggests that these are instead a part of a statistically signi cant global pattern in terrorism. Further, we no little reason

to believe that the appearance of power laws in the distribution of the severity of an event is the result of either reporting bias or changes in database management. This suggests that the power law distribution, with 2, is an inherent feature of terrorism and counter-terrorism. Indeed, the severity distribution itself has changed very little over the past 37 years of recorded events (Fig. 2), in spite of a dramatic increase in the frequency of events. This small grow th in the breadth of the severity distribution may be the result of technological changes, such as the power and availability of cheap explosives and rearms.

Surprisingly, the scale-invariance result extends beyond the total collection of events. W hen we exam ine the distributions for major industrialized nations versus the rest of the world, we nd that heavy tails are present in both (Fig.1c), but with substantially di erent exponents: $_{G7} = 1:71$ 0:03 versus $_{non G7} = 2:5$ 0:1. That is, while events occurm uch less frequently in major industrialized nations, when they do, they are much more severe (on average) than events outside those nations. A dditionally, when events are partitioned by weapon type, statistically signi cant power laws persist (Fig. 3, Table II) and show that any roughness in the scaling of the aggregate distributions (e.g., Fig. 1a) is derived from the com position weapon-speci c power laws with distinct scaling param eters and ranges. It also illustrates that there is something unique about explosives, which causes the shallow scaling of the lower tail for the injuries severity distribution.

There are many generative mechanisms in the literature for power laws, although many of them are unappealing for explaining the structure we nd in global terrorism. The highly abstract model of competition between non-state actors and states, which we propose, analyze and extend via the mixtures model, is likely too simple to capture the ne structure of global terrorism. However, we hope that our model and the statistically signi cant empirical regularities which we show here will frame future e orts to understand global terrorism.
