ON FRIEDMANN'S UNIVERSES

ANGELO LOINGER

Abstract. There is a perfect concordance between Friedmann's cosmological models and the correspondent (purely gravitational interactions and negligible pressure) Newtonian models. This renders quite intuitive the fact that in general relativity no motion of bodies generates gravitational waves.

- 1. As it is well known, Friedmann's cosmological models [1] can be characterized in the following way:
- i) A spacetime intervalds given by Friedmann-Robertson-Walkermetric $(x^1; x^2; x^3; r)$ are dimensionless coordinates):

and = 0; 1, $r^2 = (x^1)^2 + (x^2)^2 + (x^3)^2$; F (x^0) is a function of time to be determined by Einstein eld equations. Eq.(1) yields the most general metric expression describing a uniform (i.e. homogeneous and isotropic) three-dimensional space. (= 0: Euclidean space; = 1: spherical { or elliptical { space; = 1: hyperbolic space}.

ii) A m ass tensor T^{jk} , (j;k = 0;1;2;3), of the galaxy \dust", given by

where is the invariant mass density. A \dust" particle represents a galaxy. The particles interact only gravitationally. Eq.(1) is written in a particular Gaussian-normal coordinate frame [2] { synchronous frame, according to the expressive term inology of Landau-Lifchitz [2]. For frames of this kind the time lines are geodesic lines. Remark that for any physical system of particles, the mass tensor of which is given by eq.(2), the world lines of the particles are geodesic lines, and therefore no gravitational wave can be emitted [3]. Thus, our coordinate frame is synchronous and comoving [4] { and the galaxy trajectories are geodesic lines. We have:

where G is the gravitational constant, one obtains:

C learly, the distance between two galaxies is proportional to the function F of time. The solutions of eqs.(5), (6) are well known: for = 1, we have a cosm ic periodic oscillation between F = 0 and F = F_{max} ; for = 0; 1 we have a cosm ic monotonic expansion. In all cases, = $F^2(x^0)$ is the curvature of the space section x^0 = constant. For F = 0 the density is in nite and the gravitational eld is singular.

2. - In the Thirties of the past century, a Newtonian cosmology was developed: an investigation of the kinds of ow in a galaxy \dust", when homogeneity, isotropy, and irrotational ow are assumed [5]. A galaxy which is on the surface of an expanding sphere of radius < (t) is attracted by the mass M within the sphere according to Newton's law:

where is an integration constant, which characterizes the total energy, kinetic plus potential.

In conclusion, we can write the two following equations:

If we put = 0; 1, eqs. (7") and (8) become identical to Friedmann's eqs. (5) and (6).

We have here three Newtonian models which, starting from a singular point of an in nite mass density, give either a monotonic expansion (for = 0; 1) or a periodic oscillation (for = 1) between < = 0 and $< = <_{max}$. The concordance with Friedmann's results is complete.

The New tonian eqs. (7") and (8) give in a three-dimensional Euclidean Bildraum three faithful representations of the Einsteinian eqs.(5) and (6). Vice-versa, the Einsteinian eqs. (5) and (6) give in three three-dimensional Bildraume (resp. Euclidean, spherical, hyperbolic) three faithful representations of the New tonian eqs. (7") and (8).

3. - The New tonian im ages of the Einsteinian Friedmann's models render quite intuitive the physical fact that in general relativity no motion of bodies generates gravitational waves [6]. (Let us observe that Birkho's theorem [7] regards only the outside space of a spherically symmetric mass distribution).

A nother rem ark. The Oppenheim er-Snyder treatm ent of the spherically sym m etric collapse of a \dust" (with negligible pressure) { simplied im age of a gravitationally collapsing star { utilizes Friedmann's form alism relative to the return motion in a periodic oscillation, from $F=F_{\rm max}$ to F=0 [8]. These authors describe the gravitational eld in the outside space of the star with the standard Hilbert-Droste-Weyl form of solution of the Schwarzschild problem, improperly called \Schwarzschild solution". Now, this form is actually not suitable to the present problem, because it is mathematically and physically valid only for $r>2G\,M=c^2$. Neglecting erroneously this fact, one obtains a black hole as a nall product of the contraction. But if we employ the ORIGINAL form of solution given by Schwarzschild [9], which is regular for all values of the radial coordinate r dierent from zero (and is dieomorphic to the exterior part, $r>2G\,M=c^2$, of the standard HDW – form), we obtain simply a point mass, i.e. a quite usual object [10] in lieu of a ctive black hole.

This conclusion is corroborated by the following consideration. If we employ the Newtonian formalism ($\sec t.2.$) relative to the return motion in a periodic oscillation, the problem of the sphero-symmetric gravitational collapse of a star becomes quite simple { and the nalresult is quite standard: a Newtonian point mass. (Very keen papers on gravitational collapse { from both the standpoints, E insteinian and Newtonian { have been published by M c V ittie [11]).

The so-called observed black holes are only very large { or enorm ously large { m asses concentrated in relatively sm all volumes. as it can be veried very easily with a careful reading of the concerned papers.

4. - The previous form alisms are well known in the pertinent literature, only the perspective according to which they are here considered is new. I have emphasized the great signicance of Friedmann's results in regard to the question of the gravitational waves.

There is a perfect parallelism between the time variation of the curvature $=F^2$ (t) of the spatial section t = const and the time variation of

its Newtonian analogue $=<^2$ (t), which is proportional to Newton's force $M = \{8 < 2 \text{ (t)}\}$.

In general { and roughly speaking: a displacement of a given mass causes a corresponding displacement of its Newton's force and a corresponding displacement of the E insteinian space curvature. No gravitational wave is ever generated, the analogy between E instein eld and M axwell-Lorentz eld is a m isleading analogy.
