$D$ etecting subtle e ects of persistence in the stock $m$ arket dynam ics

#### Abstract

The conventionalform altoolto detecte ects of the nancialpersistence is in term $s$ of the H urst exponent. A typical corresponding result is that its value com es out close to $0: 5$, as characteristic for geom etric B row nian $m$ otion, $w$ ith at $m$ ost $s m$ all departures from this value in either direction depending on the $m$ arket and on the tim e scales involved. $W$ e study the high frequency price changes on the Am erican and on the Gem an stock $m$ arkets. For both corresponding indices, the D ow Jones and the DAX respectively, the H urst exponent analysis results in values close to $0: 5$. H ow ever, by decom posing the $m$ arket dynam ics into pairs of steps such that an elem entary $m$ ove up (dow $n$ ) is follow ed by anotherm ove up (dow $n$ ) and explicitly counting the resulting conditionalprobabilities we nd values typically close to $60 \%$. This e ect of persistence is particularly visible on the short tim e scales ranging from 1 up to 3 m inutes, decreasing gradually to $50 \%$ and even signi cantly below this value on the larger tim e scales. $W$ e also detect som e asym $m$ etry in persistence related to the $m$ oves up and dow $n$, respectively. This indicates a subtle nature of the nancial persistence whose characteristics escape detection within the conventional H urst exponent form alism .


## 1. Introduction

The nancialdynam ics results in uctuationswhose nature is, aspointed out by B achelier [1] already in 1900, of the B row nian character. By now we know that it is $m$ uch $m$ ore com plex and fascinating than just the ordinary B row nian $m$ otion. A lready the distribution of stock $m$ arket retums is far from being $G$ aussian and at the short tim e scales large uctuations develop heavy power law asym ptotics with an exponent $=3$ [2], well outside the Levy stable regim e [3], how ever. T he autocorrelation function of retums drops dow $n$ very quidkly and after a few $m$ inutes it reaches the
noise level. At the sam e tim e how ever the volatility autocorrelation function decays very slow ly w ith tim e [3], largely according to the pow er law, and rem ains positive for $m$ any $m$ onths. O $n$ a m ore advanced level of global quanti cation, the nancialdynam ics appears to be describable in term s of m ultifractality both in the transaction-to-transaction price increm ents and in the inter-trade waiting tim es [4]. This indicates a hierarchically convoluted self-sim ilar organization of the $m$ arket dynam ics. O ne related issue is an e ect of persistence. Its com $m$ only adopted $m$ easure - the $H$ urst exponent - is the $m$ ode of each $m$ ultifractal spectrum. The H urst exponent, how ever, is a global m easure while the e ects of persistence $m$ ay in principle depend on the $m$ arket phase. Below we address this issue using the high-frequency records (years 1998-99) of the two from am ong the world leading stock $m$ arket indices, the $D$ ow Jones IndustrialA verage (D JIA ) for the U nited States and the D eutsche A ktienindex (DAX) for G em any.

## 2. C onventionalm ethods

$T$ here exist tw ocom $m$ only accepted and best-know $n m$ ethods to evaluate the long-range dependences in the statistical series. T he older one is the so-called rescaled range or $\mathrm{R} / \mathrm{S}$ analysis [5]. This m ethod originates from previous hydrological analysis of H urst [6] and allow s to calculate the selfsim ilarity param eter H. A drawback of this $m$ ethod how ever is that it $m$ ay spuriously detect som e apparent long-range correlations that result from non-stationarity. A m ethod that avoids such artifacts is the D etrended F luctuation A nalysis (D FA ) [7]. In this $m$ ethod one divides a tim e series $g\left(t_{i}\right)$ of length $N \quad(i=1 ;:: \mathbb{N})$ into $M$ disjoint segm ents of length $n$ and calculates the signal pro le

where h:::i denotes the $m$ ean. For each segm ent the local trend is then estim ated by least-squares tting the straight line (in general a polynom ial) $Y$ (i) and the corresponding variance

$F$ inally, one calculates the $m$ ean value of the root $m$ ean square uctuations over all the segm ents :

The pow er-law scaling of the form

indicates self-sim ilarity and is considered to provide a m easure of persistence. If the process is white noise then $H=0: 5$. If the process is persistent then $\mathrm{H}>0: 5$; if it is anti-persistent then $\mathrm{H}<0: 5$.

T he above procedure applied to the retums

where $P$ ( $t$ ) represents the price tim e series, results in num bers as listed in the last colum $n$ of $T a b l e 1$ for $t$ ranging from 1 m in up to 30 min . In addition to the DAX and the D JIA this Table includes also what forbrevity we here call $N$ asdaq30 and what for the purpose of this work is constructed as a sim ple sum of the prices of 30 high-capitalization com panies belonging to the $N$ asdaq $C$ om posite basket. A s one can see from the $T$ able 1, typically the so-calculated $H$ urst exponents $H$ point to a trace of anti-persistence but in fact they do not deviate m uch from 0.5 , especially that an error involved in estim ation equals about $0: 4 \%$ for $t=1 \mathrm{~m}$ in and increases up to $1: 5 \%$ for $t=30 \mathrm{~m}$ in due to an e ective shortening of the series.

Still this result does not elim inate a possibility that there exist som e $m$ ore local e ect of persistence that sim ply average out when estim ated from the longer tim e intervals. In fact, som e proposals to calculate the local counterparts of $H$, based on variants of DFA, are already present in the literature [8, 9] and point to such e ects indeed. T he accuracy of the related $m$ ethods is how ever not yet w ell established. Furtherm ore, observations and experience prom pt a possibility that the nancial persistence $m$ ay happen to occur asym $m$ etrically, i.e., a $m$ ove up $m$ ay be follow ed by another $m$ ove up m ore often than a $m$ ove dow $n$ by another $m$ ove dow $n$, or vice versa. Such e ects $m$ ay carry a very valuable inform ation about the dynam ics but rem ain indistinguishable w ithin the conventional m ethods and unexplored so far. In order therefore to explore a possibility and character of such e ects we retum to the very de nition of persistence.

## 3. M easuring persistence by conditional probabilities

$G$ íven a tim e series of prige retums $g\left(t_{i}\right)$, where $t_{i}$ denotes the consecutive equidistant $m$ om ents of tim $e$, to each iwe assign +1 if $g\left(t_{i}\right)$ is positive (prige goes up), -1 if it is negative (price goes dow $n$ ) and 0 if it happens to be 0 (price rem ains unchanged). W e then explicitly count the number $N$; of all the neighboring pairs $f g\left(t_{i}\right) ; g\left(t_{i+1}\right) g$ of the type ; $=f 1 ; 0 ;+1 g$ for

which corresponds to a conditional probability that a retum of the type
is preceded by a retum of the type. This procedure can of course be perform ed on any tim e scale $t=t_{i+1} \quad t_{i}$.

Six combinations of p; corresponding to $=1$ and to all the three possible values of are listed in Table 1 for several values of $t$ starting from 1 up to 30 m in.

Q uite interestingly - and som ew hat unexpectedly in view of the corresponding values of the H urst exponents (last colum $n$ in Table 1) that are
very close to 0.5 like for the white noise - both the DAX and the D JIA show signi cant e ects of persistence on the sm all tim e scales. A m ove up (dow $n$ ) is follow ed by anotherm ove up (dow $n$ ) signi cantly m ore often than by a move in opposite direction. For $t$ larger than 5-10 m in we observe a crossover: the uctuations becom e anti-persistent and, w hat is particularly interesting, this e ect is visibly asym $m$ etric tow ards $m$ oves dow $n$ as a sys tem atically observed relation $\mathrm{p}_{1 ; 1}$ and $\mathrm{p}_{+1 ;+1}$ indicates. For the basket of the N asdaq stocks this crossover also takes place, though on the som ew hat larger tim e scales.
$T$ he tim e period (01.12.1997-31.12.1999) of the stock $m$ arket variability studied here displays a ridhness of phases. In the rst half of this period it for instance includes a spectacular draw up (D A X m ore than 50\%) follow ed by an even faster draw dow $n$ to the original level. P revious study [10] based on the correlation $m$ atrix form alism provides a serious indication that the dynam ics of long-term stock $m$ arket increases is $m$ ore com petitive and less collective (as far as correlations am ong the individual stocks form ing an index is concemed) than during long-term decreases.

It is thus interesting to inspect if and how our indicators of persistence correlate $w$ th the di erent phases of the $m$ arket dynam ics. T w o principal such coe cients (rectangles), $p+1 ;+1$ and $\mathrm{p}_{1 ; 1}$, calculated for $\mathrm{t}=1 \mathrm{~m}$ in over one trading day tim e intervals for all the consecutive days covering our 01.12.1997-31.12.1999 tim e period, versus the corresponding D A X changes are show $n$ in $F$ ig. 1. T he correlation is visible indeed.

The long-term increases system atically lead to a decrease of persistence both in $p_{+1 ;+1}$ and in $\mathrm{p}_{1 ; 1}$. A sharp increase of the DAX in the end of the period here analyzed pulls these two coe cients even below 0.5. On the contrary, the decreases are seen to be lifting our persistency coe cients up to as high as 0:7. Even more, changes of the trend in $p_{+1 ;+1}$ and P 1; 1 are som ew hat shifted in phase relative to each other which is another $m$ anifestation of asym $m$ etry in persistence. That all such e ects $m$ ay re ect a general logic of the stock $m$ arket dynam ics can be seen also from Fig .2 which displays the sam e quantities for the D JIA in the sam e period of tim e
and qualitatively analogous correlations can be postulated.
$M$ ore focus on this last issue is given in Figs. 3 and 4 and the corresponding Tables 2 and 3. Two sizable periods of the global market increases and decreases, respectively, both for the DAX and for the D JIA, are here extracted and the corresponding conditional probability coe cients p ; calculated for those periods separately. A gain one sees that the related uctuations are persistent and that these persistency e ects are even stronger during decreases. Furthem ore, even during the sam em arket phase (either global increase or decrease) the asym $m$ etry in persistence betw een the $m$ oves up and down $m$ ay occur.

## 4. C onclusion

The above observations are intriguing and of course dem and a much $m$ ore system atic study as they carry a potential to shed $m$ ore light on $m$ echan ism of the stock $m$ arket dynam ics. The present study how ever already indicates direction conceming this speci $c$ issue. T here de nitely exist higher order correlations in the nancial dynam ics that escape detection w ithin the conventional $m$ ethods. In this connection the $w$ avelet based form alism, due to its ability to focus on local e ects, seem s to o er a prom ising fram e to develop consistent related m ethodology, such that a link to multifractally perhaps can also be traced. T he wavelet based form alism can also be generalised to account for the asym $m$ etry in persistence - an e ect identi ed above. Finally and ultim ately, one needs to develop a realistic theoreticalm odel of the nancial dynam ics such that also the above e ects can be inconporated. A variant of the generalised $W$ eierstrass random walk as developed by K utner [11] m ay appear an appropriate solution especially that the $W$ eierstrass-type finctions $m$ ay inconporate log-periodicaly a kind correlations that underlay the nancialdynam ics [12, 13].
