Theory of the Laser W ake Field A ccelerator R evisited: W ake O vertaking, Localized Spectrum and Ponderom otive A cceleration

The electron and positron acceleration in the rst cycle of a laser-driven wake eld is investigated. Separatrices between di erent types of the particle motion (con ned, re ected by the wakeeld or ponderom otive potential and transient) are demonstrated. The ponderom otive acceleration is negligible for electrons but is substantial for positrons. An electron bunch, injected as quasimonoenergetic, acquires a localized energy spectrum with a cut-o at the maximum energy.

Laser-driven charged particle acceleration is an attractive alternative to cyclic accelerators and linacs, prom ising to provide much greater acceleration rate with a much more compact facility. At the dawn of the laser technology the \opticalmaser" was suggested in Ref. [1] to accelerate electrons. The long-living strong Langmuir wave (wake eld), left in the wake of a short intense laser pulse in a low-density collisionless plasma, accelerates duly injected electrons in the Laser W ake Field Accelerator (LW FA) concept introduced in Ref. [2]. For electron acceleration of charged particles, the laser pulse must be relativistically strong, i. e., its amplitude $a_0 = eE_0 = m_e! c > 1$. To provide electrons one must use an externally preaccelerated electron bunch or exploit the electron function due to a longitudinal Langmuir wave-break [3] or/and a transverse wave-break [4], which dom inates when the laser pulse waist become escome parable with or less than the wake eld wavelength, e. g., due to the pulse self-focusing. The injection of the preaccelerated electron bunch co-propagating with the laser pulse was considered in Ref. [5]. The wave-breaking occurs when the displacement of the plasma electron und moving in the wave becomes equal to or larger than the wake eld wavelength $w_f = 4$ $\frac{1}{2}ca_0 = !_{pe}$, where $!_{pe} = \frac{1}{4} \frac{1}{n_e}e^2 = m_e$ is the Langmuir frequency.

In recent experiments localized energy spectra of electrons accelerated up to 170 MeV were demonstrated [6, 7]. The indications were given that the laser pulse undergo a self-focusing, and the wave-breaking (both the longitudinal and transverse) occures in the st cycle of the wake eld with the electron self-injection into the acceleration phase. In Ref. [6] the localized electron energy spectrum formation was attributed to electrons accelerated in the wake eld

rst cycle, overtaking the laser pulse. The so-called \ponderom otive electron acceleration", suggested in Ref. [8] and analyzed in Refs. [9], describes the charged particle motion at the laser pulse front, thus it is in e ect also in the wake eld rst cycle. The positron acceleration by a long electrom agnetic wave in underdense plasm as was considered in Ref. [10].

In this Letter we revisit theory of the LazerW ake Field A coelerator and exam ine the acceleration of charged particles in the rst cycle of the wake eld. The electron energy spectrum is calculated in a general case of nonoptimal injection. The role of the ponderom otive acceleration is discussed in the case of electrons and positrons.

In the fram ework of classical electrodynam ics the one-dimensional motion of a particle with charge e and mass m_e in the laser pulse and wake eld is described by the Ham iltonian [11]

where X = x yt, x is the particle coordinate, v_g is the group velocity of the laser pulse (equal to the wake eld phase velocity), $0 < v_g < c; P_k$ and P_2 are the longitudinal and transverse components of the generalized momentum, A_2 is the laser pulse vector potential, ' is the the wake eld potential. In general, P_2 and A_2 have two components (along y and z). Here we neglect the dispersion of the the laser pulse, assuming that the laser pulse eld depends on time and coordinate as A_2 (x yt). The Ham iltonian (1) adm its a Lie group with generators $v_g e_x + e_t, e_y, e_z$. C orrespondingly, the N oether theorem in plies the motion integrals:

where h_0 and $P_{2,0}$ are constants of the particle initial momentum. We introduce dimensionless variables

We note that the variable a (X) represents both the particle initial transverse generalized momentum and the laser pulse vector-potential. In the case of $P_{?0} = 0$ it is just the laser dimensionless amplitude. The stintegral in (2) in terms of new variables (3) gives the equation

Its solution for ph < 1 is written as

where $_{ph} = (1 \qquad _{ph}^{2})^{1=2}$; the sign +' is for X increasing with time and \cdot' is for X decreasing with time. The particle moving from X₀ to X with monotonically increasing X (t) acquires the net kinetic energy

where = (X) (X₀), $E_0 = \frac{p}{1 + p_{x0}^2 + a^2 (X_0)} = 1$, $0 = E_0 + 1$ php_{x0} and $p_{x0} = p_x (X_0)$.

To exemplify the general property of the system with H am iltonian h (X; p_x), we show its phase portrait in Fig. 1 (c), (e) for the electron with $P_{?0} = 0$ in the case when the circularly polarized quasi-G aussian laser pulse with am plitude $a(X) = a_0 \exp(4\ln(2)X^2 = l_p^2)$ 1=16 at $\frac{1}{3}$ j6 l_p , 0 at $\frac{1}{3}$ j> l_p , $a_0 = 2$, FW HM size $l_p = 10$ wavelengths, propagates in an ideal Hydrogen plasma with density $n_e = 0.01n_{cr}$, and excites a wake eld, whose potential is described by the Poisson equation, [12],

where the prime denotes dimension with respect to the X coordinate, $k_p = !_{pe}=c$ and $m_i = m_e = 1836$ is the ion-to-electron mass ratio. The potential , corresponding to the longitudinal electric eld, and the electron and ion densities as well as the laser pulse envelope are shown in Fig. 1(a), (b). We consider a circularly polarized pulse to ensure the dependence of a^2 on X = x gt and existence of motion integrals (2), thus avoiding complication that the laser pulse electrom agnetic wave phase velocity is equal to $v_{ph;las} = 1 = v_g > 1$. We choose the mite quasi-G aussian pulse shape to emphasize the existence of the \ponderom otive" separatrix (see below). The pulse length is taken to be less than, but not too much, the (relativistic) wake eld wavelegth so as to make the wake eld excitation e cient enough to preserve the electron the laser eld on the particle motion inside the rst period of the wake eld and to sim plify form ulae below.

Each orbit fX (t); p_x (t)g of the electron in the (X; p_x)-plane is a segment of a level curve of the function h (X; p_x). The (X; p_x)-plane is divided into basins of a nite motion, where the particle is trapped by the wake eld potential, and two basins of in nite motion. The basins are separated from each other by special orbits, separatrices, which join at singular points situated on the curve $p_{xs}(X) = p_{h}p_{h}^{h} (1 + a^2(X)) \cdot 0$ n this line the square root in the right hand side of Eq. (6) vanishes: $(+ _{0})^{2} = p_{h}^{2} (1 + a^{2}(X)) = 0$.

An electron started from the singular point X_s acquires the maximum kinetic energy at the top X_t of the separatrix, as one can easily calculate from Eq. (6) substituting $X_0 = X_s$, $X = X_t$, $p_{x0} = p_{xs} (X_s)$. If the laser pulse length is shorter than a half of wake eld wavelength, then in the rst period of the wake eld the points X and X_t correspond, respectively, to the local minimum and maximum of the wake eld potential, $(X_s) = m_{in}$, $(X_t) = m_{ax}$. So the maximum kinetic energy on the separatrix is

where $m = m_{ax}$ m_{in} , $E_{inj} = ph$ 1. If the laser pulse length is much shorter than the wake eld wavelength and ph 1, we have E_m 2 ph m + ph 1. The lowest value of the potential is reached when the laser pulse sweeps the greatest possible amount of electrons (in 1D { a half of all the electrons per wake eld period), $m_{in} > 1 + 1 = ph$, and the highest value is limited by the ion response, $m_{ax} \in (1 = 1)$. Knowing the minimum of the solution to

Eq. (7), one can nd its maximum; in the case of a su ciently short and intense laser pulse ($l_{\rm wf}$, a 1), Eq. (7) gives $_{\rm max} = (1 \ _{\rm ph}^{1})(2 \ _{\rm ph} + 1) = (2 \ _{\rm ph} + 1)$, which in the limit $m_{\rm i}$ $m_{\rm e}$ tends to 2 $_{\rm ph}$ 1 $_{\rm ph}^{1}$. If the laser pulse has the optim al length, then $_{\rm max}$ $a^2=2$ for a. p^{-} , [13].

Since the laser pulse has a nite duration, the \runaway" separatrix exists, a segment of the level curve h (X; p_{i}) = $1 = p_{h}$ min, Fig. 1 (c). If an electron beam is injected exactly onto this separatrix, it asymptotically overtakes the laser pulse and becomes monoenergetic with the nalenergy, as it follows from Eq. (8),

where $j_{min} j = m_{min} > 0$. In the limit ph 1, this energy can be much higher than the required minimum injection energy. If, additionally, the wake eld is strongly nonlinear (a 1), m_{in} tends to its lowest value 1 + 1 = ph and we have $E_{fmax} = 2 \frac{2}{ph} + ph$ 1.

In the rst period of the wake eld behind the laser pulse there is also the \con ned" separatrix, a segment of the level curve h (X; p_x) $1 = _{ph}$ (the exact value is discussed below). It encloses a basin of orbits of electrons which are trapped inside the potential well moving along with the laser pulse. Between the \con ned" and \runaway" separatrices lies a bunch of recting orbits. On such an orbit an electron starts with the longitudinalm omentum p_x in the range $_{ph} p_h > p_x > _{ph} p_h + \frac{2}{p_h} p_h j_{min} j [\frac{2}{min} + 2 \frac{1}{p_h} j_{min} j]^{1-2} > 0$ att! 1. Then it is accelerated by the rst cycle of the wake eld, reaching the maximum energy de ned by Eq. (6), where one must substitute $X_0 = +1$, $p_{x0} = p_x$; $a(X_0) = (X_0) = 0$. Finally, the electron overtakes the laser pulse. Its longitudinalm omentum p_x and kinetic energy E increase as

where = $[1 + (p_x)^2]^{1=2}$, E = 1, $y_x = p_x = \langle p_h \rangle$. The same equations describe an elastic rebound of a relativistic particle from the wall moving at a speed p_h .

Yet another, the third, \ponderom otive" separatrix exists in the vicinity of the laser pulse front $X_f = l_p$, Fig. 1(c), (e). It pins the second, \con ned", separatrix at the point $(X_p; p_{xs}(X_p))$ de ned by equation $a(X_p)a^0(X_p) = p_h^0(X_p)^{\frac{1}{2}} \frac{1}{1 + a^2(X_p)}$ and so the exact value of the H am iltonian for both separatrices is $h_p = h(X_p; p_{xs}(X_p))$. The third separatrix encloses a thin basin of orbits with $1 = p_h < h(X; p_x) < h_p = h(X_p; p_{xs}(X_p))$, going from X = +1 at

t! 1 with $p_{k} < p_{h} p_{h}$ and rejecting back with increased $p_{k} > p_{h} p_{h}$ at t! +1. In contrast to orbits between the \con ned" and \nunaway" separatrices, where particles are rejected by the wake eld potential, the orbits enclosed by the third separatrix belong to electrons which are rejected (accelerated) by the ponderom otive force of the laser pulse. Such rejection is possible because the laser pulse has the speed $y_{k} < 1$ and the wake eld potential (X) always grows slower than the a(X) on the laser pulse front. Using series expansions of functions a(X) and (X) about the point $X = X_{f}$, $a(X_{f} +) = a_{f} + a_{f} 2 = 2 + o(3)$, $(X_{f} +) = k_{p}^{2} p_{p}^{2} (1 - 2) a_{1}^{2} 4 = 24 + a_{1}a_{2} 5 = 40 + o(6)$, where $a_{1} = a^{0}(X_{f})$, $a_{2} = a^{00}(X_{f})$, we can estimate the \ponderom otive" basin thickness, which is the energy dijerence between the upper and lower branches of the \ponderom otive" separatrix

at $j_0^0(X_f)j = 1$, $j_0^{\infty}(X_f)j = 1$, and 1, ph = 1. The ponderom otive acceleration a ects only those electrons that m ove in the same direction as the laser pulse and whose velocity is slightly less than ph. The acceleration gain turns out to be rather sm all, because the ponderom otive and electrostatic potentials alm ost com pletely com pensate each other. However, it is still not zero even with the ideal G aussian pulse; the maximum e ect is reached when the laser pulse has a sharp front.

We exam ine the energy spectrum change of an electron bunch injected into the rst period of the wake eld wave onto the \nunaway" separatrix, Fig. 1(c). When a relatively long, initially quasi-monoenergetic, bunch is injected from the singular point X_s and accelerated in the rst period of the wake eld wave, its particles are distributed along the \nunaway" separatrix with some density N (X). As a result, the particle energy spectrum broadens from the initial energy $E_{inj} = ph$ 1 to the cut-o (maximum) energy E. Besides these two limits, the spectrum can have a peculiarity at E_f , Eq. (9). Near the top of the separatrix the particle energy has a parabolic dependence on X, E(X)' E_m (1 (X) $X_t)^2 = 2$), where $2 = 2E_m = E^{(0)}(X_t)$, as it follows from Eqs. (6), (7). Hence the energy spectrum near the cut-o energy is

where $E < E_m$. Assuming that the density N (X) of the particle distribution along the separatrix is smooth enough at X = X_t, we see that the spectrum has an integrable singularity. If the particles are arranged uniform ly on the separatrix, the spectrum, despite its singularity, has rather large spread, e.g. a half of the particles occupies the energy interval $3E_m = 4.6 E < E_m$.

In general, the bunch has some initial energy spread E.D uring acceleration it occupies some region around the separatrix in the plane (X; E). To estimate the bunch spectrum, we assume that the particles are distributed uniform by between two orbits which we approximate by parabolas E_1 (X) = E_m $E = \frac{1}{2} \times 2^2 = 2$ and E_2 (X) = $E_m \times 2^2 = 2^2$. Correspondingly, the particle distribution function is

where is the Heaviside step function ([] = 1 for > 0 and = 0 for < 0), \mathbb{N} is the number of particles in the bunch. Then the energy spectrum is

where the square root must be set to zero if its argument is negative. In the limit E ! 0 this spectrum tends to $dN = dE = N_b$ $(E_m \ E) = 2$ $\overline{E_m \ (E_m \ E)}$, which is equivalent to Eq. (13) at $N_b = N \ (X_t)$. The sum of the spectrum (13) over the range of E_m varying from E_m E to E_n weighted with $\overline{E_m}$ yields Eq. (15). Both the spectra (13) and (15) are shown in Fig. 2.

The above-stated analysis concerns the phase portrait of a negatively charged particle (electron). In this paragraph we make digression considering the case of a positively charged particle, positron. In this case form ulae (4)-(6) remain valid with the substitution !. The phase portrait of the positron in the same wake eld and laser eld as above is shown in Fig. 1(d). In the wake eld, the electron's points of equilibrium correspond to the positron's singular points (for su ciently short laser pulse). The positron injected from the singular point into the second cycle of the wake eld returns back to the same singular point. In the rst half-cycle of the wake eld, in contrast to the case of the electron, both forces acting on the positron (the wake eld electrostatic force and the laser pulse ponderom otive force { pull the positron in the same direction (\forward"). Therefore we see a wide \ponderom otive" basin in which the orbits with initialm omentum $_{ph \ ph} > p_{x,pos} > \frac{2}{ph} \quad ph \quad pxpos + \quad \frac{1}{ph} \frac{P}{1 + a_{p,pos}^2} \quad \frac{2}{ph} \quad \frac{1}{ph} \frac{P}{1 + a_{p,pos}^2} \quad \frac{2}{ph} \quad \frac{1}{ph} = \frac{1}{ph} \frac{P}{ph} = \frac{1}{ph} = \frac{1}$

in accordance with Eqs. (6), (11). Here the limiting values of the positron momentum and energy in the \ponderomotive" basin are de ned via the wake eld potential and the laser amplitude a taken at the singular point ξ_{pos} , a non-trivial solution to the equation

The momentum of the lower branch of the \ponderom otive" separatrix is negative at $p_{phos} + \frac{1}{ph} \frac{p}{1 + a_{ppos}^2} > 1$, then the positron initially at rest is accelerated up to momentum 2 p_{ph}^2 and energy 2 $\frac{2}{ph} \frac{2}{ph}$, in accordance with Eqs. (10), (11). Thus even the \background" positrons, introduced externally or created in the laser-plasm a interaction, are substantially accelerated. In the limit of a long laser pulse (l_p wf), the maximum energy (16) becomes $(1 + p_{ph})^2 p_{ph}^2 a_0$, since p_{ppos} a) in this limit.

In conclusion, in the st cycle of the Langmuir wave in the wake of the short relativistically strong laser pulse electrons have at least three separatrices: on the \nunaway" separatrix the electron overtakes the wake eld and the laser pulse, on the \con ned" separatrix it moves together with the laser pulse and the \ponderom otive" separatrix places quite tight lim it for the ponderom otive acceleration. In contrast to electrons, positrons see the wake eld and the laser pulse ponderom otive force acting in the same direction. It is shown that the energy spectrum of the initially m ono-energetic particle bunch spread about the top of the separatrix has a typical localized shape / $(E_m = E)^{1=2}$ with a sharp cut-o
