M etastable C ongested States in M ultisegm ent Tra c C ellular A utom aton

We investigate a simplemultisegm ent cellular autom aton model of trac ow. With the introduction of segment-dependent acceleration probability, metastable congested states in the intermediate density region emerge, and the initial-state dependence of the ow is observed. The essential feature of three-phased structure empirically found in real-world trac ow is reproduced without elaborate assumptions.

I. IN TRODUCTION

The cellular autom aton m odel has established itself as a standard in the analysis of tra c ow with its sim – plicity, a nity to computer simulations, and also with its extendibility to handle the realistic tra c [1, 2]. A particularly appealing aspect is its capability to capture the essential characteristics of the tra c ow with very few system parameters, which is a surprising economy of assumptions. With further assumptions for the adoption to the speci c cases, the model is shown to be capable of reproducing down to the ne details of tra c ow in various settings, and it has been used for the analysis of real-life tra c with great success in past decade [3].

Lost in this process of elaboration, how ever, is the elegance of generality which the original standard model possesses. There is an obvious generic feature of the trafc ow that is beyond the reach of original model, but appears to await the explanation with a simple model. That is the three phase structure. In a typical trac, the low and high density regions show the free motion and tra c jam. In the fundam ental diagram of tra c, that plots the ux against the density, they are respectively represented by the increasing and decreasing lines, both of which are reproduced well with the standard model. In the interm ediate density, how ever, em pirical data indicate the existence of the third phase, in which there is no clear single line in the fundam ental diagram , but the points are scattered in broad region, indicating the existence of the uctuation in the trac ow.

In this article, we intend to show that this third phase appears in a very simple extension of the standard model that includes segments which has dierent system param eters. These segments are introduced to represent the natural bottlenecks { narrow road segments, hilly segments, a segment under construction, etc. { that are ubiquitous in real-life trac. We base our discussion primarily on numerical simulations and supplement them with simple intuitive physical arguments.

It has been recognized for some time that the uctuation in the trac ow is closely related to the the appearance of the metastable states [4, 5, 6]. We nd that the emergence of the third phase is also a direct result of the m etastable states that appear with a m inim al assumption in ourm odel.

II. TRAFFIC MODEL W ITH PROBABILISTIC ACCELERATION IN MULTI-SEGMENTED ROAD

We rst lay out our model. A road is divided into a one-dimensional array of L cells on which M cars are placed. The location (i.e. cell number) and the velocity of the cars are represented by integers x_i and v_i with the car index i = 1;2; ...; M . Cars are indexed in ascending order to the direction of the motion without overlap; $x_1 < x_2 < \dots < x_M$. The road is considered to be circular, so that the (L + 1)-th cell is identi ed with the st cell. The road is subdivided into S segments $S_1 = fx_1 < x = L_1 g, S_2 = fx_1 < x$ $L_1 + L_2 q_1 ...,$ $S_S = fx J_1 + \dots + L_{S-1} < x$ Lg, with the constraint on the sub-length $L_1 + \dots + L_s = L$. Each segment, s = 1; ...; S, is assigned its own maximum velocity U_s and non-acceleration probability R_s. The tim e evolution of the system in discrete time steps t! t+1 is described by the following three consecutive updating for v_i and x_i 2 S_s;

1) Probabilistic acceleration :

The updating is done in parallel for all cars i = 1;2; :::M :N am ely, the current position of the preceding car is used to calculate the distance $x_{i+1} = x_i = 1$.

The model can be thought of as a variant of the standard Nagel-Schreckenberg (NS) model in that it follows the acceleration and deceleration step-by-step. In fact, if we change the ordering of \breaking" and \random deceleration" in the standard NS model, we obtain a model where cars accelerate, and then random ly decelerate. The model then becomes almost identical to ours, apart from the treatm ent of the cars running at the m axim um velocities. This inverting of the order e ectively prohibits the cars running in the jam from random deceleration, thus models the \heightened alertness" of drivers who have the preceding cars in their close sight. Our model is also related to the Fukui-Ishibashi (FI) model in that both employ probabilistic acceleration, which is in contrast to the NS model that treats the process by splitting it into acceleration and probabilistic deceleration.

U sing the second step of the rule (1), we may de ne a jam as a block of cars in which the distance of neighboring cars is below the maximum velocity, A crucial feature of our model is the existence of the metastable block of jam made up of equi-spaced cars. This is a direct result of our model in which no further random deceleration occurs for cars inside the jam. The only limiting factor of the growth of this block is the percolation at the head of the block whose rate is proportional to $(1 R_s)$. This feature captures off observed self-form ing bottleneck of slow-moving cars in single-lane roads in real-life tra c. This could be regarded as a main justi cation for devising yet another variant of tra c cellular autom aton model.

III. NUMERICALRESULTS

W e perform num erical simulations on the model presented above with one segment, two-segments, and six segments cases, the last one being the model of generic realistic tra c.

The macroscopic characteristics of trac systems are best summarized with so-called fundamental diagram, which is the trac ux F plotted as the function of trac density , each of which are dened as

Here, hit stands for the average over m any time steps t.




FIG.1: The fundam ental diagram s of our m odel. The nonacceleration rate R is varied from R = 0 to 0.3 as indicated in the graph. The maximum velocity is xed at U = 8 for all cases. The size of the road is set to be L = 200.

We rst show the results of the single-segment trac in FIG.1. The size of the road is set to be L = 200and the maximum velocity is chosen to be U = 8. Fundamental diagram with various non-acceleration rates R are shown. Each point in the graph represents the result of 20,000 iterations starting from a single random initial con guration. In the diagram, we observe three distinct regimes of trac ow. In between the free trac regime at low density and jamming regime at high density, there is a distinct third regime at intermediate density. Here, the ux displays the sensitive dependence on the initial condition, which is shown in the graph as jittery structures.

It is certainly possible to consider the ensemble of initial conditions among which the results could be averaged




FIG.2: The fundam ental diagram s of two segment model with a common non-acceleration rates $R_1 = R_2 = 0$ are shown. The maximum velocity for the rst segment is xed at $U_1 = 8$, and it is varied as $U_2 = 8$, 3 and 1 for the second segment.

out to obtain sm ooth curves. However, we can also argue that jittery structure re ects a special feature of the model in which there can be metastable states that result in di erent ux for track with same density but di erent initial con gurations. We stress that, at this stage, the existence of the intermediate region is a result of nite size e ect. This can be easily proven by the explicit numerical calculation showing the shrinking of this region with larger L. At the lim it L ! 1, fundamental diagram with two phases with discontinuous F () is obtained. However, this intermediate region develop into a distinct phase when there are more than two segments, S 2 in a road.

That fact is clearly shown in FIG.2, in which the fundam ental diagram of two segment model with L = 200 which is split into $L_1 = 160$ and $L_2 = 40$ is shown. Here, we set a common non-acceleration rate $R_1 = R_2 = 0$ and dimension mathematical dimension of the second mathematical second mathematical second mathematical second second mathematical second second mathematical second seco

segm ent, $U_1 > U_2$. By the inspection, we sense the existence of analytical solutions represented by the straight lines connecting = 0, = 1 both at F = 0 and two critical densities ^y and [?] both at the plateau ux F[?]. At the critical density ^y, the block of jam with $v_i = U_2$ and car spacing x_{i+1} $x_i = U_2 + 1$ is form ed in the second segm ent while the tra c is at full speed $v_i = U_1$ with car spacing $U_1 + 1$ in the rst segm ent. At [?], however, the jam with $v_i = U_2$ lls the entire system . W ith elem entary calculations, we obtain the critical densities in the form s

At the plateau region y ?, the ow is limited by the block of jam with car spacing $U_2 + 1$ which now extends into the high maximum velocity region, in which drivers perceive the block as bottleneck congestion. The length of the block is determined by the requirement that \free tra c" segment has the density that corresponds to the same ux with the block, (6).

Note that the di erence between two critical densities y and $^{?}$ persists at the continuum limit L_{s} ! 1 if the ratio $L_{1}=L_{2}$ is kept constant. This clearly shows that the appearance of the interm ediate plateau region is not the artifact of the discretization nor the niteness of the model. Thus this third region can be legitim ately regarded as the third phase. The three phase structure thus obtained is rem iniscent to that obtained with the stop-and-go dynam ics [8]. The metastable characteristics of the blocks is essential in obtaining this structure.




FIG.3: The fundam ental diagram s of two segment model with a common maximum velocity $U_1 = U_2 = 8$ are shown. The non-acceleration rates for the rst segment is xed at $R_1 = 0:1$ and that of second segment is varied as $R_2 = 0:4$, 0:6 and 0.8. Line connecting the data points are drawn solely to indicate the uctuation between discretized ux: There are no points in-between the value speci ed by (7) in the interm ediate density region.

The situation becomes even more interesting when different non-acceleration rates are assigned to the dierent segments. In FIG.3, the fundamental diagrams with a common U_s and the dierent R_s are shown. Actual values are chosen to be $U_1 = U_2 = 8$, $R_1 = 0.1$ and $U_2 = 0.6$. Here, in between the free trac phase at low density region < y and jamming phase at high density region > ?, we clearly observe an intermediate phase where there is wild oscillations in F (). Dierent outcome is obtained from dierent initial conguration. A most striking feature, however, is the fact that, in this intermediate phase, the values of the ux F is discretized at the fractions

The cause of this discretization and uctuation is again the appearance of m etastable blocks composed of equipapaced carsm oving in common velocity V. The road segment with high-R $_{\rm S}$ hinders the percolation of the blocks,




FIG.4: The ow patterns of two segment model at = 0:3. The system parameters are $U_1 = U_2 = 8$, $R_1 = 0:1$ and $R_2 = 0:5$. Dierent initial conditions result in dierent metastable states: The graph on the left hand side shows the block of jam with $v_i = 4$, while the right hand side shows the one with $v_i = 2$.

and helps the developm ent of its aggregation. Thus, in e ect, the high R $_{\rm S}$ segm ent works very similar to the low $U_{\rm S}$ segm ent in previous example. A crucial di erence, how ever, is that the block velocity V is not preset. M etastable blocks with di erent V can appear and dom - inate depending on the initial condition, which results in non-unique value for F at each .

O ur claim of the appearance of plural metastable bottleneck blocks are corroborated by the ow pattern shown in FIG. 4, which is obtained from the same simulation as in FIG. 3. FIG. 4(a) and FIG. 4(b) are the results of same parameters but dierent initial conditions. clearly, metastable congestion blocks with dierent internal car spacing (thus dierent block velocities) are becoming the limiting factors of the total ow.

In order to further clarify the initial-condition dependence, we show the results of two di erent types of de -




FIG.5: The fundamental diagram of two segment model with a common maximum velocity $U_1 = U_2 = 8$ and dierent non-acceleration rates $R_1 = 0.1$, $R_2 = 0.6$. The initial condition is taken to be a single cluster.




FIG. 6: Same as FIG. 5 except that the initial condition is taken to be uniform ly distributed, equally spaced cars.




FIG. 7: The fundam ental diagram of two segment model with a common maximum velocity $U_1 = U_2 = 8$ and di erent non-acceleration rates $R_1 = 0.1$, $R_2 = 0.6$. The ux at each density is obtained by averaging over 200 di erent initial states.




FIG.8: The fundam ental diagrams of \generic" six segment m odel with a common maximum velocity $U_1 = \dots = U_6 = 8$ are shown. The non-acceleration rates for the odd segments is xed at $R_1 = R_3 = R_5 = 0.1$, and that of even segment is varied as $R_2 = 0.4$, $R_4 = 0.5$, and $R_6 = 0.6$. The lengths of the segments are $L_1 = 355$, $L_2 = 30$, $L_3 = 300$, $L_4 = 60$, $L_5 = 110$ and $L_6 = 45$. Here, results from a single random initial con guration is shown for each value of the density, as in FIG.3.

nite initial states: In FIG. 5, the fundam ental diagram of tra c ow calculated from single cluster initial states is shown. In FIG. 6, the initial condition is now a uniform distribution, m eaning equally spaced cars spread over the whole road. In both cases, a common maximum velocities $U_1 = U_2 = 8$ and di erent non-acceleration rates $R_1 = 0:1$ and $R_2 = 0:6$ are used. Even with these wellde ned non-random initial conditions, they both show the uctuating ux as the functions of density. These diagram s unam biguously show that the discretization is the results of random appearance of di erent m etastable states. In FIG. 7, the result of average over di erent initial condition is shown. The system parameters are the same as those in FIG. 5 and FIG. 6. The ux now com es in between the discretized value found in the case of single initial condition. This is what we should expect when the fundam ental diagram is drawn from the accumulation of actual data from real-life tra c.

W e now move on to show that the existence of a phase with uctuating discretized ux is not a speci c result of the two-segment model, but a feature generic to multisegment trac in our model. In FIG.8, we present the results of six segment tra c, which is brought up as a toy model of realistic single-lane \county-road" trafc. Road length is set to be L = 900. The road is now made up of the \norm al" segments s = 1;3;5 with $R_1 = R_3 = R_5 = 0:1$, and the bottleneck segments s = 2;4;6, each having $R_2 = 0:4$, $R_4 = 0:5$ and $R_6 = 0:6$. The length of each segments are set to be $L_1 = 355$, $L_2 = 30, L_3 = 300, L_4 = 60, L_5 = 110 \text{ and } L_6 = 45.$ These arbitrary numbers are chosen to make this case a generic example. A common maximum velocity U $_{\rm s}$ = 10 is used for all s. We nd the result to be essentially indistinguishable to the case of two segments. In a sense,

this is to be expected because if several jamming blocks are formed on a road with many segments, the one with smallest ux among them will eventually absorb the rest and becomes the limiting bottleneck, thus determine the total ow of the system. In this sense, analytical results of two segments with a common non-acceleration rate, (4)-(6), showing the existence of the \quantized" ux is the basis of all subsequent results showing them etastable jamming blocks.

IV. SUMMARY AND PROSPECTS

In real-life tra c, we often experience di erent mode of congestion on di erent days on sam e roads with sim ilar number of cars. In this article, we have shown that this puzzling feature is captured with a very sim ple cellular autom aton model. O ur model has a property of self-aggregating block of jam. This jam functions as a dynam ical bottleneck, and leads to the existence of the third phase at interm ediate density where visually striking non-unique ux is observed for a given density. It is our view, that am ong the multiple possible variants of original NS models, ones with such property are de nitely worth further attention.

On the other hand, we want to make clear that the introduction of the alternative new rule (1) is not the prerequisite for the existence of the third phase. In fact, it can be shown through the num erical simulations that the three phase structure is already present in multisegment model with standard NS rules. With our modied rule that allows the formation of metastable blocks of jam, how ever, the new phase obtains distinct characteristics of discretized ux.

The existence of m etastable states has been already observed in several tra c ow models [4, 5, 6] that e ectively am ount to introduce som e extra rules to the standard Nagel-Schreckenberg model. In particular, early indication of discretized ux can be observed already in [6]. Our model is arguably the simplest of such extensions since it actually reduces the number of rules. More im portant point than the sm aller num ber of rules is that, with our model, we are able to show a clear connection between the metastable states and the newly found interm ediate phase featuring the discretized ux. In light of our results, it is suspected that the existence of the metastable states observed in elaborate realistic tra c m odels do not com e from detailed m odel-speci c assum ptions but have a simple dynam ics behind it which is captured in our m in im alm odel.

The form ation of m etastable clusters is recently observed in a cellular autom aton m odel of ants' trail [9]. It would be bene cial to compare our results with those of this work to gain a better insight into the dynam ics of block of jam.

It is worth mentioning that the state of the system in the newly identied third regime at intermediate density shares many common features with so-called self-organized criticality [10]. It is as though the system is at critical point for extended range of parameter values with various competing metastable states formed spontaneously without ne-tuning of the system. It should be interesting to check, for example, the existence of 1/f type uctuation on some measure, a hall mark of self-organized criticality, to further clarify the connection.
