# M etastable C ongested States in M ultisegm ent Tra c C ellular A utom aton

#### Abstract

We investigate a sim plem ultisegm ent cellular autom aton modeloftra cow. W ith the introduction of segm ent-dependent acceleration probability, $m$ etastable congested states in the interm ediate density region em erge, and the in itial-state dependence of the ow is observed. The essential feature of three-phased structure em pirically found in real-w orld tra $c$ ow is reproduced w ithout elaborate assum ptions.

## I. IN TRODUCTION

T he cellular autom aton $m$ odel has established itself as a standard in the analysis of tra $c$ ow $w$ ith its sim plicity, a nity to com puter sim ulations, and also w ith its extendibility to handle the realistic tra c [lll in A particularly appealing aspect is its capability to capture the essential characteristics of the tra $c$ ow w th very few system param eters, which is a surprising econom y of assum ptions. $W$ th further assum ptions for the adoption to the speci c cases, the $m$ odel is show $n$ to be capable of reproducing down to the ne details of tra $c$ ow in various settings, and it has been used for the analysis of real-life tra cw ith great success in past decade [\$].

Lost in this process of elaboration, how ever, is the elegance of generality which the original standard $m$ odel possesses. There is an obvious generic feature of the trafc ow that is beyond the reach of originalm odel, but appears to aw ait the explanation w ith a sim ple model. $T$ hat is the three phase structure. In a typicaltra $c$, the low and high density regions show the free $m$ otion and tra $c j a m$. In the fiundam ental diagram of tra $c$, that plots the ux against the density, they are respectively represented by the increasing and decreasing lines, both of which are reproduced well w ith the standard $m$ odel. In the interm ediate density, how ever, em pirical data indicate the existence of the third phase, in which there is no clear single line in the fundam ental diagram, but the points are scattered in broad region, indicating the existence of the uctuation in the tra $c$ ow.

In this article, we intend to show that this third phase appears in a very sim ple extension of the standard $m$ odel that includes segm entsw hich has di erent system param eters. T hese segm ents are introduced to represent the natural bottlenecks \{ narrow road segm ents, hilly seg$m$ ents, a segm ent under construction, etc. \{ that are ubiquitous in real-life tra c. W e base our discussion pri$m$ arily on num erical sim ulations and supplem ent them w ith sim ple intuitive physical argum ents.

It has been recognized for some time that the uctuation in the tra $c$ ow is closely related to the the
 that the em ergence of the third phase is also a direct re-
sult of the $m$ etastable states that appear $w$ ith a $m$ in im al assum ption in ourm odel.

> II. TRAFFIC MODELW ITH PROBABILISTIC
> ACCELERATION IN M U LT I-SEGMENTED ROAD

W e rst lay out our model. A road is divided into a one-dim ensional array of $L$ cells on which $M$ cars are placed. T he location (i.e. cell num ber) and the velocity of the cars are represented by integers $x_{i}$ and $v_{i} w$ ith the car index $i=1 ; 2 ;::: ; \mathrm{M}$. Cars are indexed in ascending order to the direction of the $m$ otion $w$ thout overlap; $\mathrm{x}_{1}<\mathrm{x}_{2}<:::<\mathrm{x}_{\mathrm{M}}$. The road is considered to be circular, so that the ( $L+1$ )-th cell is identi ed with the st cell. The road is subdivided into $S$ segm ents $S_{1}=\mathrm{fxj} 0<\mathrm{x} \quad \mathrm{L}_{1} \mathrm{~g}, \mathrm{~S}_{2}=\mathrm{fx} \mathrm{L}_{1}<\mathrm{x} \quad \mathrm{L}_{1}+\mathrm{L}_{2} \mathrm{~g}, \ldots$, $S_{S}=\mathrm{fx}_{\mathrm{L}}+:::+\mathrm{L}_{\mathrm{S}} \mathrm{I}_{1}<\mathrm{x} \quad \mathrm{Lg}$, w th the constraint on the sub-length $L_{1}+:::+L_{S}=L$. Each segment, $s=1 ;::: ; S$, is assigned its own $m$ axim um velocity $U_{s}$ and non-acceleration probability $R_{s}$. The tim e evolution of the system in discrete tim e steps $t$ ! $t+1$ is described by the follow ing three consecutive updating for $v_{i}$ and $x_{i}$ $2 S_{s}$;

1) P robabilistic acceleration :

The updating is done in parallelfor allcars $i=1 ; 2 ;:: \mathrm{M}$ : N am ely, the current position of the preceding car is used to calculate the distance $x_{i+1} \quad x_{i} \quad 1$.
$T$ he $m$ odel can be thought of as a variant of the standard N agel-Schreckenberg ( $\mathrm{N}, \mathrm{S}$ ) m odel in that it follow s the acceleration and deceleration step-by-step. In fact, if we change the ordering of \breaking" and \random deceleration" in the standard NS m odel, we obtain a m odelw here cars accelerate, and then random ly decelerate. The $m$ odel then becom es alm ost identical to ours,
apart from the treatm ent of the cars nunning at the $m$ axim um velocities. This inverting of the order e ectively prohibits the cars running in the jam from random deceleration, thusm odels the \heightened alertness" ofdrivers who have the preceding cars in their close sight. O ur m odel is also related to the Fukui-Ishibashi (FI) m odel in that both em ploy probabilistic acceleration, which is in contrast to the NS m odel that treats the process by splitting it into acceleration and probabilistic deceleration.

U sing the second step of the rule $\left[\overline{1} \overline{1}_{1}\right)$, we m ay de ne a jam as ablock ofcars in which the distance ofneighboring cars is below the m axim um velocity, A crucial feature of our $m$ odel is the existence of the $m$ etastable block of jam $m$ ade up of equi-spaced cars. This is a direct result of our $m$ odel in which no further random deceleration occurs for cars inside the jam. The only lim iting factor of the grow th of this block is the percolation at the head of the block whose rate is proportional to ( $1 \quad R_{s}$ ). This feature captures oft observed self-form ing bottleneck of slow m oving cars in single-lane roads in real-life tra $c$. $T$ his could be regarded as a $m$ ain justi cation fordevising yet another variant of tra c cellular autom aton $m$ odel.

## III. NUMERICALRESULTS

W e perform num erical sim ulations on the model presented above with one segm ent, two-segm ents, and six segm ents cases, the last one being the $m$ odel of generic realistic tra c.

The $m$ acroscopic characteristics of tra c system s are best sum $m$ arized $w$ th so-called fundam ental diagram, which is the tra c uxF plotted as the function oftra c density , each ofwhich are de ned as

$H$ ere, $\mathrm{hi}_{\mathrm{t}}$ stands for the average over $m$ any tim e steps $t$.
$W$ e rst show the results of the single-segm ent tra $c$ in FIG.1. The size of the road is set to be $L=200$ and the maxim um velocity is chosen to be $U=8$. Fundam ental diagram w ith various non-acceleration rates $R$ are show $n$. Each point in the graph represents the result of 20,000 iterations starting from a single random initial con guration. In the diagram, we observe three distinct regim es of tra c ow. In betw een the free tra c regim e at low density and jam $m$ ing regim e at high density, there is a distinct third regim e at interm ediate density. H ere, the ux displays the sensitive dependence on the intial
 tures.

It is certainly possible to consider the ensem ble of initialconditions am ong which the results could be averaged

out to obtain sm ooth curves. H ow ever, we can also argue that \#\#ttery structure re ects a special feature of the $m$ odel in which there can be $m$ etastable states that result in di erent ux for tra cs with same density but di erent initial con gurations. W e stress that, at this stage, the existence of the interm ediate region is a result of nite size e ect. This can be easily proven by the explicit num erical calculation show ing the shrinking of this region w ith larger L . At the $\lim$ it L ! 1 , fundam ental diagram w ith two phases w ith discontinuous $F()$ is obtained. H ow ever, this interm ediate region develop into a distinct phase when there are $m$ ore than two segm ents, $S \quad 2$ in a road.
$T$ hat fact is clearly show $n$ in F IG . 2, in which the fundam ental diagram of two segm ent $m$ odel $w$ th $L=200$ which is split into $L_{1}=160$ and $L_{2}=40$ is show $n$. H ere, we set a com m on non-acceleration rate $\mathrm{R}_{1}=\mathrm{R}_{2}=0$ and di erent $m$ axim um velocities $U_{1}$ and $U_{2}$ for tw o segm ents. $W$ e assum e the sm allerm axim um velocity for the second
segm ent, $\mathrm{U}_{1}>\mathrm{U}_{2}$. By the inspection, we sense the existence of analytical solutions represented by the straight lines connecting $=0,=1$ both at $\mathrm{F}=0$ and two critical densities y and ? both at the plateau ux $\mathrm{F}^{\text {? }}$. At the critical density ${ }^{\mathrm{y}}$, the block of jam w th $\mathrm{V}_{\mathrm{i}}=\mathrm{U}_{2}$ and car spacing $x_{i+1} \quad x_{i}=U_{2}+1$ is form ed in the second segm ent while the tra $c$ is at full speed $v_{i}=U_{1} w$ th car spacing $U_{1}+1$ in the rst segm ent. At ?, how ever, the jam $w$ th $V_{i}=U_{2}$ lls the entire system. W ith elem entary calculations, we obtain the critical densities in the form $s$

W e also obtain the plateau ux

At the plateau region $y \quad ?$, the ow is lim ited by the block of jam w ith car spacing $U_{2}+1$ which now extends into the high $m$ axim um velocity region, in which drivers perceive the block as bottleneck congestion. T he length of the block is determ ined by the requirem ent that $\backslash$ free tra $\mathrm{C"}$ segm ent has the density that corresponds to the same ux w ith the block, ( $\overline{6} \bar{\sigma}^{\prime}$ ).
$N$ ote that the di erence betw een two critical densities ${ }^{y}$ and ? persists at the continuum lim $\operatorname{it}_{\mathrm{s}}$ ! 1 if the ratio $\mathrm{L}_{1}=\mathrm{L}_{2}$ is kept constant. This clearly show s that the appearance of the interm ediate plateau region is not the artifact of the discretization nor the niteness of the m odel. Thus this third region can be legitim ately regarded as the third phase. The three phase structure thus obtained is rem iniscent to that obtained with the stop-and-go dynam ics [id]. The $m$ etastable characteristics of the blocks is essential in obtaining this structure.
$T$ he situation becom es even $m$ ore interesting $w$ hen different non-acceleration rates are assigned to the di erent segm ents. In F IG. 3, the fundam ental diagram $s$ w ith a com $m$ on $U_{s}$ and the di erent $R_{s}$ are show $n$. A ctual values are chosen to be $U_{1}=U_{2}=8, R_{1}=0: 1$ and $\mathrm{U}_{2}=0: 6$. Here, in betw een the free tra c phase at low density region < y and jam $m$ ing phase at high density region > ? , we clearly observe an interm ediate phase where there is wild oscillations in F (). D i erent outcome is obtained from di erent initial con guration. A m ost striking feature, how ever, is the fact that, in this interm ediate phase, the values of the ux $F$ is discretized at the fractions

The cause of this discretization and uctuation is again the appearance of $m$ etastable blocks com posed of equispaced cars $m$ oving in com $m$ on velocity $V$. T he road seg$m$ ent $w$ th high $R_{s}$ hinders the percolation of the blocks,

and helps the developm ent of its aggregation. Thus, in e ect, the high $R_{s}$ segm ent works very sim ilar to the low $-U_{s}$ segm ent in previous exam ple. A crucial di erence, how ever, is that the block velocity $V$ is not preset. $M$ etastable blocksw th di erent $V$ can appear and dom inate depending on the initialcondition, which results in non-unique value for $F$ at each.

O ur claim of the appearance of pluralm etastable bottleneck blocks are corroborated by the ow pattem shown in F IG . 4, which is obtained from the sam e sim ulation as in FIG.3. FIG. 4 (a) and FIG. 4 (b) are the results of sam e param eters but di erent initial conditions. clearly, $m$ etastable congestion blocks with di erent intemal car spacing (thus di erent block velocities) are becom ing the lim iting factors of the total ow .

In order to further clarify the initial-condition dependence, we show the results of tw o di erent types of de -

nite initialstates: In F IG .5, the fundam entaldiagram of tra c ow calculated from single cluster initial states is shown. In FIG . 6, the initial condition is now a uniform distribution, $m$ eaning equally spaced cars spread over the whole road. In both cases, a com $m$ on $m$ axim um velocities $U_{1}=U_{2}=8$ and di erent non-acceleration rates $R_{1}=0: 1$ and $R_{2}=0: 6$ are used. Even w ith these wellde ned non-random initial conditions, they both show the uctuating $u x$ as the functions of density. These diagram s unam biguously show that the discretization is the results of random appearance of di erent $m$ etastable states. In FIG.7, the result of average over di erent initial condition is show. The system param eters are the same as those in FIG. 5 and FIG.6. The ux now com es in betw een the discretized value found in the case of single initial condition. This is what we should expect when the findam ental diagram is drawn from the accum ulation of actual data from real-life tra c.

W e now $m$ ove on to show that the existence of a phase w ith uctuating discretized ux is not a speci c result of the two-segm ent $m$ odel, but a feature generic to m ultisegm ent tra c in our model. In F IG. 8, we present the results of six segm ent tra c, which is brought up as a toy $m$ odel of realistic single-lane \county-road" traf-
c. Road length is set to be $L=900$. The road is now $m$ ade up of the $\backslash$ norm al" segm ents $s=1 ; 3 ; 5 \mathrm{w}$ th $R_{1}=R_{3}=R_{5}=0: 1$, and the bottleneck segm ents $s=2 ; 4 ; 6$, each having $R_{2}=0: 4, R_{4}=0: 5$ and $R_{6}=0: 6$. $T$ he length of each segm ents are set to be $L_{1}=355$, $\mathrm{L}_{2}=30, \mathrm{~L}_{3}=300, \mathrm{~L}_{4}=60, \mathrm{~L}_{5}=110$ and $\mathrm{L}_{6}=45$. $T$ hese arbitrary num bers are chosen to m ake this case a generic exam ple. A com $m$ on $m$ axim um velocity $U_{s}=10$ is used for all s. We nd the result to be essentially indistinguishable to the case of two segm ents. In a sense,
this is to be expected because if several jam $m$ ing blocks are form ed on a road $w$ ith $m$ any segm ents, the one $w$ ith sm allest ux am ong them willeventually absorb the rest and becom es the lim iting bottleneck, thus determ ine the total ow of the system. In this sense, analytical results of tw o segm ents $w$ th a com $m$ on non-acceleration rate, (4)-(6), show ing the existence of the \quantized" ux is the basis of allsubsequent results show ing them etastable jam m ing blocks.

## IV. SUM MARYAND PROSPECTS

In real-life tra c, we often experience di erent $m$ ode of congestion on di erent days on sam e roads $w$ ith sim ilar num ber of cars. In this article, we have show $n$ that this puzzling feature is captured $w$ ith a very sim ple cellular autom aton $m$ odel. Our model has a property of self-aggregating block of jam. This jam functions as a dynam ical bottleneck, and leads to the existence of the third phase at interm ediate density where visually striking non-unique ux is observed for a given density. It is our view, that am ong the multiple possible variants of originalN S m odels, ones w ith such property are de nitely w orth further attention.

O n the other hand, we want to $m$ ake clear that the introduction of the altemative new rule [11) is not the prerequisite for the existence of the third phase. In fact, it can be show $n$ through the num ericalsim ulations that the three phase structure is already present in multisegm ent m odel with standard NS rules. W ith our modi ed rule that allow s the form ation of $m$ etastable blocks of jam, how ever, the new phase obtains distinct characteristics of discretized ux.

The existence of $m$ etastable states has been already observed in severaltra c ow m odels [ 4 tively am ount to introduce som e extra rules to the standard N agel-Schreckenberg m odel. In particular, early indication of discretized ux can be observed already in [id]. O ur m odel is arguably the sim plest of such extensions since it actually reduces the num ber of nules. M ore im portant point than the sm aller num ber of rules is that, w ith our model, we are able to show a clear connection betw een the $m$ etastable states and the new ly found interm ediate phase featuring the discretized ux. In light of our results, it is suspected that the existence of the $m$ etastable states observed in elaborate realistic tra c m odels do not com efrom detailed $m$ odel-speci cassum $p-$ tions but have a sim ple dynam ics behind it which is captured in our minim alm odel.

The form ation of $m$ etastable clusters is recently $\mathrm{ob}-$ served in a cellular autom aton $m$ odel of ants' trail [19 would be bene cial to com pare our results $w$ th those of this work to gain a better insight into the dynam ics of block of jam .

It is worth $m$ entioning that the state of the system in the new ly identi ed third regim e at interm ediate density shares $m$ any com $m$ on features $w$ th so-called self-organized criticality $\left.[1]{ }_{1}^{1}\right]$. It is as though the system is at critical point for extended range of param eter values $w$ ith various com peting $m$ etastable states form ed spontaneously w thout ne-tuning of the system. It should be interesting to check, for exam ple, the existence of $1 / \mathrm{f}$ type uctuation on som e m easure, a hall $m$ ark of self-organized critically, to further clarify the connection.
