N um erical m odeling of quasiplanar giant w ater w aves

In this work we present a further analytical developm ent and a num erical in plem entation of the recently suggested theoretical model for highly nonlinear potential long-crested water waves, where weak three-dimensional elects are included as small corrections to exact two-dimensional equations written in the conform al variables [V P.Ruban, Phys. Rev. E 71, 055303 (R) (2005)]. Num erical experiments based on this theory describe the spontaneous form ation of a single weakly three-dimensional large-amplitude wave (alternatively called freak, killer, rogue or giant wave) on the deep water.

I. IN TRODUCTION

Roque waves are extrem ely high, steep and dangerous individual waves which som etim es appear suddenly on a sea surface am ong relatively low waves (see, for instance, the recent works [1, 2, 3], and references therein). The crest of a roque wave can be three or even more times higher than the crests of neighboring waves. Dierent physical mechanisms contribute to the rogue wave phenom enon: dispersion enhancem ent, geom etrical focusing, wave-current interaction [1], but the most important at the nal stage is the nonlinear self-focusing mechanism resulting in accumulation of the wave energy and momentum on the scale of a single wavelength [3]. For weakly m odulated periodic planar Stokes waves this mechanism leads to the well-known Benjam in-Feir instability [4, 5], generated by four-wave nonlinear resonant interactions 2! 2. This instability is predom inantly two-dimensional (2D), and it is dom inant for low amplitudes (h= 0:09 where h is the peak-to-trough height and is the length of the Stokes wave [6]). For larger steepness parameter h= , another, genuinely three-dim ensional (3D), instability becomes dominant, which is generated by ve-wave interactions 3 ! 2, and results in the well-known crescent, or \horse-shoe" wave patterns (see [7, 8, 9], and references therein). It is in portant that real ocean giant waves are observed in situations when this 3D instability is not principal, and all the waves are typically longcrested, corresponding to a narrow-angle Fourier spectrum. Thus, many essential features of a roque wave form ation can be observed already in purely 2D geom etry, as in the works by Zakharov and ∞ -workers [2, 3]. For instance, in Ref. [3] a num erical giant wave was com puted with the impressive spatial resolution of up to 2 10 points. Zakharov and co-workers simulated an exact system of dynam ic equations for 2D free-surface inviscid potential ows, written in terms of the so called conform al variables, which m ake the free boundary e ectively at (the corresponding exact 2D theory is described in Refs. [10, 11, 12, 13, 14, 15, 16]). W ith these variables, highly nonlinear equations of m otion for planar water waves are represented in an exact and compact form containing integral operators diagonal in the Fourier representation. Such integro-di erential equations are easy to treat num erically with m odern libraries for the discrete fast Fourier transform (FFT) as, for example, FFTW [17]. Recently, by introducing an additional conform al m apping, the exact 2D conform al description has been generalized to non-uniform and tim e-dependent bottom pro les, so that a very accurate 2D m odeling of nearcoastal waves and tsunam i-like processes has been possible [18, 19].

However, real sea waves are never ideally planar, and the second horizontal dimension might play an important role in the wave dynam ics. Various num ericalm ethods have been developed for nonlinear 3D surface gravity waves (see [9, 20, 21] for a review). Some of them are based on exact formulation of the problem (the boundary integralm ethod and itsm odi cations; see [22, 23, 24] and references therein), another approach uses approxim ate equations of m otion, as the Boussinesq-type m odels [25, 26], the equations derived by Matsuno [27], by Choi [28], the weakly nonlinear Zakharov equations [29, 30], or the equations for wave packets the nonlinear Schroedinger equation (NLS) and its extensions [31, 32, 33, 34]. The num erical methods based on exact equations are quite \expensive" and thus provide a relatively low spatial resolution (typically 128 64, as in the recent work [24] for essentially 3D waves). On the other hand, the applicability of the approximate equations is lim ited by the condition that the waves must not be too steep. To 11 this gap, som e new approximate, relatively com pact explicit equations of m otion for highly nonlinear 3D waves were needed as the basis for a new num erical m ethod. R ecently, as an extension of the exact conform al 2D theory, a weakly 3D conform altheory has been suggested [35], which is valid for steep long-crested waves. Equations of this theory contain 3D corrections of the order of = $(l_x = l_q)^2$, where l_x is a typical wave length, and

 l_q is a large transversal scale along the wave crests. In Ref. [35], the general case was considered, with a static nonuniform quasi-one-dimensional bottom prole. Since the corresponding general equations are rather involved, it is natural to focus on some simple particular cases in the rst place, for instance on the deep water limit. The purpose of the present work is a further development of the weakly 3D conform altheory and its numerical im plementation for them ost simple deep water case. Ourmain result here is that we have developed a numerical scheme based on FFT which is su ciently simple, accurate and fast simultaneously. As an application, we have simulated a freak wave formation with the nal resolution up to 16384 256.

This article is organized as follows. In Sec. II we adopt for the deep water limit the general weaky 3D fully nonlinear theory described in Ref. [35]. We also suggest some modi cation of the obtained dynamical system which results in the correct linear dispersion relation not only within a small region near the k_1 -axis, but in the whole Fourier-plane. In Sec. III we describe our numerical method and present numerical results for the problem of a rogue wave form ation. Finally, Sec. IV contains our sum mary and discussion.

II. W EAKLY 3D NONLINEAR THEORY

A. General rem arks

It is a well known fact that a principal di culty in the 3D theory of potential water waves is the general impossibility to solve exactly the Laplace equation for the velocity potential' (x;y;q;t),

In the traditional approach, the problem is partly solved by an asymptotic expansion of the kinetic energy K on a small parameter the steepness of the surface (see Refs. [30, 36, 38], and references therein). As the result, a weakly nonlinear theory is generated, which is not good to describe large-amplitude steep waves [see Ref. [38] for a discussion about the lim its of such theory; practically, the wave steepness ka (k is a wave num ber, a is an amplitude) should be not more than 0:1 (that is h= 0:1= 0:03)]. Below in this section we consider a di erent, recently developed theory [35] (adopted here for the case of in nite depth), which is based on another small parameter | the ratio of a typical length of the waves propagating along the x-axis, to a large scale along the transversal horizontal direction, denoted by q [alternatively, it is the ratio of typical wave num bers $k_{\alpha} = k_{x}$ in the Fourier plane $(k_{x}; k_{\alpha})$]. Thus, we de ne $= (l_{x} = l_{q})^{2}$ 1 and note: the less this parameter, the less our ow diers from a purely 2D ow, and the more accurate the equations are. A pro le y = (x;q;t) of the free surface and a boundary value of the velocity potential (x;q;t) ' (x; (x;q;t);q;t) are allowed to depend strongly on the coordinate x, while the derivatives over the coordinate q will be small: $j_q j_{qj}^{1=2}$, $j_q j_{qj}^{1=2}$.

B. Conform al variables in 3D

In the same m anner as in the exact 2D theory [10, 13], instead of the Cartesian coordinates x and y, we use curvilinear conform al coordinates u and v, which m ake the free surface e ectively at:

Equations (11) and (15) completely determ ine evolution of the system, provided the kinetic energy functional Kf ;Z;Zg is explicitly given. It should be emphasized that in our description a general expression for K remains unknown. How ever, under the conditions $j_{cg}j$ 1,

Here the combination (Z u) is written instead of Z just for convenience, as it is nite at the in nity. A ctually the equations of motion \do not feel" this difference. In the derivation we have used the identity $[(Z_u \ _q \ _{Z_q} \ _u)^2 = Z_u]_u du = 0$, which holds because the integrand is analytical in the low erhalf-plane. From here one can express the variational derivatives ($K^{(1)} =$) and ($K^{(1)} = Z$) by the form ulas

D. M odi cation of the H am iltonian

It can be easily obtained that the linear dispersion relation for the system (27)-(33) is

where m is the wave-number in the q-direction (the wavenumber k in the u-direction was introduced earlier). Obviously, here we have the rst two terms from the expansion of the exact 3D linear dispersion relation

A lso, the correct linear dispersion relation is strongly desirable, since it determ ines which waves interact by nonlinear resonances. O f course, a possible regularization is not unique as we keep only zeroth- and rst-order terms on = $(m = k)^2$ in the H am iltonian. Below we suggest a modi cation which adds terms of the order O (²) to the approximate H am iltonian P + K (⁰⁾ + K (¹⁾ (a modi ed H am iltonian H⁻ = P + K will remain valid up to). These equations were integrated numerically as described in the following section. It is interesting to note that we also considered another choice for the regularization, with $G_0 = (k^2 + m^2 = 2)(k^2 + m^2)^{1=2}$ instead of jkj in K⁽⁰⁾, and $(k^2 + m^2)^{1=2}$ instead of 1=jkj in the rst term in K⁽¹⁾. The numerical results were found very close in both cases, since the wave spectra were concentrated in the region $m^2 = k^2 - 1$.

III. NUMERICALMETHOD AND RESULTS

In our num erical simulations, we used the following procedure. A rectangular dom ain L_u L_{α} with the periodic boundary conditions in the (u;q)-plane was reduced to the standard dimensionless size 2 2 [the aspect ratio " = $(L_u = L_g)^2$ was taken into account]. This standard square was discretized by N L points $(u_h; q_l) =$ 2 (n=N;l=L), with integer n and l. The time variable was rescaled to give g = 1. As the primary dynam icalvariables, the (com plex) Fourier components Y_{km} and $P_{km} = (k^2 + "m^2)^{1=4}$ km were used, where k and m were integer numbers in the limits $0 \ k < K$, M m M, 3N =8, M 3L=8. For negative k, the propwith K erties $Y_{k;m} = \overline{Y_{km}}$ and $P_{k;m} = \overline{P_{km}}$ were implied. It should be noted that after rescaling u, q, and t, the linear dispersion relation has been $!_{km} = (k^2 + "m^2)^{1=4}$, and that the com binations

in the linear lim it coincide with the norm alcom plex variables [13, 36].

U sing the FFTW library [17], the quantities Z $(u_n;q_l)$, $(u_n;q_l)$, their corresponding u- and q-derivatives, and \hat{G}_0 $(u_n;q_l)$ are represented by 2-dimensional complex arrays. The variational derivatives (43), (44), (42) and the right-hand-sides of Eqs. (40)-(41) are then computed and transformed into Fourier space in order to evaluate the multi-dimensional function which determ ines the time derivatives of Y_{km} and P_{km}. This function is used in the standard fourth-order R unge-K utta procedure (RK 4) for the time integration of the system. A fler each RK 4 step, a large-wave-num ber Itering of the arrays Y_{km} and P_{km} is carried out, so that only the Fourier components

with 0 $k < K_{eff}$, M_{eff} m M_{eff} are kept, where K_{eff} N =4 and M_{eff} L=4. To estimate the accuracy of the computations, conservation of the total energy H[°] and the mean surface elevation are monitored.

Typically, at t = 0 we put N = 2^{12} , L = 2^{6} , and the initial time step = 0.01. During the computation, as wave crests become more sharp and the spectra get broadened, we several times adaptively double N (together with K, K_{eff}) and L (together with M, M_{eff}), with the time step half-decreasing when N is doubled. At the end, when a giant wave is form ed, we have N = 2^{13} ¹⁴, L = 2^{78} . As a result of such adaptive scheme, the conservation of the total energy is kept up to 5-6 decim al digits during m ost part of the evolution. O nly at a very late stage, when N and L are not allowed to double anym ore, the conservation is just up to 3-4 digits, and the litering of the higher harm onics becomes m ore in uential.

The e ciency of the above described num ericalm ethod crucially depends on the speed of the FFT routine, since m ost of the com putational time (approxim ately 80%) is spent in the Fourier transform s. To com pute the evolution through the unit (dimensionless) time period, on a m odem PC (Intel Pentium IV 3.2 GHz) it takes three-four m inutes with N = 4096, L = 64, = 0.01, and m ore than one hour with N = 8192, L = 256, = 0.005. The total time needed for a single num erical rogue-wave experiment is about 3-5 days.

Two num erical experim ents are reported below for horizontal physical box sizes of 4 4 km (the nal resolution was 16384 256 in both). In the rst of them, the main mechanism for a big wave form ation is the linear dispersion, when a group of longer waves overtakes a group of shorter waves, and their amplitudes are added (see [1] for a discussion). However, due to nonlinear e ects, in maximum the crest is higher than simply the sum of two amplitudes. In the second experiment, a giant wave is formed by an essentially nonlinear mechanism (due to Benjam in-Feir instability) from a slightly modulated periodic wave, close to a stationary Stokes wave.

A. \Linear" big wave

In the rst num erical experim ent (referred to as [A]), the initial state was a composition of two spatially separated wave groups, as shown in Fig.1. Two typicaldim ensionless wave numbers are present, $k_1 = 17$, corresponding to the wave length 1235 m (at the central part of Fig. 1) and $k_2 = 23$ ($_2$ 174 m). Att = 0 the highest crests were about 5 m in both groups (see Fig. 2). Due to di erence in the group velocities (cgr $j_{1}^{1=2}$), the longer waves move faster and after som e tim e overtake the shorter waves. As a result of alm ost linear superposition, big waves with high crests and deep troughs are form ed, separated by the spatial period $2 = \mathbf{k}_2 \quad \mathbf{k}_1 \mathbf{j} \mathbf{w}$ ith the maximum amplitude about 12 m, which is approxim ately equal to the sum of the individual am plitudes (the nonlinearity slightly increases the maximum height). The corresponding num erical results are presented in Figs.3 and 4.

B. Nonlinear big wave

O ur second num erical experim ent (referred to as [B]) is a weakly 3D analog of the 2D num erical experim ents perform ed by Zakharov and co-workers [2, 3], when a slightly modulated periodic Stokes wave evolves to pro-

duce a giant wave. However, with two horizontaldim ensions we could not achieve the same very high resolution as Zakharov with co-workers did for the case of a single horizontaldimension (16384 256 in our experiment [B] 1 in Ref. [3]). Our computations were versus 2 190 term inated well before the moment when a giant wave reached its maximum height and began break, since the num ber of the employed Fourier modes became inadequate. The accuracy could be betterw ith largerN and L, and with a smaller , but it required much more memory and computational time. In general, to resolve in conform al variables a sharp wave crest with a minim al radius of curvature and with the asymptotic angle 2 = 3 (as in the lim iting Stokes wave), the required number K $_{\rm eff}$ $^{3=2}$ $^{1=2}$. The power should adaptively vary as 3=2results in strong di culties when is small. A nother im portant point is that Zakharov and co-workers were able to re-form ulate the purely 2D equations in terms of the $\phi = 1 = Z_u$ and $U = i_u = Z_u$, thus obtaining very elegant and compact cubic evolution equations (the Dyachenko equations [15]). In our 3D case, a similar simplication seems to be impossible, and we dealt directly with the original conform al variables Z and . Nevertheless, our results are su ciently accurate to reproduce the fact of a giant wave form ation.

As the initial state for the experiment [B], we took a weakly modulated periodic wave with the main wave num ber k = 19 (210 m) and with a few rst harmonics on 2k, 3k, etc., similar to a Stokes wave (not shown). After some period of evolution, the Benjam in-Feir instability developed and resulted in form ation of a big wave, with the amplitude 13 m at t = 172:8 versus the initial maximum amplitude 5 m (see Figs. 5-7 and compare with Ref. [3]). The peak-to-trough height h of this computed roque wave was approximately 20 m at t = 172:8 (the steepness parameter h =0:1), and it was still growing at that moment (so, at t = 173.0we observed the amplitude 14 m, but the accuracy was already not su cient). It is interesting that this num ericalsolution has a well de ned envelope until a very nal stage of evolution. Thus, our equations m ay serve to test the sim pli ed wave-packet m odels like the extended NLS equations [31, 32, 33].

IV. SUMMARY AND DISCUSSION

We have developed an e cient numerical method for modeling the rogue wave phenomenon. The underlying theory for the method is the weakly 3D formulation of the free surface dynamics reported earlier [35] with slight modi cations. In particular, the Ham iltonian has been regularized in a way to give the exact linear 2D dispersion relation in the entire Fourier space, and a liter removing shortest waves has been added in the numerical im plementation. With these techniques, weakly threedimensional e ects could be included in simulations of rogue wave formation as illustrated in the two examples given. In particular, the genuinely non-linear 2D instability reported by Zakharov et al. [2, 3] could be veried in the weakly 3D regime despite the relatively low resolution (compared to 2D) of 16384 256 points used here.

The results indicate that the assumption of weak variation in the third direction holds even in the late stage of rogue wave form ation, which dem onstrates the consistency of the expansion in $= (l_{\pm}=l_q)^2$ and thereby the applicability of the present theory.

Planned further steps in the continuation of this work are a more e cient computational implementation through parallelization of the code and the inclusion of additional e ects like a bottom prole, which is already covered by the formalism reported earlier [35].
