Inverse Statistics for Stocks and M arkets

In recent publications, the authors have considered inverse statistics of the D ow Jones Industrial A veraged (D JIA) [1, 2, 3]. Speci cally, we argued that the natural candidate for such statistics is the investment horizons distribution. This is the distribution of waiting times needed to achieve a prede ned level of return obtained from detrended historic asset prices. Such a distribution typically goes through a maximum at a time coined the optim alinvestment horizon, , which de nest them ost likely waiting time for obtaining a given return. By considering equal positive and negative levels of return, we reported in [2, 3] on a quantitative gain/loss asymmetry most pronounced for short horizons. In the present paper, this gain/loss asymmetry is re-visited for 2/3 of the individual stocks presently in the D JIA. We show that this gain/loss asymmetry established for the D JIA surprisingly is not present in the time series of the individual stocks. The most reasonable explanation for this fact is that the gain/loss asymmetry cascade processes (or \synchronization") which disappear in the inverse statistics of the individual stocks.

I. IN TRODUCTION

W hat drives prices? This question has been studied for centuries with quantitative theories dating back at least to Bachelier [4], who proposed the random walk hypothesis for price trajectories. As prices in general do not become negative, econom ist later realized that a more realistic fram ework was obtained by assuming the random walk hypothesis for the logarithm of the price [5]. This has made relative returns the prime focus of nancial investigation with only a few exceptions, such as hedge funds focusing on absolute returns, and benchmarking are almost exclusively done by the nancial community by comparing relative returns with respect to a xed time interval.

W ithin the current economic paradigm | the E cient M arket H ypothesis (EM H) [6] | the idea of random ly uctuating prices in the absence of new hard information has been re-form ulated in the fram ework of hard-working rational traders with complete know ledge of all available information whose continuing e ort more or less instantaneously removes any imbalance in prices due to past di erences in the expectations of traders. In short, the EM H states that current prices re ect all available information about the priced commodity, i.e., all available information is at any given instant already priced in by the market and any change in prices can only be due to the revelation of new information. In other words, there is no free lunch.

Hence, the EMH claims that inform ation drives prices. Unfortunately, this just have us with another question, namely how to price in the available inform ation [21]? In the case of a stock, this must be done by considering how the available inform ation a ects future earnings of the company. This obviously (again) introduces some ambiguity as not only do peoples expectations to a largely unpredictable future di er, but so do their strategies with respect to for example investment horizons, i.e. how long they intend to hold their investment before taking any prot, and how large a risk they are willing to take over that time period.

In order to qualify di event pricing models etc., the nancial industry has performed many statistical studies establishing a number of so-called stylized facts $[\beta, 9, 10]$ as well as benchmarking for the performance of various

nancial instruments with respect to investment returns and in its complement, risk taking. Due to this focus on returns and risk, most nancial studies essentially amount to measuring two-point correlations in one way or another,

most commonly done by studying the distribution of returns calculated over some pre-de ned xed time period t [8, 9, 10].

Empirically it has been established, that for not too long time intervals t's, say less than a week, the return distributions are characterized by fat tails" [8, 9, 10]. Fat tails of a distribution refers to a much larger probability for large price changes than what is to be expected from the random walk or G aussian hypothesis. As treaches longer time scales, the distribution of returns gradually converges to a G aussian distribution. However, no real consensus regarding the exact quantitative nature of this distribution exist.

>From the point of view of the present authors, a more reasonable answer to the question of what drives prices, besides the in uence of interest rates and other macroscopic econom ic factors as well as quarterly earnings reports etc. of the company in question, is hum an psychology with all its facets of bounded rationality, limited information, personal beliefs etc. In accordance with this view, the econom ics and nancial communities have in the past 5{10 years witnessed an increased interest in what has been coined \BehaviourialE conom ics". A prime example of such a study is the book by R J. Schiller entitled \IrrationalE xuberance" [22], published in 2000, but written before the crash of April of this year [11]. This book gives numerous examples of both present (at that time) and past events where the price of stocks, and more relevant, the P/E (price-earning-ratio) has more or less exploded based on little more than vague notions of a \new econom ic era" [23] and the only reald i erence com es with the speci c sector driving the bubble prior to the crashes seen in the past 150 years or so.

If we focus on the US stock market, then in the 1860s and 1870s it was rail road era, in the 1920s it was utilities, sem i-conductors (\Tektronix") in uenced the development in 1950s and 1960s, in the 1980s it was a general public investment boom driven by liberalization of the nancial markets and, most recently, in second half of the 1990s it was rst an emerging market boom and then the notorious information technology bubble. Most notable are the \explosions" in the P/E in the 1920s and in the period from early 1980s to 2000. During these periods, the P/E of the SP 500 went from about 5 to 32 and from about 7 to 45, respectively [24]. This corresponds to a more than six-fold increase in little less that one and two decades for the two respective periods.

A fier the O ctober 1987 crash, R J. Schiller asked a num ber of institutional and individual investors the following question: \W hich of the following better describes your theory of the decline (s): (i) a theory about investor psychology, or (ii) a theory about fundamentals such as prots and interest rates?" The answers revealed that about 68% of the institutional investors and 64% of the individual investors picked the form er alternative. From this R J. Schiller concluded that: \It appears that the stock market crash had substantially to do with a psychological feedback bop among the general investing public from price declines to selling and thus further selling, and so forth". This conclusion was in accordance with his investigation of the news stories published im mediately prior to the crash of O ctober 1929 where also no speci c event or events could be singled out as responsible for the crash.

>From the point of view of hum an psychology, the nancial communities focus on returns does not make as much sense as one would like. The obvious answer to the question: \W hat return would you like to see a year from now?", is of course | \As large as possible!" | or, if the question concerned risk | \As small as possible!". A more natural investment strategy is thus to settle for some return level and/orm axim um risk and then ask how long one must wait in order to achieve this. But how is one to determ ine a priori this investment horizon in an utterly unpredictable world with respect to the future some months away? Even if one solely focus on macroscopic fundamentals as well as those of the company in question, the predictability of future earnings is a very di cult question. As J.P. Bouchaud said in a lecture in G ranada of February 2005: \I do not know how to price even my own company within a factor of two or perhaps even three though I know everything to be known about it!"

A nother, m ore philosophical problem, with standard m odels of nancial markets is the following: If one, as these m odels do, only assumes that the market participants are purely sel shindividuals, who optimize their own utility function through xed time contracts with other nominally identical individuals, then, despite the achievement of mutual bene ts, the term \contract" would not be de ned in a general context. W hy is this so?

Because, a general and lasting de nition of the term \contract" requires long-term (meaning much longer than an ordinary hum an time span) institutions, which can only be upheld through non-sel sh behavior. Legal institutions, for exam ple, have a life time of centuries and hence cannot be put to work within a fram ework of sel sh individuals who's time horizon can't possibly be longer that there own life span. Hence, most models of the nancial markets are lacking a very essential ingredient, which one usually denote by the general word \culture". In conclusion, in our opinion most models of the nancial markets lack \psychology and culture".

This does not mean, however, that one cannot ask what drives the economy and the stock market on longer time scales, i.e. over decades, and what behaviour the economy exhibits over these time scales! An example of such a study is presented on Fig. 1. Here, the historical public debt of the USA is shown together with a labeling of the most signi cant historic events, mostly military con icts, involving the US during the same period. Notice that the K orean W ar and it's form al UN -forces did not represent any signi cant increase in US public debt. How ever, the so-called C old W ar between the USA and the USSR most certainly did. It is clear that the over-all rise in the public debt is exponential driven by large \bum ps" signifying rapid increases in public debt.

It is striking, on a qualitative level, that the origin of these large increases in US public debt is simply related to war with two major exceptions; the purchase of the Louisiana Territory from Napoleon in 1803 on the unauthorized initiative of the US-am bassador in Paris, and the K eynesian (in the meaning massive public investments) \New Deal" of Roosevelt in the 1930s. Note, that the logarithm ic scale is the reason why the \bumps" belonging to the purchase of the Louisiana Territory and the Spanish W ar of 1898 do not \stand out" in Fig.1.

If one compares this gure with one of the US stock market, say, the DJIA (Figs.2) one clearly sees that on a qualitative level the rises in the public debt, due to wars and N ew D eal, are followed by steep rises in the stock market with one big exception, namely the bubble of the 1920s. In hind-sight, this may not be so surprising, since increases in public debt normally means large public spending which finnels large amounts into the private sector. However, one should note that the average growth rate of the US public debt is about 8:6%, see Fig. 1. This should be compared with that of the DJIA until the 1950s, which is about 2:5%. W hat is surprising is that most time periods with peace exhibit a signi cant decline in the public debt, most notably the period after the war of 1812 until the second war with the Sem incle Indians (1835{1842}), as well as modest grow th in the DJIA. In the rst half of the 19th century, the US public debt dropped to a meager US\$ 33.733 in 1835 from US\$ 75.463.477 in 1791[25]. In conclusion with respect to long-term grow th in the stock market, public spending, especially in the case of war, has played a very signi cant role in the long-term grow th of the US economy and hence of the DJIA.

In the next sections, we will turn to the subject of optim al investments horizon distributions for both individual stocks as well as markets. We will do this in order to qualify an answer to the previous questions re-form ulated as \what a return is reasonable to expect in x days from now "for both individual stocks as well as markets by considering the gain distribution for pre-de ned return levels. In order to quantify the risk from historical data, we also consider the corresponding loss distribution [26].

The remaining part of this paper is organized as follows. In the next section, we turn to the short-term behaviour of three US stock markets, namely the DJIA, the SP 500 and the Nasdaq. Here, we will re-introduce a conceptually new framework for the analysis of short-term (in the sense of days and weeks) price uctuations. We call this tool of analysis for inverse statistics as we x the return level and let time oat, and not vice versa, as in the usual return statistics. (It is worth noting that an analysis, where both return level and time oats conditioned on a stable trend in either direction has been published by the rst author [3, 14]). First, we re-visit previous results for the DJIA as well as presenting new results for the SP 500 and the Nasdaq index, showing that the distribution of time horizons needed to obtain a speci ed return can be excellently parameterized by a generalized gam ma-distribution. Such distributions are well-known from various rst-passage problem [5], but the quality of this param etrization is nevertheless suprising considering the nature of the data. We then turn to the previously found gain/bss asym metry for the DJIA [2] and show that a sim ilar asym metry is present in both the SP 500 and Nasdaq. In the third section, we turn to the use of the inverse statistics on the single stocks that are included in the DJIA in order to further investigate the origin of this gain/loss asym metry. Surprisingly, we nd that the gain/loss asym metry found in the index comes from a cooperative cascade through the various sectors of the economy represented in the DJIA.

II. PREVIOUSWORK

In resent publications [1, 2, 3, 16], the present authors have proposed to invert the standard return-distribution problem and instead study the probability distribution of waiting times needed to reach a xed level of return for the stating (see also Ref. [7]). As mentioned previously, this is in the literature known as the $\$ rst passage time"-problem [15] and the solution is known analytically for a Brownian motion as the G am ma-distribution

(with a /), where one for large (waiting) times recovers the well-known st return probability for a random walk $p(t) = t^{3-2}$.

H istorical nancial time series such as the D JIA, SP 500 and N asdaq possesses an (offen close to exponential, see how ever [18]) positive drift over long time scales due to the overall grow th of the economy m odulated with times of recession, wars etc. If such a drift is present in the analyzed time series, one can obviously not compare directly the empirical probability distribution for positive and negative levels of return. As the focus of the present paper will be on such a comparison, we must eliminate or at least signi cantly reduce the e ect of this drift. One possibility for detrending the data is to use so-called de ated asset prices, but such prices are calculated using certain econom ic assumptions, which we as physicists are naturally suspicious of.

In the present study as well as in those of [1, 2], we have instead chosen to remove the drift based on the use of wavelets [19, 20], which has the advantages of being non-parametric. This technique has been described in detail

elsewhere [1] and for the present purpose, it su ces to say that this wavelet technique enables a separation of the original time series s(t) into a short scale (detrended) time series s(t) and a (long time-scale) drift term d(t) so that s(t) = s(t) + d(t) (cf. Fig. 2(c)).

Based on s(t) for some historical time period of the DJIA, the empirical investment horizon distributions, p(), needed to obtain a pre-de ned return level for the rst time can easily be calculated for di erent 's. As s(t) is stationary overtime scales beyond that of the applied wavelet (for a time larger than say 1000 days) it is straightforward to compare positive and negative levels of return.

A s the em pirical logarithm ic stock price process is known not to be B rownian, we have suggested to use a generalized (shifted) G am m a distribution

where the reasons behind t_0 are purely technical[27].

The results so far have been very encouraging with respect to excellent param etrization of the empirical probability distributions for three major stock markets, namely DJIA, SP 500 and Nasdaq; cf. Figs. 3(a), 4(a) and 5 for examples using a return level of 5% and the gure captions for values of the t parameters. The choice of = 0.05 is not accidental. It is su ciently large to be above the \noise level" quanti ed by the historical volatility and su ciently small to be of quite frequently occurrence. We have also considered other return levels, showing qualitatively the same features, but there results are not show n.

In all three cases, the tail-exponents +1 of the distributions param eterized by Eq. (2) are indistinguishable from the \random walk value" of 3=2, which is not very supprising. W hat is both supprising and very interesting is that these three m a prUS stock markets (D JIA, SP 500 and N asdaq) exhibit a very distinct gain/loss asymmetry, i.e., the distributions are not invariant to a change of sign in the returm (Figs. 3 (a), 4 (a) and 5). Furtherm ore, this gain/loss asymmetry quanti ed by the optim al investment horizon de ned as the peak position of the distributions has for at least the D JIA a supprisingly simple asymptotically power law like relationship with the return level, see Fig. 6.

See Ref. [16] for an application of inverse statistics to high-frequency foreign exchange data, speci cally the US\$ against the D eutch M ark and the Japanese Yen. W e are also currently investigating the use of inverse statistics for intra-day stock prices, but the results so far are still prelim inary.

III. NEW RESULTS

A sm entioned previously, the purpose of the present paper is to further investigate the origin of the gain/loss asym - metry in DJIA.W e do that by simply comparing the gain and loss distributions of the DJIA with the corresponding distributions for a single stocks in the DJIA as well as their average.

An obvious problem with this approach is that the stocks in the DJIA changes with historical period and hence an exact correspondence between the DJIA and the single stocks in the DJIA is di cult to obtain if one at the sam e time wants good statistics. This is the trade-o , where we have put the emphasis on good statistics. However, if this choice produces interpretational di culties, then one must ask why analyze the historical DJIA at all?

The 21 com pany stocks analyzed and presently in the DJIA (by the change of April 2004) are listed in table I together with the their date of entry into the DJIA as the time period of the data set analyzed.

As previously mentioned, the empirical distributions for = 0.05 are presented in Figs. 3(a), 4(a) and 5 for the DJIA, the SP 500 and the Nasdaq respectively for the entire time span available to the authors. Furtherm ore, in Figs. 3(b) and 4(b) we have truncated the full data sets of the DJIA and SP 500 to a shorter historical time period in order to compare the results for the indices with that of the individual stocks. W hat one should primarily note in the comparison between the two sets of gures, i.e., the longer data sets with the shorter, is that the only signi cant di erence is to be found in the weaker statistics of the shorter periods; the positions of the maxim a for the positive and the negative gains are in both cases roughly just below 10 and 20 days, respectively, i.e., a di erence of roughly a factor of 2 for all three indices for a return level of 5%.

In Figs. 7 we show the waiting time distributions for 4 companies in the DJIA, which are representative for the distributions obtained for all the companies listed in Table I. We see that, for a return level j = 0.05, the value of the optim al investment horizon, i.e. the position of the peak in the distribution, ranges from around 2 days to around 10 days depending on the company. More importantly, it is clear from just looking at the gures that, within the statistical precision of the data, the distributions are the same for positive and negative values of .

In order to further quantify this invariance with respect to the sign of , we have averaged the (com pany) gain and loss distributions separately in order to obtain an average behavior for the stocks listed in Table I. The result of this averaging process (Fig. 8) is nothing less that an alm ost perfect agreem ent between the gain and loss distributions with a peak position around 5 days for both distributions. This means that the optim all investment horizon for the average of these selected individual stocks is approximately half that of the loss distribution for the D JIA and approximately one fourth of that for the gain distribution. In other words, it is twice as slow to move the D JIA down and four times as slow to move the D JIA up compared to the average time to move an individual stock in the D JIA up or down.

How can we rationalize these results? W hat we have done in essence is to interchange the operations of averaging over the stocks in the DJIA and calculating the inverse statistics for the stocks of this index. Since the DJIA is constructed such that it covers all sectors of the economy of which it seems quite reasonable to assume that a 5% gain/loss in the shares of for example Boeing A invays in general has nothing fundam entally to do with a corresponding gain/loss in the shares of C oca-C ola C om pany especially since the data are detrended. In other words, it seems quite reasonable to assume that there is nothing special about a return level of 5% in terms of econom ic fundam entals etc. This assumption is also strongly supported by the results presented in Fig. 6.

This then m eans that the two operations, i.e. the averaging and the inverse statistics calculation, do not commute not even approximately. Hence signing cant inter-stock correlations must exist even for a rather modest return level = 0.05. In our view, this is a quite surprising result and especially considering that the large dimensions in the optim al investment horizons for the distributions of the index and the average of the individual stocks.

IV. SUMMARY AND CONCLUSIONS

We have considered inverse statistics for nancial data. It is argued that the natural candidate for such statistics is what we call the investment horizon distribution. Such a distribution, obtained from the historic data of a given market, indicates the time span an investor historically has to wait in order to obtain a prede ned level of return. For the three major US markets, namely the DJIA, SP 500 and Nasdaq, the distributions are parametrized excellently by a shifted generalized G amma distributions for which the st m om ent does not exist.

The typical waiting time, for a given level of return, can therefore be characterized by e.g. the time position of the maximum of the distribution which we call the optimal investment horizon. By studying the behaviour of this quantity for positive (gain) and negative (loss) levels of return, a very interesting and pronounced gain/loss asymmetry emerges for all three markets considered. The nature of this gain/loss asymmetry was further investigated by calculating the investment horizon distribution for 21 of the 30 individual stocks in the D JIA. Quite supprisingly the observed gain/loss asymmetry in the D JIA is not present in the investment horizon distribution for the individual stocks.

Speci cally, we have shown that if one rst \average" the stock prices of, say, the D JIA in order to create the index and then calculate the inverse statistics of it, then one obtains a pronounced gain/loss asym m etry. R eversing the order of these two operations, how ever, m akes this asym m etry disappear. A dm ittedly, this has been done system atically for only a single gain and loss level , but it seems unreasonable to claim anything special about the 5% gain/loss level used. Hence, the investm ent horizon distribution for the individual stocks is invariant under a change of sign for .

Furtherm ore, the optim al investment horizon for the average of the distributions for the individual stocks is approximately half that of the loss distribution for the entire market (DJIA) and approximately one fourth of that for the gain distribution for the entire market. In other words, it is twice as slow to move the DJIA down and four times as slow to move the DJIA up compared to the average time to move an individual stock in the DJIA up or down.

There are several possible scenarios which m ay explain the observed behavior. How ever, they all am ount to m ore or less the same thing. A down/up-turn in the D JIA m ay be initiated by a down/up-turn in some particular stock in some particular econom ical sector. This is followed by a down/up-turn in econom ically related stocks in other sectors and so forth. The result is a cascade, or synchronization, of consecutive down/up-turns in all the sectors covered by the D JIA. The initiation of this m ay be some m ore general new piece of information, which is considered m ore crucial for one sector than other sectors, but as argued for in length in [11] it m ay also happen for no obvious reason what so ever.

An (rational) example would be that Intel drops signi cantly due to bad quarterly earnings in turn, by a cascade process, a ecting the stock price of IBM and M icroSoft and so forth. As the index, at least from a physicist's point of view, can be compared to an external eld, m ovem ents in the index due to a single or a few stocks can rapidly spread through m ost or all sectors, if psychology in general and speci cally feed-back loops are in portant, thus creating a relatively large m ovem ents in the over-all index. That losses in general are faster than gains m ust also be attributed to hum an psychology: people are in generalm uch m ore risk adverse than risk taking [28].

In conclusion, the results presented here thus provide further evidence for the presence of cooperative behavior (or synchronization) possibly with a psychological origin in the stock market beyond what can be deduced from standard nancial models.

- [27] Its actual value depends on possible short-scale drift which m ay in part be due to the fact that we are using the daily close. Ideally, one should use som e m easure of all prices during the day, but it's not obvious how to de ne such a representative price for the entire trading day. We are aware that the m id price often is used as proxy but it is not obvious that this m easure is to be preferred as relatively large price changes tend to occur in the beginning and end of the trading day.
- [28] The reason for this has an evolutionary origin: one of the functions of emotions is to speed up decisions, which is an excellent feature in terms of physical survival. However, in the case of the stock markets, where nancial survival may be at stake, rational decisions are to be prefered. But, as rational decisions take longer time to make, people will offen act on emotions. In a study, published in June in the journal Psychological Science by a team of researchers from Stanford University, Camegie M ellon University, and the University of Iowa, a group of functional psychopats outperform ed a group of people with norm alemotional responses in a nancial gam e.






FIG.1: G raph of the historical US public debt from 1791 till 2000. The dashed diagonal line represents an exponential function corresponding to an average grow th rate of about 8:6%. Some historic events are marked by dashed vertical lines in the gure. They are: (a) the 1812 war (1812{1814}); (b) the second warw ith the Sem inole Indians (1835{1842}); (c) The M exican-Am erican W ar (1846{1848}); (d) The C ivilW ar (1861{1865}); (e) The Spanish Am erican W ar (1898); (f) The First W orld W ar (1914{1918}); (g) The Second W orld W ar (1940{1945}) (h) The C old W ar (1947{1991}).






FIG. 5: Same as Fig. 3(a), but for the Nasdaq. The historical time period considered is 1971.2 to 2004.6. Again he solid lines represent t of the empirical data against Eq. (2) with parameters: 0.51, 4:72, 0:73 and t₀ 7:92 (loss distribution); 0:51, 4:16, 2:41 and t₀ 0:07 (gain distribution). Note again that the tail exponents + 1 are very close to the \random walk value" of 3=2 for both distributions.




FIG.6: The optimal investment horizon for positive (open circles) and negative (open squares) levels of return for the DJIA. In the case where < 0 one has used on the abscissa for reasons of comparison. If a geometrical B rownian price process is assumed, one will have with = 2 for all values of . Such a scaling behaviour is indicated by the lower dashed line in the graph. Empirically one nds ' 1.8 (upper dashed line), only for large values of the return.




FIG. 7: Sam e as Fig. 3(a), but for som e of the individual com panies of the DJIA: (a) Boeing A inways (1962.1{1999.8}; (b) G eneralE lectric (1970.0{1999.8}; (c) G eneralM otors (1970.0{1999.8}; (d) Exxon & M obil, form er Standard O il (1970.0{1999.8}).




FIG.8: A veraged gain and loss distribution for the companies listed in table I. The t is Eq. (2) with values 0:60, 3:24, 0:94 and t₀ 1:09. Note that the tail exponent + 1 is 0:1 above the \random walk value" of 3=2.
