L in itations of scaling and universality in stock m arket data

W e present evidence, that if a large enough set of high resolution stock m arket data is analyzed, certain analogies with physics { such as scaling and universality { fail to capture the full complexity of such data. D espite earlier expectations, the mean value per trade, the mean number of trades per m inute and the mean trading activity do not show scaling with company capitalization, there is only a non-trivial m onotonous dependence. The strength of correlations present in the time series of traded value is found to be non-universal: The Hurst exponent increases logarithm ically with capitalization. A sim ilar trend is displayed by intertrade time intervals. This is a clear indication that stylized facts need not be fully universal, but can instead have a well-de ned dependence on company size.

In the last decade, an increasing num ber of physicists is becoming devoted to the study of economic and nancial phenomena [1, 2, 3]. One of the reasons for this tendency is that societies or stock markets can be seen as strongly interacting systems. Since the early 70's, physics has developed a wide range of concepts and models to e ciently treat such topics, these include (fractal and multifractal) scaling, frustrated disordered systems, and far from equilibrium phenomena. To understand how sim ilarly complex patterns arise from hum an activity, albeit truly challenging, seems a natural continuation of such e orts.

W hile a rem arkable success has been achieved [4, 5, 6], studies in econophysics are often rooted in possible analogies, even though there are in portant di erences between physical and nancial system s. Despite the obvious sim ilarities to interacting system s here we would like to em phasize the discrepancy in the levels of description. For example, in the case of a physical system undergoing a second order phase transition, it is natural to assume scaling on profound theoretical grounds and the (experim ental or theoretical) determ ination of, e.g., the critical exponents is a fully justi ed undertaking. There is no sim ilar theoretical basis for the nancial market whatsoever, therefore in this case the assumption of power laws should be considered only as one possible way of tting fat tailed distributions [7, 8]. A lso, the reference to universality should not be plausible as the robustness of qualitative features { like the fat tail of the distributions { is a much weaker property. W hile we fully acknow edge the process of understanding based on analogies as an important method of scienti c progress, we emphasize that special care has to be taken in cases where the theoretical support is sparse.

The aim of this paper is to sum marize some recent advances that help to understand these fundam ental differences. We present evidence, that the size of com panies strongly a ects the characteristics of trading activity of their stocks, in a way which is incompatible with the popular assumption of universality in trading dynam ics. Instead, certain stylized facts have a well-de ned dependence on company capitalization. Therefore, e.g., averaging distributions over companies with very di erent capitalization is questionable.

The paper is organized as follows. Section I introduces the notations and data that were used. Section II shows that various measures of trading activity depend on capitalization in a non-trivial way. In Sec. III, we analyze the correlations present in traded value time series, and nd that the Hurst exponent increases with the mean traded value per minute logarithm ically. Section IV deals with a similar size-dependence of correlations present in the time intervals between trades. Finally, Section V concludes.

I. NOTATIONSAND DATA

For time windows of size t, let us write the total traded value (activity, ow) of the ith stock at time t as

where t_i (n) is the time of the n-th transaction of the i-th stock. This corresponds to the coarse-graining of the individual events, or the so-called tick-by-tick data. V_i (n) is the value traded in transaction n, and it can be calculated as the product of the price p and the traded volum e of stocks V,

Price does not change very much from trade to trade, so the dom inant factor in the uctuations and the statistical properties of f is given by the variation of the number of stocks exchanged in the transactions, ∇ . Price serves as a conversion factor to a common unit (US dollars), and it makes the comparison of stocks possible, while also automatically corrects the data for stock splits. The statistical properties (norm alized distribution, correlations, etc.) are otherwise practically indistinguishable between traded volum e and traded value.

W e used empirical data from the TAQ database [9] which records all transactions of the New York Stock Ex- change and NASDAQ for the years 1993 2003.

F inally, note that throughout the paper we use 10-base logarithm s.

II. CAPITALIZATION AFFECTS BASIC MEASURES OF TRADING ACTIVITY

M ost previous studies are restricted to an analysis of the stocks of large companies. These are traded frequently, and so price and returns are wellde ned even on the time scale of a few seconds. Nevertheless, other quantities regarding the activity of trading, such as traded value and volum e or the num ber of trades can be de ned, even for those stocks where they are zero form ost of the time. In this section we extend the study of Zum bach [10] which concerned the 100 large companies included in London Stock Exchange's FT SE-100 m arket index. This set spans about two orders of m agnitude in capitalization. Instead, we analyze the 3347 stocks[28] that were traded continuously at NYSE for the year 2000. This gives us a substantially larger range of capitalization, approxim ately 10^6 :::6 10^1 USD.




Figure 1: (a)-(c) Capitalization dependence of certain measures of trading activity in the year 2000. The functions are monotonously increasing and can be piecew is approximated by power laws as indicated. All three tendencies break down for large capitalizations. (a) M ean value per trade hV i in USD. The tted slope corresponds to the regime $5 \quad 10^{\circ} < C < 75 \quad 10^{\circ}$ in USD. (b) M ean number of trades per minute hN i. The slope on the left is from a tto C < 45 10° USD, while the one on the right is for C > 45 10° USD. (c) M ean trading activity (exchanged value per minute) hf i in USD. The plots include 3347 stocks that were continuously available at NYSE during 2000. (d) P lot of mean value per trade hV i versus mean number of trades per minute hN is for the year 2000 of NYSE. For smaller stocks there is no clear tendency. For the top 1600 com panies (hN i > 0.05 trades/m in), however, there is scaling with an exponent = 0.57 0.08.

Following Ref. [10], in order to quantify how the value of the capitalization C_i of a company is rejected in the trading activity of its stock, we plotted the mean value per trade hV_ii , mean number of trades per minute hN_ii and mean activity (traded value per minute) hf_ii versus capitalization in Fig. 1. Ref. [10] found that all three quantities have power law dependence on C_i , how ever, this simple ansatz does not seem to work for our extended range of stocks. W hile mean trading activity can be { to a reasonable quality { approximated $ashf_ii / C_i^{0:98} = 0:06$, neither hV i nor hN i can be tted by a single power law in the whole range of capitalization. Nevertheless, there is an unsurprising monotonous dependence: higher capitalized stocks are traded more intensively.

O ne can gain further insight from Fig. 1(d), which elim inates the capitalization variable, and show shV i versus hN i. For the largest 1600 stocks we nd the scaling relation

with = 0.57 0.09. The estimate based on the results of Zum bach [10] for the stocks in London's FTSE -100, is

1, while Ref. [11] nds = 0.22 0:04 for NASDAQ. The regime of smaller stocks shows no clear tendency.

O ne possible interpretation of the e ect is the following. Sm aller stocks are exchanged rarely, but there must exist a sm allest exchanged value that is still pro table to use due to transaction costs, hV i cannot decrease inde nitely. On the other hand, once a stock is exchanged more offen (the change happens at about hN i = 0.05trades/m in), it is no more traded in this m inim al profitable unit. W ith more intensive trading, trades "stick together", liquidity allows the exchange of larger packages. This increase is clear, but not very large, up to one order of m agnitude. A lthough increasing package sizes reduce transaction costs, price in pact [12, 13, 14, 15] increases, and pro ts will decrease again. The balance between these two e ects can determ ine package sizes and m ay play a role in the form ation of (3).

III. NON-UN IVERSAL CORRELATIONS OF TRADED VALUE

Scaling m ethods [16, 17, 18] have long been used to characterize stock market time series, including prices and trading volum es [4, 5]. In particular, the Hurst exponent H (i) is often calculated. For the traded value time series f_i^{t} (t) of stock i, it can be de ned as

where h i denotes time averaging with respect to t. The signal is said to be correlated (persistent) when H > 0.5, uncorrelated when H = 0.5, and anticorrelated (antipersistent) for H < 0.5. It is not a trivial fact, but several recent papers [19, 20] point out that the variance on the left hand side exists for any stock's traded value and any time scale t. Therefore, we carried out m easurem ents of H on all 2647 stocks that were continuously traded on NYSE in the period 2000 2002. We investigated separately the 4039 stocks that were traded at NASDAQ for the same period.




Figure 2: Behavior of the Hurst exponents H (i) for the period 2000 2002, and two markets ((a) NYSE, (b) NASDAQ). For short time windows (#), all signals are nearly uncorre-0:51 0:52, regardless of stock market. The lated, H (i) tted slopes are NYSE (t < 20m in) = 0:001 0:002, and NASDAQ (t < 2m in) = 0.003 0.002. For larger time w indows (), the strength of correlations depends logarithm ically on the mean trading activity of the stock, NYSE (t> 300 m in) = 0.060:01 and NASDAQ (t > 60m in) = 0:05 0:01. Shu ed data (5) display no correlations, thus $H_{shuff}(i) = 0.5$. Insets: The log -log t scaling plots () for two example stocks, GE (NYSE) and DELL (NASDAQ). The darker shaded intervals have well-de ned Hurst exponents, the crossover is indicated with a lighter background. Results for shu ed time series (#) were shifted vertically for better visibility.

We nd, that stock market activity has a much richer behavior, than simply all stocks having Hurst exponents statistically distributed around an average value, as assumed in Ref. [21]. Instead, there is a crossover [19, 22, 23] between two types of behavior around the time scale of a few hours to 1 trading day. An essentially uncorrelated regime was found when t < 20 m in forNYSE and t < 2 m in for NASDAQ, while the time series of larger companies become estrongly correlated when t > 300 m in for NYSE and t > 60 m in for NASDAQ. As a reference, we also calculated the Hurst exponents H shuff (i) of the shu ed time series. The results are plotted in Fig. 2.

O ne can see, that for shorter time windows, correlations are absent in both markets, H (i) 0.51 0.53. For windows longer than a trading day, however, while sm all hf i stocks again display only very weak correlations, larger ones show up to H 0.9. Furtherm ore, there is a distinct logarithm ic trend in the data:

with (t > 300m in) = 0:06 0:01 for NYSE and (t > 60m in) = 0:05 0:01 for NASDAQ. This result can be predicted by a general fram ework based on a new type of scaling law [11, 24]. Shorter time scales correspond to the special case = 0, there is no system atic trend in H. A fler shu ing the time series, as expected,

they become uncorrelated and show H_{shuff} (i) 0.5 at alltime scales and without signi cant dependence on $hf_{i}i$.

It is to be emphasized, that the crossover is not simply between uncorrelated and correlated regimes. It is instead between hom ogeneous (all stocks show H (i) H₁, = 0) and inhom ogeneous (> 0) behavior. One nds H₁ 0:5, but very smallhfi stocks do not depart much from this value even for large time windows. This is a clear relation to company size, as hfi is a monotonously growing function of company capitalization (see Sec. II and Ref. [19]).

Dependence of the e ect on hfi is in fact a dependence on company size. This is a direct evidence of non-universality. The trading mechanism that governs the marketplace depends strongly on the stock that is traded. In a physical sense, there are no universality classes [25] comprising a given group of stocks and characterized by a set of stylized facts, such as Hurst exponents. Instead, there is a continuous spectrum of com – pany sizes and the stylized factsm ay depend continuously on com pany size/capitalization. System atic dependence of the exponent of the power spectrum of the number of trades on capitalization was previously reported in Ref. [26], based on the study of 88 stocks. That quantity is closely related to the Hurst exponent of the respective time series (see Ref. [22]). D irect analysis nds a strong, monotonous increase of the Hurst exponent of N with growing hN i, but no such clear logarithm ic trend as Eq. (5).

IV. NON-UNIVERSAL CORRELATIONS OF INTERTRADE TIMES

To strengthen the arguments of Sec. III, we carried out a a similar analysis of the intertrade interval series T_i (n = 1:::N_i 1), de ned as the time spacings between the n'th and n + 1'th trade. N_i is the total number of trades for stock i during the period under study.

P reviously, Ref. [22] used 30 stocks from the TAQ database for the period 1993 1996 and proposed that H $_{\rm T}$ has the universal value 0:94 0:05.

W e analyzed the sam e database, but included a large num ber of stocks with very di erent capitalizations. First it has to be noted that the m ean intertrade interval has decreased drastically over the years. In this sense the stock m arket cannot be considered stationary for periods m uch longer than one year. W e analyzed the two year period 1994 1995 (part of that used in Ref. [22]) and separately the single year 2000. We used all stocks in the TAQ database with hTi < 10^5 sec, a total of 3924 and 4044 stocks, respectively.

T he H urst exponents for the tim e series $T_{\rm i}$ can w ritten, analogously to Eq. (4), as

where the series is not de ned in time, but instead on a tick-by-tick basis, indexed by the num ber of transactions.




Figure 3: Hurst exponents of $T_{\rm i}$ for windows greater than 1 day, plotted versus the mean intertrade time $hT_{\rm i}i$. Stocks that are traded less frequently, show markedly weaker persistence of T for time scales longer than 1 day. The dotted horizontal line serves as a reference. We used stocks with hT i < $10^5\,$ sec, the sam ple period was 1994 1995. The inset shows the two regimes of correlation strength for the single stock G eneral E lectric (G E) on a log-log plot of (N) versus N. The slopes corresponding to Hurst exponents are 0:6 and 0:89.

The data show a crossover, similar to that for the traded value f, from a lower to a higher value of H $_{\rm T}$ (i) when the window size is approximately the daily m ean number of trades (for an example, see the inset of Fig. 3). For the restricted set studied in Ref. [22], the value H $_{\rm T}$ 0:94 0:05 was suggested for window sizes above the crossover.

Similarly to the case of traded value Hurst exponents analyzed in Section III, the inclusion of more stocks[29] reveals the underlying systematic non-universality. Again, less frequently traded stocks appear to have weaker autocorrelations as H_T decreases monotonously with growing hT i. One can t an approximate logarithm ic law [30]'[31] to characterize the trend:

where $_{T} = 0.10 \quad 0.02$ for the period 1994 1995 (see Fig. 3) and $_{T} = 0.08 \quad 0.02$ for the year 2000 [27].

In their recent preprint, Yuen and Ivanov [23] independently show a tendency sim ilar to Eq. (7) for intertrade times of NY SE and NASDAQ in a di erent set of stocks.

V. CONCLUSIONS

In this paper we have sum marized a few recent advances in understanding the role of com pany size in trading dynam ics. We revisited a num ber of previous studies of stock market data and found that the extension of the range of capitalization of the studied rm s reveals a new aspect of stylized facts: The characteristics of trading display a fundam ental dependence on capitalization.

W e have shown that trading activity hfi, the number of trades per minute hN i and the mean size of transactions hV i display non-trivial, monotonous dependence on company capitalization, which cannot be described by a simple power law. On the other hand, for moderate to large companies, a power law gives an acceptable t for the dependence of the mean transaction size on the trading frequency.

The Hurst exponents for the variance of traded value/intertrade times can be de ned and they depend logarithm ically on the mean trading activity hf i/mean intertrade time hT i.

These ndings imply that special care must be taken when the concepts of scaling and universality are applied to nancial processes. For the modeling of stock market processes, one should always consider that many characteristic quantities depend strongly on the capitalization. The introduction of such models seems a real challenge at present.

- [31] Note that for window sizes smaller than the daily mean number of trades, intertrade times are only weakly correlated and the Hurst exponent is nearly independent of hT i. This is analogous to what was seen for traded value records in Sec. III.
