## Scaling laws for the photo-ionisation cross section of two-electron atoms

The cross sections for single-electron photo-ionisation in two-electron atoms show uctuations which decrease in amplitude when approaching the double-ionisation threshold. Based on sem iclassical closed orbit theory, we show that the algebraic decay of the uctuations can be characterised in terms of a threshold law  $/ \pm j$  as  $E \pm 0$  with exponent obtained as a combination of stability exponents of the triple-collision singularity. It diers from W annier's exponent dominating double ionisation processes. The details of the uctuations are linked to a set of in nitely unstable classical orbits starting and ending in the non-regularisable triple collision. The notings are compared with quantum calculations for a model system, namely collinear helium.

Recent experimental progress has signicantly im proved the energy resolutions of highly excited two electron states below [1,2] and above [3] the double ionisation threshold E = 0. Near the threshold, electron-electron correlation e ects becom e dom inant which are directly observable in total and partial cross sections, see [4, 5, 6] for recent reviews; an example is W annier's celebrated threshold law for double ionisation [7] con med experimentally in [8]. For E < 0, two-electron atom s exhibit a rich resonance spectrum while the classical dynam ics of this three-body Coulom b problem becom es chaotic. A pproaching the double ionisation threshold from below has thus proved challenging [6] and recent experim ental and theoreticale orts still only reach single-ionisation thresholds I<sub>N</sub> with N 15 [1, 2, 9]. Sem iclassicalm ethods need to address the chaotic nature of the classical dynam ics which is dominated by the complex folding patterns of the stable/unstable manifolds of the triple collision [10]. Due to the high dimensionality of the system sem iclassical applications have been restricted to subsets of the full spectrum and again small N values [6].

In this letter, we show that the uctuations in the total cross section for single electron photo-ionisation below the three-particle breakup energy decays algebraically with an exponent determ ined by the triple collision singularity di erent from W annier's exponent. W riting the cross section in dipole approximation [11, 12], we obtain

where  $_{i}$  is the wave function of the initial state and D =  $(r + r_{2})$  is the dipole operator with , the polarisation of the incoming photon and  $r_{j}$ , the position of electron j. Furtherm ore, G (E) is the G reen function of the system at energy E = E<sub>i</sub> + ~! and = e<sup>2</sup>=~c. Note that we work in the in nite nucleus mass approximation, that is, the position of the nucleus is xed at the origin.

By expressing the G reen function sem iclassically in terms of classical trajectories [11], uctuations in the cross section of hydrogen-like atoms in external elds

have been analysed successfully using closed orbit theory (COT) [11, 12]. In the sem iclassical lim it, the support of the wave function i shrinks to zero relative to the size of the system reducing the integration in (1) to an evaluation of the G reen function at the origin. This is strictly valid only for potentials su ciently smooth at the origin, corrections due to di ractive scattering at the central singularity give additional contributions often treated in quantum defect approximation [13, 14]. The situation is di erent for two-electron atom swhere the dynam ics near the origin is dominated by the non-regularisable triple collision singularity. C losed orbit theory has been used to analyse experim ental photoabsorbtion spectra of helium with and without external elds [13, 15] for highly asymmetric states; accompanying theoretical considerations treat the system in a single electron approximation thus not considering the triple collision dynam ics which becom es in portant for doubly-excited resonances.

In the following, we will discuss a COT treatment of two-electron atoms explicitly including the triple collision dynamics when approaching the limit E ! 0 . Introducing the hyperradius  $R = (r_1^2 + r_2^2)^{1=2}$ , we x  $R_0$ such that a surface dened as  $R = R_0$  encloses the support of initial state i. The surface naturally leads to a partition of the con guration space into physically distinct regions. In particular, quantum contributions to (1) from the inner region are insensitive to the total energy. Contributions from the outer region test the full scale of the classically allowed region of size  $\neq j^1$  and will be responsible for the resonance structures near the double ionisation threshold E = 0. Following G ranger and G reene [16], we write the photo-ionisation cross section (1) in term s of local scattering matrices, that is,

Here,  $S^{\ddagger}$  is a core-region scattering matrix which maps amplitudes of waves coming in at onto amplitudes of the wave components going out at ; it thus contains all the inform ation about the correlated two-electron dynam ics near the nucleus. Likew ise, S "describes the wave dynam ics of the two-electron wave function emanating from and returning to and thuspicksup long-range correlation in the exterior of . Furtherm ore, d is the atom ic dipole vector, d\_n (E) = <  $\frac{1}{n}$  (E)  $\mathcal{D}_i > with \frac{1}{n}$  (E) being the nth linearly-independent energy-normalised solution of the Schrödinger equation inside with incom - ing wave boundary conditions at [16]. This type of scattering form ulation was independently developed in [17] for general surfaces , for a sem iclassical form ulation, see [18]. The series expansion (3) was exploited in [13, 14, 19] in order to include core-region scattering or quantum defect e ects in COT.

For the wave dynam ics inside , the double ionisation threshold E = 0 is irrelevant and the core-region scattering matrix S  $^{\sharp}$  as well as the dipole vector d vary sm oothly across E = 0; they can be regarded as constant for energies su ciently close to the threshold. The inform ation about the increasing number of overlapping resonances near the threshold is thus largely contained in S<sup>"</sup>.

Sem iclassical approxim ations for the quantities introduced above are valid in the outer-region  $R > R_0$ . The long-range scattering matrix, S<sup>"</sup>, can thus be treated sem iclassically while d and S<sup>#</sup> dem and a full quantum treatment. The sem iclassical representation of S<sup>"</sup> in position space reads [16, 17, 18]

where the sum is taken over all classical paths j connecting points x and x<sup>0</sup> on without crossing ; S <sub>j</sub>(E) denotes the action of that path, <sub>j</sub> is the M aslov index and f = 4 is the dimension of the system for xed angular momentum. Furthermore,  $M_{12}j_j^{1=2} = j^2S_j(x;x^0)=(2x^0x^0j^{-2}, where M_{12} is a (3 3) sub-matrix$ of the 6-dim. M onodrom y matrix describing the linearised ow neara trajectory. Note that due to the stronginstability of the classical dynamics near the triple collision, these matrix elements become a singular for triplecollision orbits (TCO) starting from or falling into thetriple collision R = 0. It is thus in portant here that trajectories contributing to (4) start at a xed hyper-radiusR<sub>0</sub> > 0 away from the triple collision [20].

M aking use of the scaling properties of the classical dynam ics, we introduce the transform ation [21]

where r;p corresponds to coordinates and momenta at xed energy E = 1 and L is the total angular momentum. Expressing L in scaled coordinates, we have E ! 0as E ! 0 and can thus restrict the analysis to the three degrees of freedom subspace E = 0 (for xed L) [10].

In scaled coordinates, the inner-region shrinks according to  $\mathcal{R}_0 = \Xi \mathcal{R}_0 \ ! \ 0$  for E  $\ ! \ 0$  , and the part of the

dynam ics contributing to S" in (4) is form ed by trajectories starting and ending closer and closer to the triple collision R = 0 as  $f_{E_0} / R_0 ! 0$ . TCOs only occur in the so-called eZe space [10], a collinear subspace of the full three body dynam ics where the two electrons are on opposite sides of the nucleus [21]. As  $\mathbb{R}_0$  ! 0, only orbits com ing close to the eZe space can start and return to  $\sim$ and they will do so in the vicinity of a closed triple collision orbit (CTCO) starting and ending exactly in the triple collision. The dynam ics in the eZe space is relatively simple as it is conjectured to be fully chaotic with a com plete binary sym bolic dynam ics. In particular, for every nite binary symbols string there is a CTCO, the shortest being the so-called W annier orbit (W O) of sym m etric collinear electron dynam ics. Furtherm ore TCOs escape from or approach the triple collision at R = 0always symmetrically along the  $r_1 = r_2$  axis in the eZe space, that is, along the WO [22]. This universality will be exploited below when treating the energy-dependence ofM  $_{12}$  in (4).

Returning to the cross-section (2), we write  $= _0 + _{fl}$ , where we identify the smooth contribution  $_0$  with the leading term in the series expansion (3). The main contribution to the uctuating part of the cross section  $_{fl}$  is contained in S<sup>"</sup> which in sem iclassical approximation (4) can be expressed in terms of orbits returning to  $^{\sim}$  once; multiple traversals of  $^{\sim}$  represented by S<sup>"</sup>S<sup>#</sup> <sup>k</sup> with k 2 will give sub-leading contributions in the sem iclassical limit E ! 0 due to the unstable dynamics near the triple collision. Furtherm ore, swarm s of trajectories starting on  $^{\sim}$  and returning to  $^{\sim}$  will do so close to the eZe subspace and thus in the neighbourhood of a CTCO with actions and am plitudes approaching those of the CTCO trajectory as  $\tilde{K}_0$  ! 0. The uctuating part can thus in leading order be written in the form

and  $z = 1 = \sqrt{\frac{p}{F}}$ . In (5), the sum is taken over all CTCO's j starting and ending at ~. Note that the stability  $M_{12}(\mathcal{R}_0)$  in scaled coordinates depends on energy in plicitly through the scaled radius  $\mathcal{R}_0(E) = \frac{p}{F} \mathcal{R}_0$ . As E ! 0,  $M_{12}$  picks up additional contributions of parts of the CTCO closer and closer to the triple collision. A symptotically, all CTCO s approach the triple collision along the WO and the contributions to  $M_{12}$  become orbit-independent. The R-dependence for the M on-odrom y matrix of the WO can for small  $\mathcal{R}$  be obtained analytically [23] leading to

Thus, in unscaled coordinates, M  $_{12}$  in (6) diverges which is a direct consequence of the non-regularisability of the triple collision acting as an in nitely unstable point in phase space; details will be presented in [23]. The exponent in (8) is universal for all CTCOs and consists of two components:  $_{eZe}$  is related to the linearised dynam – ics in the eZe space and  $_{wr}$  picks up contributions from two equivalent expanding degrees of freedom orthogonal to the eZe space in the so-called W annier ridge (W R). The latter is the invariant subspace of symmetric electron dynamics with  $jr_1 j = jr_2 jat all times [21]$ . The uctuations in the photo-ionisation cross section thus vanish in amplitude as E ! 0 according to

where the rescaled am plitudes  $a_j = f j A_j$  depend only weakly on E. These am plitudes contain contributions from the linearised dynamics along the orbit far from as well as information about the inner quantum region  $R < R_0$  via the dipole vector d and the core-region scattering matrix  $S^{\sharp}$ . Furthermore, multiple traversals of contained in  $S^{"S^{\sharp}}$  with k 2 in (3) approach the triple collision k times from the sem iclassical side and w ill thus contribute at lower order with weights scaling at least as  $A_{kj} = f$ . The exponent in (8) is dierent from W annier's exponent with

O ne obtains, for example, = 1:30589:::: compared to  $_{W}$  = 1:05589:::: for helium; the W R contributes to the decay for Z > 9=4 when  $_{Wr}$  is real.

The exponent can be interpreted in term s of stability exponents of the triple collision singularity. U sing an appropriate scaling of space and time by, for example, em ploying M cG ehee's technique [22], the dynam ics near the singularity is dom inated by two unstable xed points in scaled phase space, the double escape point (DEP) and the triple collision point (TCP). In unscaled coordinates, these xed points correspond to the W 0 at energy E = 0, that is, the DEP is the trajectory of symmetric double escape while the TCP corresponds to the symmetric triple collision and is the time reversed of the DEP. The triple collision itself can be mapped onto the classical dynam ics at E = 0; likew ise,  $\mathbb{R}_0 = \mathbb{E} \mathbb{R}_0$  acts as a parameter m easuring the closeness to the E = 0 m anifold which contains the xed points, see [10, 22]. Most classical trajectories emerging from ~ in the vicinity of the triple collision  $\mathbf{R} = 0$  will lead to immediate ionisation of one electron carrying away a larger am ount of kinetic energy.

Only a fraction of orbits starting on ~ near the W O will enter a chaotic scattering region; the W O at E < 0 thus acts as an unstable direction of the DEP,  $U_D^{\ WO}$ , with a stability exponent  ${}^{WO}_{U_D}$ . From there, they can return to the triple collision region and thus approach the surface ~ again along the W O, that is, along the stable direction  $S_T^{\ WO}$ . The transition from the DEP into the chaotic scattering region and from this scattering region to the TCP is limited by the least stable eigendirections of the xed points in each of the invariant subspaces (eZe or W R) perpendicular to the W O.

Trajectories leaving ~ along the W O in the eZe space diverge from the W O along an unstable direction  $U_D^{eZe}$  with a stability exponent  $U_D^{eZe}$ . Competition of the instability in  $U_D^{wo}$  with that in  $U_D^{eZe}$  determines the fraction

 $^{\rm D}_{\rm eZ\,e}$  of orbits entering the chaotic scattering region. By using m ethods as in [10, 24], one  $\,$  nds that

with exponent equal to W annier's exponent (10). For the cross section (1), inform ation about the phase space region returning from the chaotic scattering region to the surface ~ along the W O is also needed. W hile approaching ~, these orbits are de ected away from the triple collision along an unstable direction  $U_T^{eZ\,e}$  of the TCP xed point. The fraction of orbits reaching the surface ~ am ong those leaving the chaotic scattering region scales thus as in (11) now with exponent  $\frac{eZ\,e}{U_T} = \int_{S_T}^{WO} j$ . Sim ilar m echanism s apply for the W R dynam ics.

The fraction of two-electron trajectories making the transition from ~back to ~can thus in the limit E ! 0 be estimated in terms of the stability exponents of the xed points, also referred to as Siegel exponents [24] in celestial mechanics. One obtains /  $R_0^2$  with as in (8) which can be written as

for the actual values of the stability exponents , see [7, 10]. The mean amplitude of the uctuations in the quantum signal is thus asymptotically related to the fraction of phase space volume starting and ending at  $\mathbb{R}_0$ .

A numerical study of the full three-body quantum problem is still out of reach for energies  $E < I_N$  with N 15 [1, 9]; we therefore chose a model system, namely eZe collinear helium rst studied quantum mechanically in [25]. We calculated the cross section (1) directly in a large set of basis functions using the method of complex rotation and obtained a converged signal for N 55. Sem iclassically, we consider now the dynamics in the eZe space alone, which contains all the important parts regarding the algebraic decay in the uctuations. The number of basis functions used are scaled with energy to cover a xed scaled region in  $\mathcal{R}$  containing CTCOs with S=2 20. Adopting the basis functions used by

Puttner et al [1] leading to a strongly banded H am iltonian m atrix, it is possible to increase the basis size to 10<sup>6</sup>. Starting with an odd initial state <sub>i</sub>, we obtain the cross section for the even parity eZe spectrum; its uctuating part after num erically subtracting a sm ooth background is shown in Fig. 1. The num erical value of the exponent is determ ined by rescaling the signal according to

and testing the stationarity of the Fourier transform of

F (z) in dierent energy windows [23]. The best value thus obtained is  $= 1:306 \quad 0:035$  in good agreem ent with the theoretical prediction (8). (Note that the real parts of the exponents for 3-dim . helium and for eZe helium coincide as  $< w_r = 0$ ). Furtherm ore, the peaks in the Fourier transform can be associated one-by-one with CTCO's in the eZe system, see Fig. 1. W e do not observe peaks associated with the concatenation of di erent CTCO's or repetitions of single CTCO's. This is consistent with the expected suppression of orbit contributions traversing m ore than once as discussed earlier. Furtherm ore, we calculated the geom etrical contribution to the coe cients a i in (9) directly from the matrix-elements M  $_{12}$  by scaling out the leading order divergence; a clear correlation with the peak heights can be seen in Fig. 1. Quantum contributions from the core region are thus indeed roughly the sam e for all CTCOs.

In conclusion, we show that the uctuations in the total photo-ionisation cross section below the double ionisation threshold follow an algebraic law with a novel exponent which can be written in terms of stability exponents of the triple collision. Our notings are veriled numerically for a collinear model systems; we furthermore predict that the algebraic decay law is valid for the physically relevant 3 dimensional cases with an additional contribution from the W R dynamics for Z > 9=4. Our notings will provide new in petus for experimentalists and theoreticians alike to study highly doubly excited states in two-electron atom s.
