# M echanical Interpretation of Existence Theorem s in a N on linear $D$ irich let $P$ roblem

#### Abstract

The existence of radialsolutions of a nonlinearD irichlet problem in a ball is translated to the language ofM echanics, i.e. to requirem ents on the tim e ofm otion of a particle in an extemalpotential and under the action of a viscosity force. This approach reproduces existing theorem $s$ and, in principle, provides a $m$ ethod for the analysis of the general case. E xam ples of new theorem s are given, which prove the usefillness of this qualitative $m$ ethod.


## 1 Introduction

In the present paper, we consider the follow ing nonlinear D irichlet problem

\end{align*}

where f is a di erentiable function and is the ball of radius $R$ in $\prec$. W e look for conditions guaranteing the existence of spherically sym m etric solutions to (1-2).

The above $m$ entioned problem has been extensively studied in the last years (see, for exam $\mathrm{ple},[1-5]$ and references therein). In this paper, our purpose is to develop a very sim ple picture, based on $M$ echanics, for the analysis of the existence of solutions to (1-2). This qualitative picture reproduces the existing results and, in principle, provides a fram e for the analysis of the radial solutions to ( $1-2$ ) in presence of an arbitrary nonlinear function f. Exam ples of new theorems are given, which show the usefulness of the $m$ ethod.

To our know ledge, the analogy of the radialequation (1) w ith the $N$ ew tonian law ofm otion of a particle was rst used by Colem an [6] to obtain the approxim ate form of the solution connecting false and true vacua in scalar
eld theories. This solution enters the sem iclassical expresion for the decay probability of the false vacuum state. A pplication of this analogy to the analysis of the existence of solitary w aves in nonlinear one-dim ensionalm edia has proven to be very usefiul too [7].

Theplan of the paper is as follow s. In the next Section, the problem about the existence of solutions to (1-2) is translated to the language of $M$ echanics. T wo lim iting solvable cases, the one-dim ensional problem and the linear equation, are considered and a few general results are given. Let us stress that the fiunction $f(u)$ is interpreted as the derivative of a potential, thus the linear equation describes them otion in a quadratic potential. Section 3 deals $w$ th potentials having a well around $u=0$. The most interesting exam ples studied in this Section are, in our opinion, the potentials with barriers. In Section 4, we study the $m$ otion in a potential w ith a hill around $u=0$. In Section 5, we consider singular ( nite and in nite) potentials. C oncluding rem arks are given at the end of the paper.

## 2 The A nalogy w ith M echan ics

W e start by considering the spherically sym $m$ etric version of P roblem (1-2)

W ritten in this form, the analogy w ith M echanics is evident. Equation 3 is nothing, but the $N$ ew ton law for a particle of unit $m$ ass $m$ oving in a potentiall which is the antiderivative of $f, f(u)=d V=d u$, and under the action of a viscosity force inversely proportional to tim e. The particle should start $w$ ith zero velocity from a position $u(0)$ and arrive to $u=0$ in a timeR ( F ig. 1a).

W e have draw $n$ in $F$ ig. 1 b a generic positive solution to (3-4) for a given V . In general, the particle w ill realize dam ped oscillations around the point $\mathrm{u}=0$ ( F ig. 2). Let $\mathrm{T}_{\mathrm{n}}(\mathrm{u}(0))$ be the tim e the particle spends to reach the point $u=0 \mathrm{n}$ tim es starting from $u(0)$. Thus, the existence of a solution to (3-4) m ay be form ulated in the follow ing term s :
\In the potential $V$, there exists an $u(0)$ and a positive integer, $n$, such that $\mathrm{T}_{\mathrm{n}}(\mathrm{u}(0))=\mathrm{R}{ }^{\prime \prime}$

The interesting point is that in $m$ any cases we $m$ ay perform sim ple estim ates, based on physical principles, of the dependence $T_{n}$ vs $u(0)$ and, consequently, we m ay give criteria for the existence of solutions to (3-4).

Let us rst study two lim iting cases in which equation (3) $m$ ay be solved exactly. T hey w ill be very useful in the analysis below .

### 2.1 The one-dim ensional ( $\mathrm{D}=1$ ) problem

The $D=1$ case is characterized by the absence of friction. Thus, the energy $E=(1=2)(d u=d r)^{2}+V(u)$ is conserved, $d E=d r=0$, and the dependence $r(u)$ $m$ ay be expressed in the form of an integralin each intervalw here du=dr does not change sign,

In such conditions, the $m$ otion of a particle in a well is a periodic m otion characterized by the function $T_{1}$

(For negative $u(0)$ the integration lim its shall be reversed). N ote that $T_{n}$ m ay be expressed in term s of $\mathrm{T}_{1}$ :

where $[q] m$ eans the integer part of $q$, and $u(0)$ is de ned from $V\left({ }^{*}(0)\right)=$ V (u (0)) = E.

For a given potential, the equation $T_{n}=R m$ ay be explicitly w ritten and the existence of solutions to P roblem $(3-4) \mathrm{m}$ ay be explicitly investigated.

W e are not going to give further details of the analysis in this sim ple case and tum out to the higher dim ensional ( $\mathrm{D}>1$ ) problem, i.e. motion $w$ ith friction. In this situation, there is another exactly solvable problem : the $m$ otion in a quadratic potential.
2.2 M otion in a quadratic potential (T he linear equation)

W e consider a quadratic potentialV $(u)=(1=2) u^{2} . T$ he equation ofm otion (3) takes the form

The solution of this Eq. w ith initial condition $\frac{d u}{d r}(0)=0$ is expressed as $r^{1}{ }^{n=2} J_{-p=2}{ }_{1 j}\binom{P}{r}$, where $J$ is the Bessel function [8]. It is important to note that the $m$ ain properties of the solution $m$ ay be understood sim ply from the invariance properties of Eq. (8).

LEM MA: $T_{n}$ does not depend on $u(0)$ and is proportional to $\quad 1=2$.
PROOF:The Eq. is invariant under a change in the scale of $u$, and also under the transform ation

where $C_{r}=C^{1=2}$.
A coording to this Lem $m$ a, the function $\mathrm{T}_{\mathrm{n}}(\mathrm{u}(0))$ takes a xed value that depends only on and n. Varying appropiately the param eter (the potential), one $m$ ay ful l the requirem ent $T_{n}=R$. The corresponding set of param eters, $\mathrm{f}_{\mathrm{n}} \mathrm{g}$, de ne the eigenvalues of the linear problem.

### 2.3 Som e useful results

In this Subsection, we derive a few general results follow ing from the analogy w ith M echanics and classify the potentials to be studied.

In the presence of dissipation, the rate of change of the energy is written as

i.e. $u(r)$ is dam ped, asm entioned above. It $m$ eans that $E(u(0))=V(u(0))>$ $E(0)>V(0){\overline{R_{u}}}_{u} 0$ (we have supposed that $f$ is integrable, so that $V(u) m$ ay be de ned as $\left.{ }_{0}^{u} f(x) d x\right)$. Then, we arrive at the follow ing

THEOREM (A necessary condition): If $u(r)$ is a solution to (3-4) and f is integrable, then $u(0)$ is such that

The last condition on the sign of $f(u(0)) \mathrm{m}$ eans that the particle shall be pushed tow ards the origin at the initial position, u(0). O therw ise, it w ill never $m$ ove to the origing passing through $u(0)$ because of the energy losses.
$M$ ore sophisticated versions of this $T$ heorem $w$ ill be form ulated below when studying potentials w th barriers.

A second im portant result concems the retardation e ect of friction. Let us suppose that the particle $m$ oves from $u_{a}$ to $u_{b}$. The tim e it spends in this $m$ otion $m$ ay be w ritten as


Of course, this is not a closed expression because the derivative in the tim e interval $\left(r_{\mathrm{a}} ; r_{\mathrm{b}}\right)$ enters the r.h.s. of it. H ow ever, it is evident that

i.e.

LEM MA:The tim e interval $r_{\mathrm{b}} \quad r_{\mathrm{a}}$ is greater than the tim e the particle spends to $m$ ove from $u_{a}$ to $u_{b} w$ thout friction.
$F$ inally, let us classify the potentials according to their properties in the neighborhood of $u=0$. In the present paper, we will study four classes of potentials having di erent behaviours in the vicinity of this point ( $F$ ig. 3):
a) The wells are de ned as concave potentials around $u=0$.
b) The hills are convex around $u=0.0$ fcourse, at large ju $V$ (u) shallbe positive (the necessary condition).
c) and d) correspond to singular potentials.

W ew ill study below each class of potentials separately.

## $3 \quad W$ ells around $u=0$

A well is de ned as a region with only one local extrem um, the $m$ inim um at $u=0$. In this Section, we study som e exam ples of potentials having a well around $u=0$.

### 3.1 P otentials, quadratic in $u=0$ and $j u j!1$

Let V (u) be a potential such that

additionally, we will asume that the only zero of $f$ is at $u=0$. Then, we have the follow ing

THEOREM : If $(0)<1$ and $(1)>{ }_{k}$, then Problem ( $3-4$ ) has at least $2 \mathrm{k}+1$ solutions.

This Theorem was obtained in [5]. W e w ill give a detailed proof of it by $m$ eans of our $m$ ethod as an illustration. For the incom $m$ ing $T$ heorem $s$, the proof w ill be shortened.
$T$ he statem ent is that the function $T_{n}$ vs $u(0)$ has the form depicted in F ig. 4 for $1 \mathrm{n} \quad \mathrm{k}$, i.e. for each $\mathrm{T}_{\mathrm{n}}$ there are two solutions.

Indeed, the very sm all am plitude $m$ otion is govemed by the $u$ ! 0 asym ptotics of $V$. $T_{n}$ depends very sm oothly on $u(0)$ in this region and $\mathrm{T}_{\mathrm{n}} \quad \mathrm{T}_{1}>\mathrm{R}$. The latter inequality com es from ( 0 ) < 1 .

On the other hand, the large am plitude $m$ otion is govemed by the juj! 1 asym ptotics and, according to the inequality $(1)>k$, we have $T_{n}$ $\mathrm{T}_{\mathrm{k}}<\mathrm{R}$. The point to clarify is why $\mathrm{T}_{\mathrm{n}}$ for large $\mathrm{u}(0)$ is not a ected by the sm all-u behaviour of $V$.

The answer is that, when $u(0)$ is large, the tim e the particle spends to $m$ ove in the sm allu region is negligible. This result com es from the scale invariance of the quadratic potential as shown in Fig. 5. Shadowed areas correspond to $m$ otion in the region $j u j<u_{a}$. It is seen that when $j u(0) j$ ! 1 the tim e spent in this $m$ otion shrinks to zero. It $m$ eans that one can deform $V$ (u) at low jujw thout changing signi cantly $T_{n}$.

Thus, P roblem (3-4) has $2 k$ nontrivial solutions plus the trivialu $=0$.

### 3.2 P otentials w ith barriers

In the previous Subsection, we assum ed continuity of $\mathrm{T}_{\mathrm{n}}$ vs $\mathrm{u}(0)$. H ow ever, continuity is broken when $V$ has localextrem $a$, others than $u=0$. The point is that, as m ay be seen from Eq. 5 and the retardation Lem m a of Section 2.3, the time the particle spends to $m$ ove out of a localm axim um tends to in nity when $u(0)$ approaches the position of the $m$ axim um .

Then, let us rst suppose that $f$ has a unique second zero at a point $a>0$. The follow ing $T$ heorem $m$ ay be form ulated

THEOREM. If (0) > $k$ and $V j_{i(0)!} \quad 1>V(a)$, then Problem (3-4) has at least $k$ solutions $w$ ith $0<u(0)<a$.

To prove it, we draw again the finction $T_{n}(u(0))$, w ith $1 \quad n \quad k$ and positive $u(0)$. At low $u(0), T_{n} T_{k}<R . W$ hen $u(0)!$ a from below, $\mathrm{T}_{\mathrm{n}}$ ! 1 . The condition on $\mathrm{V}(1)$ guarantees that the m otion is oscillatory around $u(0)$ and the particle does not escape to 1 .
$N$ ote that it is di cult to draw the dependence $T_{n}$ vs u(0) for negative u (0) w ithout a know ledge of the potential. T he follow ing T heorem, contained in Ref. [5], states that for asym ptotically quadratic potentials one can say much more.

THEOREM. If $f$ has positive zeroes, the rst of $w h i d h$ is at $u=a$, and (0), (1 ) > k, then Problem (3-4) has at least $4 k \quad 1$ solutions.

W e have draw n in Fig . 6 the potential and the functions $\mathrm{T}_{1}, \mathrm{~T}_{\mathrm{n}}, 1<\mathrm{n}$ $k$. The points $b_{+}$and $b$ are de ned in the monotone regions. They satisfy $\mathrm{V}(\mathrm{a})=\mathrm{V}\left(\mathrm{b}_{+}\right)=\mathrm{V}(\mathrm{b}) . \mathrm{D}$ ashed linesm eans that the curves are conditionally drawn, while shadowed intervals of $u(0)$ m ean physically im possible initial conditions.

The dependence $T_{1}$ on $u(0)$ when $0<u(0)<a$ is the same as in the previous $T$ heorem. For very large positive $u(0), T_{1}$ is determ ined by ( 1 ), i.e. $\mathrm{T}_{1} \dot{J}_{(0)!1}<\mathrm{T}_{\mathrm{k}}<\mathrm{R}$. On the other hand, because of energy losses, if the particle starts from $b_{4}$ it $w$ ill not reach the origin. By continuly, there exists $\mathrm{c}_{1}>\mathrm{b}_{4}$ such that the particle arrives at a w ith zero velocity. This corresponds to an in nite $T_{1}$. W hen $u>c_{1}$ the particle reaches the origin and the dependence $T_{1}(u(0))$ is show $n$. N ote that we can not say anything about $\mathrm{T}_{1}$ for negative $\mathrm{u}(0)$. Thus, the equation $\mathrm{T}_{1}=\mathrm{R} \mathrm{w}$ ill have, at least, two solutions.

A nalog reasonings are used in the analysis of $\mathrm{T}_{\mathrm{n}}, 1<\mathrm{n} \quad \mathrm{k} . \mathrm{C}_{\mathrm{n}}$ is now de ned such that when $u(0)>G$ the origin is reached $n$ tim es. N ote that $\mathrm{T}_{\mathrm{n}}\left(\mathrm{C}_{\mathrm{n}}\right)=1$ and also that $\mathrm{C}_{1}=\mathrm{C}_{2}<\mathrm{C}_{3}=\mathrm{C}_{4}<\mathrm{c}_{5}:::$ On the lh.s. of the origin, we can de ne the points $e_{\text {a }}<d<b$. $d$ is such that when the particle arrives to a it do so w ith zero velocity, while $e_{n}$ is such that for $u(0)<e_{n}$, the particle reaches the origin $n$ tim es. $N$ ote that $e_{2}=e_{3}>e_{4}=e_{5}>e_{6}::$. In other words, for each $n$ there are 4 solutions. $T$ his proves the $T$ heorem .
$N$ otioe that, unlike papers [1-5], we are able to indicate forbidden regions for $u(0)$. This is a generalization of the necessary condition of Section 2.3 .

### 3.3 Thepotentials $V=9 j u$

Let us now consider the potentials $V=$ gjuj, with $g>0,>1 . W$ e shall rst prove that, whatever be, $u(r) w$ ill have the form drawn in $F i g .2$. A fter that, we w ill use scale-invariance properties of the equation of m otion to obtain the dependence $\mathrm{T}_{\mathrm{n}}$ vs u(0). Let us prove the follow ing general

LEM M A. In a potential well, $u(x)$ is an oscillating function of decaying am plitude.

PROOF. It is evident that the particle will reach the origin w hatever the in itialposition be. It can not stop in an interm ediate point where the force is not zero. Thus, the question is how long it takes to reach the origin and what is the nal velocity. If this time and the velocily are nite, we can repeat the argum ent to conclude that $u(r) w i l l$ have in nite zeroes.

Let $r_{a}$ be an interm ediate tim e such that $\frac{d u}{d r}\left(r_{a}\right)>0$. D ue to the particular form of the friction, we can obtain an upper bound for the tim e to reach the origin starting from $u\left(r_{a}\right), r_{b}$, and a low er bound for $\frac{d u}{d r}\left(r_{b}\right)$, if we neglect the potential for $r>r_{a}$ and solve the problem :

It $m$ eans that $u=0 \mathrm{w}$ ill be reached in a nite $\underset{6}{ } \mathrm{w}$ ith a nite velocity and $u(r) w$ ill have in nite zeroes.

Thus, let us now tum out to the dependence $T_{n}$ vs u(0) in the potentials $V=g j u j . T$ he equation ofm otion takes the form

The properties of $T_{n}$ follow ing from the scale invariance of the equation are given in the next Lem ma:

LEMMA. For xed $g, T_{n} \quad j u(0) j=2$, while for xed $u(0), T_{n} \quad g^{1=2}$.
Thus, for every $n$, the equation $T_{n}=R$ will have two solutions, and we arrive to the follow ing

THEOREM.Problem ( $3-4$ ) with $V=g j j, g>0, \quad>1$ has in nite solutions [3].

O ne can now com bine these w ith previous results. In quality of exam ple, let us form ulate the follow ing

THEOREM . Let $(0)<k$ and $V j_{j j} j_{1} \quad j u j$, with $>2$, then solutions to $P$ roblem ( $3-4$ ) w th any $n \quad k$ zeroes exist.

The curve $T_{n}$ vs $u(0)$ for $n \quad k$ ay be easily draw $n$ in this case. $N$ ote that the dependence of $T_{n} j_{j(0) j!} 1$ on the low $-u(0)$ properties of $V$ is, for > 2 , weaker than in the quadratic potential.

## $4 \quad \mathrm{H}$ ills around $u=0$

W e now study the m otion in a potential like that one show n in F ig. 3 b . For sim plicity, we assum $e$ that $V$ is quadratic near zero ( $(0)<0)$ and also quadratic at large values of $u$. N o addtitional zeroes of $f$ exist. Then one can form ulate the follow ing

THEOREM. If $(0)<0$ and $(1)\rangle \quad k$, then Problem (3-4) has $2 k+1$ solutions.
$W$ e have drawn in $F$ ig. 7 the curve $T_{n}$ vs $u(0)$ for $1 \quad n \quad k$. The large-u (0) behaviour of it is evident. The points $b_{+}$and $b$ are the zeroes of $V$. The points $C_{n}$ and $e_{n}$ are de ned as in the previous Section, i.e. starting from the right of $c_{n}$ (the left ofe $e_{n}$ ) the particle $m$ ay reach the origin $n$ tim es. $N$ ote that would it start from $C_{n}\left(e_{n}\right)$, then it would arrive to $u=0$ with zero velocity, i.e. $T_{n}\left(c_{n}\right)=T_{n}\left(e_{n}\right)=1 . N$ ote also that $b_{4}<c_{1}<c_{2}$ $\mathrm{b}>\mathrm{e}_{1}>\mathrm{e}_{2}>$. Thus, foreach n there are two solutions and the $T$ heorem is proved.

O ther potentials could be analysed, but we think that to show the advantages of the $m$ ethod the given exam ple is enough.

## 5 S ingular P otentials

The $m$ ain property of the singular potentials, $F$ igs. 3 c ) and d), is that the force, $d V=d u$, at u $=0$ is ill-de ned. So, them otion an intervaloftim e after the particle reaches the origin is not well de ned, and we can only analyse the existence of positive solutions to (3-4).

A n exam ple ofa potentiallike 3 c ) is $V=$ gjuj, with $g>0$ and $0 \ll 1$. Let us stress that the upperbound for $r_{\mathrm{b}}$ and the dependence $T_{1} \quad j u(0) j=2$, obtained in the Lem m as ofSection 3.3, are valid, so that the equation $T_{1}=R$ has always a solution in this case.

The sam e analysis holds for the potential $V=9 j u j, w i t h g ;>0$. This is a potential of the form 3 d ). Scale invariance in this case leads to $\mathrm{T}_{1} \mathrm{ju}(0) \mathrm{J}^{+}=2$, so that the equation $\mathrm{T}_{1}=\mathrm{R}$ w ill alw ays have a solution also.

W e can now combine possibilities to obtain interesting situations. Let, for exam ple, the potential $V$ be quadratic at the origin with (0) > 0 , while at long distances $V \quad V_{0} \quad g j u j$. No zeroes off exist, except the trivial at $\mathrm{u}=0$. Then, we obtain the follow ing

THEOREM. If $(0)>{ }_{k}$, then Problem $(3-4)$ has at least $2 k+1$ solutions.

The proof is trivial.

## 6 C oncluding $R$ em arks

In the present paper, we used the analogy ofE q. (3) w ith the second $N$ ew ton's law in order to obtain existence theorem s in Problem (3-4). A ppart from reproducing existing results, we give new exam ples of potentials (of f) in which it is relatively easy to analyse the existence of solutions.

W e think that the given exam ples show that them ethod is generalenough to provide a rst insight to the problem for any reasonable function $f$. A fter that, we may go further on in two ways: i) U se m ore rigurous $m$ ethods to com plete the proof and/or ii) Obtain num erical solutions to the equation.
