A bstract


#### Abstract

$T$ he variational principle of barotropic Eulerian uid dynam ics is known to be quite cum bersom e containing asm uch as eleven independent functions. This is $m$ uch $m$ ore than the the four functions (density and velocity) appearing in the Eulerian equations ofm otion. T his fact $m$ ay have discouraged applications of the variationalm ethod. In this paper a four function Eulerian variational principle is suggested and the implications are discussed brie $y$.


## 1 Introduction

Them otion of a uid is usually described in two ways. In the Lagrangian approach we follow the trajectory of each uid particle. W hile in the Eulerian approach we study the evolution of the velocity and density elds.

V ariational principles have been developed in both cases. A variational principle in term $s$ of Lagrangian variables has been described by Eckart [ī1] and B retherton $[\overline{2}]$. W hile a variationalprinciple in term of the Eulerian variables is given by H erivel


The Eulerian approach appears to bem uch $m$ ore appealing involving $m$ easurable quantities such as velocity and density elds instead of the trajectories of unseen particles of the Lagrangian approach.

H ow ever, regretfiully the variational principle of the Eulerian ow appears to be $m$ uch $m$ ore cum bersom $e$ than the Lagrangian case, containing quite a few "Lagrange m ultioliers" and "potentials". In fact the total num ber of independent functions in this form ulation according to the approach suggested by H erivel [] $\overline{3}]$, Serrin $\left[\begin{array}{l}{[4]}\end{array}\right]$ and Lin $\left[\frac{15}{1}\right]$ is eleven which exceeds by $m$ any the four functions of velocity and density appearing in the Eulerian equations of a barotropic ow.
$T$ he variationalprinciple of the Lagrangian approach is on the other hand sim ple and straightforw ard to im plem ent. B retherton $[\underline{[2}]$ has suggested to use the Lagrangian variational principle w ith Eulerian variables and especially constructed
"Eulerian displacem ents" for which the equations of $m$ otion are derived. This procedure appears to be inconvenient for stability and num erical calculations.

Instead I intend to develop in this paper a sim pler variational principle in term $s$ of Eulerian variables. This $w$ ill be done by rearranging the term $s$ in the original variational principle and using a sim ple tridk to be discussed below. T he result w ill be a variational principle in term s of four E ulerian independent functions which is the appropriate num ber.

The plan of this paper is as follow s: rst I review the originalE ulerian variational principle and the equations derived from it. T han I derive a new variationalprinciple and discuss its im plications.

## 2 The Eulerian A pproach to the B arotropic F low

In the Eulerian description of barotropic uid dynam ics we seek a solution for the velocity $v=v\left(x^{k} ; t\right)$ and density $=\left(x^{k} ; t\right)$ elds of a given ow. Those elds depend on the space coordinates $\left.x=\left(x^{k}\right)=(x ; y ; z) \quad k ; l ; m ; n=1 ; 2 ; 3\right]$ and on the tim e variable $t . T$ he elds are obtained by solving the Euler equations:

in which $\tilde{r}=\frac{@}{@ x^{k}}$. The potential $=\left(x^{k} ; t\right)$ is a given function of coordinates, while $h=h()$ is the speci $c$ enthalpy which is a given function of usually designated as the equation of state. In addition the density and velocity elds must satisfy the continuity equation :

Thus we have to solve four equations in order to obtain four unknown elds. This can be done when supplem ented the appropriate boundary conditions.

### 2.1 The C lassical Eu lerian V ariational P rinciple

 the Euler and continuity equations (equation $\left.\overline{11}_{1}^{1}\right)$ and equation $\left.\bar{Z}_{\mathbf{I}}\right)$ ) can be derived, arrived at the action A given in term $s$ of the Lagrangian $L$ as:

In which " ( ) is the speci c intemal energy connected to the speci centhalpy by the equation :

The volum e elem ent is given by $d^{3} x$ and the operator $\frac{D}{D t}$ is de ned such that: $\frac{D}{D t}$ $\frac{\varrho}{@ t}+v \tilde{r}$. The variation principle contains in addition to the desired four functions $; \mathbb{v}$ also the seven "potentials" ; ; ~ reaching to a total of eleven variational variables. Varying the above action w ith respect to those variables such that the variations vanish for $x$ and $t$ su ciently large. W e see that in order to have A vanish for otherw ise arbitrary ( $\mathrm{w} ; \quad$; $; \sim \mathcal{F}^{\sim}$ ), the follow ing equations $m$ ust be satis ed:

C om bining equation ( $(\overline{-} \bar{\sigma})$ and equation ( $\left.\bar{S}_{1}^{1}\right)$ we arrive at the sim pler equation :

C alculating the expression $\frac{D *}{D t}$ using equations ( of Euler:

Thus the functions $w$ and are extrem a of the action A if they satisfy the Euler and continuity equations.

### 2.2 The V ariational Principle of Seliger \& W itham

Seliger \& W tham [G] have proposed to take $\sim=(; 0 ; 0)$ and $\sim=(; 0 ; 0)$, in this way one obtains a variational principle w th only seven functions. Rew riting equations $\left(\overline{5}_{1}\right.$

W e see that equations $(\overline{1} \overline{2}, 1, \overline{1} \bar{G})$ rem ain unchanged. T he velocity $v$ is given now by the C lebsch representation (equation (1] $\overline{1} \mathbf{1})$ ) and the entire set of equations are designated
 B retherton [2] have quoted a rem ark by H.K.M o at conceming the possibility of the function being not single valued. A coording to M o at [ $[\underline{[ }]$ the helicity integral:

which is a m easure of the knottedness of the vortex lines, $m$ ust be zero if is single valued which is clearly not true in general. This can be shown as follow s: suppose that is single valued than by inserting equation $\overline{(1) \overline{1})}$ into equation $\left(\overline{1} \mathbf{1}_{-}^{-}\right)$and integrating by parts we obtain:

If we choose a volum em ade of closed vortex lam ents such that $\tilde{r} \quad v \quad \pi=0$ than clearly $\mathrm{H}=0$. H ow ever, as B retherton [2] noticed the equations of $m$ otion being local are una ected by global properties such as the non single-veluedness of .

A $n$ analogue from classical $m$ echanics $m$ ay $m$ ake things even clearer. A few w ill ob ject to describe the two dim ensional m otion of a particle moving under the in uence of the potentialV ( $R$ ) (w here $R$ is the radialcoordinate), by the coordinates $R$; . W here is the azim uthalangelwhich is not single valued. This form is found to be $m$ ore convenient than the single valued $C$ artesian $x ; y$ representation.

## 3 The R educed V ariational Principle

A though Seliger \& W itham (1968) have m anaged to reduce the Eulerian variational principle from eleven to seven functions. T he num ber of variational variables is still too much, since the Eulerian equations contain only four unknown functions. I intend to suggest a solution to this problem here.
$F$ irst let us rew rite the Lagrangian of Seliger \& W itham (equation (ī) w ith and being scalars):

The Lagrangian $L$ is dissected into a part depending on the uid velocity $v$ which is denoted as $L_{v}$ and the rem aining part which does not depend on $w$ which is denoted $L_{r}$. Let us look at the action:

This action is a functional of the four variables: ; ; ; N ote that the last term of $\mathrm{L}_{\mathrm{r}}$ is a fulltim e di erential and thus does not contribute to the equations ofm otion. In order to sim plify the variational calculations we introduce the notations:

U sing the above notations and assum ing that the arbitrary variations ( ; ; ; ) vanish for $x$ and $t$ su ciently large we obtain that $A_{r}=0$ only if the follow ing equations are satis ed:

If we take $u$ to be a Clebsch representation of som e velocity eld $v=u$, than the above equations becom e the $C$ lebsch transform ed equations of uid $m$ otion (equations contain w as a variational variable. This situation in which only the potentials appear in the variational principle but not the physical velocity eld v itself is fam iliar from other branches of physics and w ill be discussed below .

It rem ains to discuss the Lagrangian $L_{v}$ given in equation ( $\left.\overline{2} \bar{\sigma} \bar{\sigma}_{1}\right)$, using the theorem of $G$ auss and the de nition (2 ${ }_{2}^{2}$ í) of o we arrive at the form :

If we take a to be a C lebsch representation of v than the rst part of $\mathrm{L}_{\mathrm{v}}$ vanishes. Further $m$ ore the surface integral rem aining vanish for both uids contained in a vessel in which $*$ is parallel to the vessels surface and for astrophysical ow sin which the density vanishes on the surface of the ow. H ow ever, in the case of helical
ow s is not single-valued and one must add in addition to the physical surface a "cut". Thus one obtains: $\quad z$

where [ ] represents the discontinuity of across the "cut". W e conclude that for helical ow $L_{v}$ does not vanish altogether. A nd thus for those ows the new Lagrangian $L_{r}$ is not equal to the Seliger \& $W$ tham Lagrangian $L$, the di erence being a surface integral over the "cut".

### 3.1 A C om m ent $R$ egarding E sthetics

It was already noted that the last term of $L_{r}$ given in equation (2-5]) does not contribute to equations of $m$ otion. It seem esthetically plausible to om it this term altogether thus obtaining:

The Lagrangian is quadratic in the spatial $C$ lebsch representation $\tilde{r}+\tilde{r}$, and linear in the tem poral "C lebsch representation": $\frac{\varrho}{\varrho t}+\frac{\varrho}{\varrho t}$.

### 3.2 P otentials as Lagrangian V ariables

$T$ he Lagrangian $L_{s}$ contains variables ( ; ; ) that have no physicalm eaning outside the context of the Clebsch representation. This is also the situation in electrom agnetics in which the Lagrangian (see for exam ple Goldstein (1980) p. 582) is given by:

In which $\mathbb{A} ; A_{0}$ are the vector and scalar electrom agnetic potentials, $e$ is the charge of the electron, 3 is the current and is the charge density $\mathrm{y}^{2} .0 \mathrm{nly}$ after the problem is solved in term $s$ of the potentials $\mathbb{A} ; A_{0}$ the physical electric $E$ and $m$ agnetic $B$ elds can be obtained through the relations:

which are analogue to the C lebsch representation given by equation (13) in the uid dynam ical case.

### 3.3 Linearity in $T$ im e D erivatives

A nother odd characteristic of the Lagrangian $L_{s}$ given by equation ( $\left.\overline{3} \overline{9} \bar{g}_{1}\right)$ is that it contains only linear term $s$ in tim e derivatives. This is unlike the generic case in classical $m$ echanics in which term $s$ quadratic in tim e derivatives appear in the kinetical energy part the Lagrangian. For this situation I have been able to nd an analogue from quantum mechanics. The Schroedinger Lagrangian is given by:

in which $\mathrm{h}=\frac{\mathrm{h}}{2}$ is the P lanck C onstant, $\mathrm{i}={ }^{\mathrm{P}} \overline{1}$, is the wave function and is its com plex con jugate. $\mathrm{L}_{\text {sch }}$ is linear in tim e derivatives and in this respect resem bles $\mathrm{L}_{\mathrm{s}}$.

## 4 C onclusions

A theough a com pact variational principle have been obtained in equation ( $\overline{3} \overline{\underline{9}} \bar{q}_{1}$ ) it rem ains to see the possible im plications of this expression. O ne possible utility is to obtain better num erical algorithm $s$ for solving uid ow problem sbased on the above variationalprinciple (see Y ahalom [1] of certain stationary ows in the spirit of the works by $K$ atz, Inagaki \& Yahalom


[^1]Further M ore, it is also desirable to have a variationalprinciple for incom pressible ow s which should contain only three functions since the density is not a variable in this case. A sim ilar reduction in degrees of freedom should be obtained for two dimensional ows in which the velocity has only two com ponents. The above list of extensions of the Eulerian variational principles is of course not com prehensive. A nd the undertakings $m$ entioned are left for future papers.
