Inverse H arish-C handra transform and di erence operators

In the paper we calculate the images of the operators of multiplication by Laurent polynomials with respect to the Harish-Chandra transform and its non-symmetric generalization due to Opdam. It readily leads to a new simple proof of the Harish-Chandra inversion theorem in the zonal case (see [H C, H e1]) and the corresponding theorem from [D1]. We assume that k > 0 and restrict ourselves to compactly supported functions, borrowing the growth estimates from [D1].

The Harish-Chandra transform is the integration of symmetric functions on the maximal real split torus A of a sem i-simple Lie group G multiplied by the spherical zonal function (X;), where X 2 A; 2 (LieA $_{\rm R}$ C): The measure is the restriction of the invariant measure on G to the space of A=W for the maxim alcom pact subgroup K double cosets K nG =K G and the restricted W eyl group W . The function is a symmetric (W -invariant) eigenfunction of the radial parts of the G-invariant di erential operators on determ ines the set of eigenvalues. The parameter k is given by the G=K; root multiplicities (k = 1 in the group case). There is a generalization to arbitrary k due to Calogero, Sutherland, K oornwinder, M oser, O Ishanetsky, Perelom ov, Heckman, and Opdam. See [HO1,H1,O2] for a system atic theory. In the non-symmetric variant due to Opdam [01], the operators from [C5] replace the radial parts of G-invariant operators and their k-generalizations. The problem is to de ne the inverse transforms for various classes of functions.

In the papers [C1-C4], a di erence counterpart of the Harish-Chandra transform was suggested, which is also a deform ation of the Fourier transform in the p-adic theory of spherical functions. Its kernel (a q-generalization of) is de ned as an eigenfunction of the q-di erence \radial parts" (M acdonald's operators and their generalizations). There are applications in combinatorics (the M acdonald polynom ials), the representation theory (say, quantum groups at roots of unity), and the m athem atical physics (the K nizhnik-Zam olodchikov equations and m ore). The di erence Fourier transform is self-dual, i.e. the

kernel is x \$ sym m etric for $X = q^x$. This holds in the dimensional theory only for the so-called rational degeneration with the tangent space T_e (G =K) instead of G =K (see [He1,D,J]) and for special k = 0; 1. In the latter cases, the dimensional dimension is coincide up to a norm alization.

The di erential case is recovered when q goes to 1. At the moment the analytic m ethods are not m ature enough to m anage the limiting procedure in detail. So we develop the corresponding technique without any reference to the di erence Fourier transform, which is not introduced and discussed in the paper, switching from the double a ne Hecke algebra [C 9] to the degenerate one from [C 7]. The latter generalizes Lusztig's graded a ne Hecke algebra [L] (the G L_n-case is due to D rinfeld). M ainly we need the intertw iners and creation operators from [C 2] (see [C 9] and [K S] for G L_n). It is worth m entioning that the p-adic theory corresponds to the limit q ! 0, which does not violate the standard di erence convergence condition jqj < 1 and hardly creates any analytic problem s.

The key result is that the O pdam transforms of the operators of multiplication by the coordinates coincide with the operators from [C 6] (see (4.11) below). Respectively, the Harish-C handra transforms of the multiplications by W -invariant Laurent polynomials are the di erence operators from (4.14). It is not very supprising that the transforms of these in portant operators haven't been found before. The calculation, not di cult by itself, involves the following ingredients new in the harm onic analysis on symmetric spaces:

- a) The Dunk l-type operators [C5], their relation to degenerate (graded) a ne Hecke algebras [C8], and the Opdam transform [D1].
- b) The M acdonald operators, di erence counterparts of D unkloperators, and double a ne H ecke algebras [M 1,M 2,C 6,C 9].

We begin the paper with some basic facts about double a ne Hecke algebras and their polynom ial representations which are necessary to produce difference Dunkl-type operators. Then we discuss the two degeneration procedures leading respectively to the operators from [C 5] (di erential) and from [C 6] (di erence). Both are governed by the same degenerate double a ne Hecke algebra (introduced in [C 7]). It eventually results in the inversion theorem.

H opefully this approach can be extended to any k and, m oreover, m ay help to (re)establish the analytic properties of the direct and inverse transform s. I believe that this paper will stimulate a system atic renewal of the H arish-C handra theory and related representation theory on the basis of the di erenceoperator m ethods.

In the case of GL_n , the element P_1 (it is of in nite order) was used by K nop and Sahi (see [Kn]) to construct the non-symmetric M acdonald polynom ials and eventually con m the M acdonald integrality conjecture. They introduced it independently of [C9] and checked the \intertwining" property directly. G enerally speaking, a direct veri cation of (2.8) without the X -intertwiners and the involution " is possible but m uch more di cult.

The operator P_1^0 in the case of GL_n (it is of in nite order) plays the key role in [KS]. The formulas for 0_i when 1 i n are well-known in the theory of degenerate (graded) Lusztig algebras. i.e. ${}^{1}S_{\hat{w}}^{+} = S_{\hat{w}}^{-1}$ for the anti-involution ${}^{+}$ sending ${}_{b}$? ${}_{b}$; \hat{w} ? \hat{w}^{-1} ; where $\hat{w} \geq W^{-b}$.

Proof. Statem ent a) is a straightforward degeneration of the polynom ial representation of H. Since $(X_b) = (q^b) = (X_b^{-1})$ and $q = q^{-1}$, we get the -invariance of and come to (4.13).

Following Theorem 3.1 (and [C6]), the operators

5. Opdam transform

From now on we assume that R 3 k > 0 for all and keep the notation from the previous section; i is the imaginary unit, <;= the real and imaginary parts.

Theorem 5.1. There exists a solution G (x;) of the eigenvalue problem

bounded for x 2 Rⁿ when 2 iRⁿ. The solution of (5.1) is unique in the class of continuously di erentiable functions on Rⁿ (for a given).

This theorem is from [D1] (Theorem 3.15 and Proposition 6.1). Opdam uses that v

is a generalized hypergeom etric function, i.e a W -sym metric eigenfunction of the restrictions L_p^0 of the operators $p(D_{b_1}; :::; D_{b_n})$ to sym metric functions:

where p is any W -invariant polynom ial of $i = b_i$. The operators L_p^0 generalize the radial parts of Lap lace operators on the corresponding sym m etric space (see Introduction). The normalization is the same: F (0;) = 1. It xes F uniquely. So it is W -invariant with respect to as well.

A system atic algebraic and analytic theory of F-functions is due to Heckman and Opdam (see [HO1,H1,O2,HS]). There is a formula for G in terms of F (at least for generic) via the operators D_b from (4.5). The positivity of k implies that it holds for all 2 Cⁿ. See [D1] for a nice and simple argument (Lemma 3.14). This formula and the relation to the a neK nizhnik-Zam olodchikov equation [C5,Ma,C8,O1] are applied to establish the grow th estimates for G. Actually it gives more than was formulated in the theorem (see C orollary 6.5, [D1]).

We introduce the O pdam transform (the rst component of what he called \C herednik's transform ") as follows:

for the standard measure dx on R $^{\rm n}$.

Proposition 52. a) Let us assume that f(x) are taken from the space C_c^1 (Rⁿ) of C-valued compactly supported 1 -di erentiable functions on Rⁿ. The inner product

b) The O pdam transforms of such functions are analytic in on the whole Cⁿ and satisfy the Paley-W iener condition. A function g() is of PW -type $(g \ 2 \ PW \ (C^n))$ if there exists a constant A = A(g) > 0 such that for any N > 0

for a proper constant C = C (N;g).

Proof. The rst claim is obvious. The Paley-W iener condition follows from Theorem 8.6 [D1]. The transform under consideration is actually the rst component of O pdam 's transform from D e nition 7.9 (ibid.). We also om it the complex conjugation in his de nition and change the sign of x (instead of). The estimates remain the same. \Box

6. Inverse transform

We are coming to the inversion procedure (for positive k). The inverse transform is well-de ned for Paley-W iener functions g() on C $^{\rm n}$ by the formula

for the standard measure d . The transforms of such g belong to C_{c}^{1} (Rⁿ).

The existence readily follows from (5.5) and known properties of the Harish-Chandra c-function (see below). The embedding G (PW (Cⁿ)) C_c^1 (Rⁿ) is due to Opdam. It is similar to the classical one from [Hel] (see also [GV]).

Let us rst discuss the shift of integration contour in (6.1). There exists an open neighborhood $U_{+}^{a} = R^{n}$ of the closure $C_{+}^{a} \ge R^{n}$ of the a ne W eyl chamber C_{+}^{a} from (1.8) such that

for su ciently big C > 0. So the products of PW -functions by tend to 0 for j j? 1, and we can switch to . A ctually we can do this for any integrand analytic in U_{+}^{a} + iRⁿ and approaching 0 at 1. We come to the following:

Proposition 6.1. The conditions of part b), Proposition 4.3 are satis ed for

in the class of PW -functions, i.e. the operators $S_{\hat{w}}$ are well-de ned on such functions and unitary.

Proof. It is su cient to check the unitarity for the generators S $_j$ = S_{sj} (0 j n) and $_r$ (r 2 0). For instance, let us consider s₀. We

Since (6.5) holds for one it is valid for all of them in U_+^a including 0. The consideration of the other generators is the same.

The scalar factors on the left are necessary to preserve the normalization G(0;) = 1, so we can use the main property of the intertwiners (2.8) and the uniqueness of G(x;) (Theorem 5.1). Expressing s_j^x in terms of s_j (when applied to G!), we get (6.6) for $\hat{w} = s_j$. It is obvious for $\hat{w} = _r$. Using the commutativity of \hat{w}^x and S_{tt} for \hat{w} ; $\hat{u} \ge W^b$, we establish this relation in the general case. For $w \ge W$ it is due to Opdam.

Formula (6.7) results directly from (6.6) because we already know that \hat{w}^x are unitary for ff; f⁰g and $S_{\hat{w}}$ are unitary with respect to fg; g⁰g for the considered classes of functions. See Theorem s 42, 4.3 and (5.4), (6.4).

For instance, let us check (6.8) for F, which is a particular case of (6.7):

Thus the Opdam transforms of the \multiplications by the coordinates" X $_{\rm b}$ are the operators $_{\rm b}.$

Since D_b and b_b are self-adjoint for the corresponding inner products (see Theorem 4.2), we get (6.9), which is in fact the dening property of F and G.

Corollary 6.3. The compositions $GF : C_c^1 (\mathbb{R}^n) ! C_c^1 (\mathbb{R}^n)$, and $FG : PW (\mathbb{C}^n) ! PW (\mathbb{C}^n)$ are multiplications by nonzero constants. The transforms F; G establish isomorphisms between the corresponding space identifying f; g and f; g up to proportionality.

Proof. The rst statement readily follows from the Main Theorem. The composition GF sends C_c^1 (Rⁿ) into itself, is continuous (due to Opdam), and commutes with the operators X_b (multiplications by X_b). So it is the multiplication by a function u(x) of C¹ -type. It must also commute with D_b. Hence G (x;)u(x) is another solution of the eigenvalue problem (5.1) and u(x) has to be a constant.

Let us check that F G, which is a continuous operator on PW (Cⁿ) (for any xed A) commuting with multiplications by any b, has to be a multiplication by an analytic function v(). Indeed, the image of F G with respect to the standard Fourier transform (k = 0) is a continuous operator on C_c^1 (Rⁿ) commuting with the derivatives Q=Qx₁. So it is the convolution with some function and its inverse Fourier transform is the multiplication by a certain v(). Since F G (g) = C onst g for any g() from F (C_c^1 (Rⁿ)), v is constant.

The claim about the inner products is obvious because fF (f);gg = ff;G(g)g for $f 2 C_c^1 (\mathbb{R}^n)$, $g 2 PW (C^n)$.

The corrolary is due to Opdam ([D1], Theorem 9.13 (1)). He uses Peetre's characterization of di erential operators (sim ilar to what Van Den Ban and Schlichtkrull did in [BS]). Anyway a certain nontrivial analytic argument is involved to check that GF is multiplication by a constant.

The symmetric case. The transforms can be readily reduced to the symmetric level. If f is W -invariant then

for F from (5.2). Here we applied the W -sym m etrization to the integrand of the (5.3) and used that is W -invariant. So F coincides with the k-deform ation of the Harish-Chandra transform on W -invariant functions up to a m inor technical detail. The W -invariance of F in results in the W -invariance of F (f).

A s to G, we W -sym m etrize the integrand in the de nition with respect to x and , replacing G by F and by by its W -sym m etrization. The latter is the genuine H arish-C handra m easure"

up to a coe cient of proportionality.

Finally, given a W -invariant function $f \ge C_c^1$ (Rⁿ); Z (6.14) $f(x) = Const g()F(x;)^0 d$ for g = F(f):

A similar formula holds for G. See [HC, He2] and [GV], Ch.6 for the classical theory.

As an application, we are able to calculate the Fourier transforms of the operators $p(X) \ge C[X_b]^{W}$ (symmetric Laurent polynomials acting by multiplication) in the Harish-Chandra theory and its k-deformation. They are exactly the operators $_p$ from Section 4. In the minuscule case, we get formulas (4.15). We mention that in [D1] and other papers the pairings serving the Fourier transforms are herm itian. Com plex conjugations can be added to ours.

We hope that the method used in this paper can be generaized to negative k and to other classes of functions (cf. [BS,HO2]). Relations (6.6) considered as di erence equations for G (x;) with respect to may help with the grow th estimates via the theory of di erence equations and the equivalence with difference K nizhnik-Zam olodchikov equations. However I believe that the main progress here will be connected with the di erence Fourier transform.
